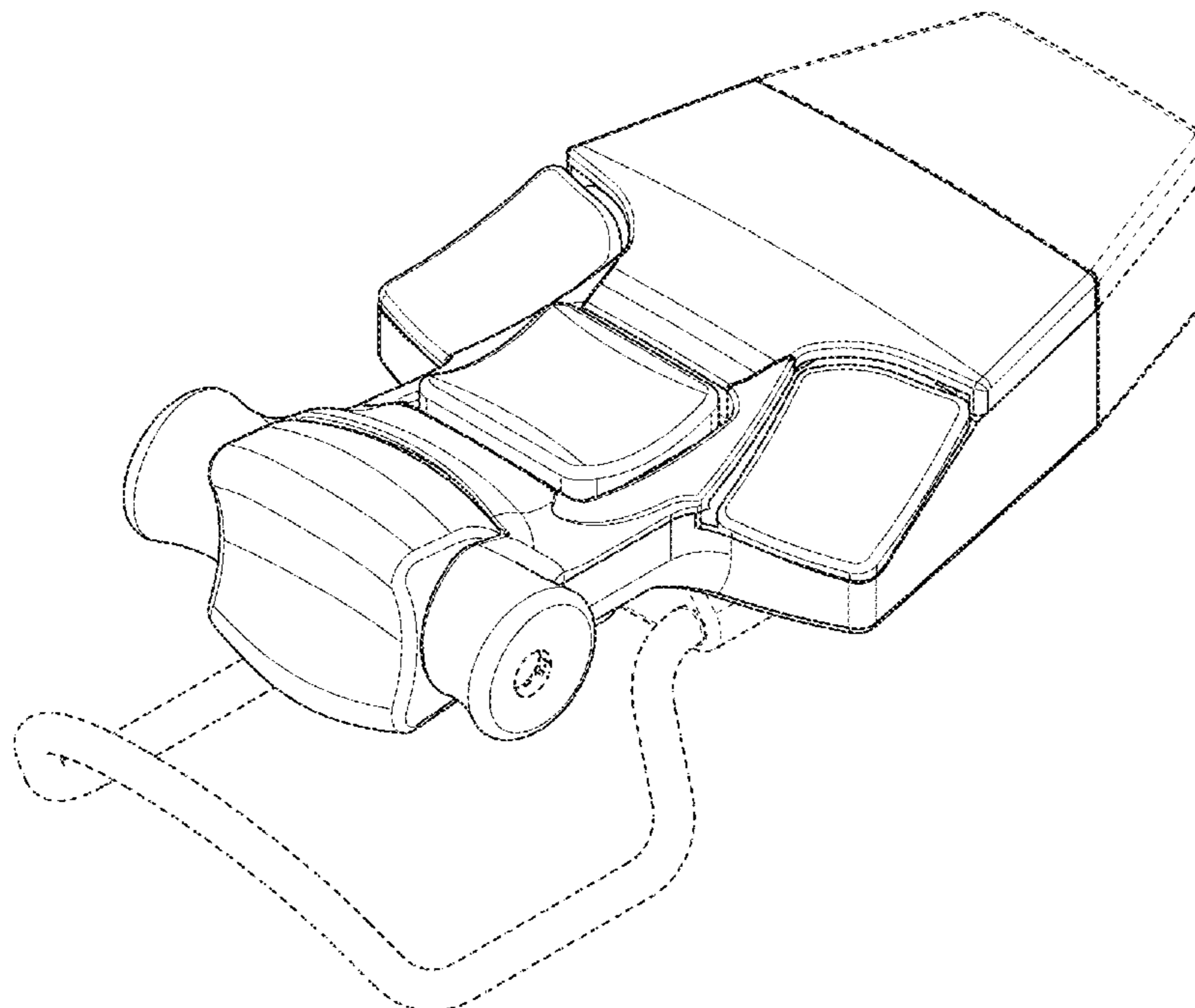
FIG. 1 is a front perspective view of an embodiment of a tiller control, showing my new design;

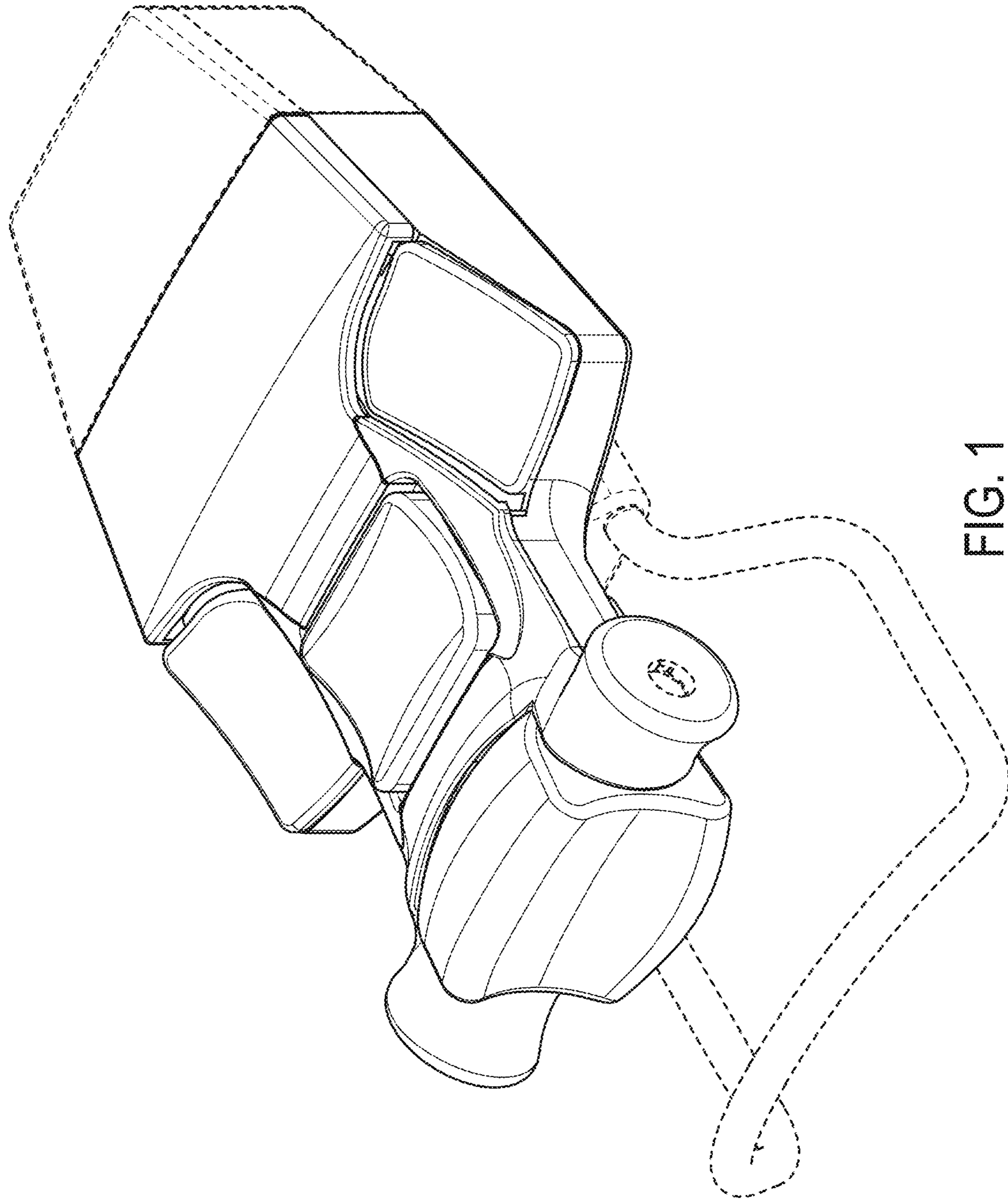

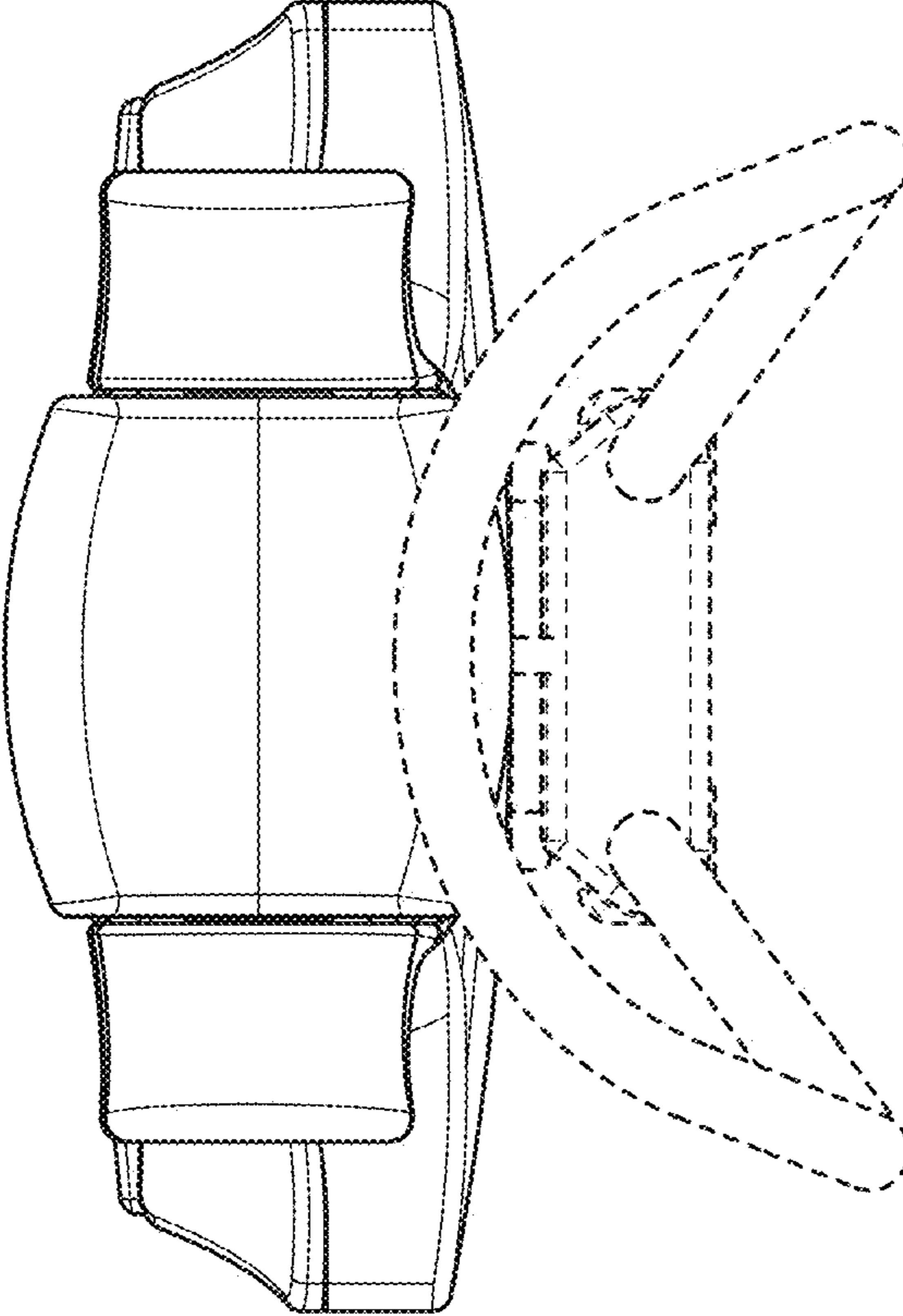

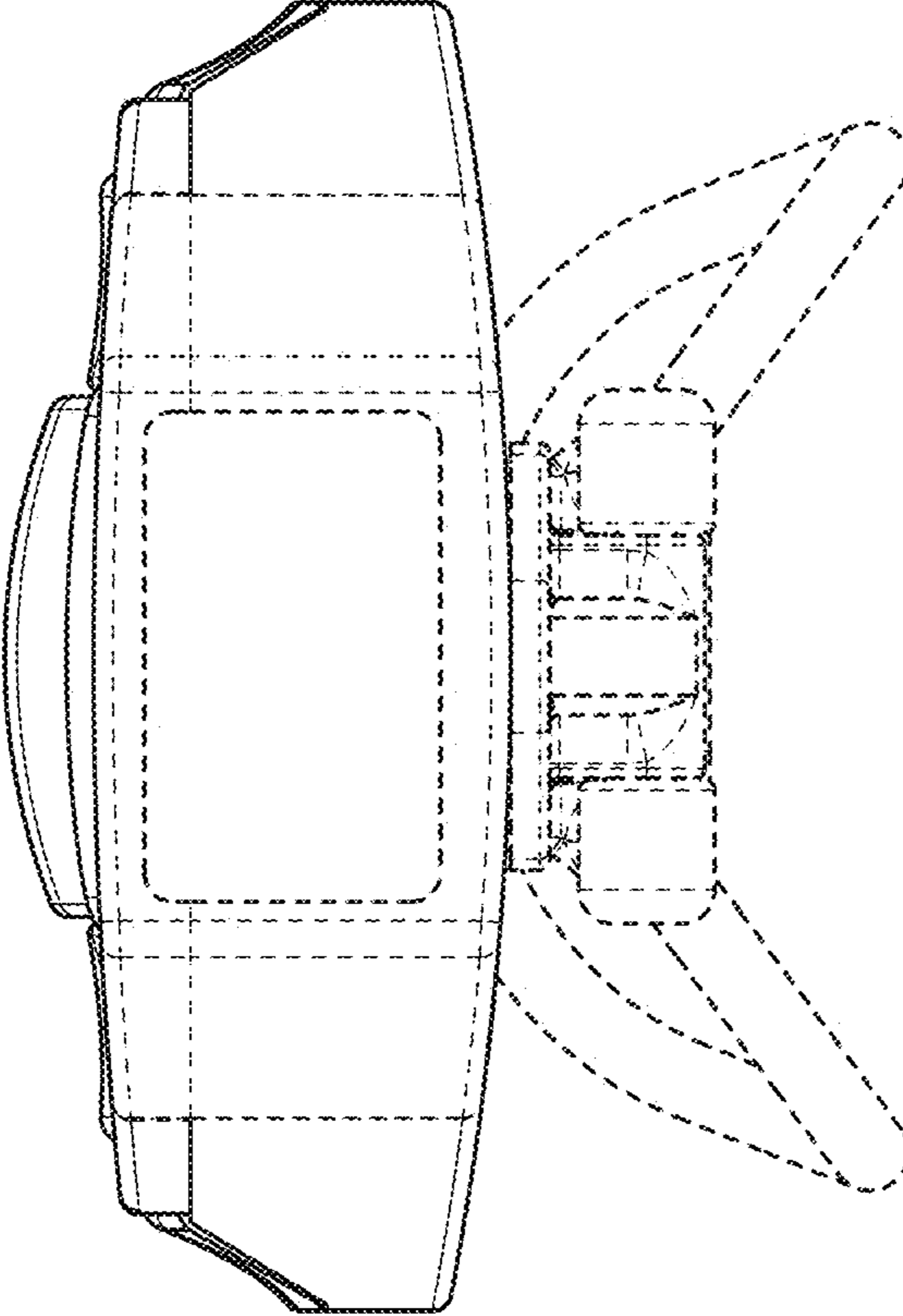

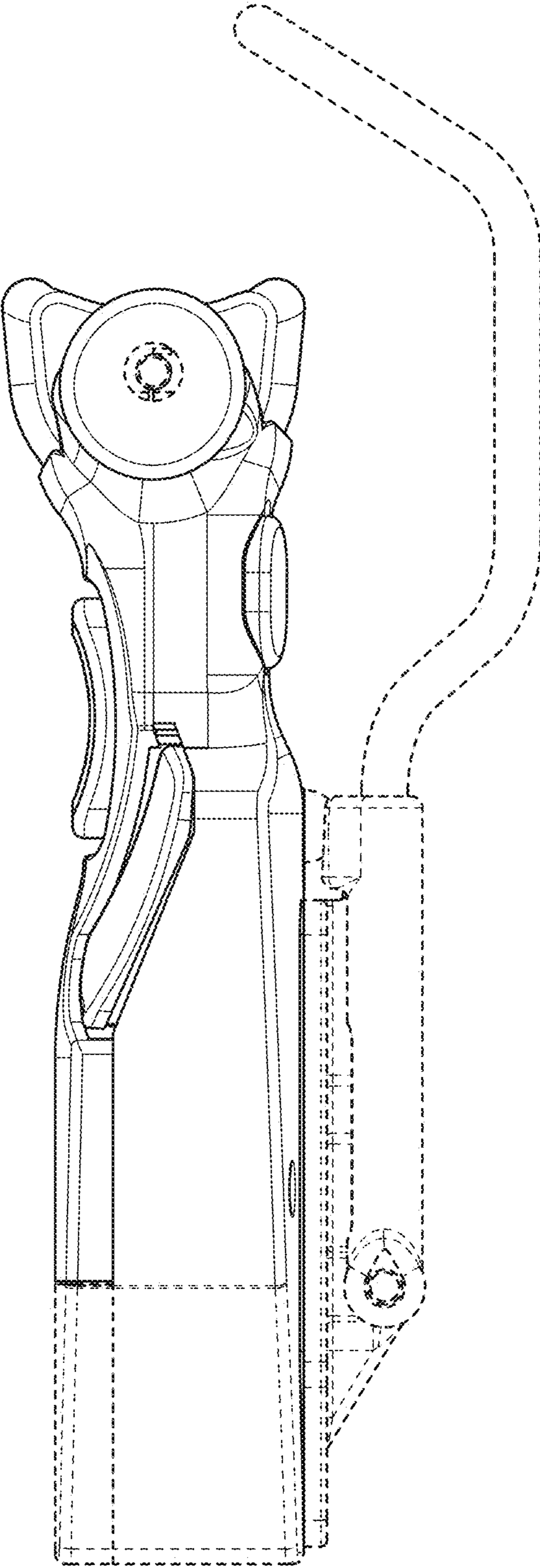

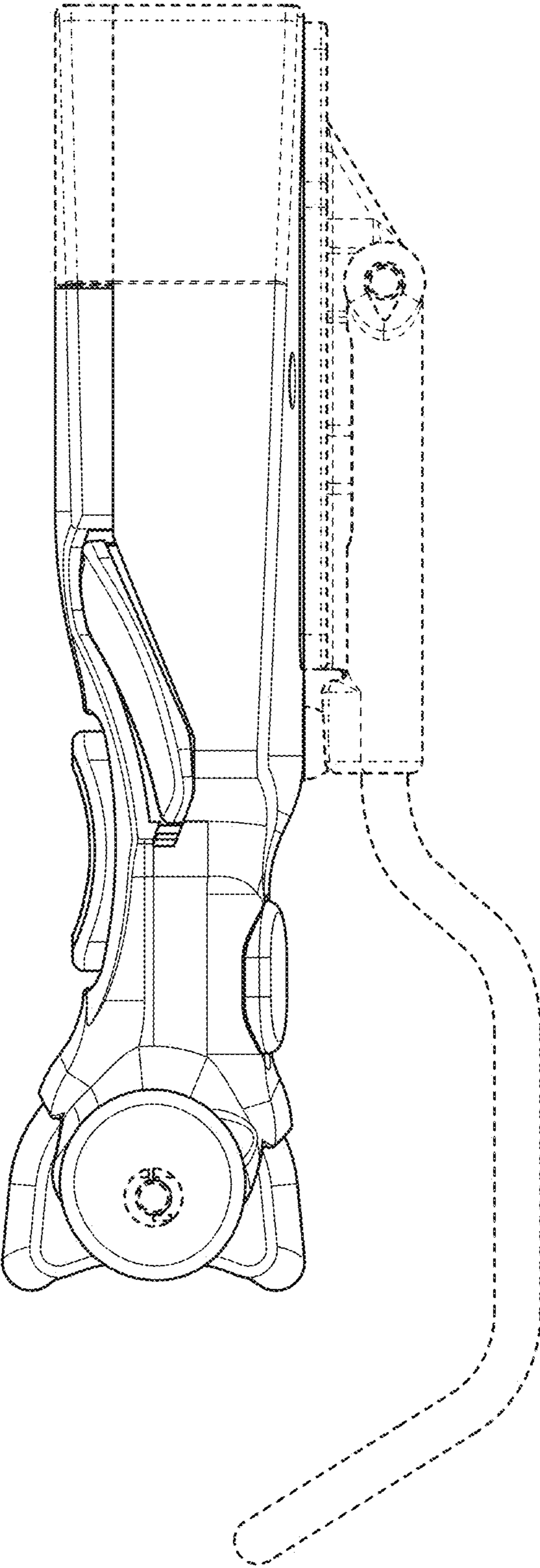

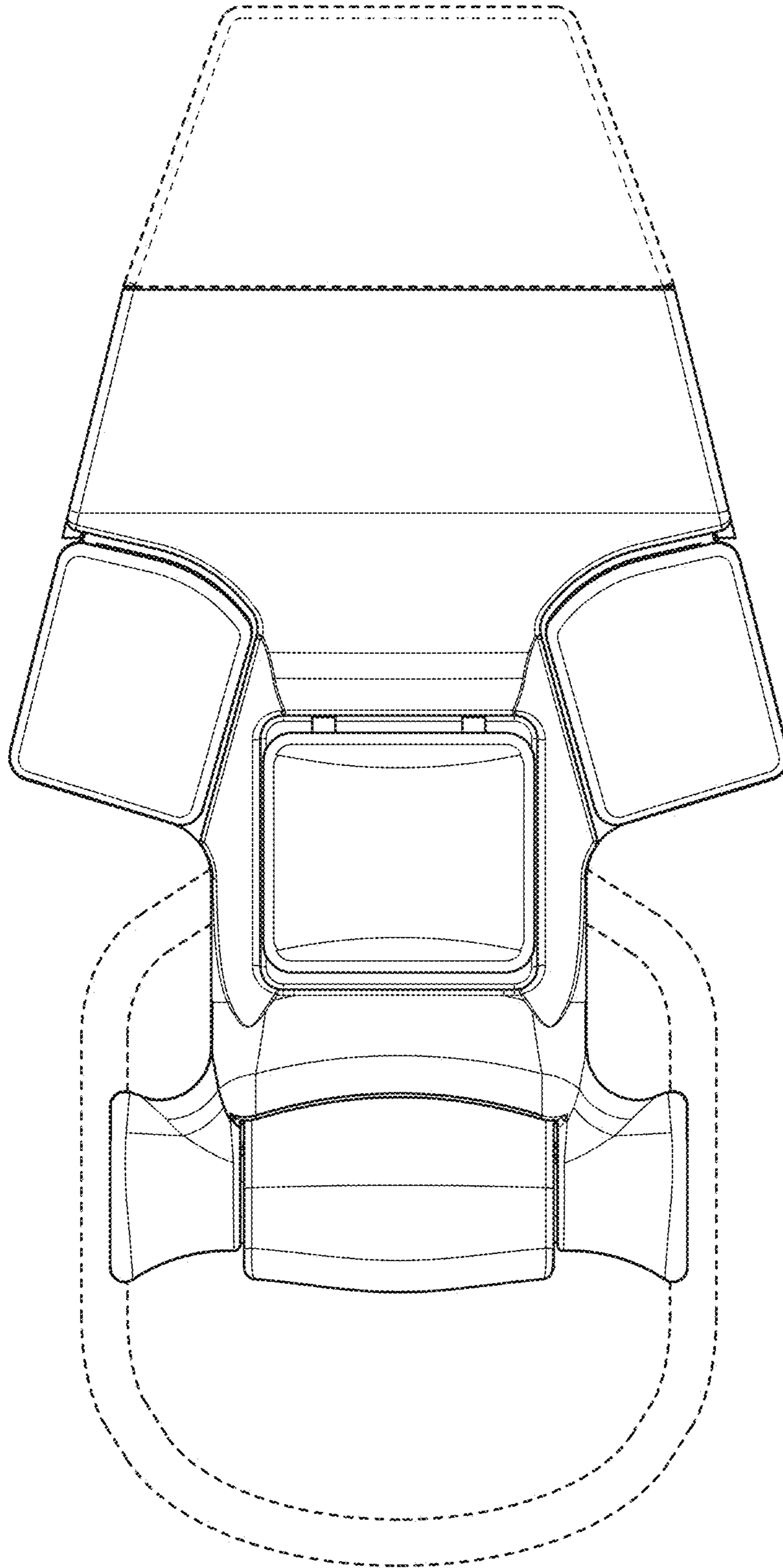

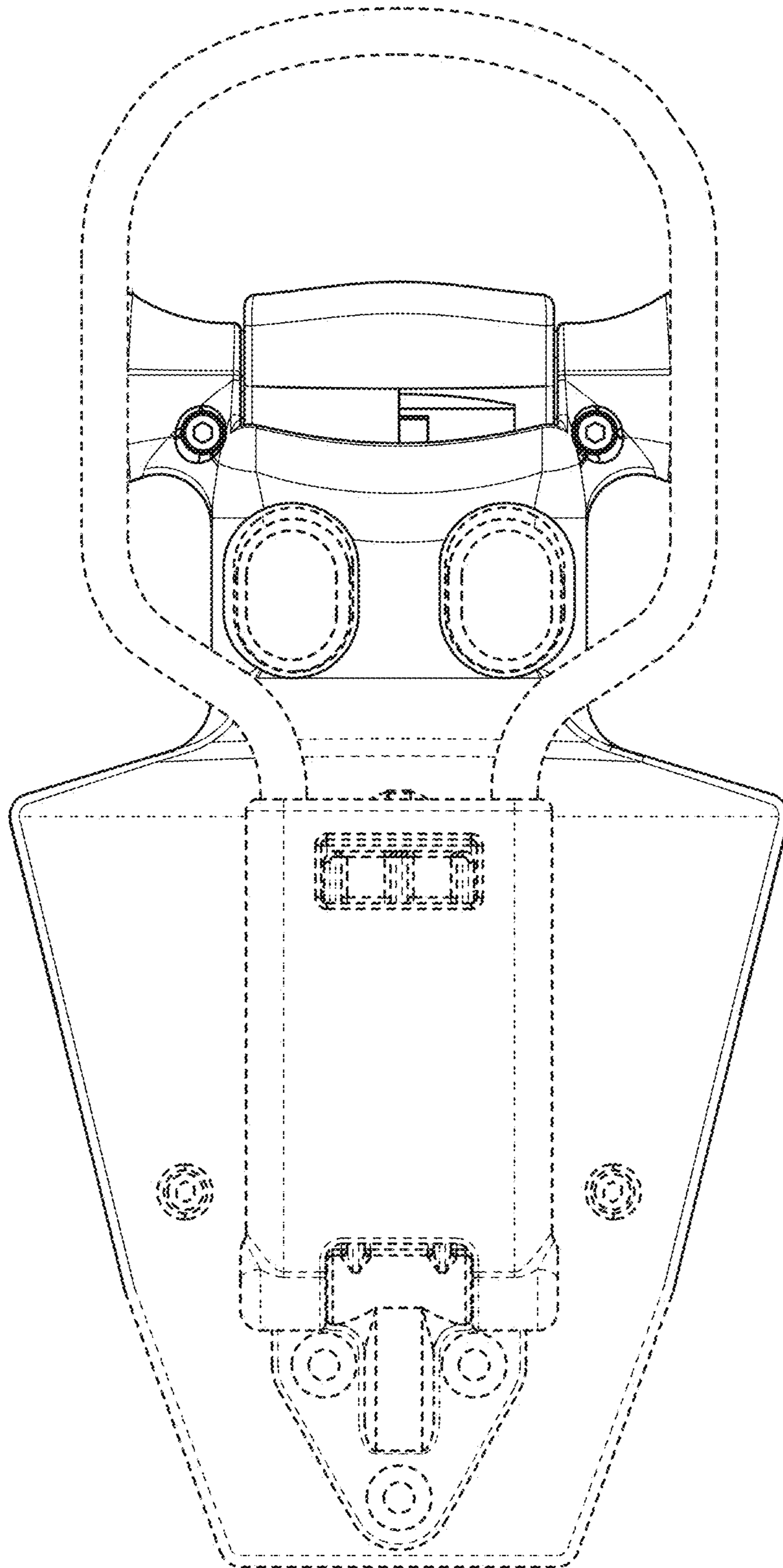
