DESCRIPTION

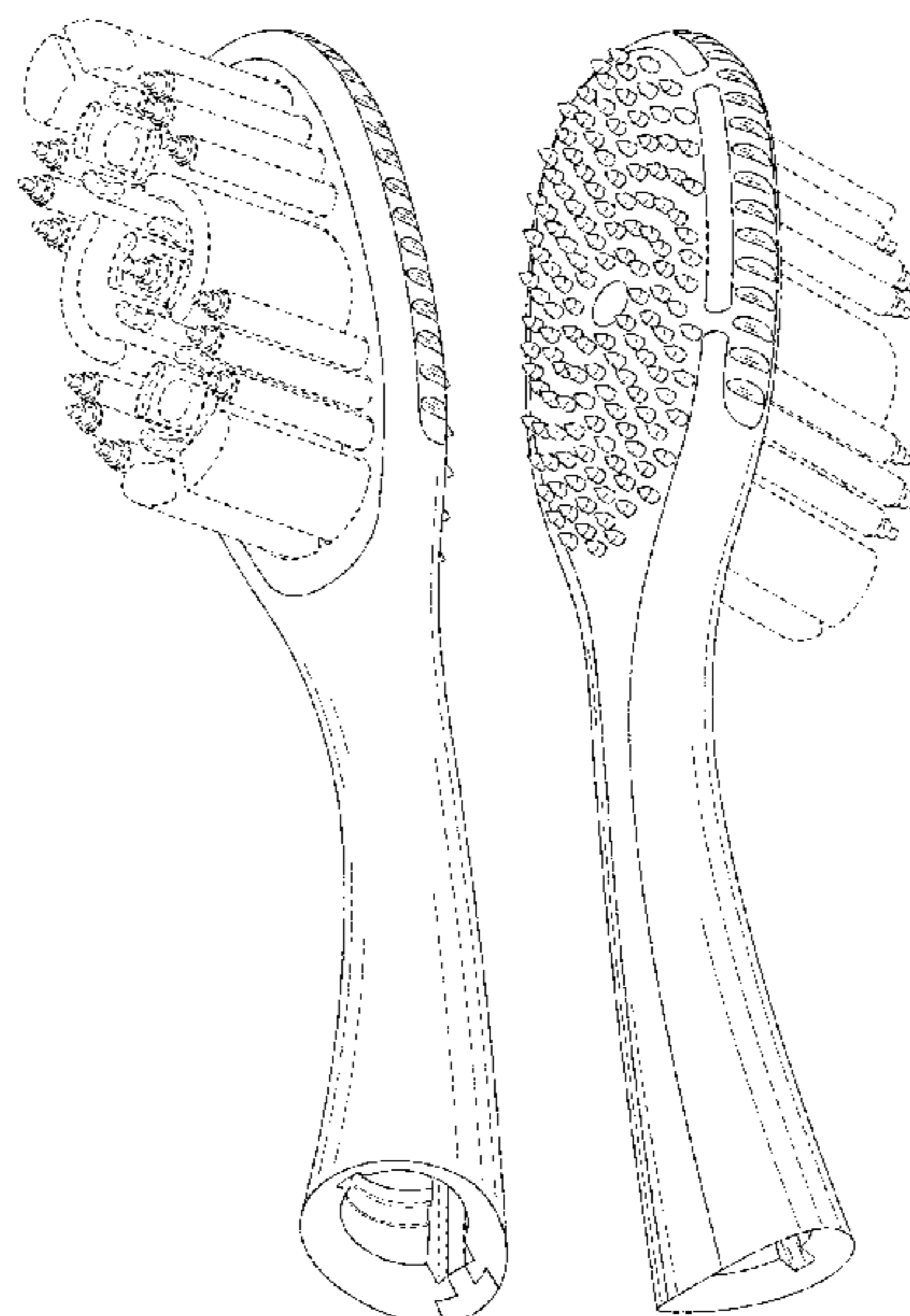
FIG. 1 is a top, front and left side perspective view of a refill head for a toothbrush according to an embodiment of the new design;

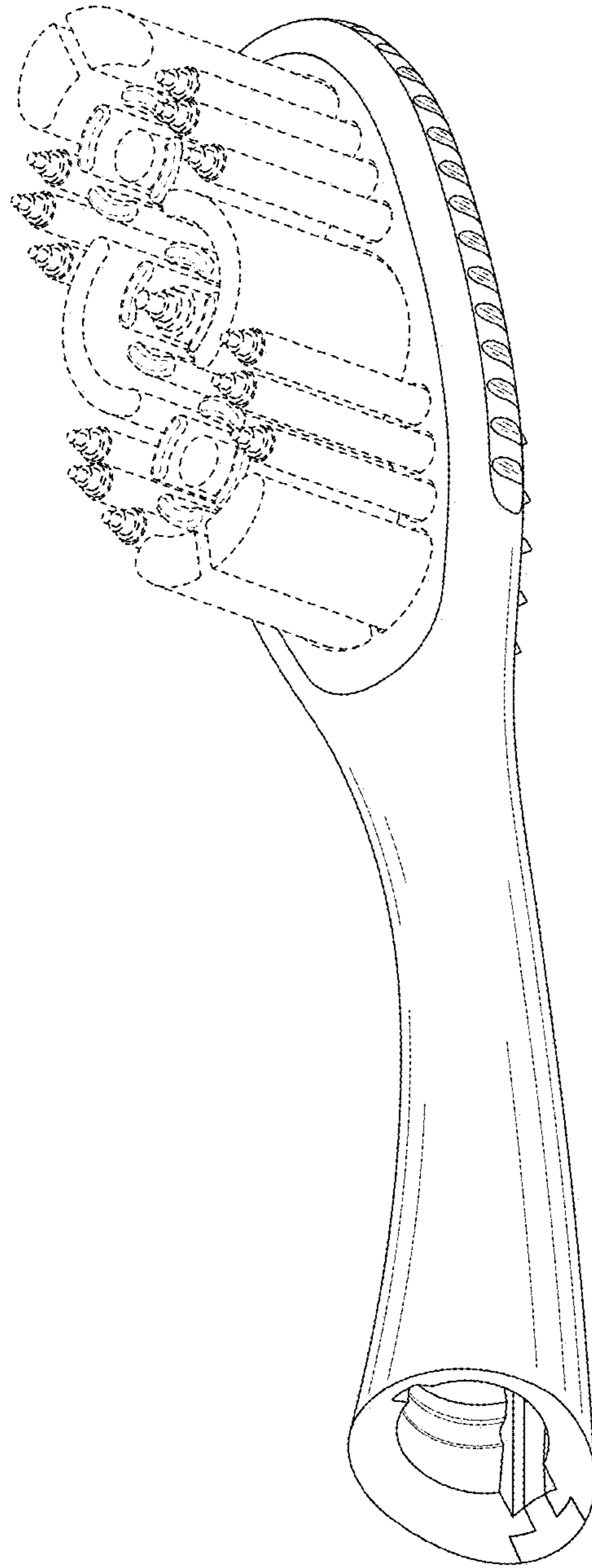

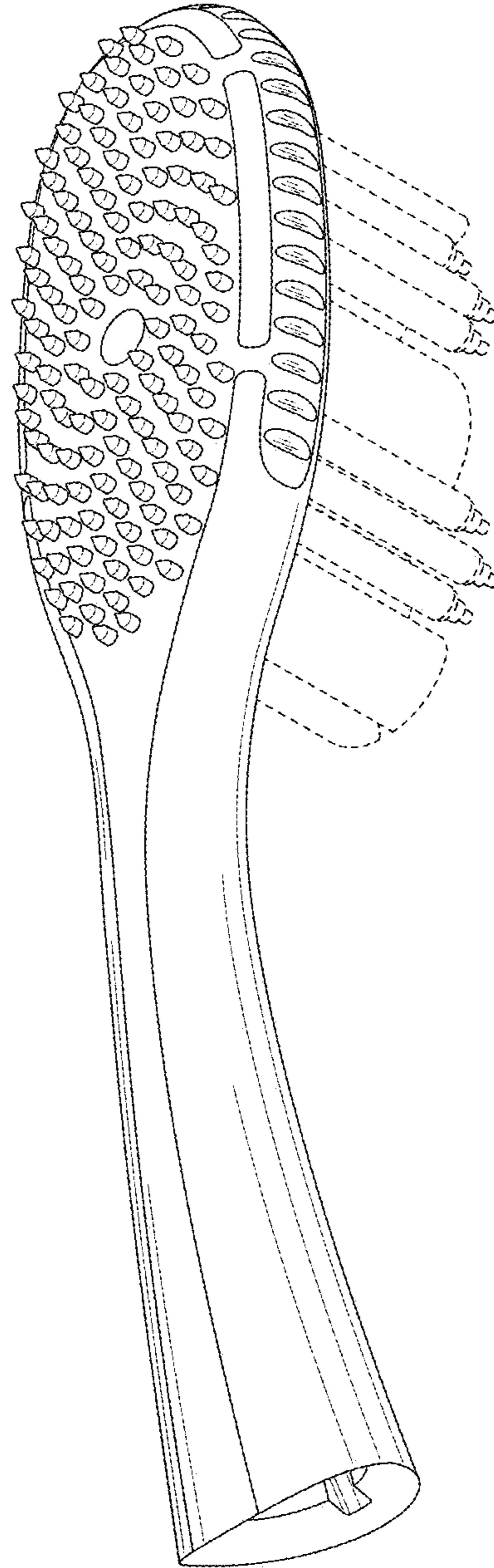

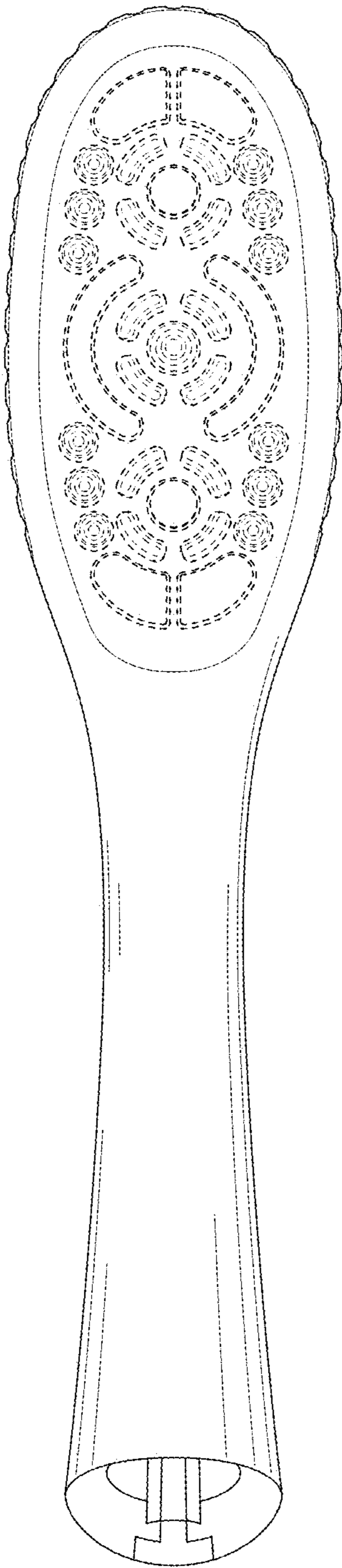

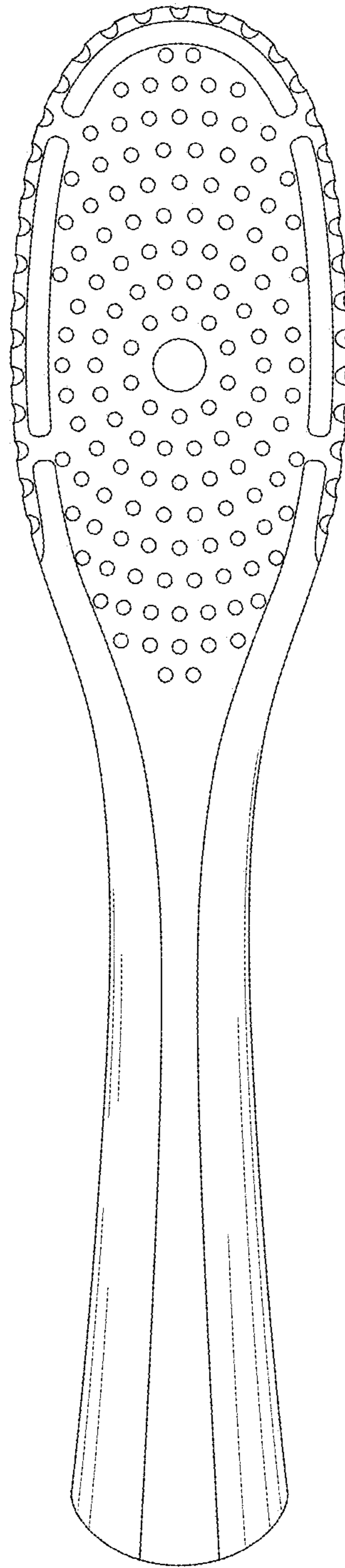

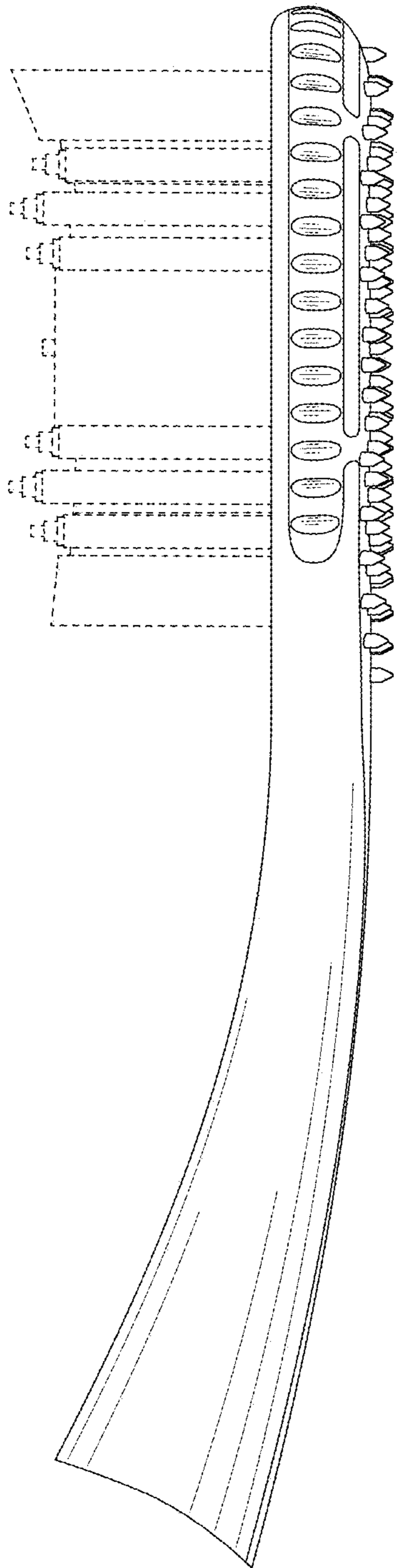

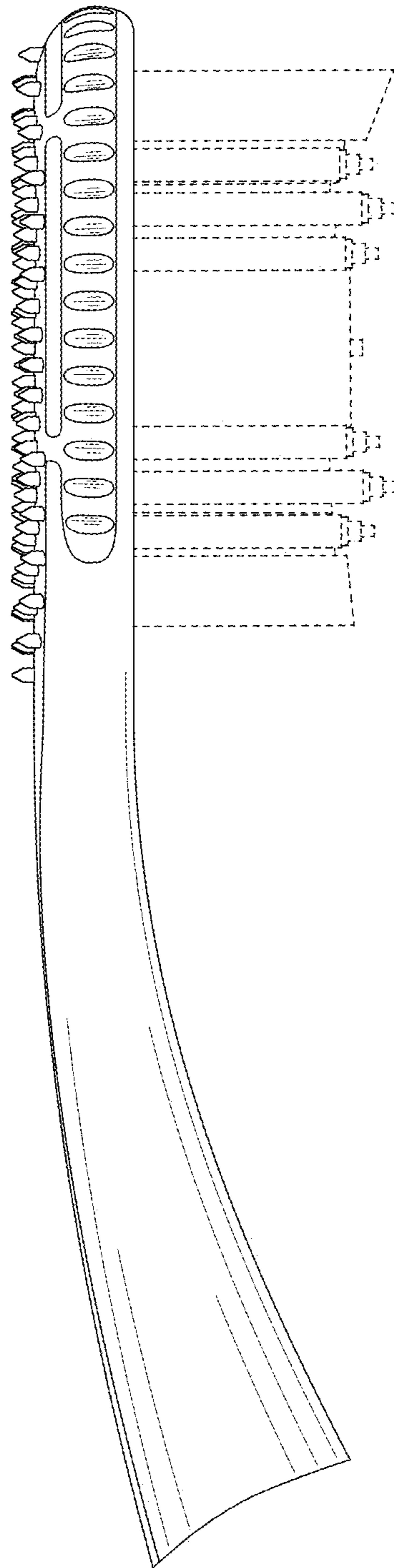

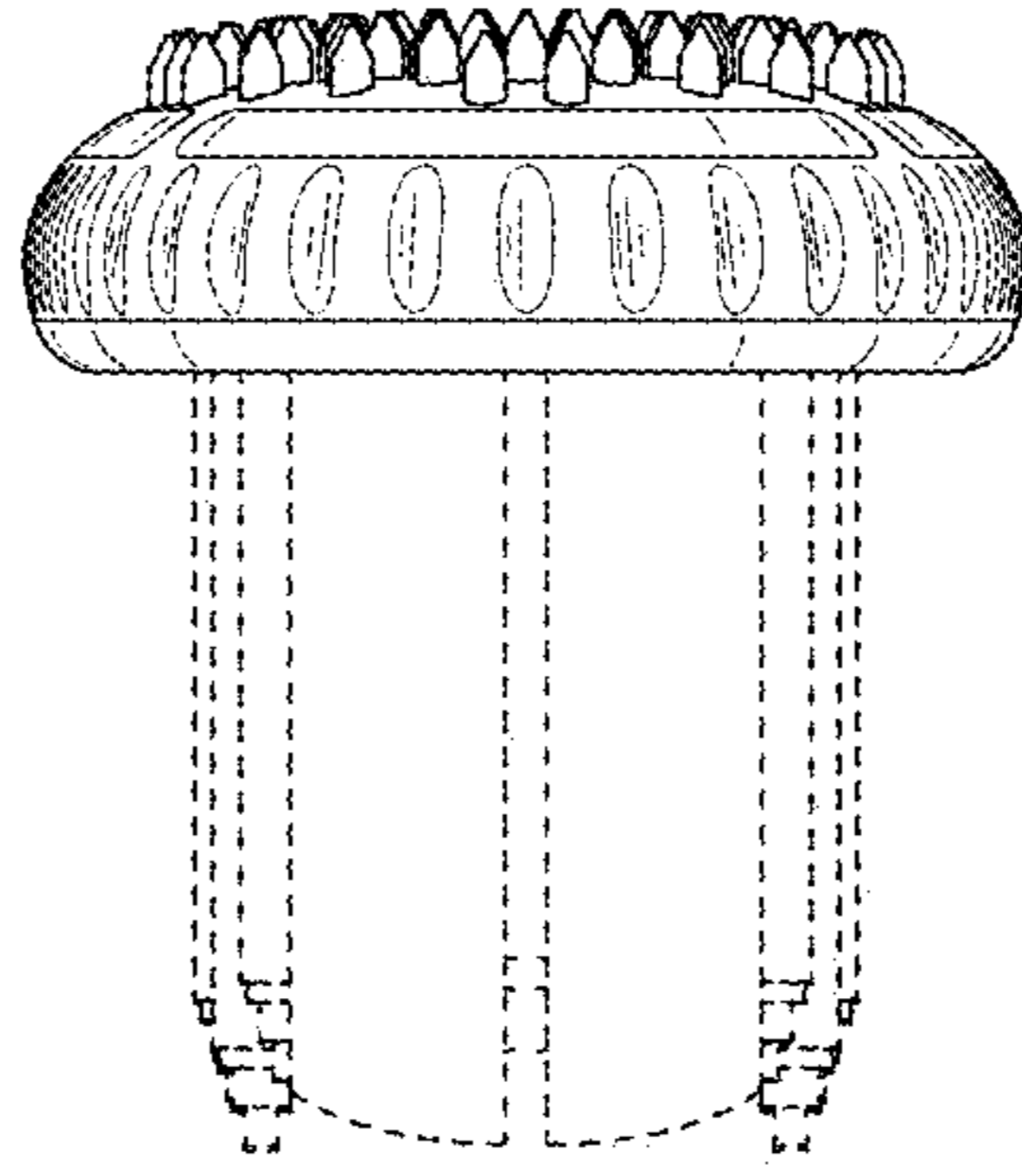

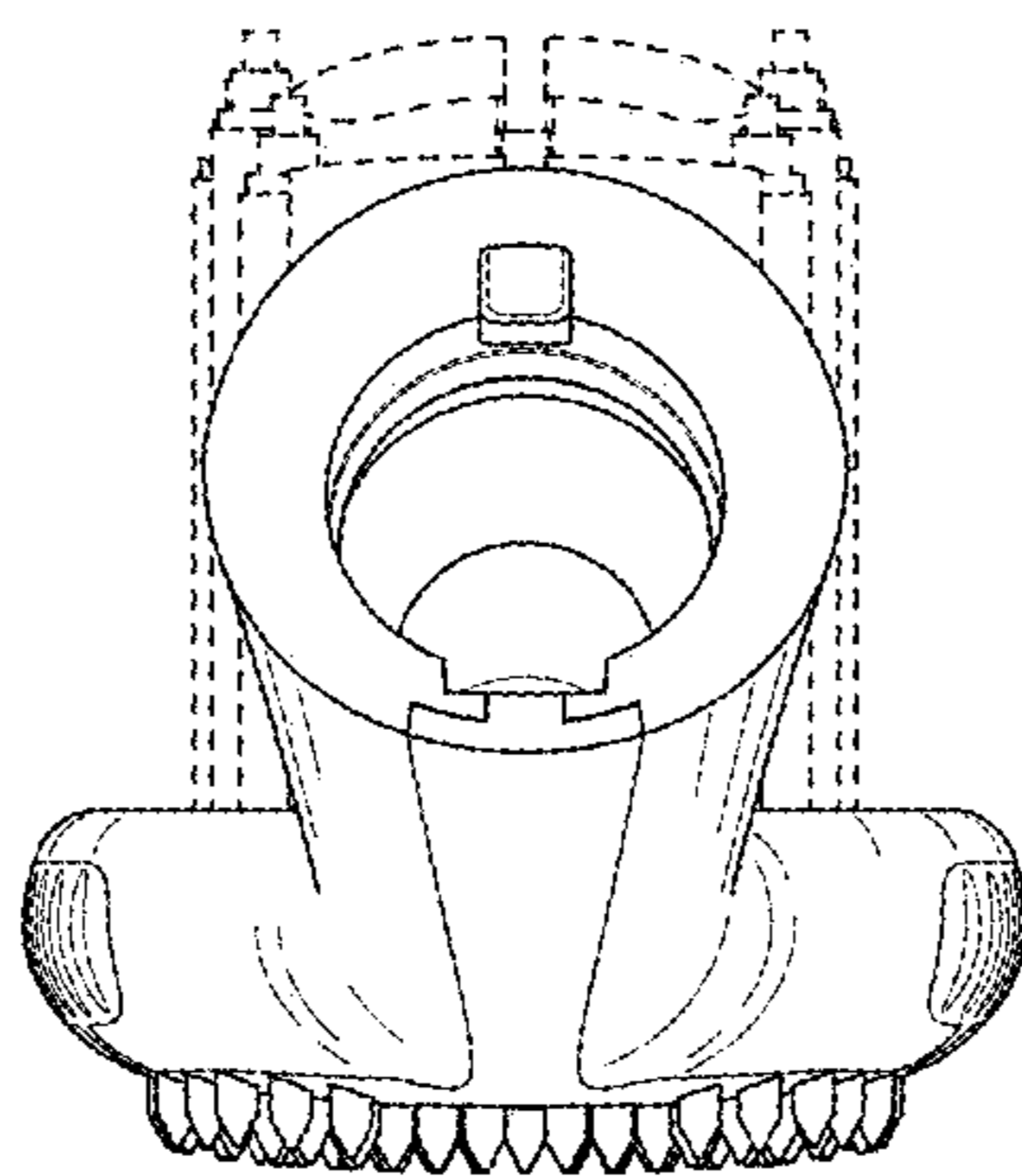
