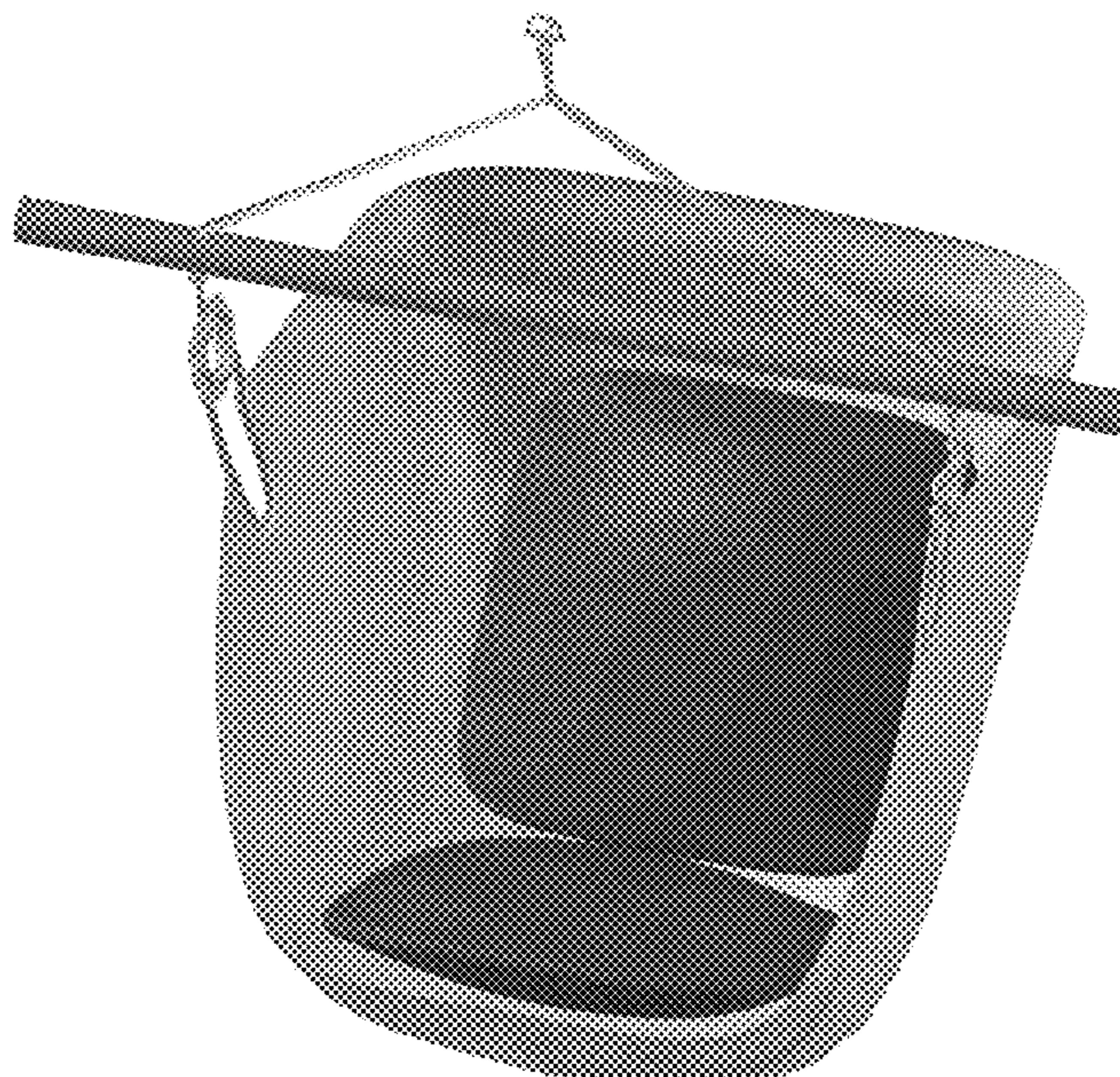
The ornamental design for a hammock chair, as shown and described.

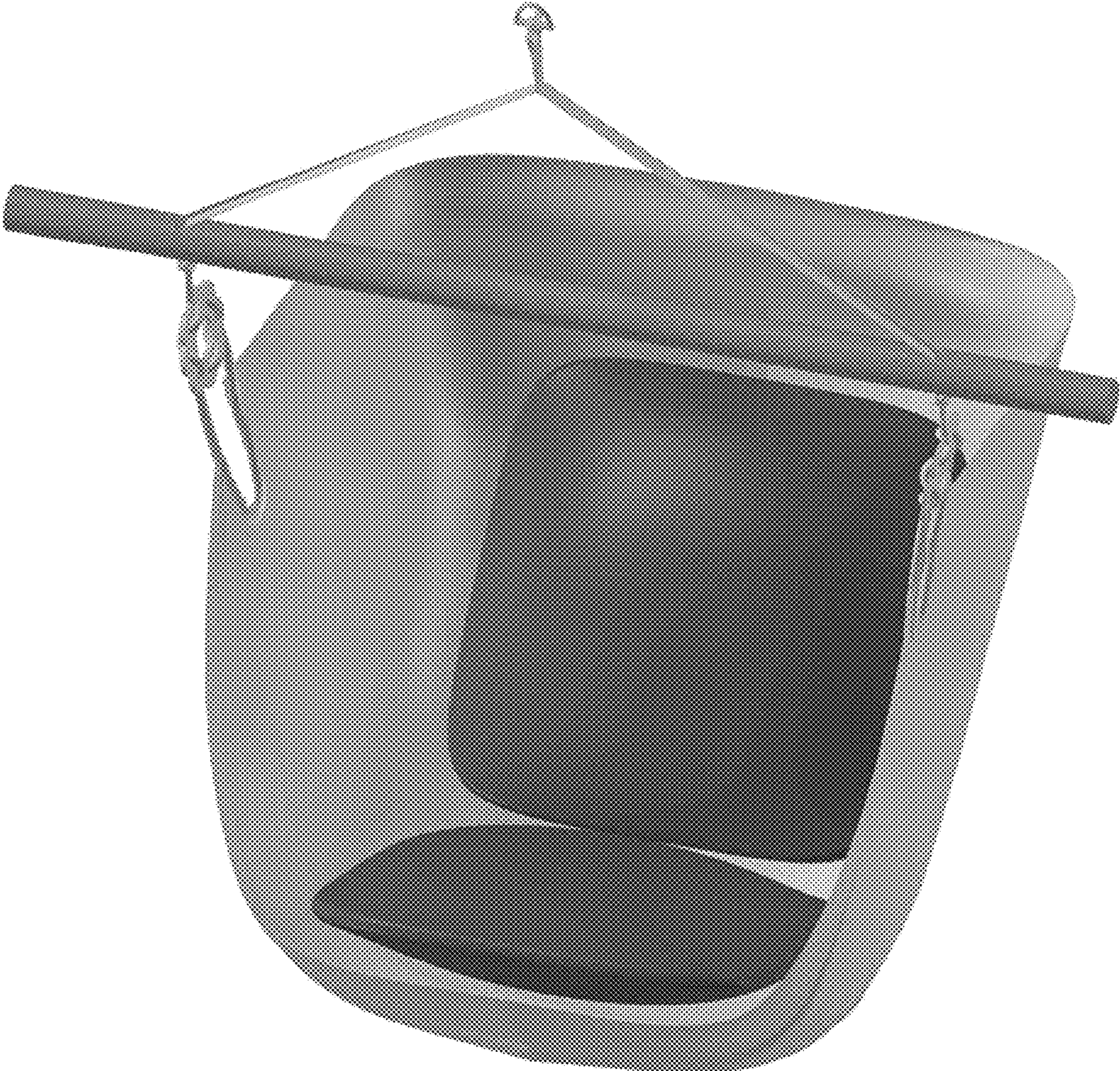

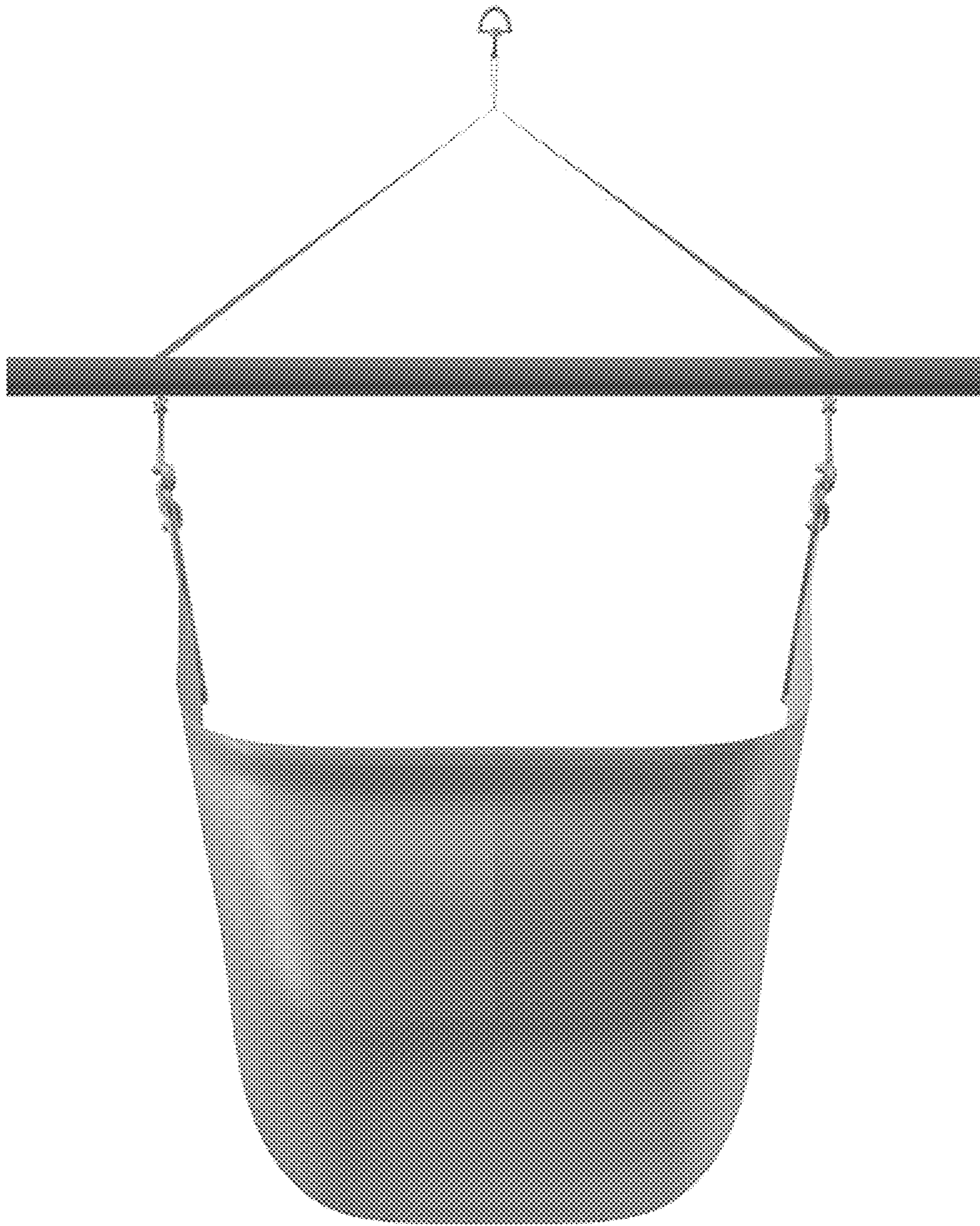

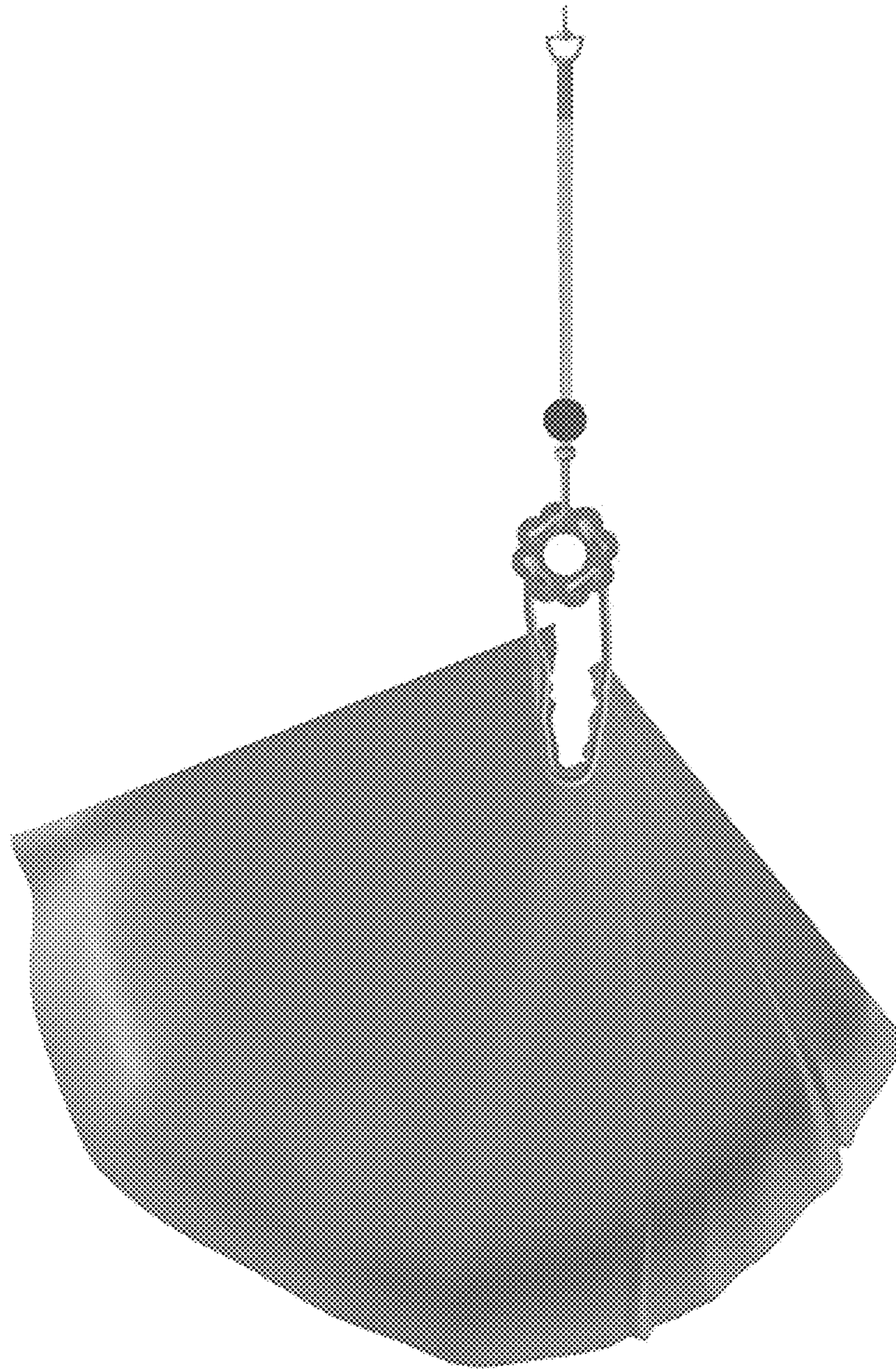

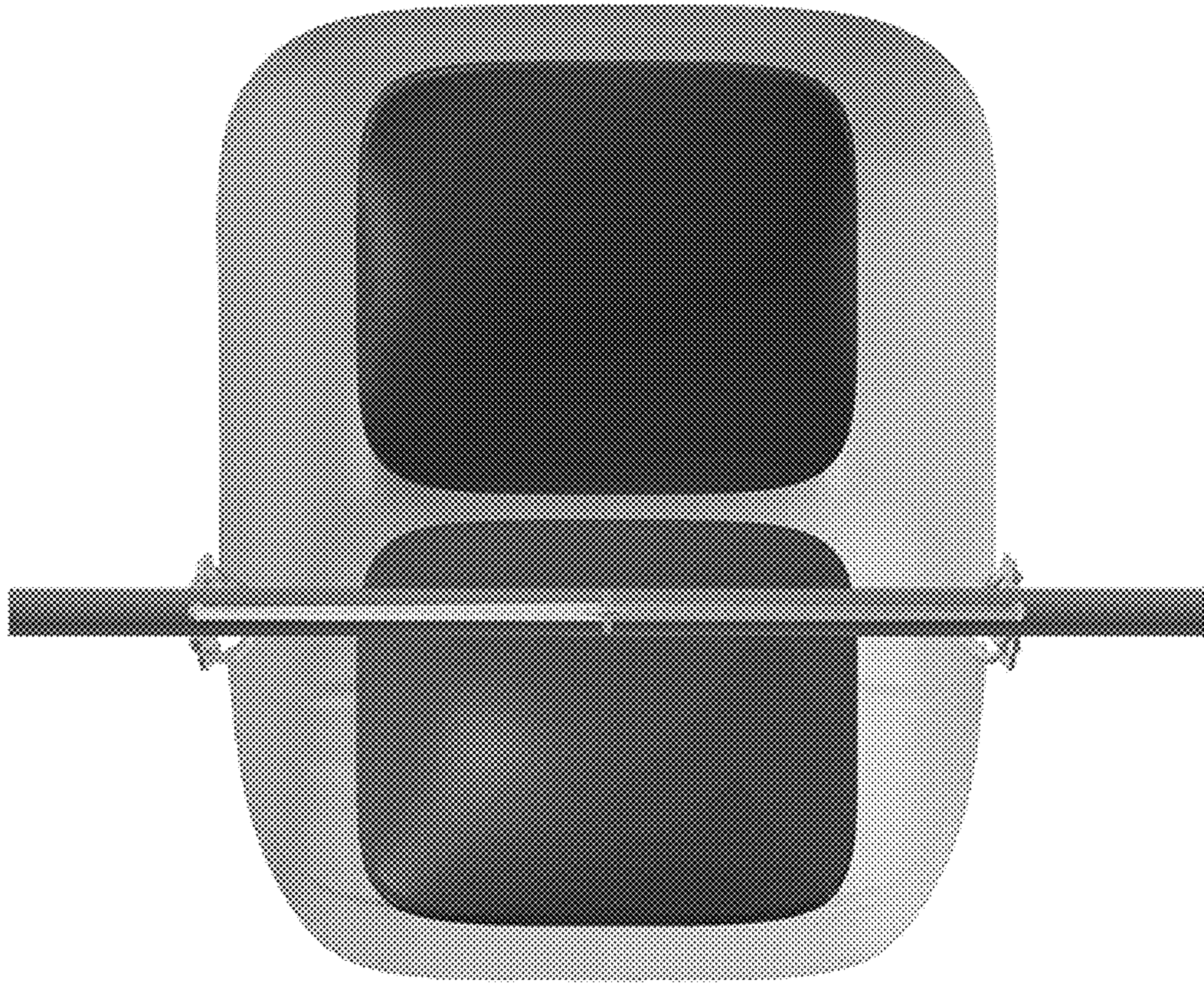
