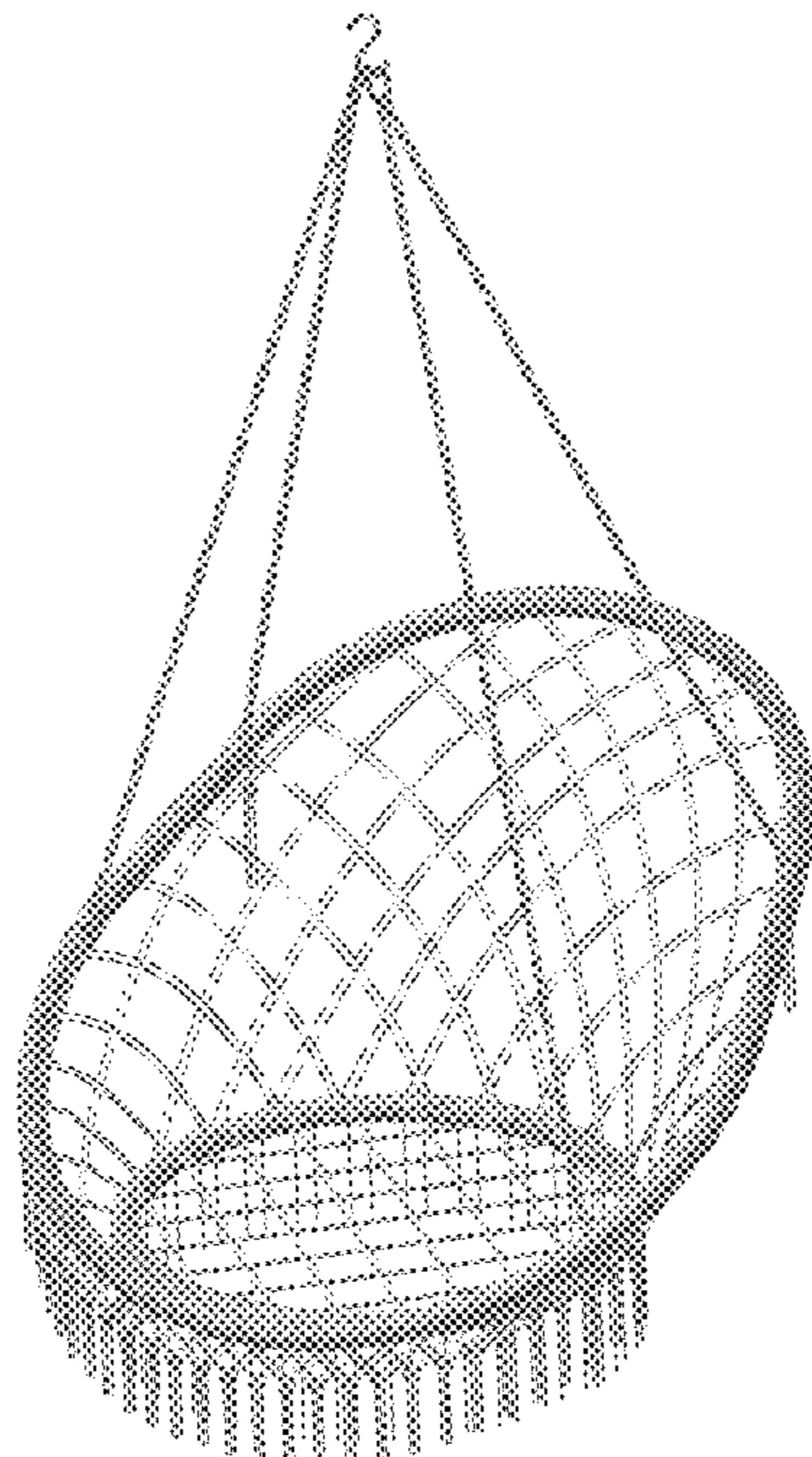
(57) **CLAIM**

The ornamental design for a swinging chair, as shown and described.

DESCRIPTION

FIG. 1 is a front, right and top perspective view of a swinging chair, showing my design.
FIG. 2 is a front elevation view thereof.
FIG. 3 is a rear elevation view thereof.
FIG. 4 is a left side elevation view thereof.
FIG. 5 is a right side elevation view thereof.
FIG. 6 is a top plan view thereof.
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a partial enlarged view of an area labeled 8 in FIG. 2.
The dot-dash broken lines in FIGS. 2 and 8 depict the boundaries of the enlargements that form no part of the claimed design.

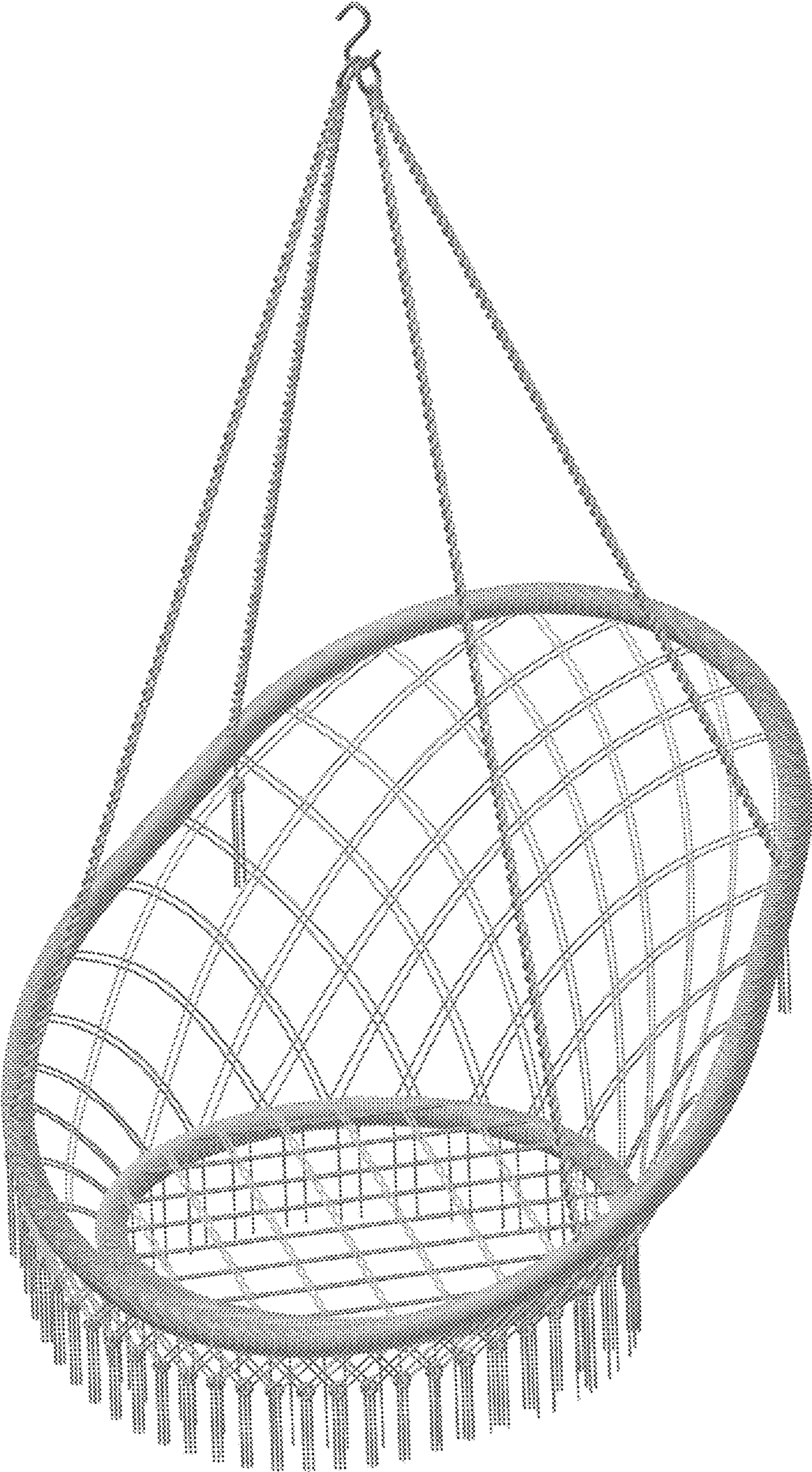

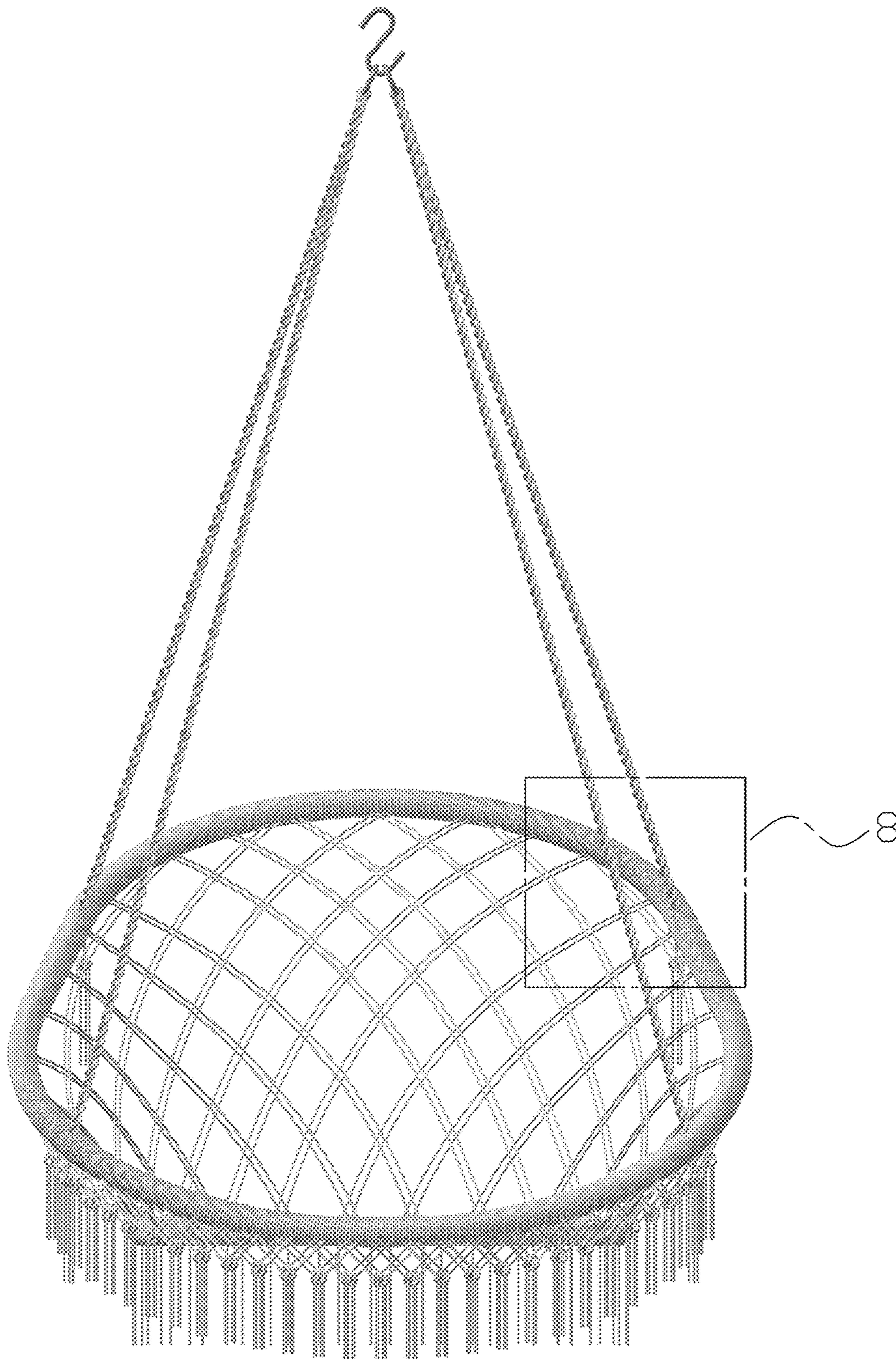

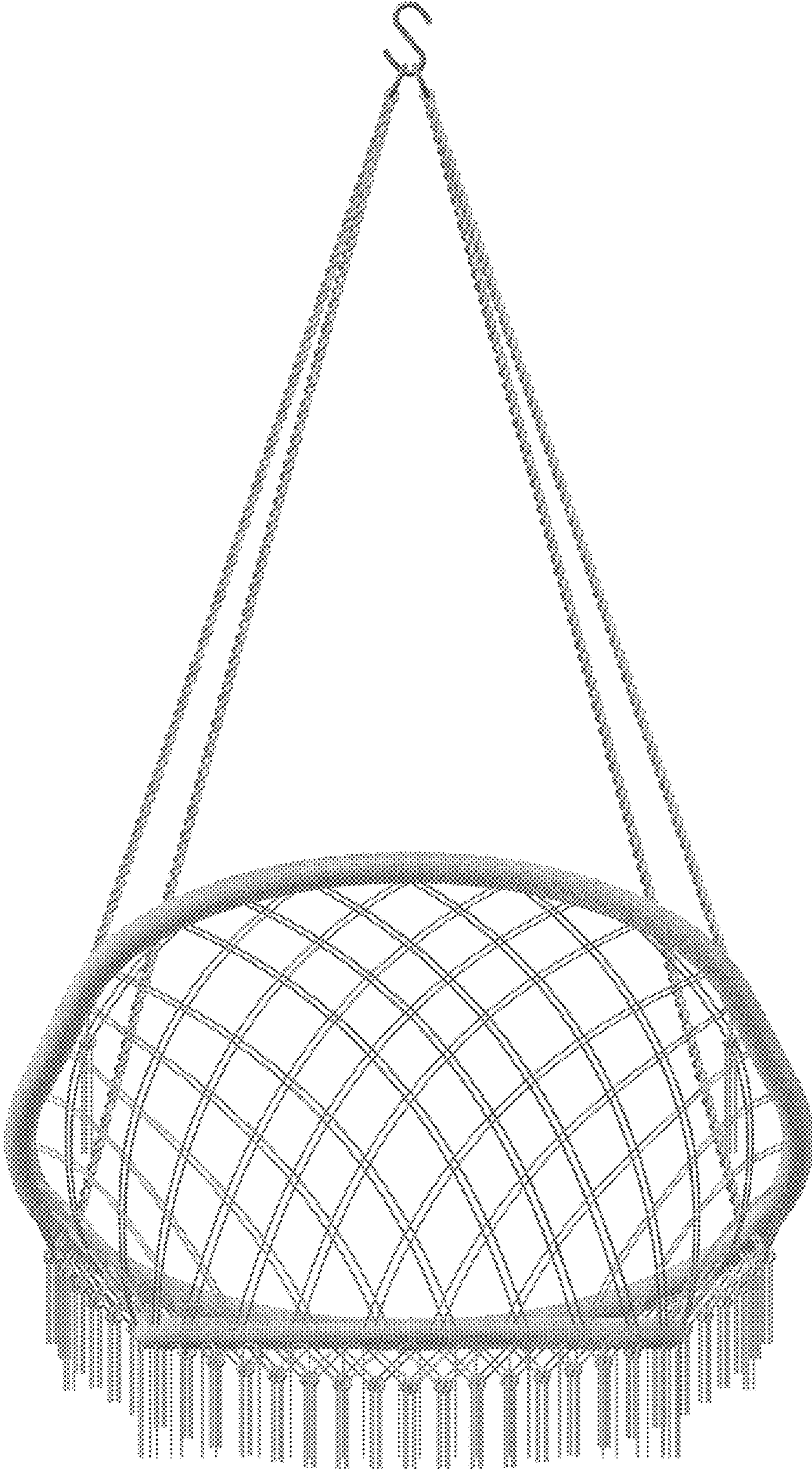

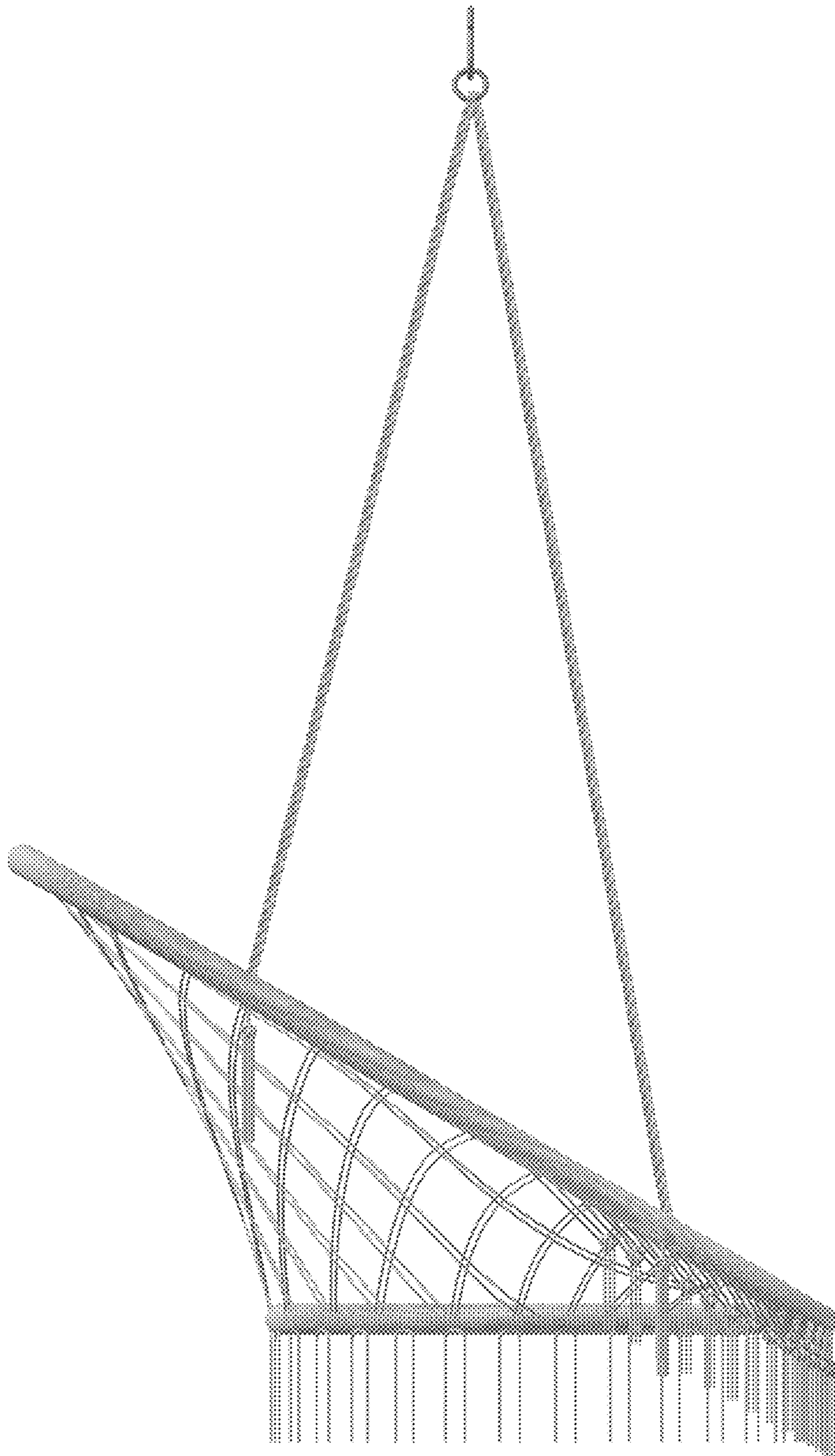

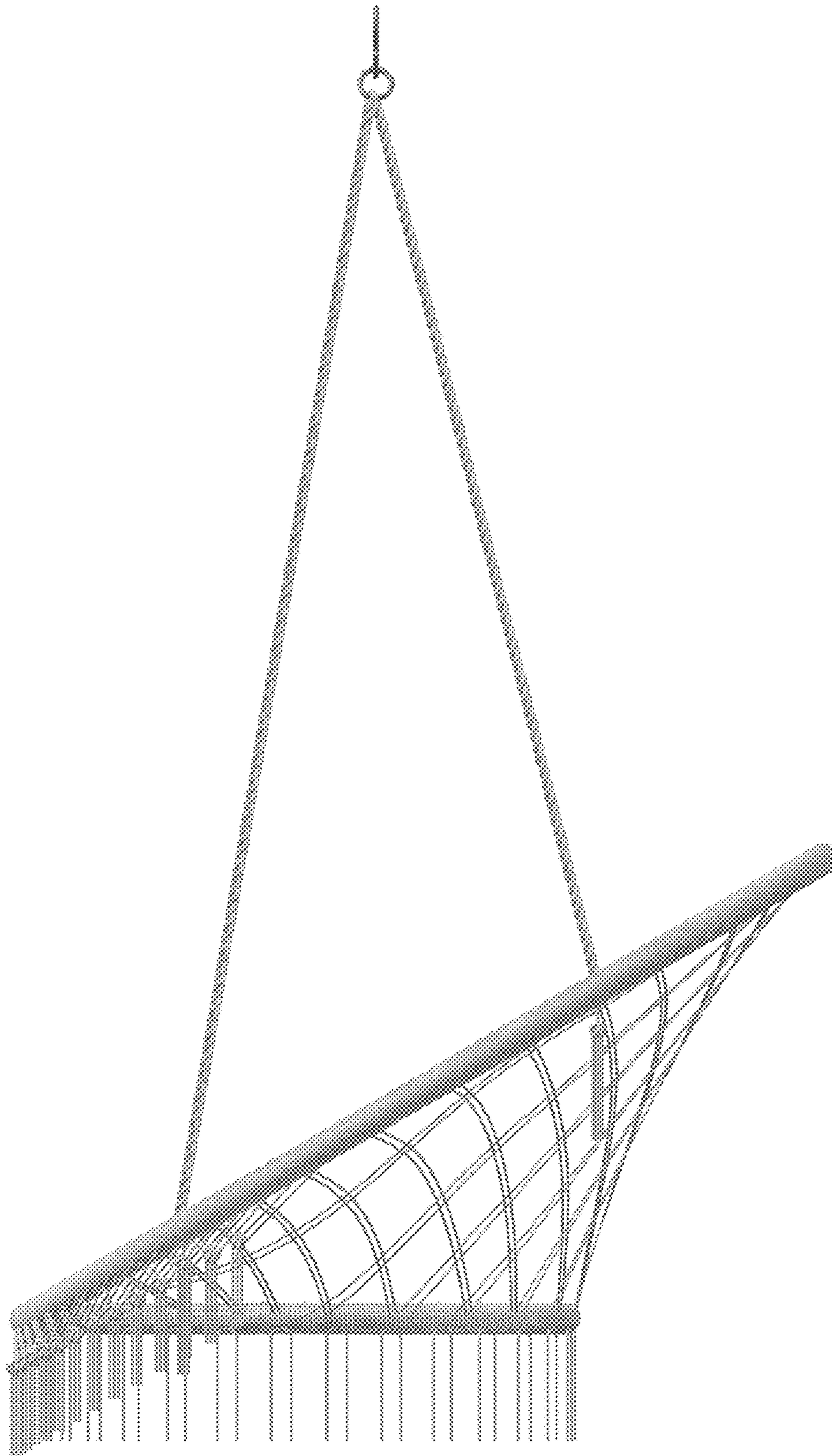

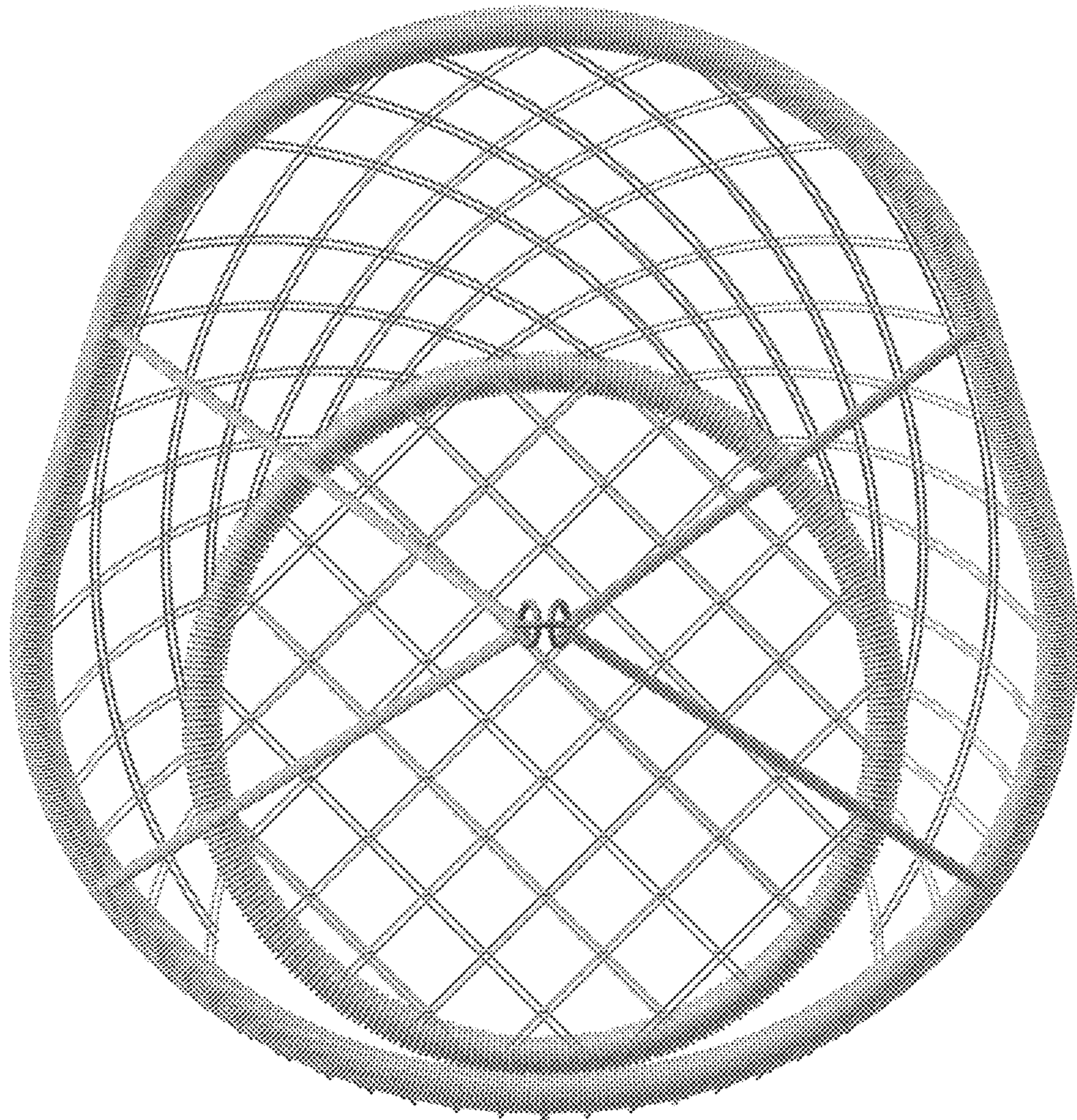

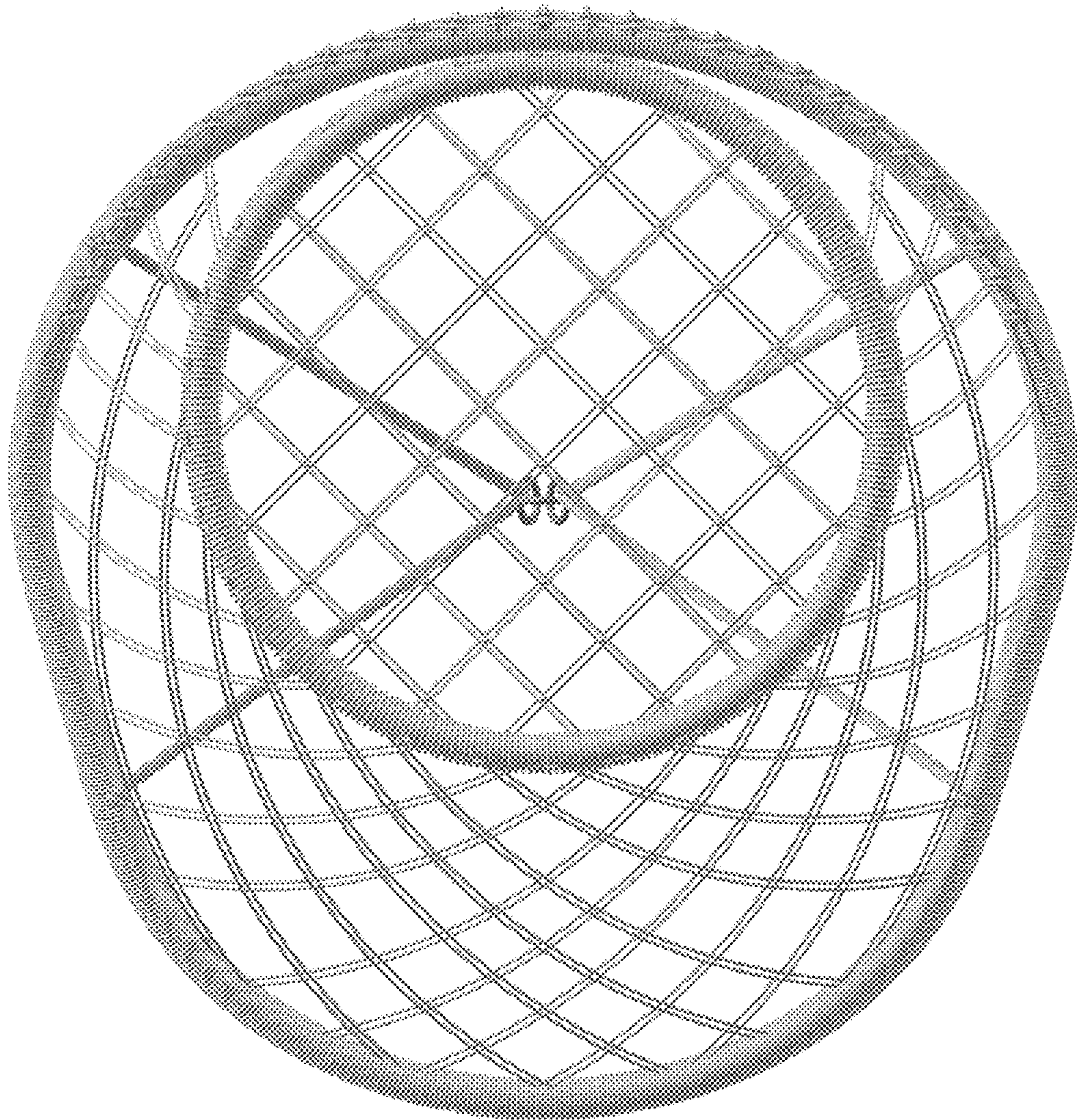

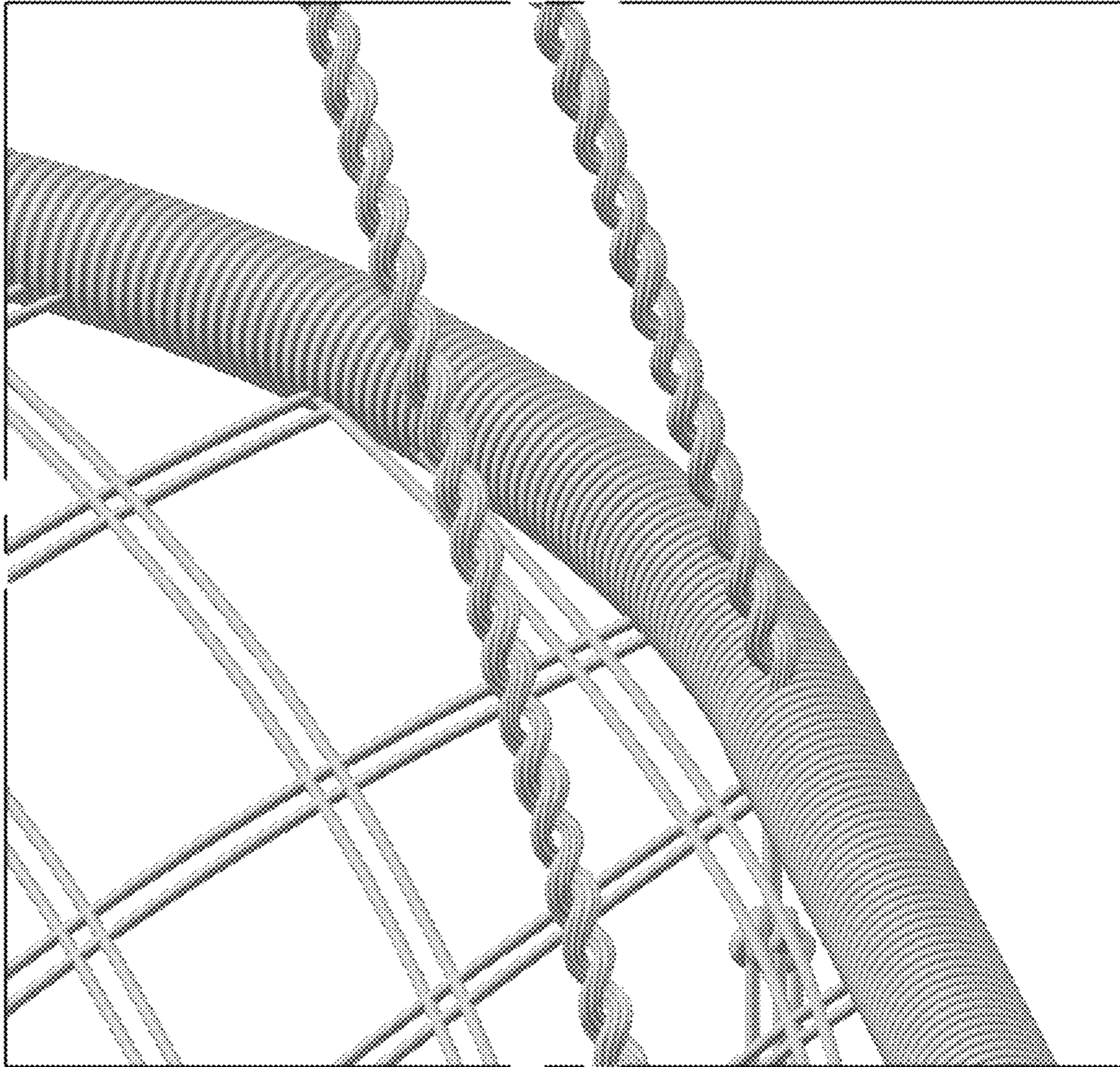
