The ornamental design for a bottle sleeve, as shown and described.

DESCRIPTION

FIG. 1 is a front, top perspective view of a bottle sleeve showing my new design;
FIG. 2 is a rear, bottom perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a back view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a top view thereof; and,
FIG. 8 is a bottom view thereof.

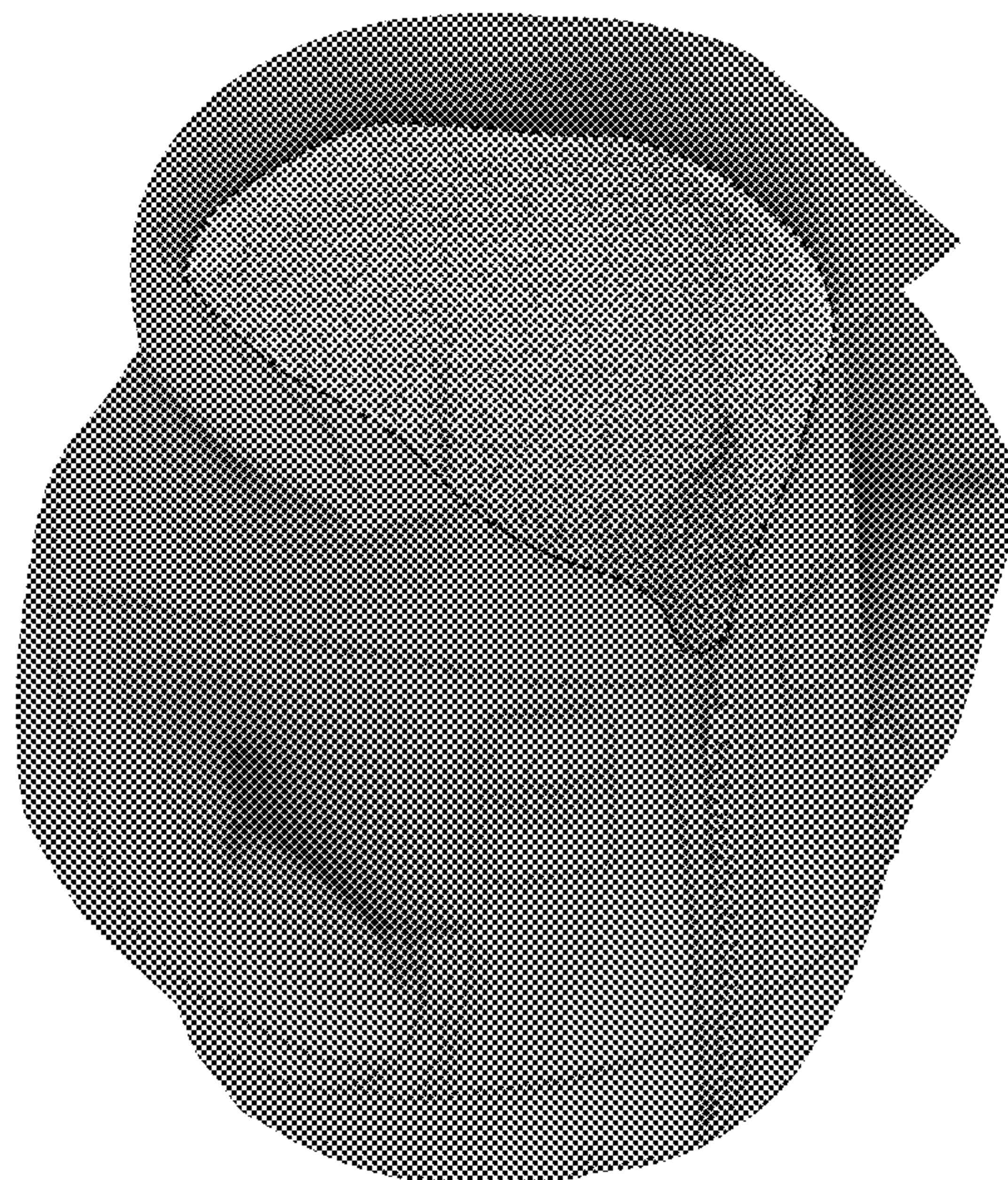

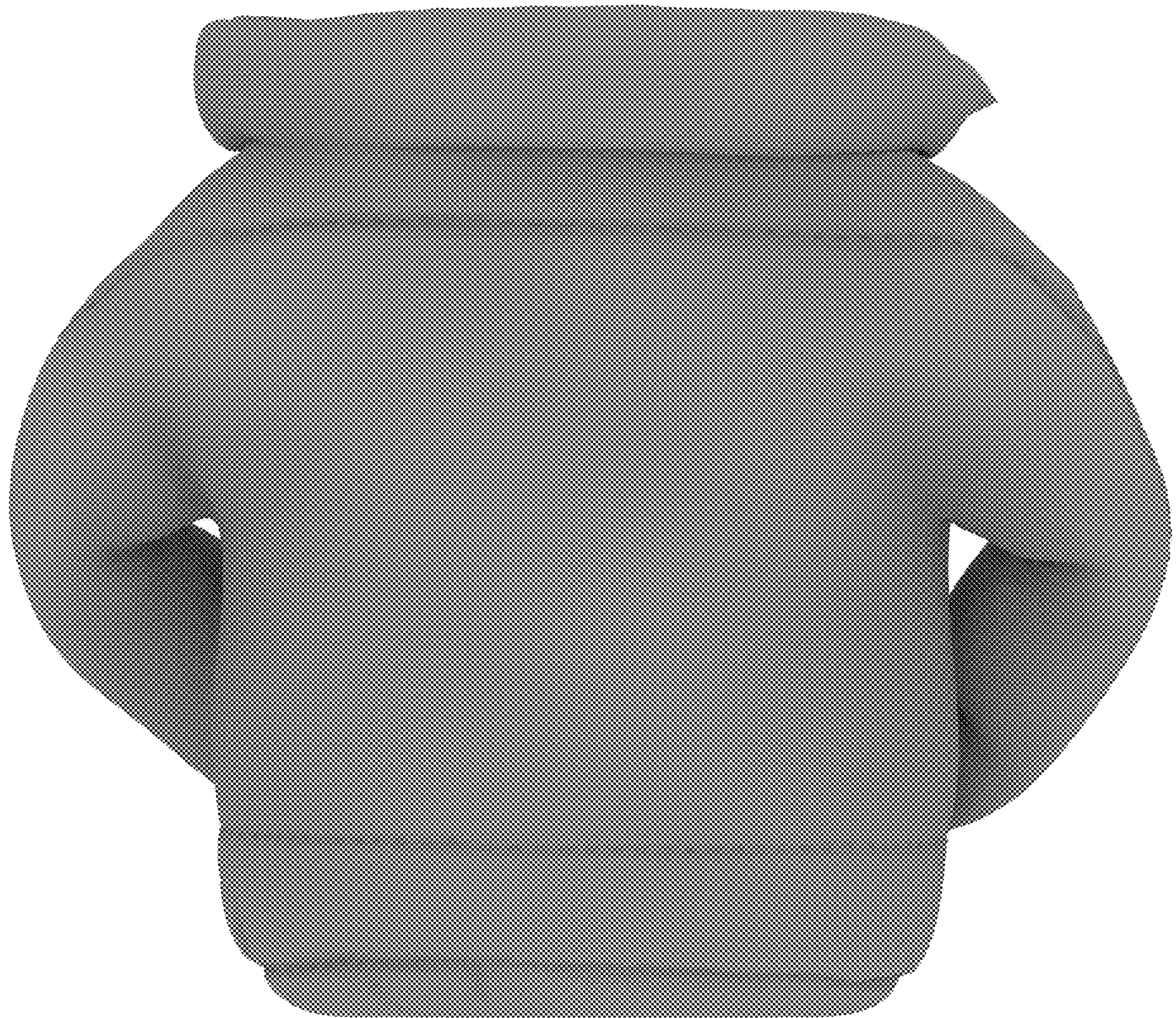

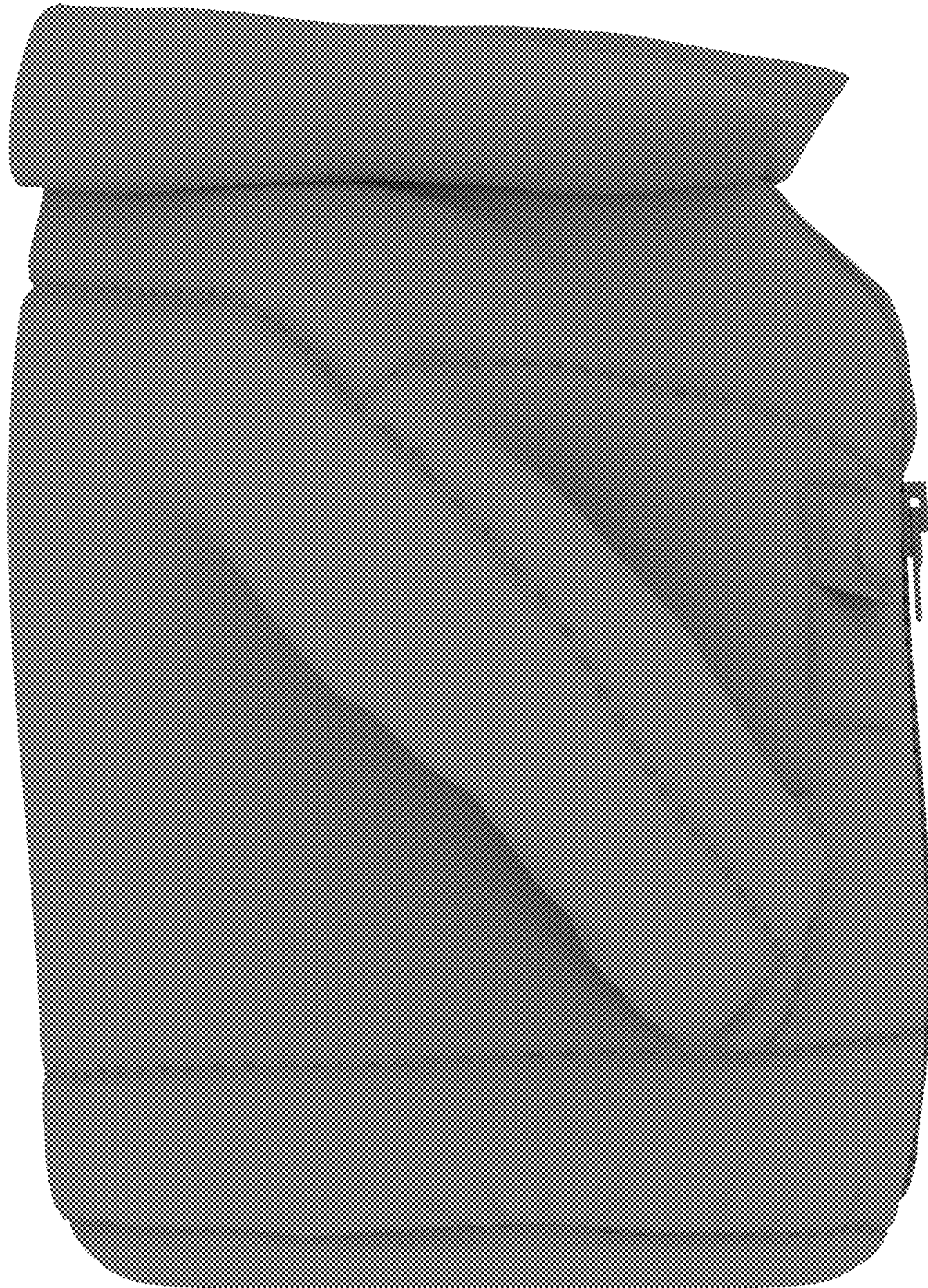

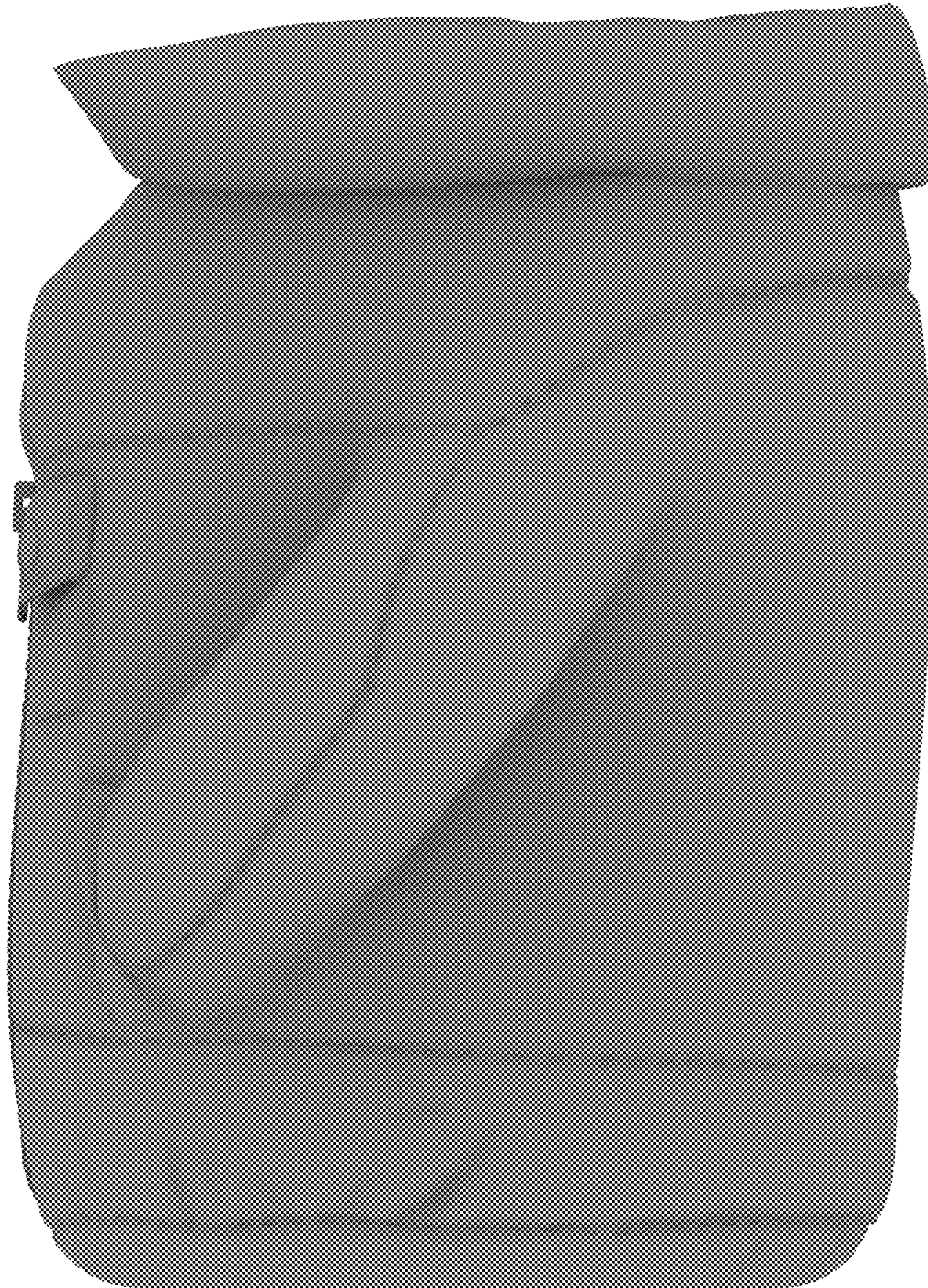

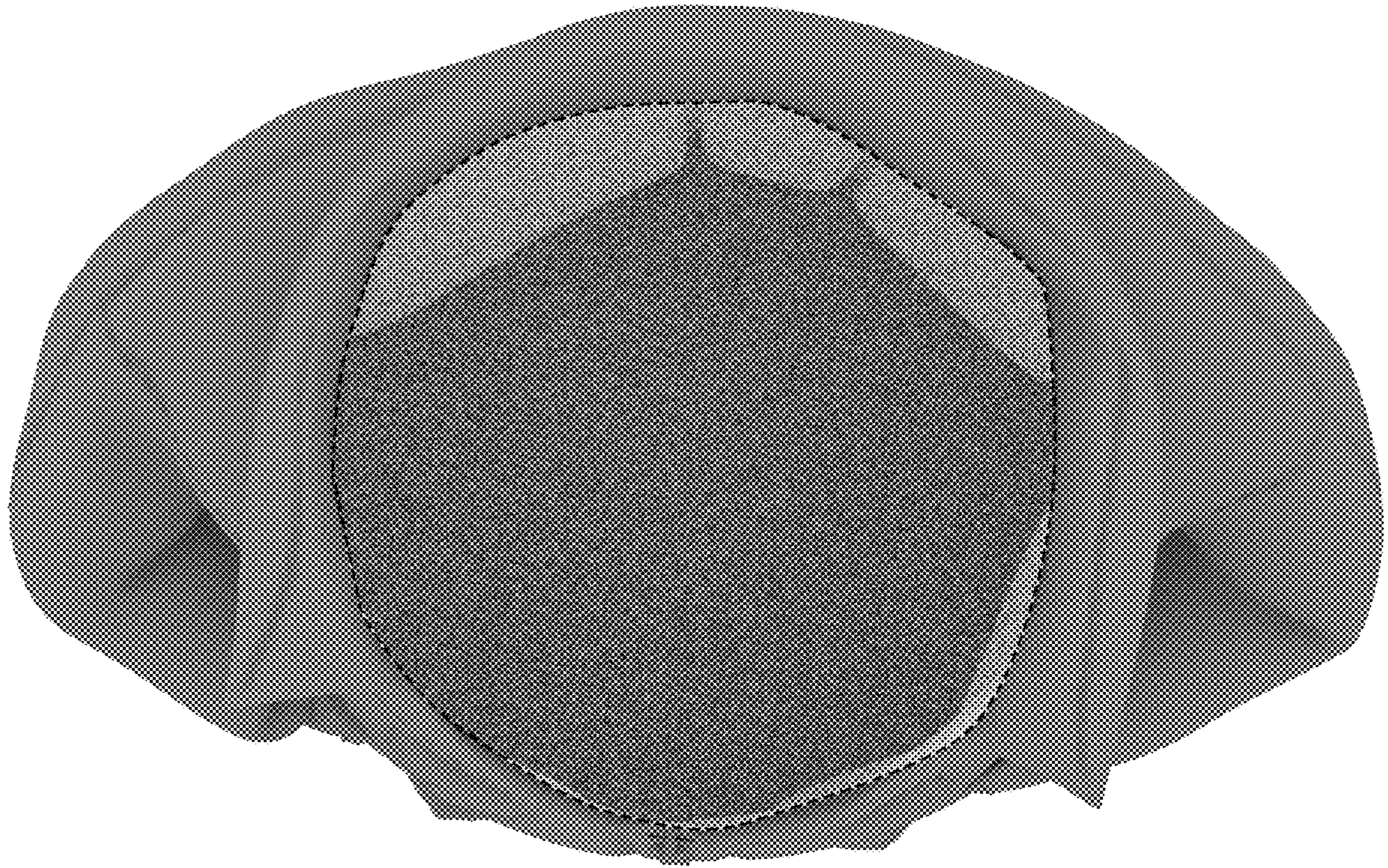

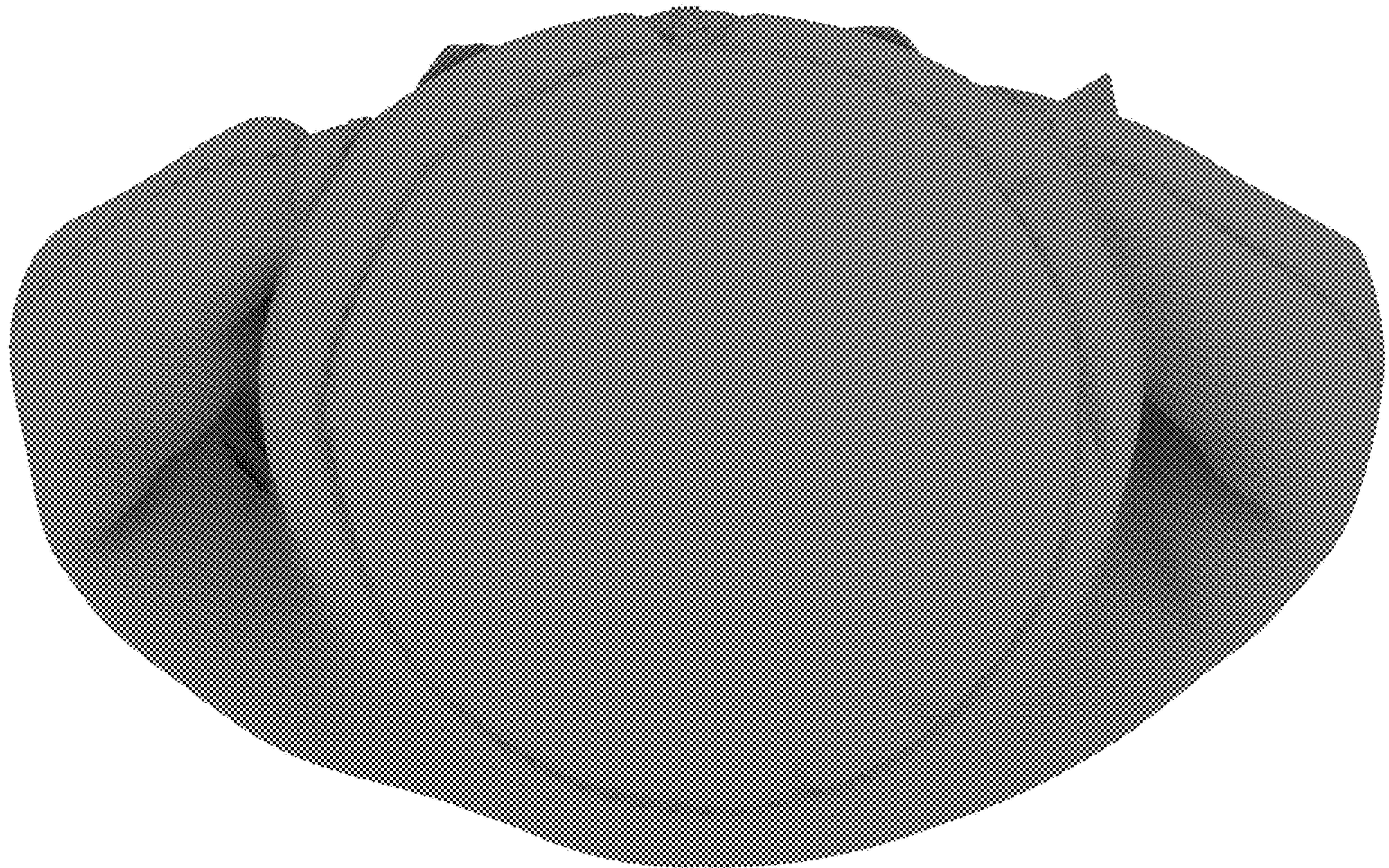
