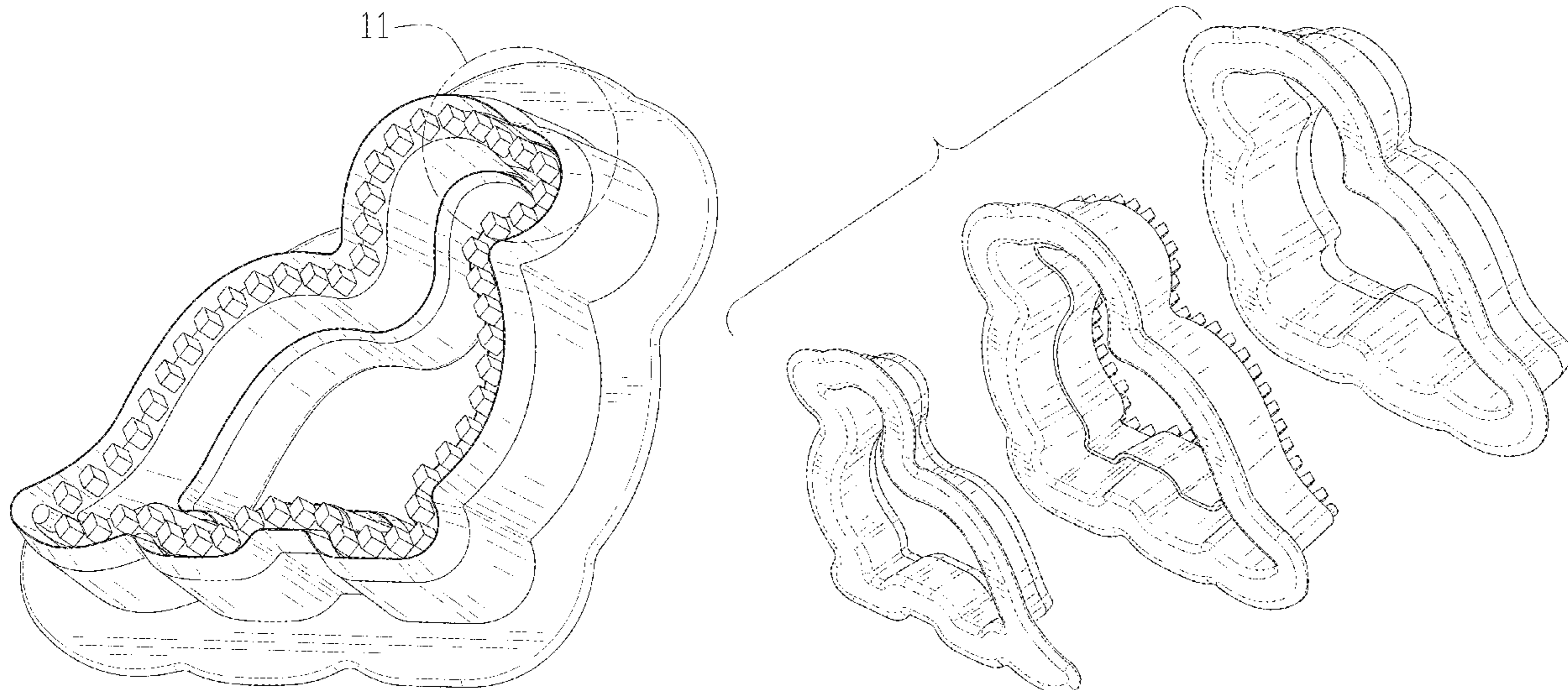
(57) **CLAIM**

The ornamental design for a sandwich cutter, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sandwich cutter showing my new design;
FIG. 2 is another perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof;
FIG. 9 is an exploded perspective view of the sandwich cutter;
FIG. 10 is a cross-sectional view taken along a transverse middle section of the sandwich cutter shown in FIG. 1; and,
FIG. 11 is an enlarged view of portion 11 shown in FIG. 2. The dot-dash broken lines represent boundaries of the enlarged portion and form no part of the claimed design.

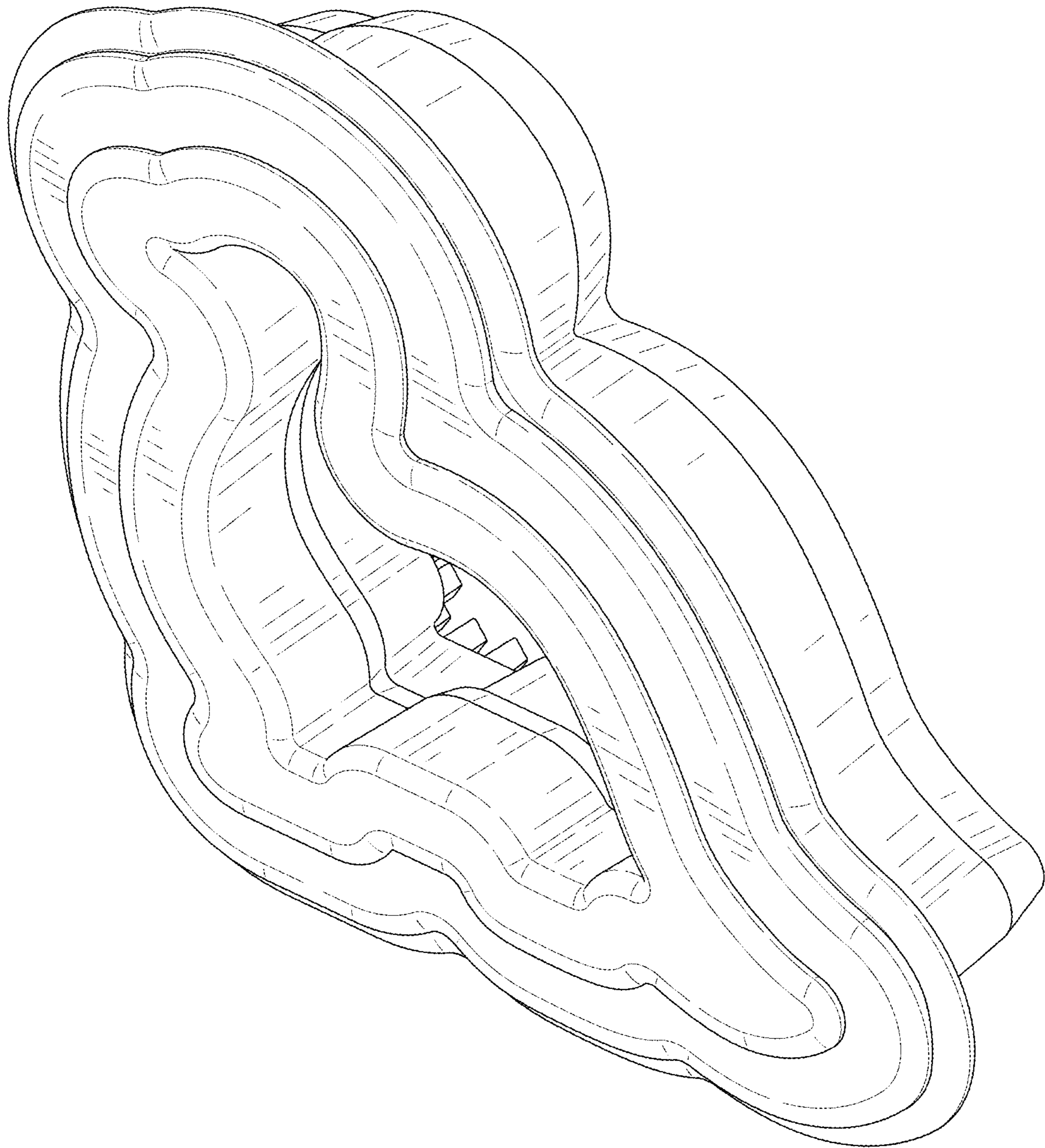

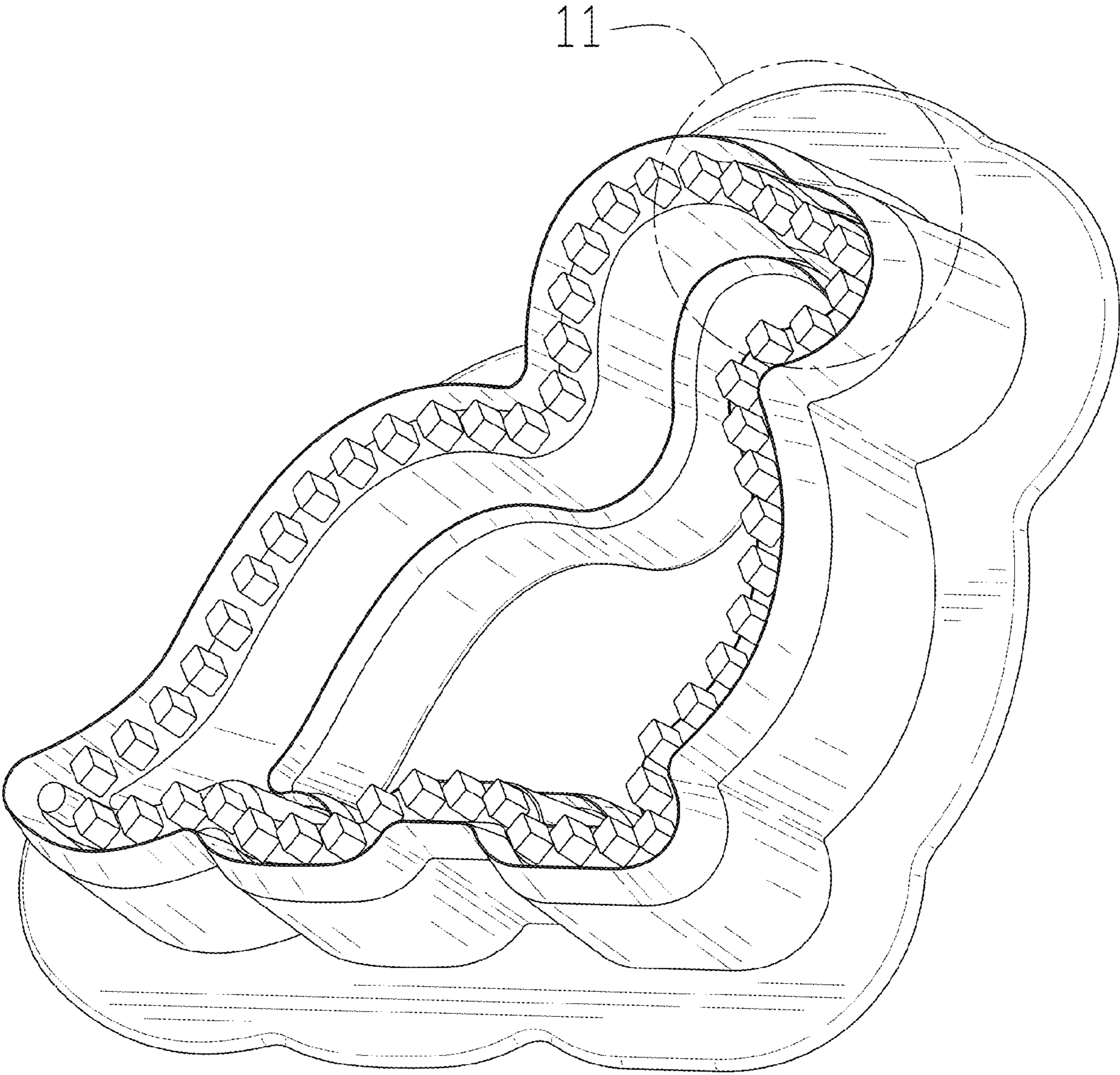

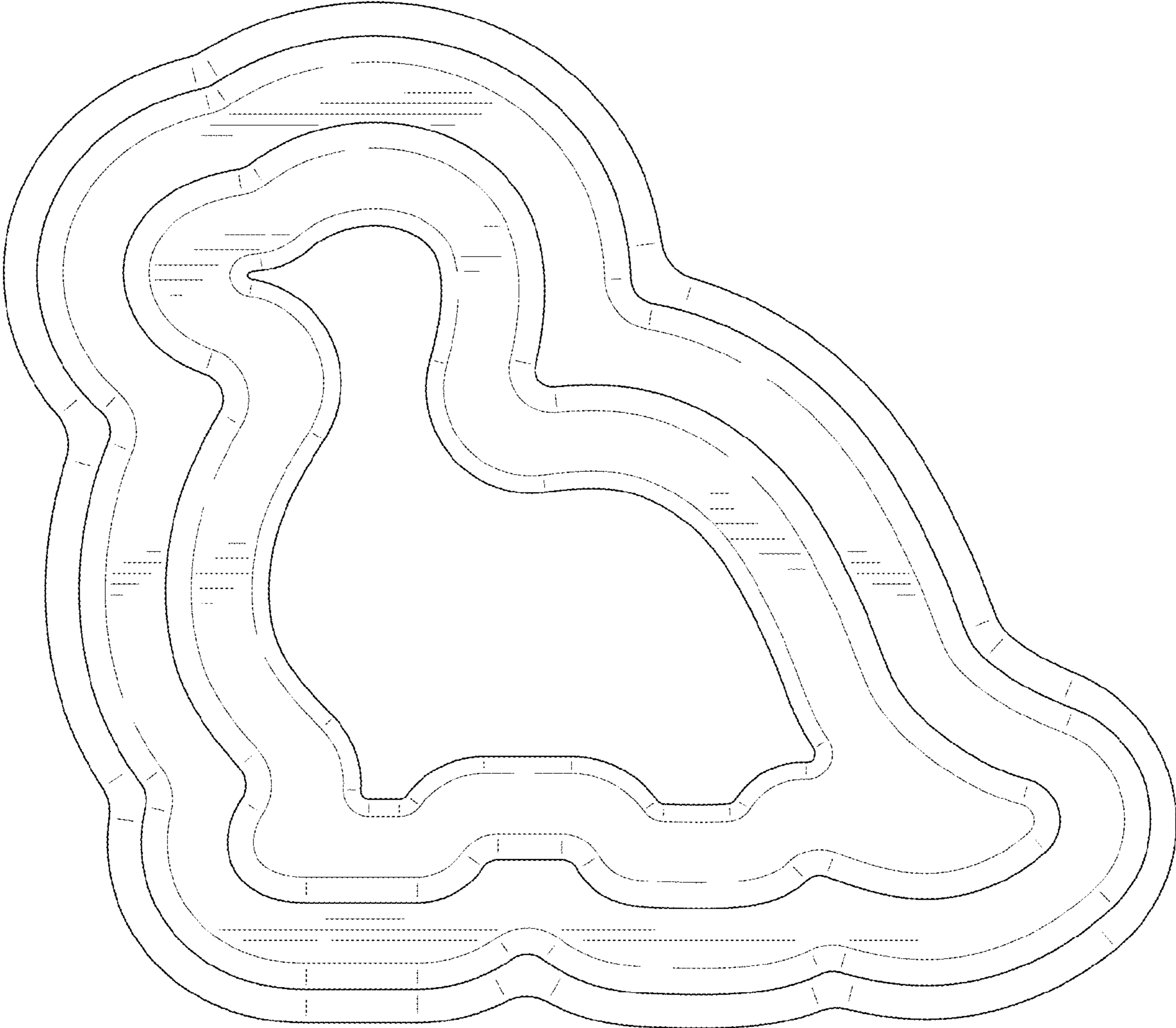

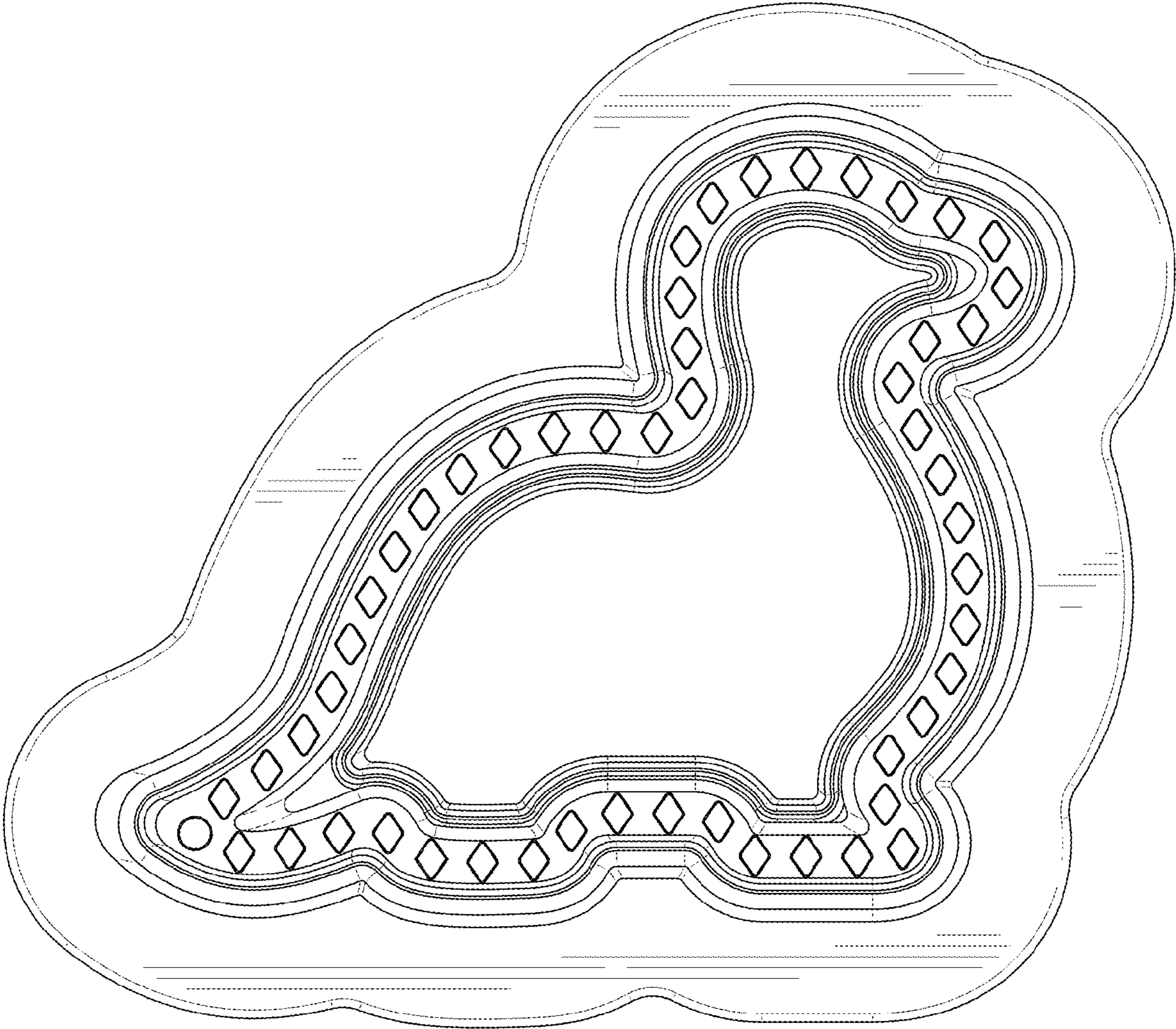

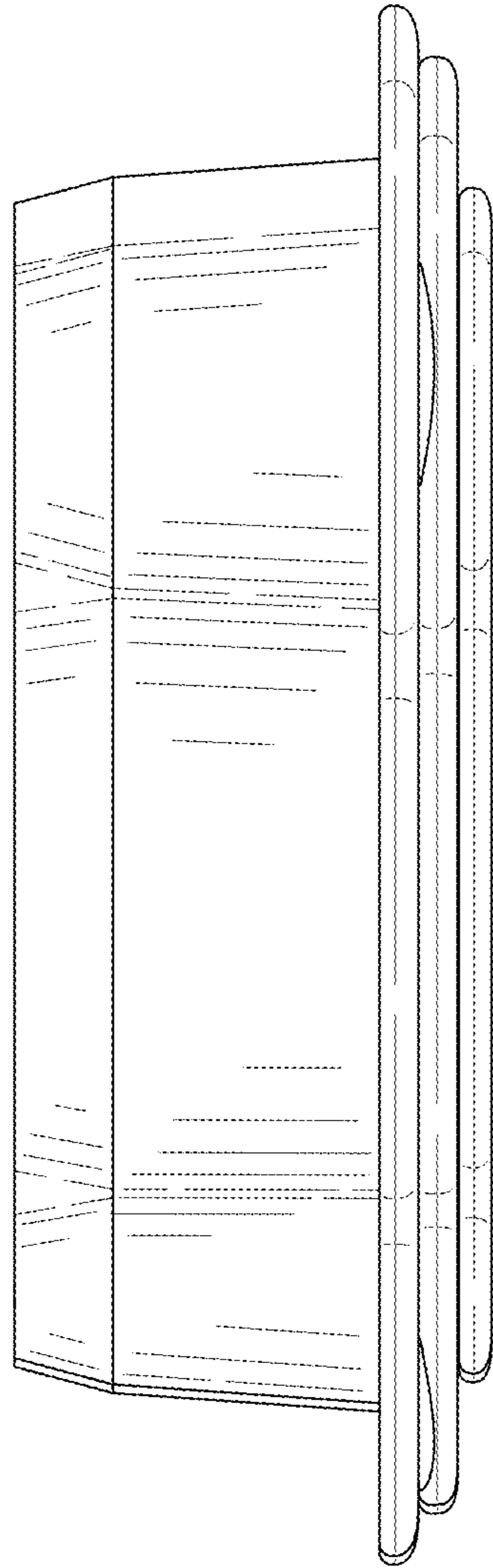

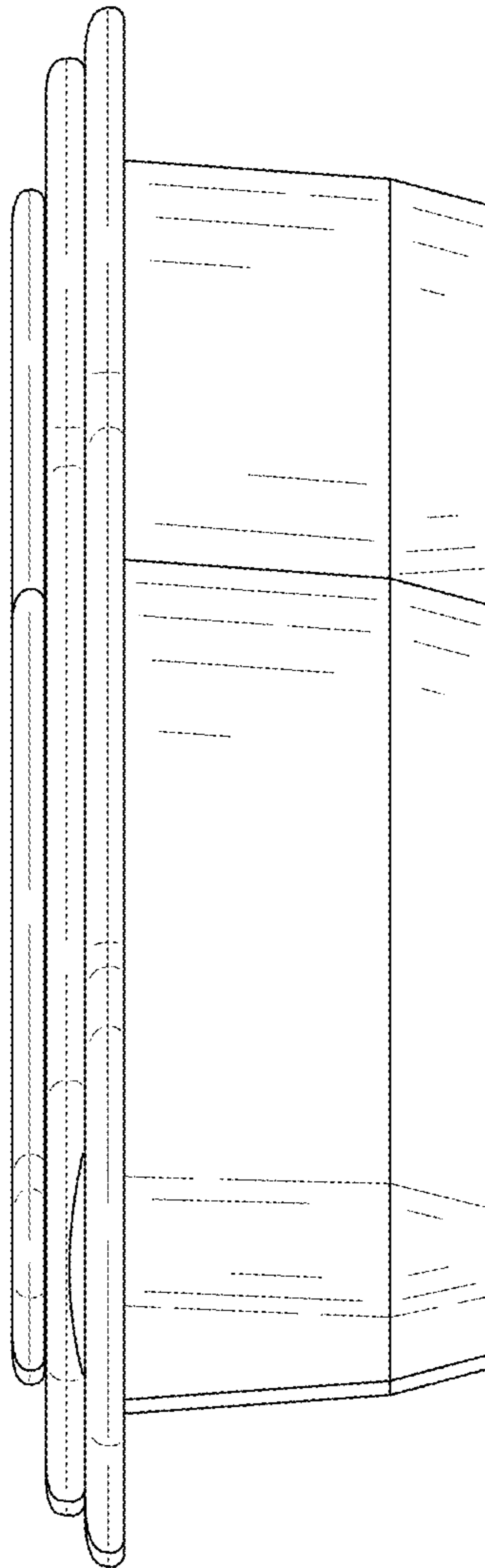

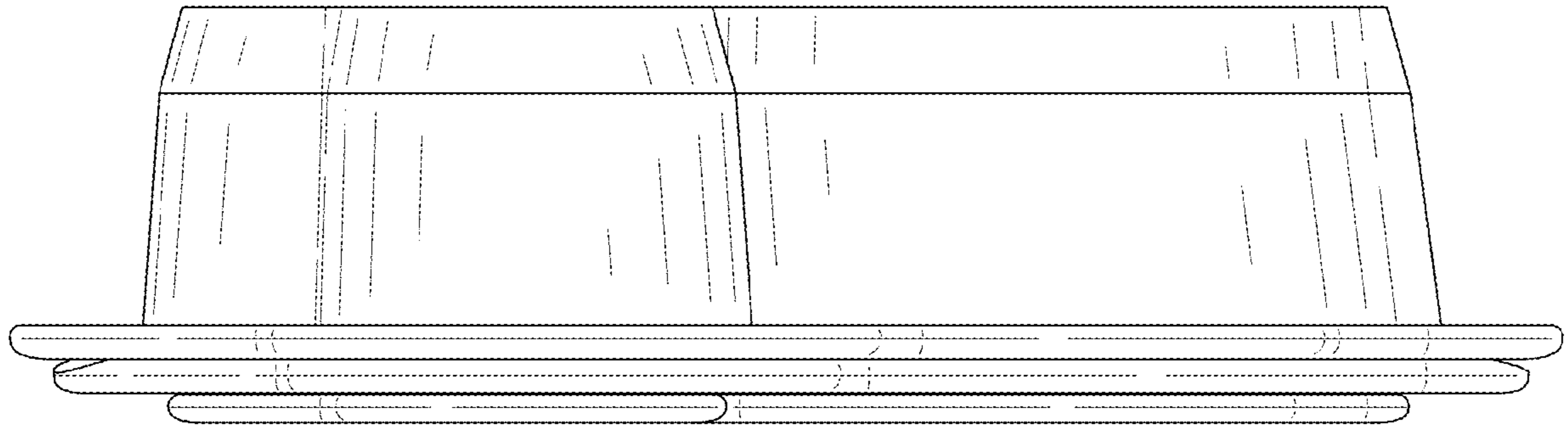

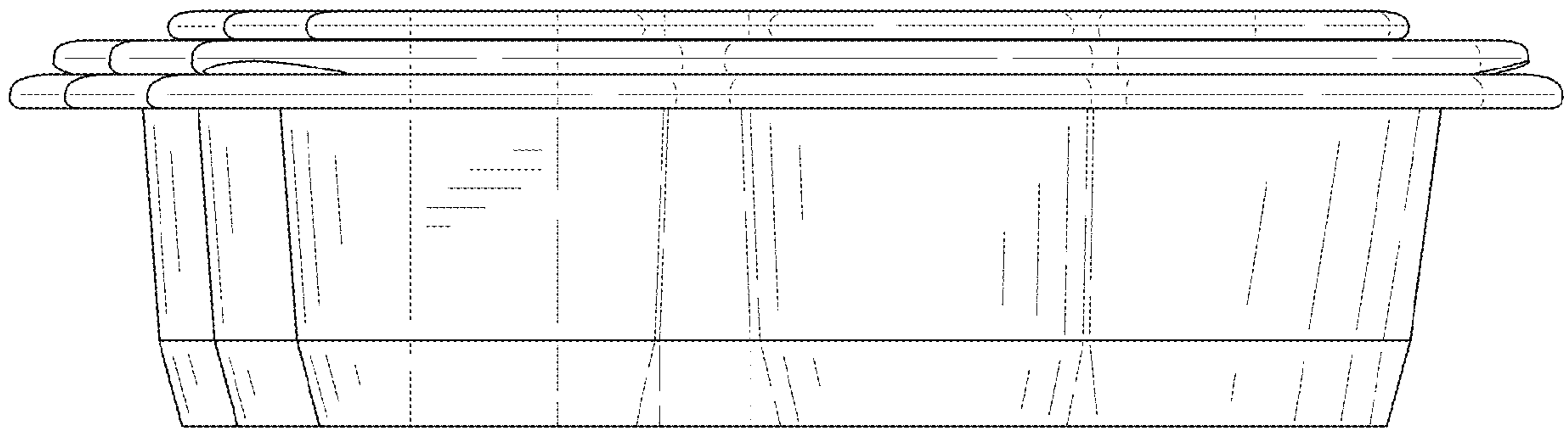

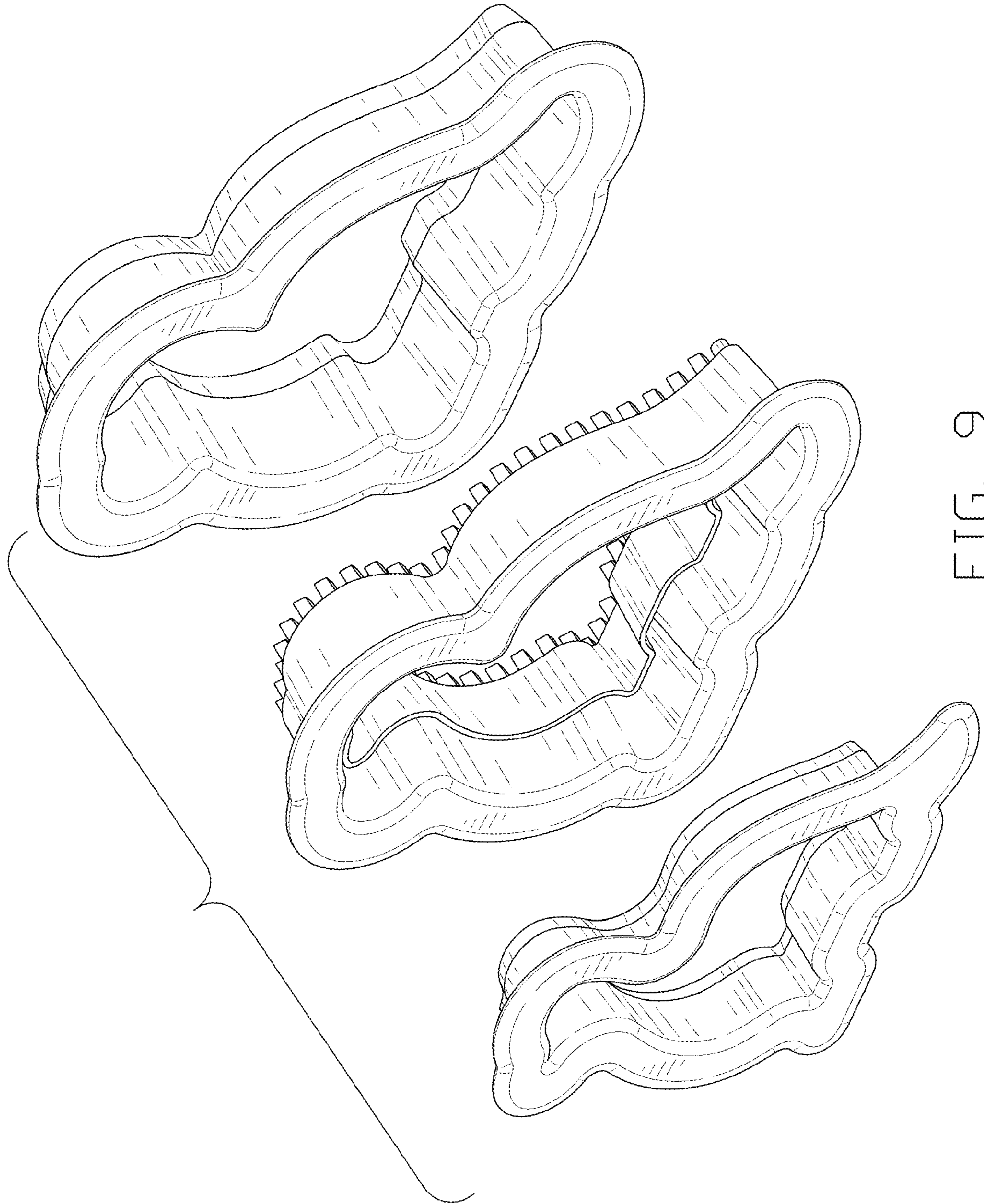

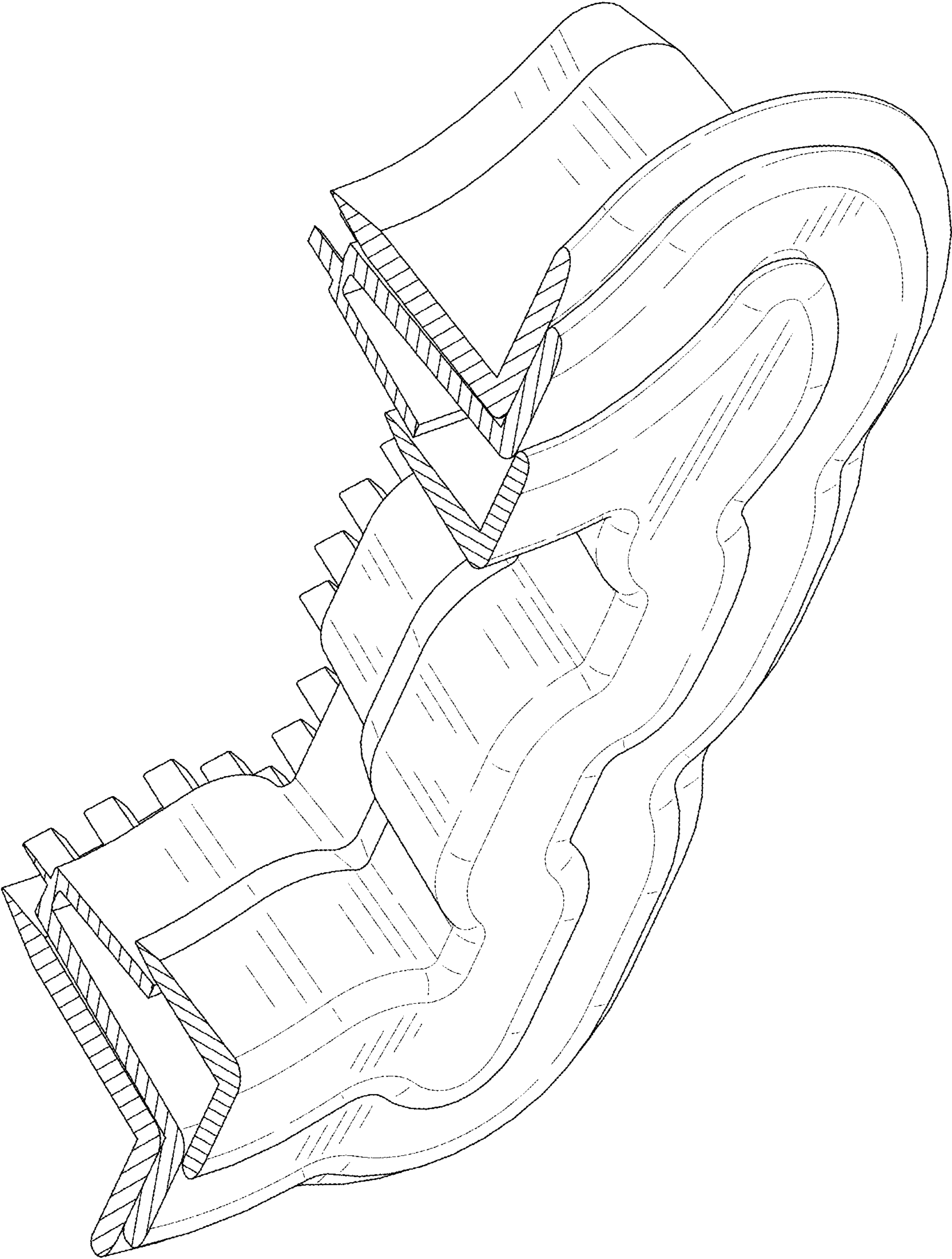

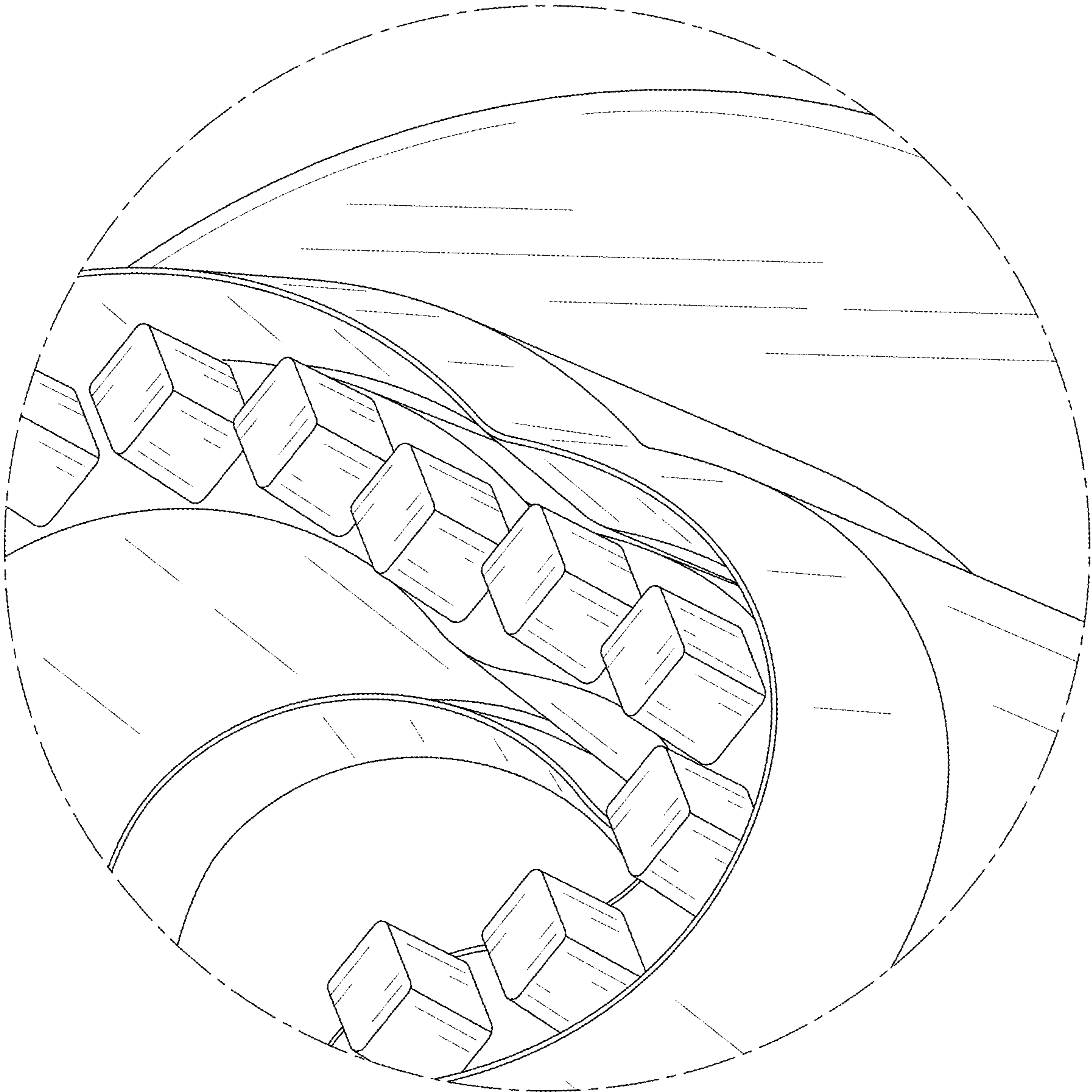
