DESCRIPTION

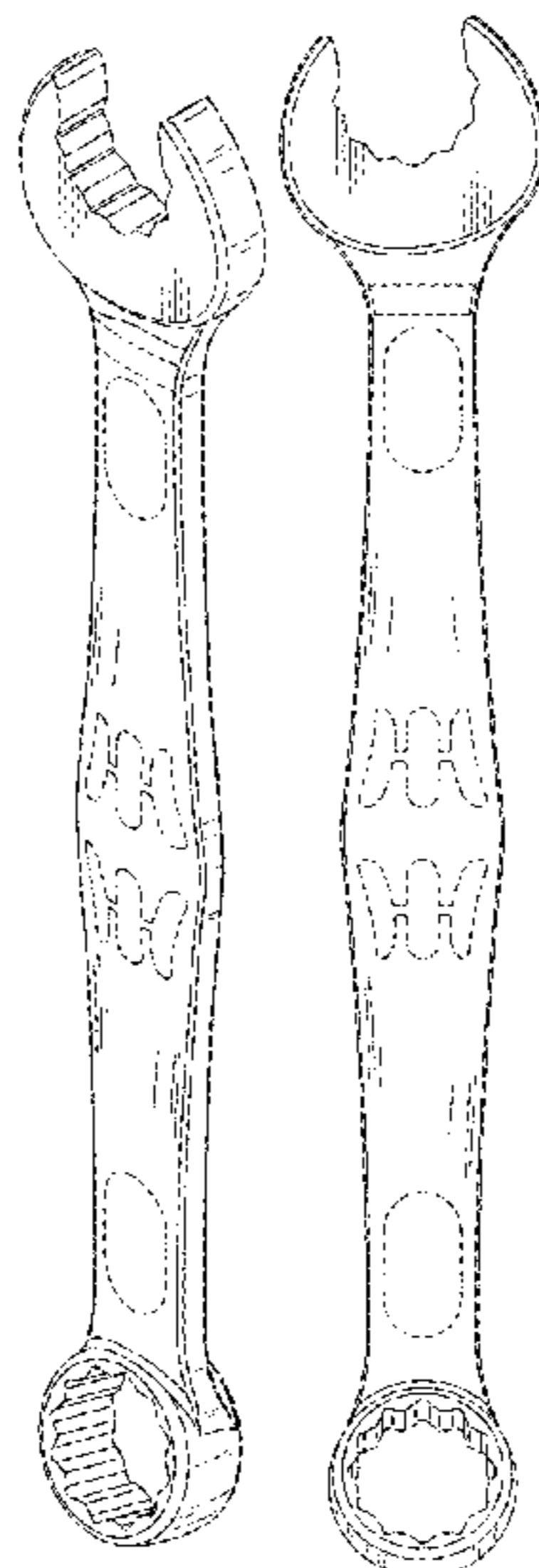
FIG. 1 is a front isometric view of a wrench in accordance with the new design;

FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;

FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

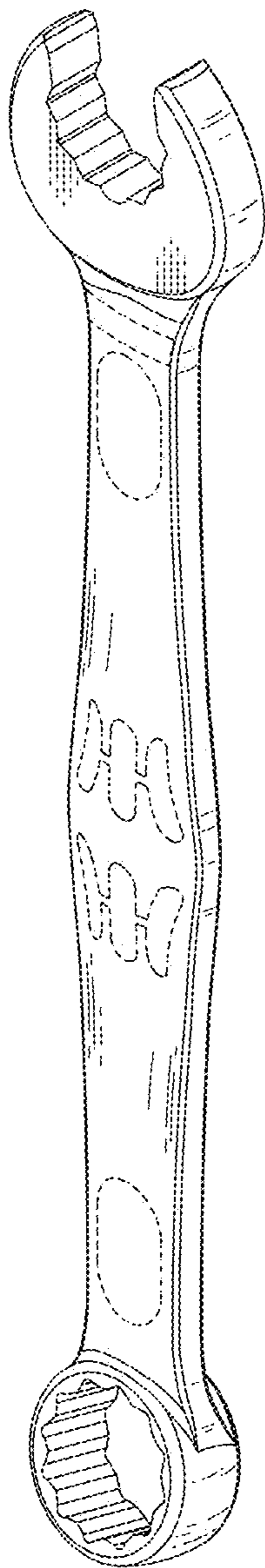

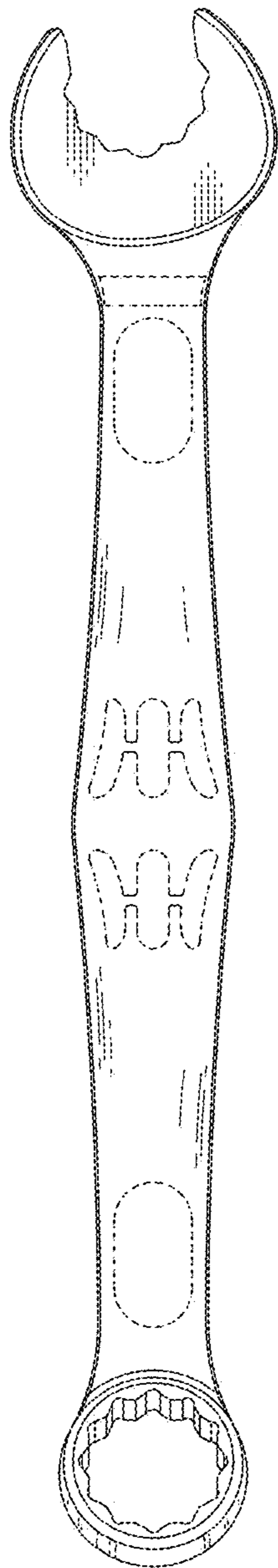

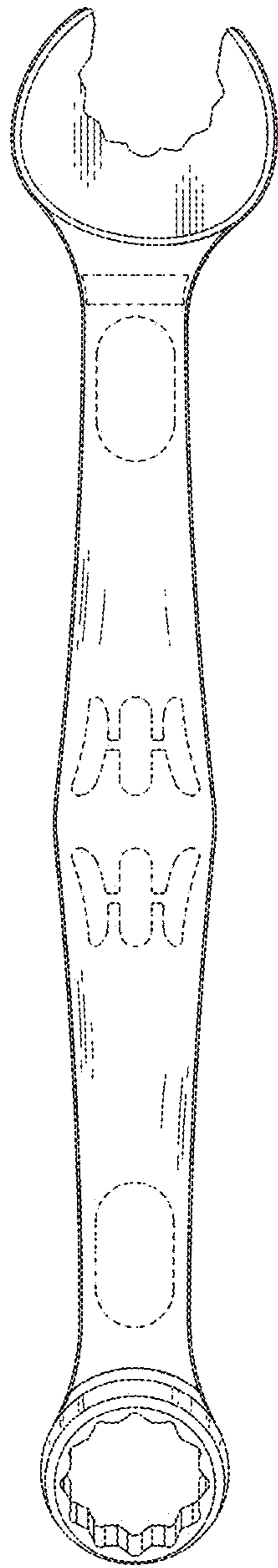

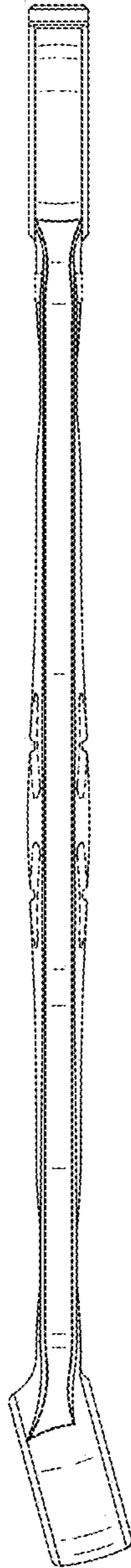

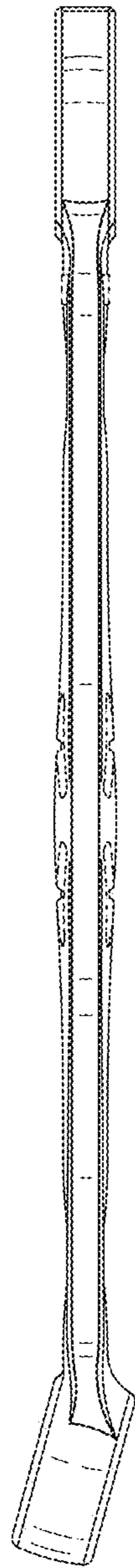

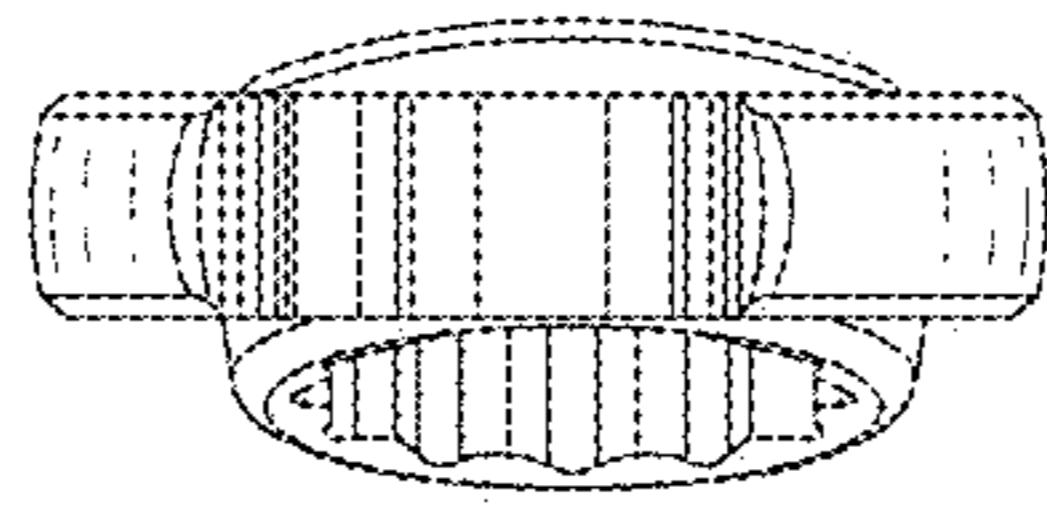
