The ornamental design for a top portion of a motor vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a right, front perspective view of a top portion of motor vehicle showing my new design;
FIG. 2 is a left, front perspective view thereof;

FIG. 4 is a right, rear perspective view thereof;

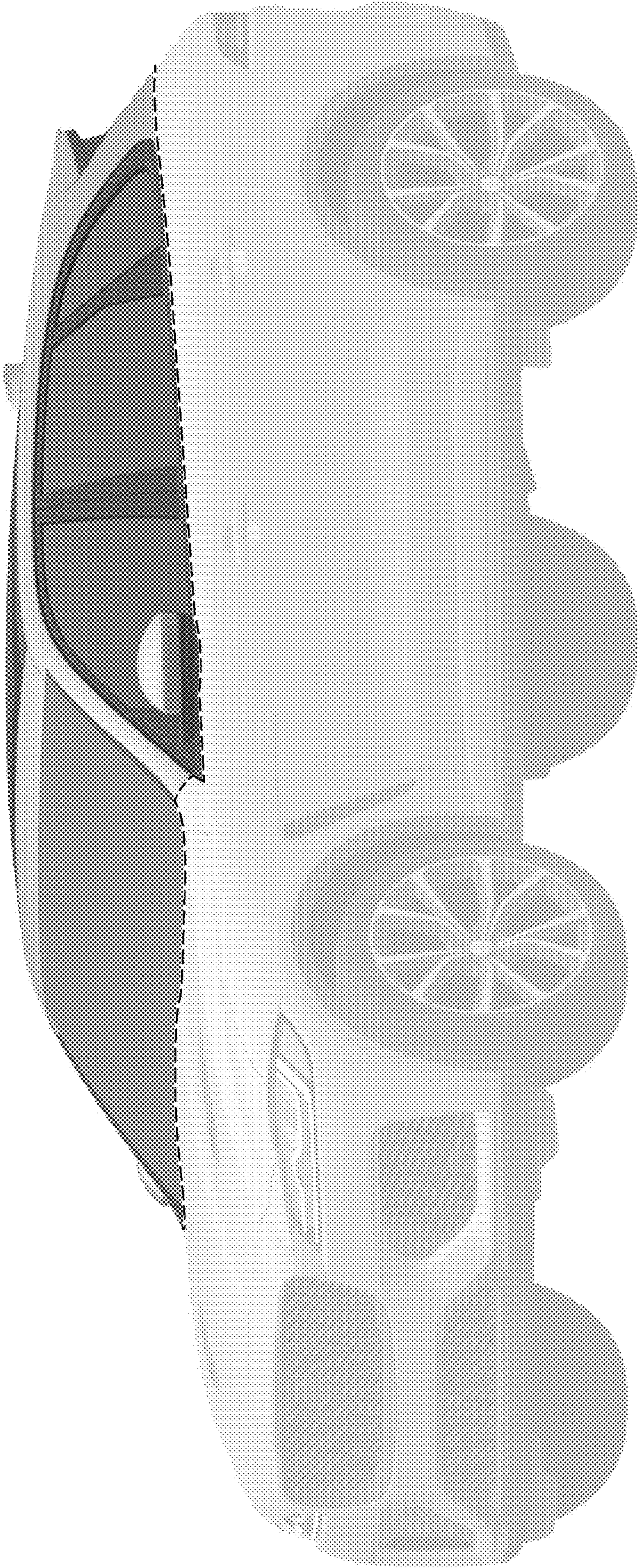

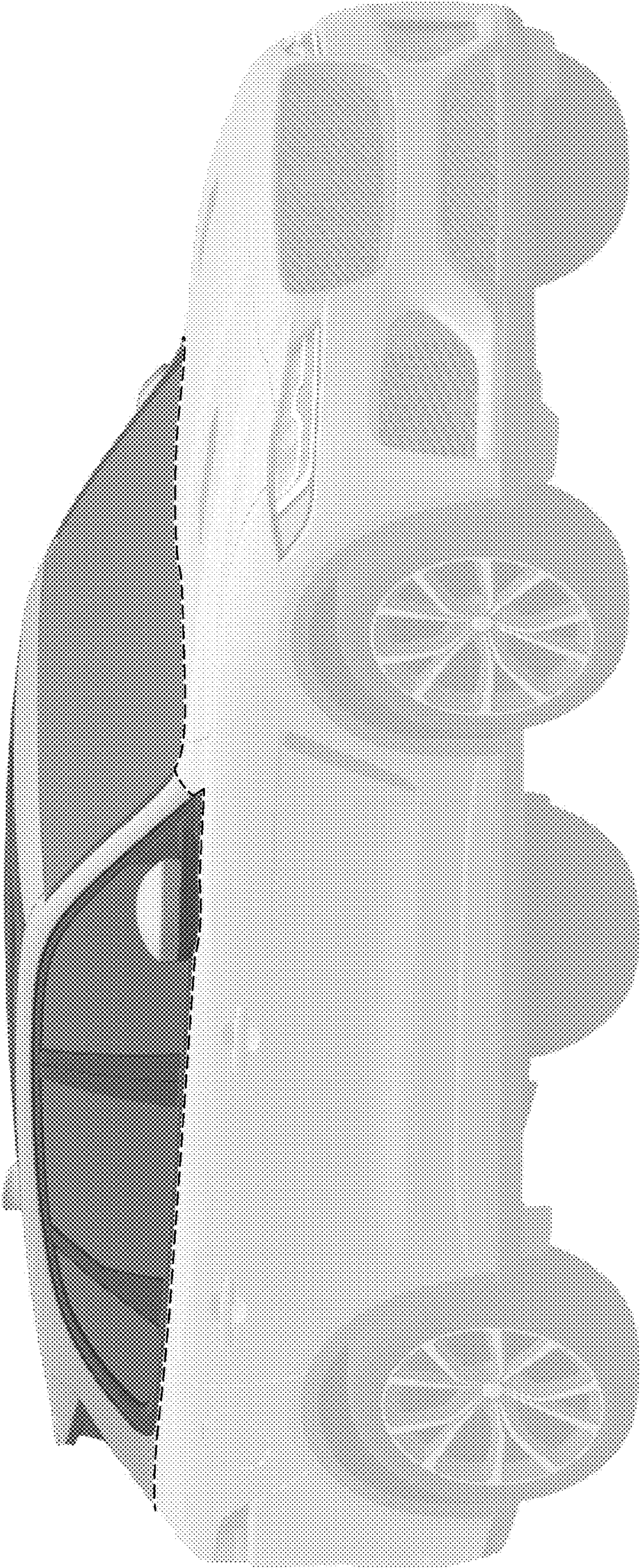

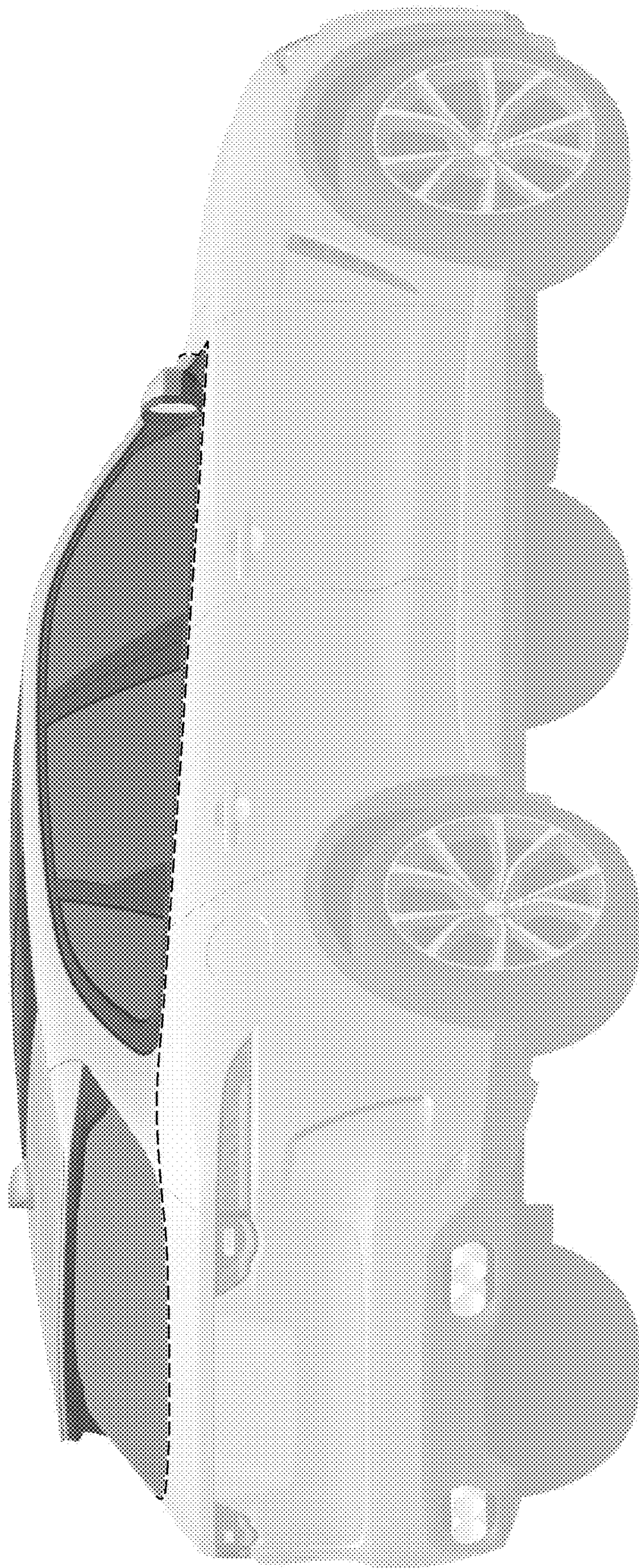

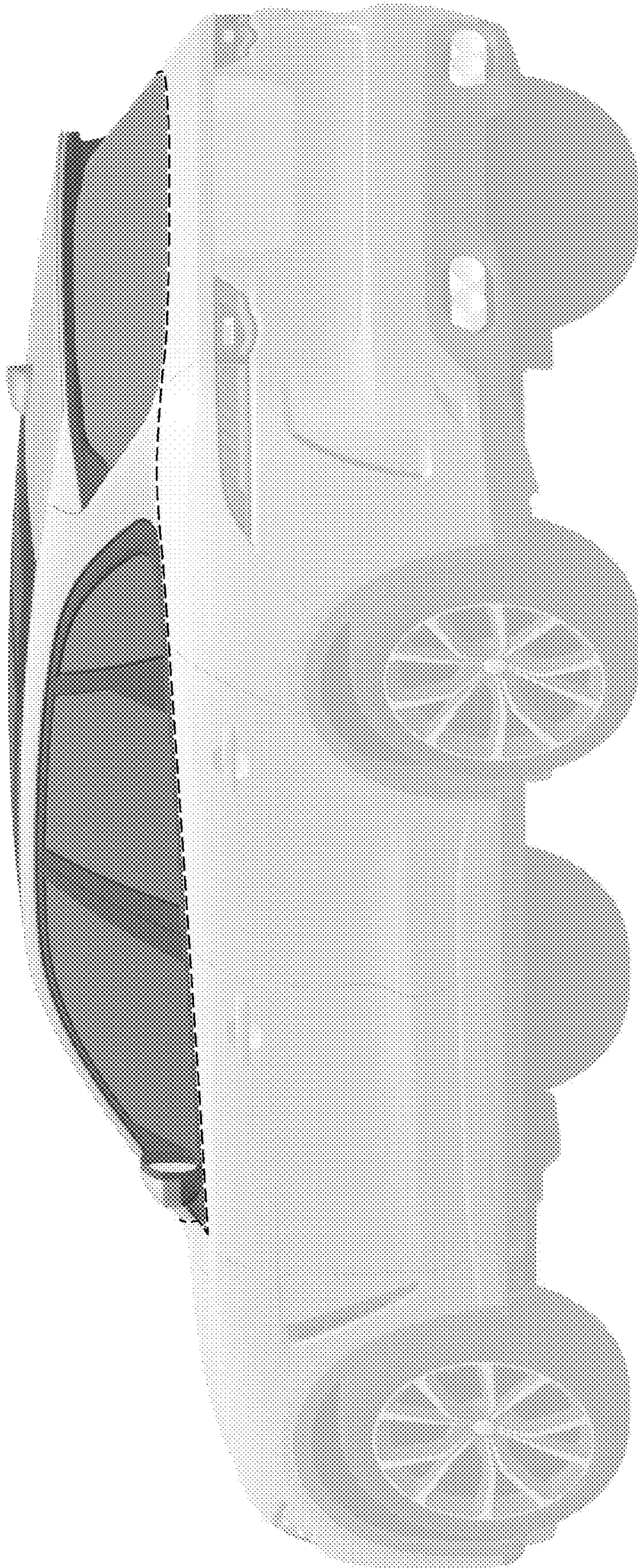

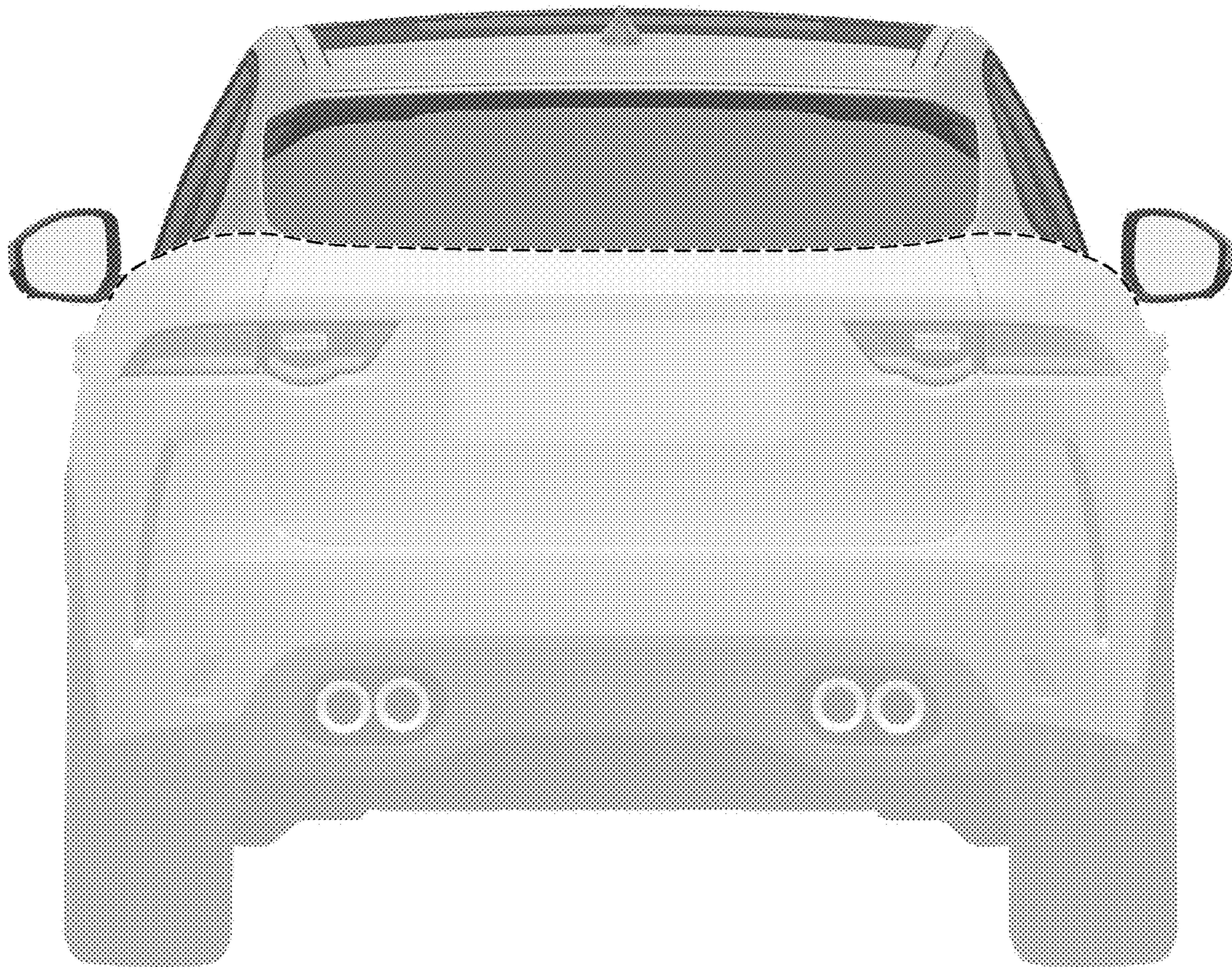

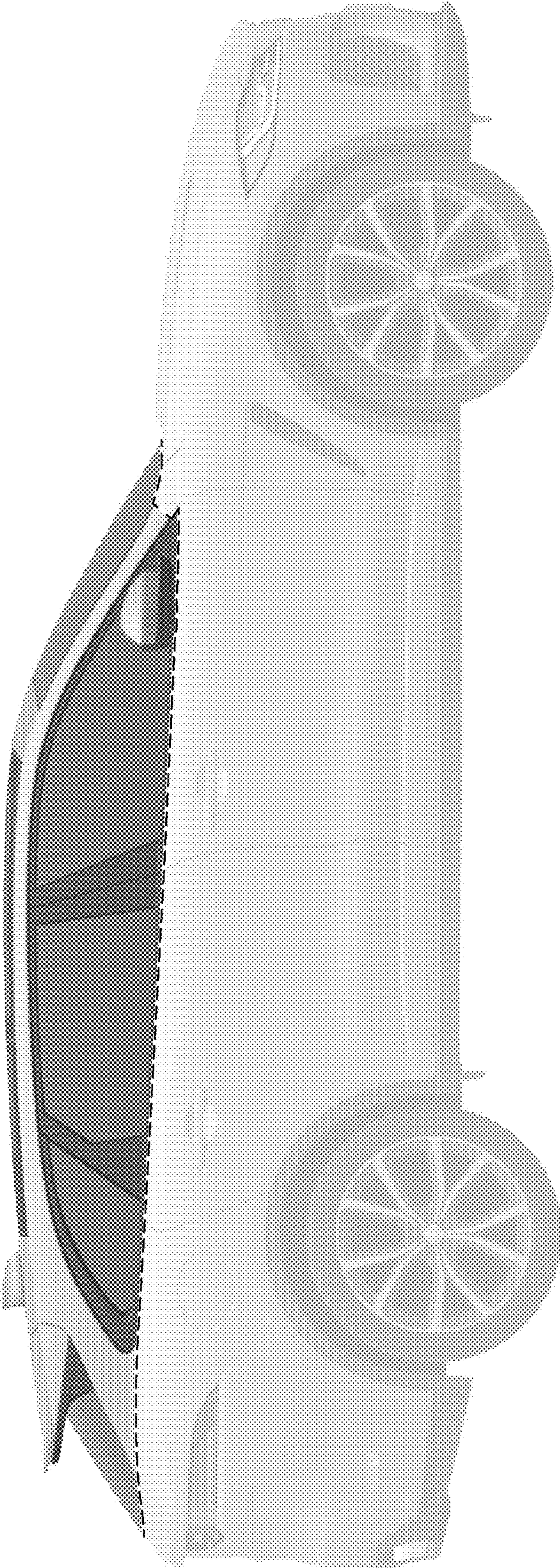

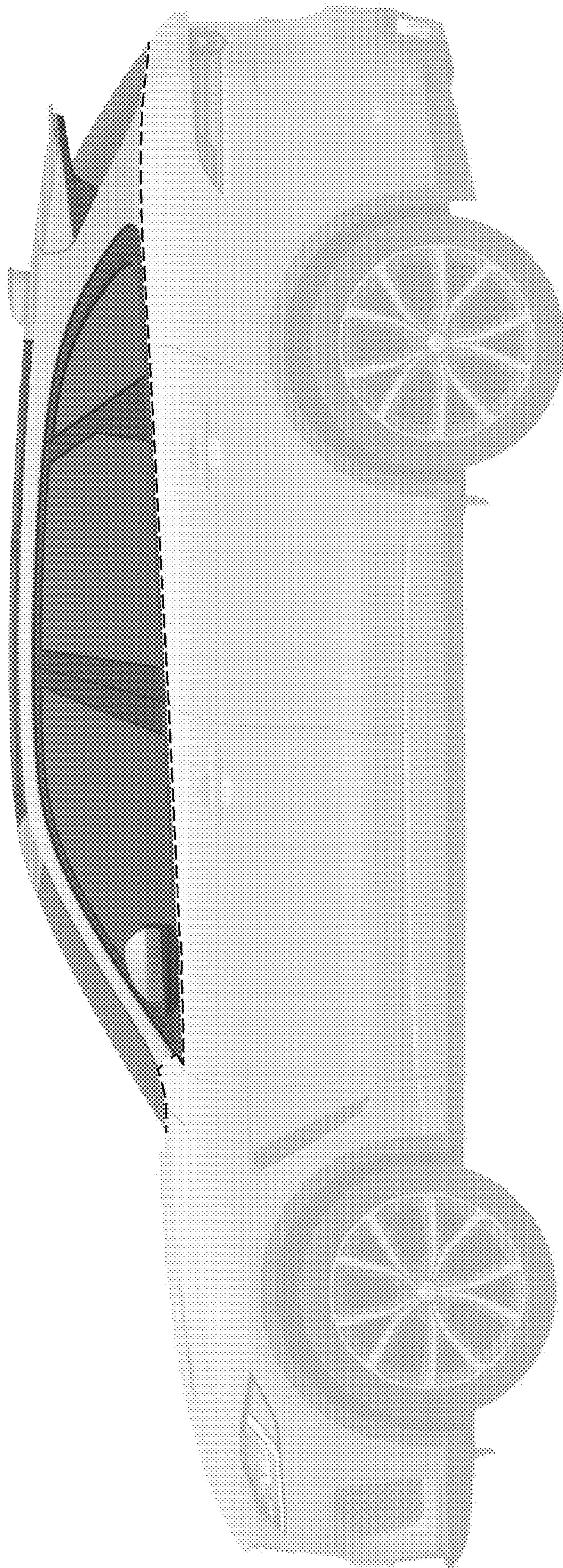

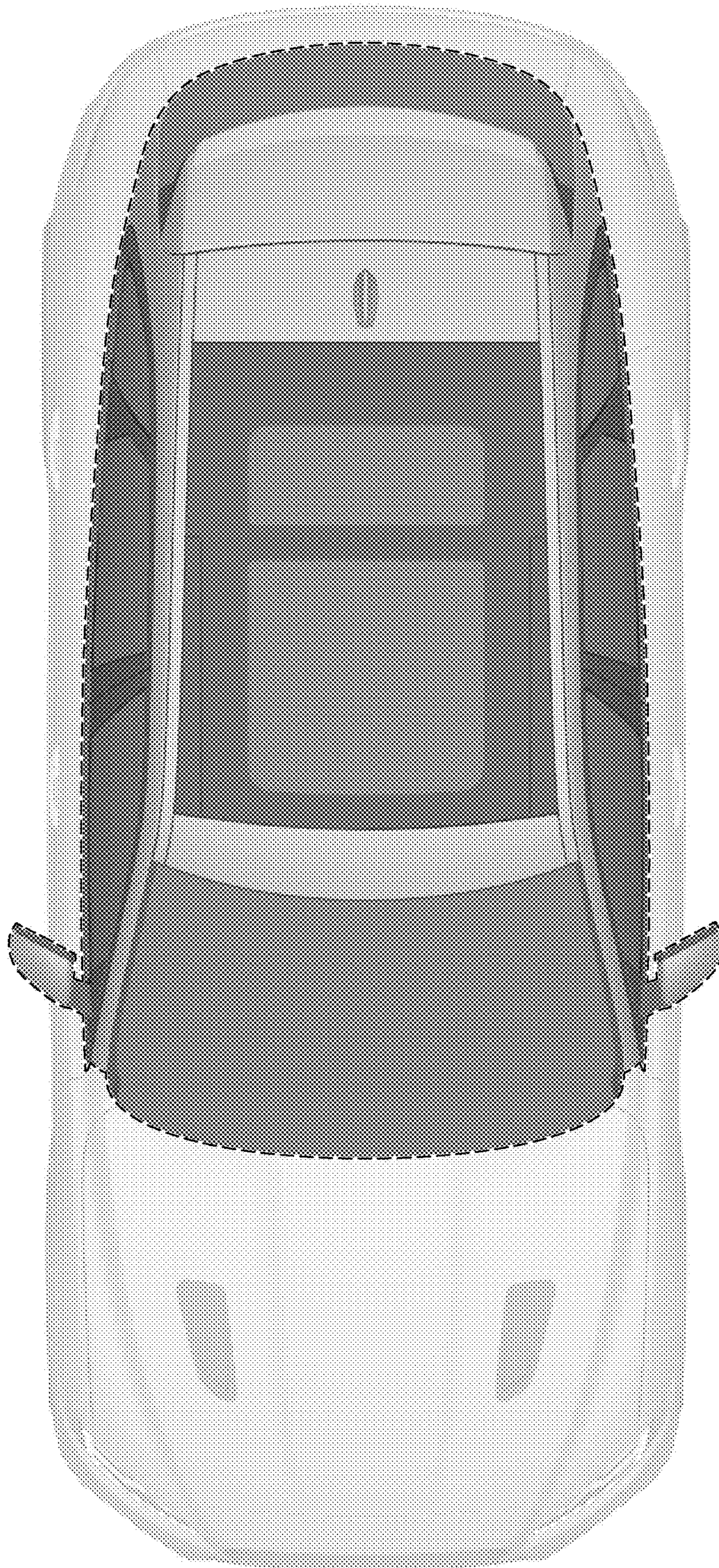
