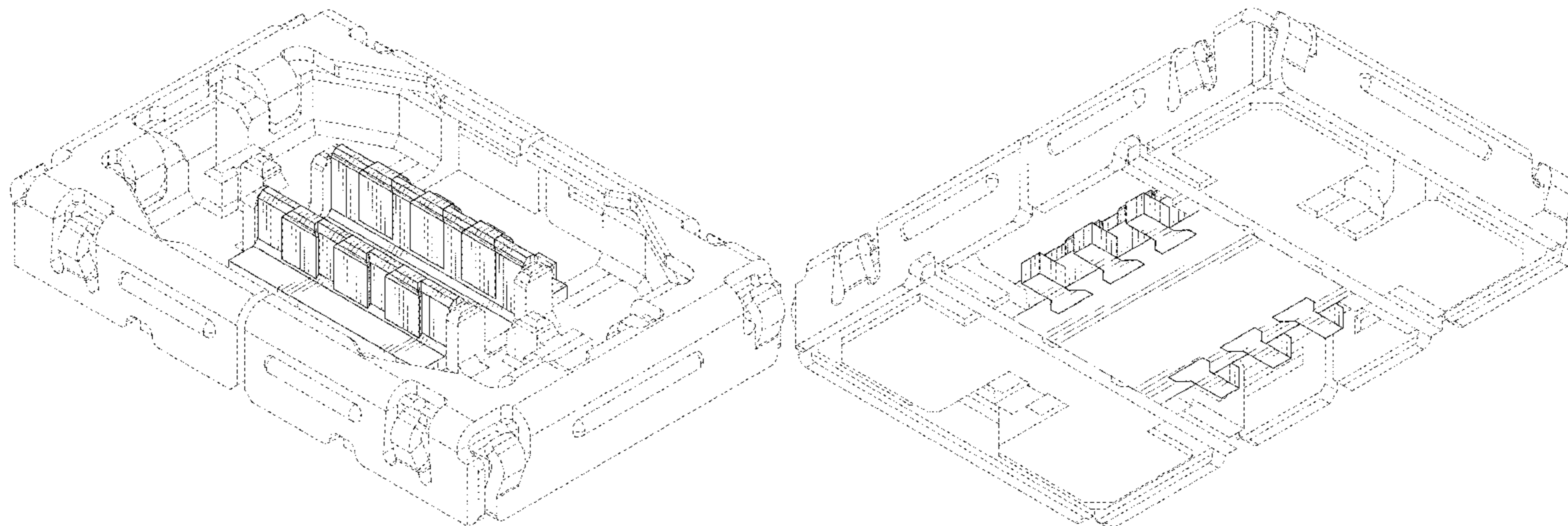
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of a connector showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a perspective view from a top side thereof; and,
FIG. 8 is a perspective view from a bottom side thereof.
The dashed broken line showing of the connector is for the purpose of illustrating portions of the article, and the dot-dash broken line defines the bounds of the claimed design. The dashed broken line and the dot-dash broken line form no part of the claimed design.

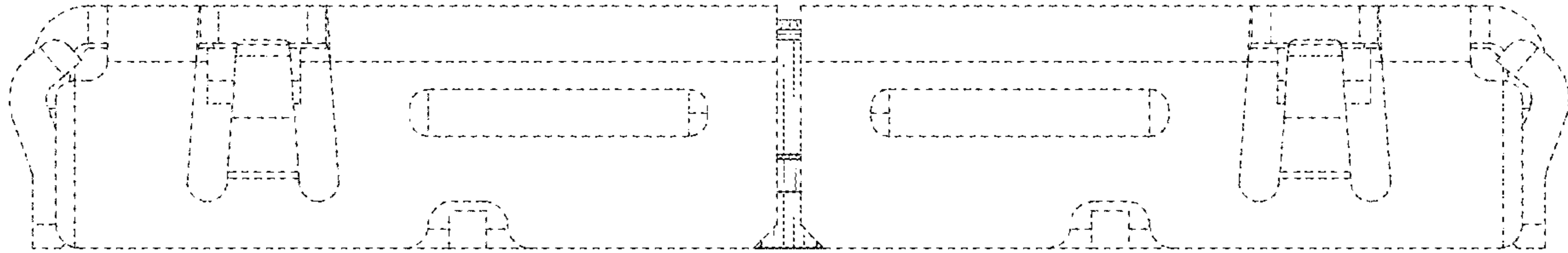

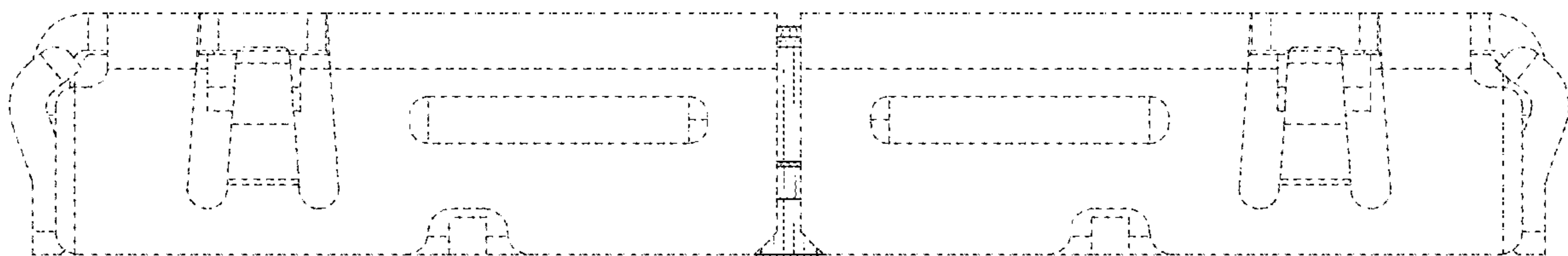

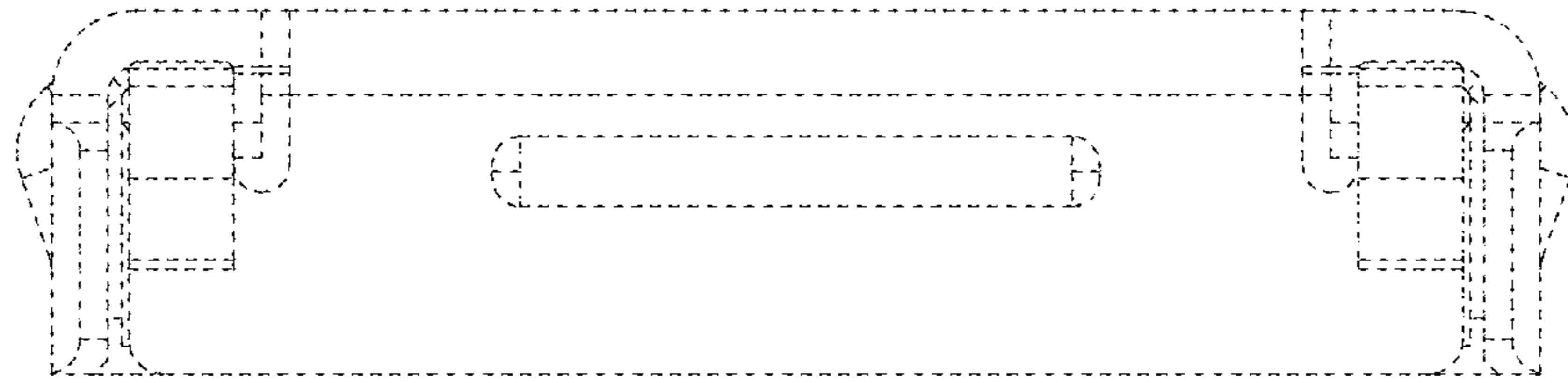

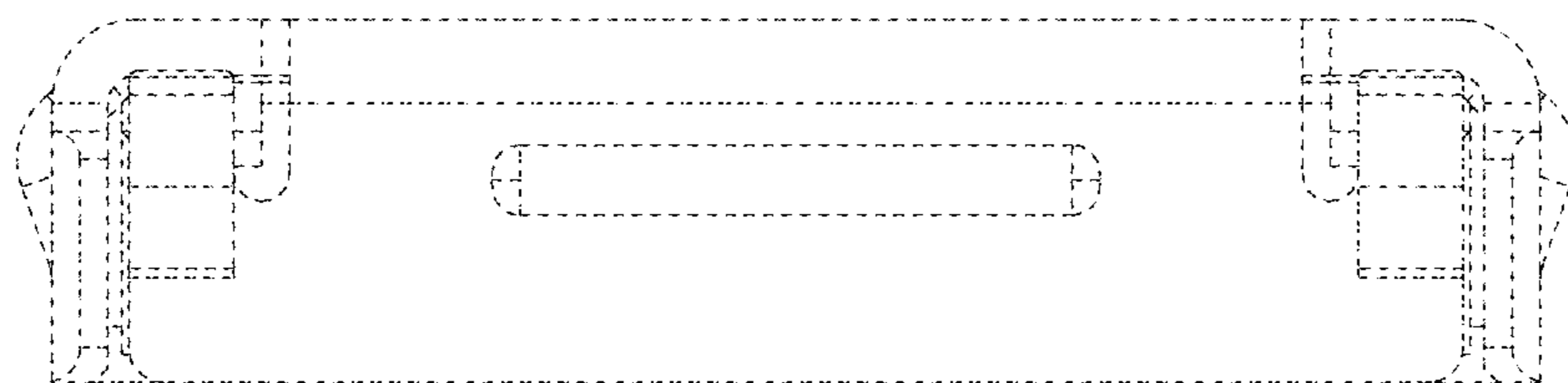

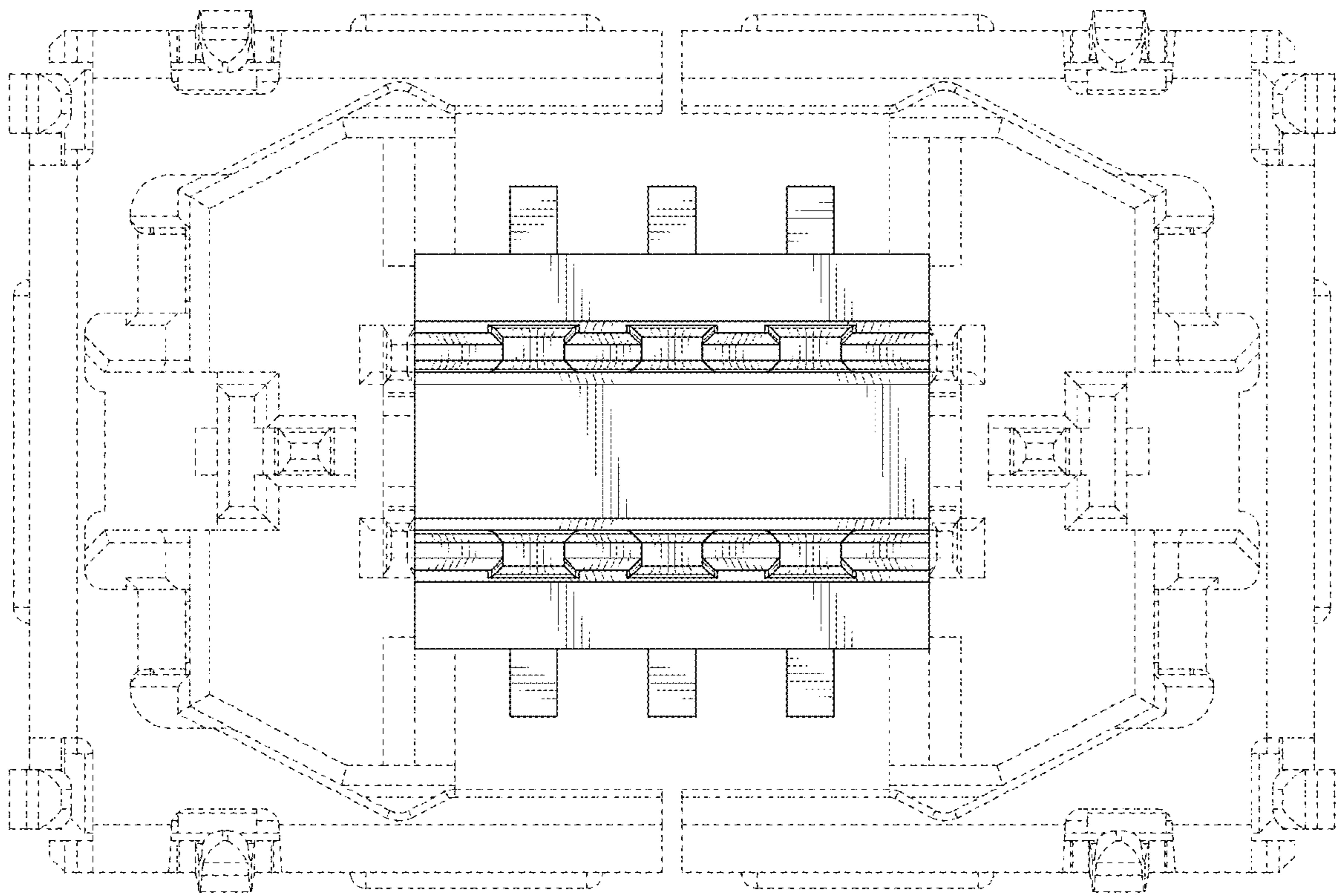

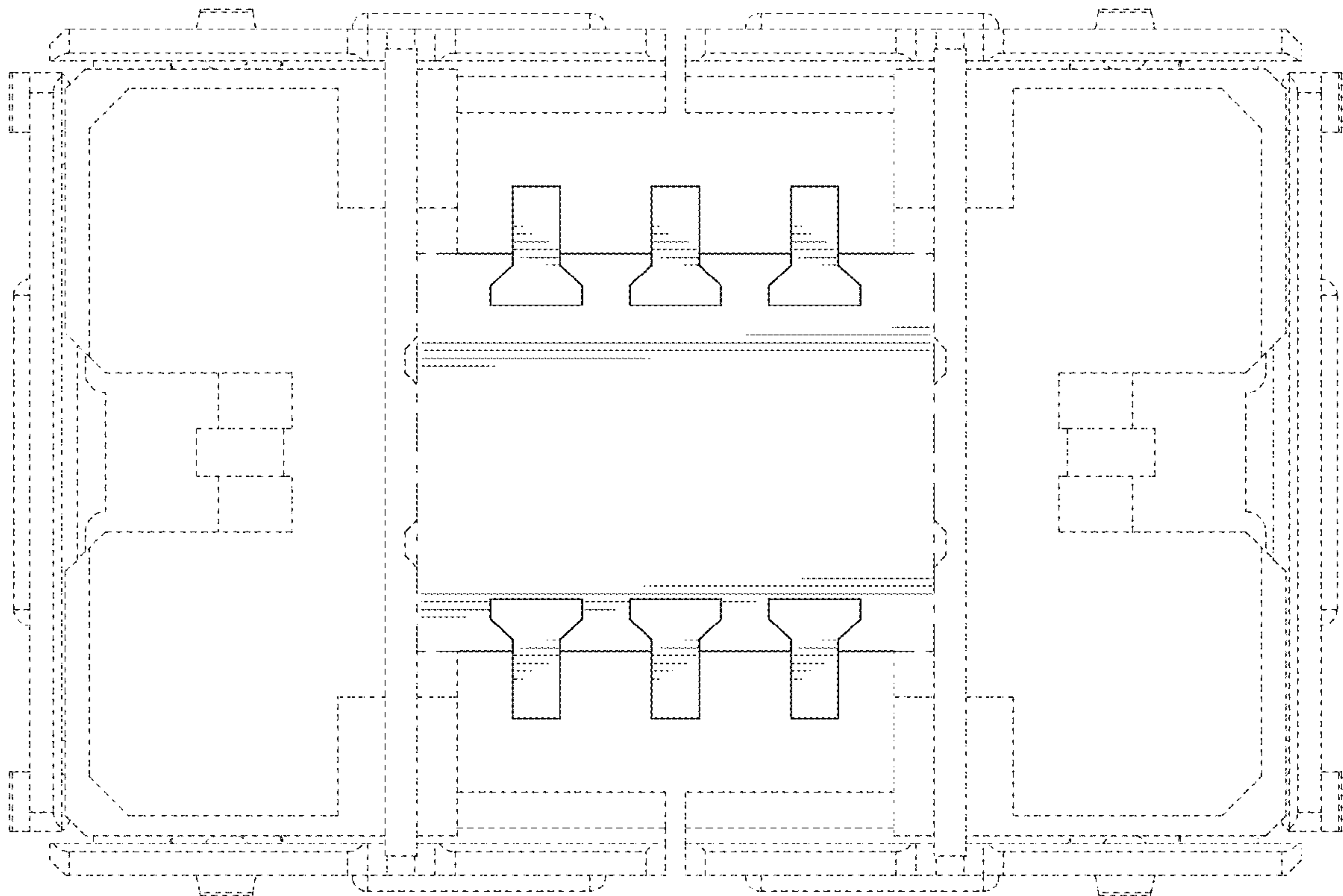

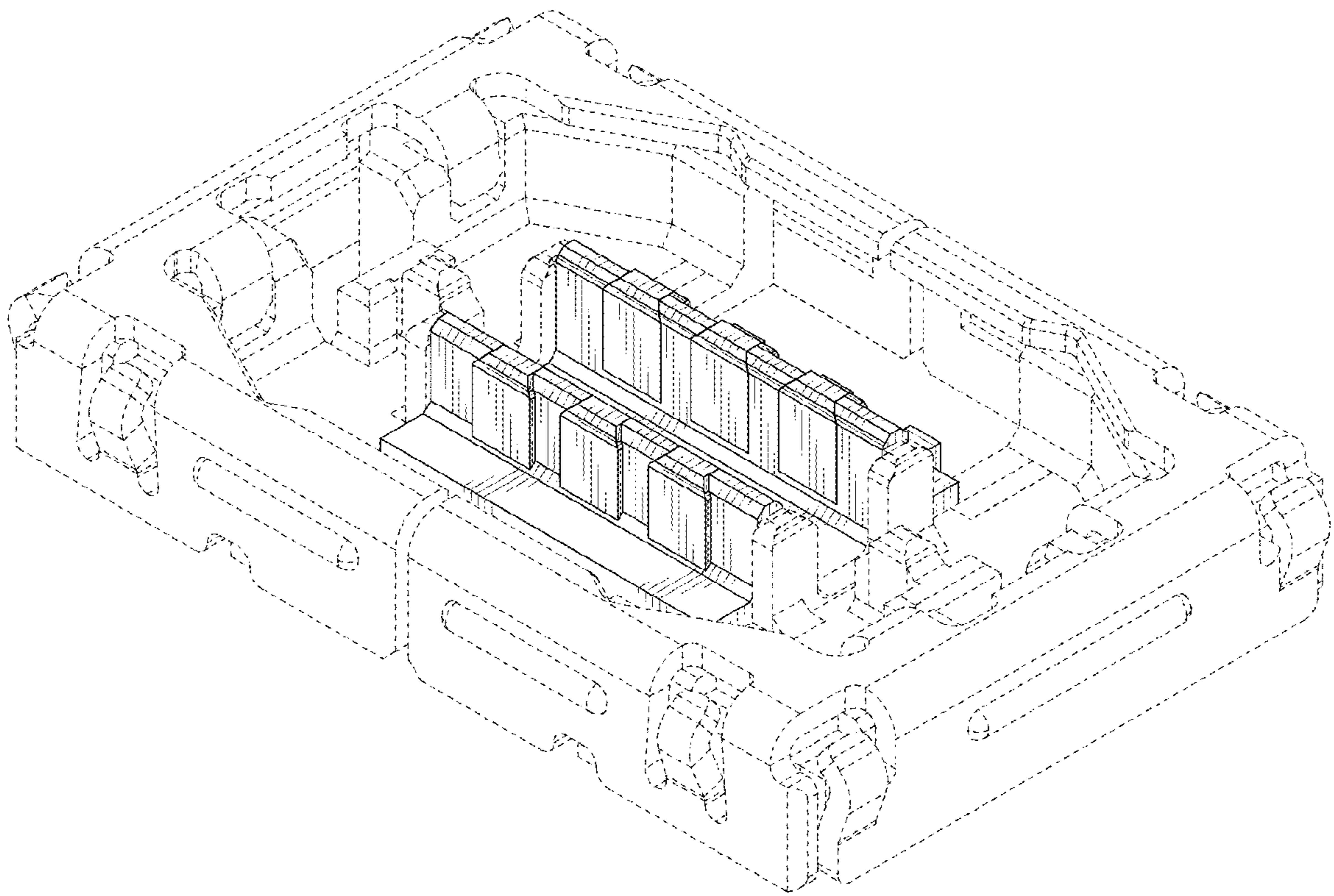

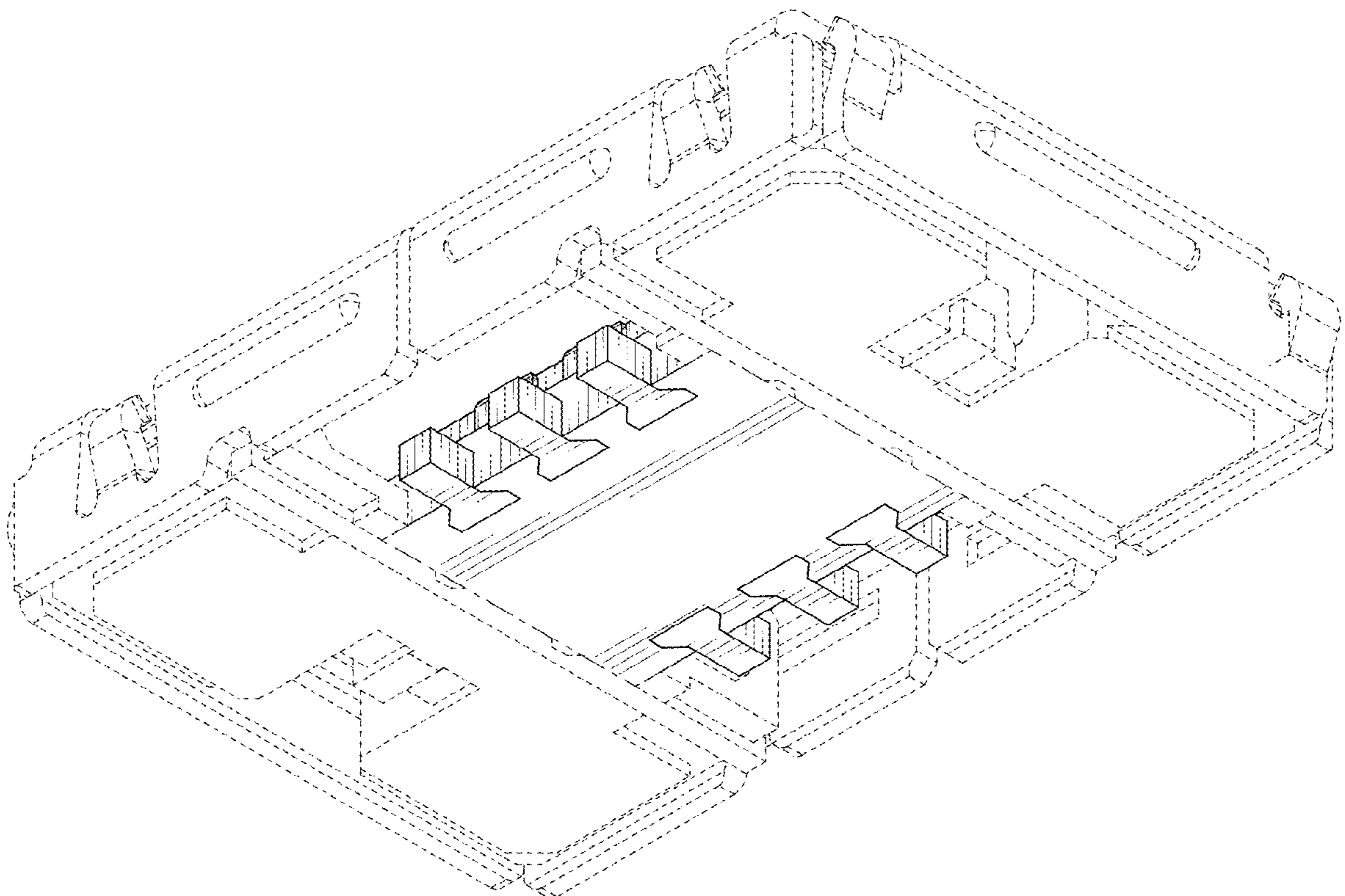
