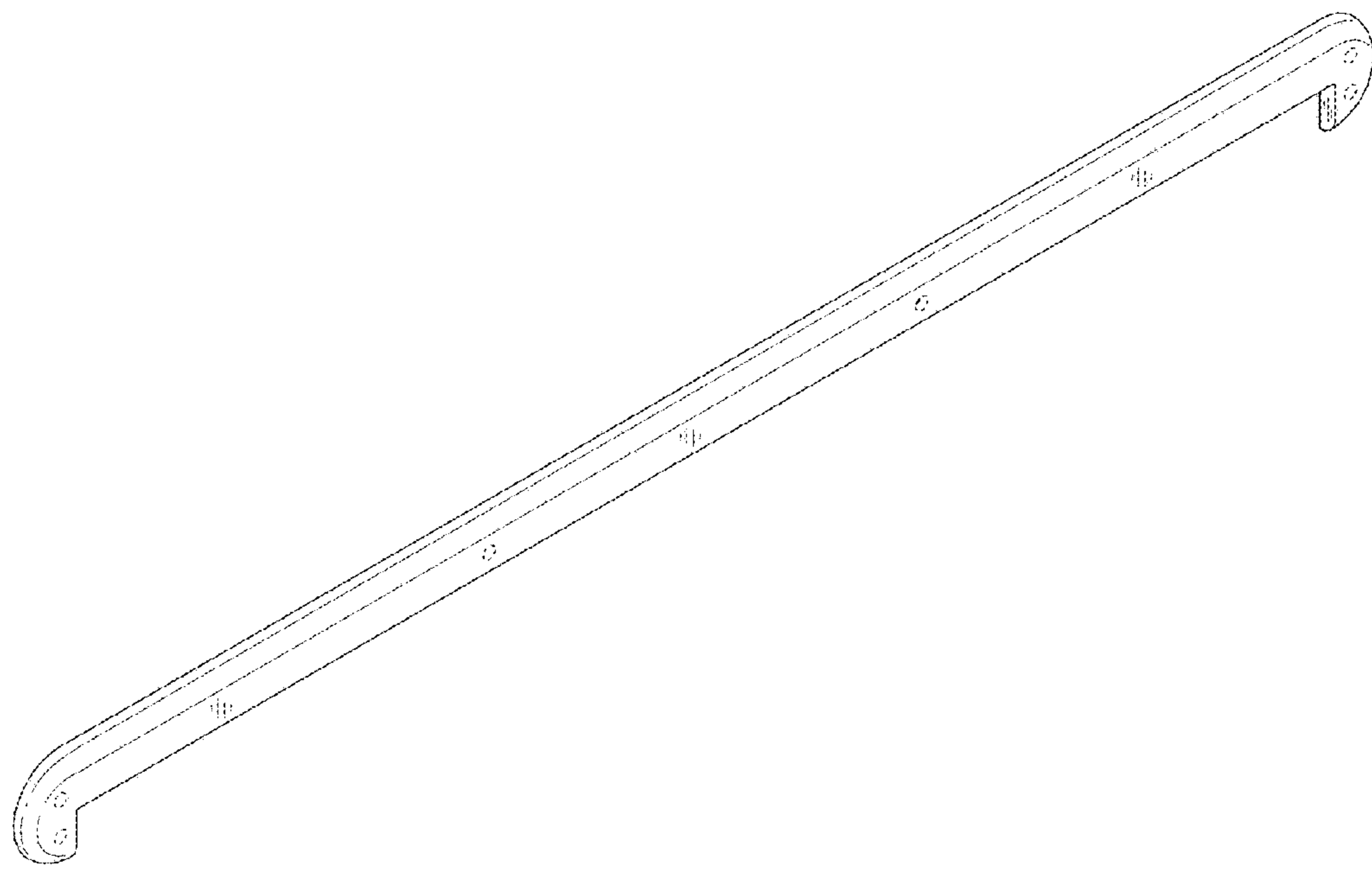
(57) **CLAIM**

The ornamental design for an anti-ligature door frame cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an anti-ligature door frame cover showing our new design; FIG. 2 is a front side view thereof; FIG. 3 is a back side view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a left side view thereof; and, FIG. 7 is a right side view thereof. The broken lines are included for the purpose of illustrating portions of the anti-ligature door frame cover that form no part of the claimed design.

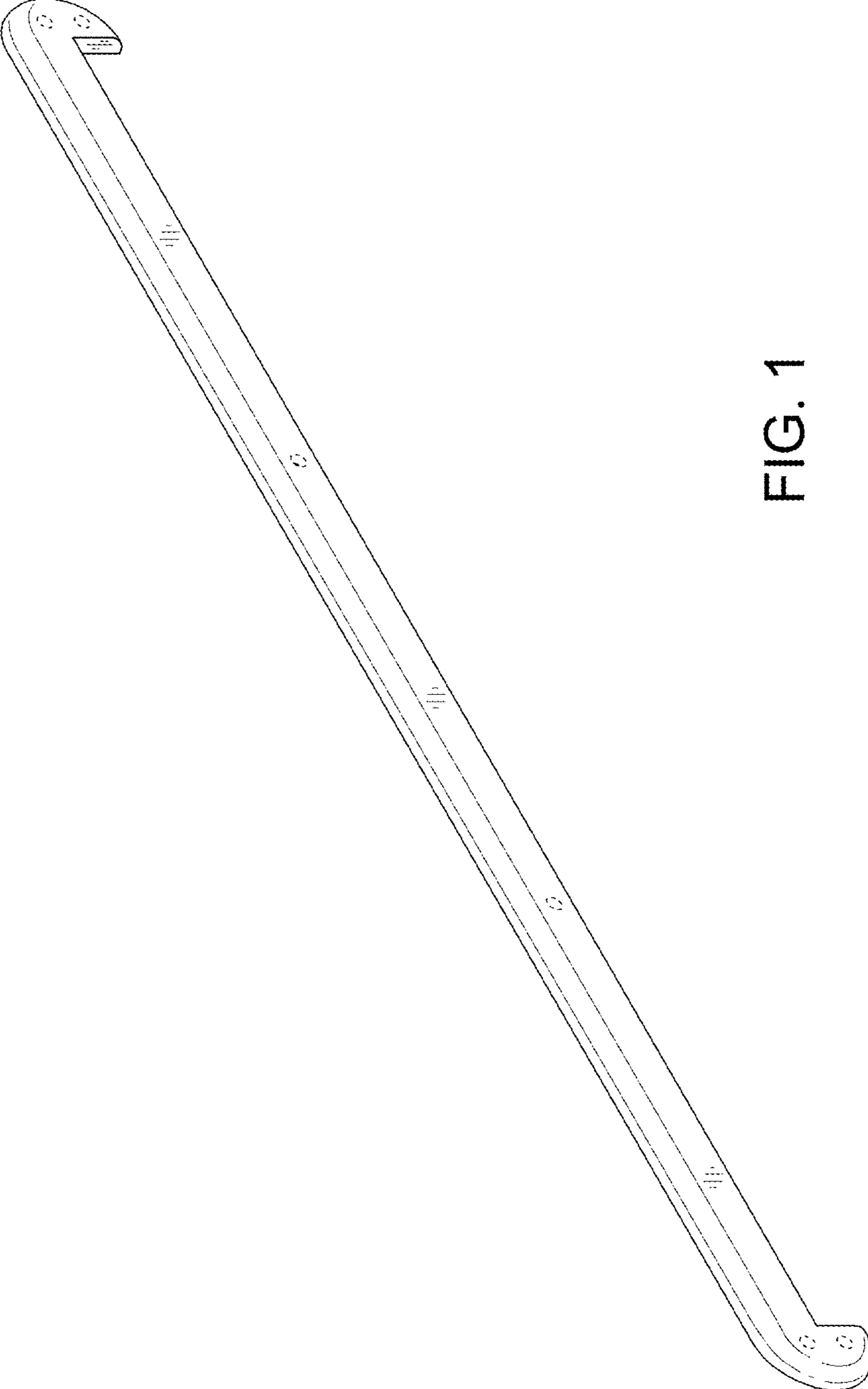

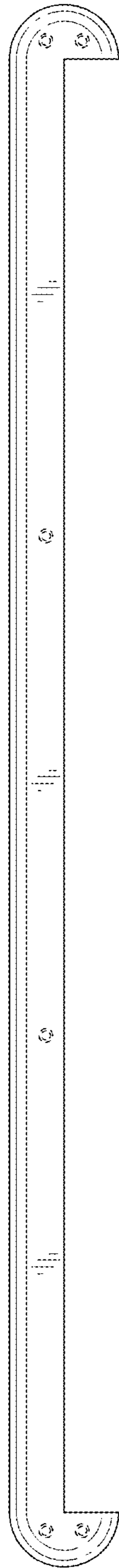

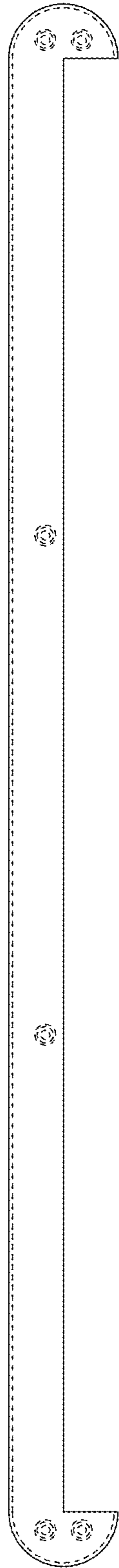

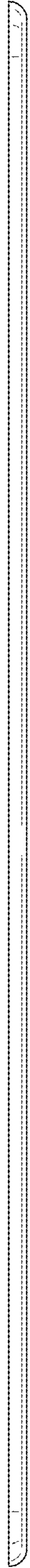

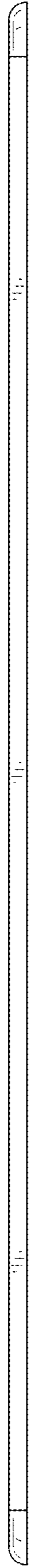

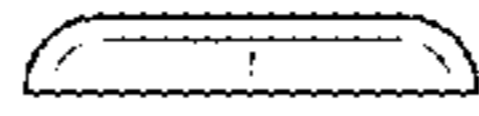

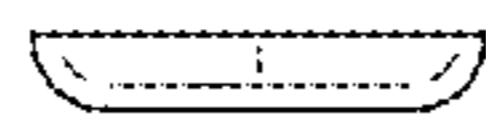
