The ornamental design for a wig with lace headband, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a wig with lace headband showing my new design;

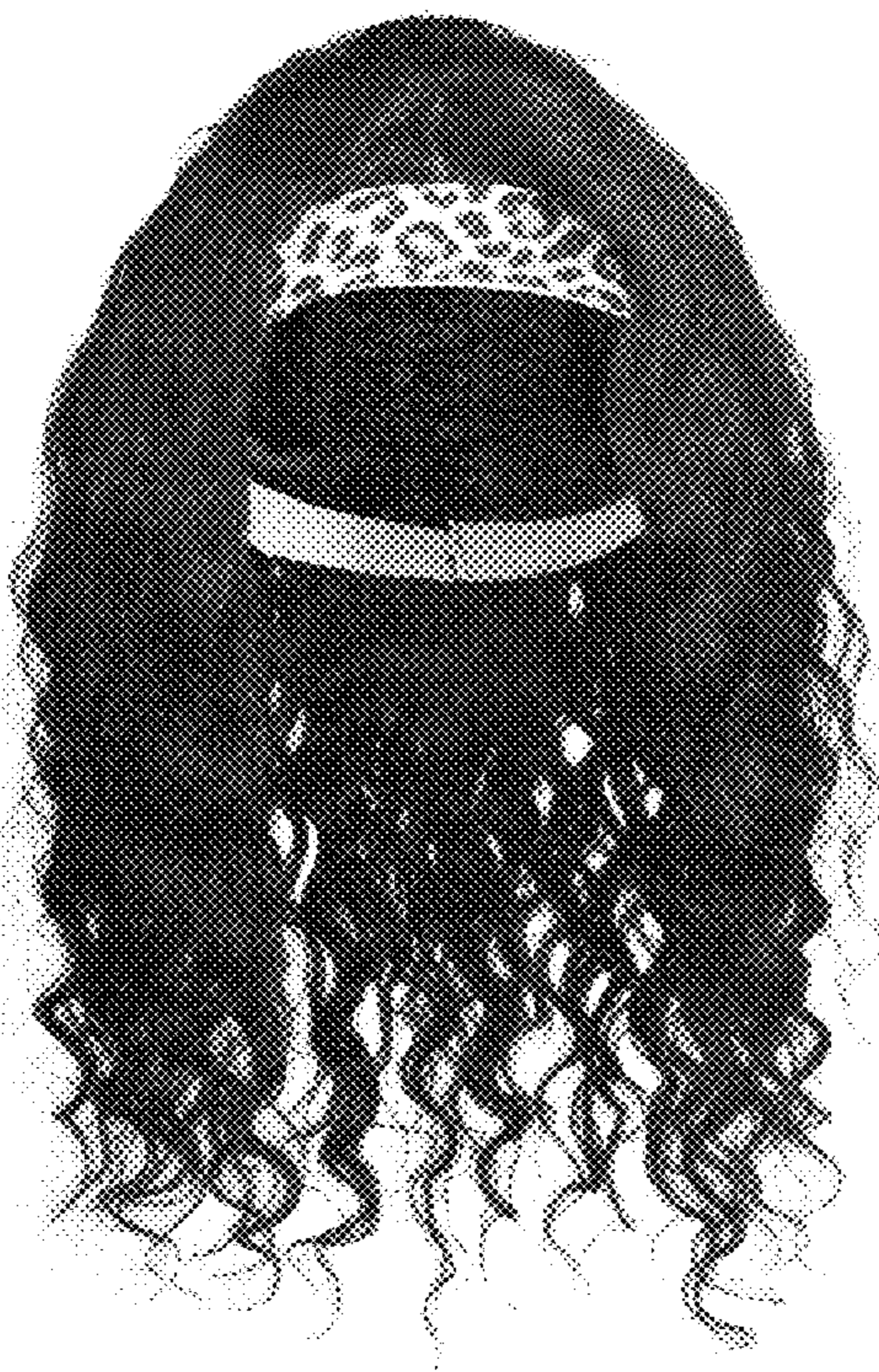
