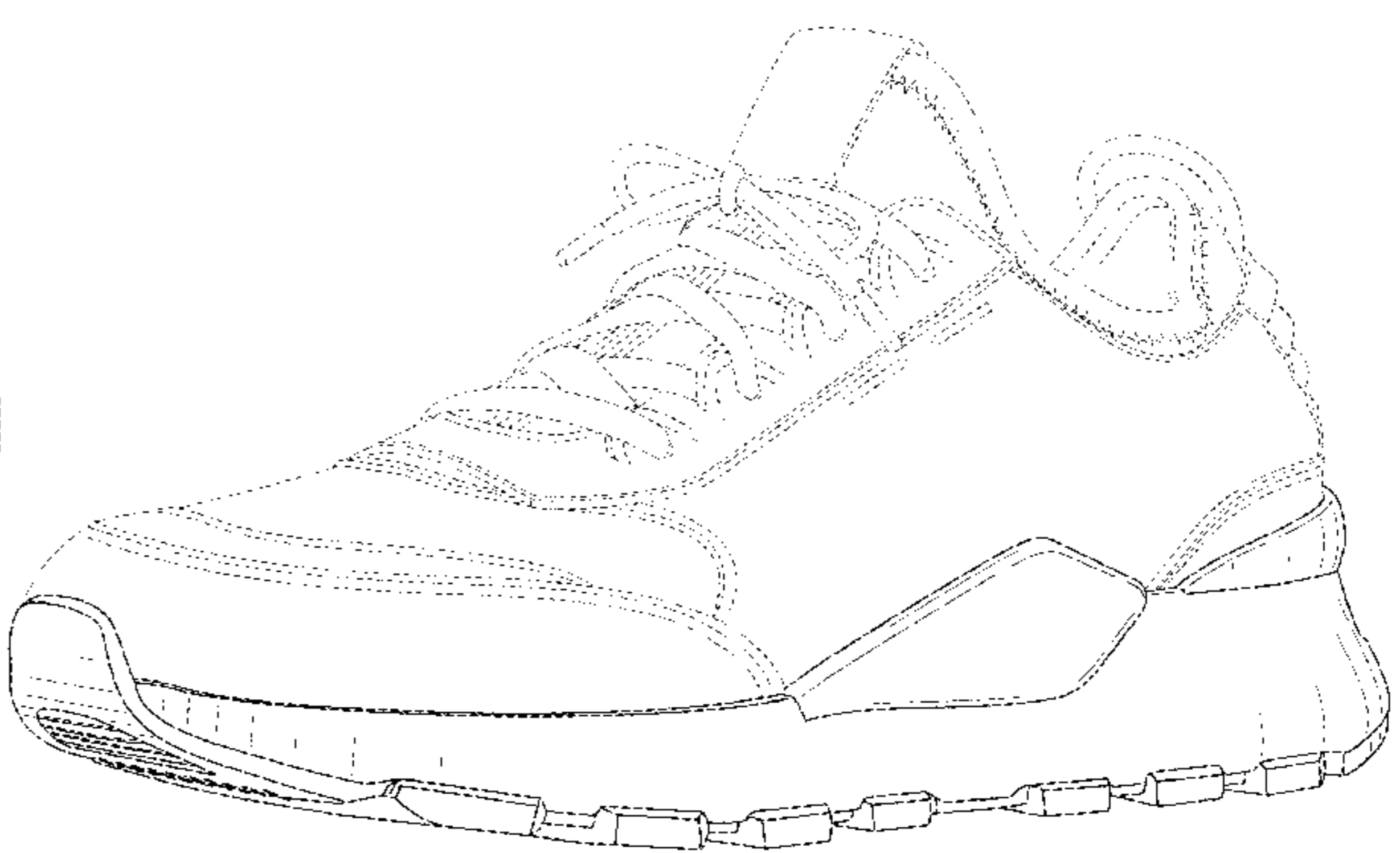
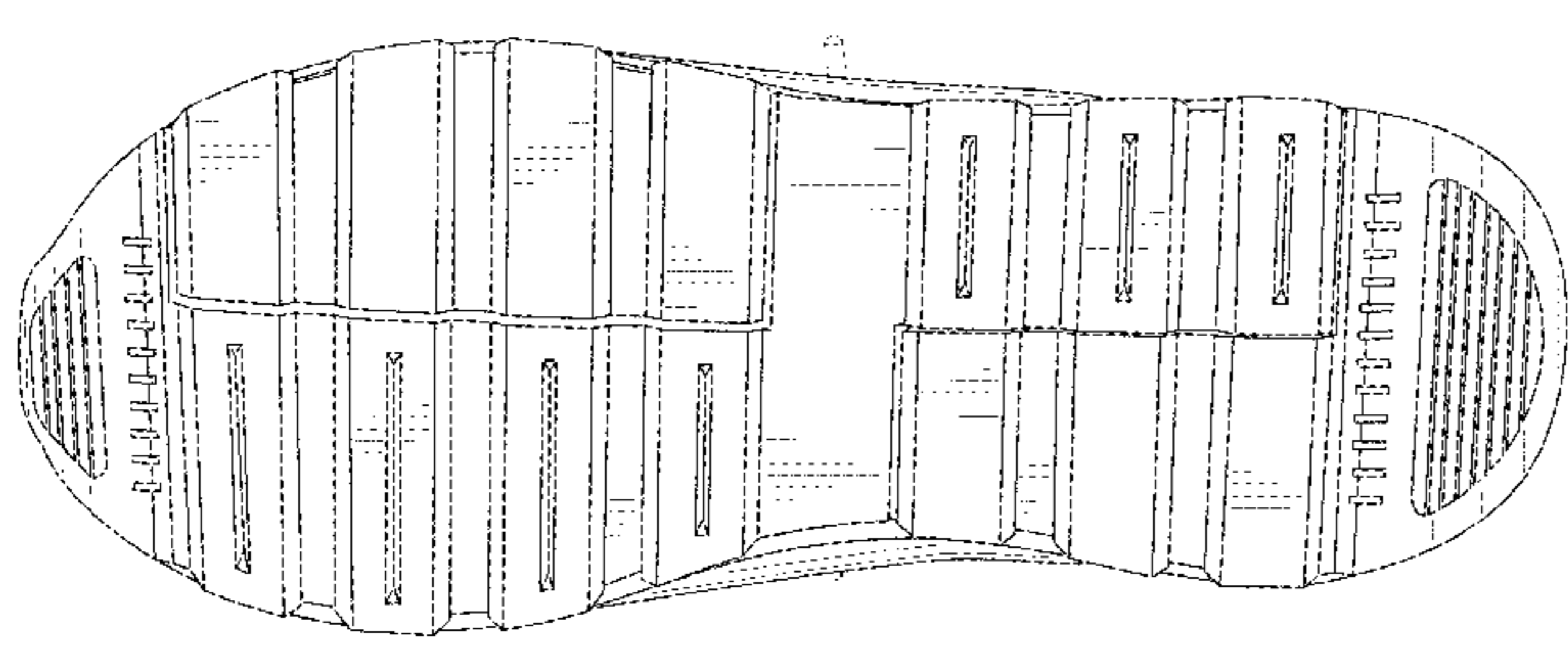
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a lateral side view of a shoe showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a medial side view thereof;

FIG. 5 is a front-top perspective view thereof;
FIG. 6 is a bottom view thereof;

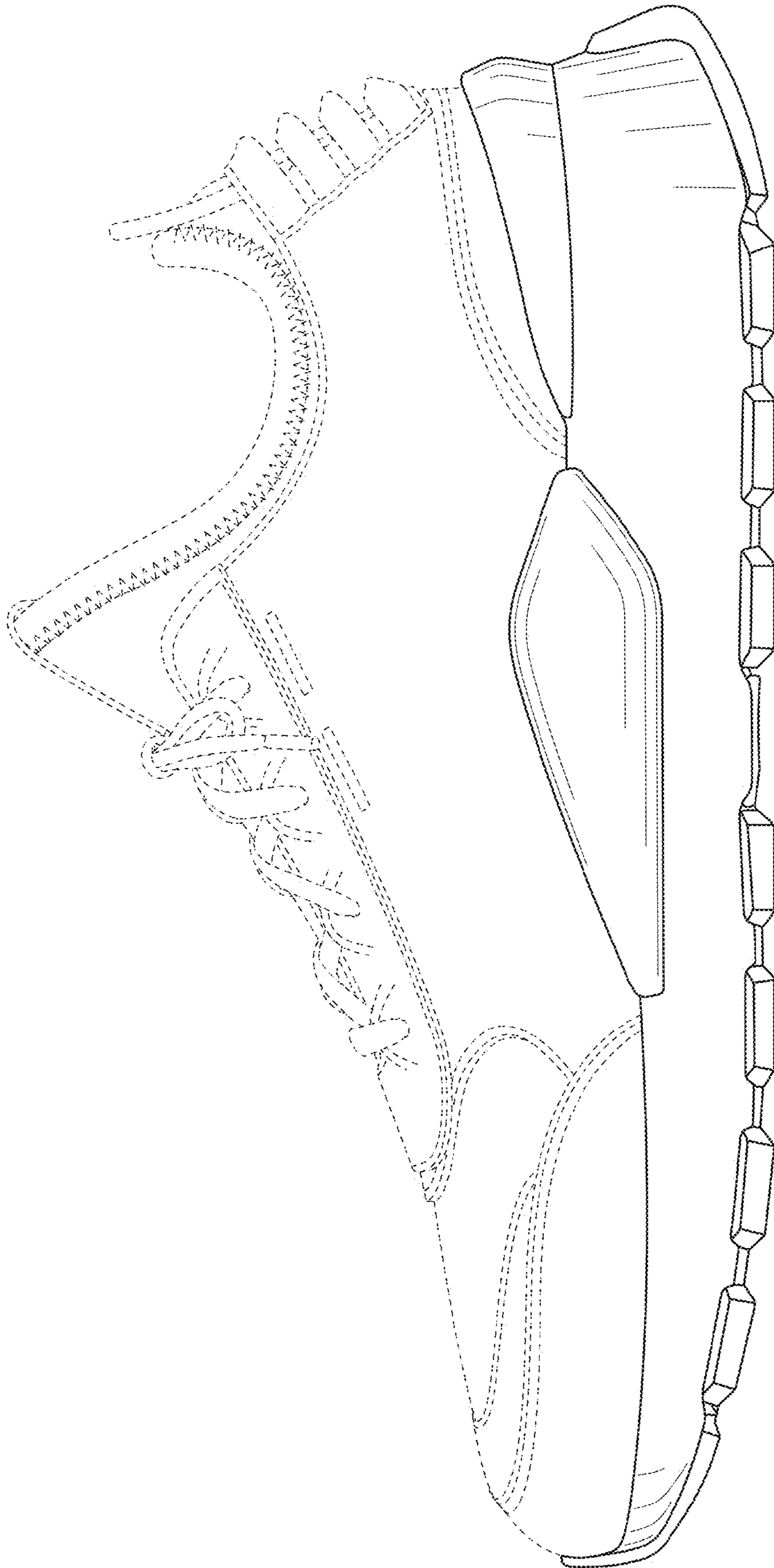

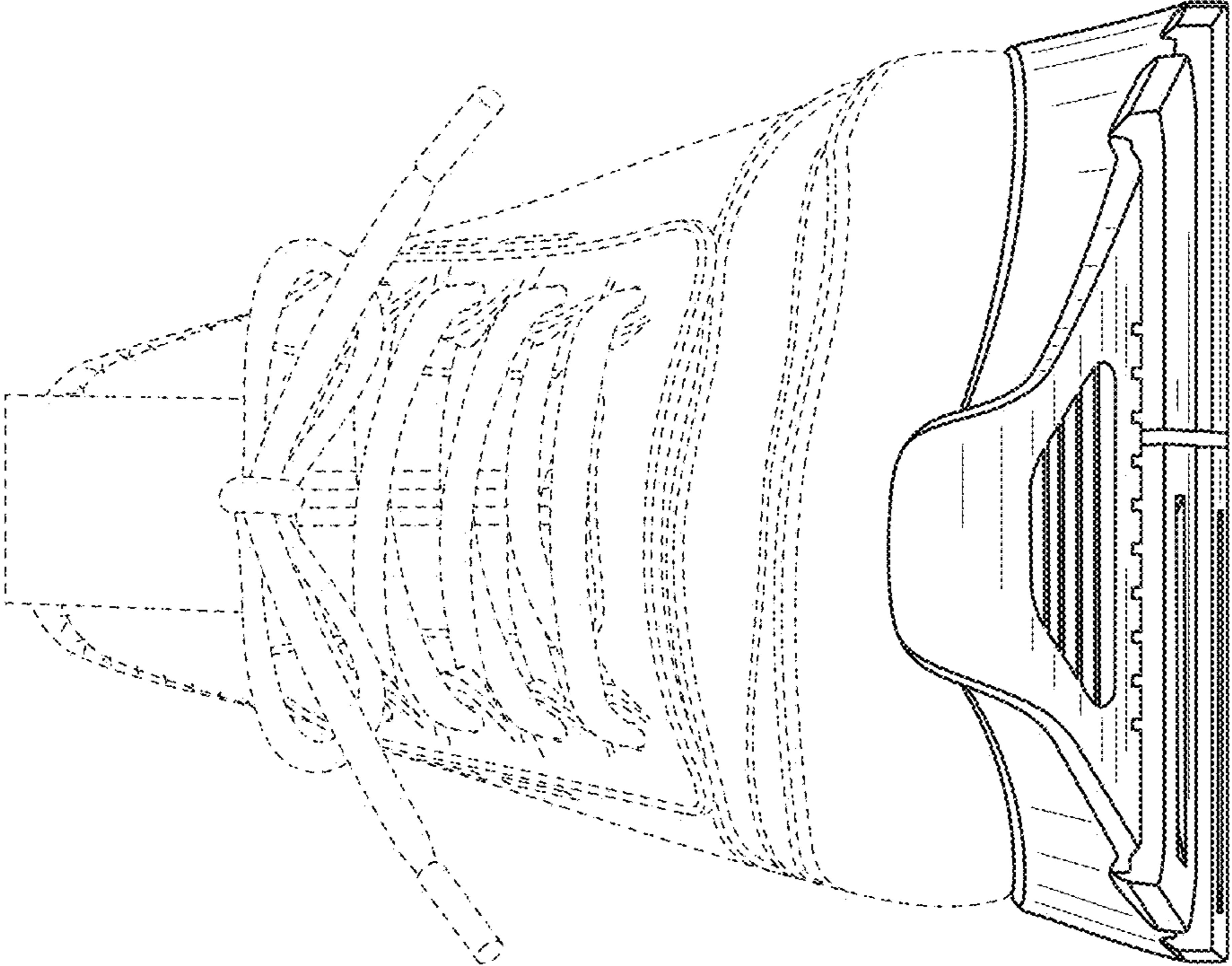

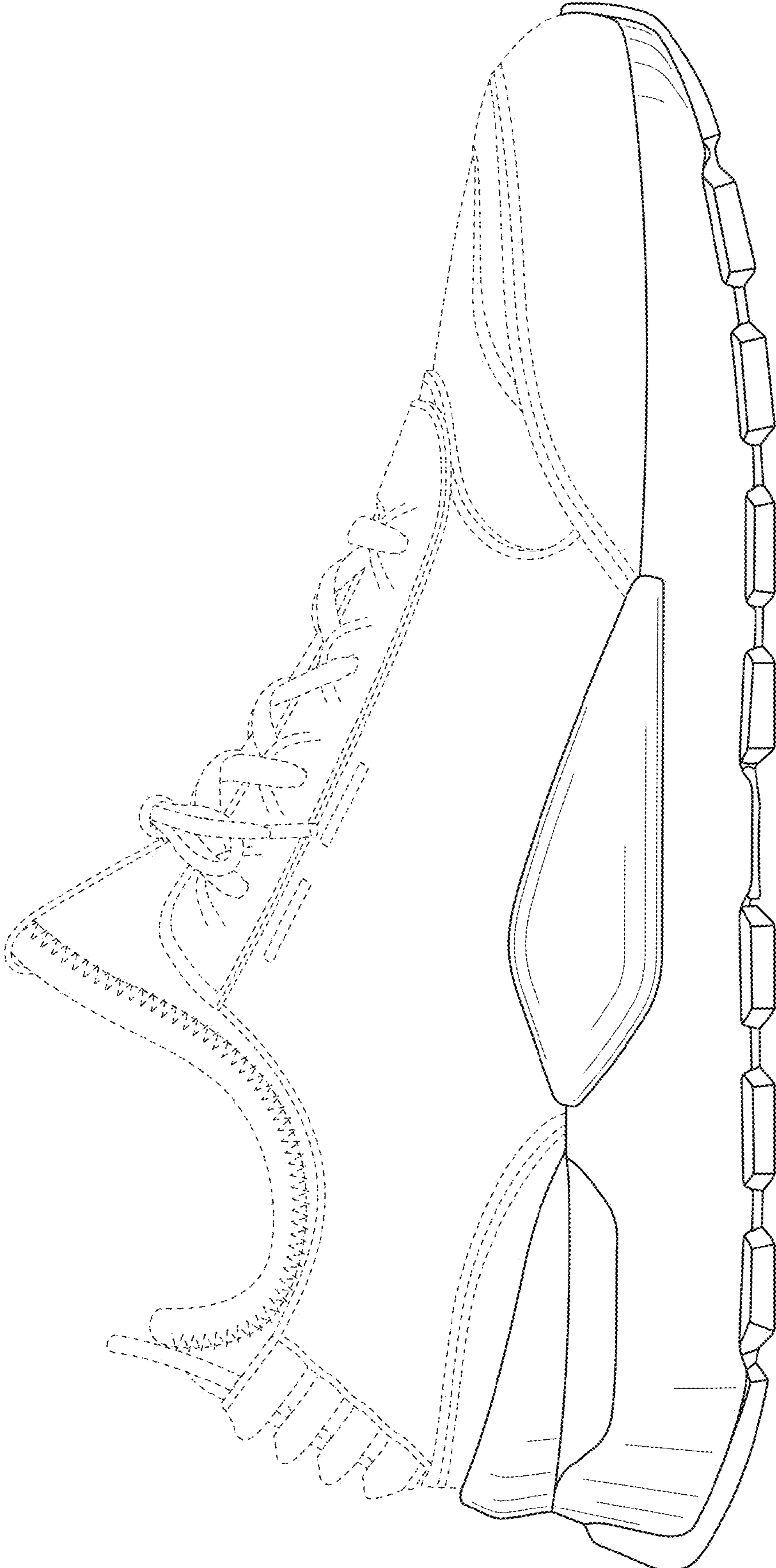

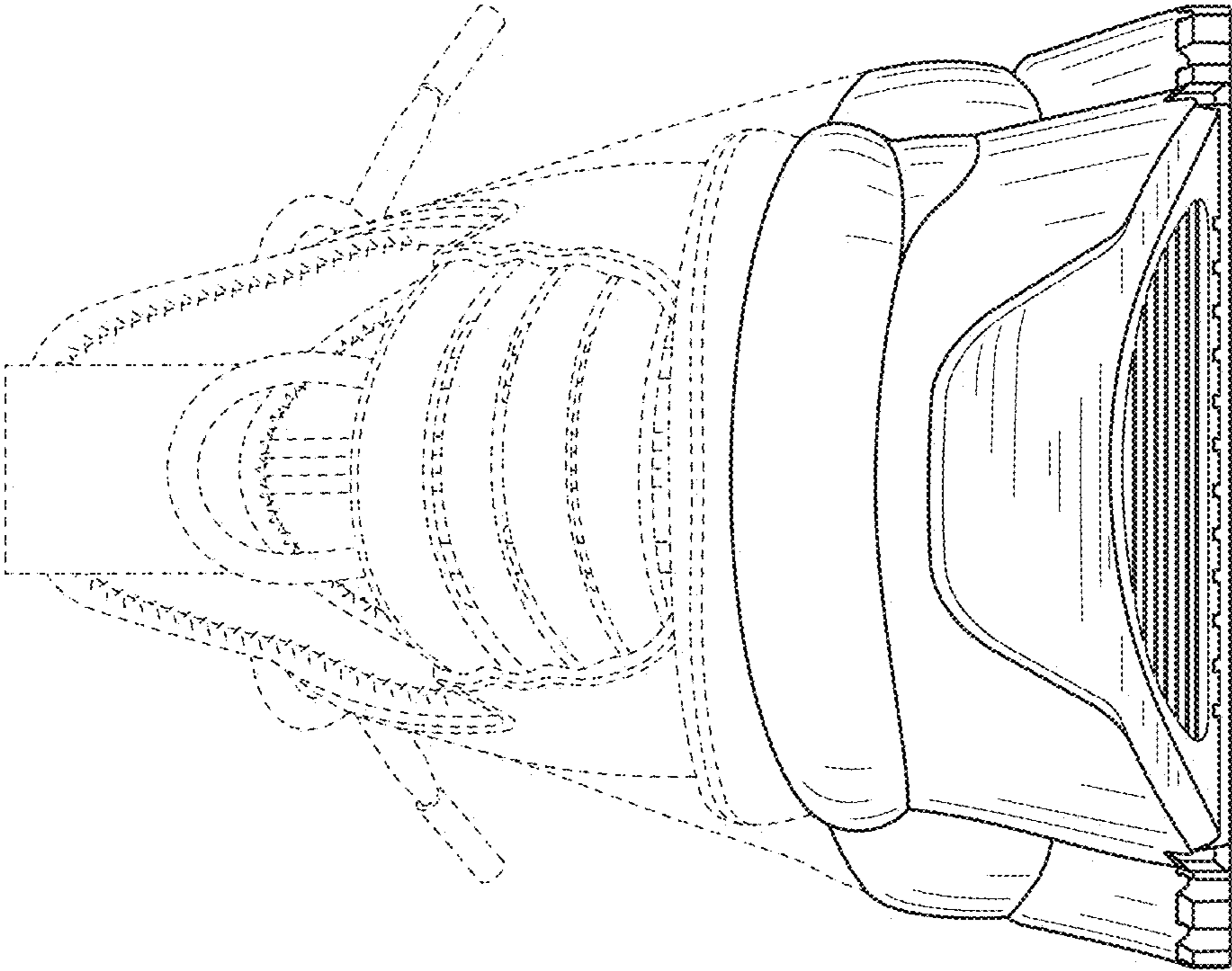

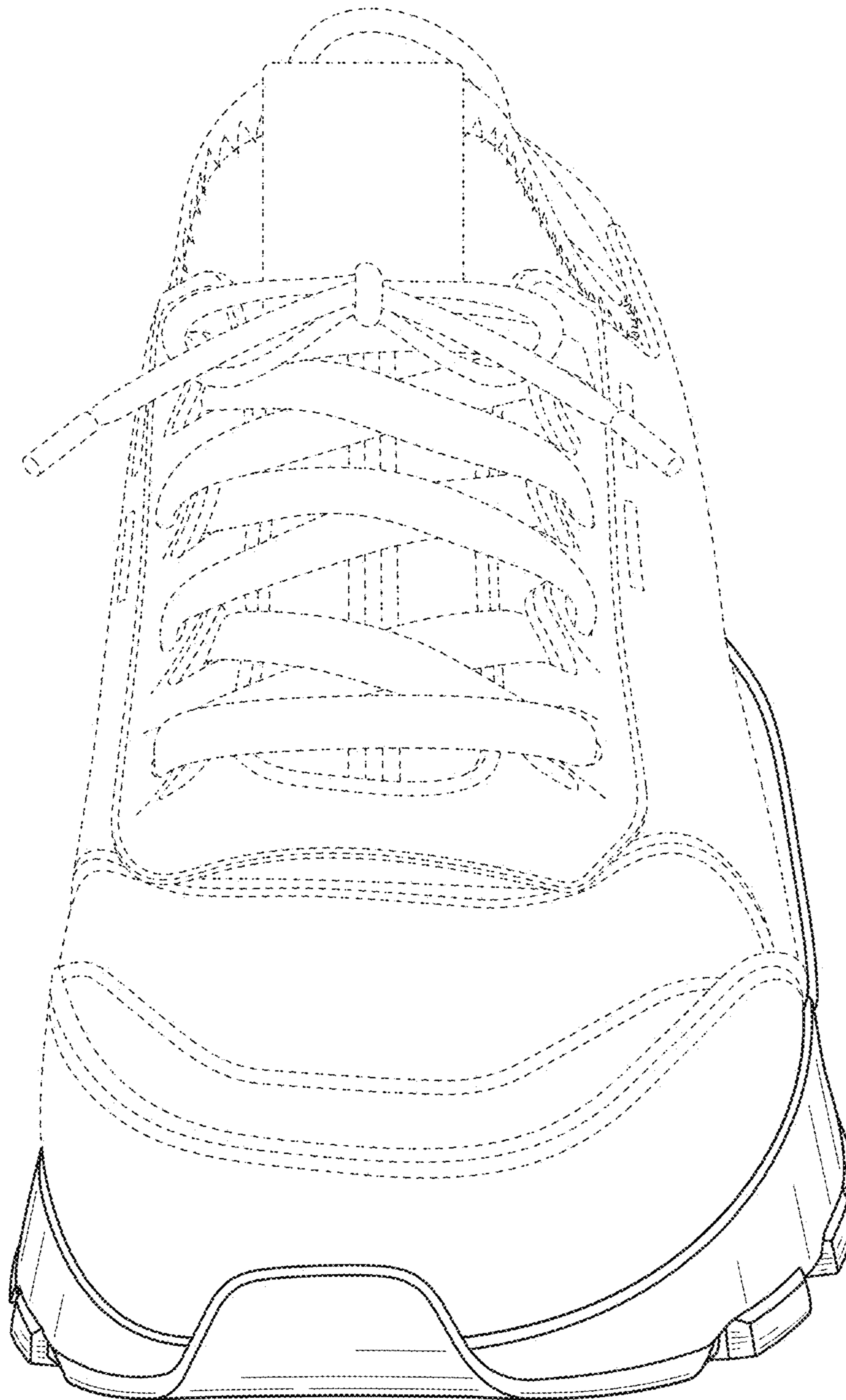

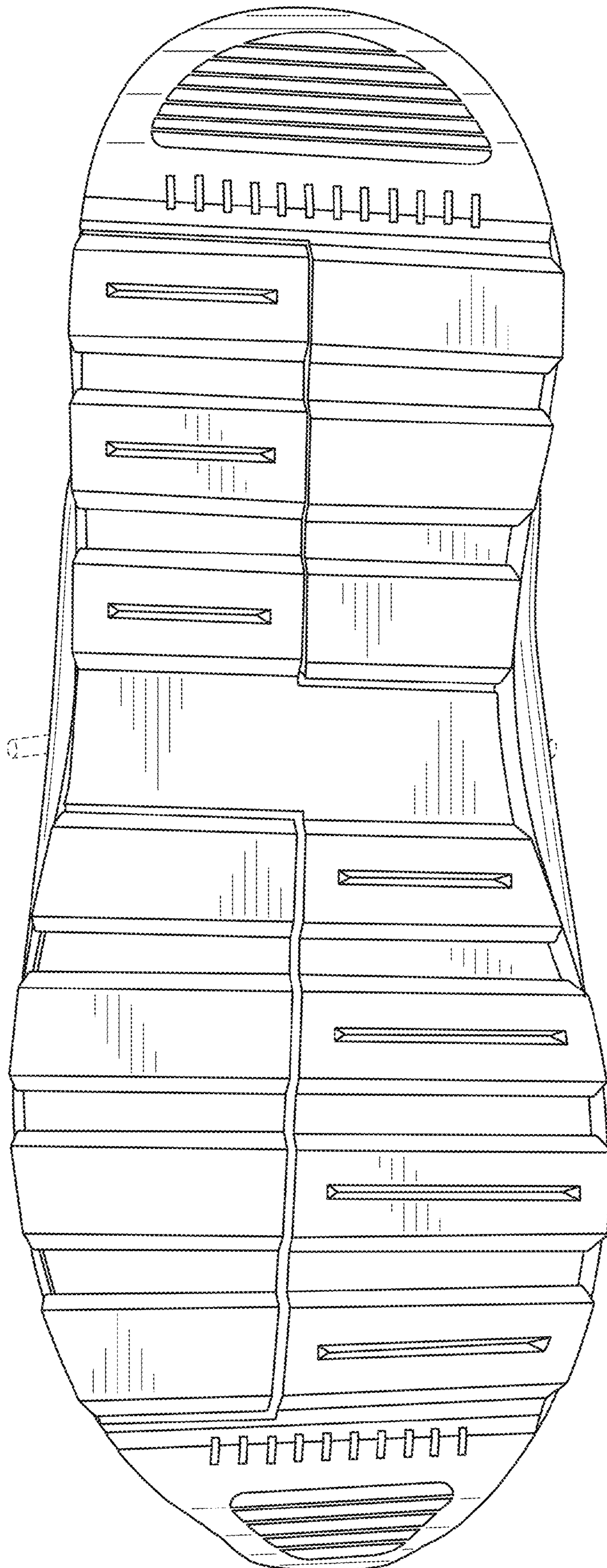

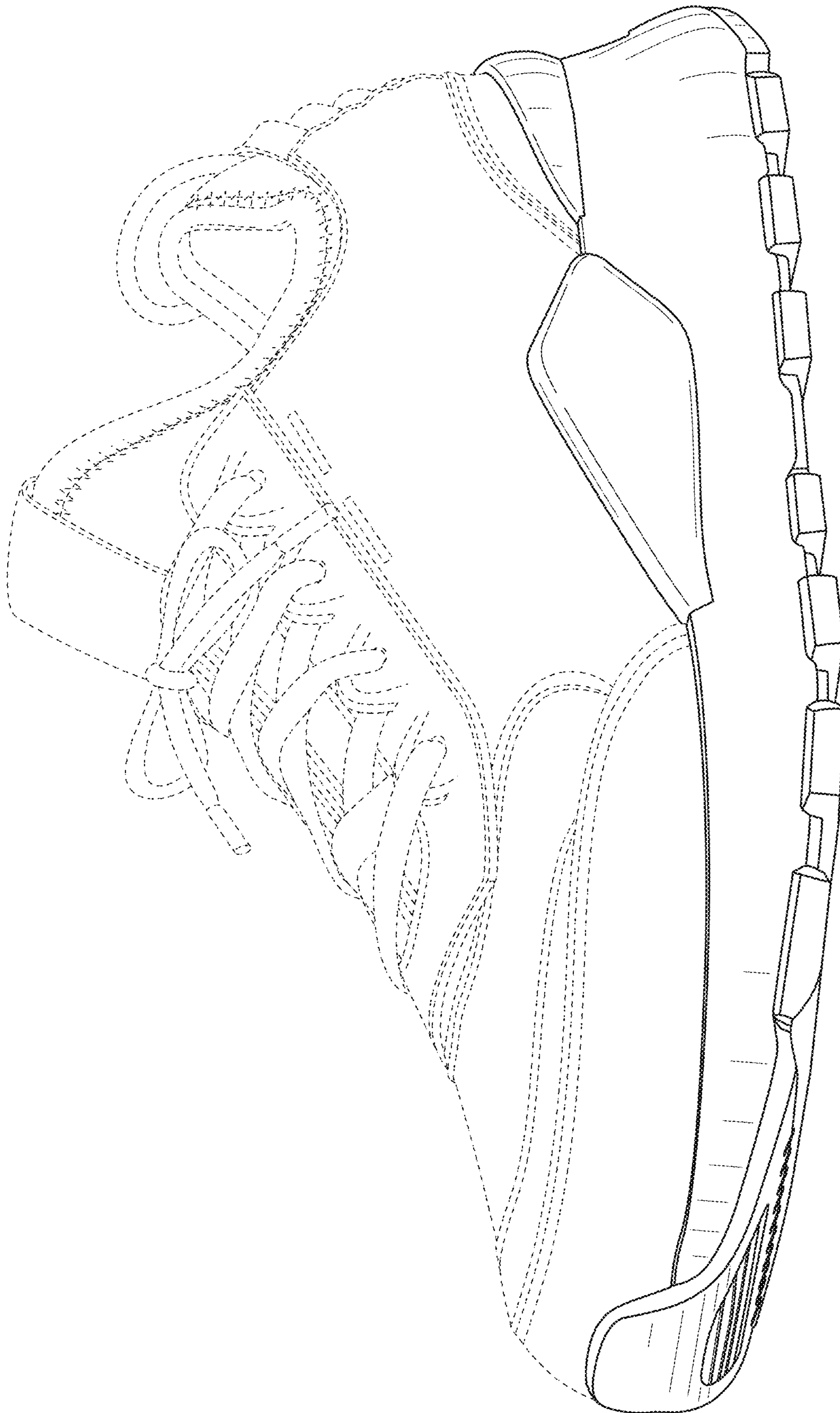

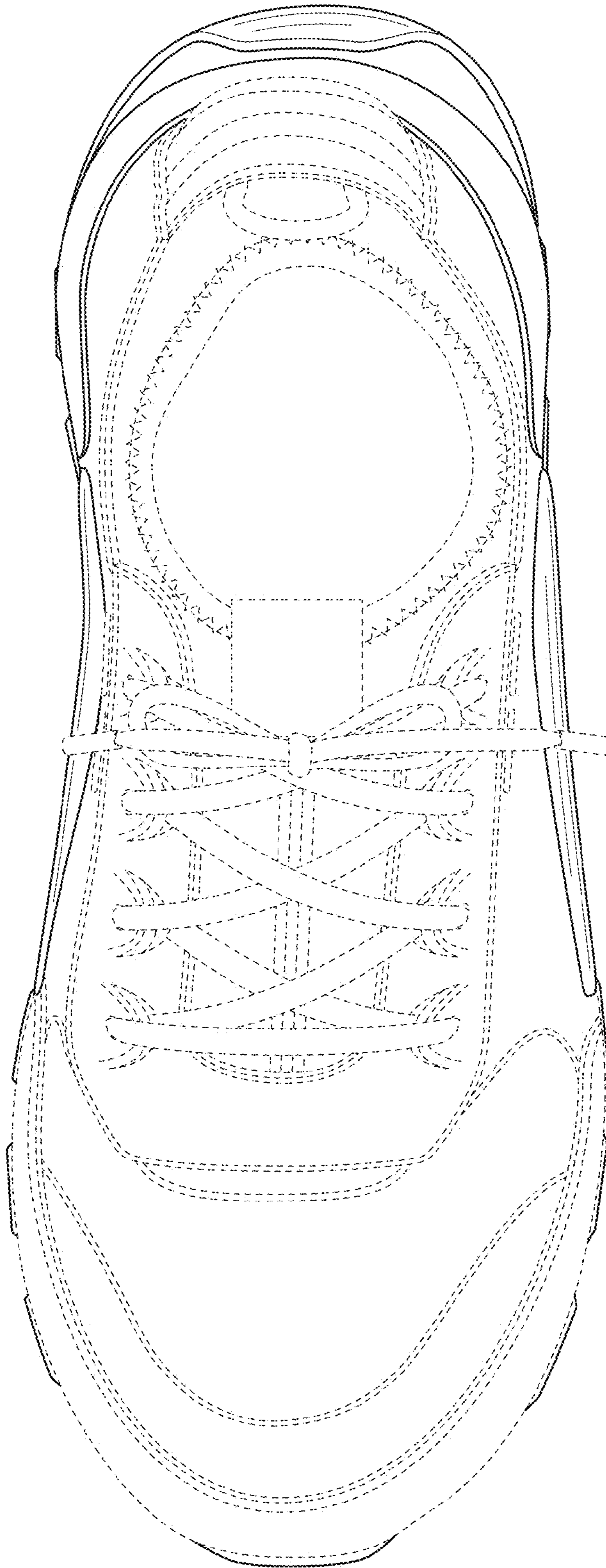
