(57) **CLAIM**

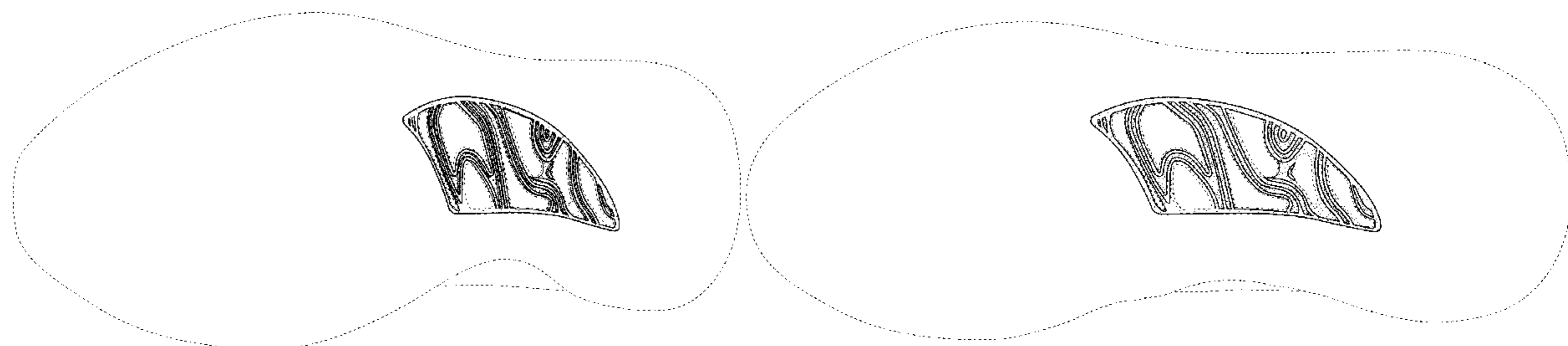
I claim the ornamental design for a shoe, as shown and described.

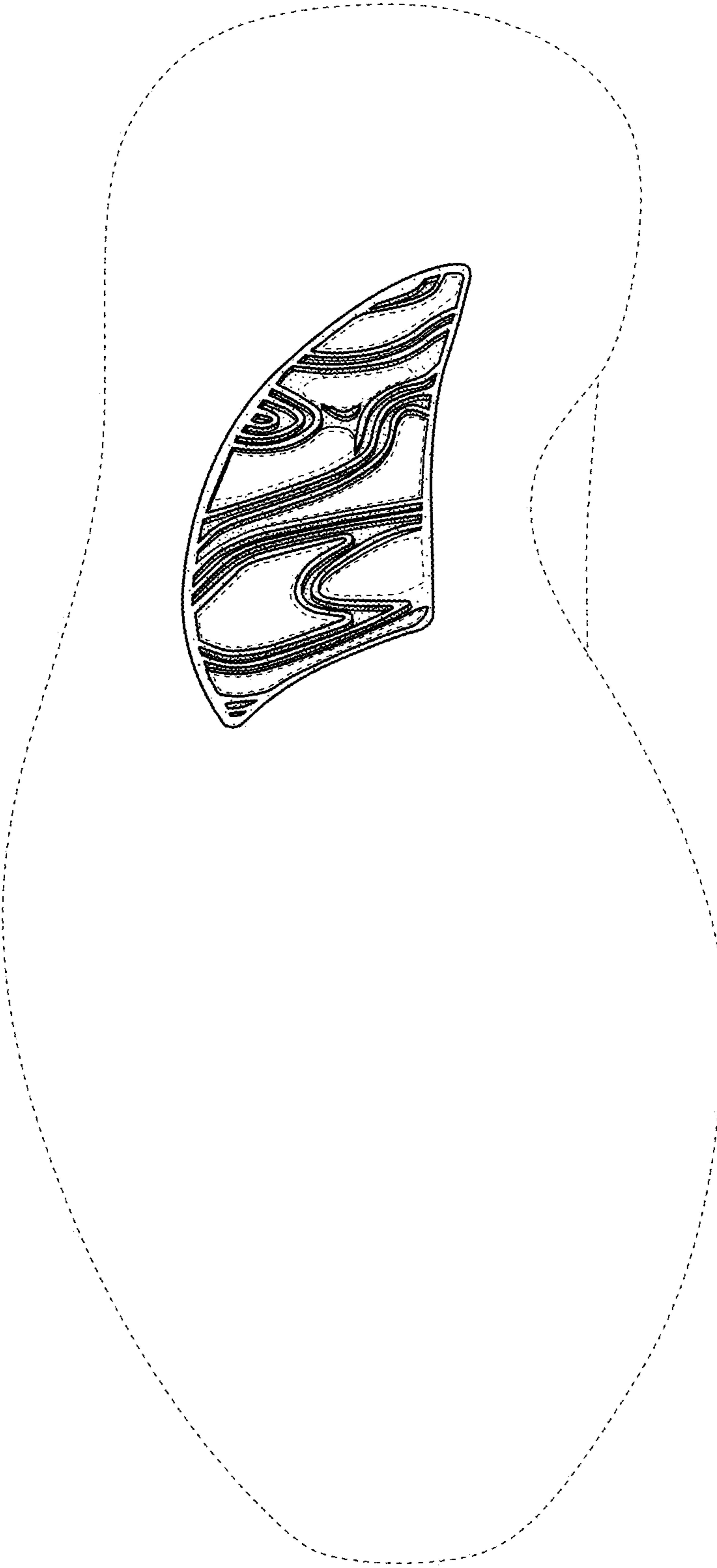

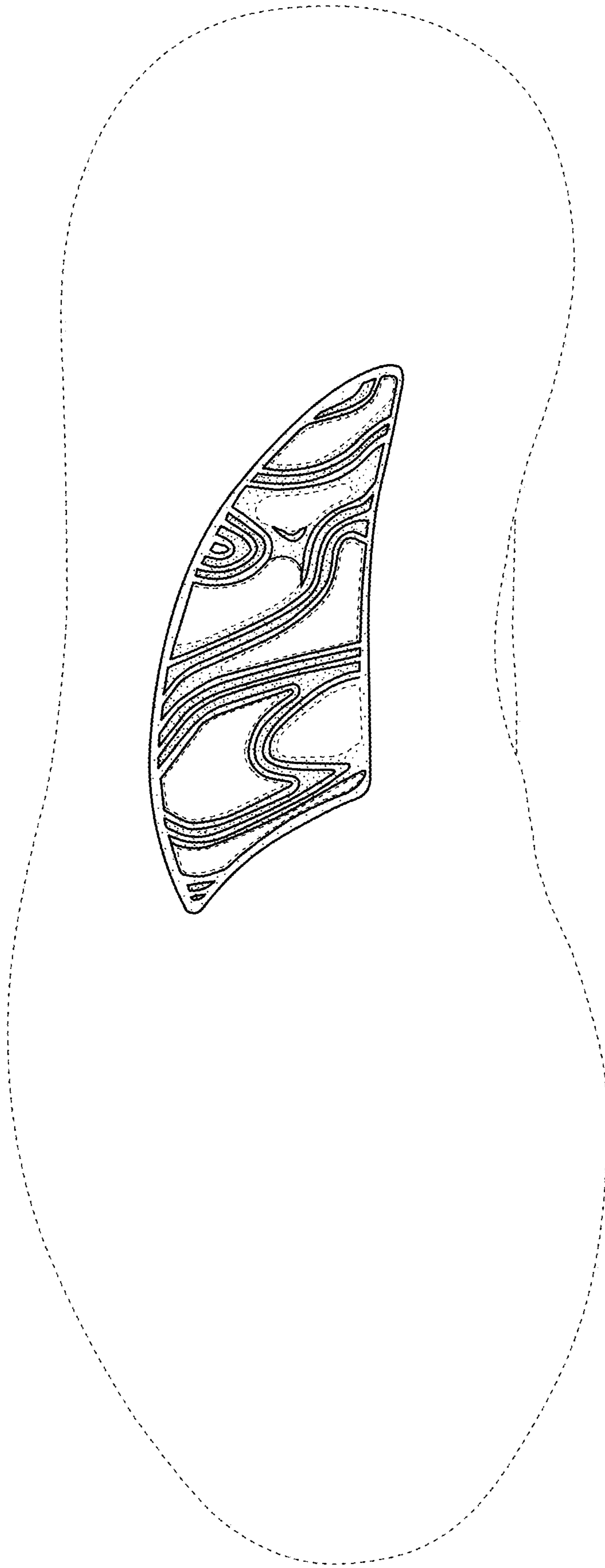

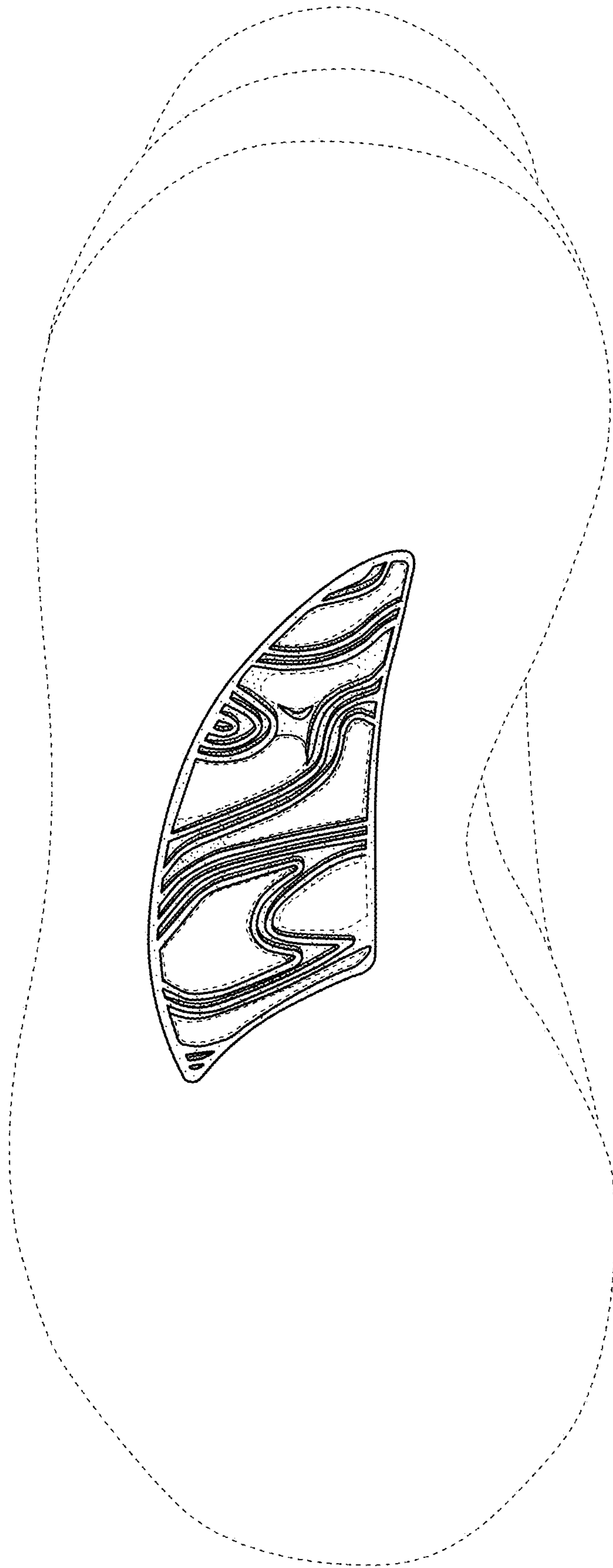
