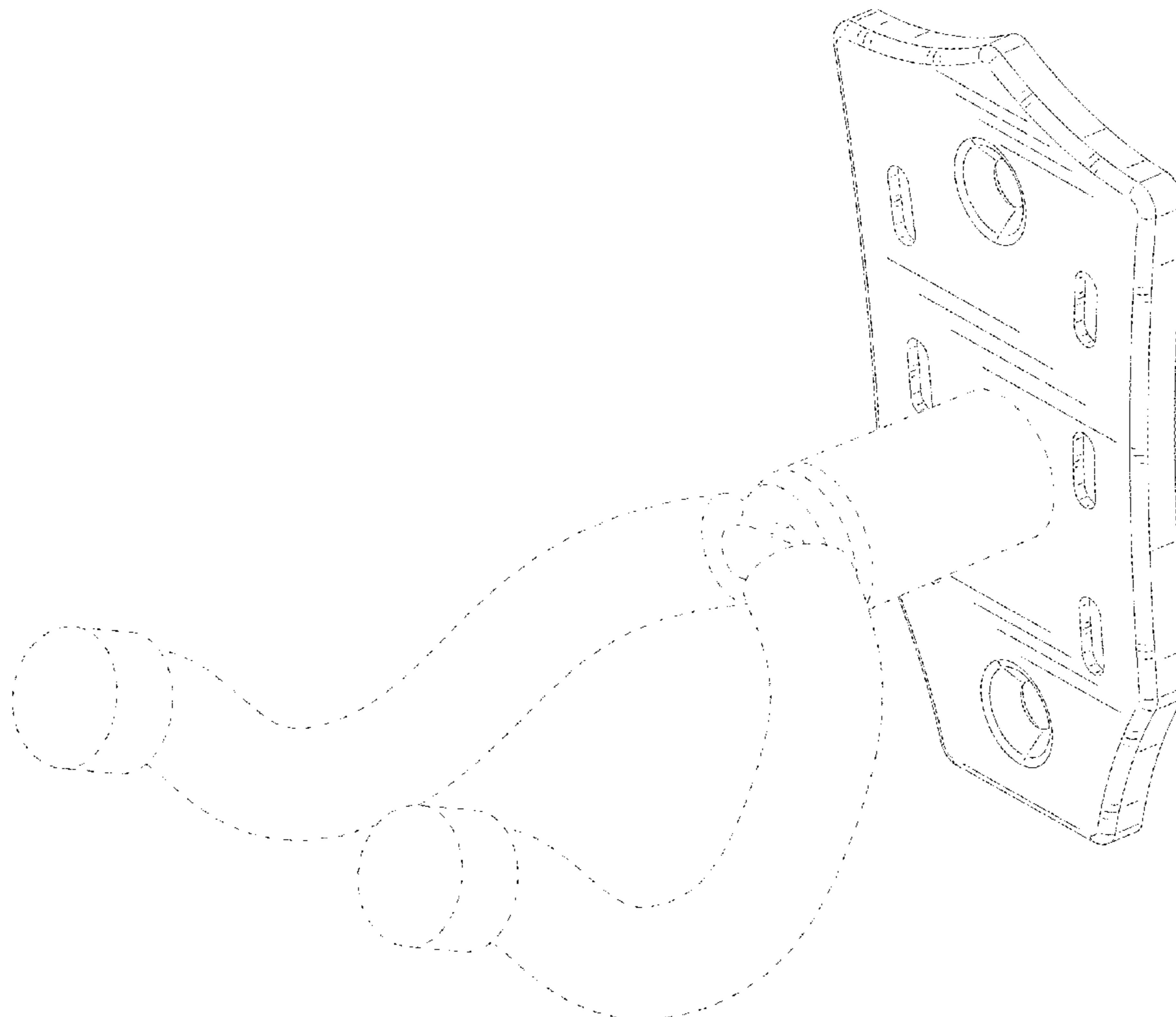
(57) **CLAIM**

The ornamental design for a hook pedestal for guitar, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the hook pedestal for guitar showing my new design;  
FIG. 2 is a perspective view thereof from another angle;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a left side elevational view thereof;  
FIG. 6 is a right side elevational view thereof;  
FIG. 7 is a top plan view thereof; and,  
FIG. 8 is a bottom plan view thereof.

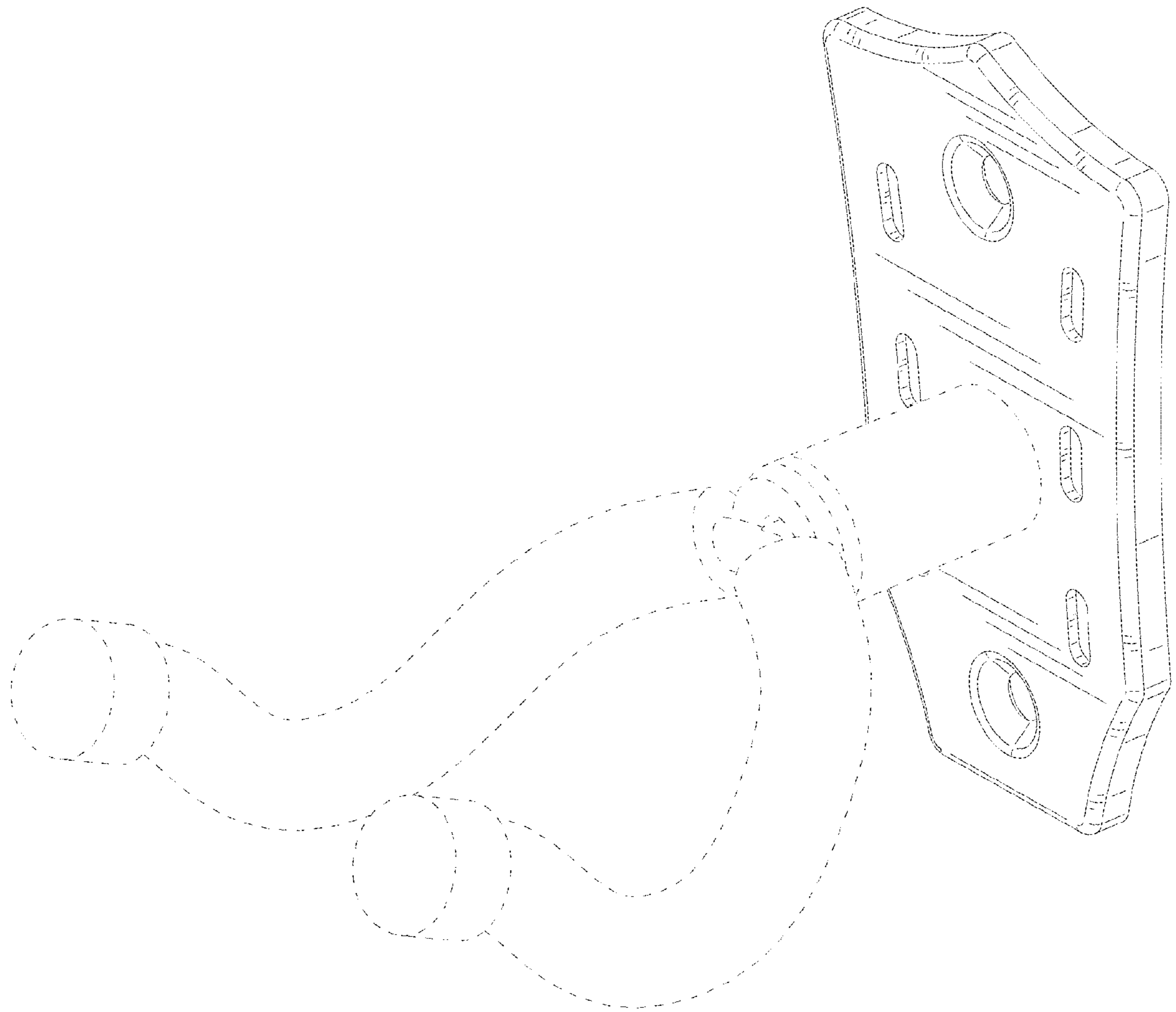

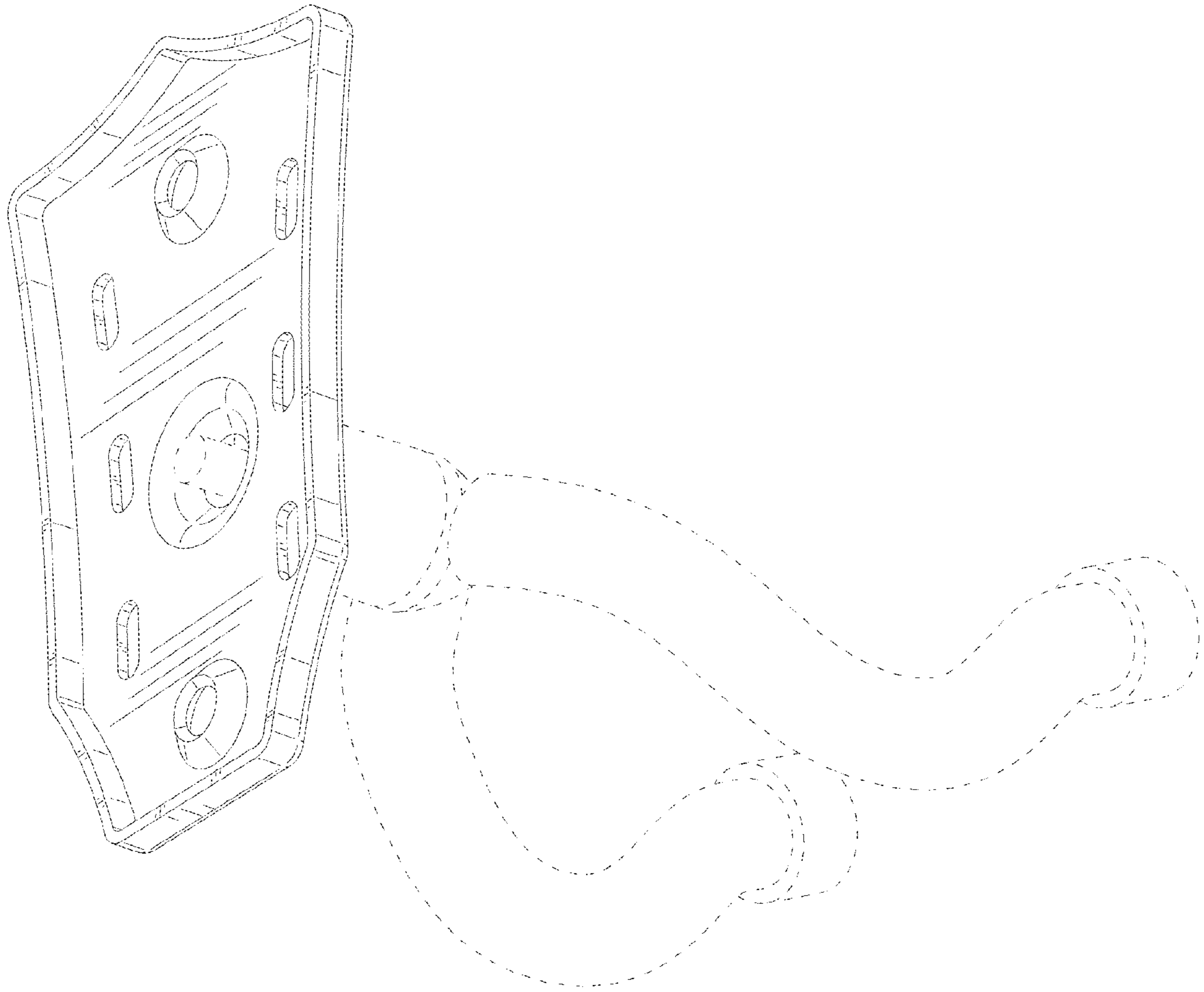

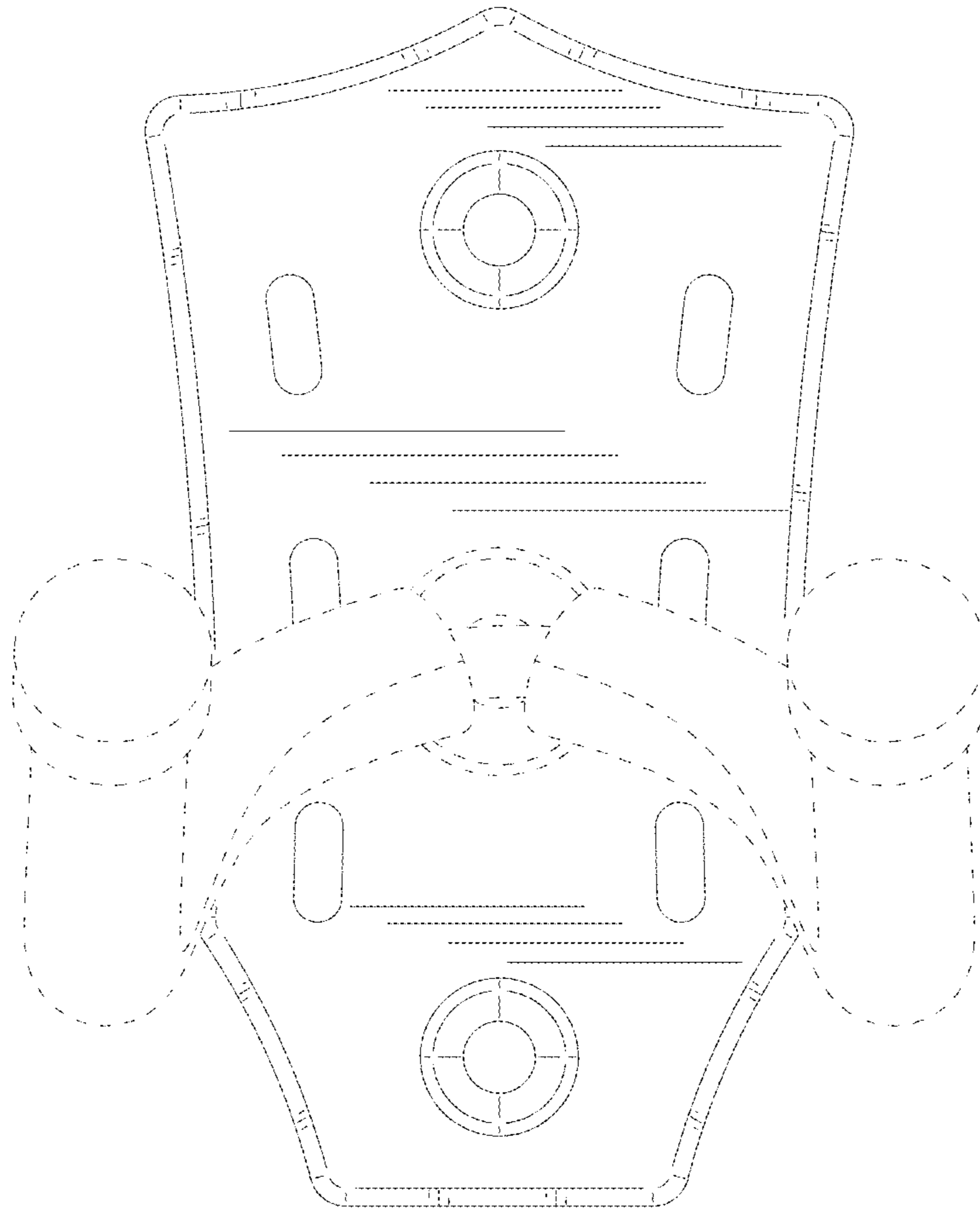

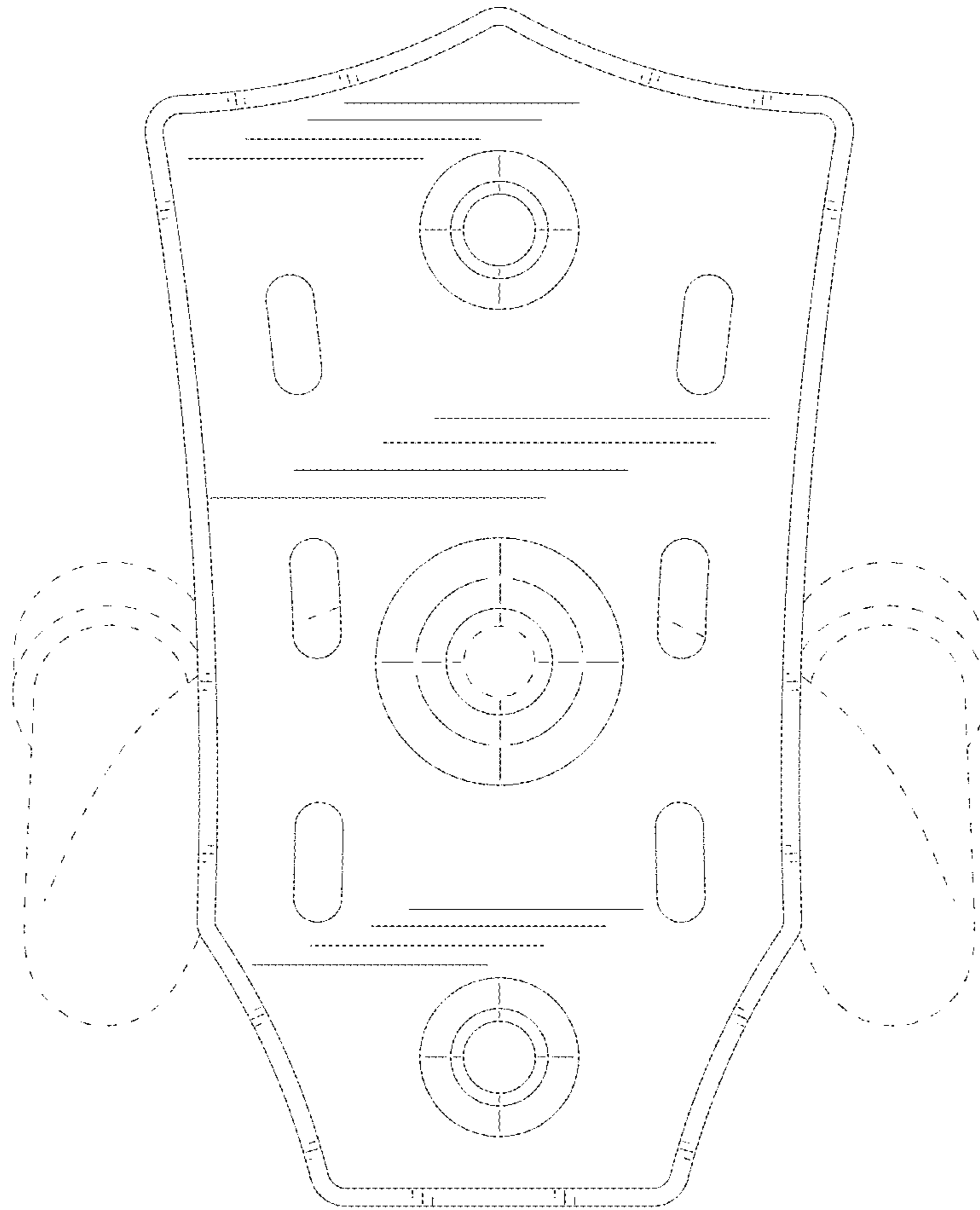

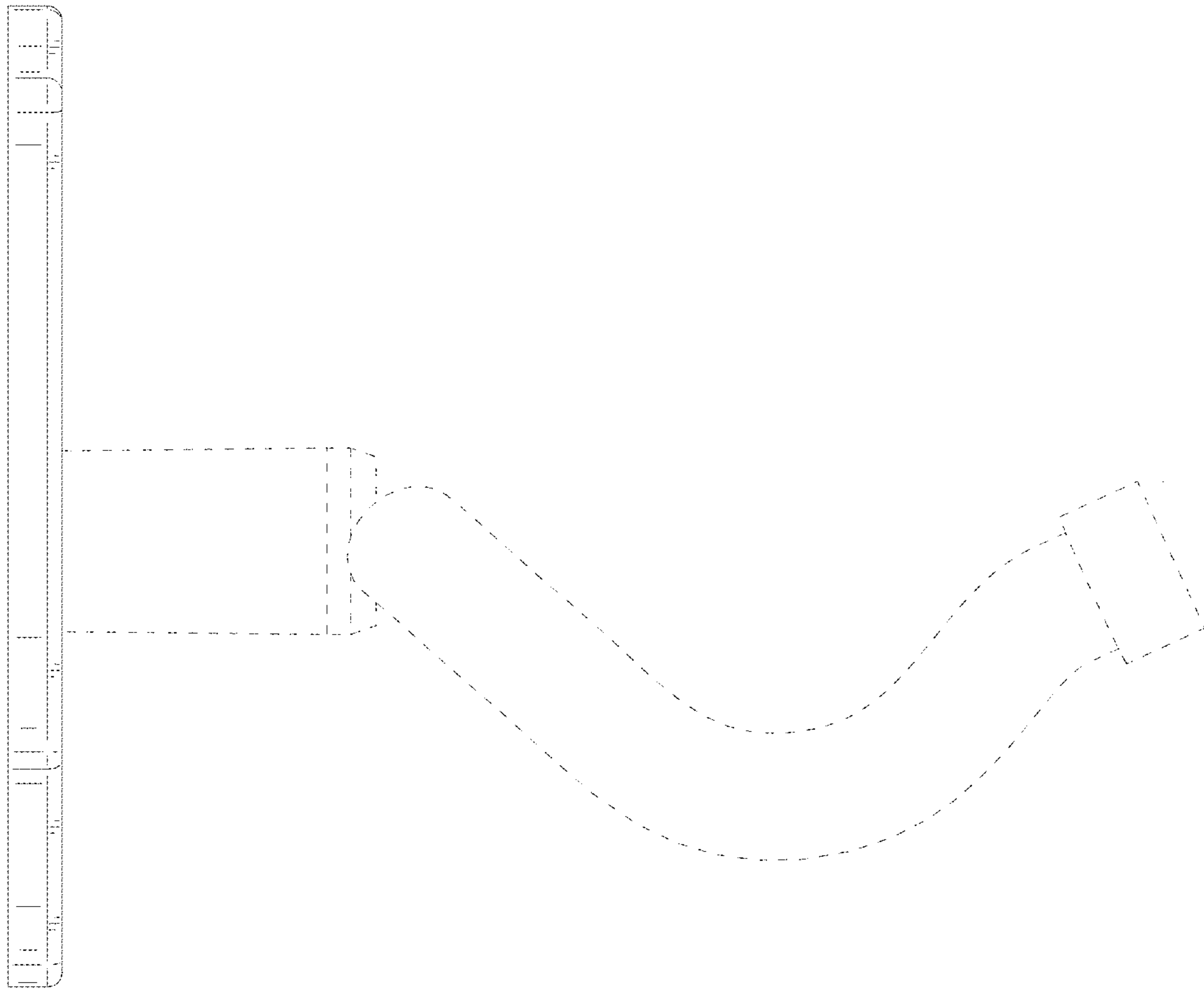

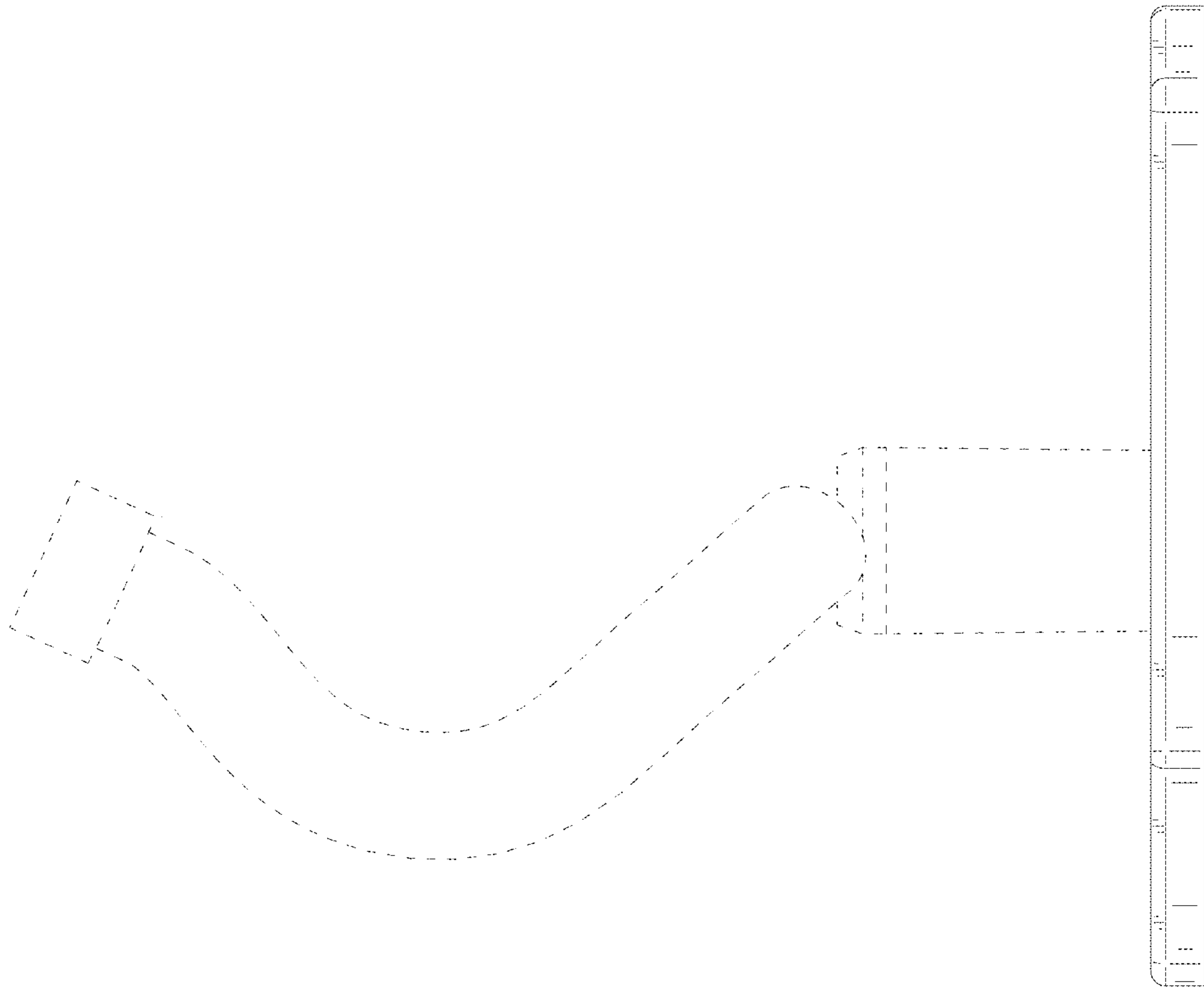

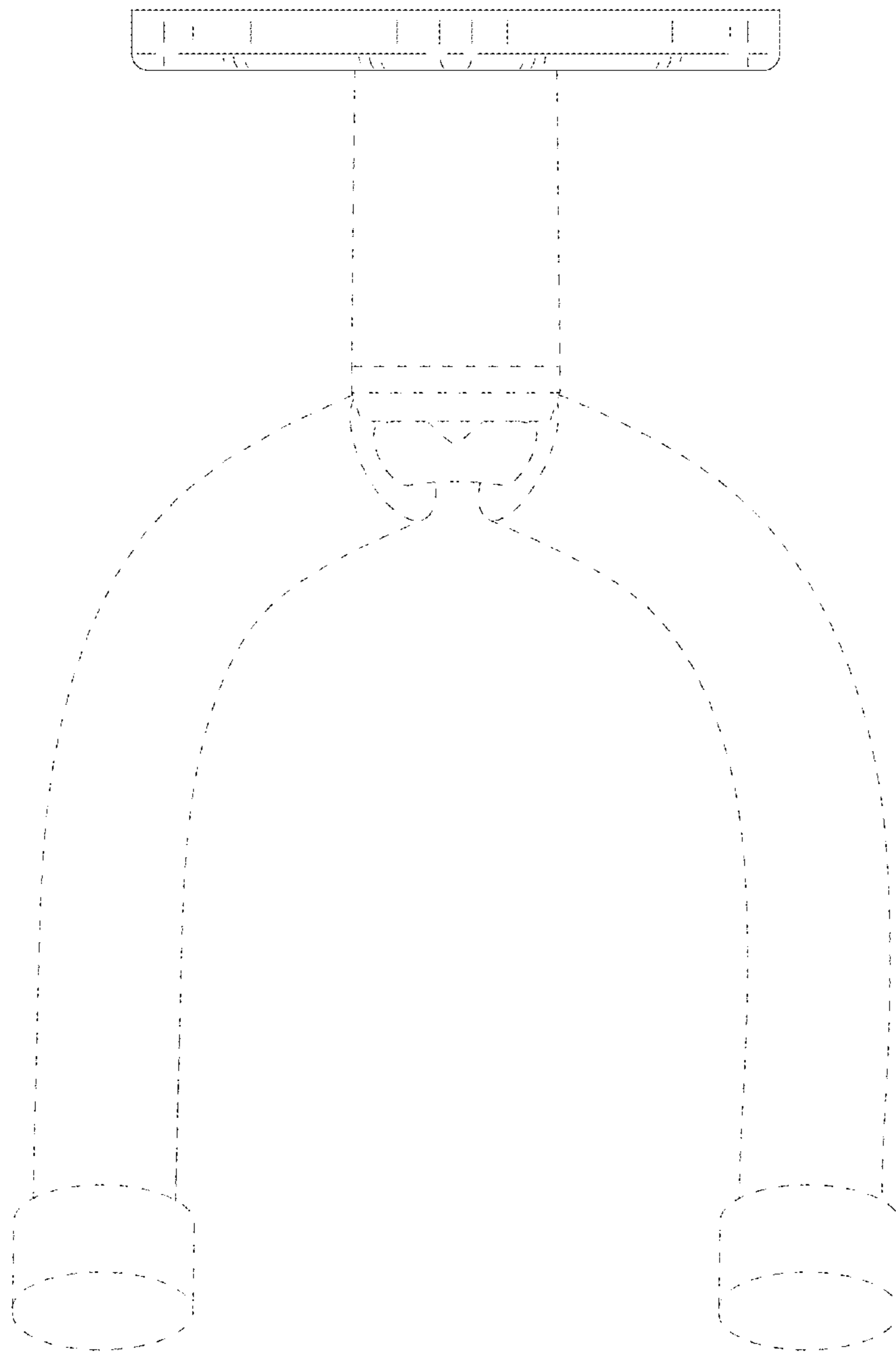

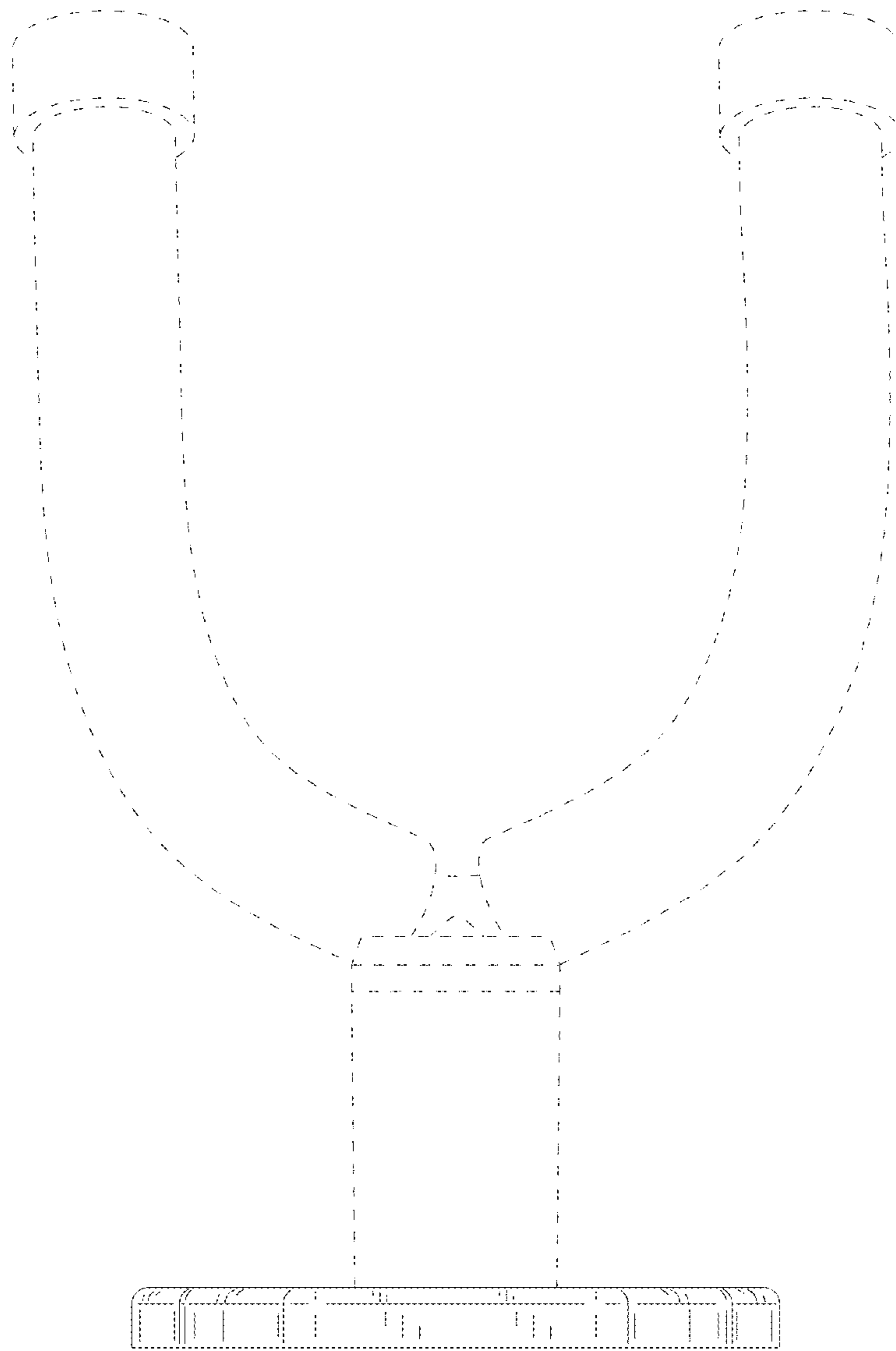
