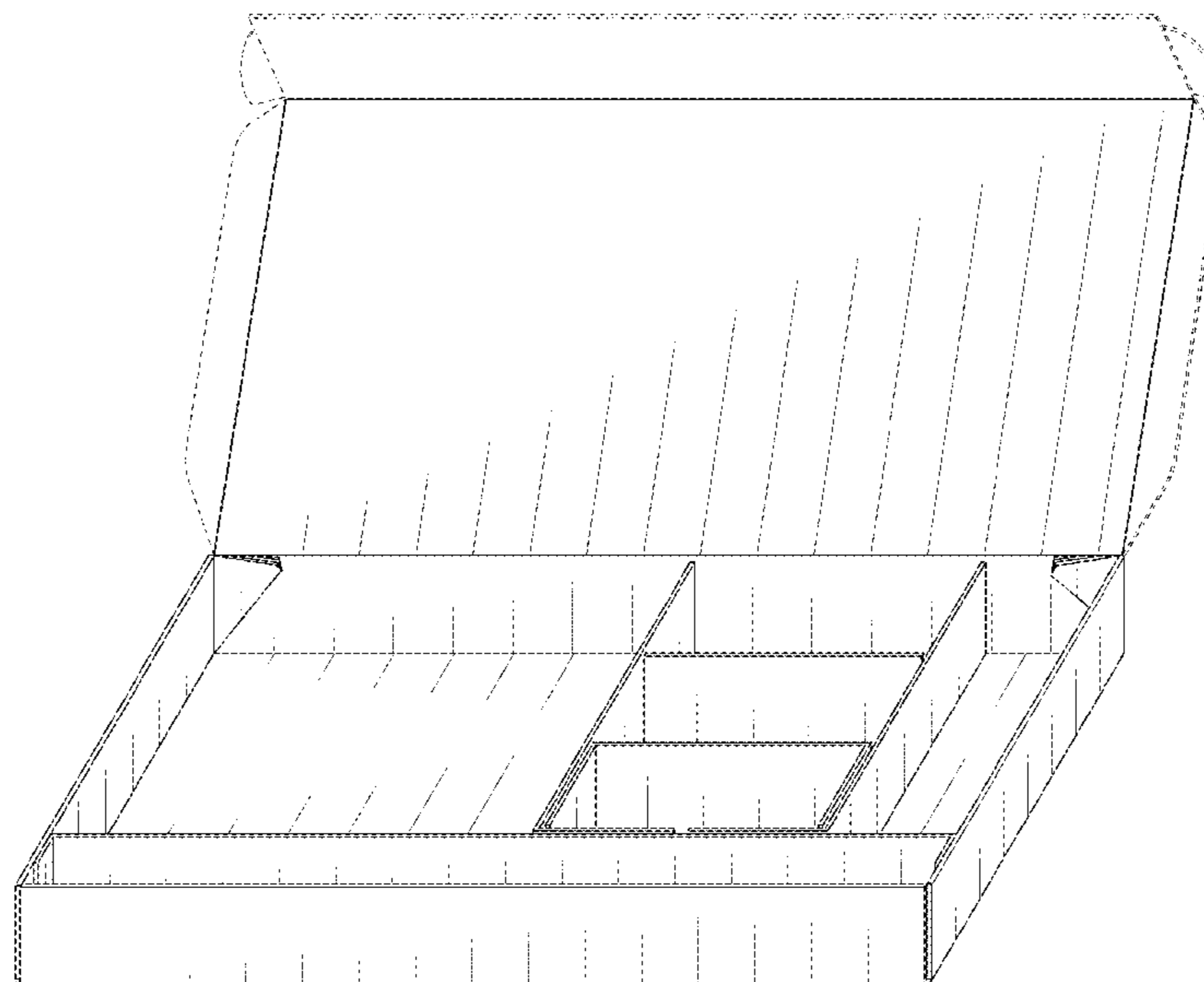
(57) **CLAIM**

The ornamental design for a takeout box, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a takeout box, with the lid open, showing our new design.
FIG. 2 is a perspective view of the takeout box, with the lid partially closed.
FIG. 3 is a perspective view of the takeout box, with the lid fully closed.
FIG. 4 is a front view of the takeout box with the lid open.
FIG. 5 is a rear view of the takeout box with the lid open.
FIG. 6 is a left side view of the takeout box with the lid open.
FIG. 7 is a top view of the takeout box with the lid open; and, FIG. 8 is a bottom view of the takeout box with the lid open. The broken lines in the drawings depict portions of the takeout box that form no part of the claimed design.

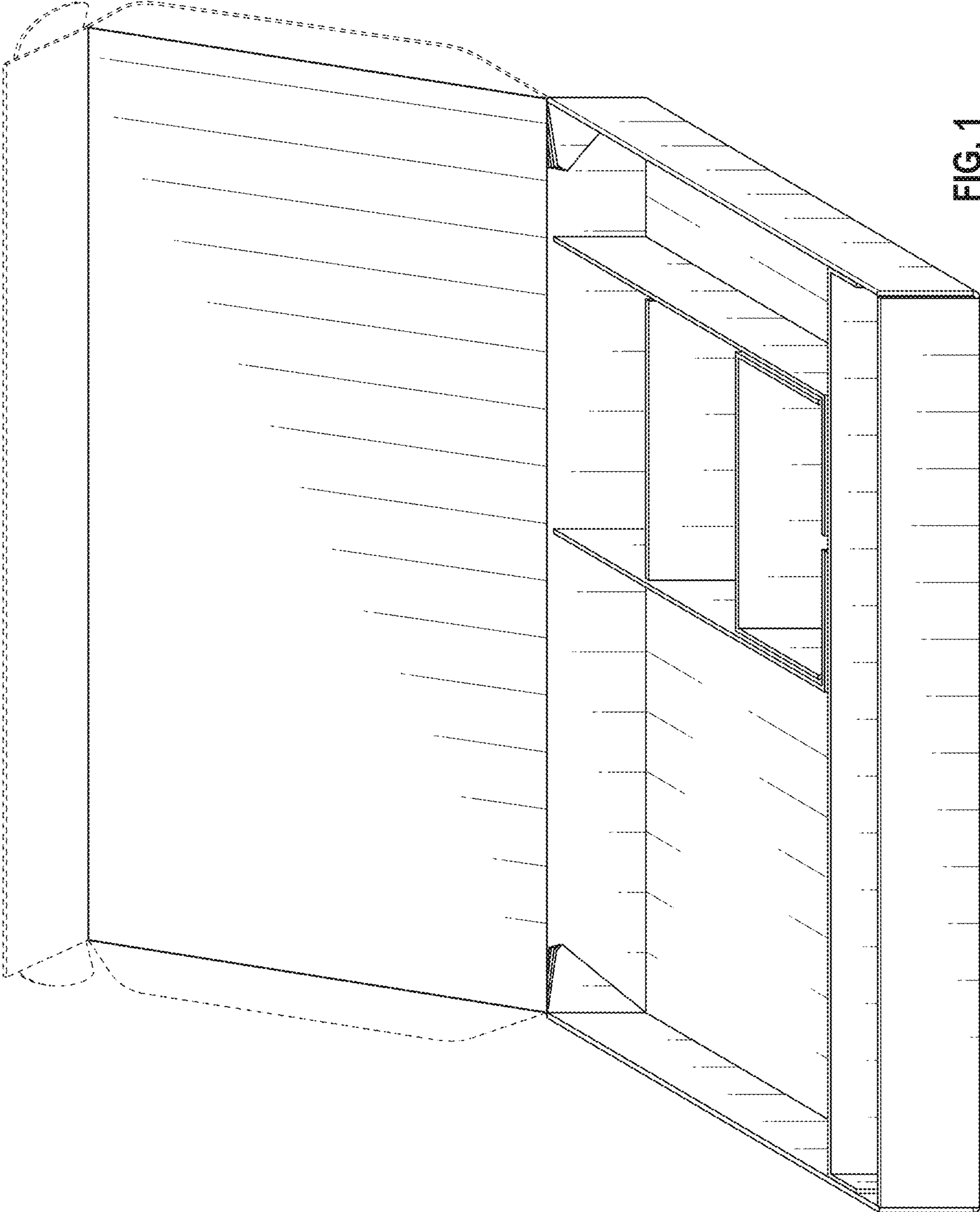

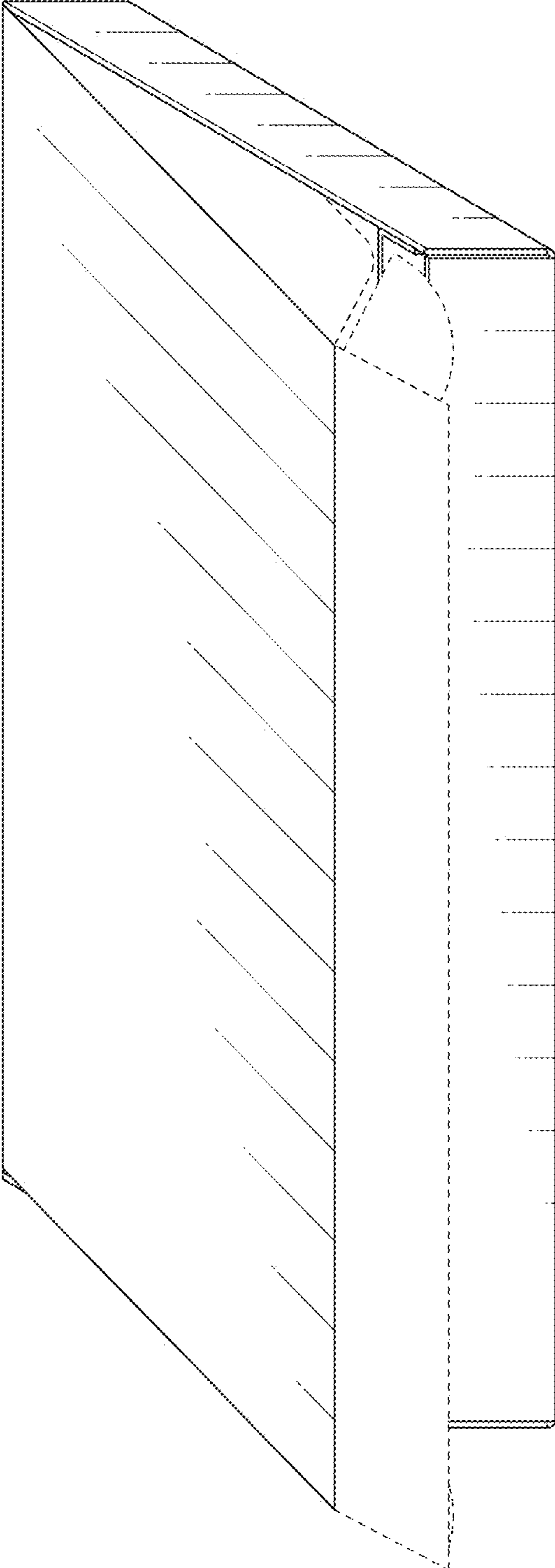

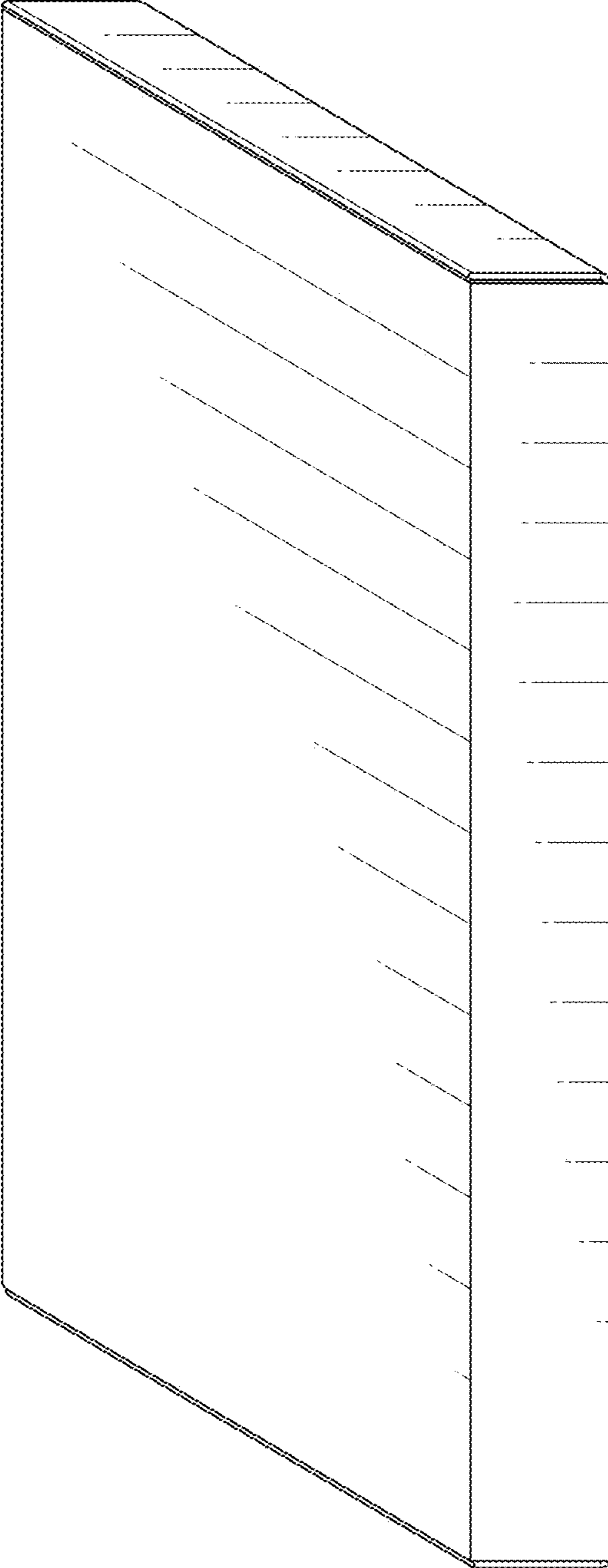

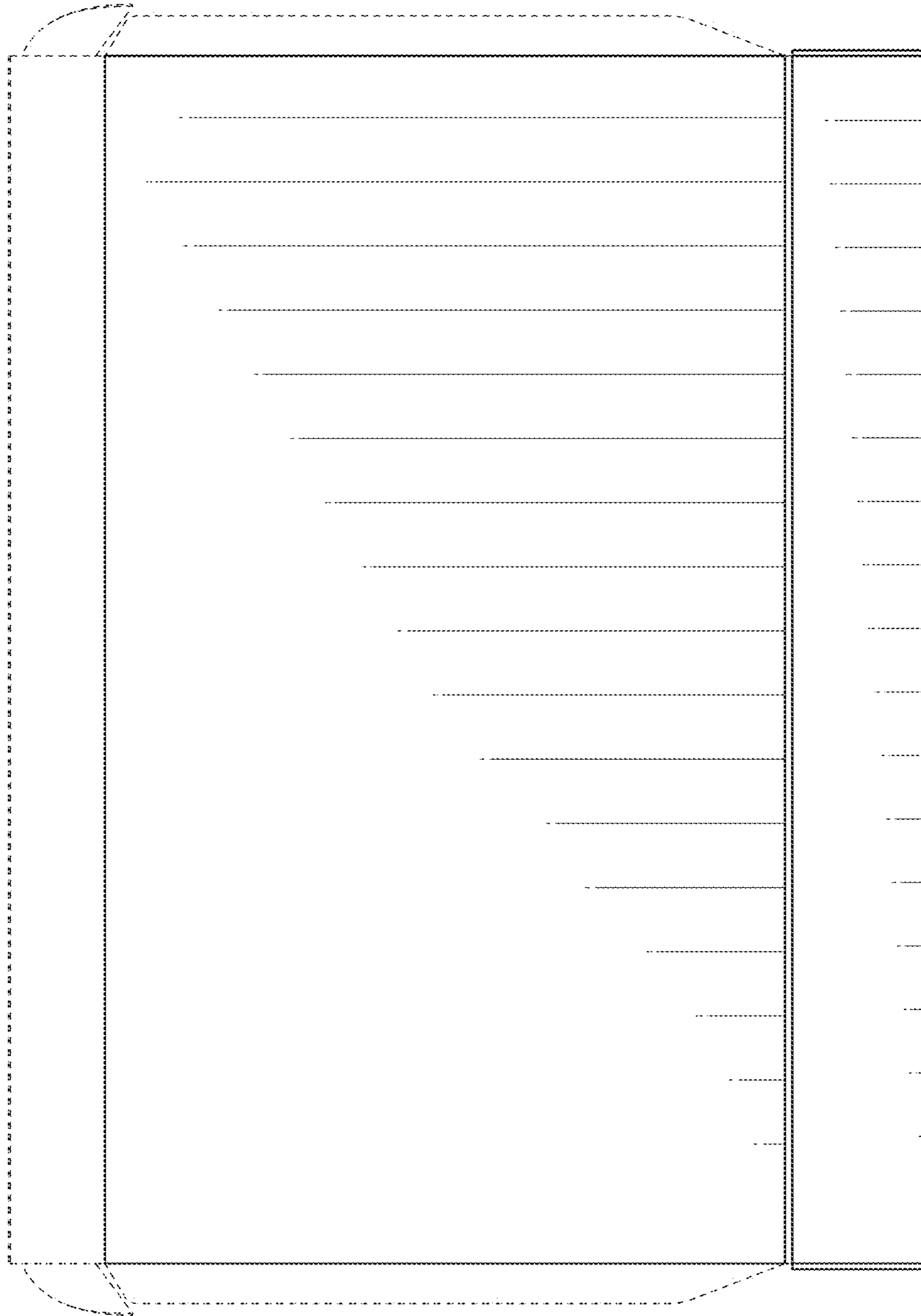

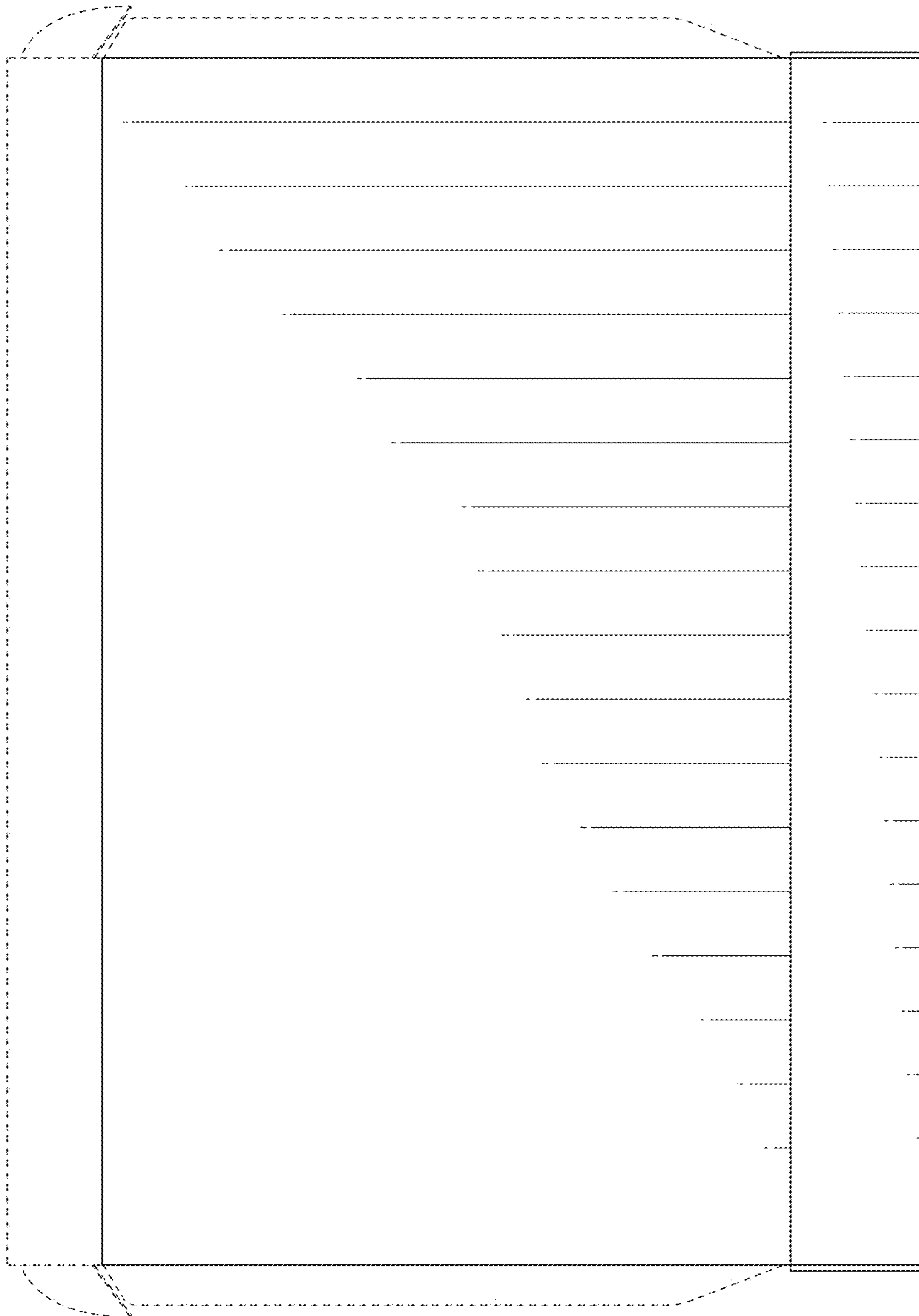

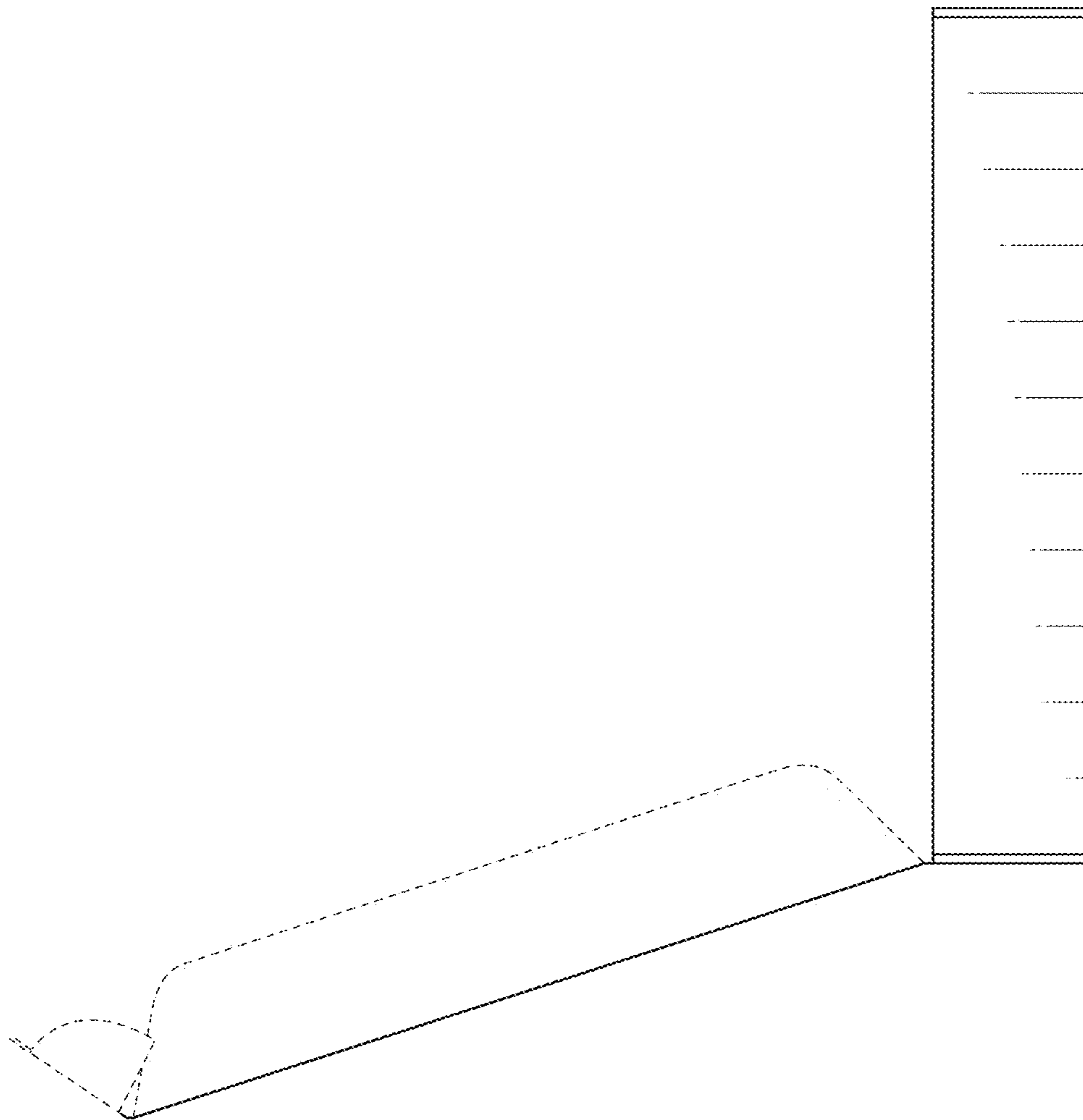

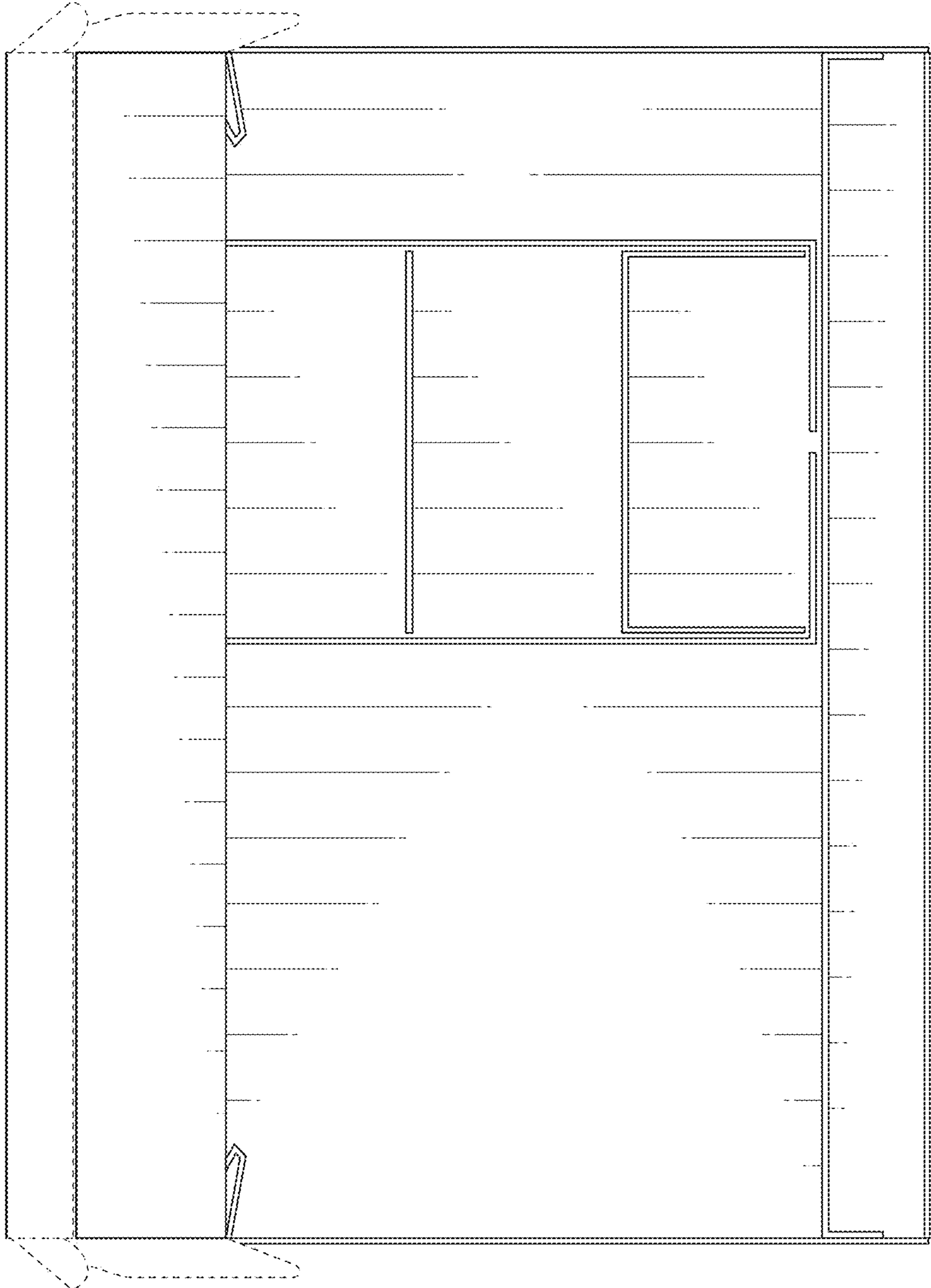

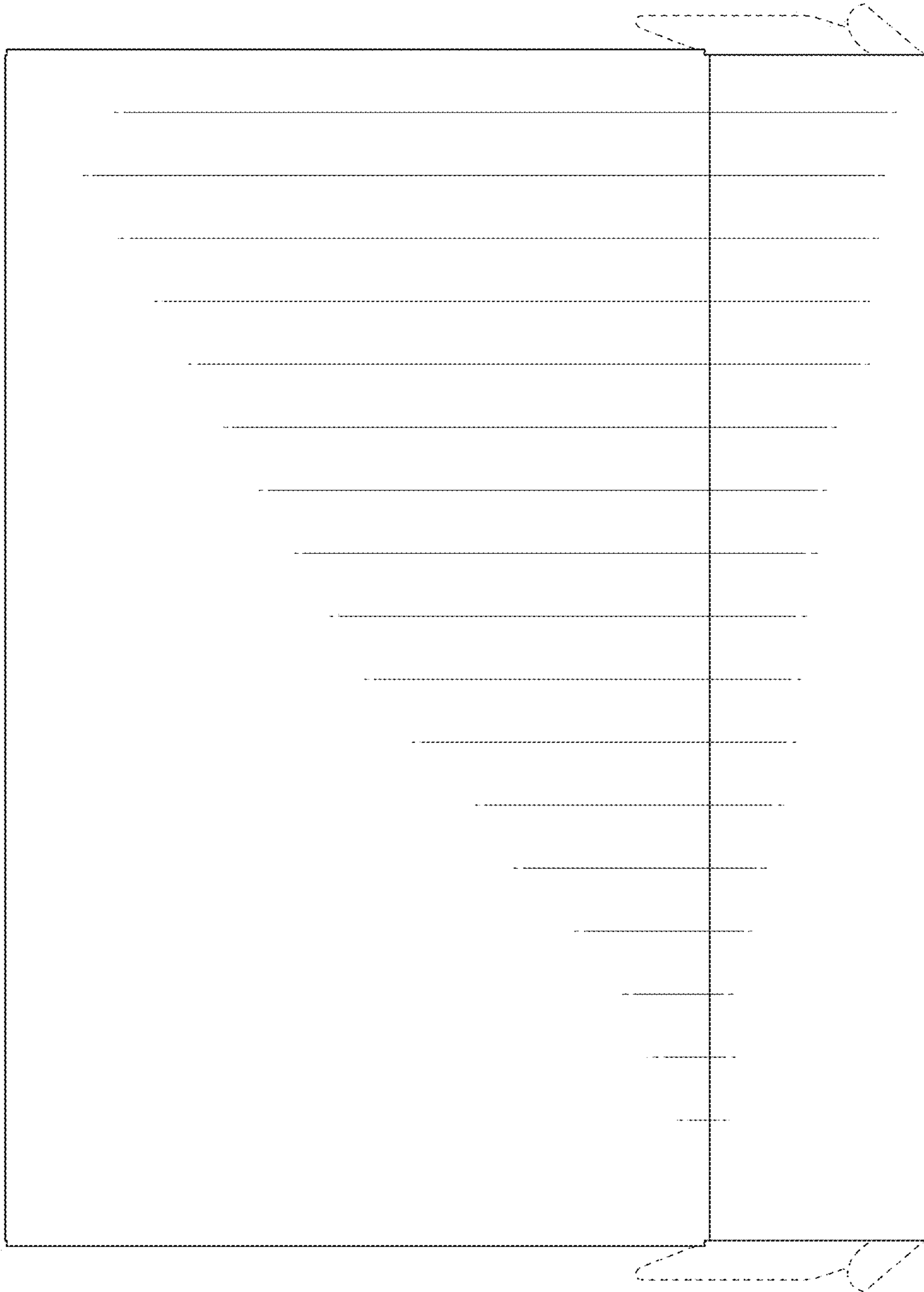
