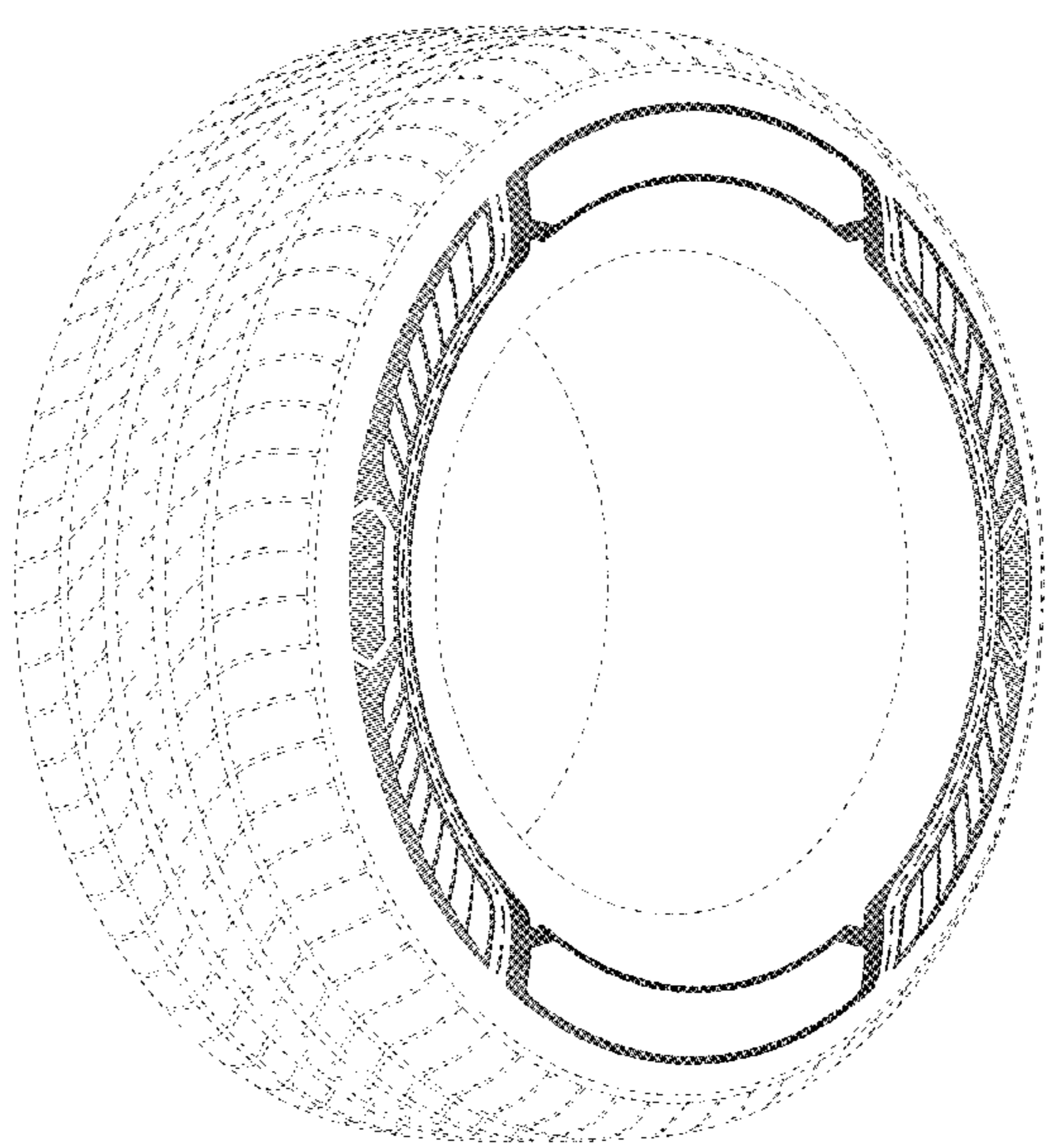

The ornamental design for a tire sidewall, as shown and described.

**DESCRIPTION**  
FIG. 1 is a perspective view of a tire sidewall showing our new design; and,

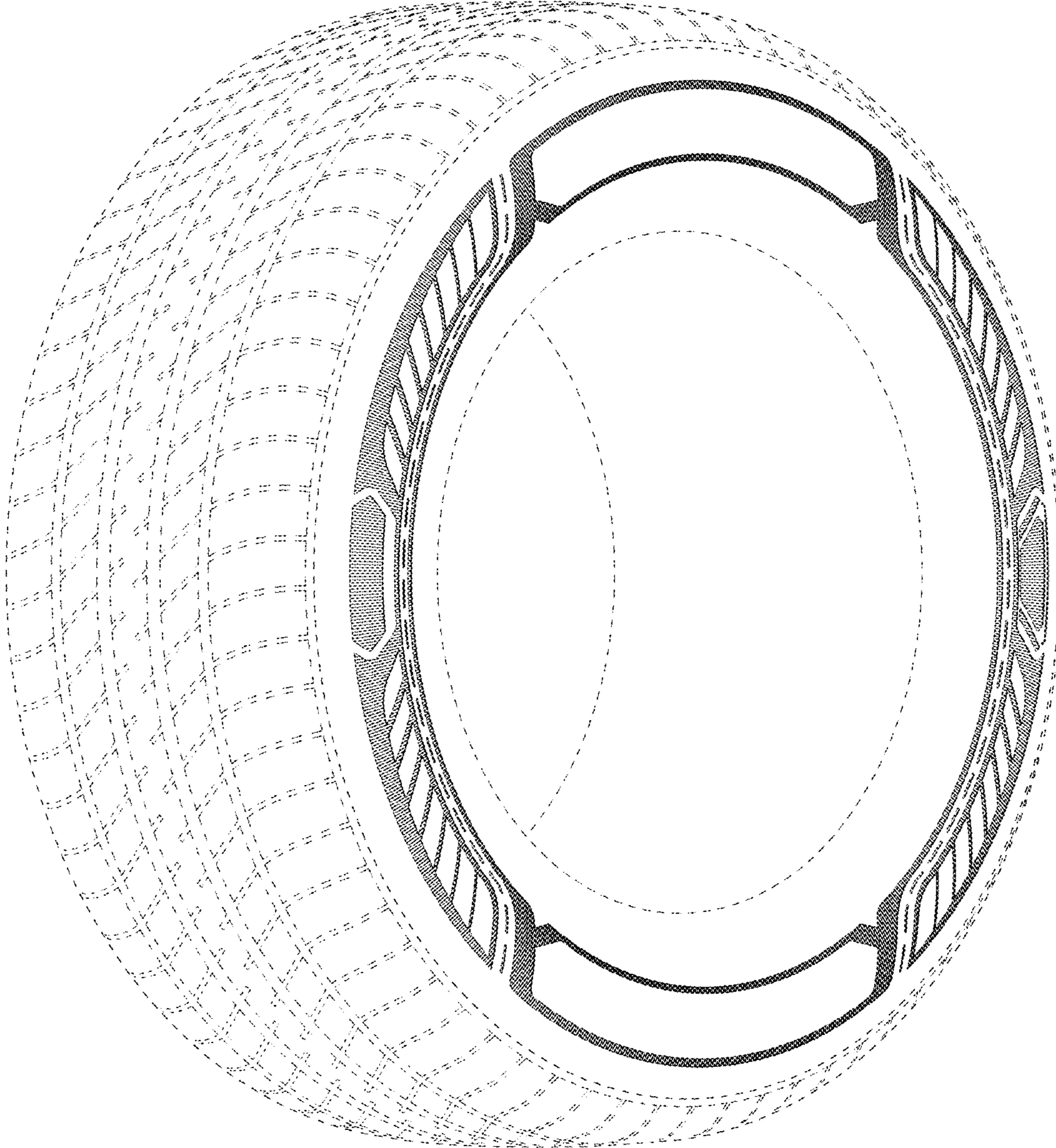

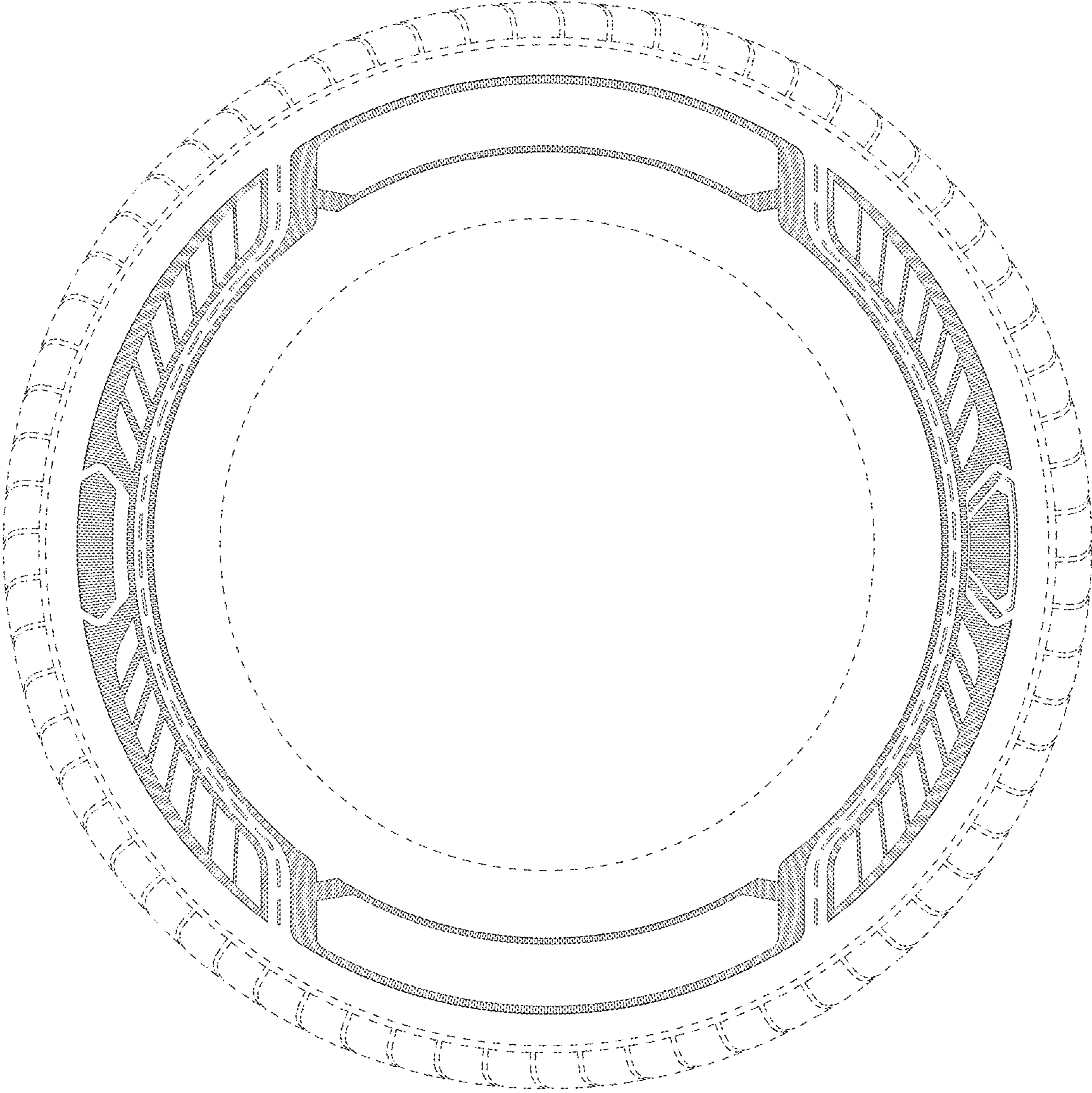
