(57) **CLAIM**

The ornamental design for a load center with integrated receptacles, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a load center with integrated receptacles;  
FIG. 2 is an enlarged view of portion 2 shown in FIG. 1;  
FIG. 3 is a front view of a load center with integrated receptacles;  
FIG. 4 is a back view of a load center with integrated receptacles;  
FIG. 5 is a right-side view of a load center with integrated receptacles;  
FIG. 6 is an enlarged view of portion 6 shown in FIG. 5;  
FIG. 7 is a left-side view of a load center with integrated receptacles;  
FIG. 8 is a top view of a load center with integrated receptacles;  
FIG. 9 is a bottom view of a load center with integrated receptacles;  
FIG. 10 is another top perspective view of a load center with integrated receptacles illustrated in FIG. 1, shown with the door in an open position to display internal components of the load center;  
FIG. 11 is another front view of a load center with integrated receptacles illustrated in FIG. 3, shown with the door in an open position to display internal components of the load center;  
FIG. 12 is another back view of a load center with integrated receptacles illustrated in FIG. 4, shown with the door in an open position;  
FIG. 13 is another right-side view of a load center with integrated receptacles illustrated in FIG. 5, shown with the door in an open position;  
FIG. 14 is another left-side view of a load center with integrated receptacles illustrated in FIG. 7, shown with the door in an open position;

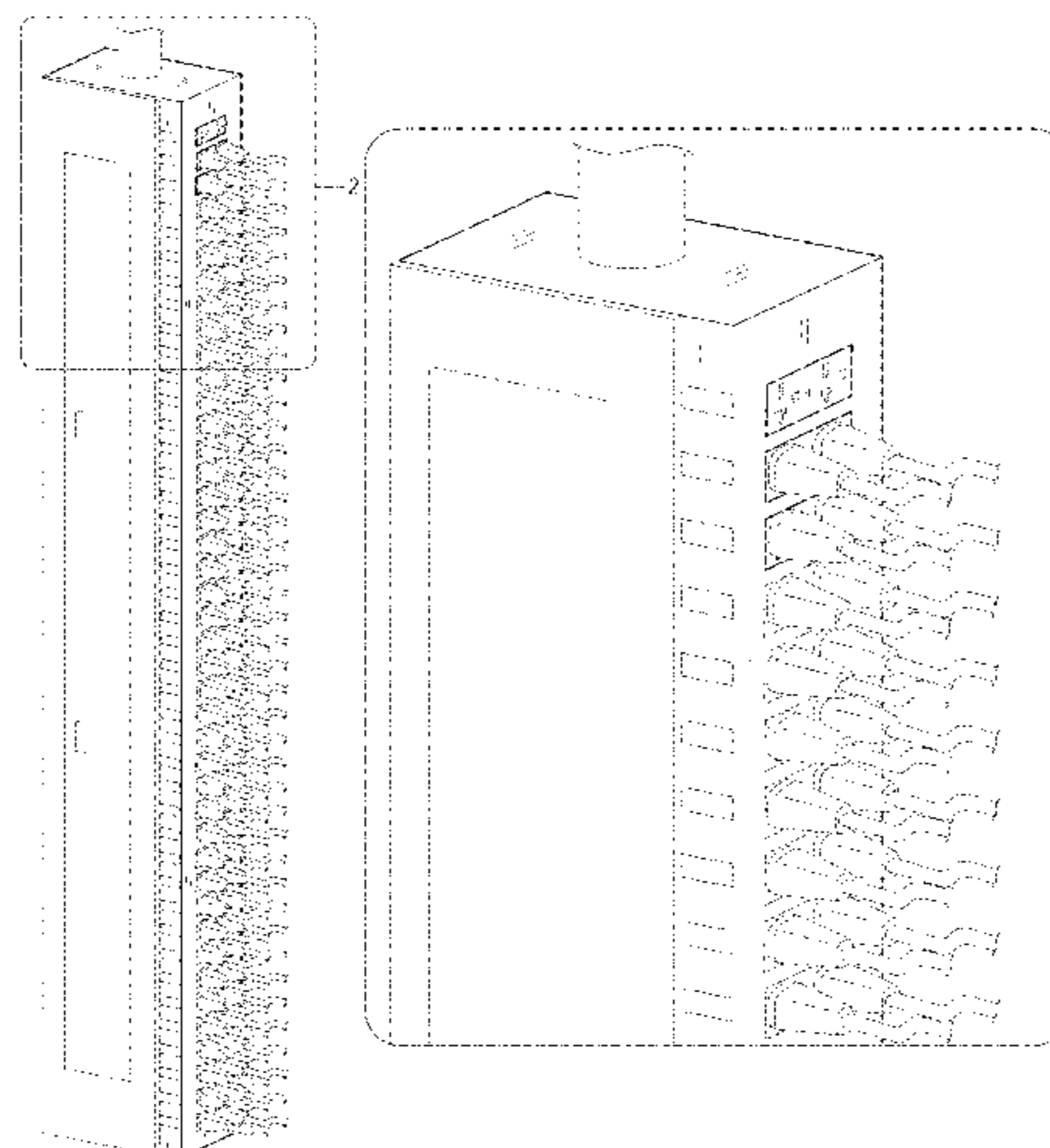


FIG. 15 is another top view of a load center with integrated receptacles illustrated in FIG. 8 shown with the door in an open position; and,

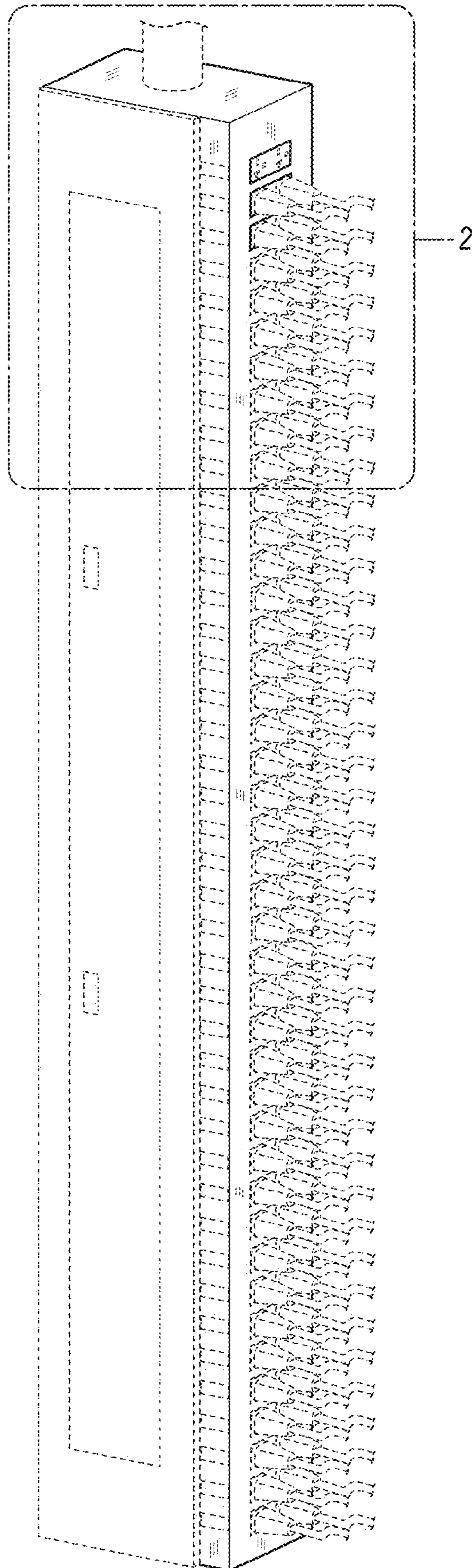

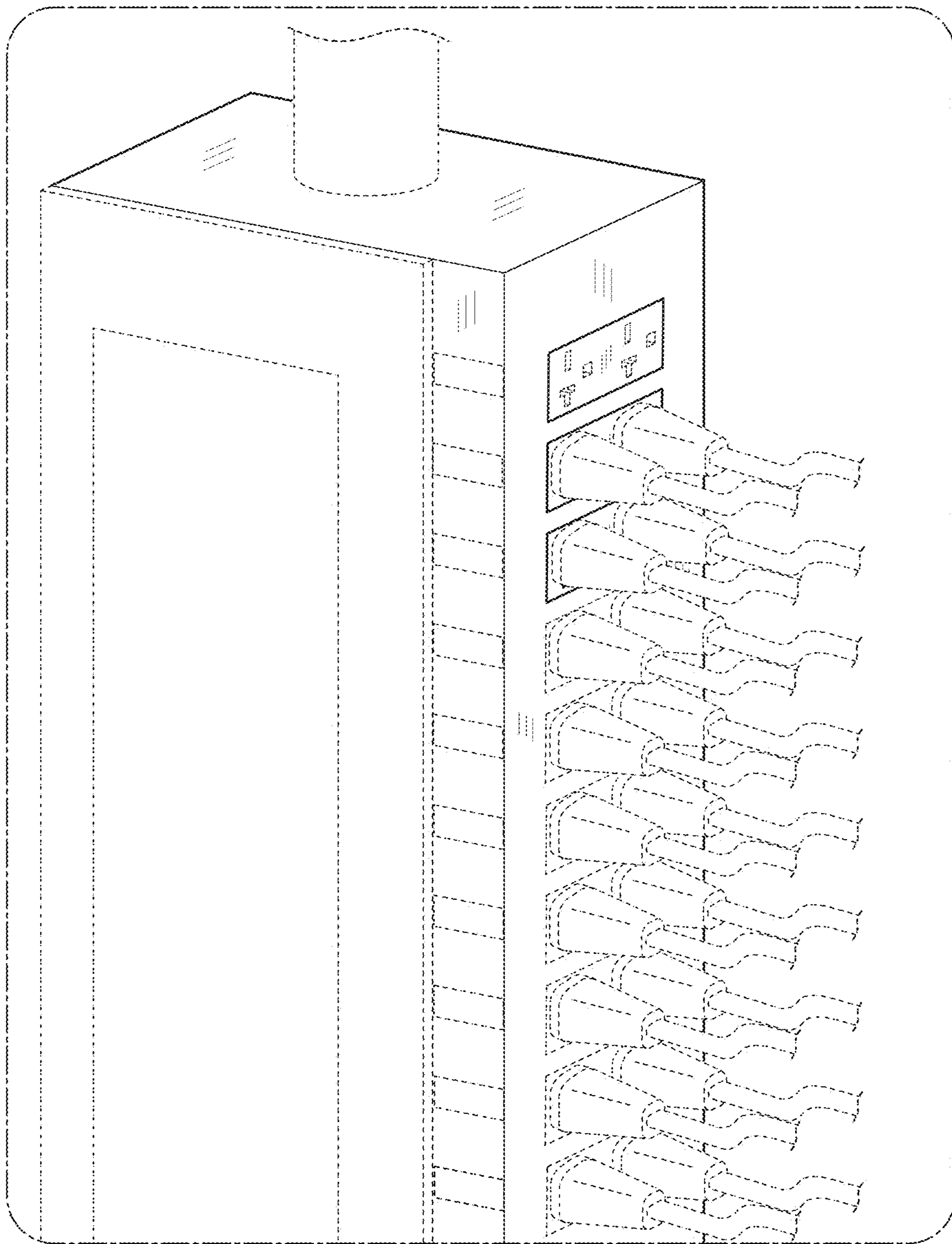

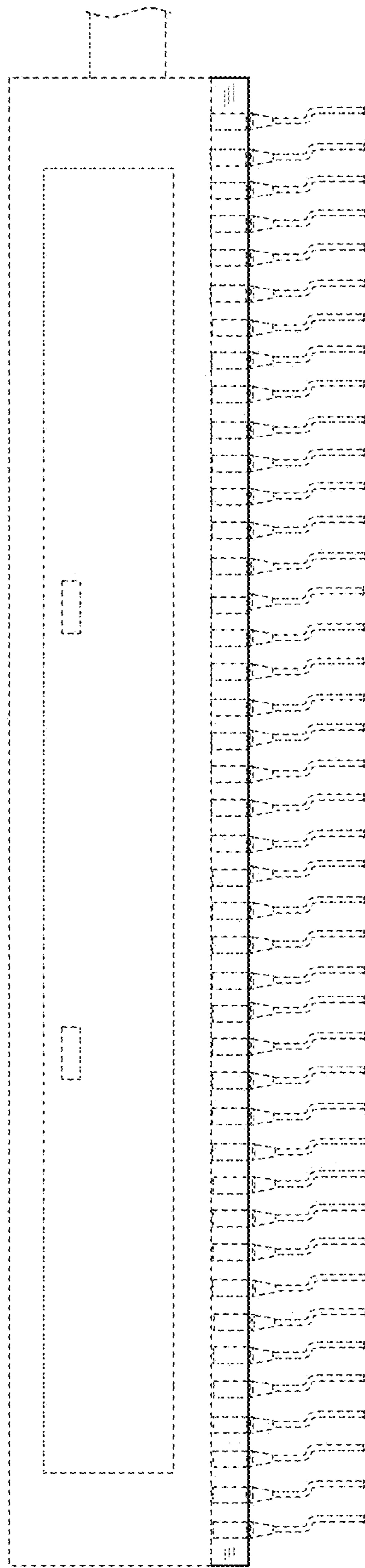

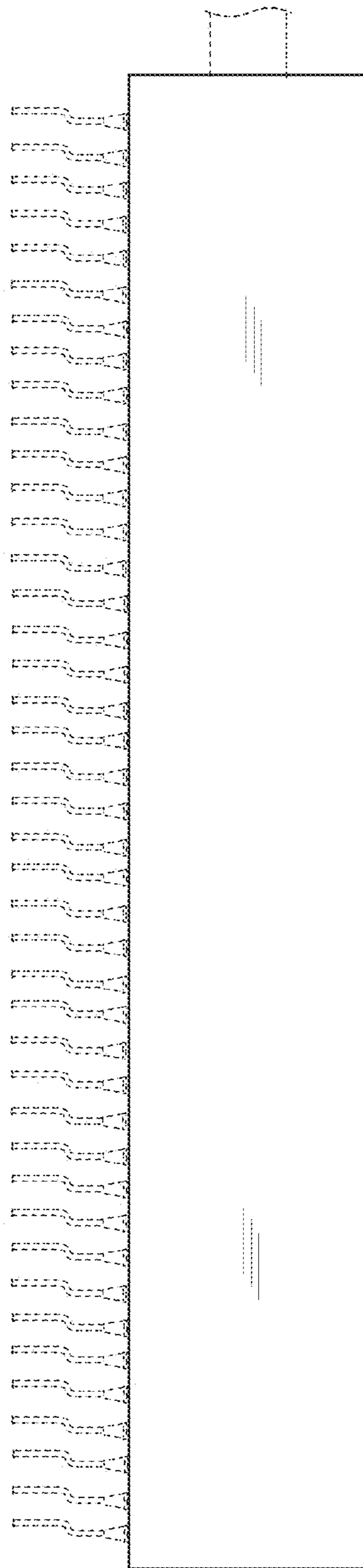

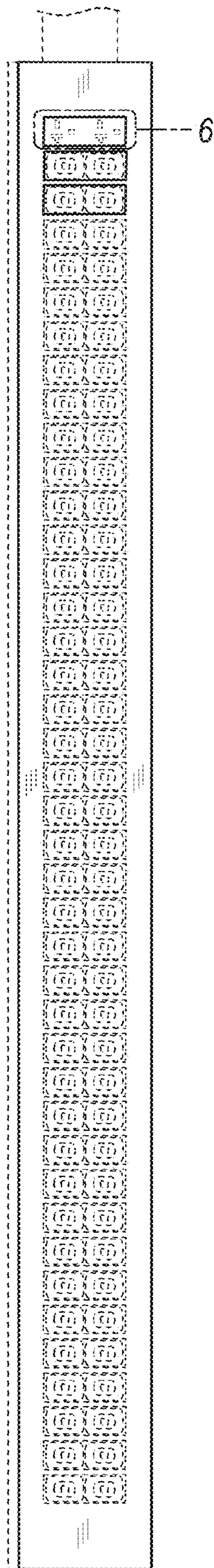

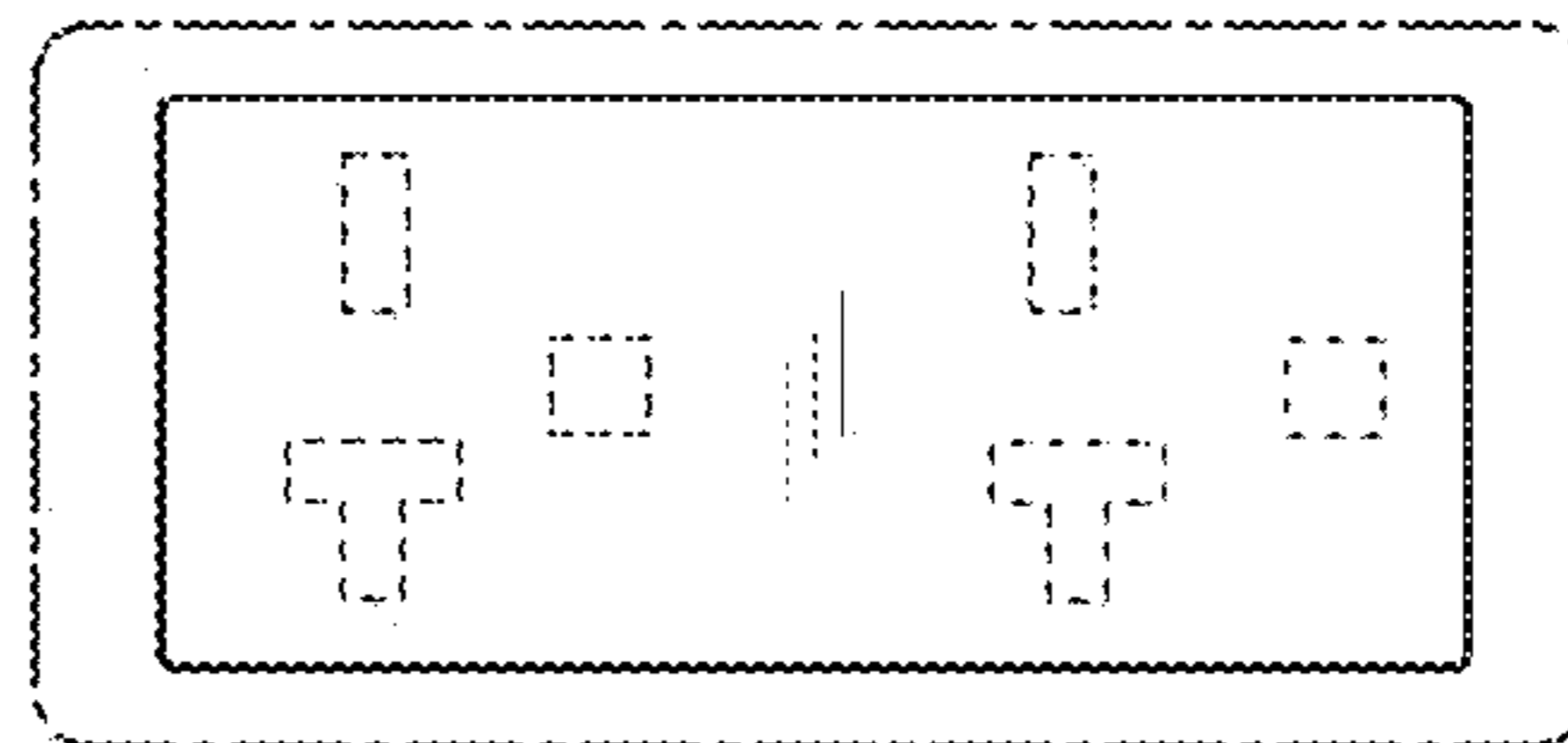

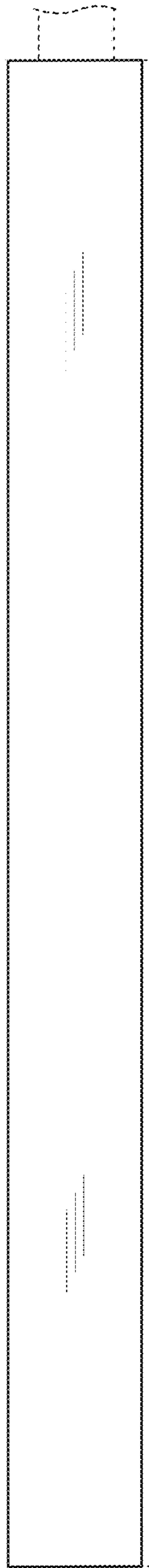

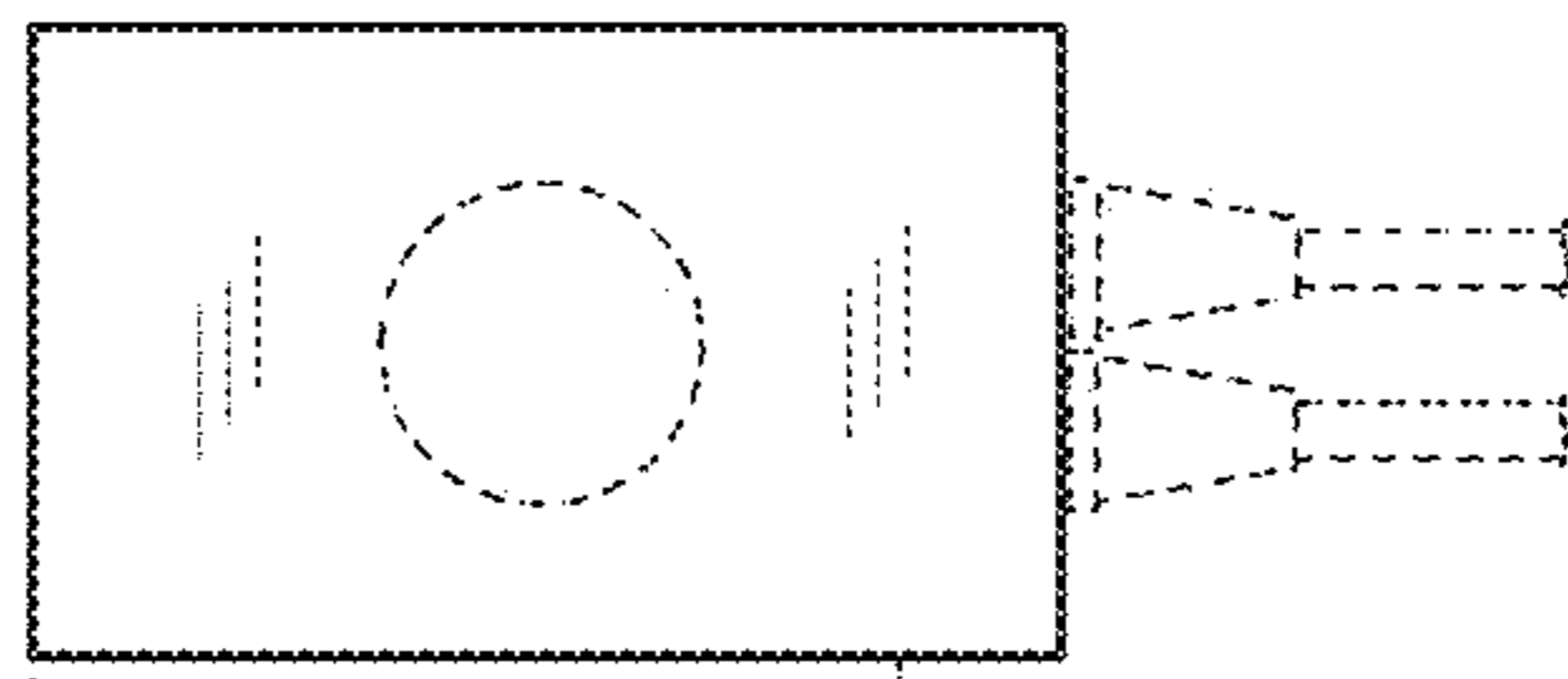

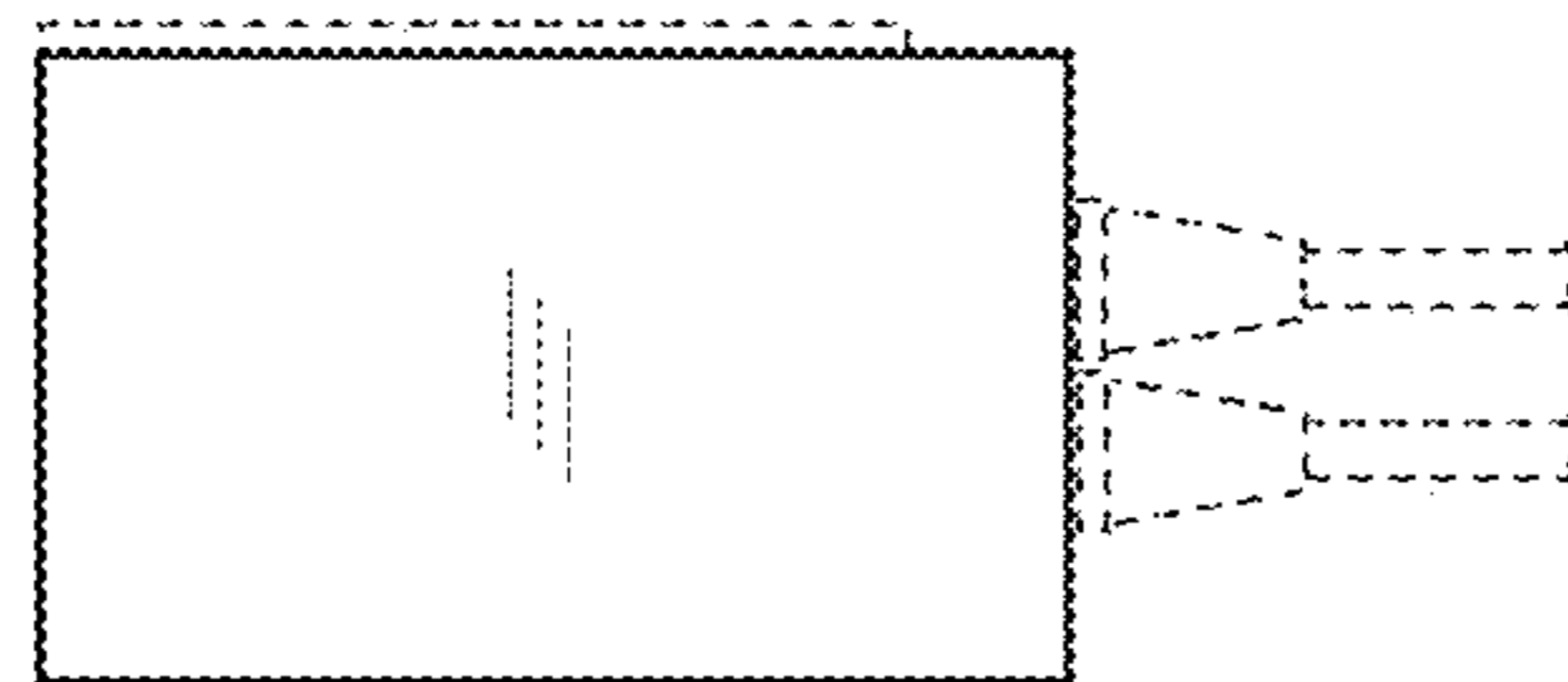

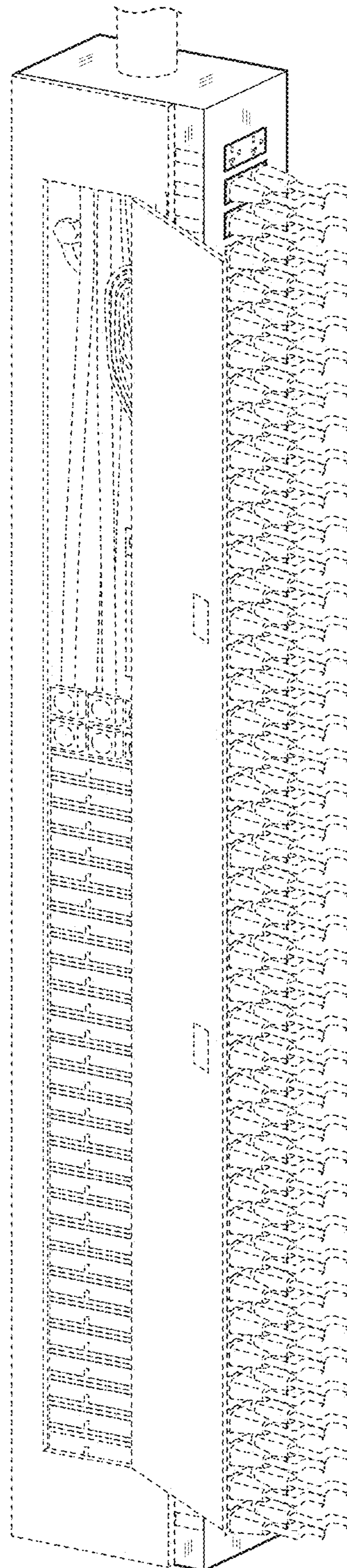

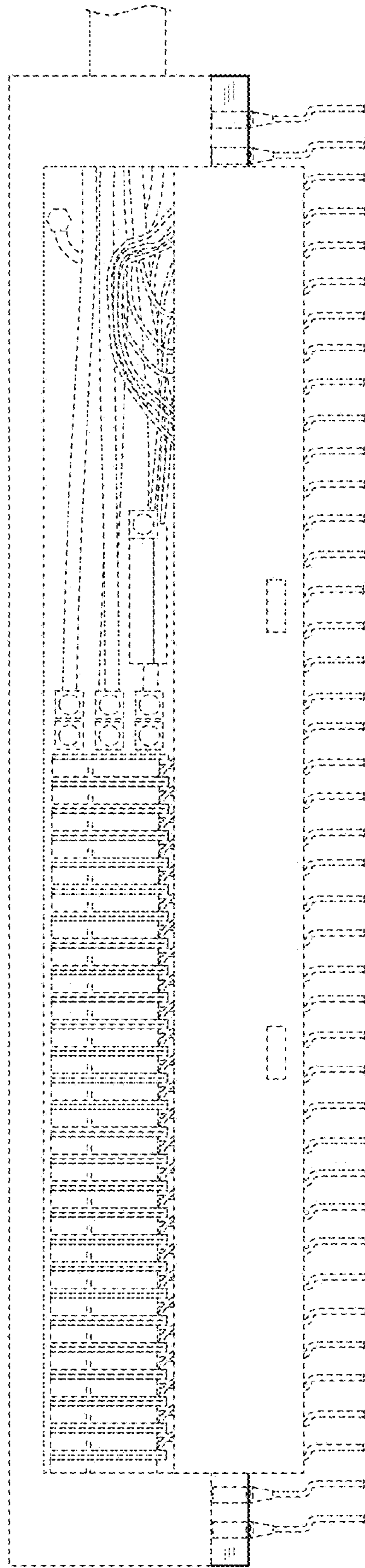

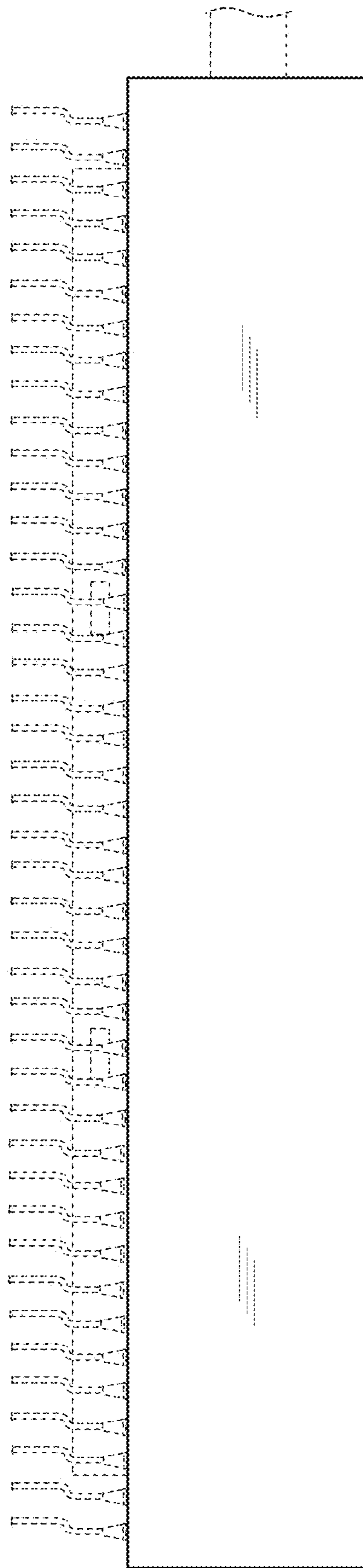

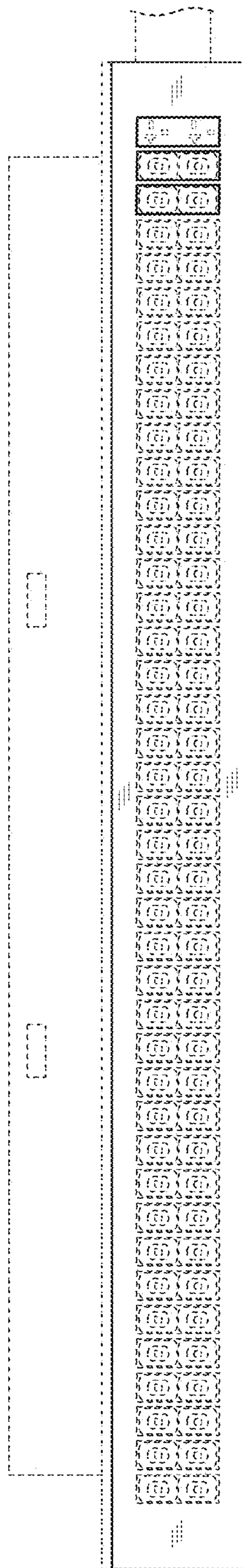

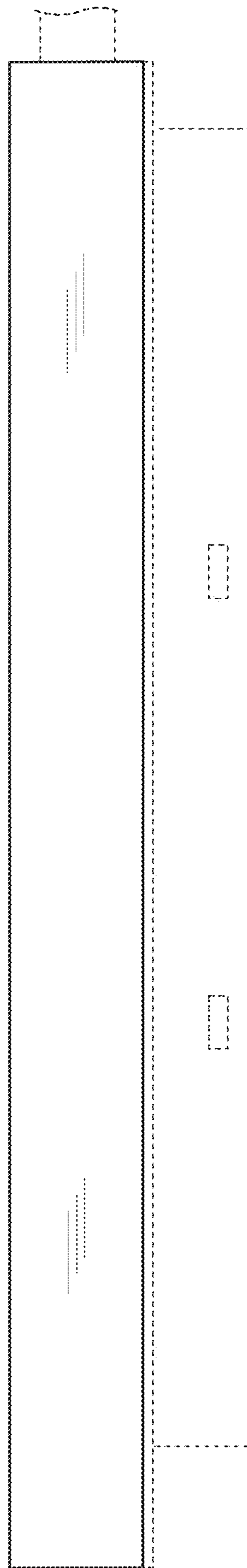

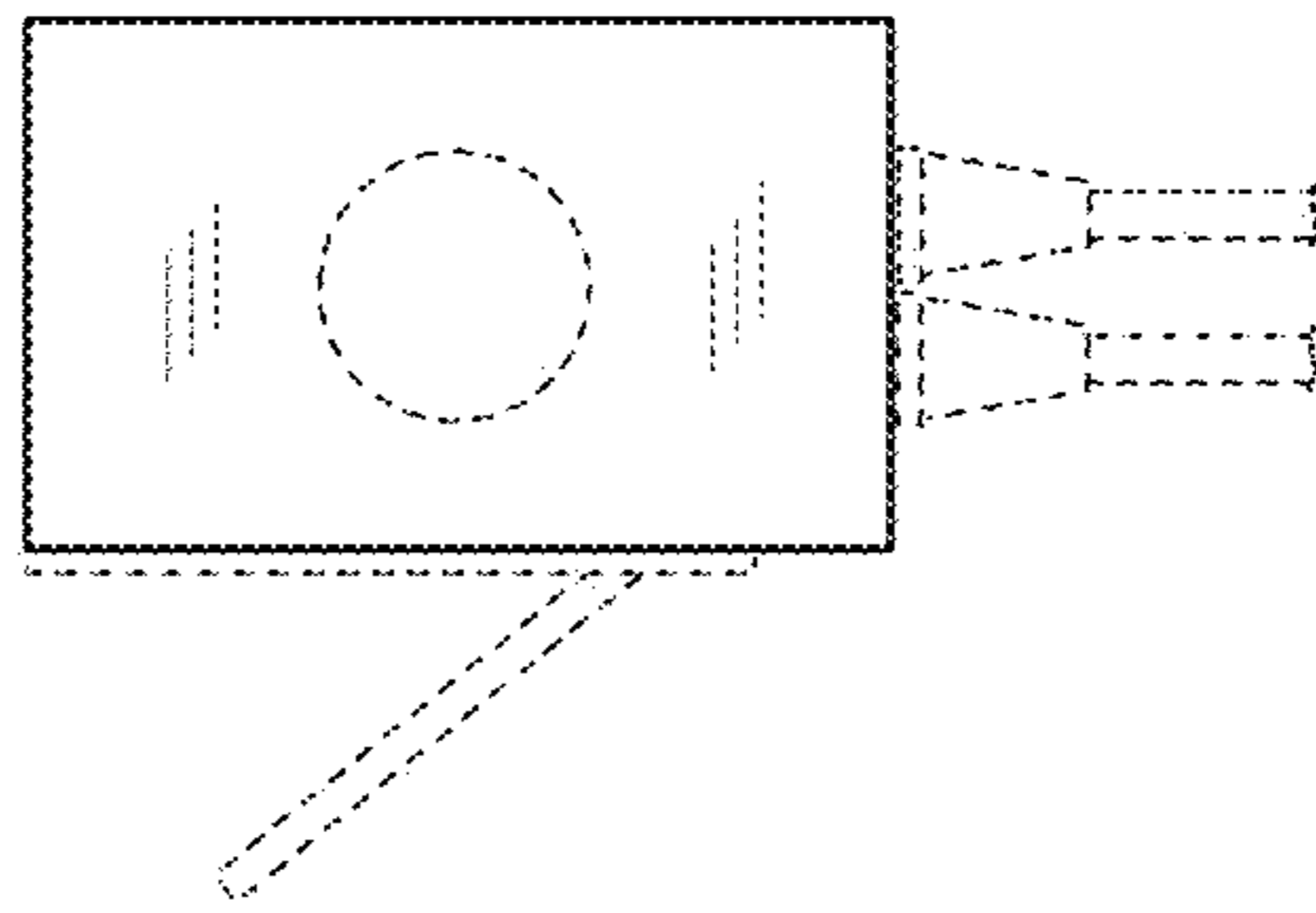

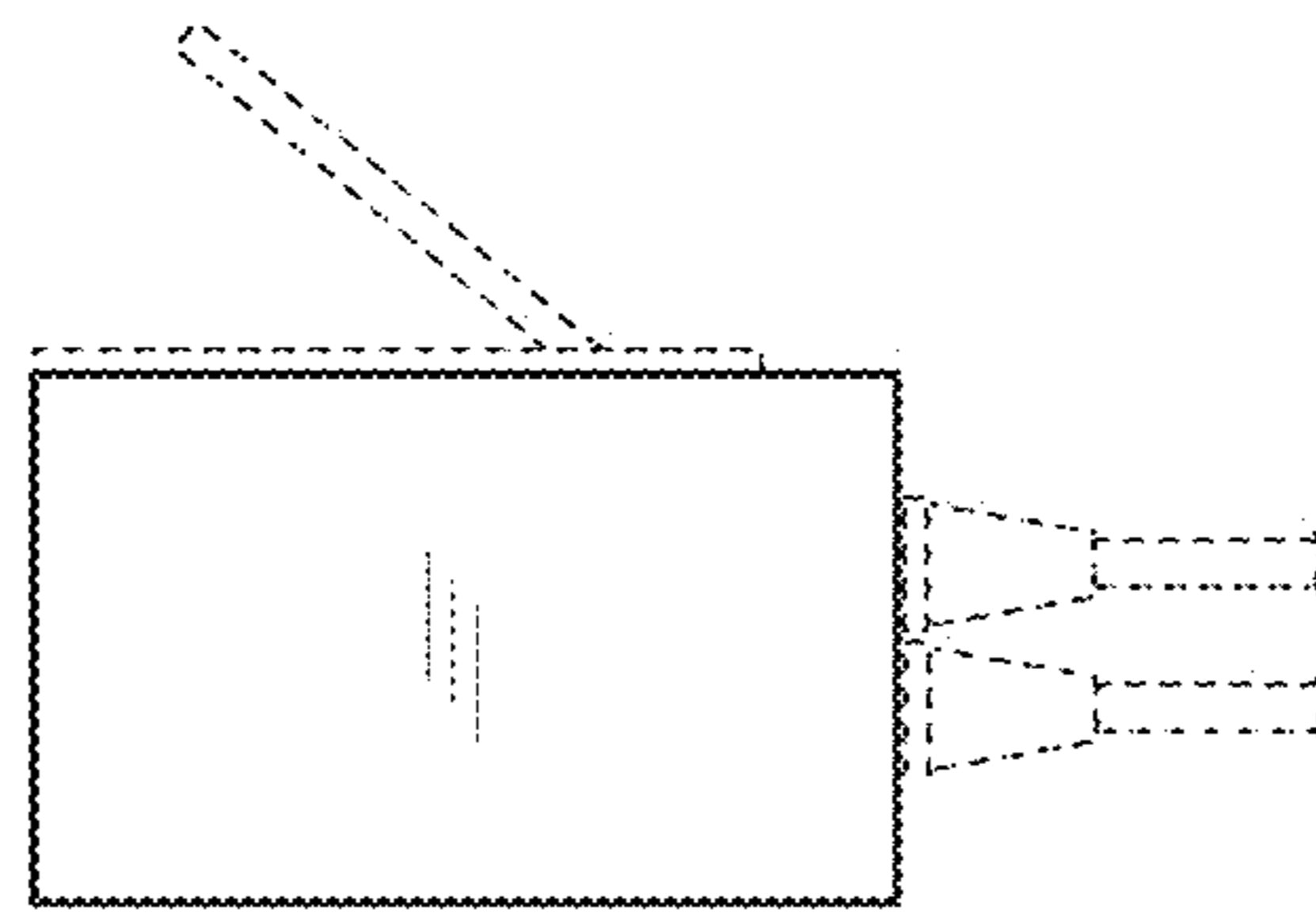
