(57) **CLAIM**

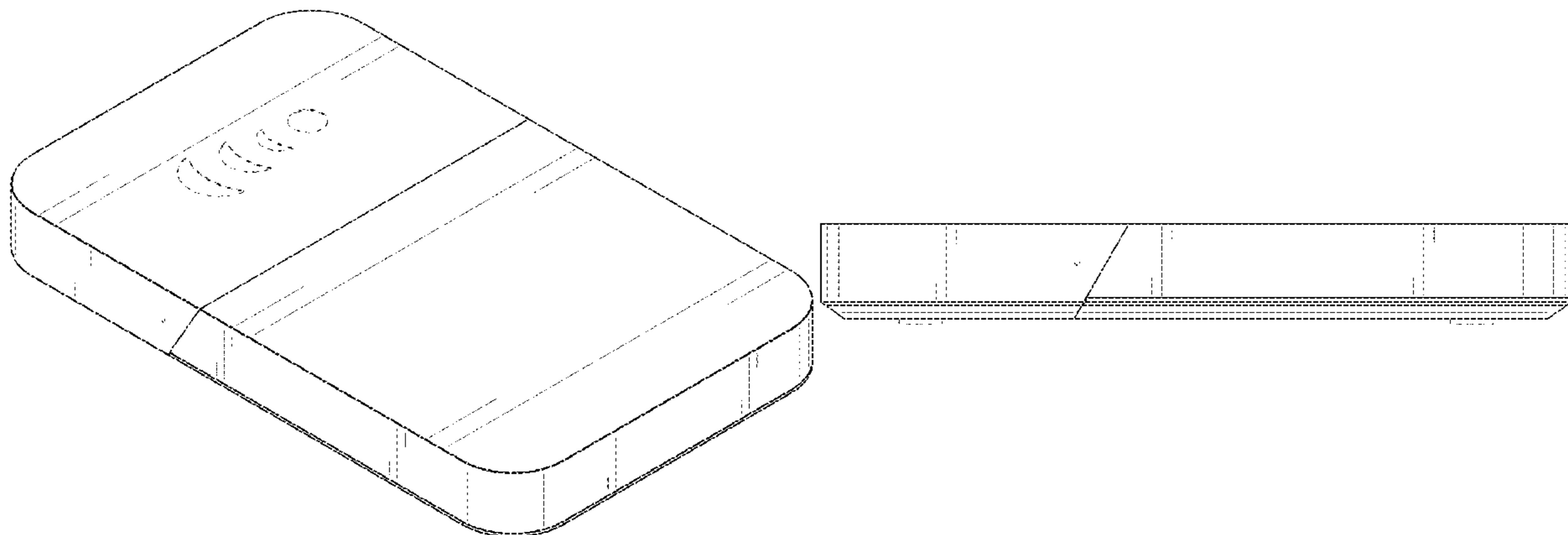
The ornamental design for a television receiver device, as shown and described.

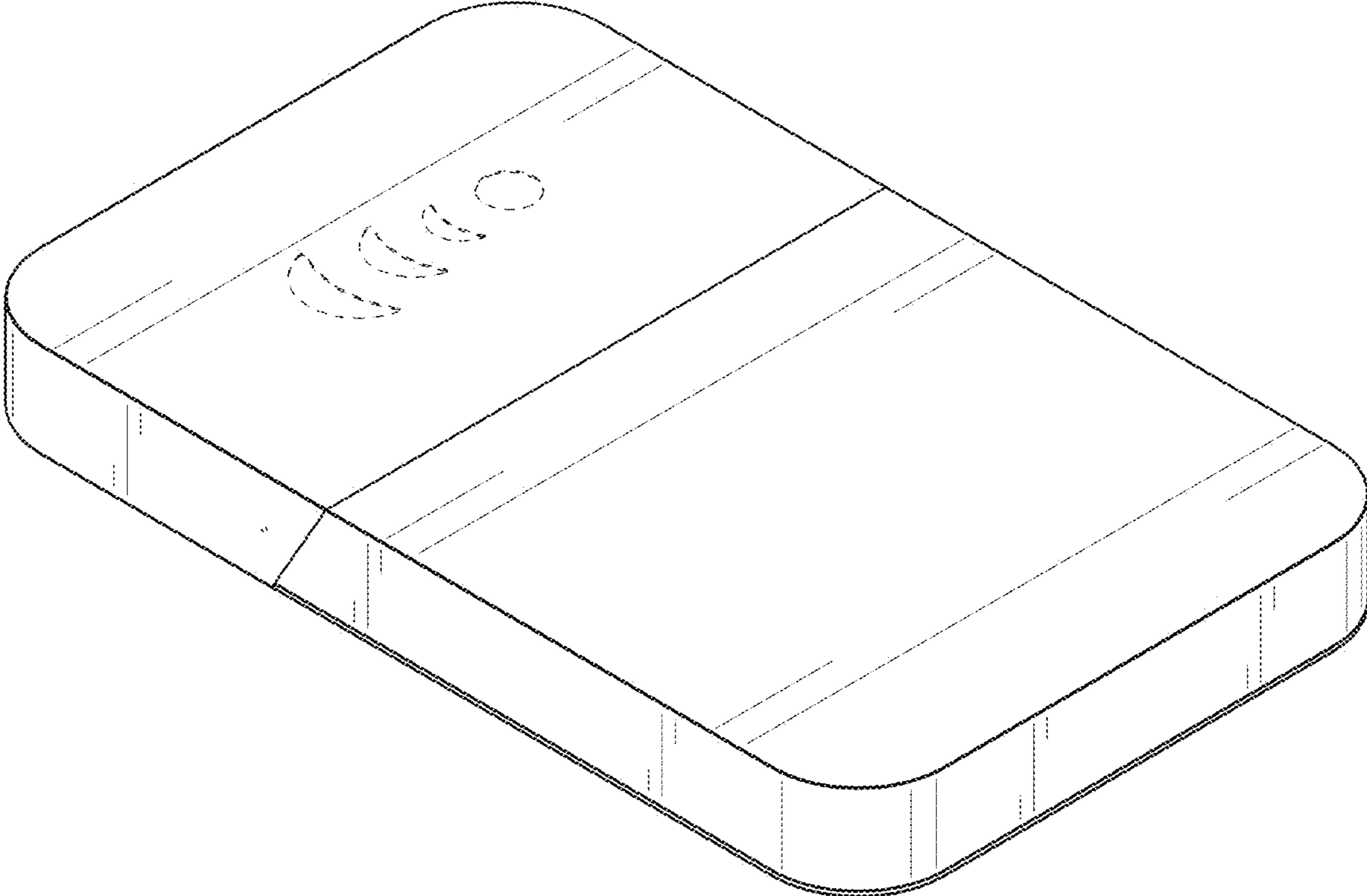

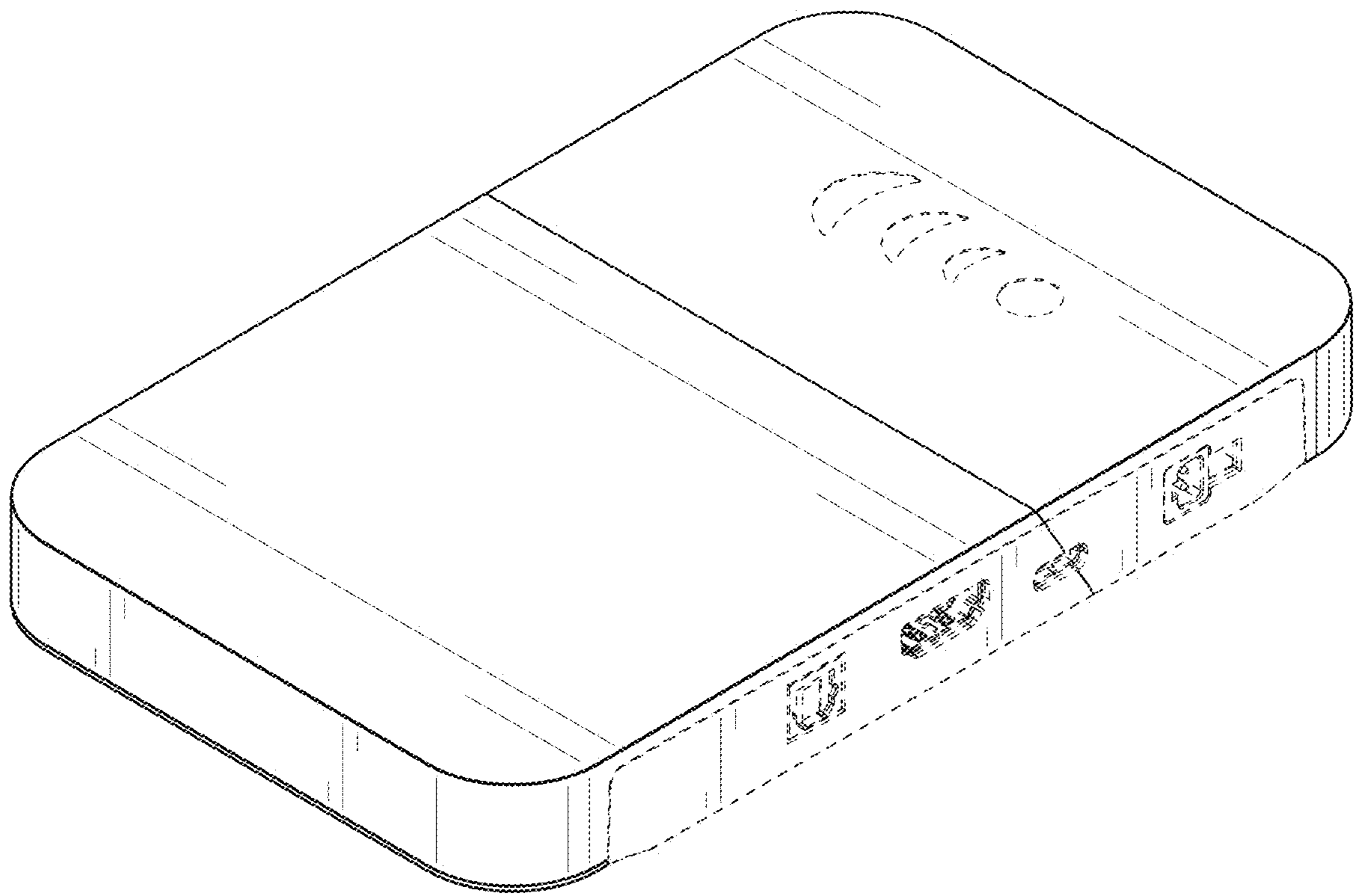

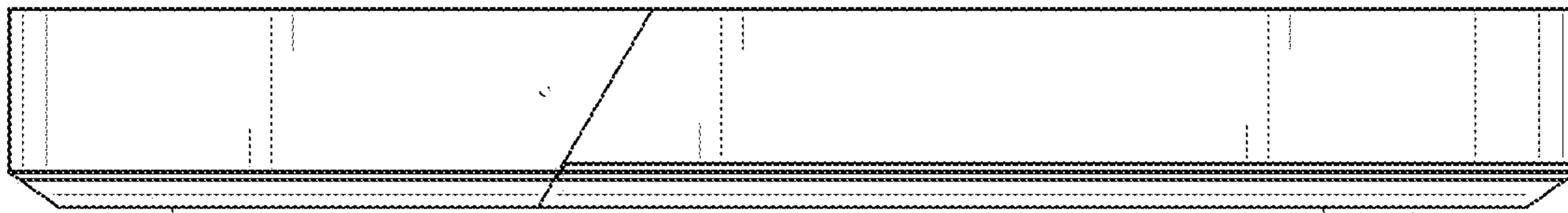

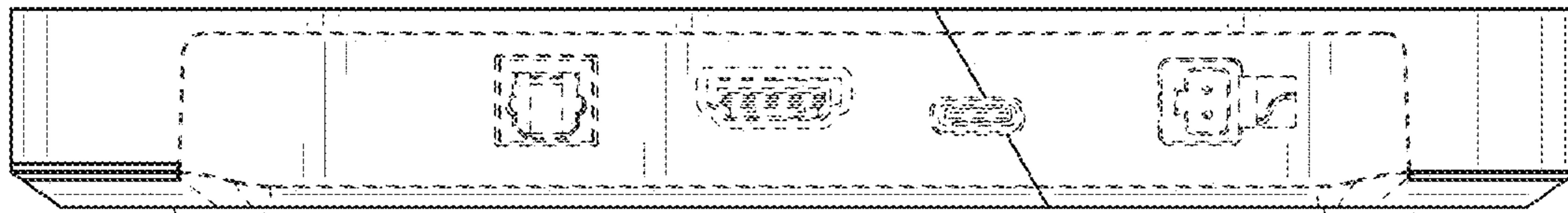

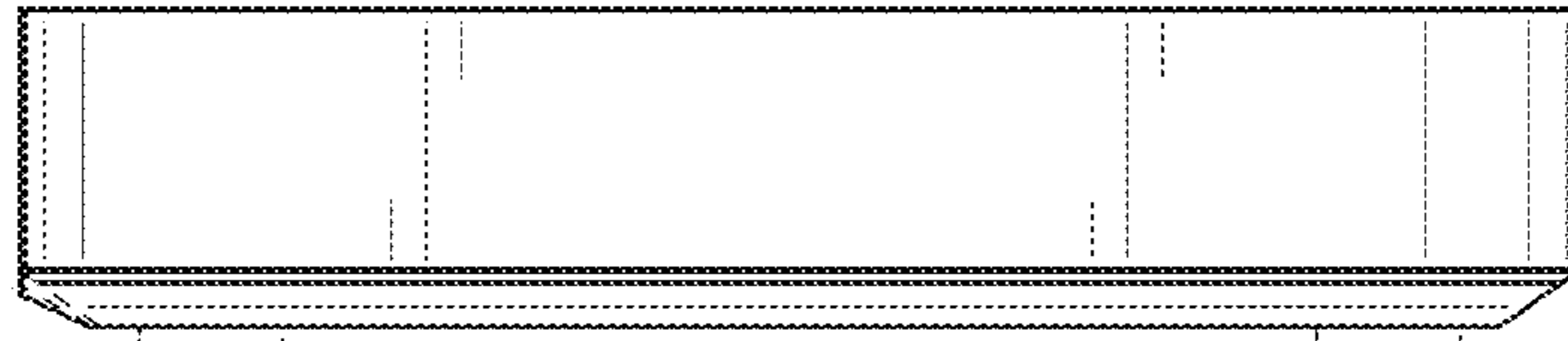

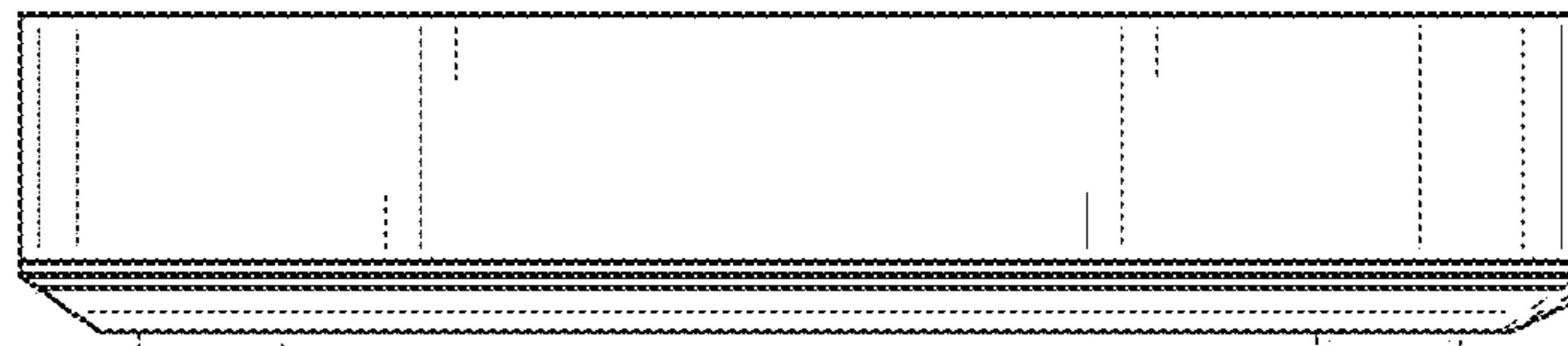

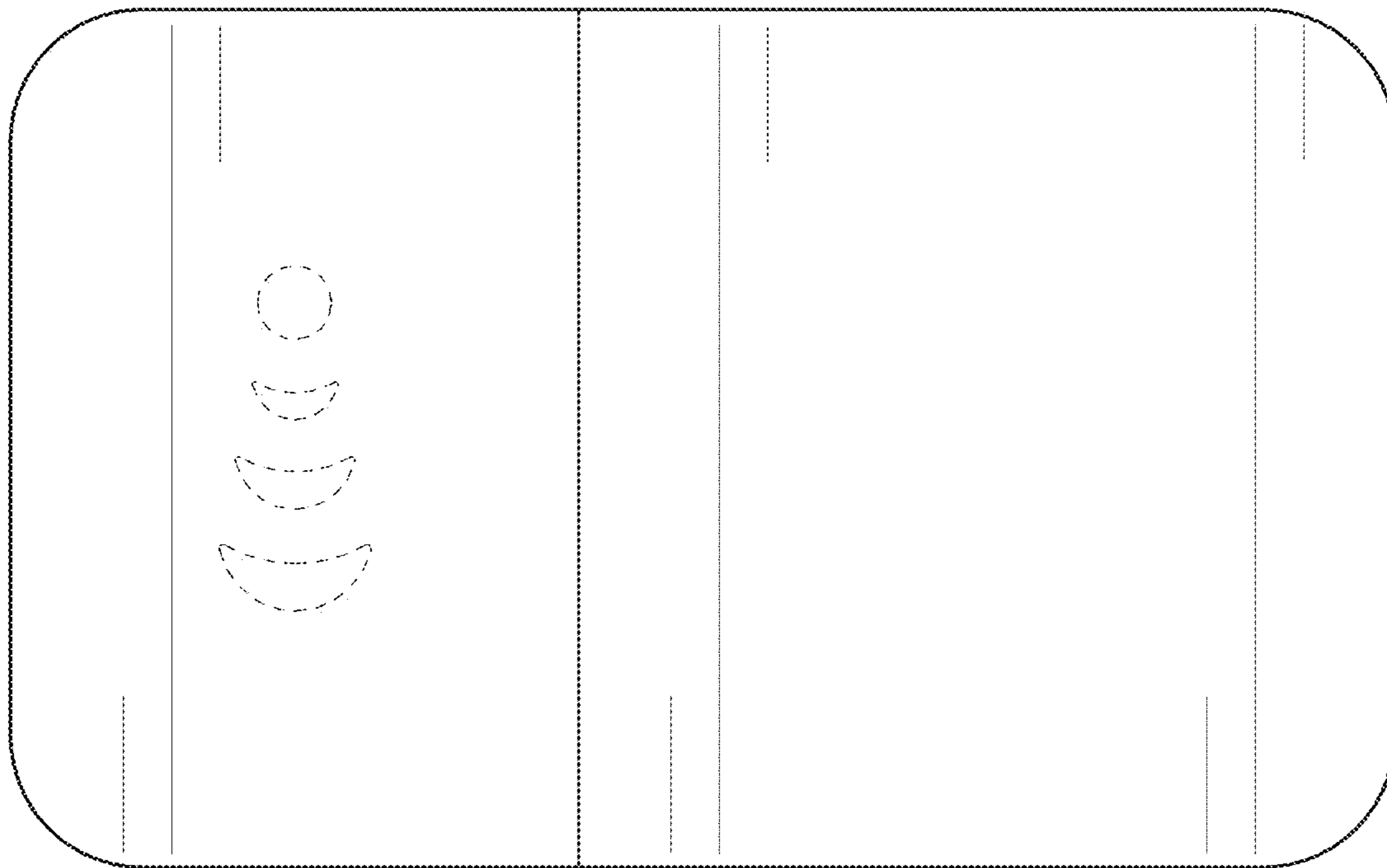

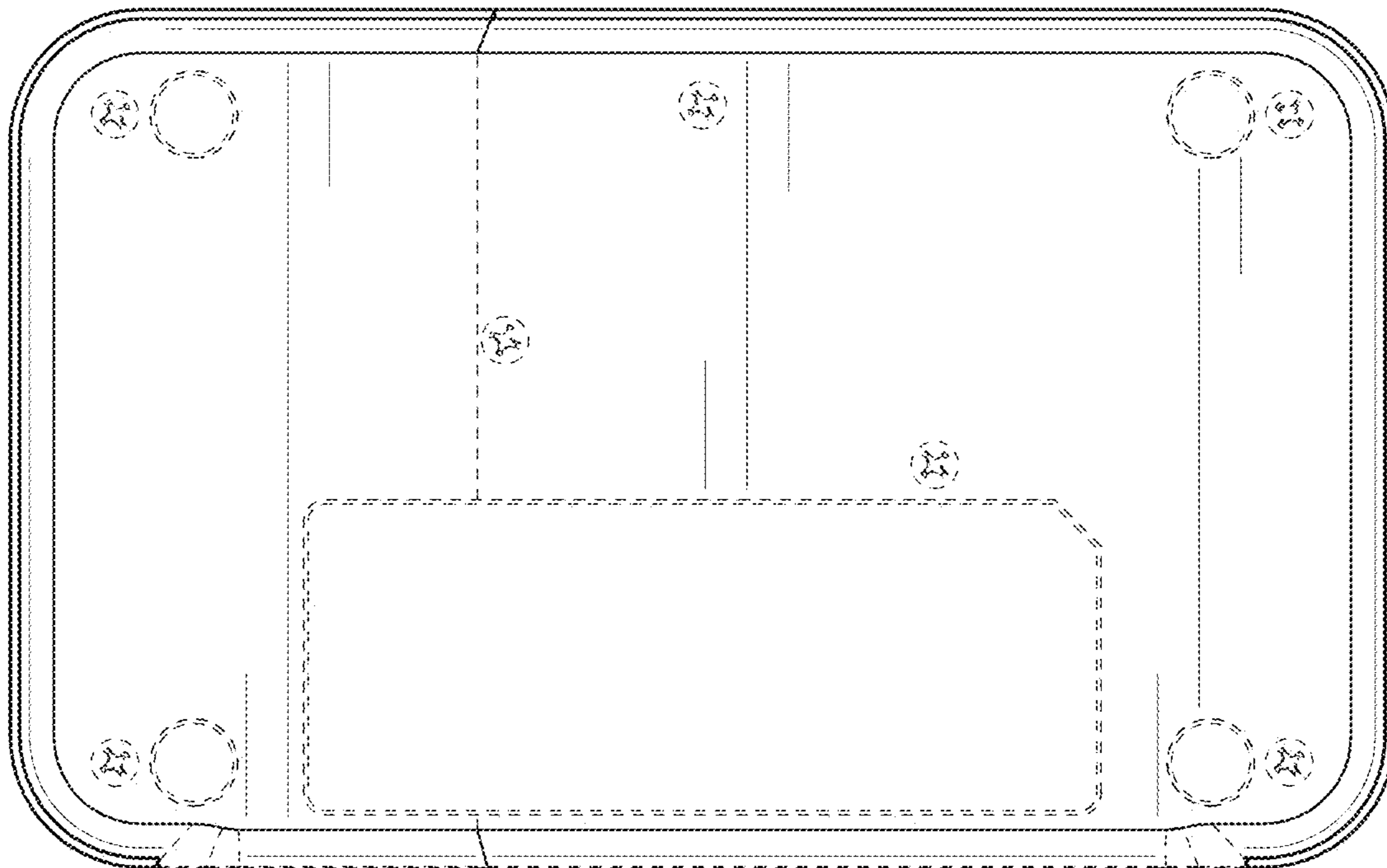
