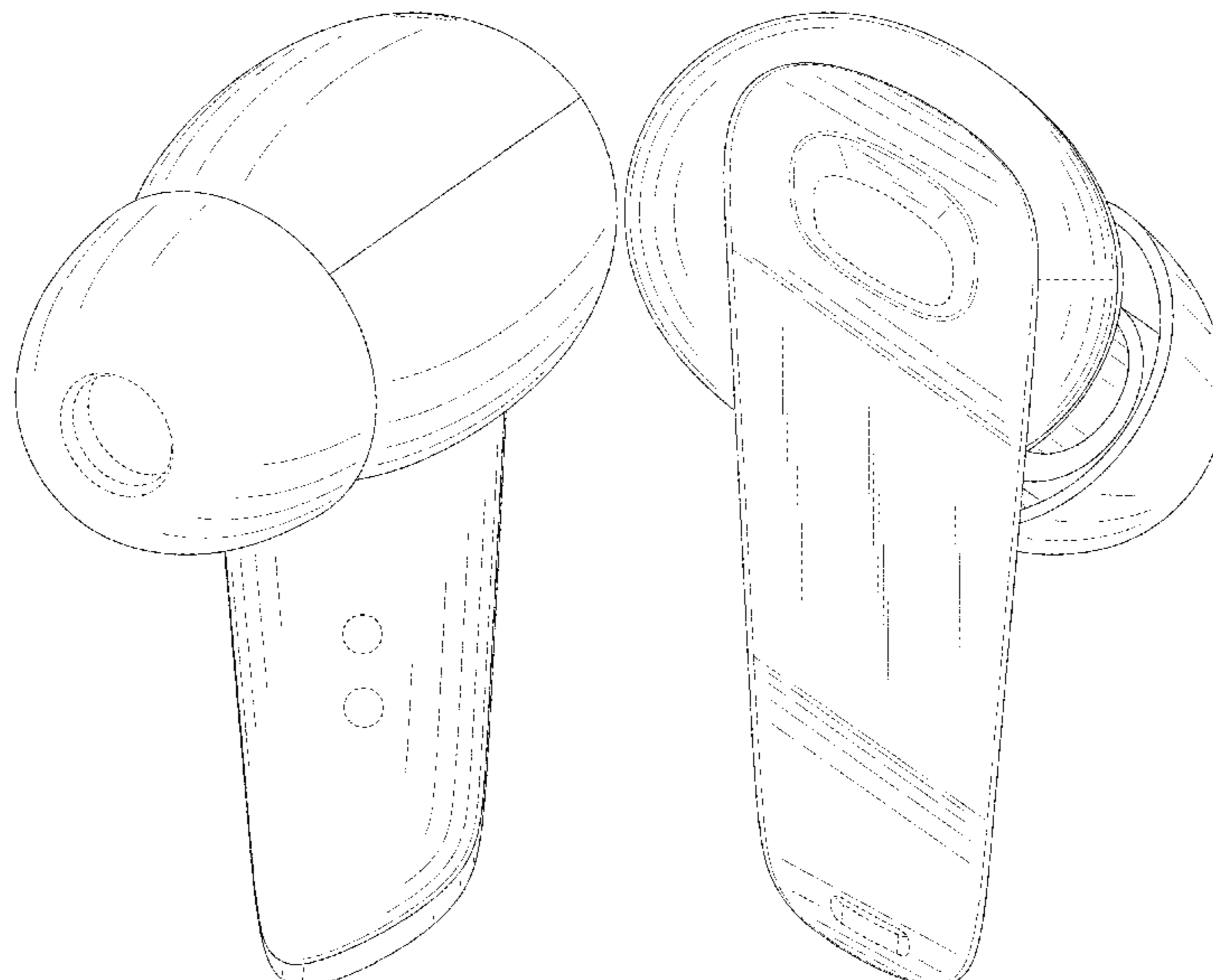
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front and left side perspective view of an earphone;  
FIG. 2 is a rear, bottom and left side perspective view thereof;

FIG. 4 is a front elevation view thereof;  
FIG. 5 is a rear elevation view thereof;

FIG. 9 is a bottom plan view thereof.

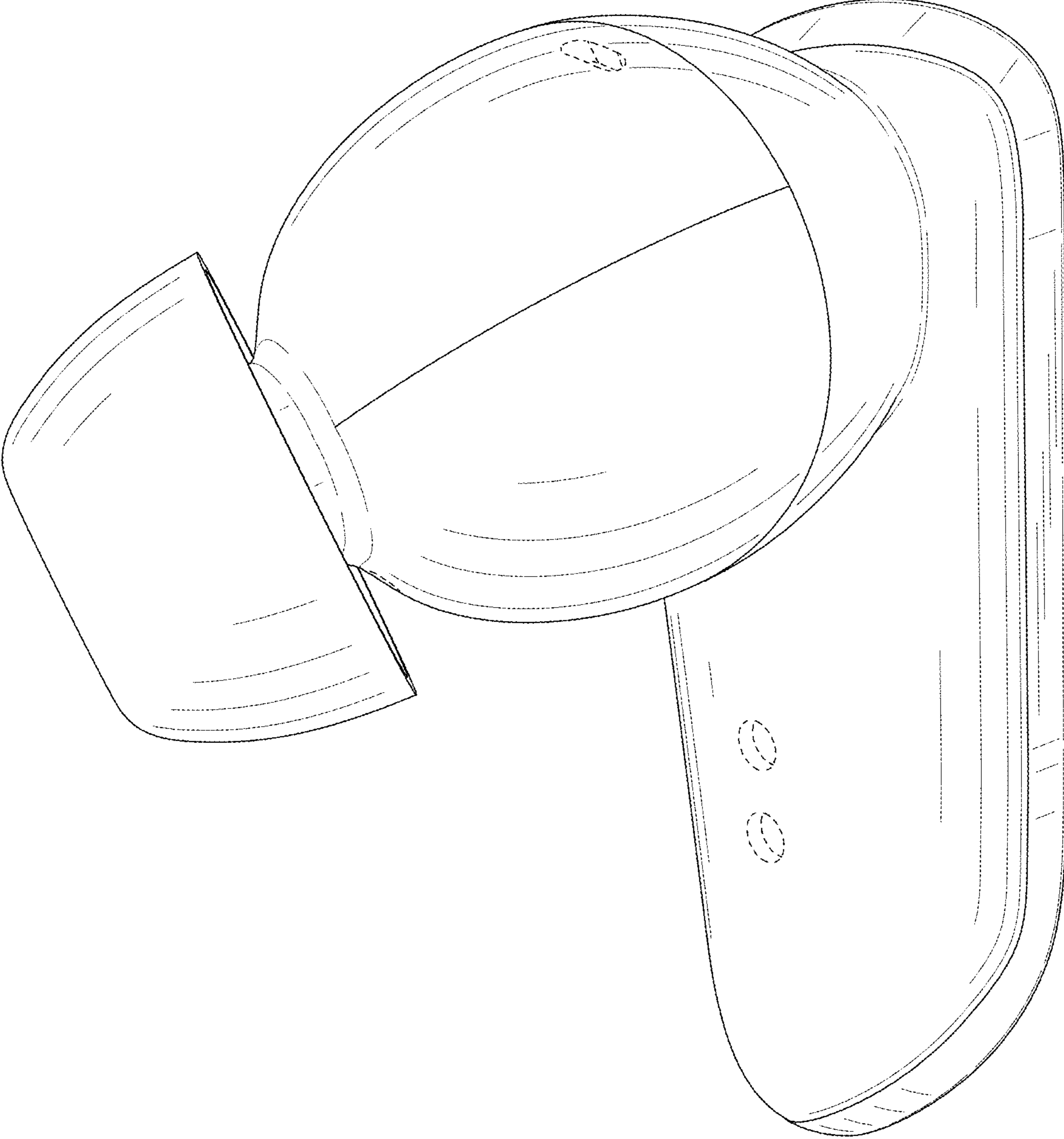

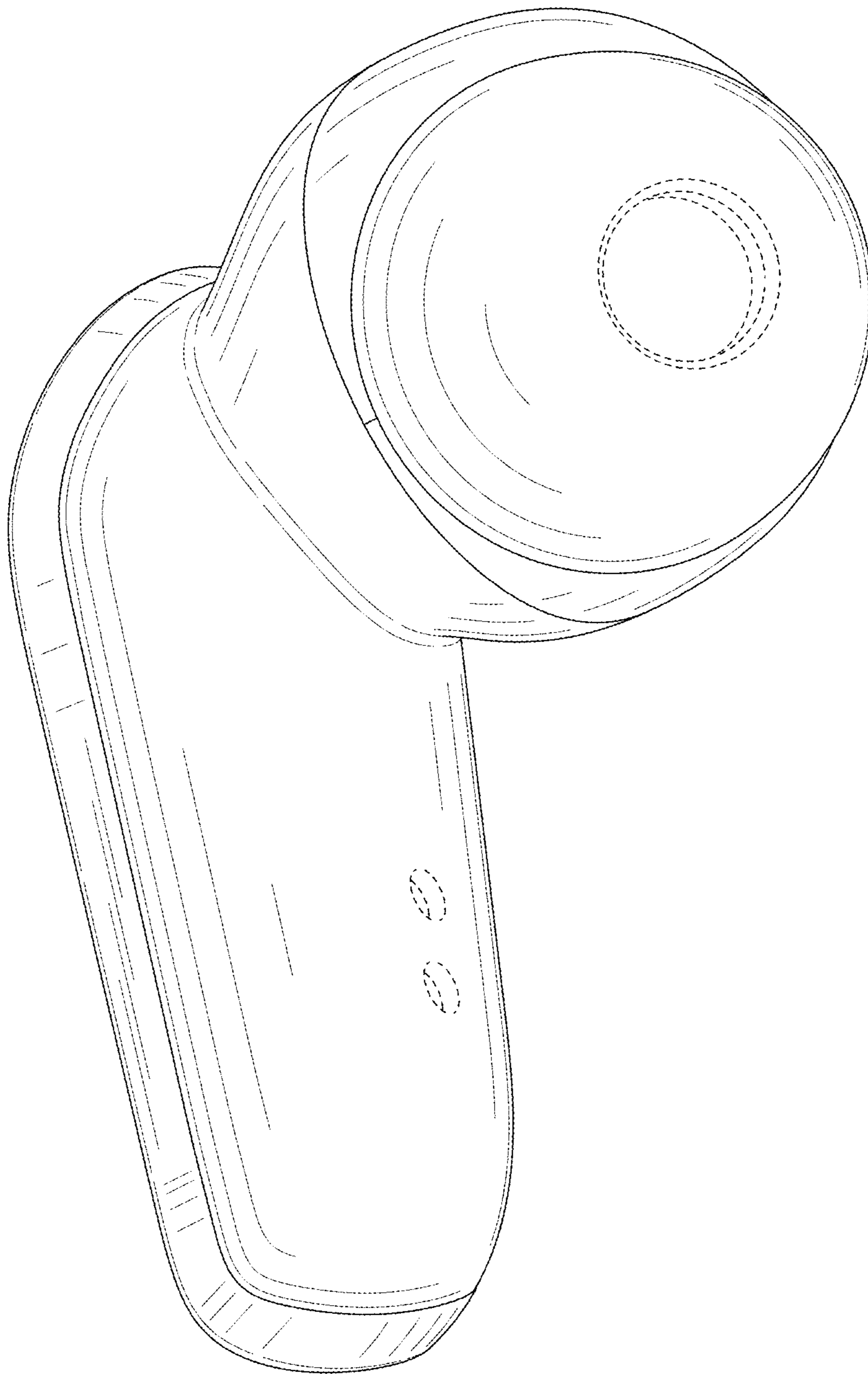

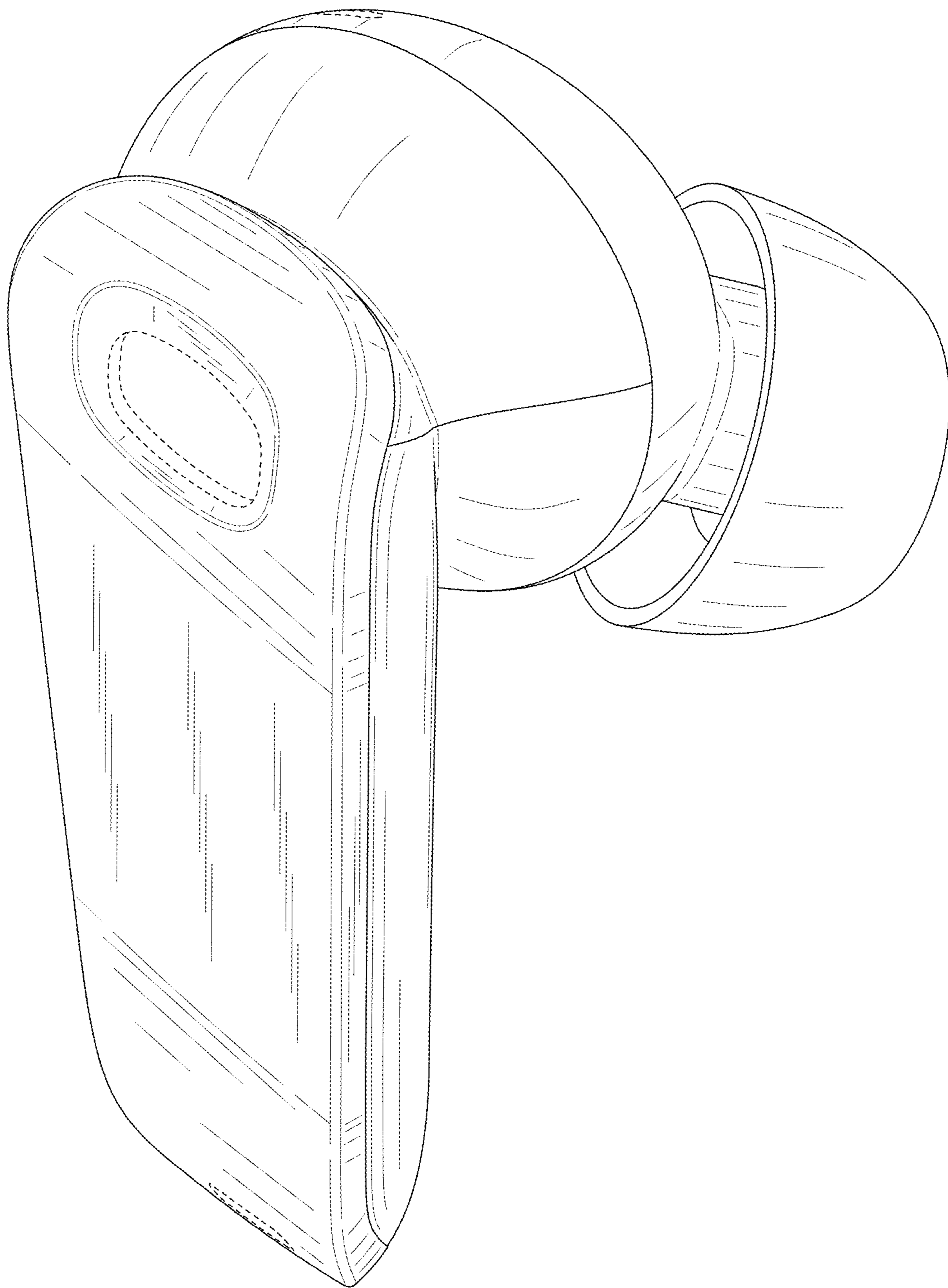

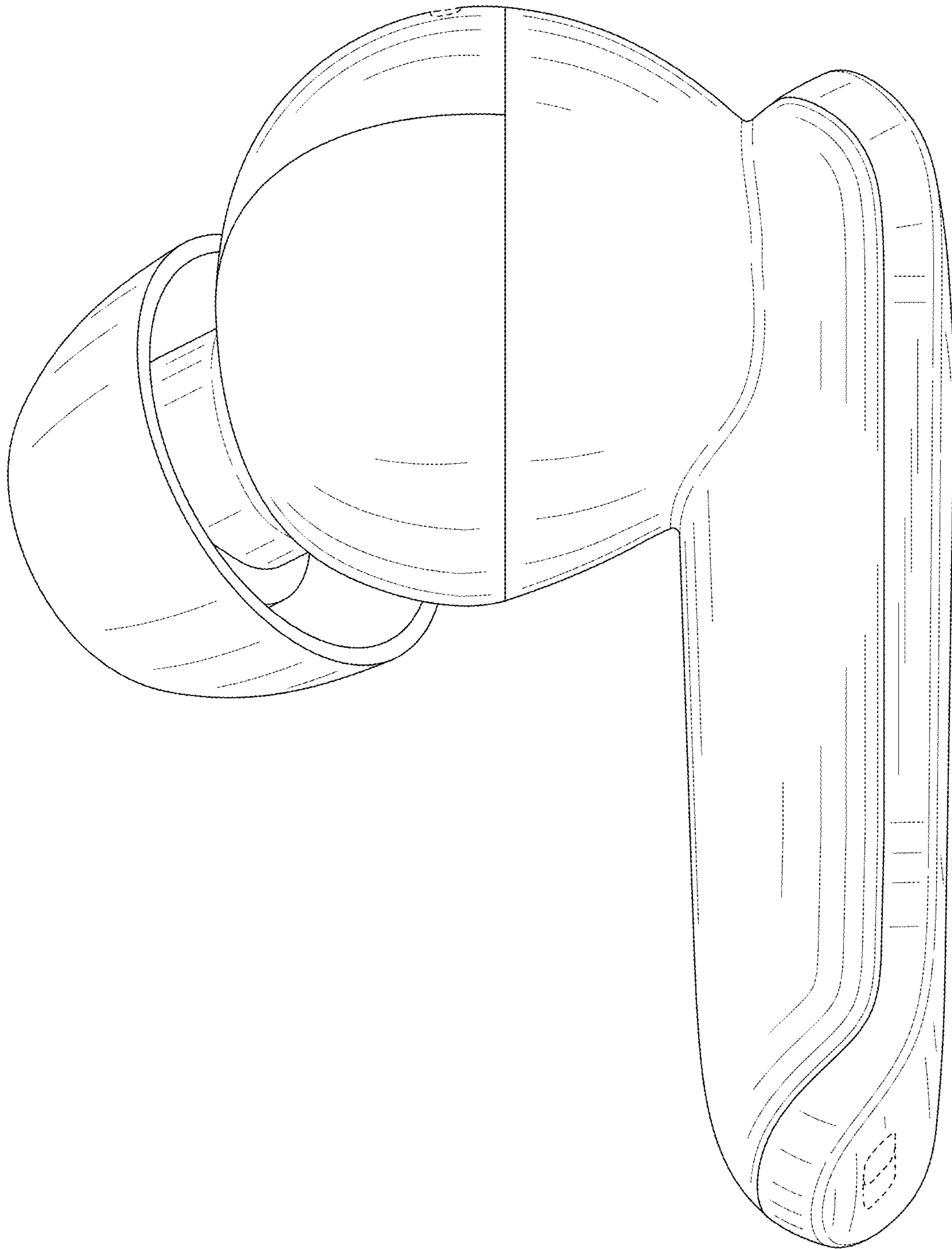

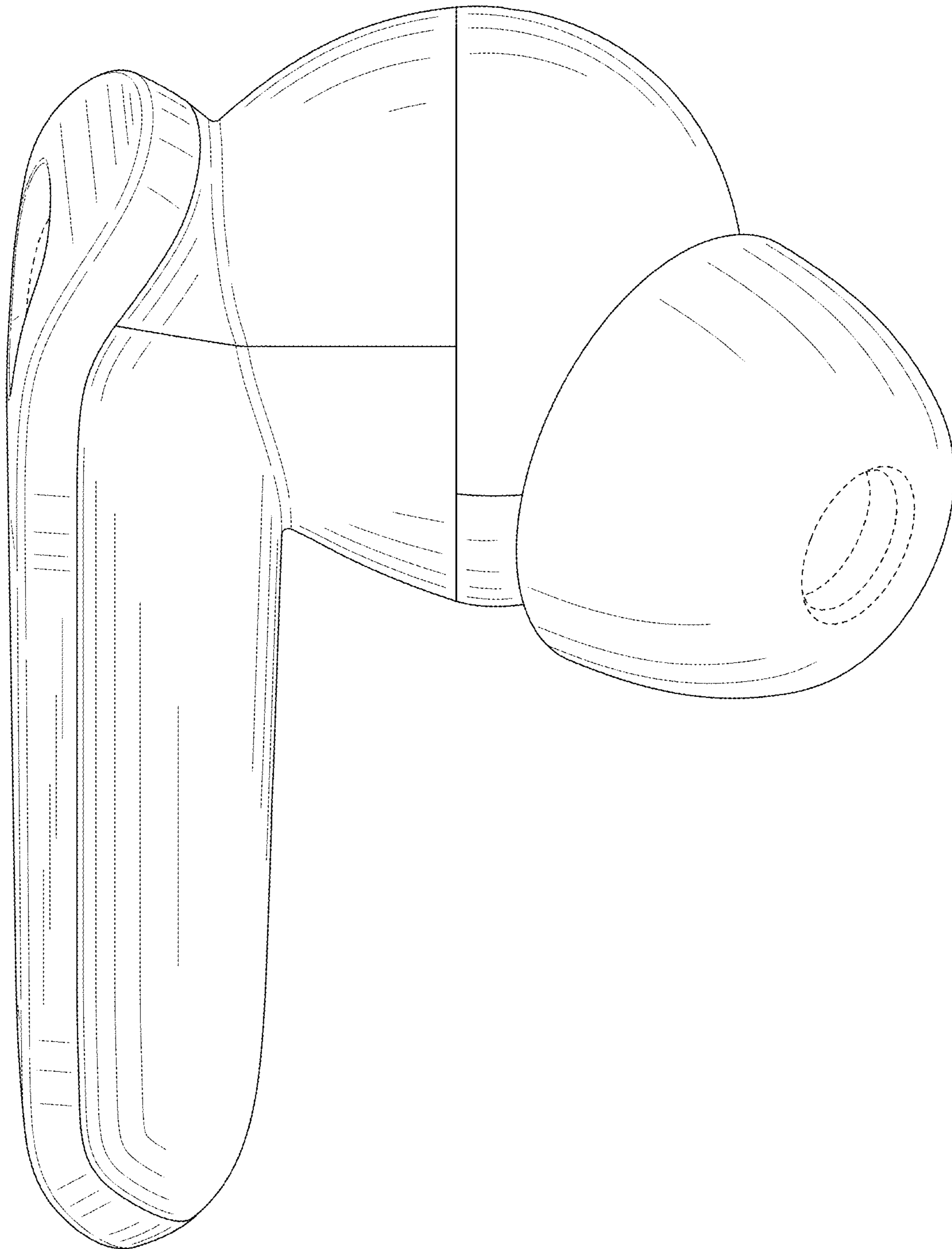

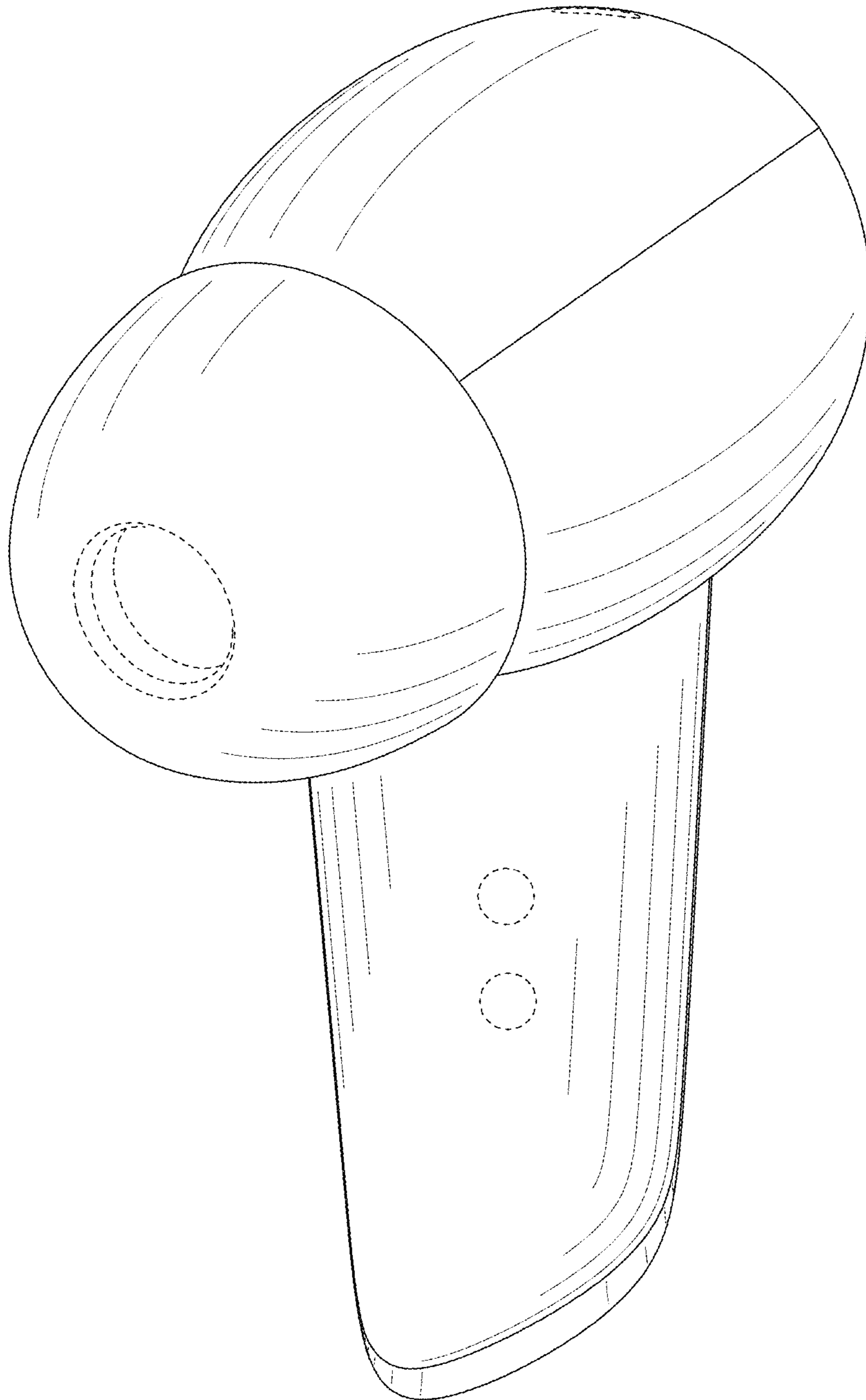

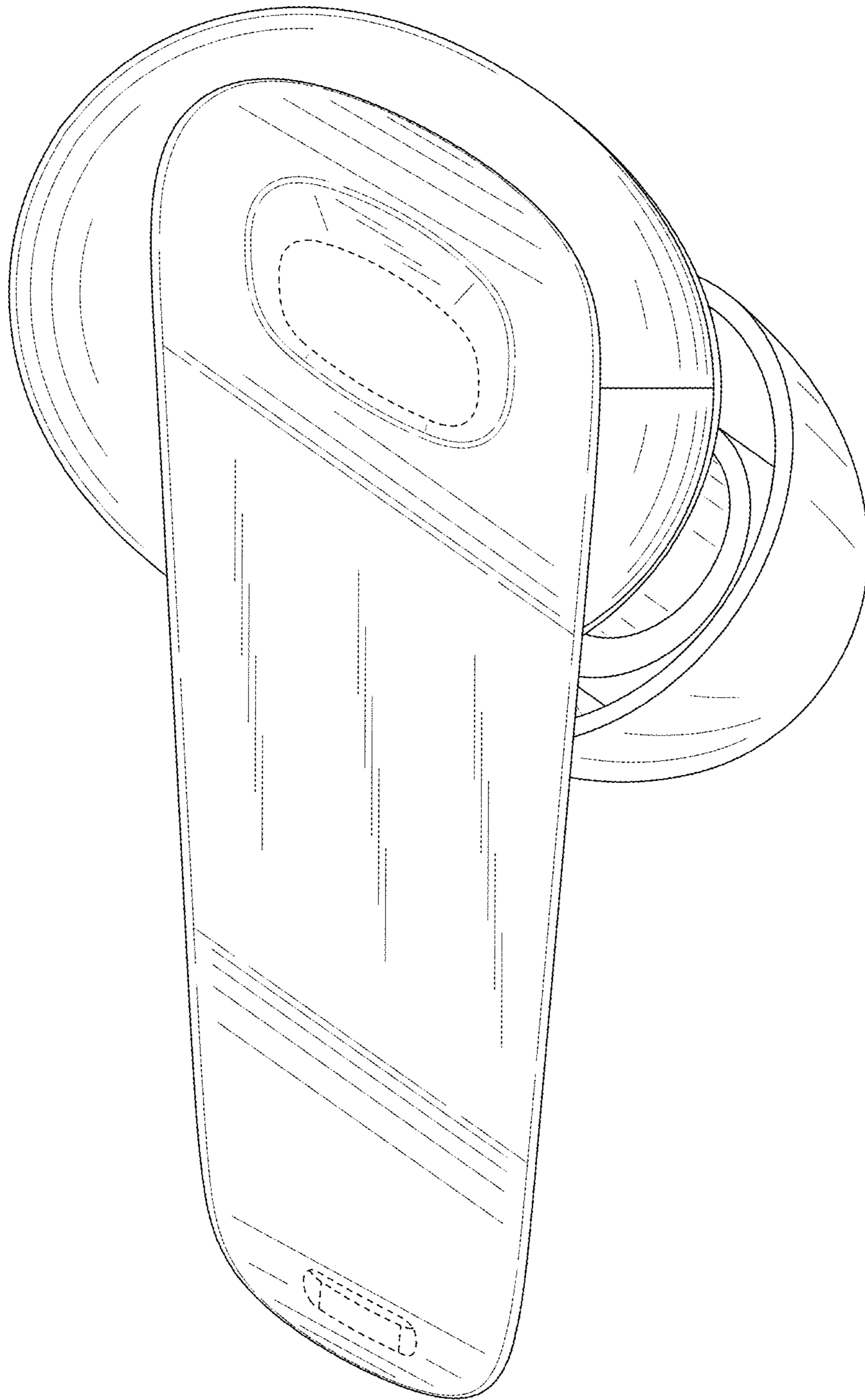

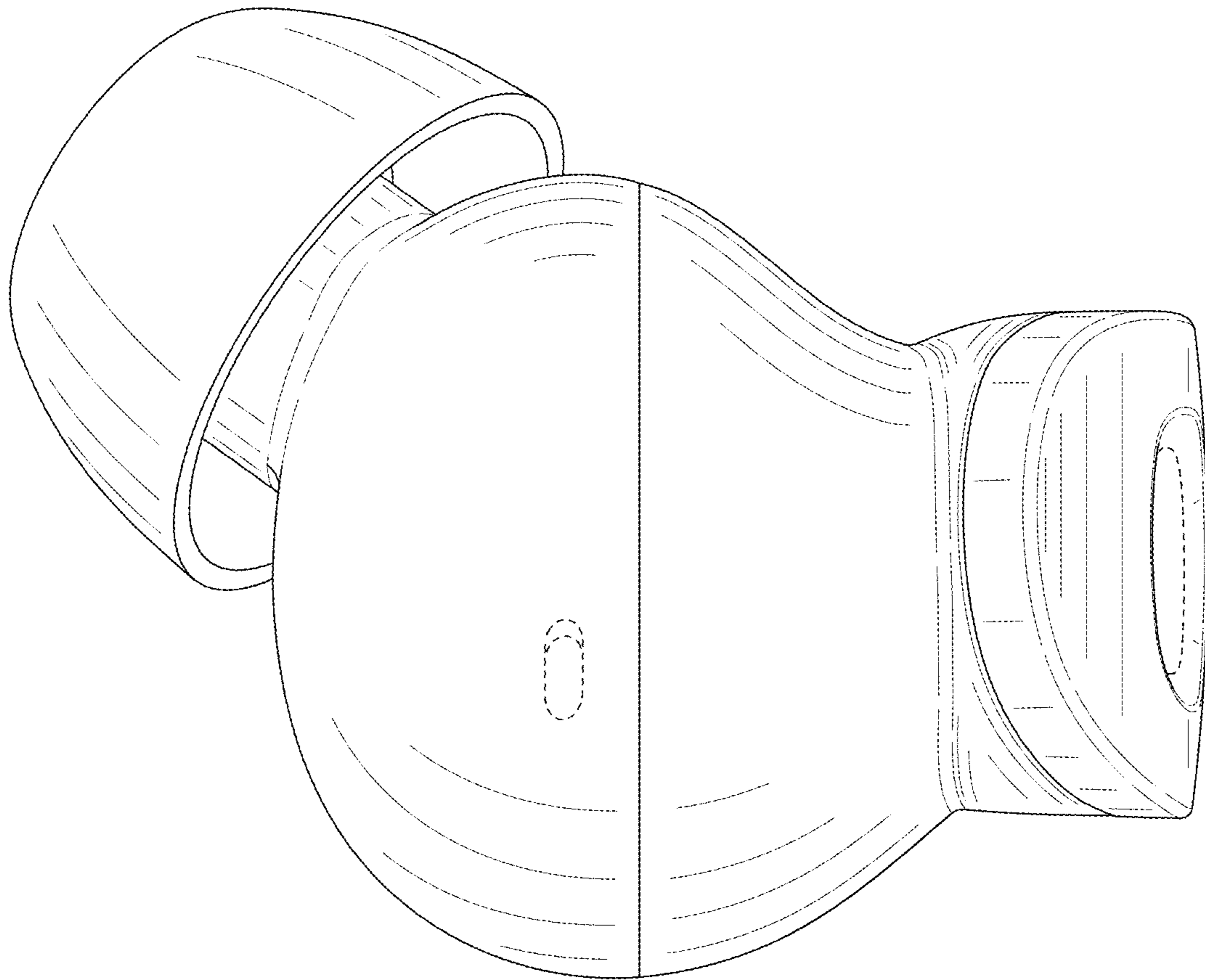

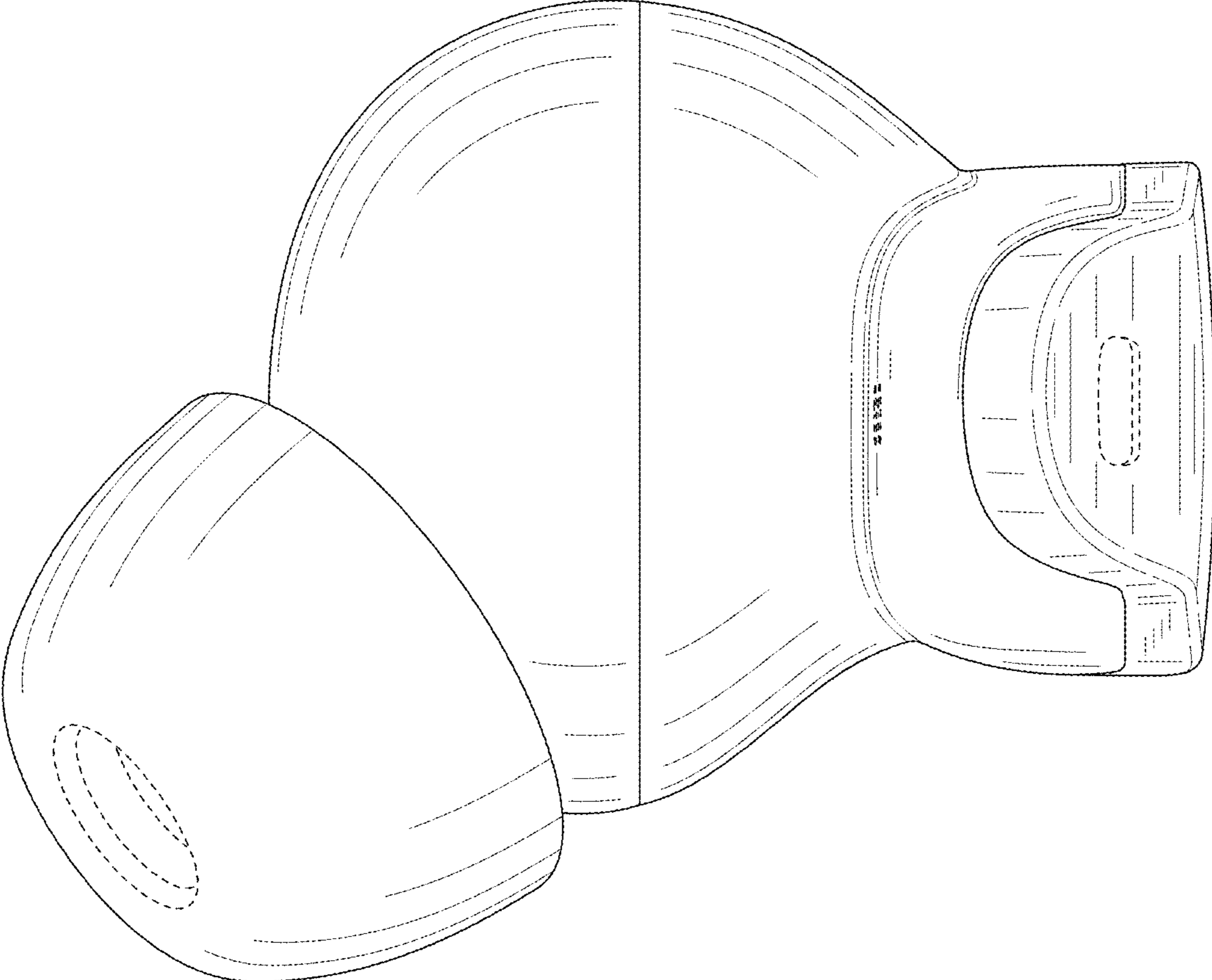
