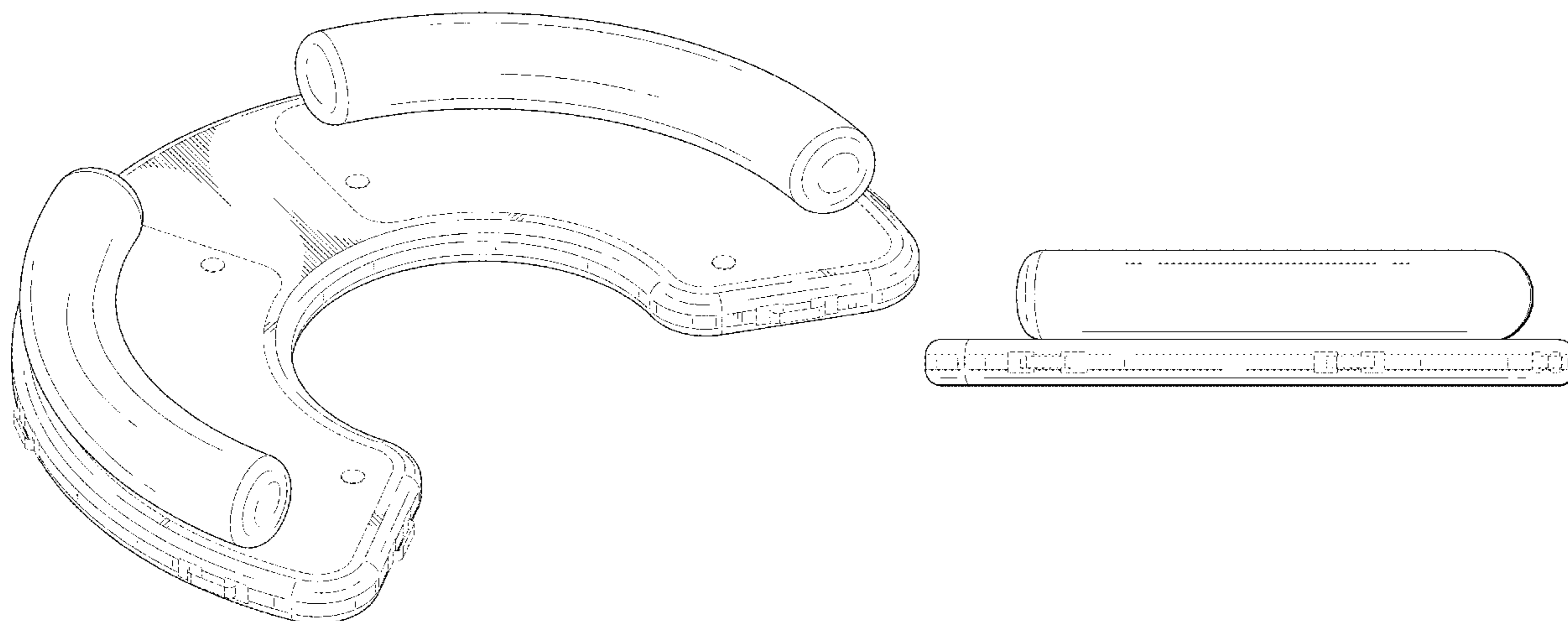
(57) **CLAIM**

The ornamental design for the inflatable dock, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the inflatable dock showing the new design;
FIG. 2 is a front elevation view thereof;

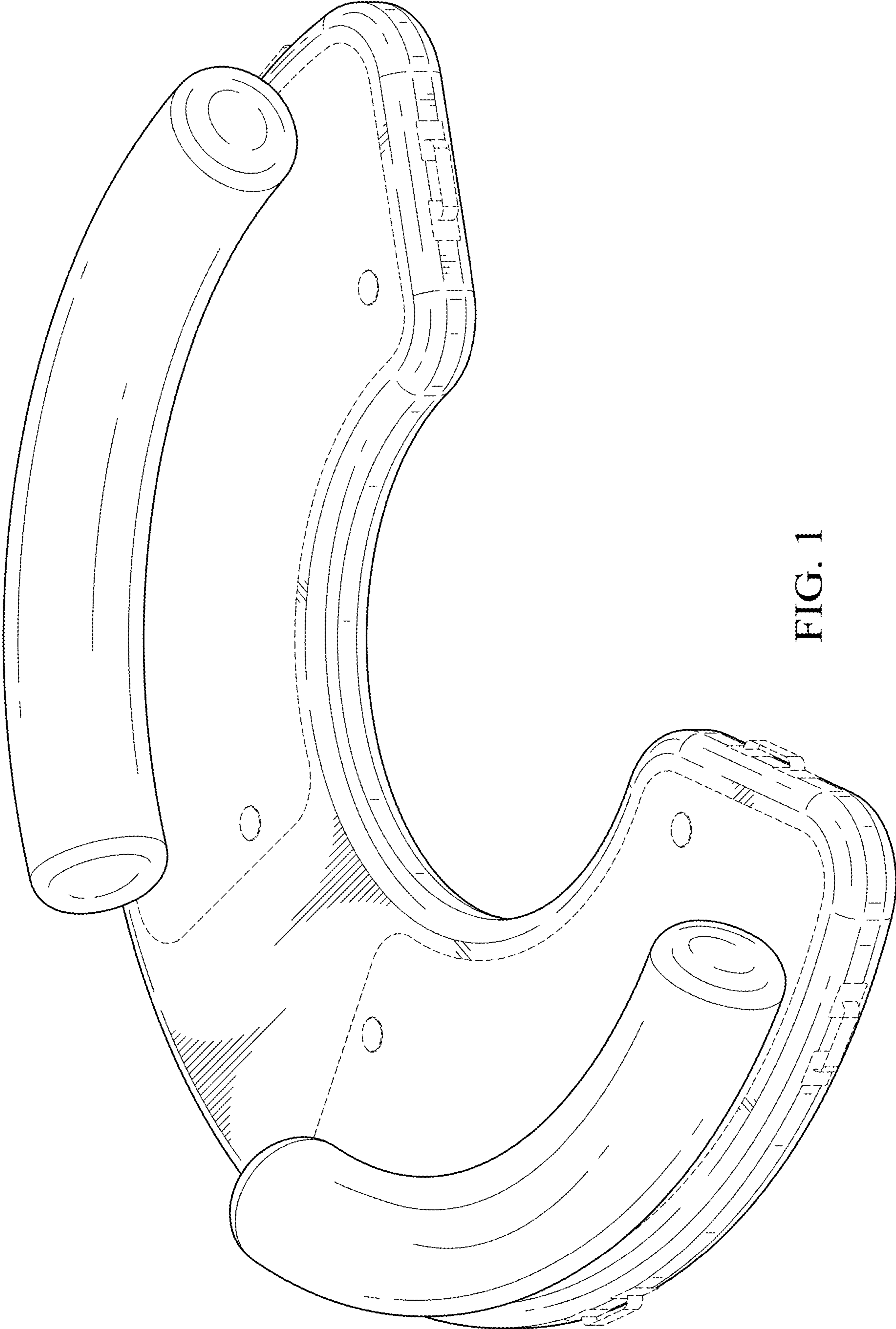

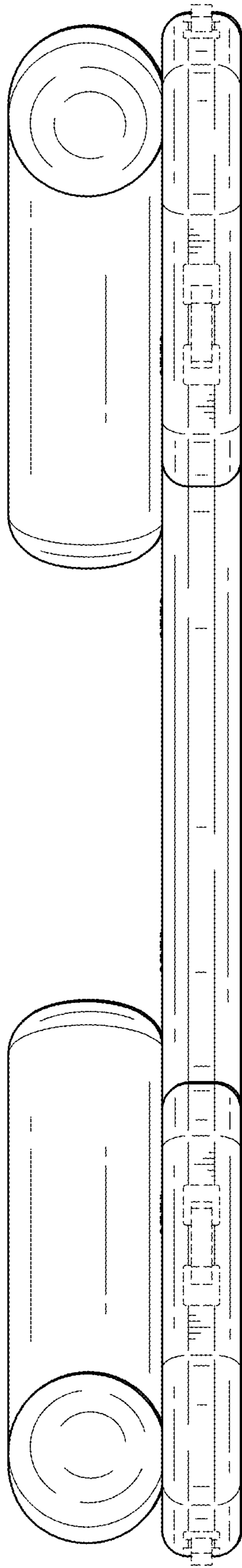

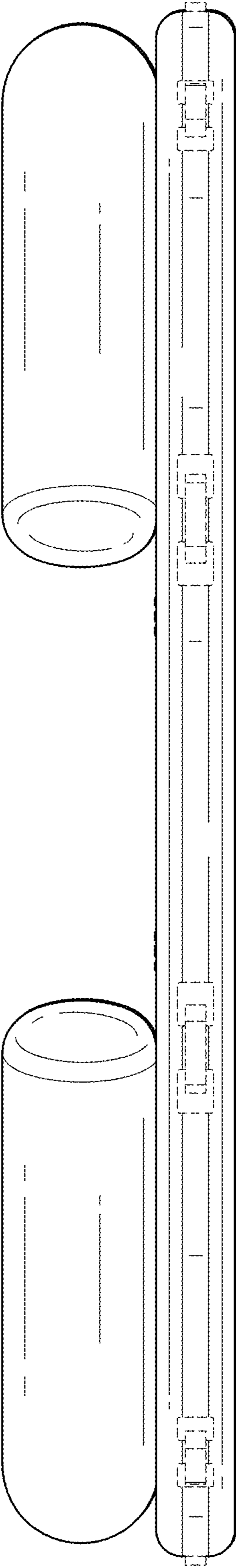

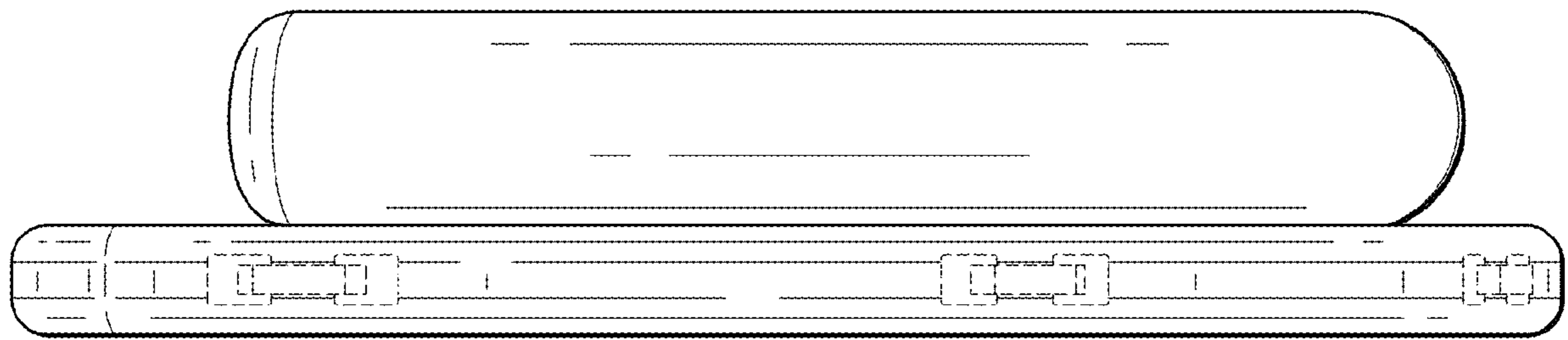

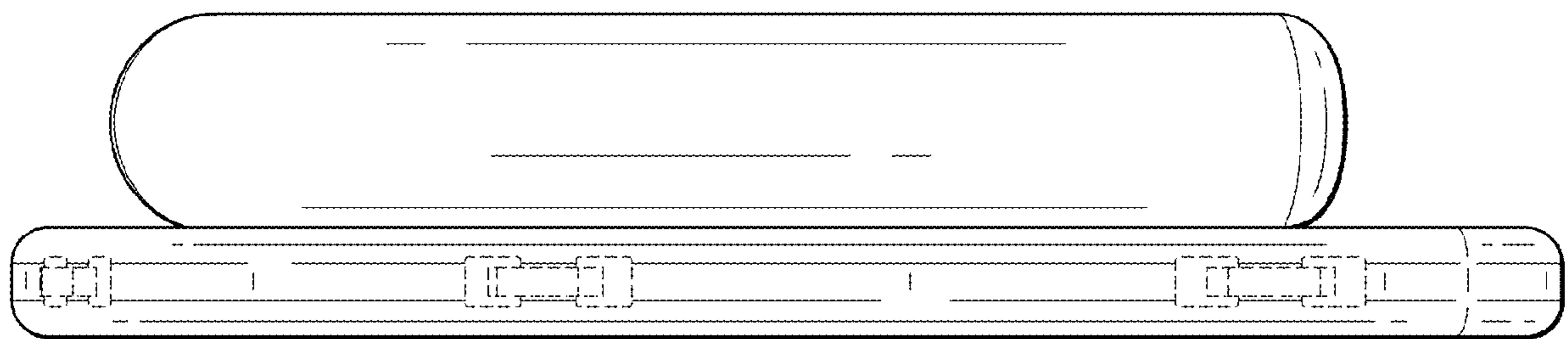

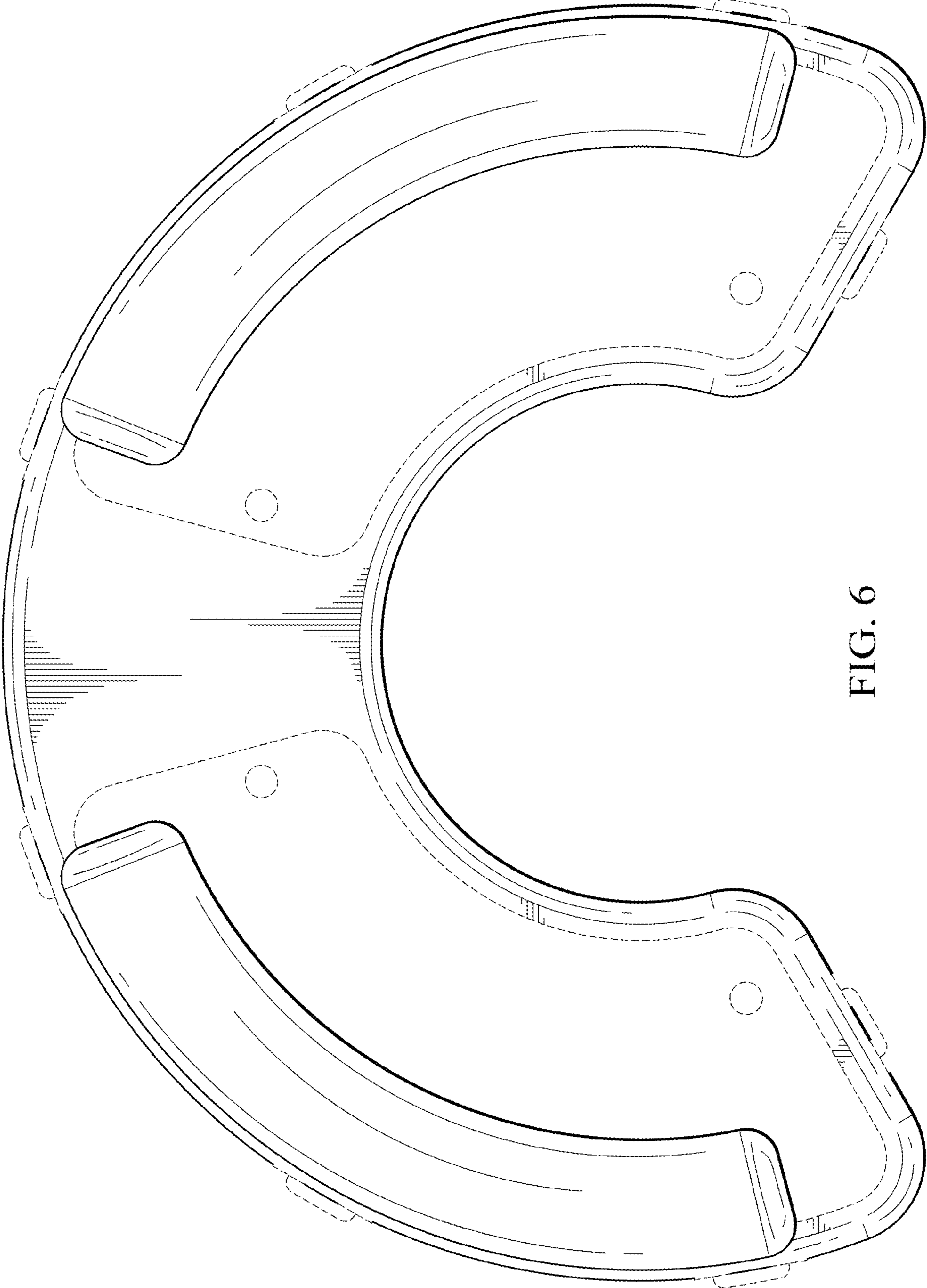

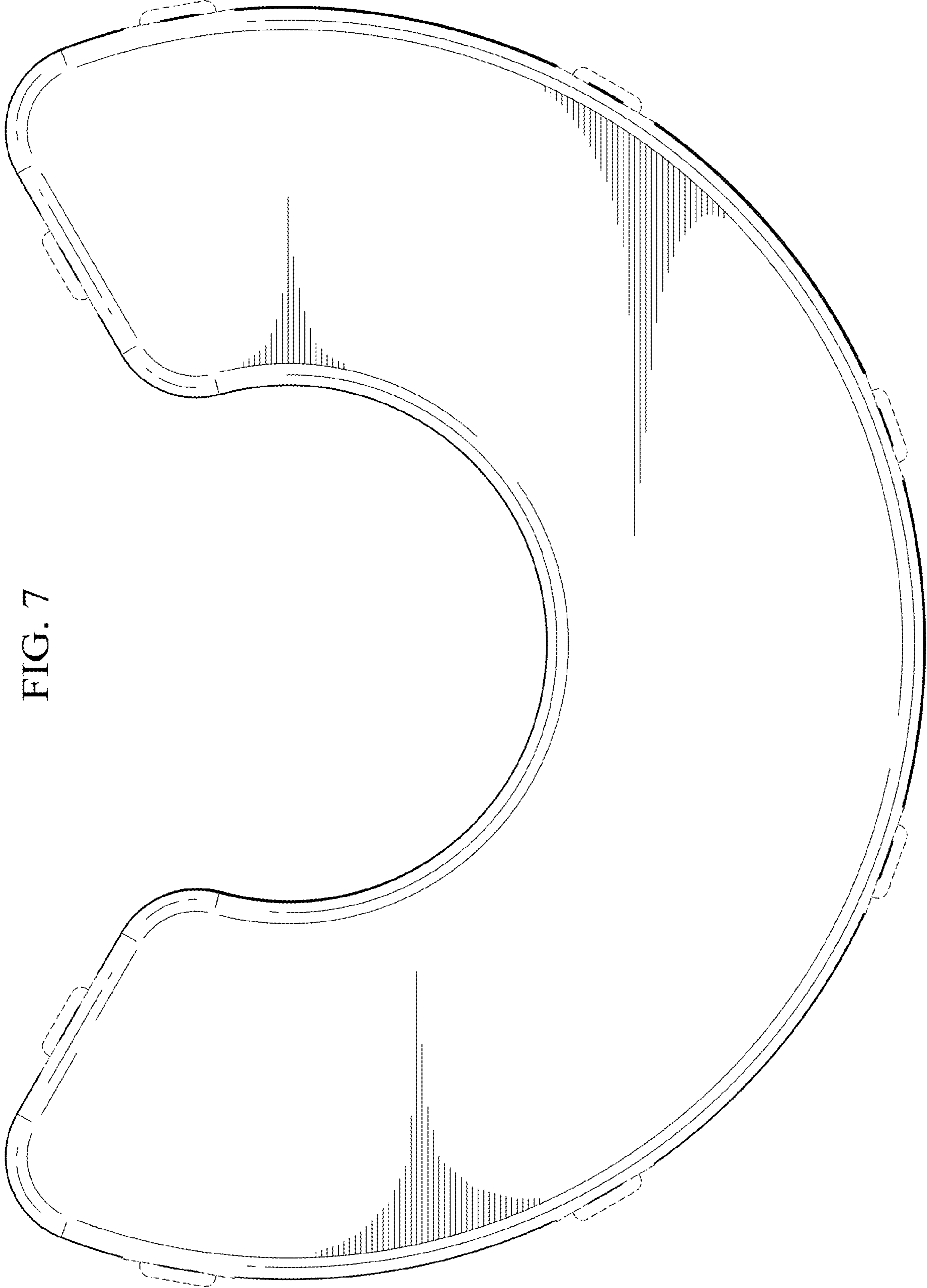

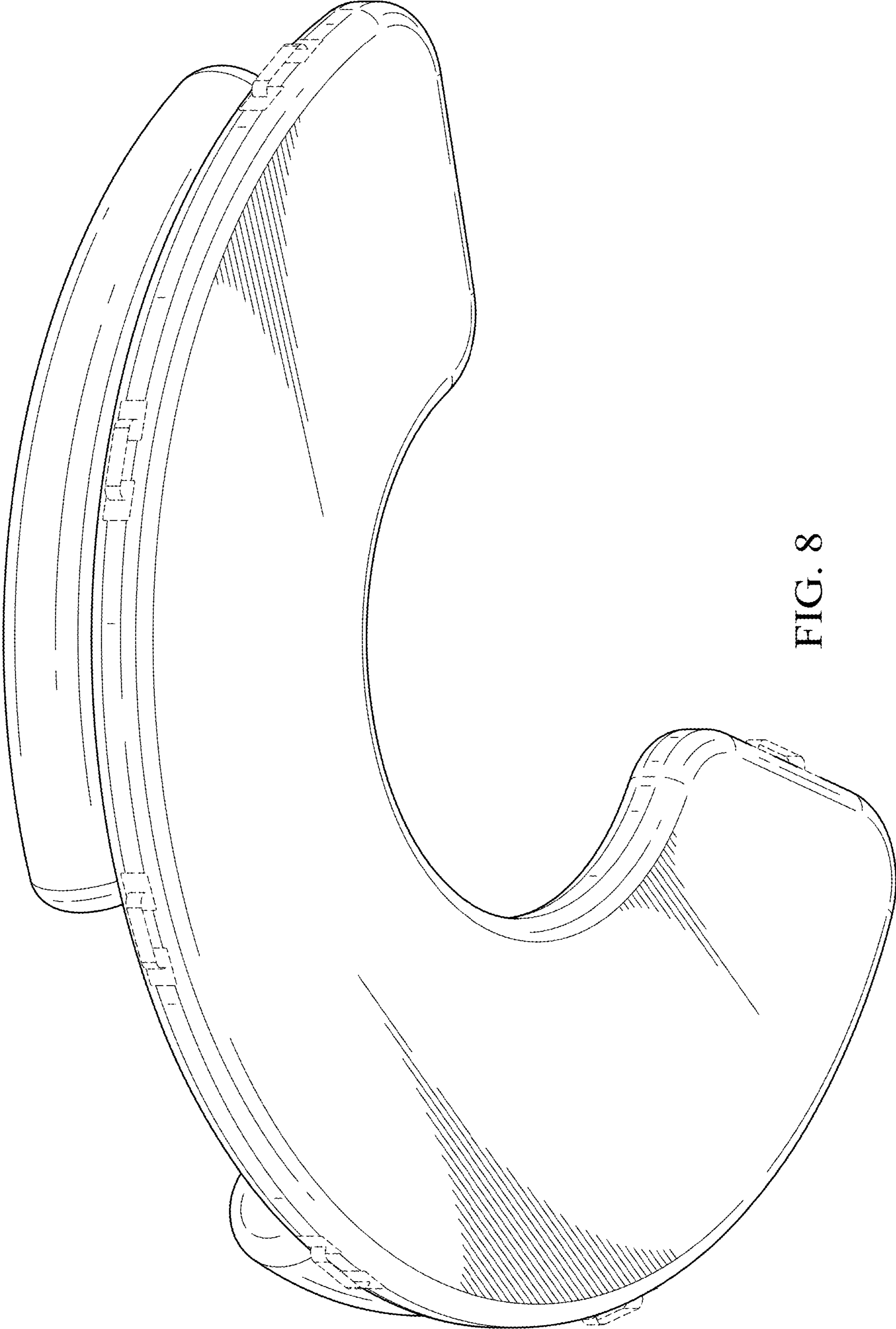
