The ornamental design for an extracorporeal marker for medical use, as shown and described.

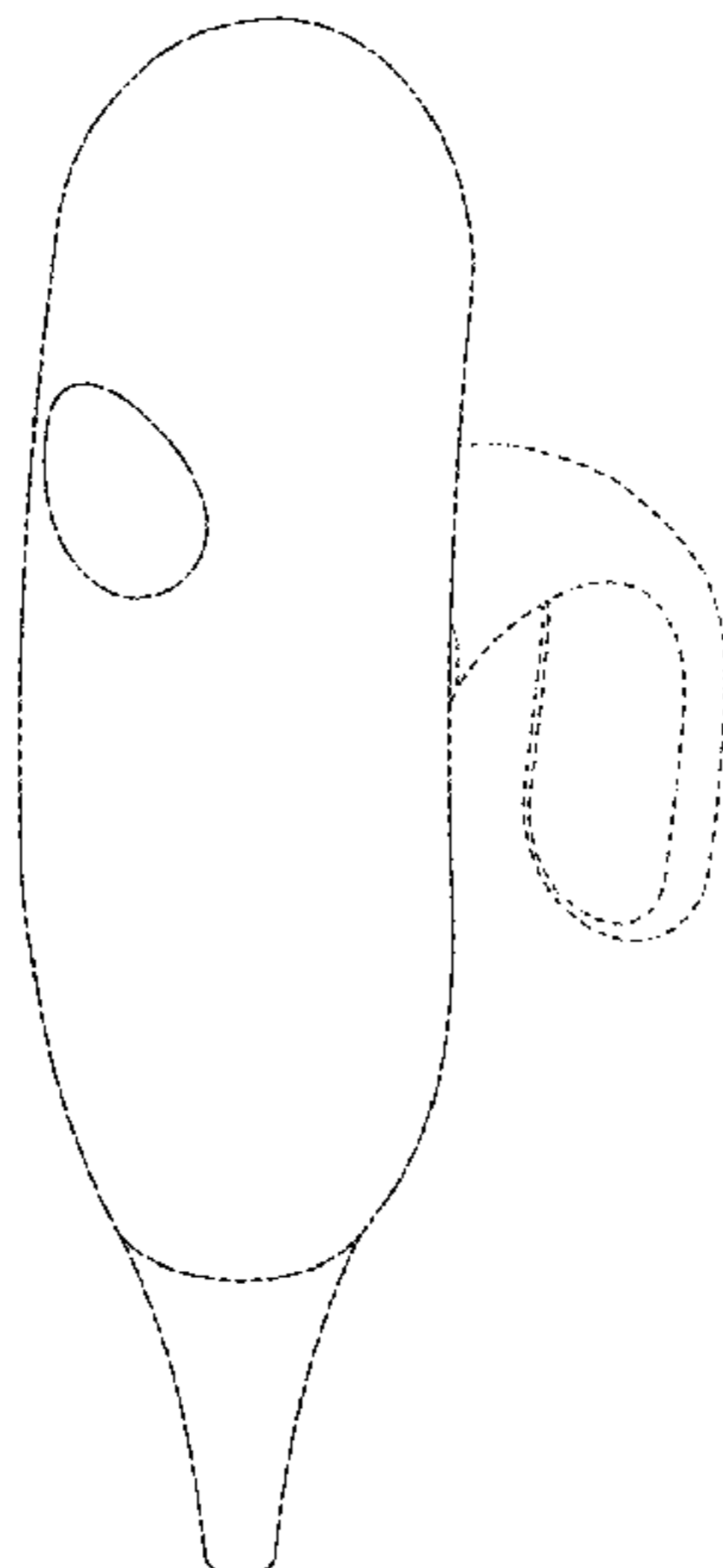
**DESCRIPTION**

FIG. 1 is a front perspective view of an extracorporeal marker for medical use, showing the new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a right-side view thereof; FIG. 6 is a left-side view thereof; FIG. 7 is a top view thereof; FIG. 8 is a bottom side view; and, FIG. 9 is another perspective view of the extracorporeal marker for medical use shown in FIG. 1, shown in a position of use.

The broken lines depicting portions of the extracorporeal marker for medical use form no part of the claimed design. Additionally, the broken lines in FIG. 9 showing a human hand and a cable depict environment and form no part of the claimed design.

The present article is an extracorporeal marker for medical use which is intended to be used in conjunction with an endoscope.

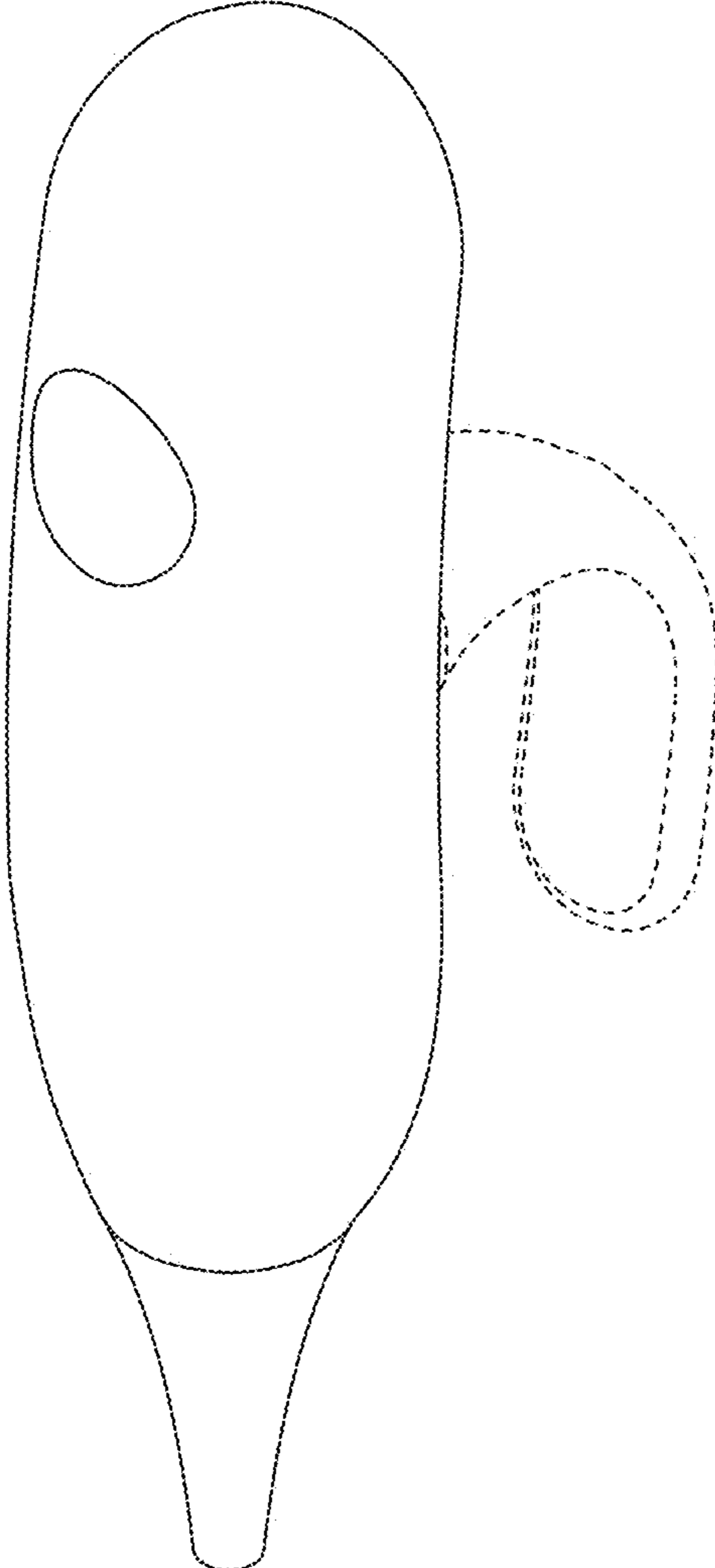

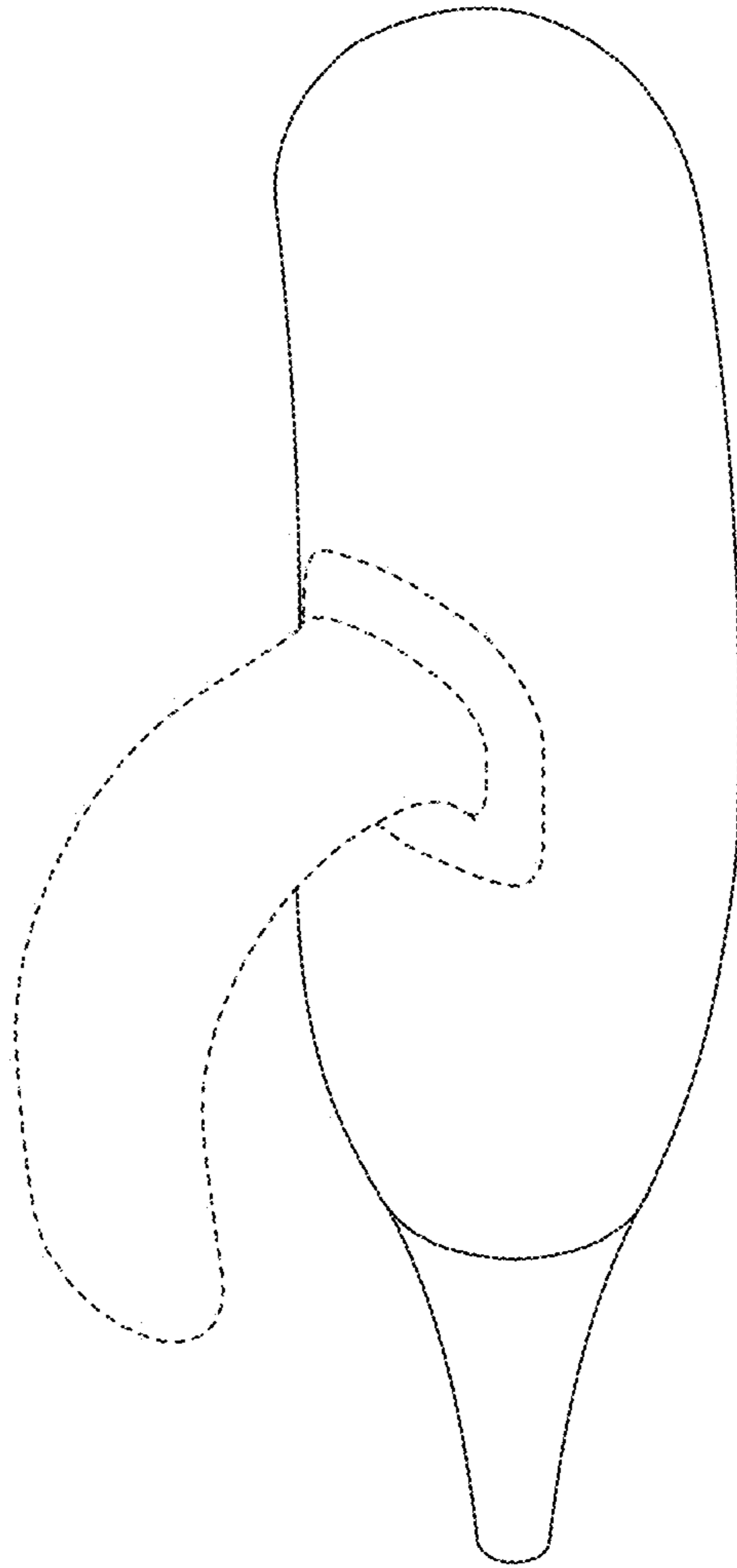

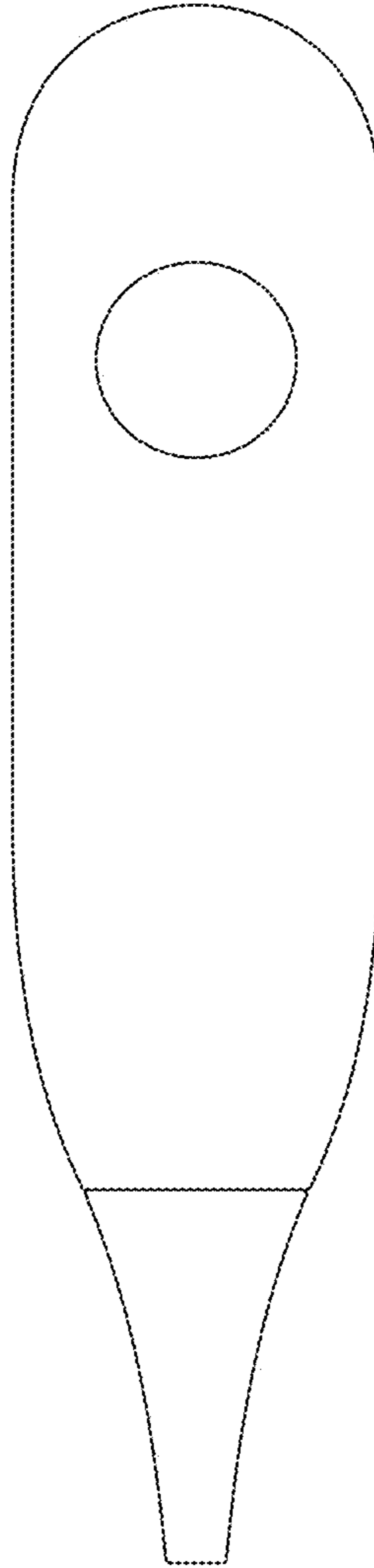

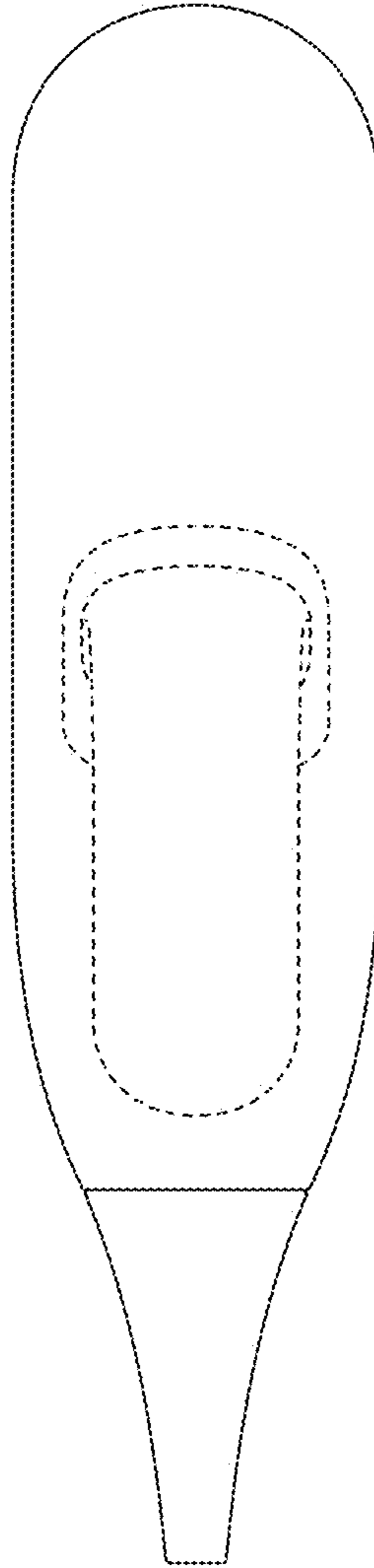

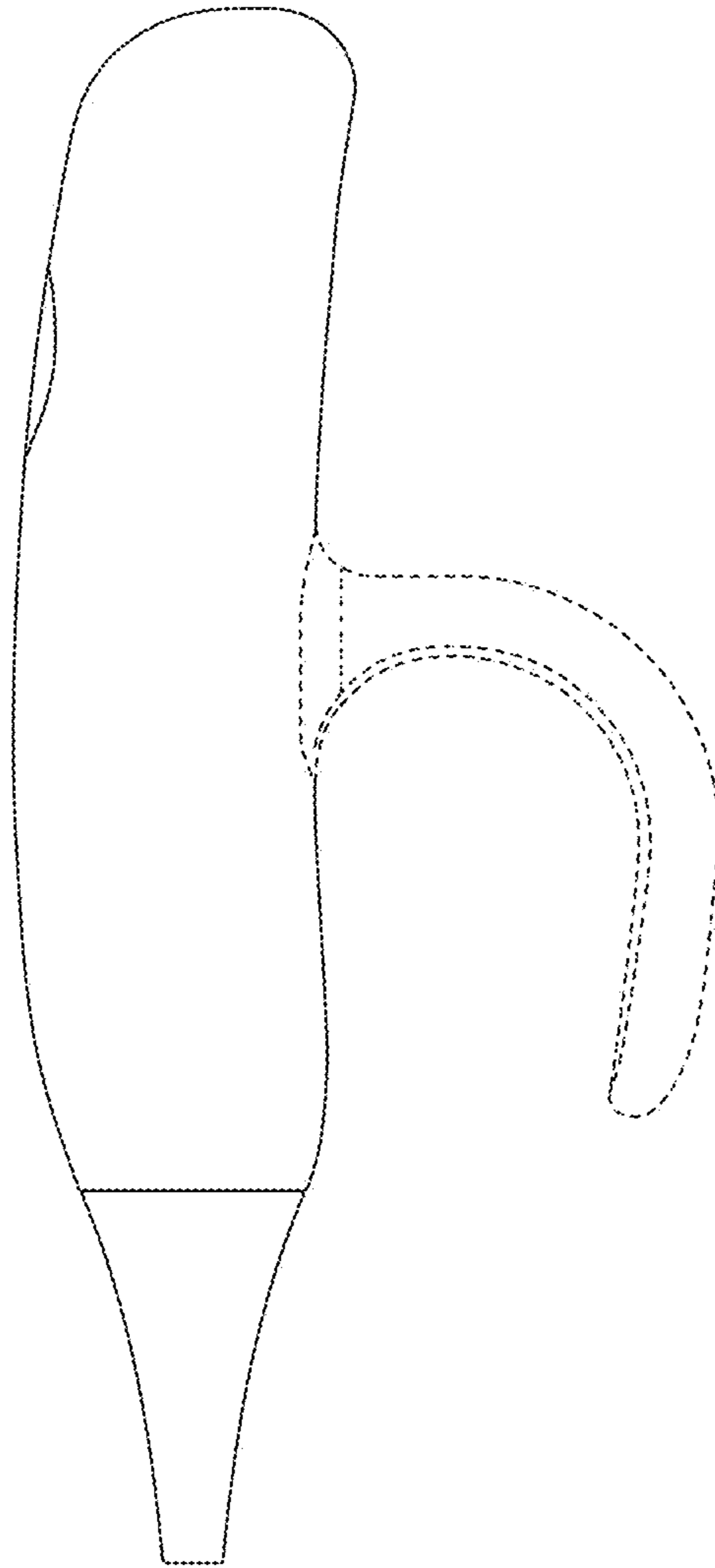

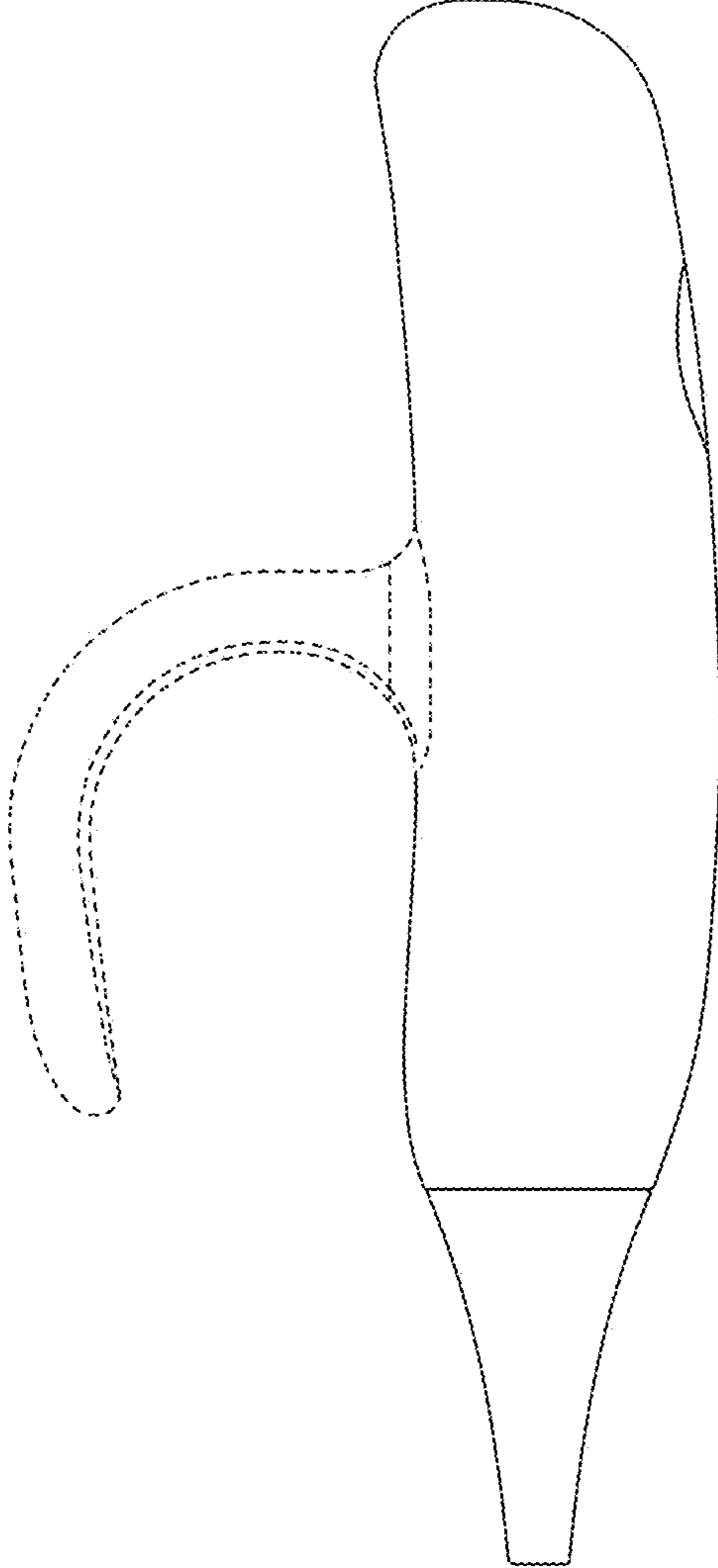

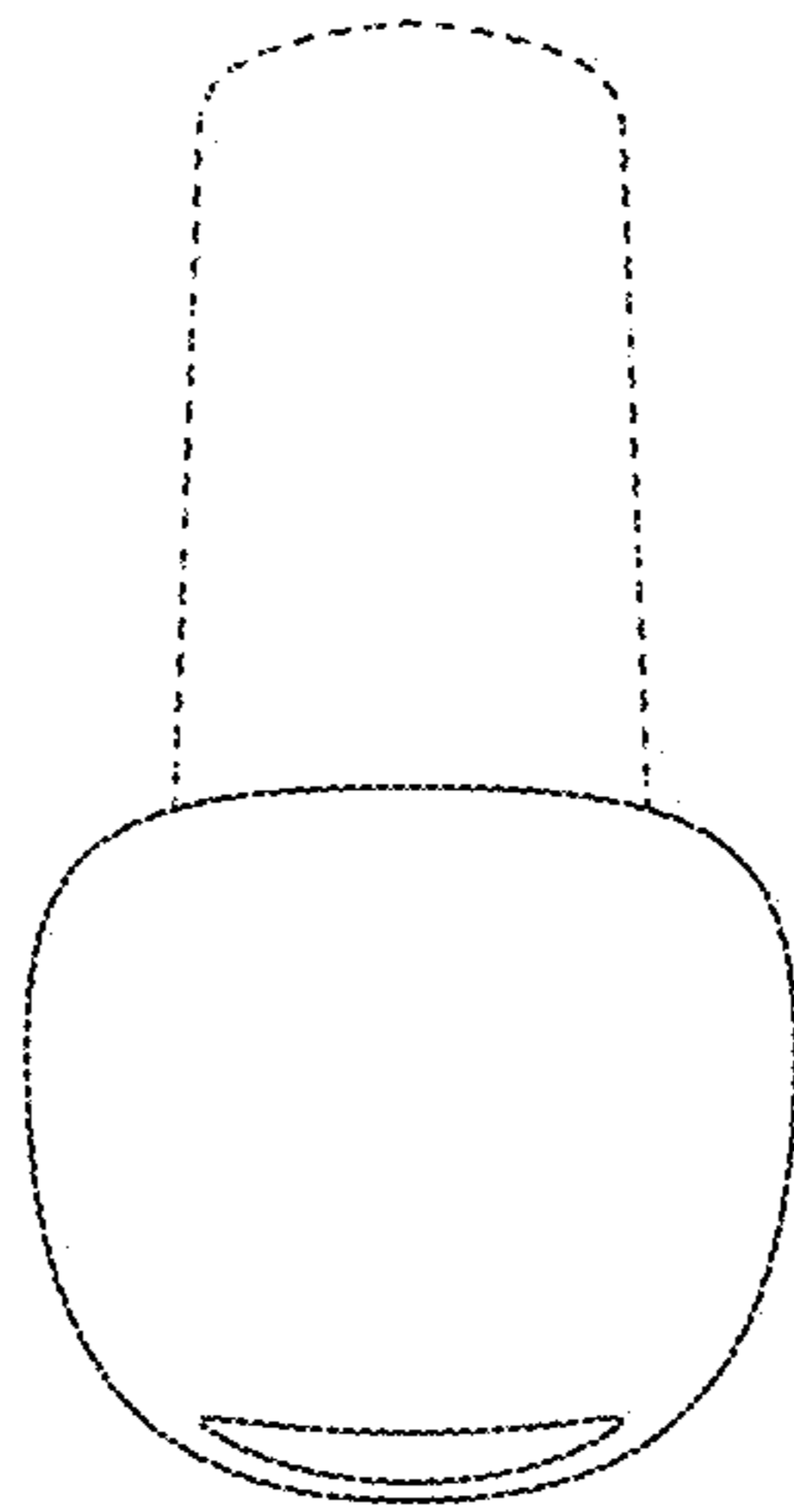

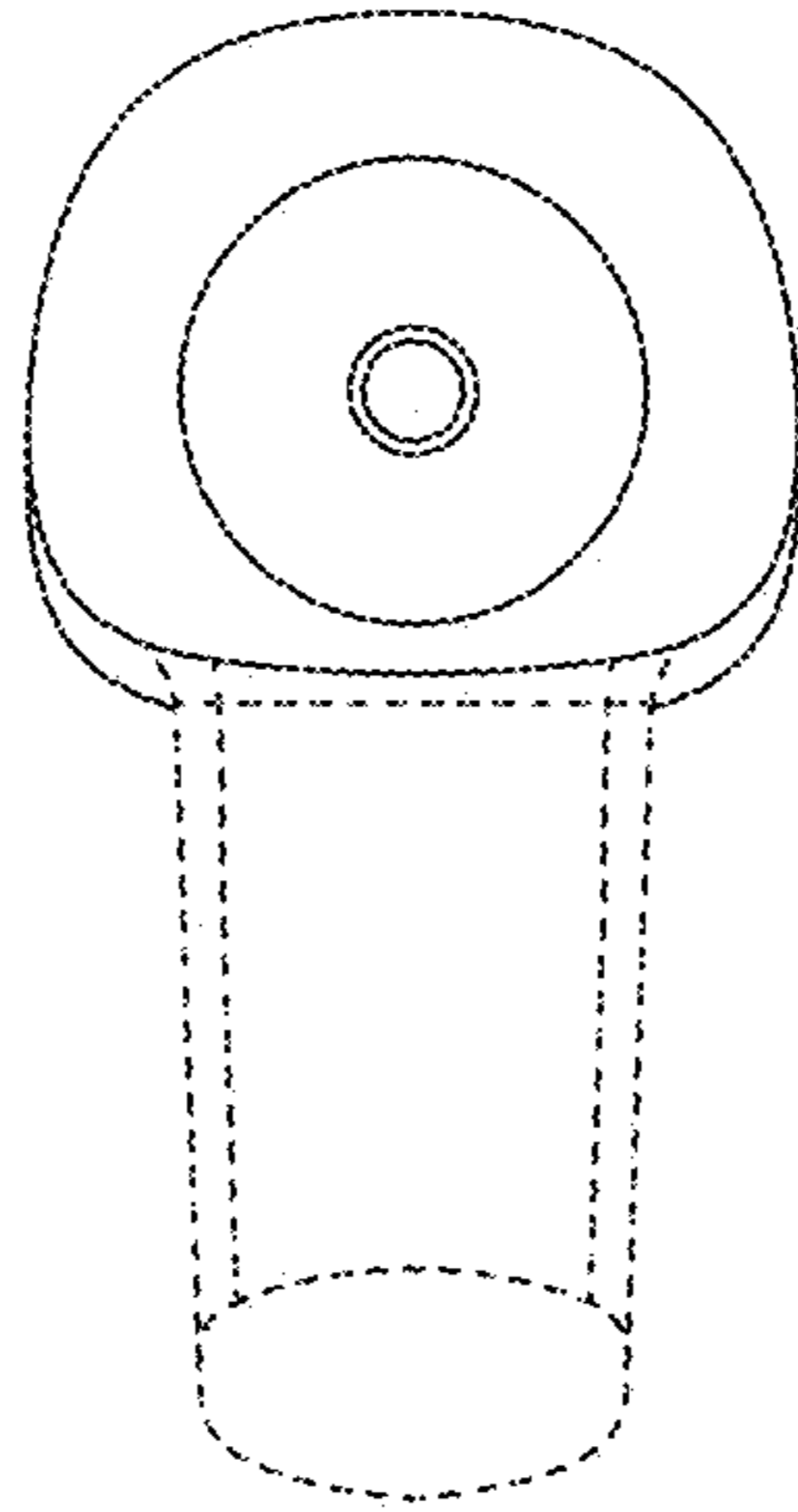

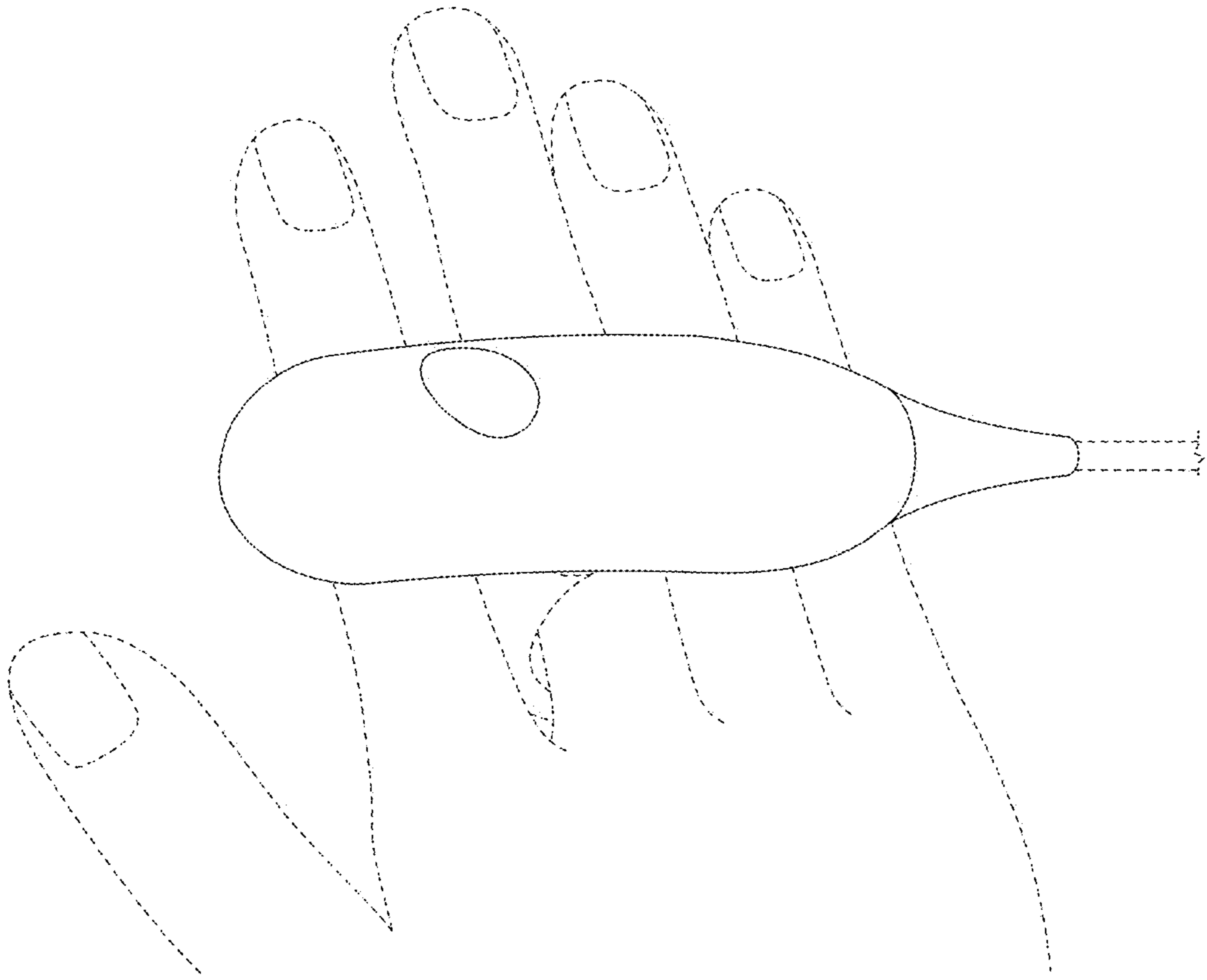
