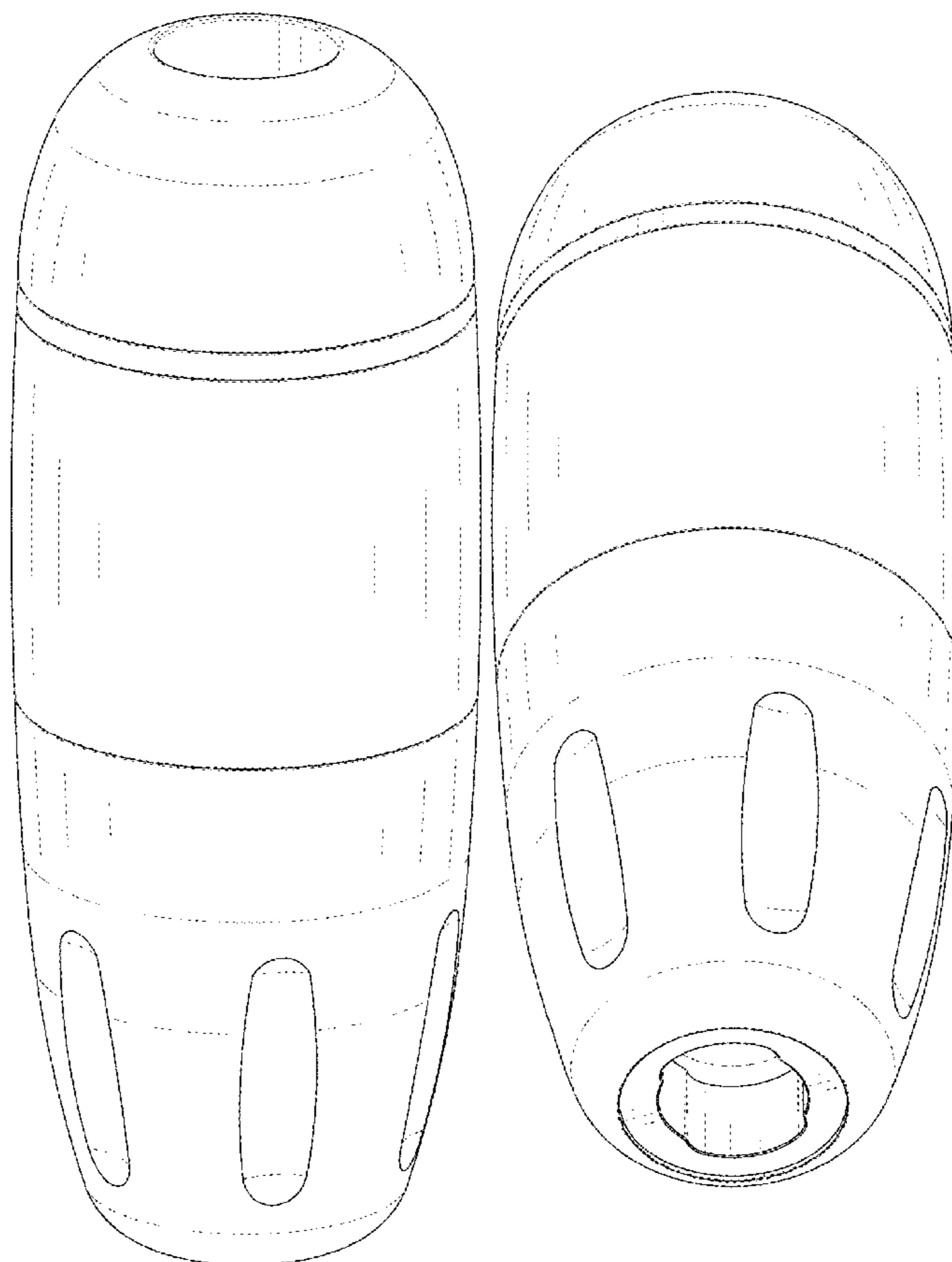

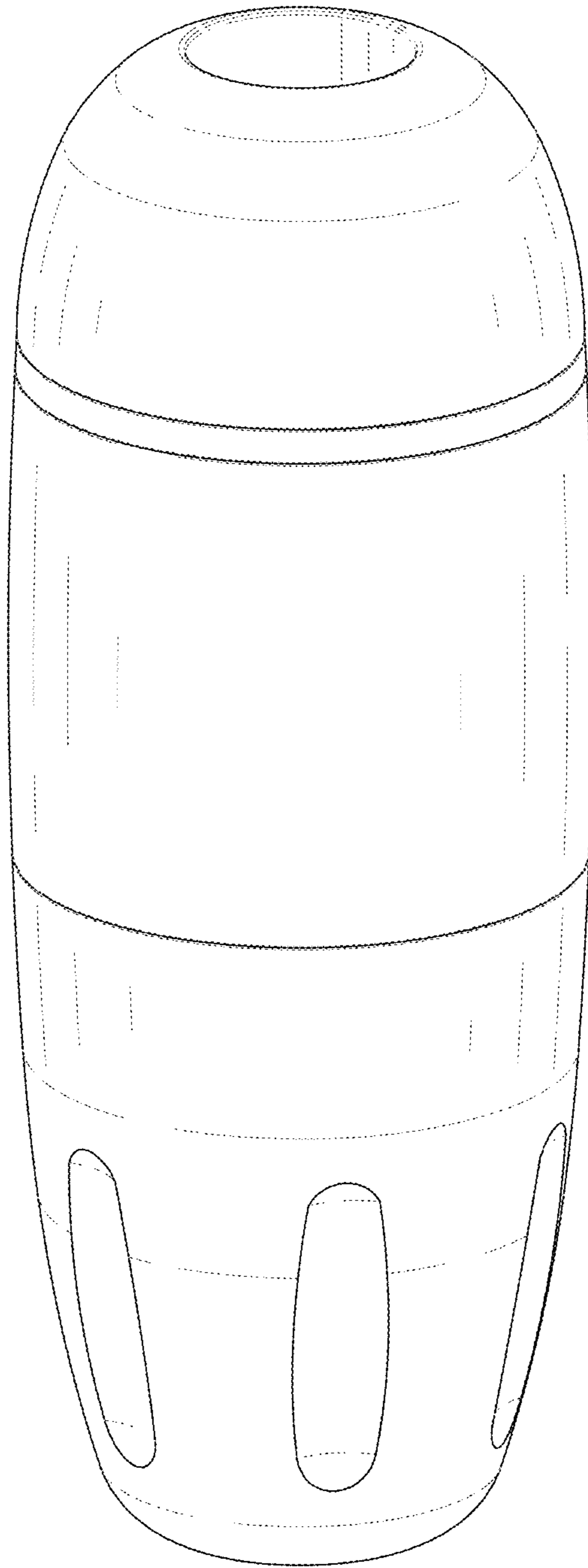
The ornamental design for a tattoo machine, as shown and described.

**DESCRIPTION**

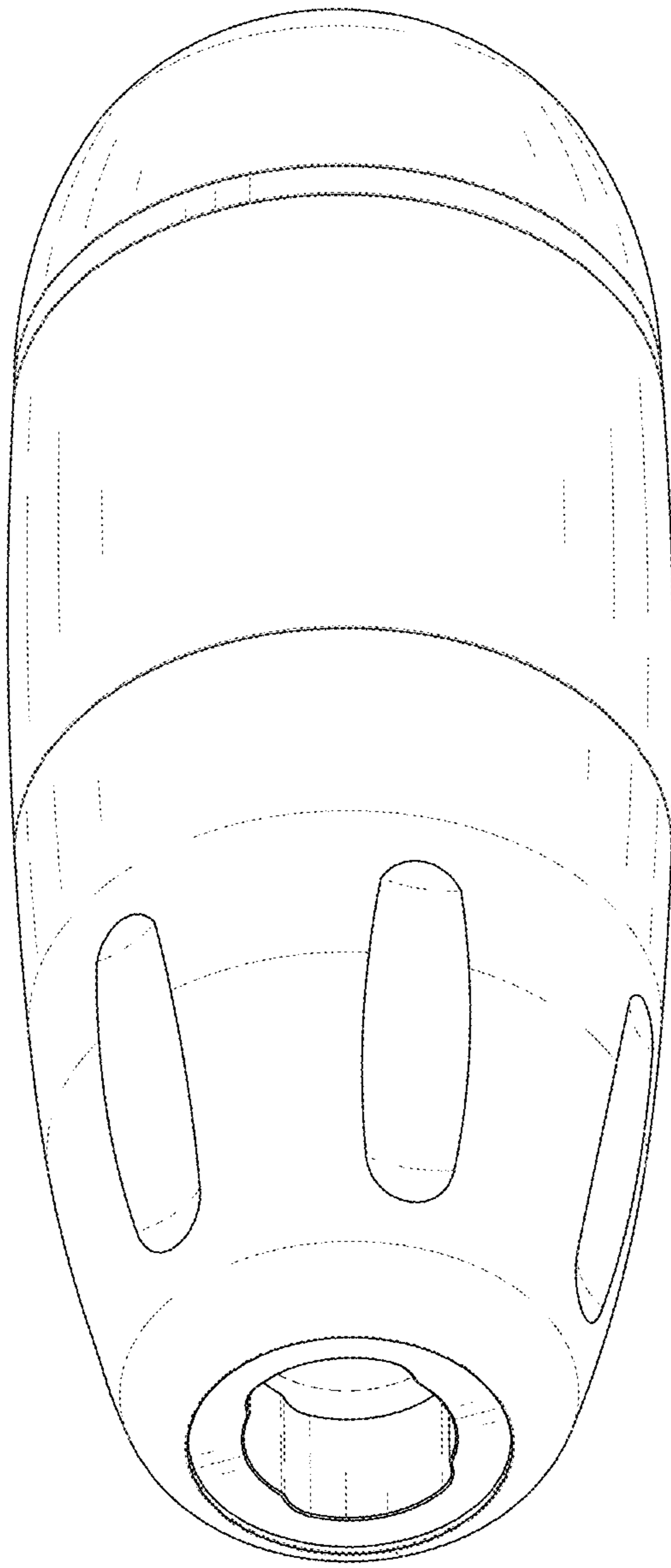
FIG. 1 is a perspective view of a tattoo machine showing my new design;

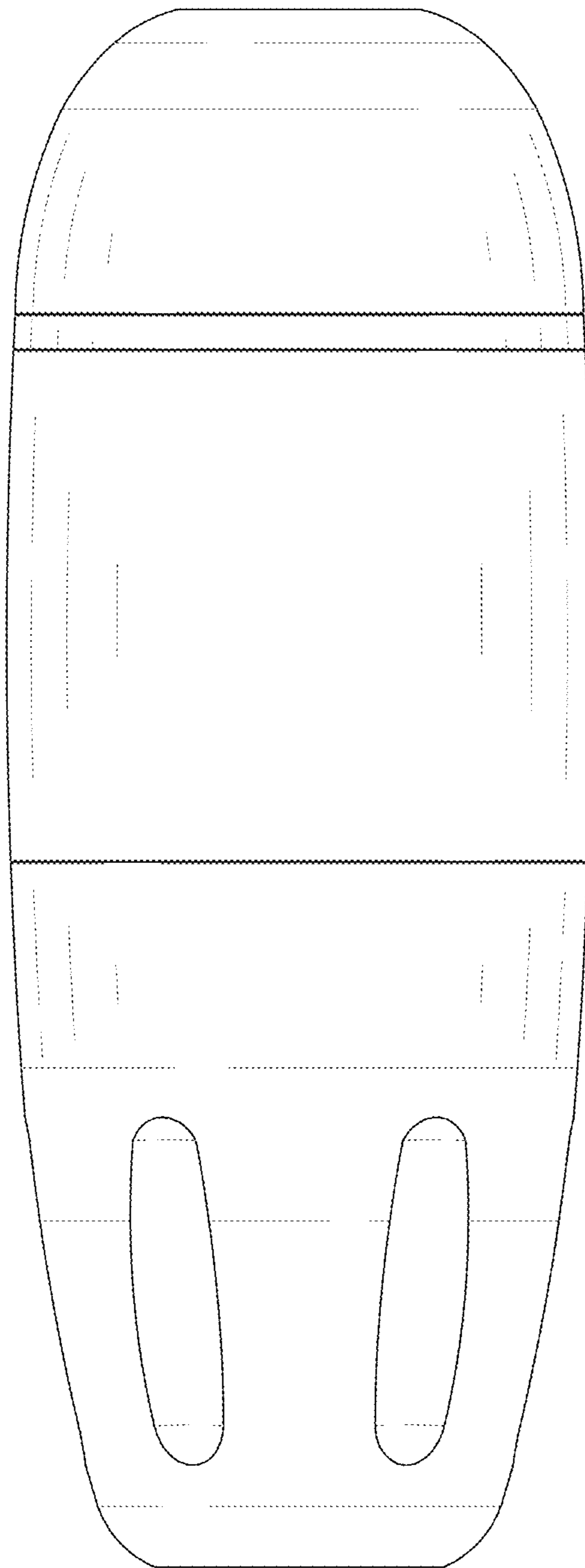




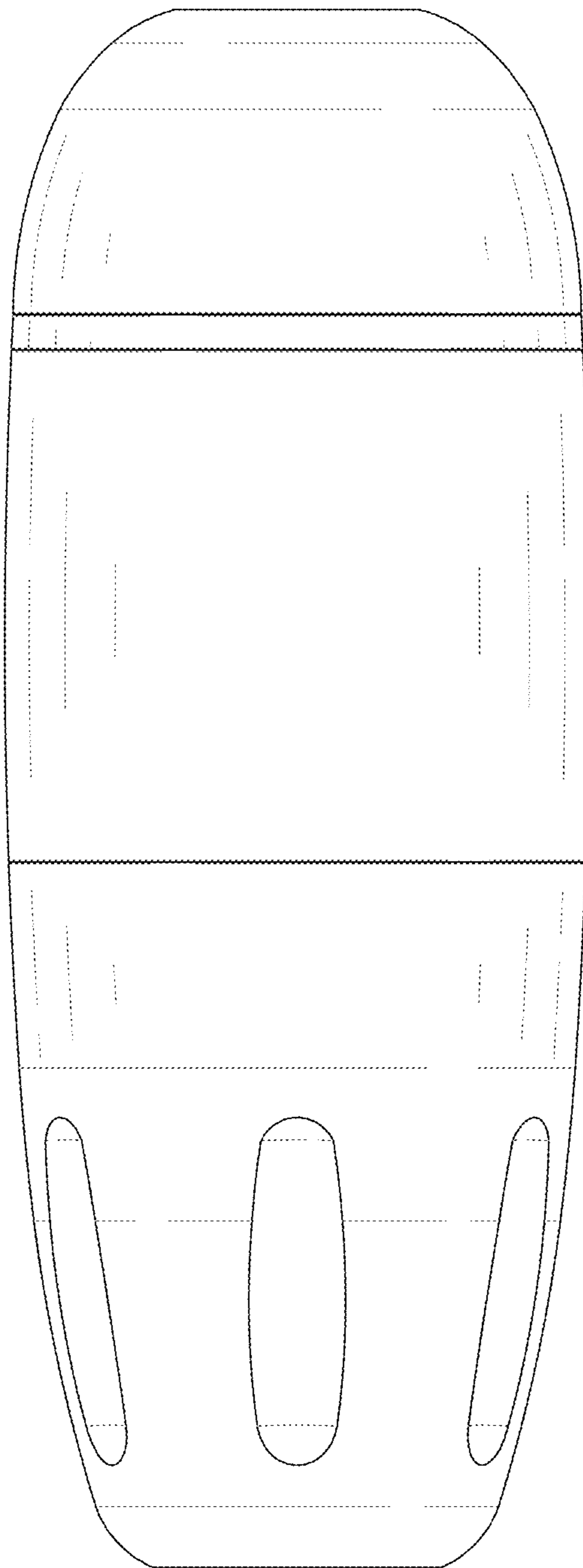

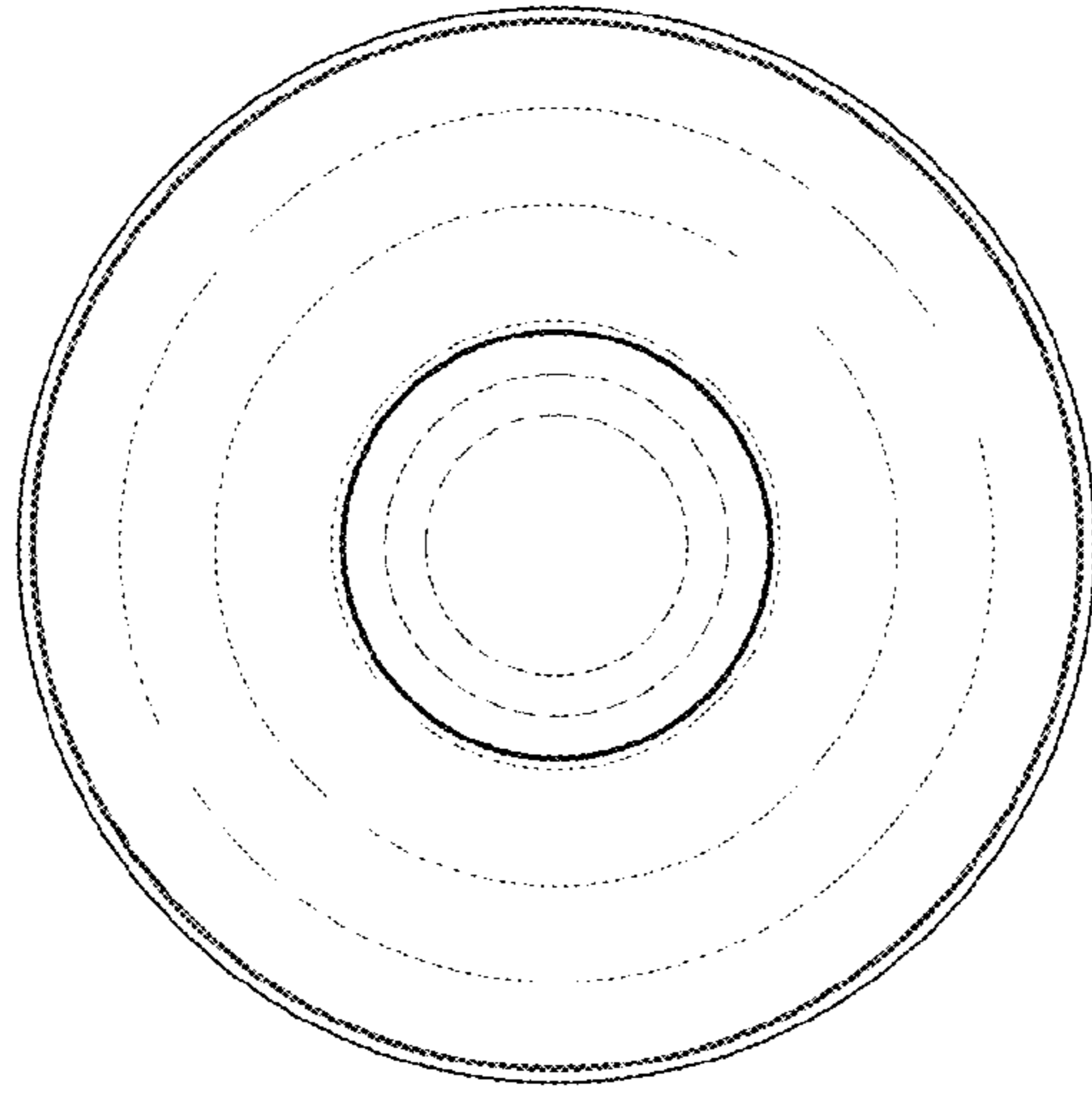

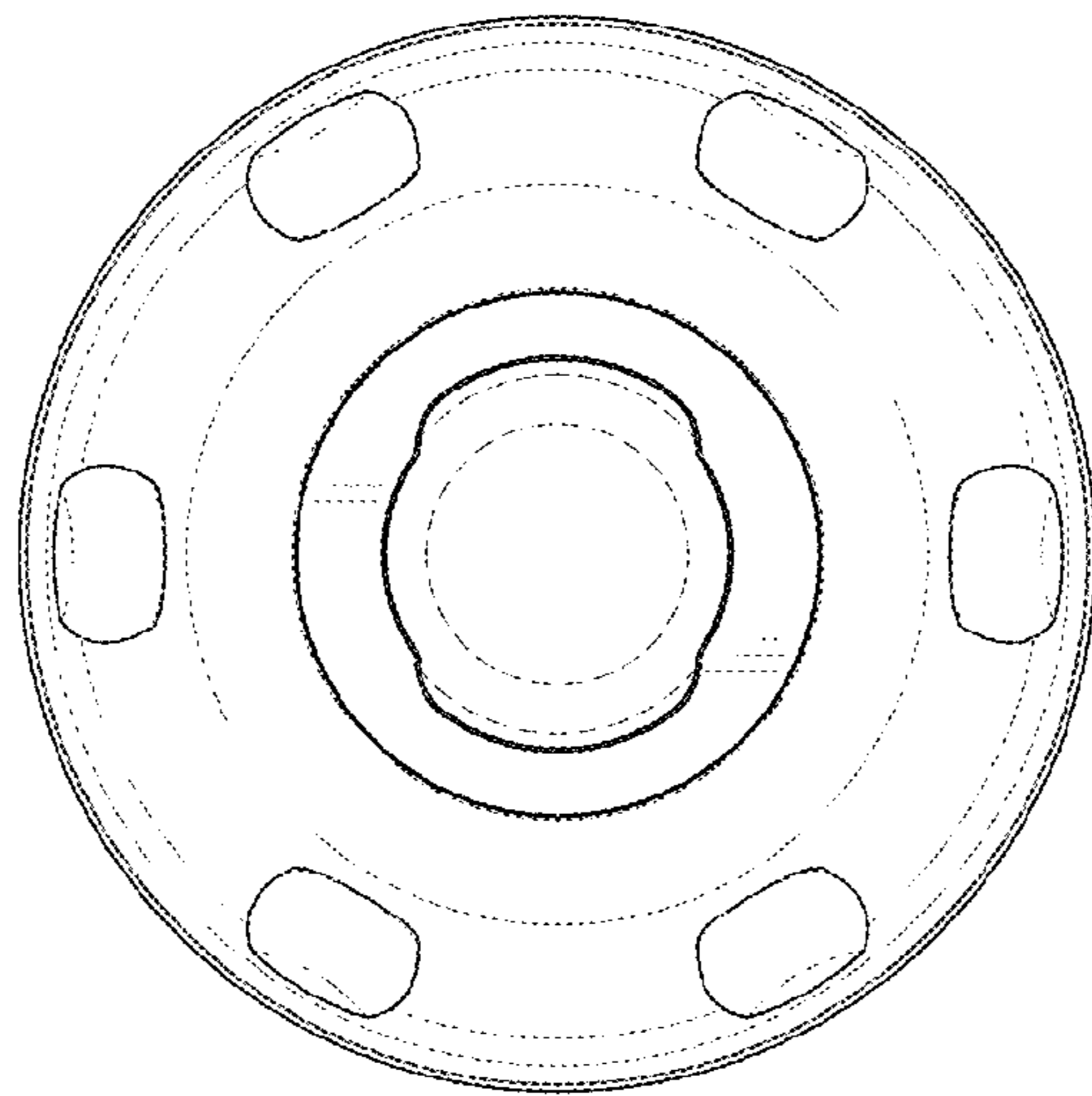
