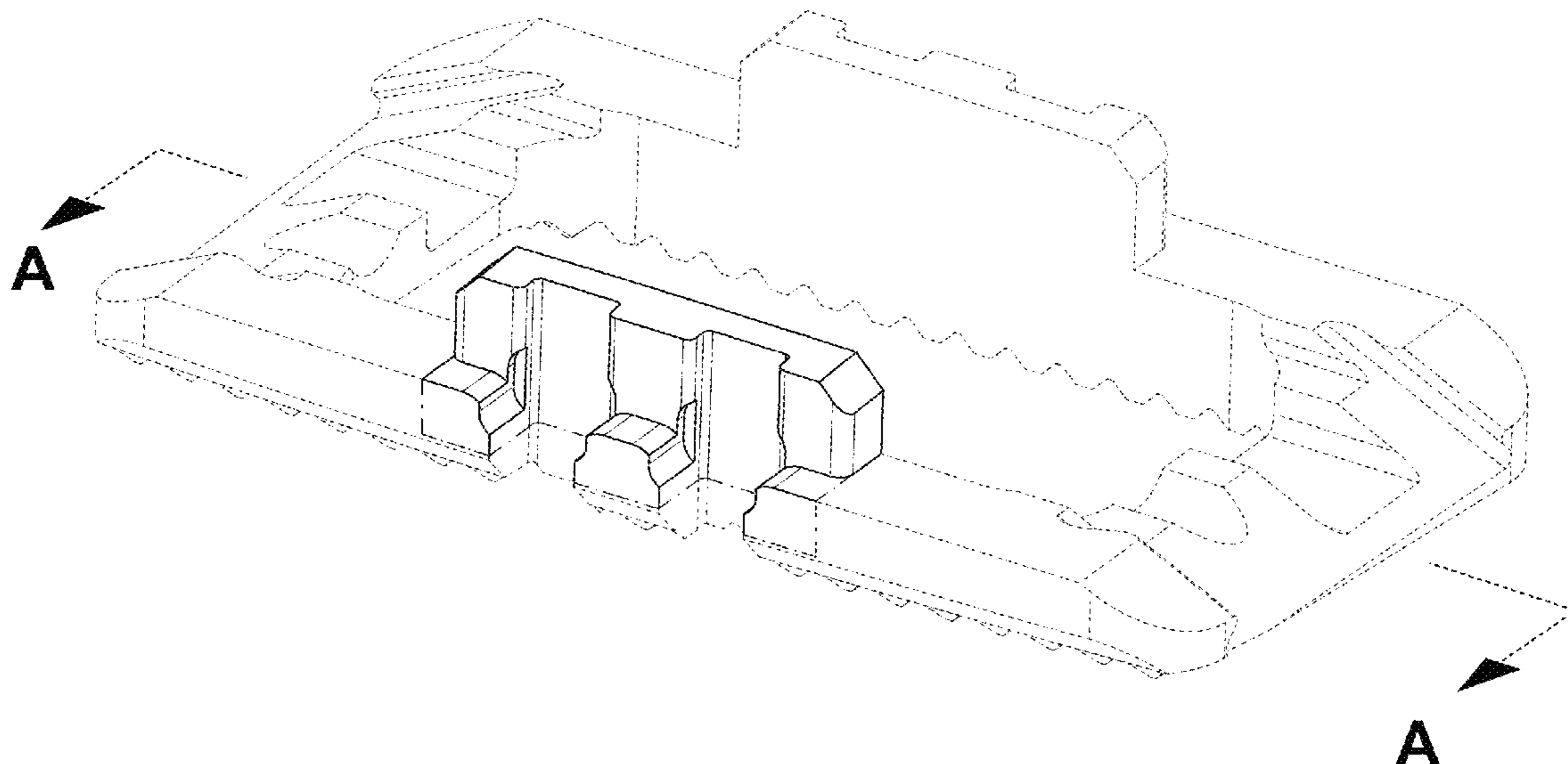

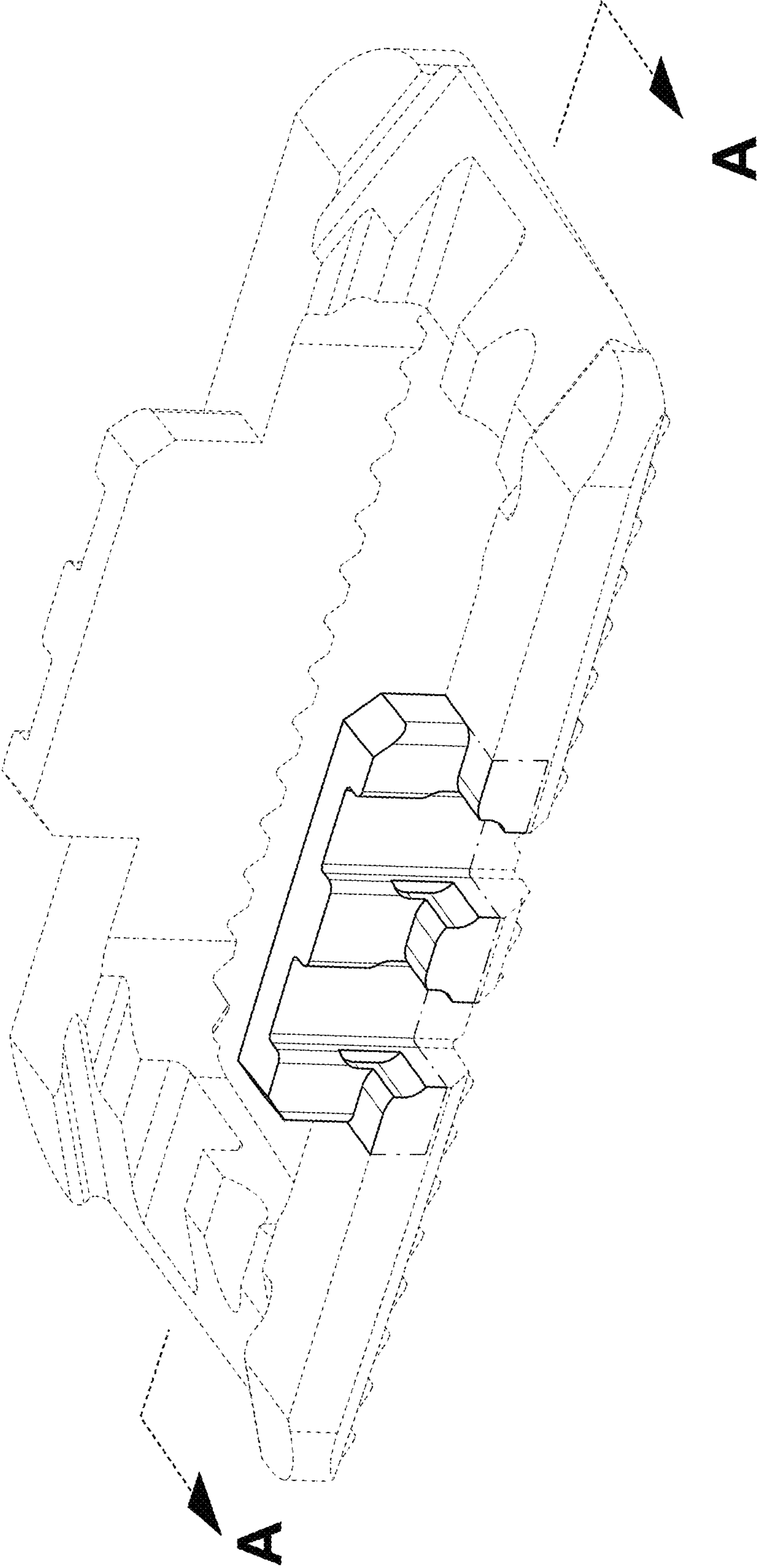
The ornamental design for an end plate for spinal fusion cage, as shown and described.

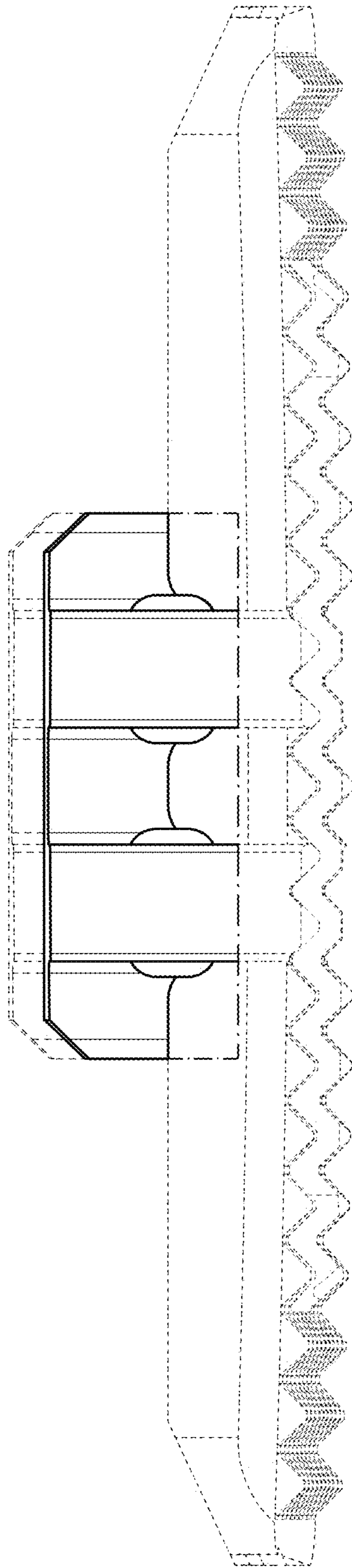

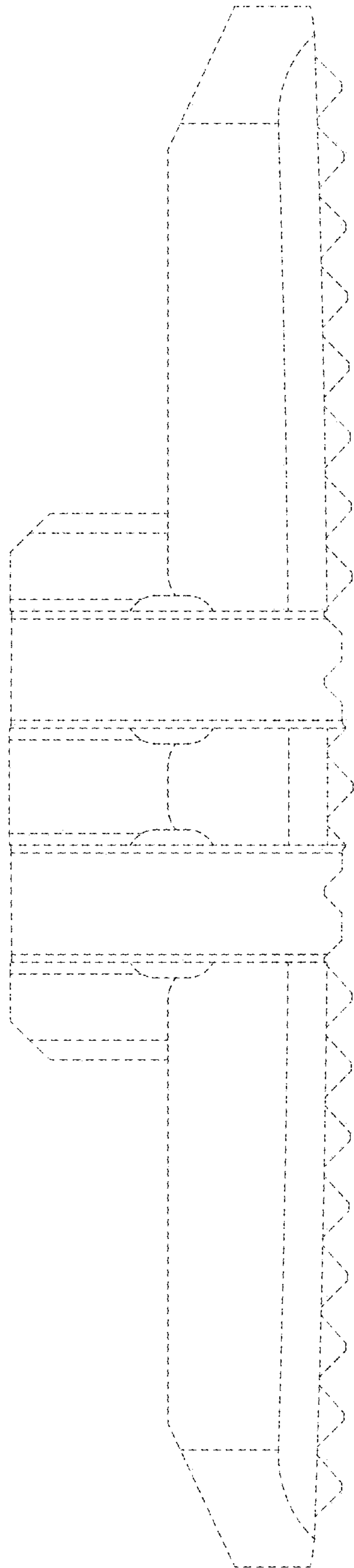




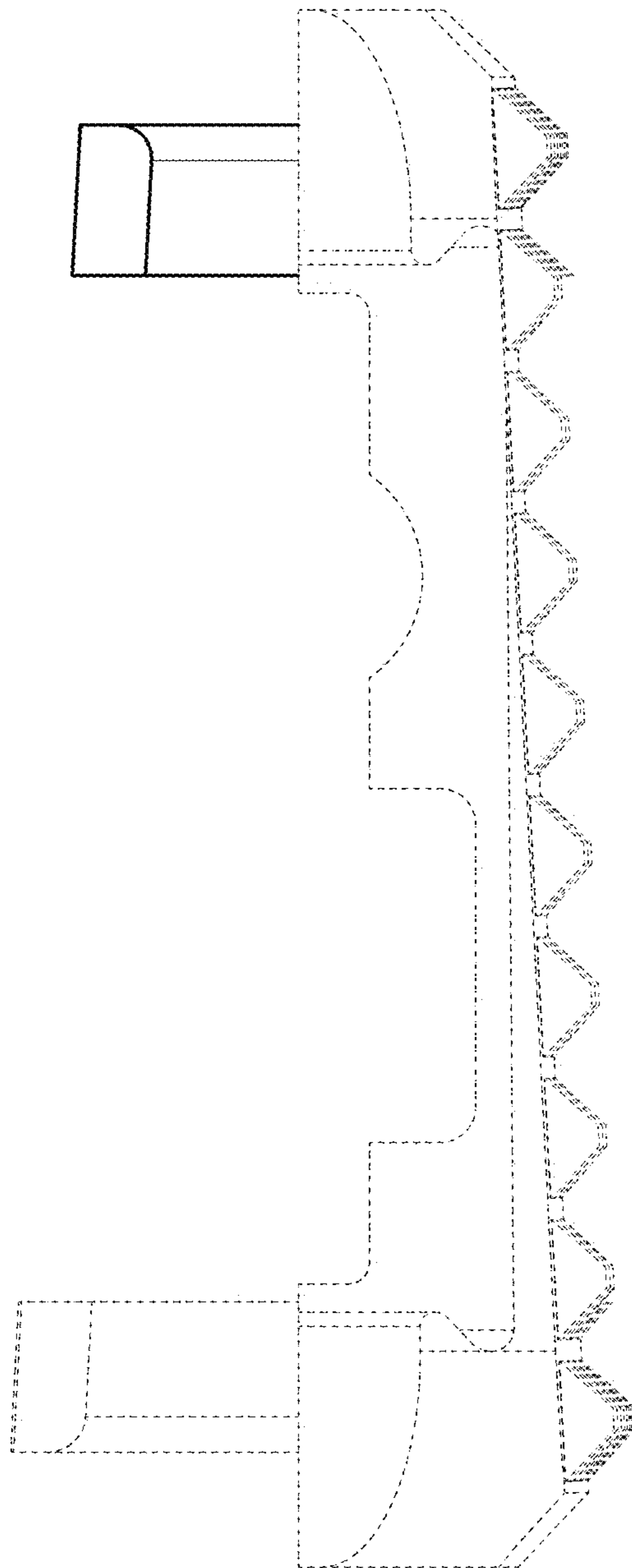

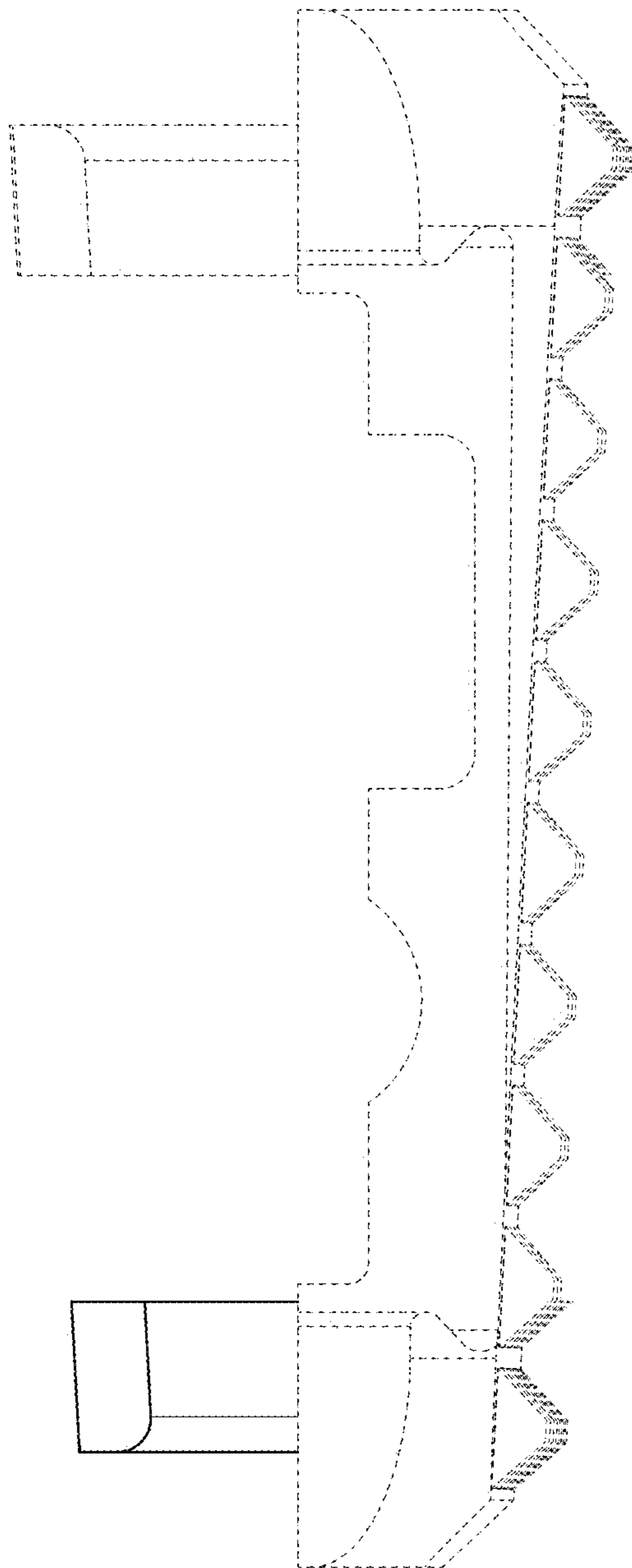

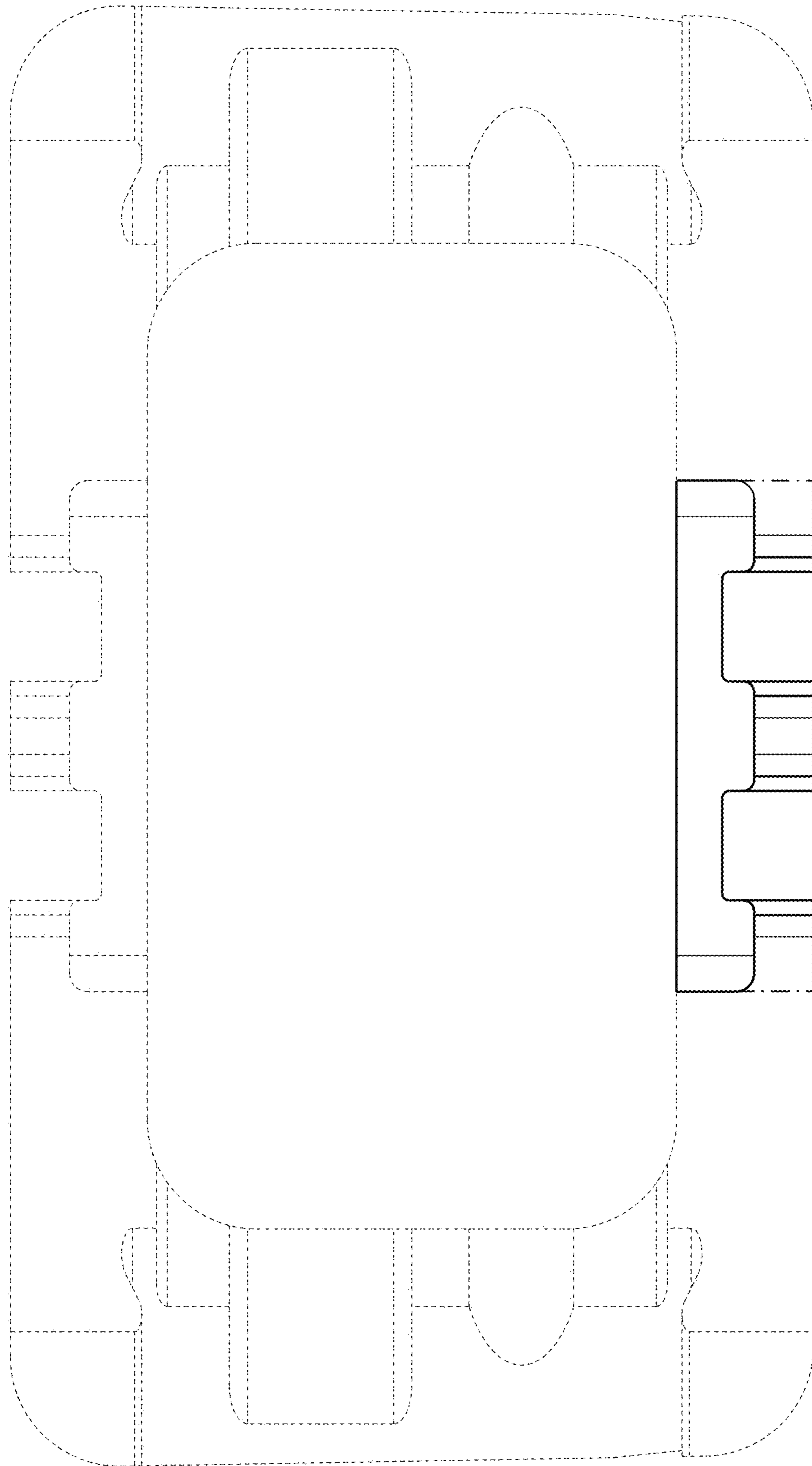

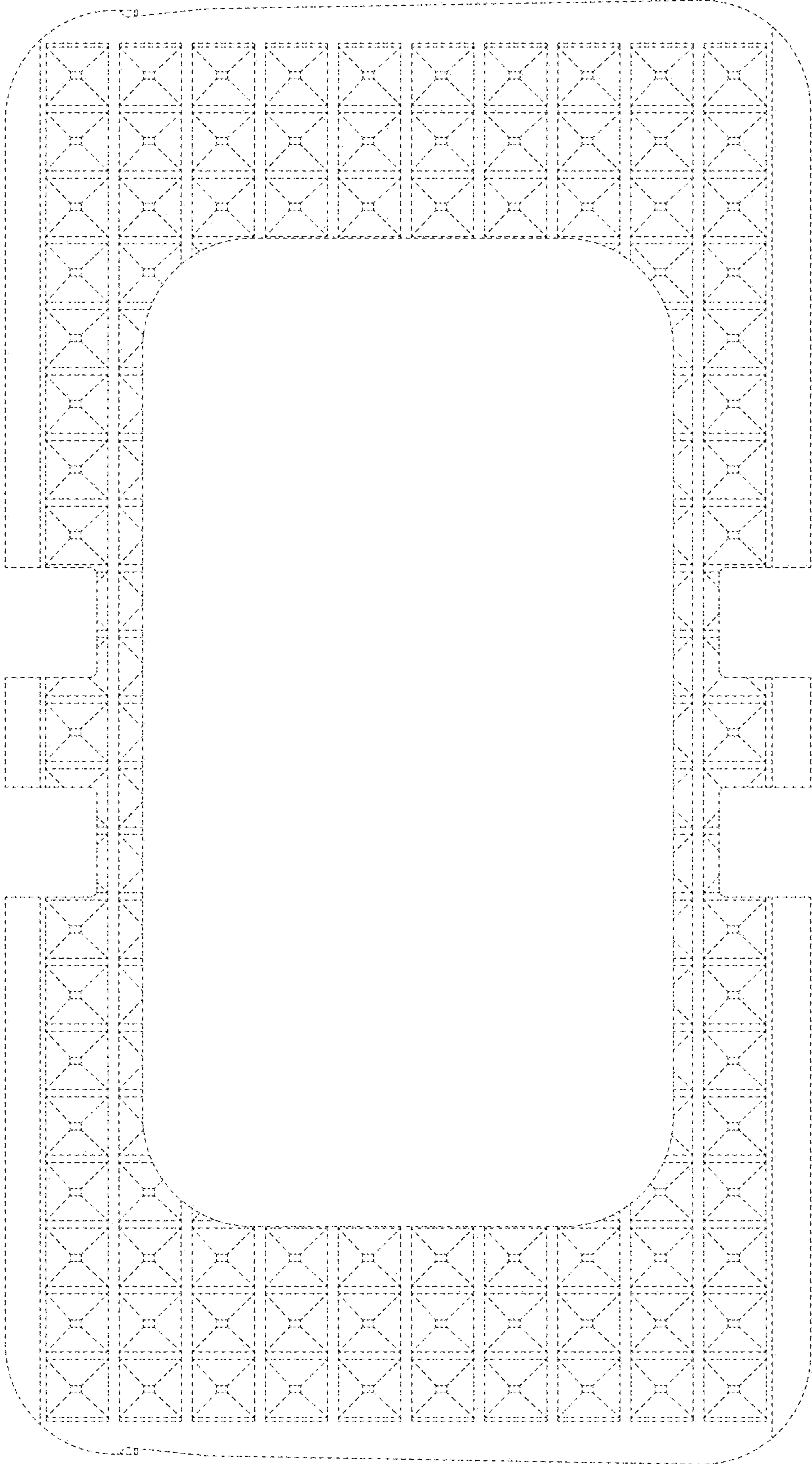

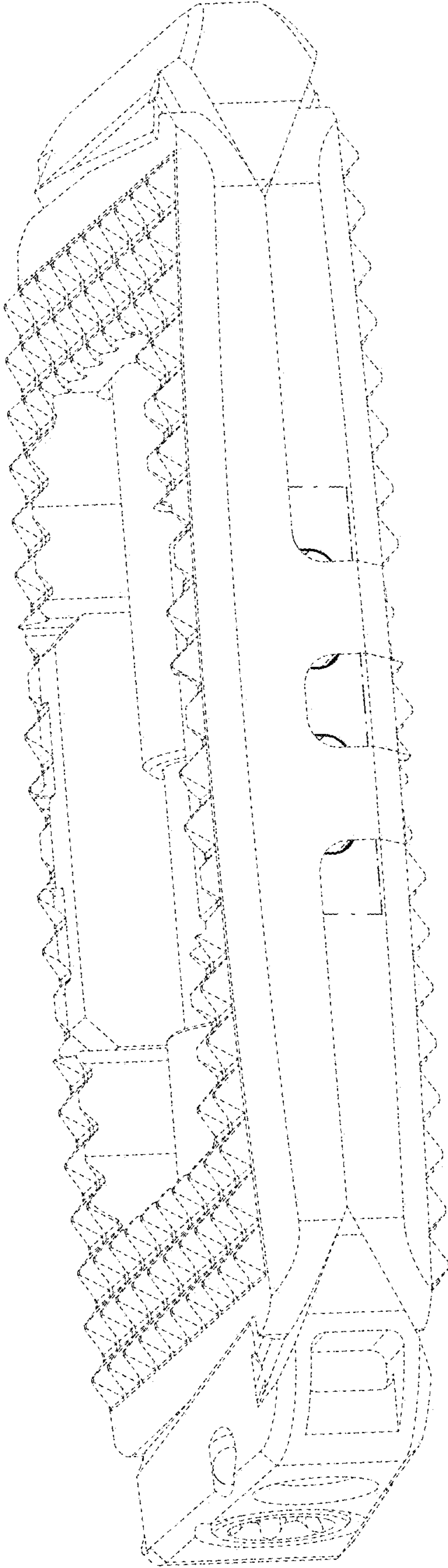

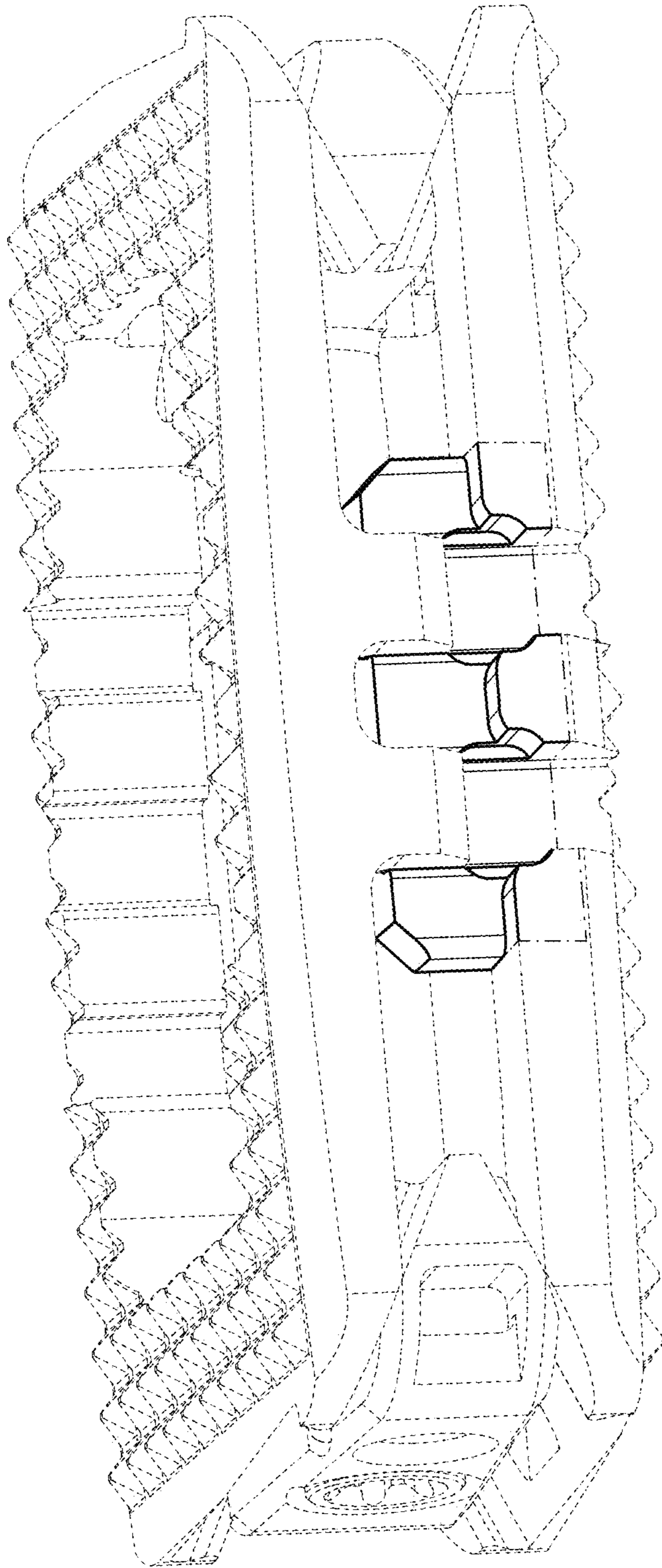

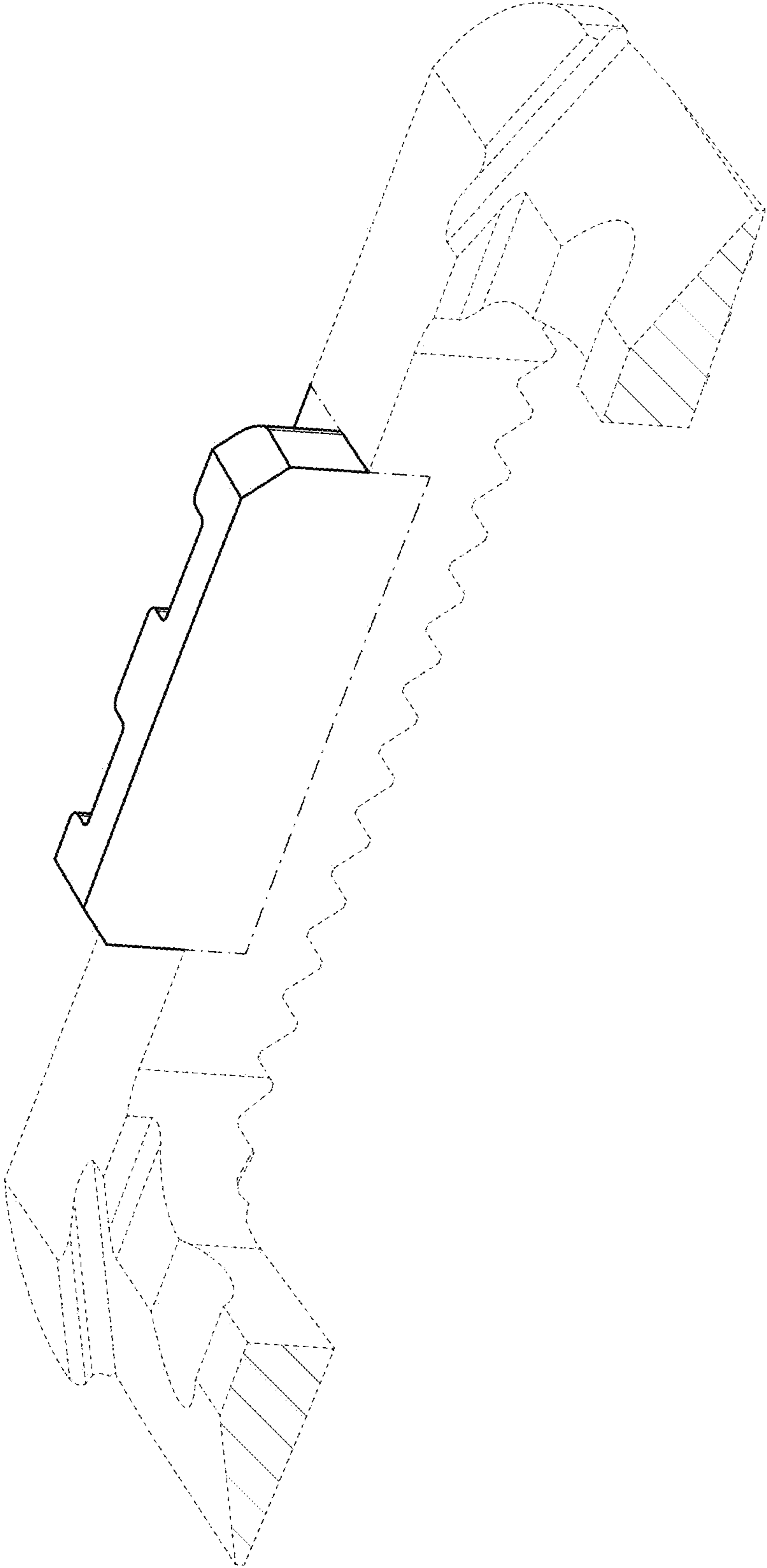
