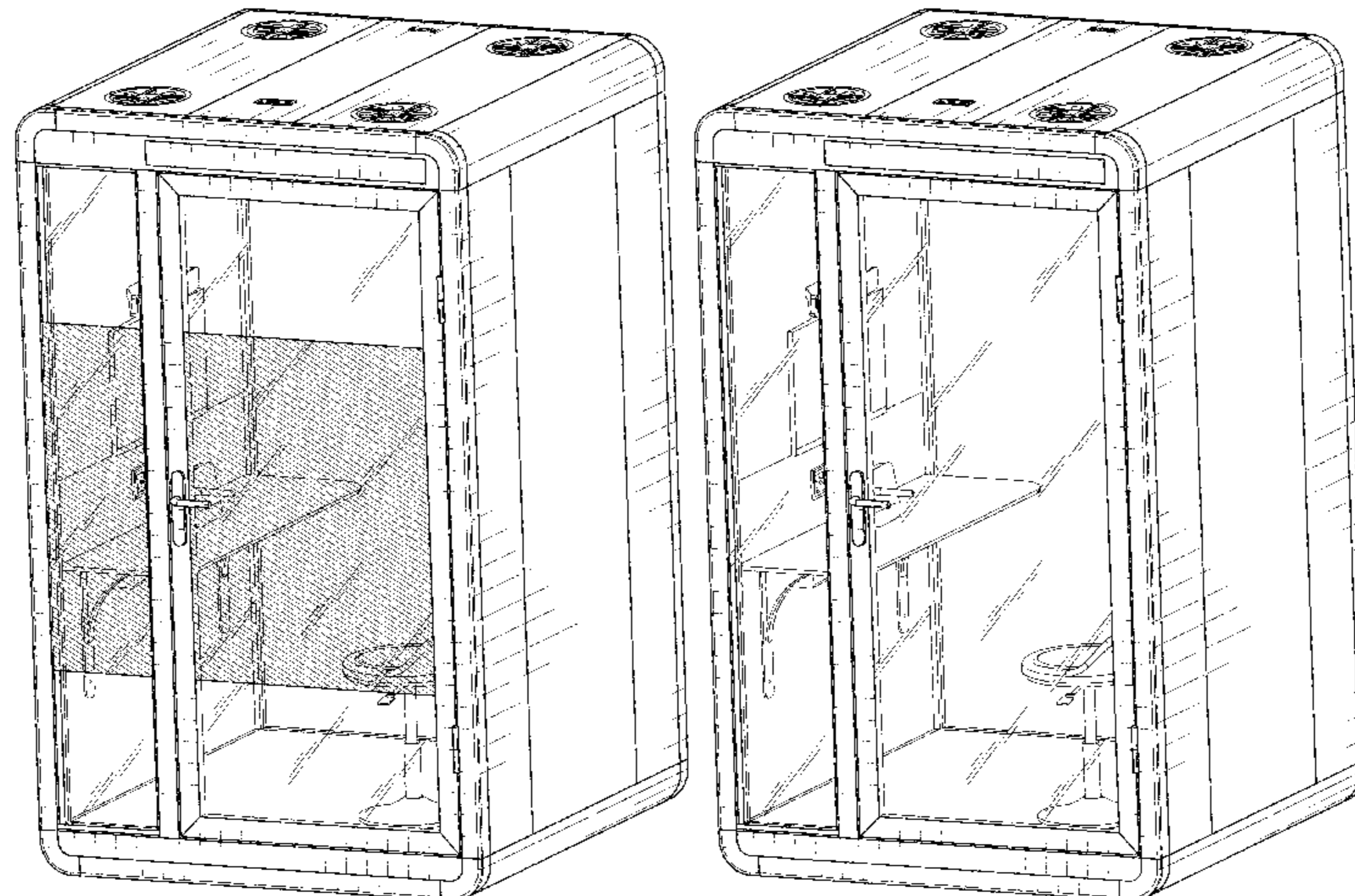

(57) **CLAIM**

The ornamental design of a mobile conference room, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a first embodiment of a mobile conference room according to some embodiments of the disclosure.

FIG. 2 is a rear elevation view of a first embodiment of a mobile conference room according to some embodiments of the disclosure.

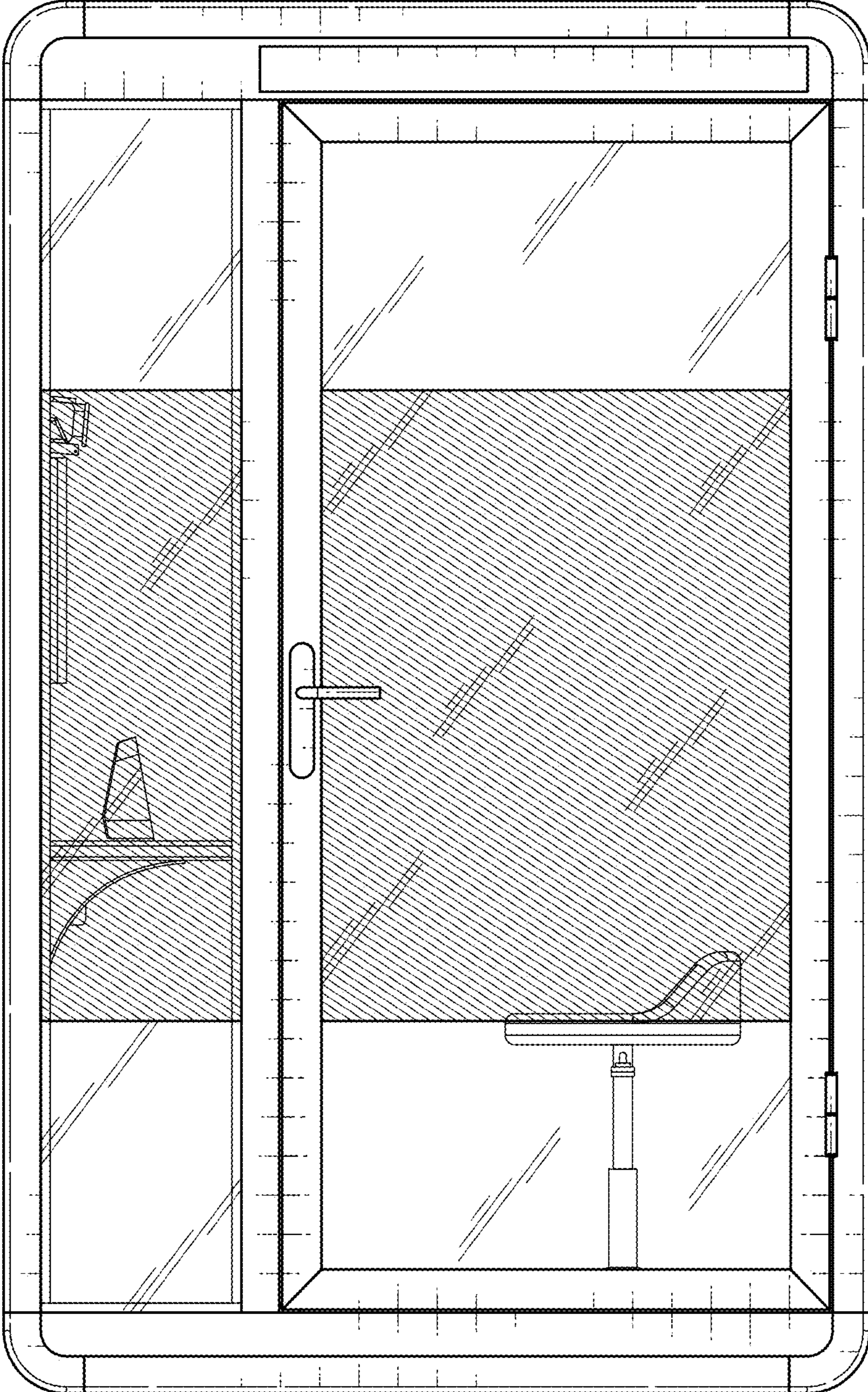

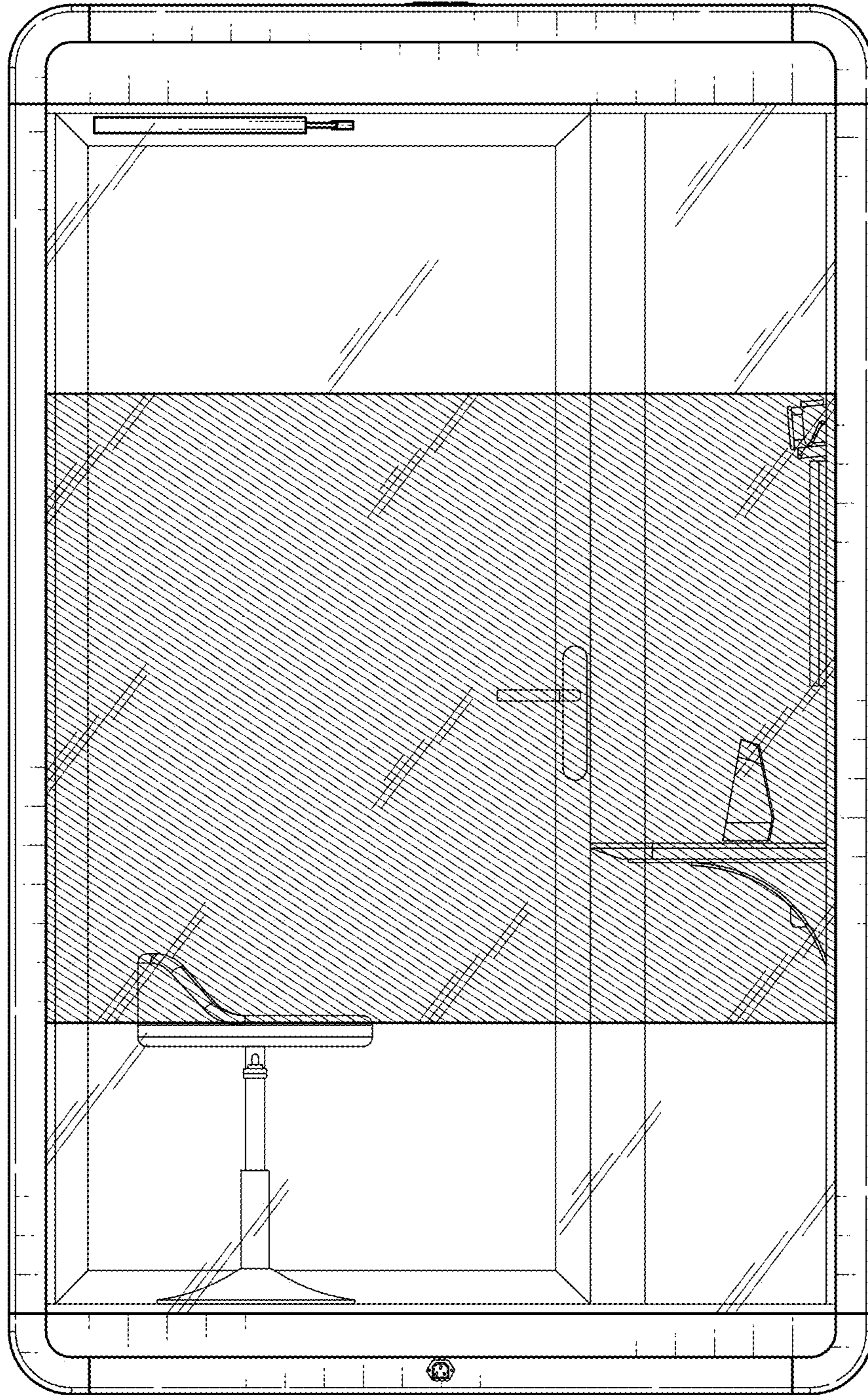

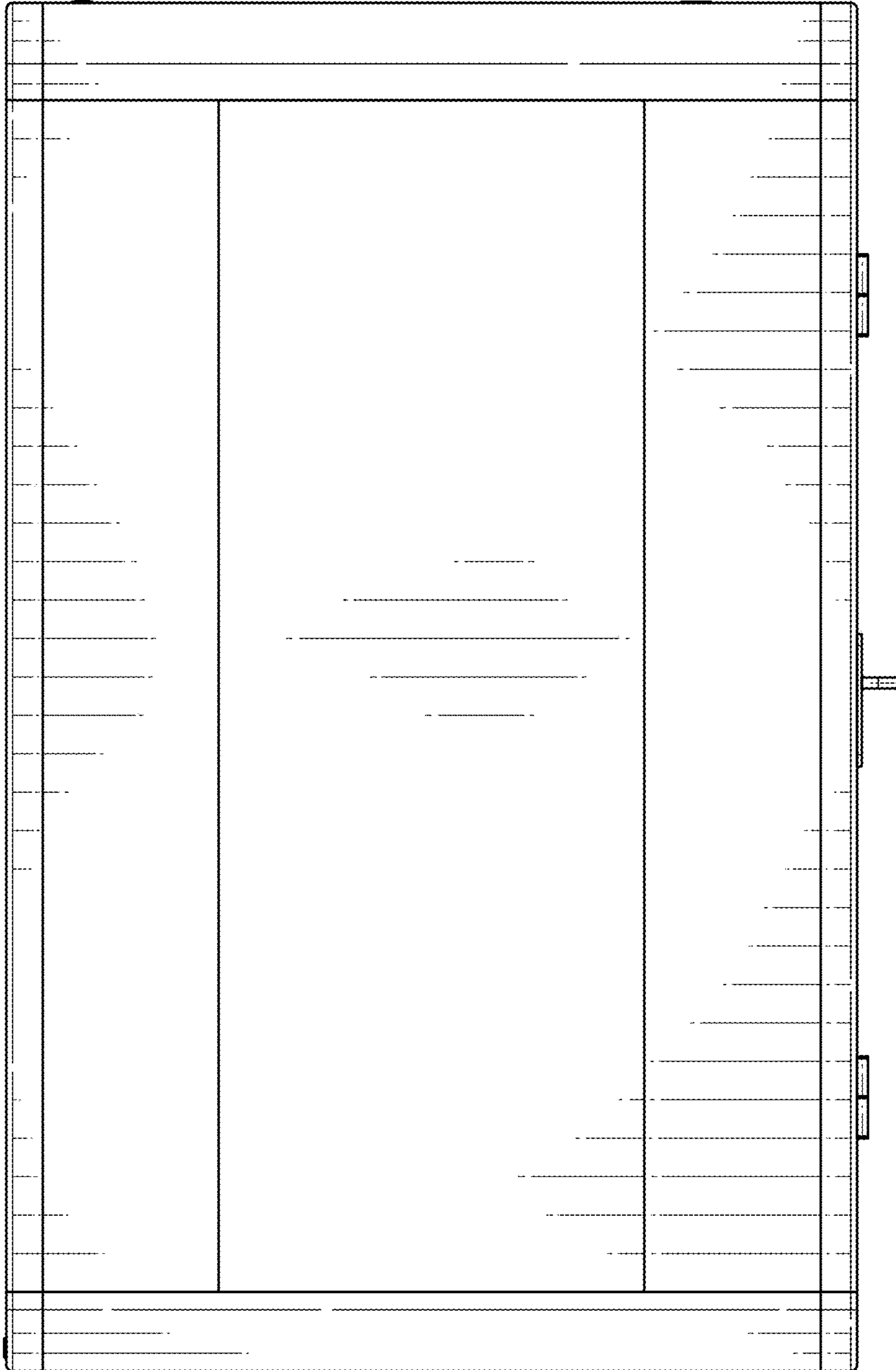

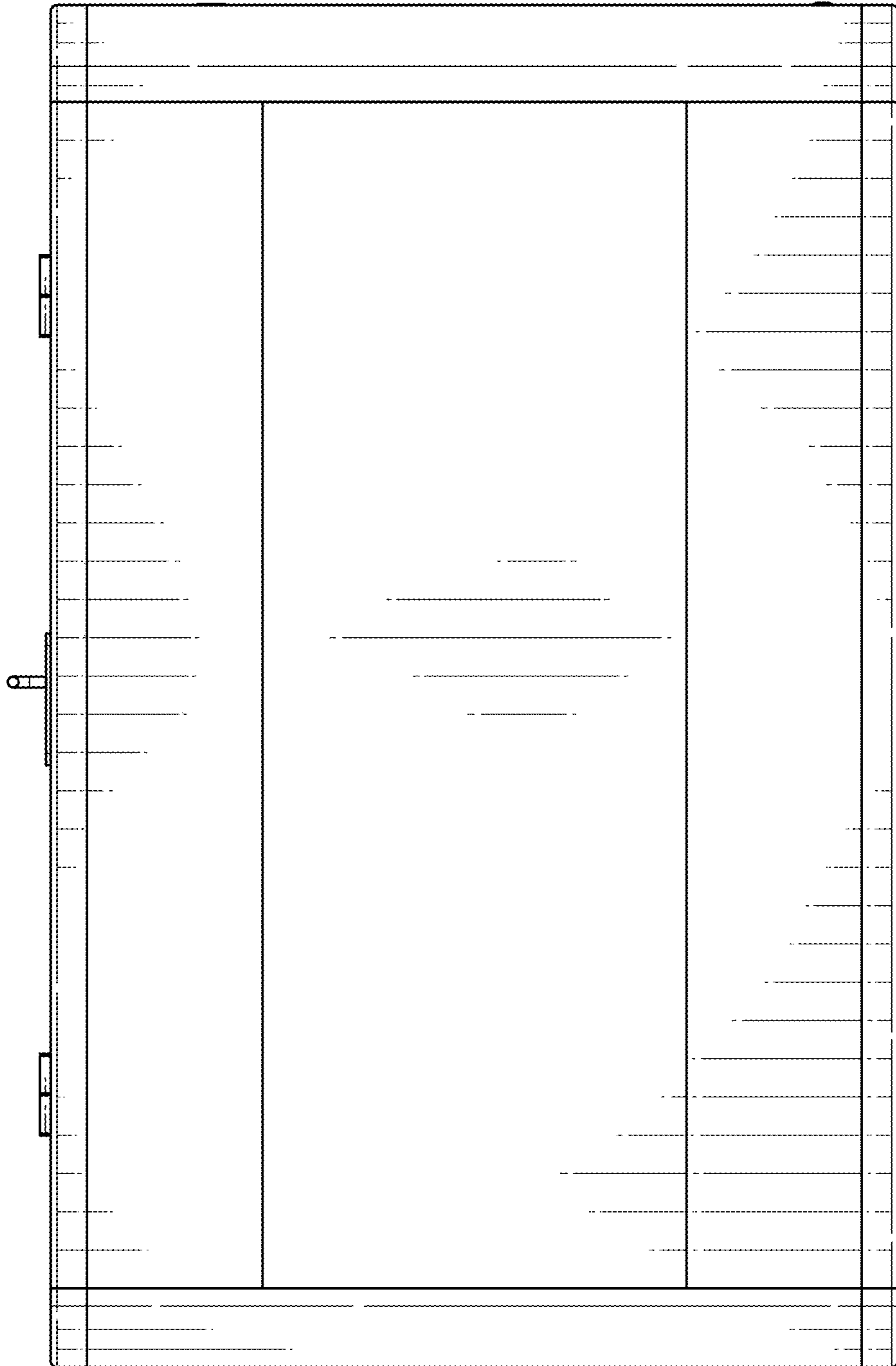

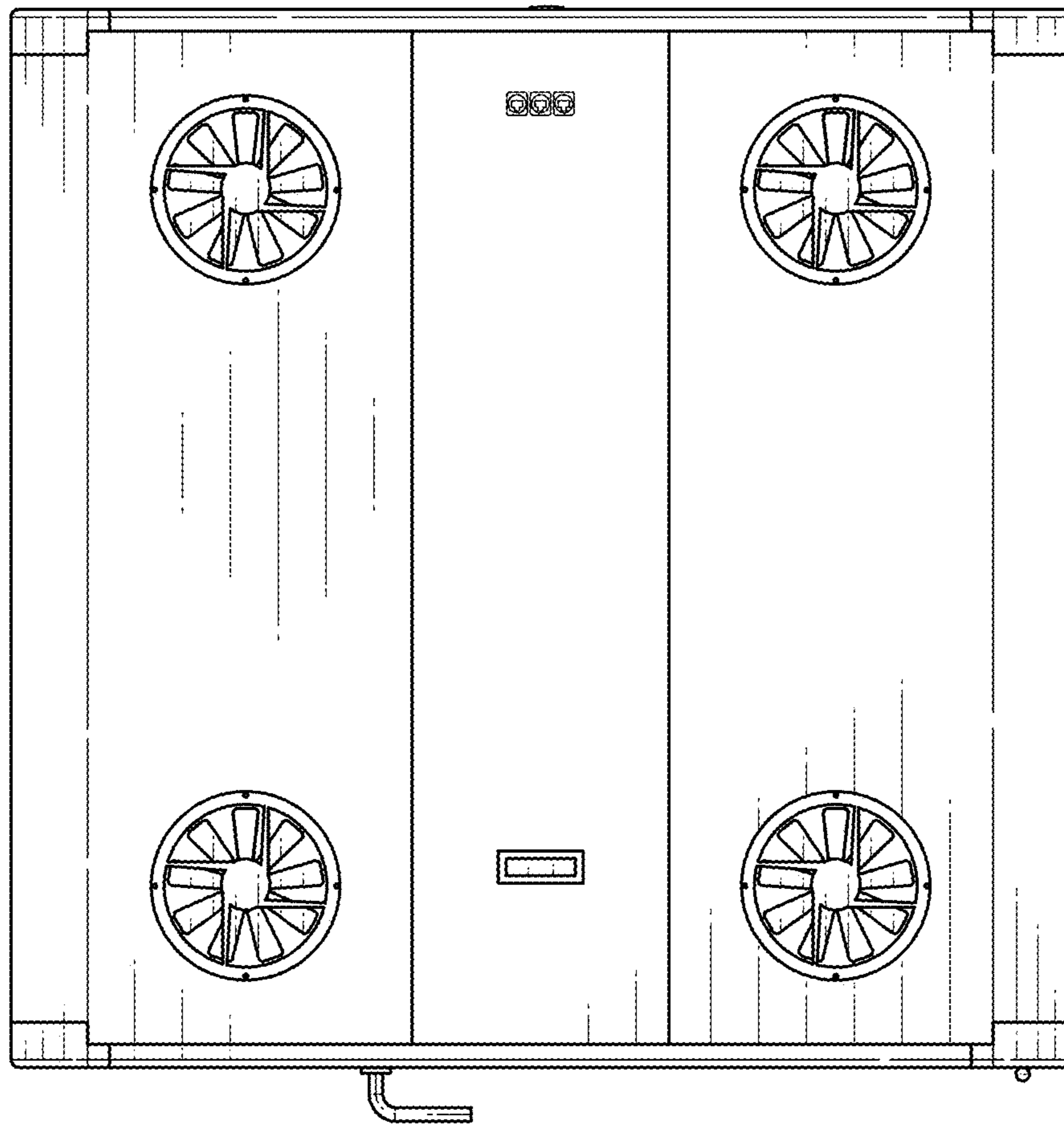

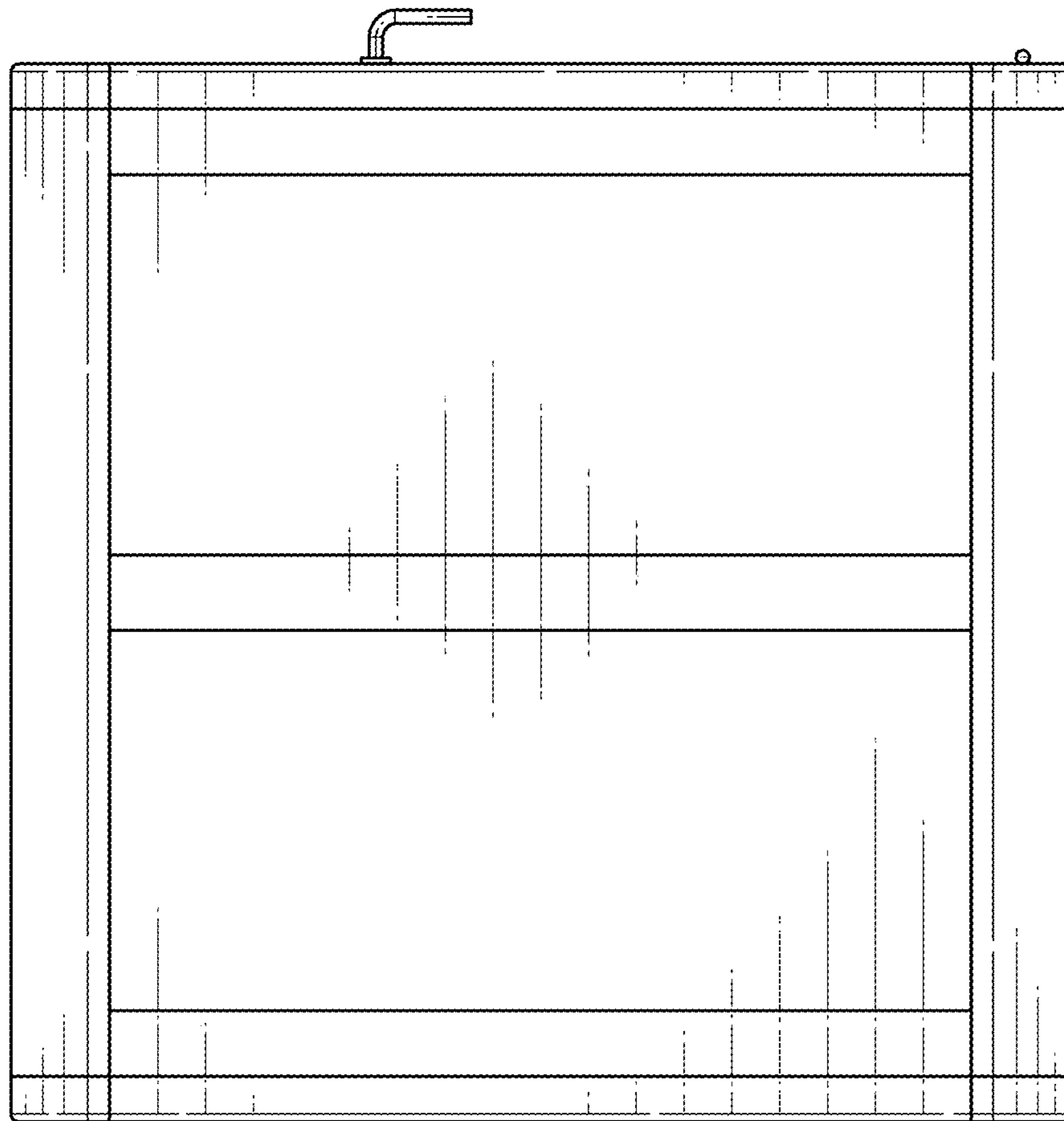

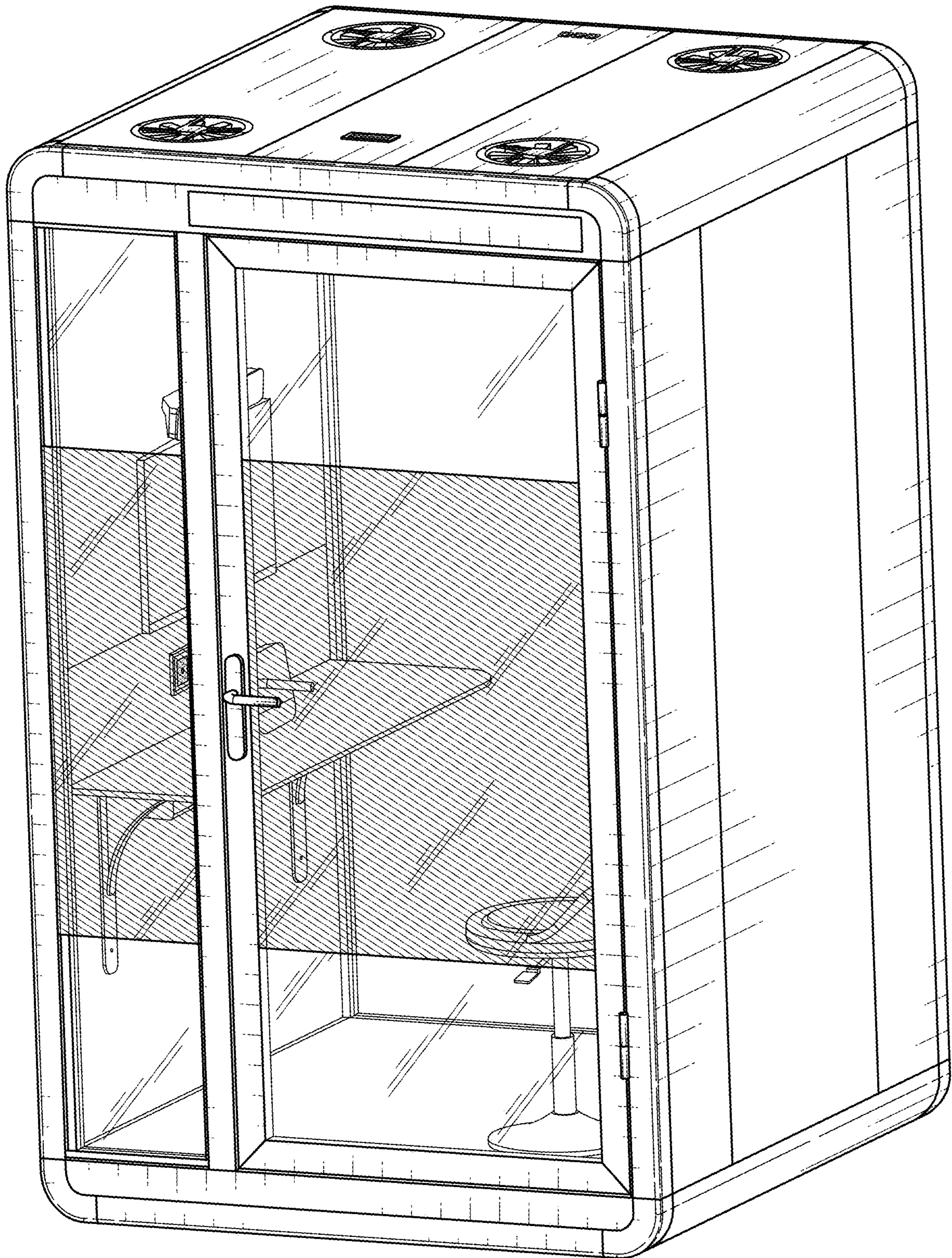

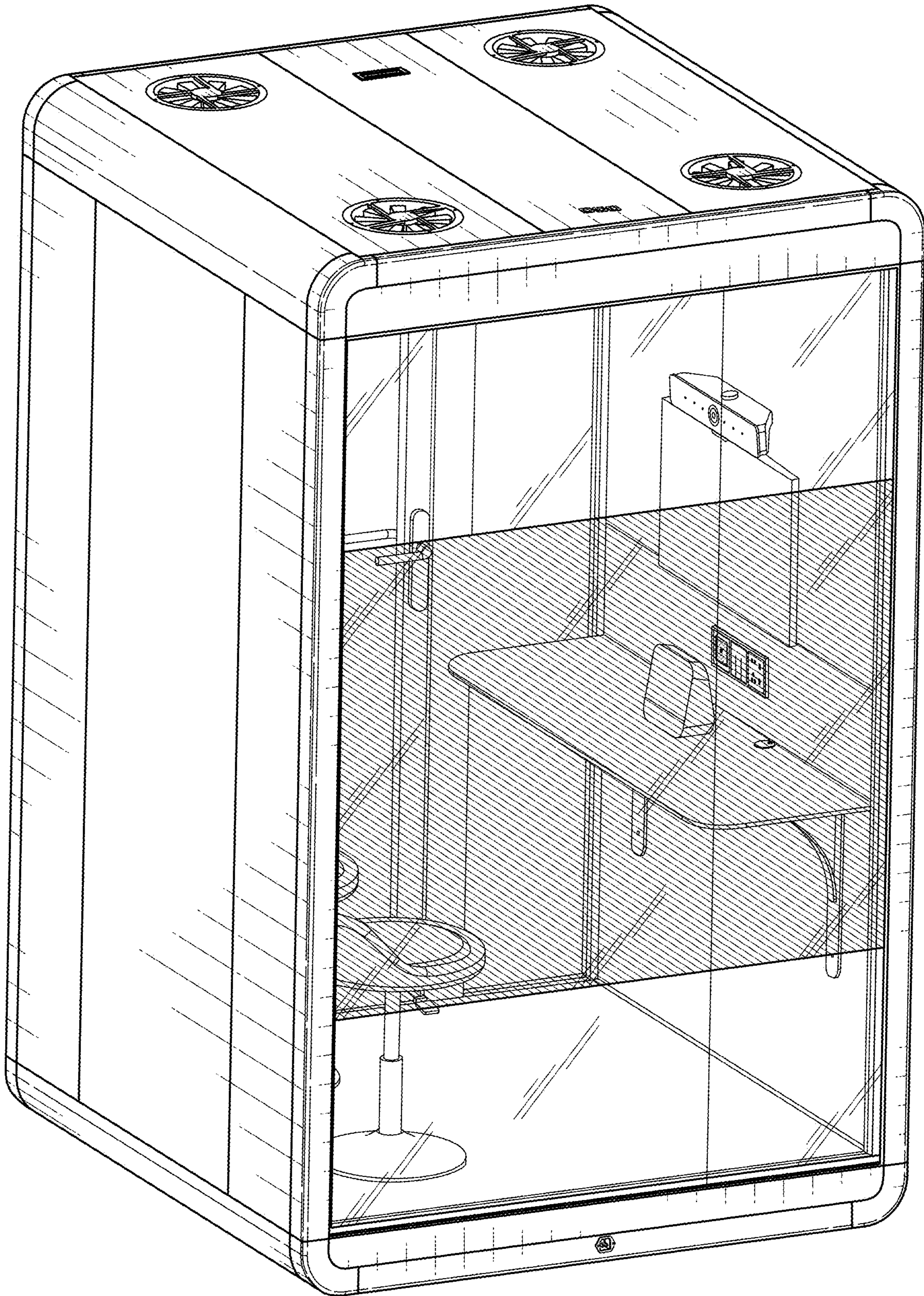

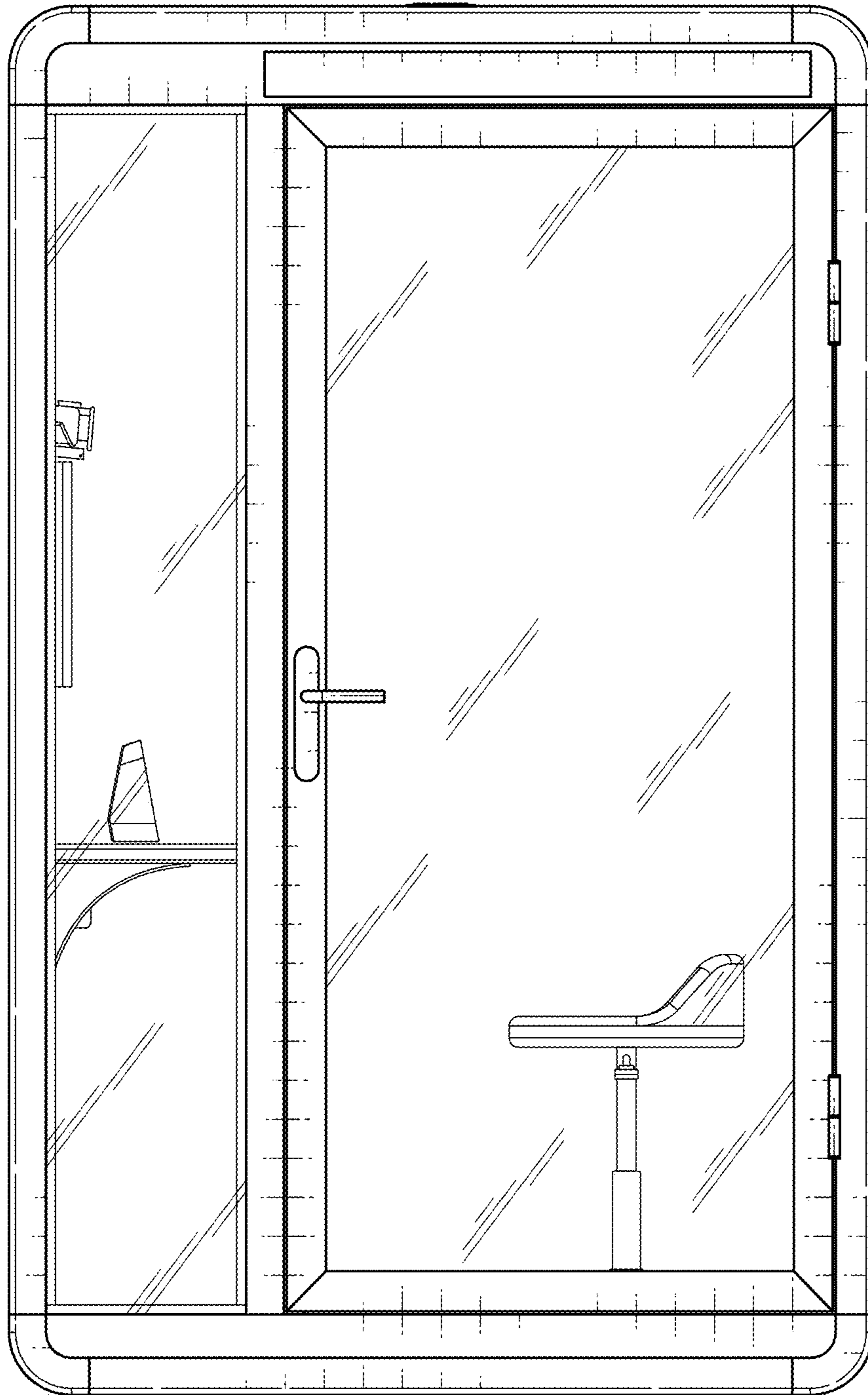

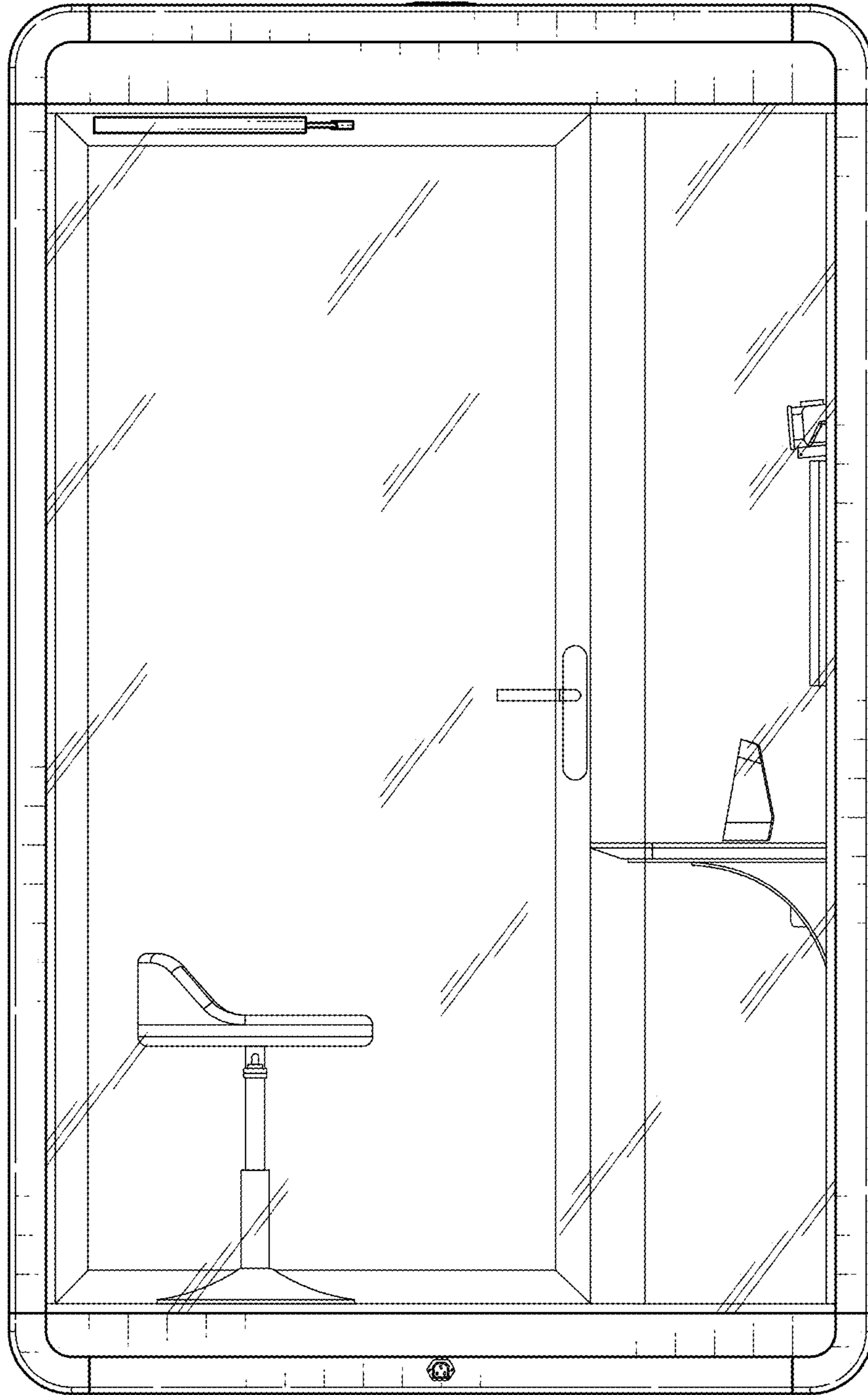

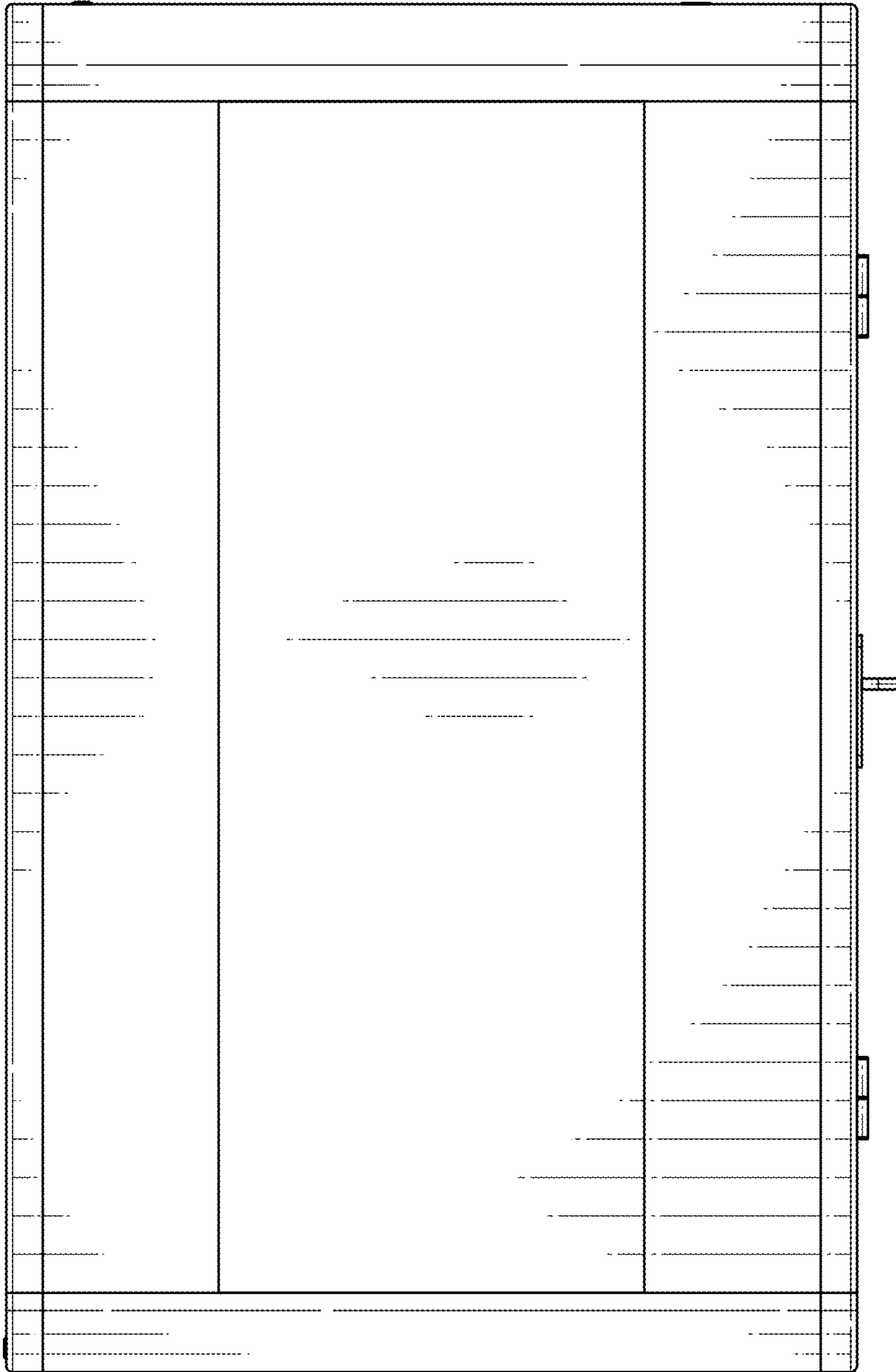

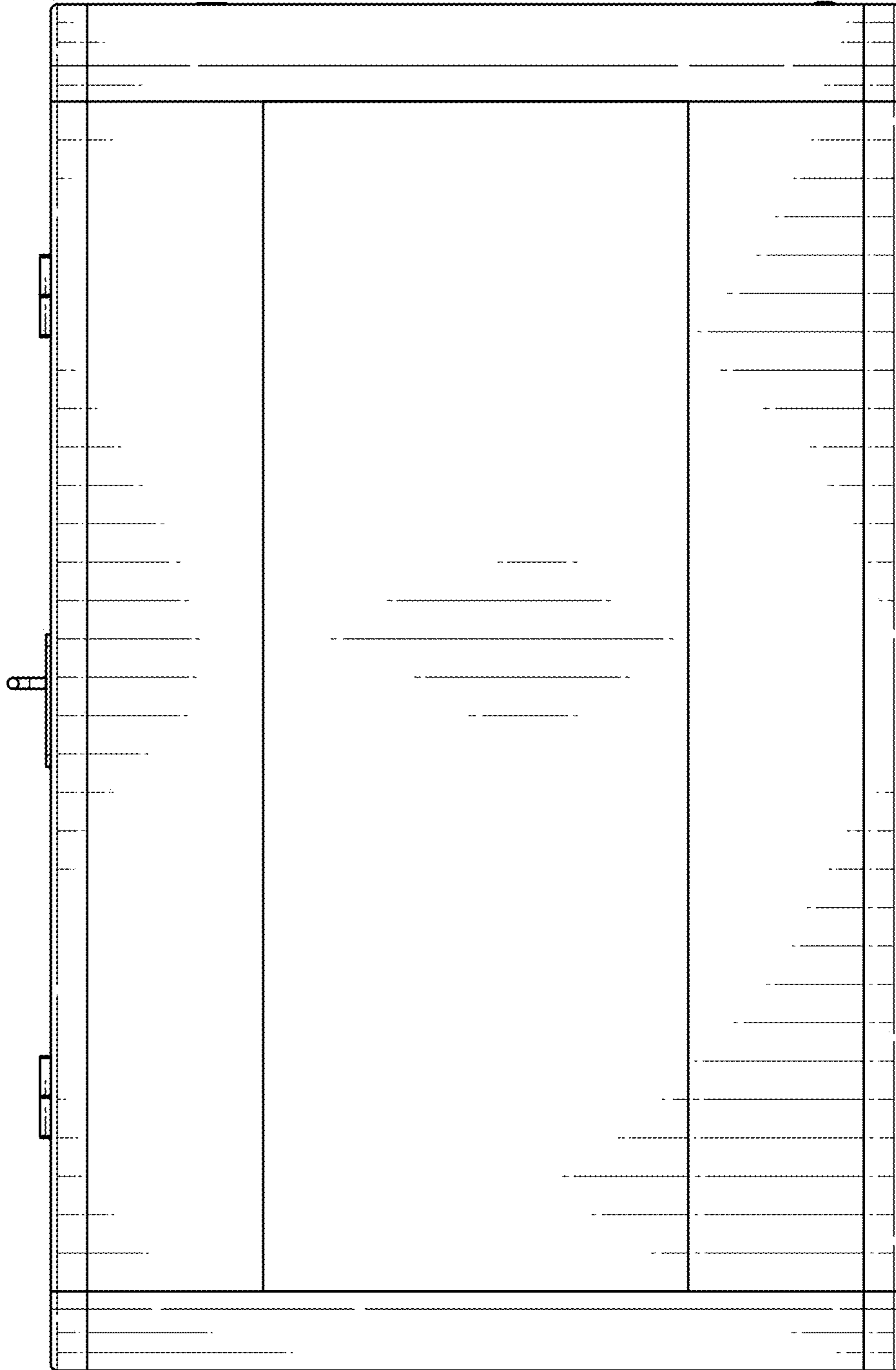

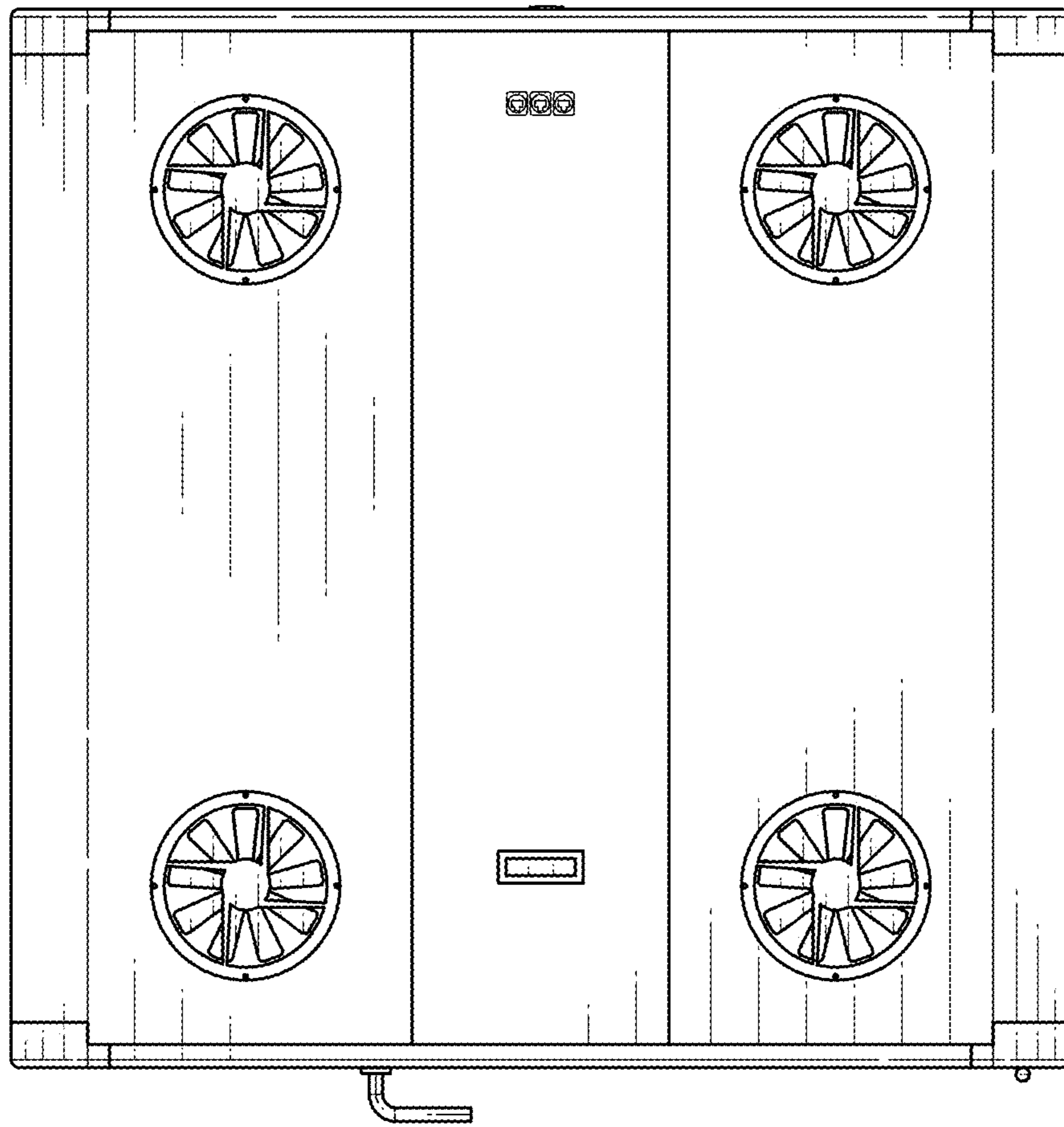

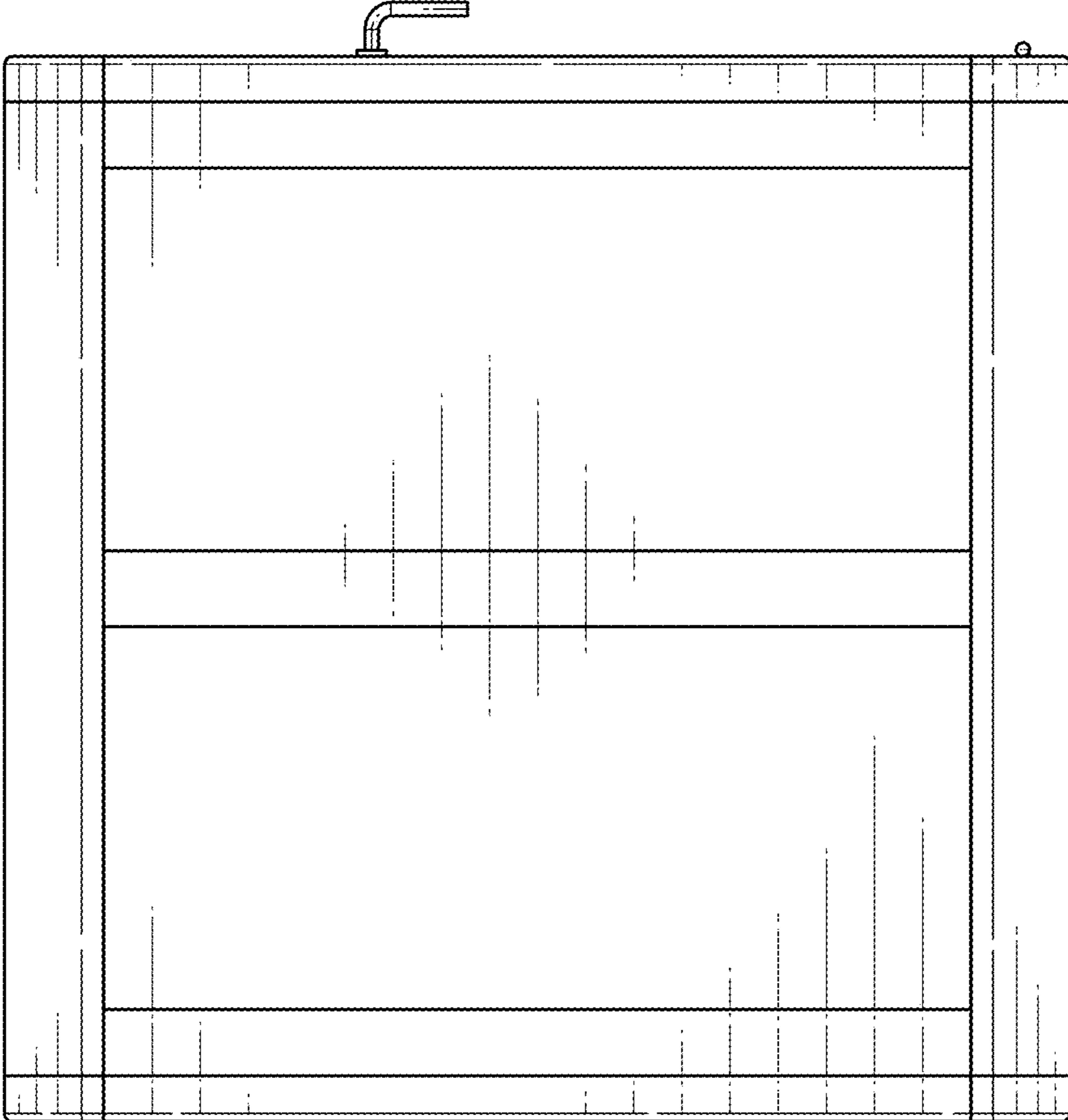

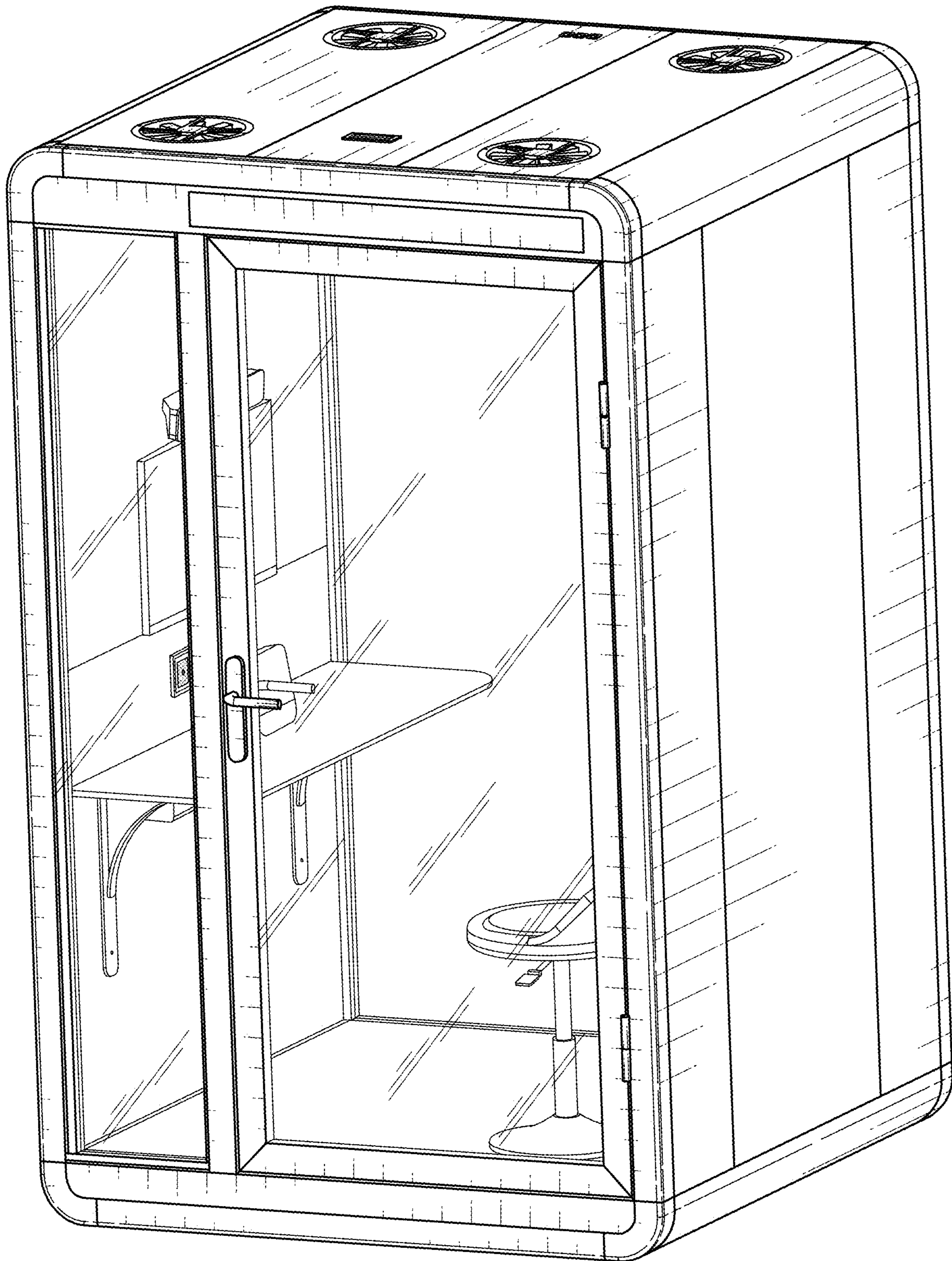

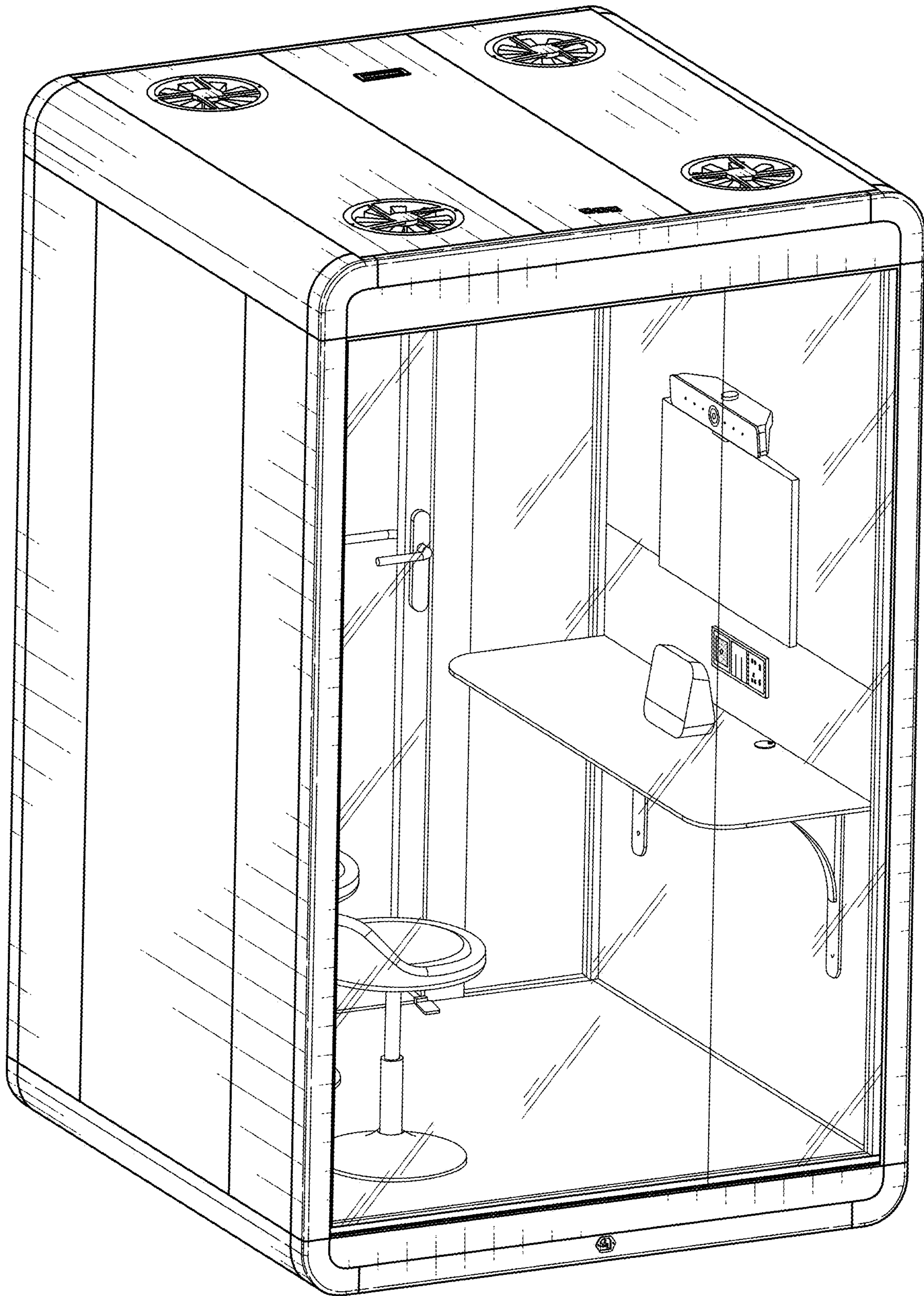
