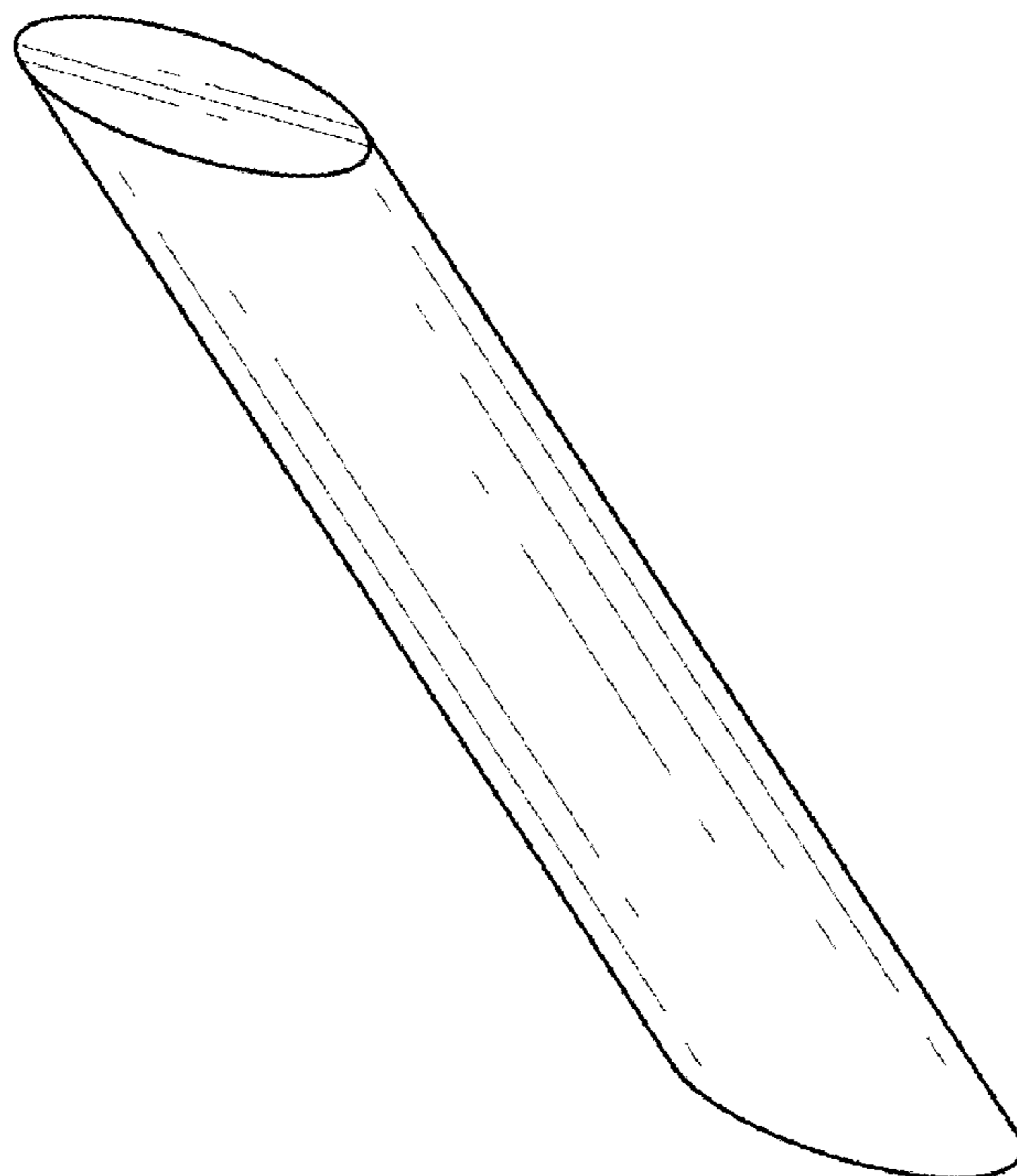
The ornamental design for a wooden candle wick, as shown.

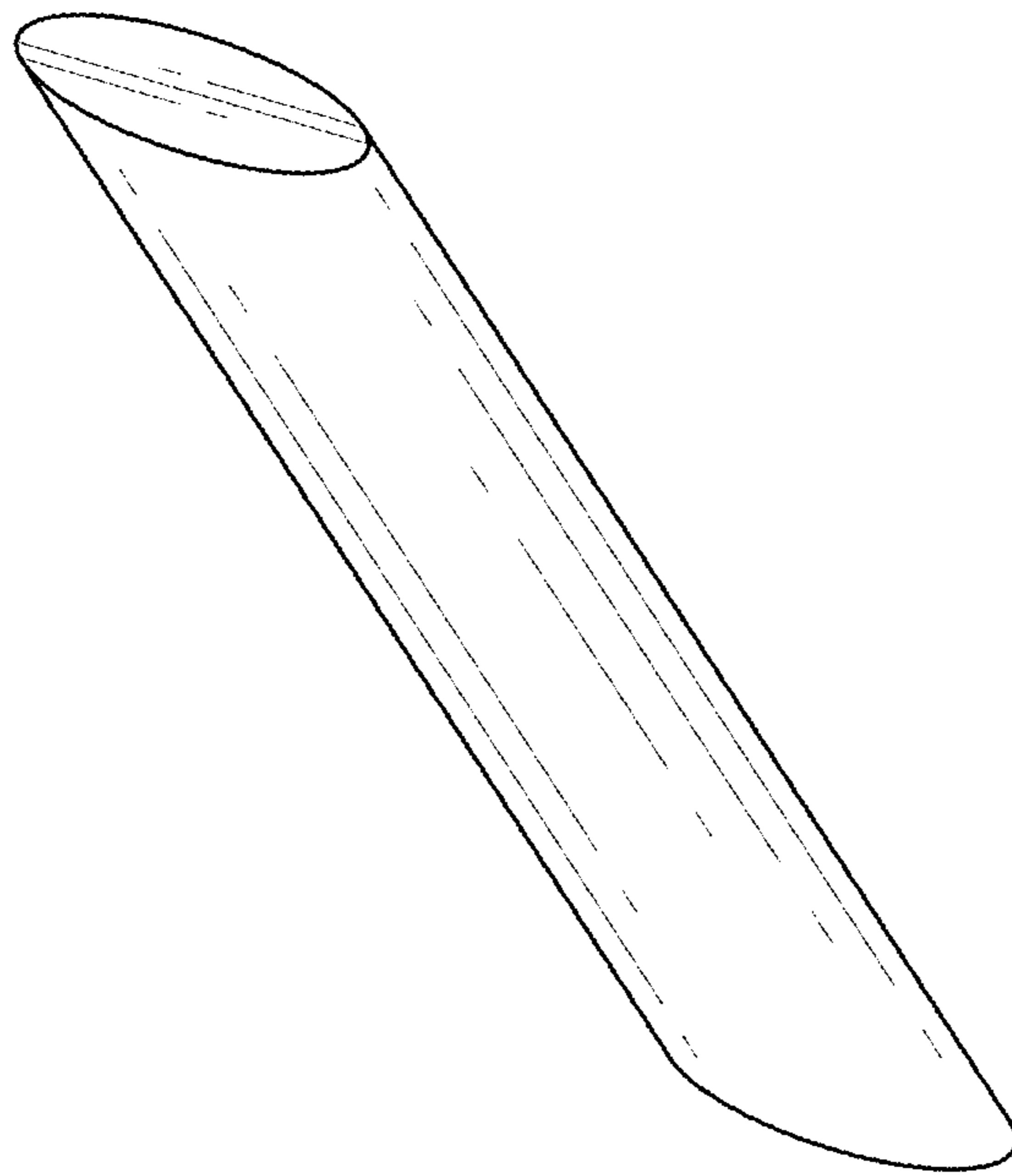

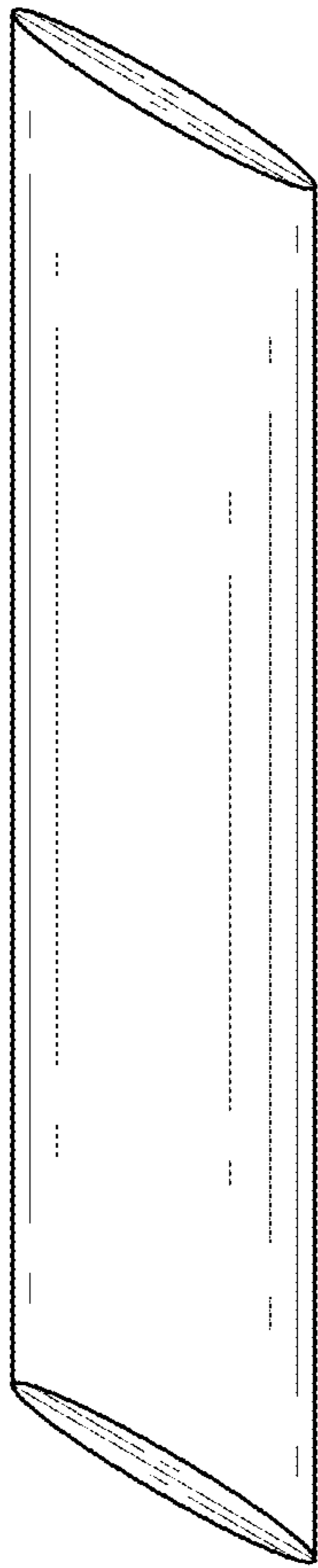

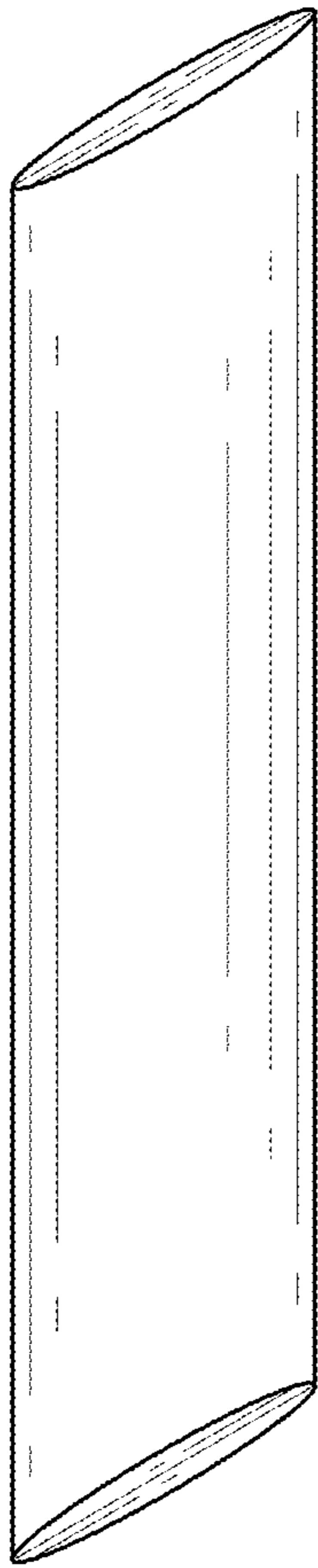

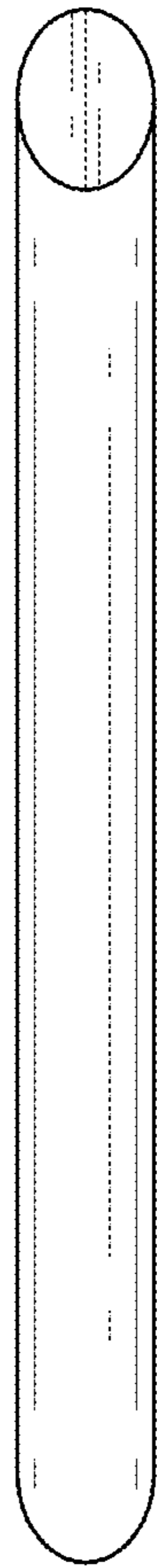

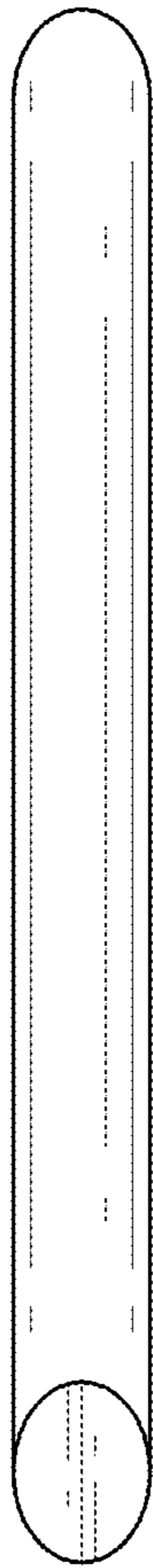

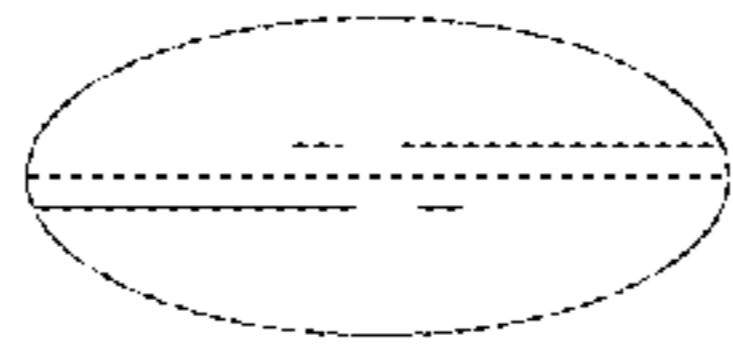

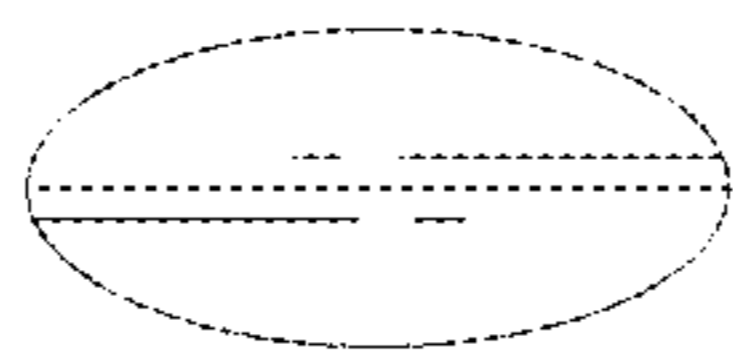

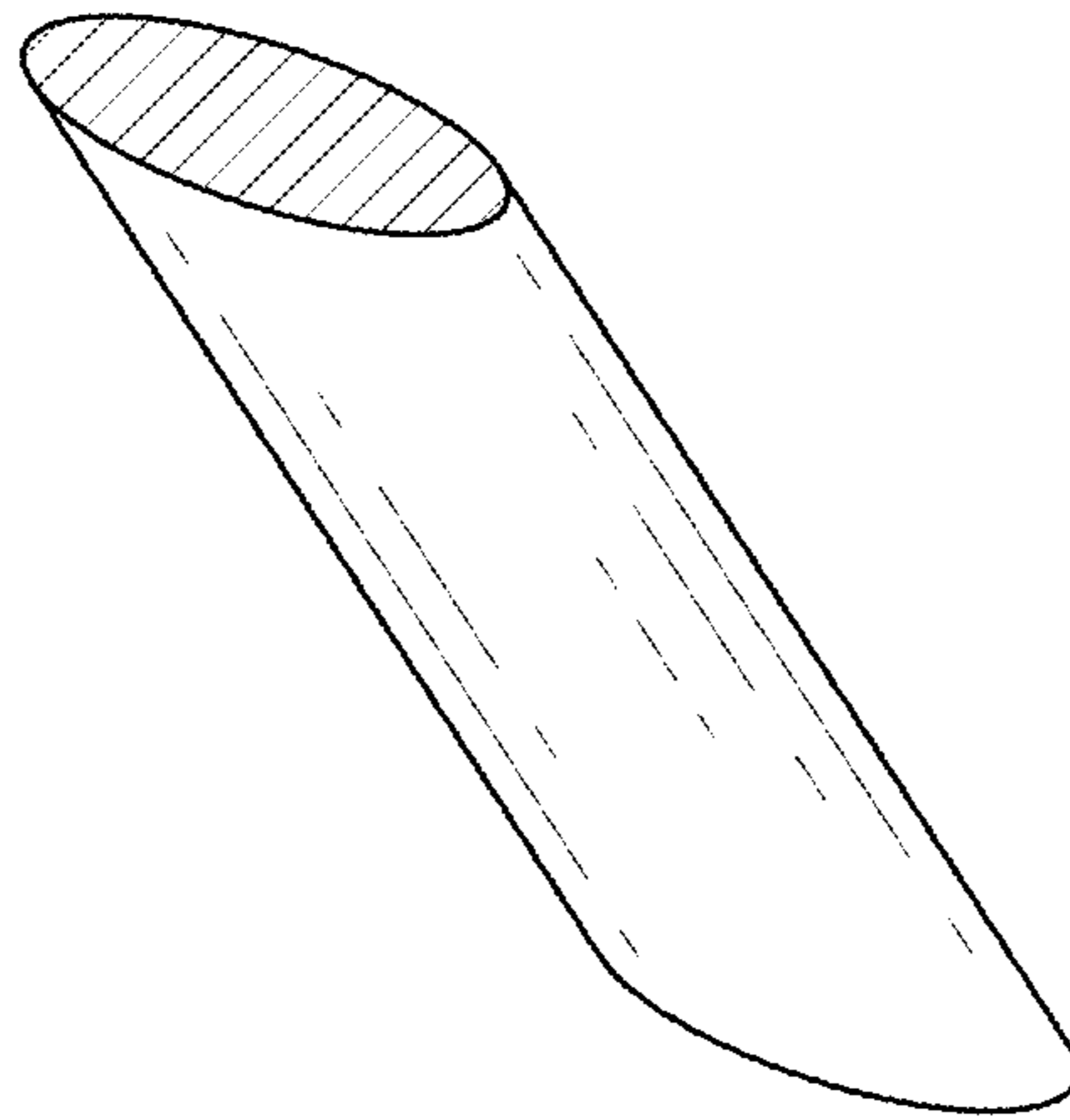
