(57) **CLAIM**

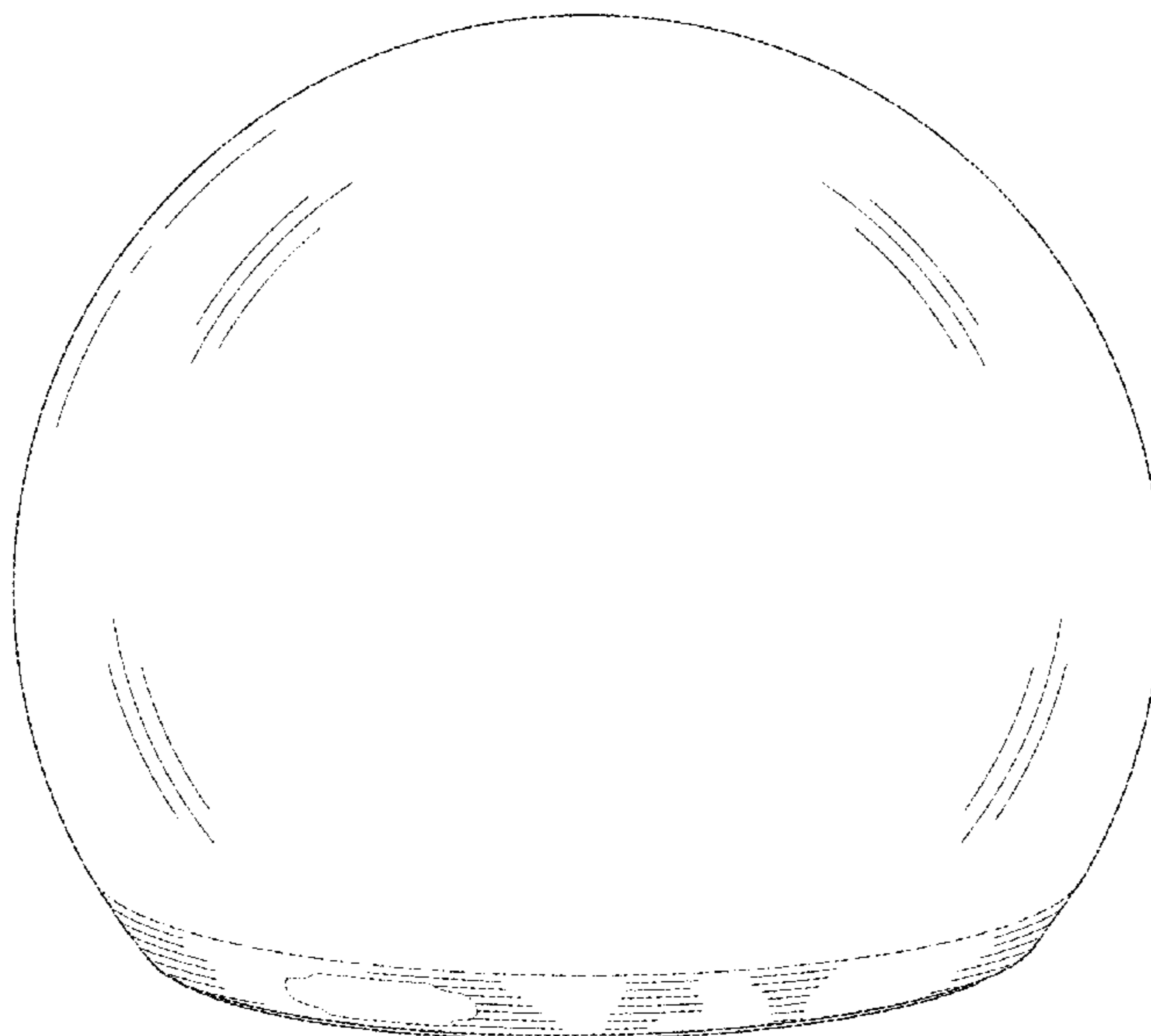
The ornamental design for a decorative spherical light, as shown and described.

DESCRIPTION

FIG. 1 is an isometric right front view of a decorative spherical light;
FIG. 2 is an isometric top, right rear view thereof;
FIG. 3 is an isometric bottom, left front view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a rear view thereof;

FIG. 13 is an isometric right front view of an alternate embodiment decorative spherical light;

FIG. 16 is a front view thereof;
FIG. 17 is a rear view thereof;
FIG. 18 is a right side view thereof;
FIG. 19 is a left side view thereof;

FIG. 22 is a right elevation sectional view of the decorative spherical light taken along the line 22-22 of FIG. 20;

FIG. 24 is an isometric rear elevation sectional view of the decorative spherical light taken along the line 23-23 of FIG. 20.

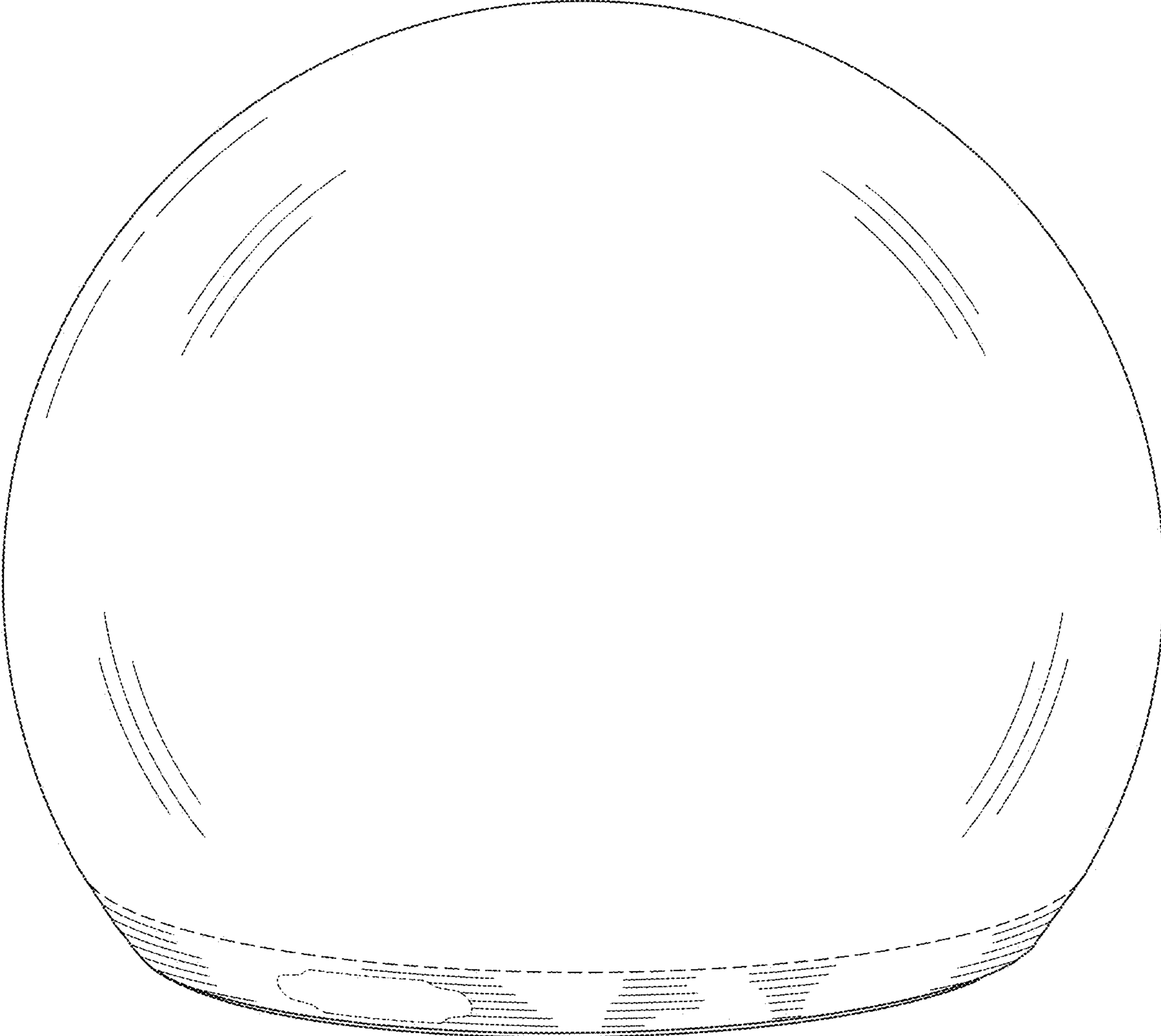

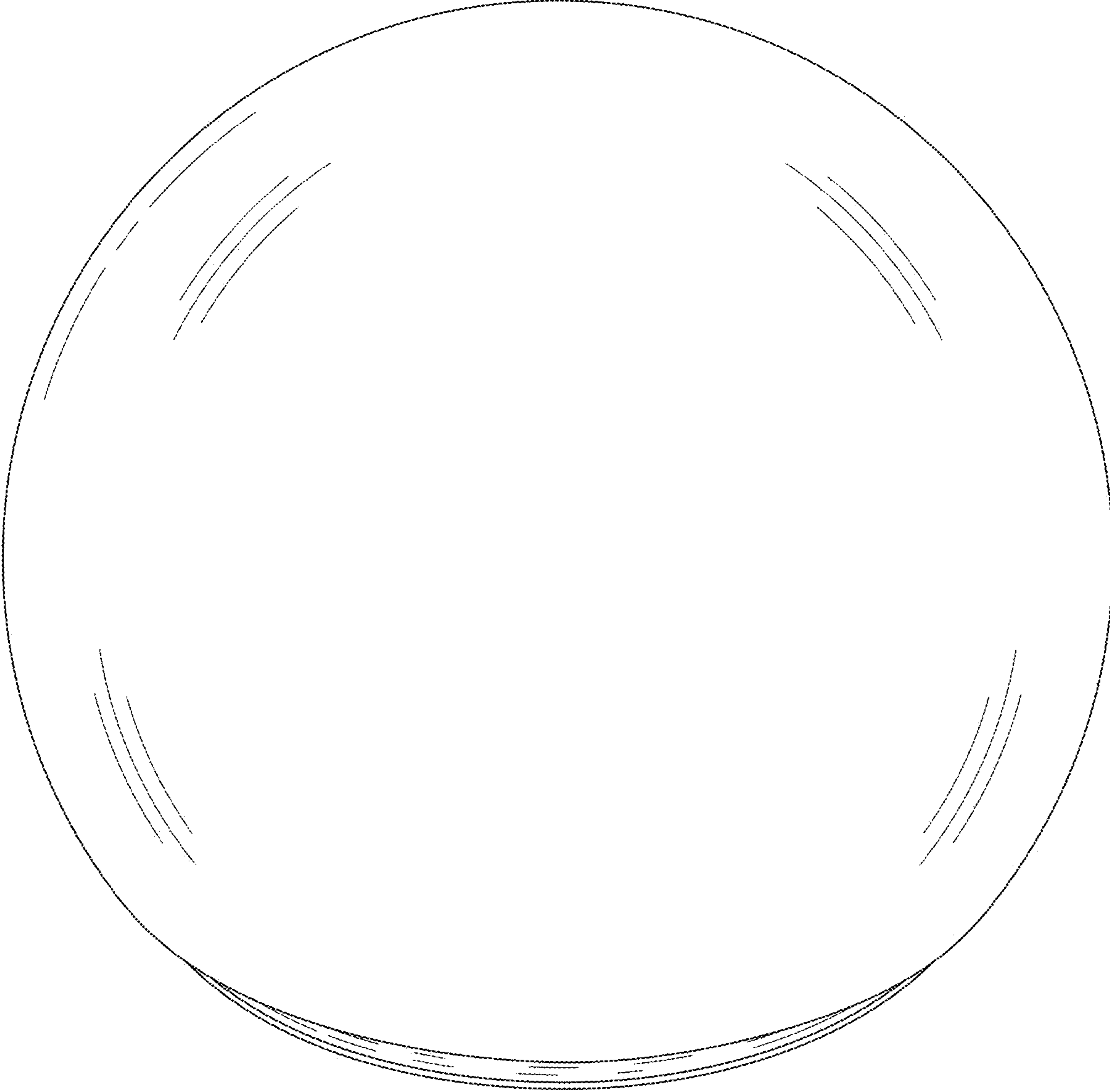

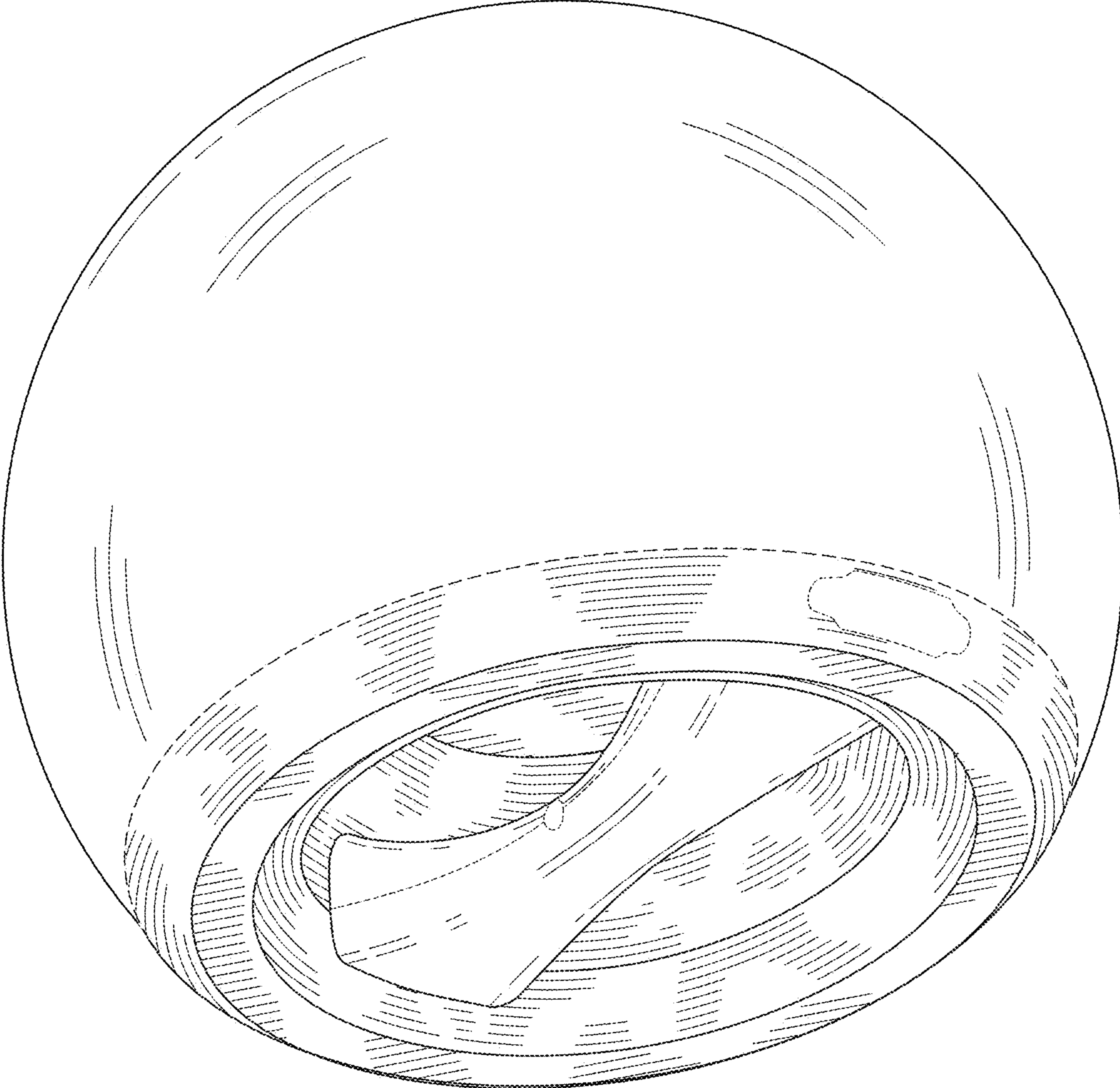

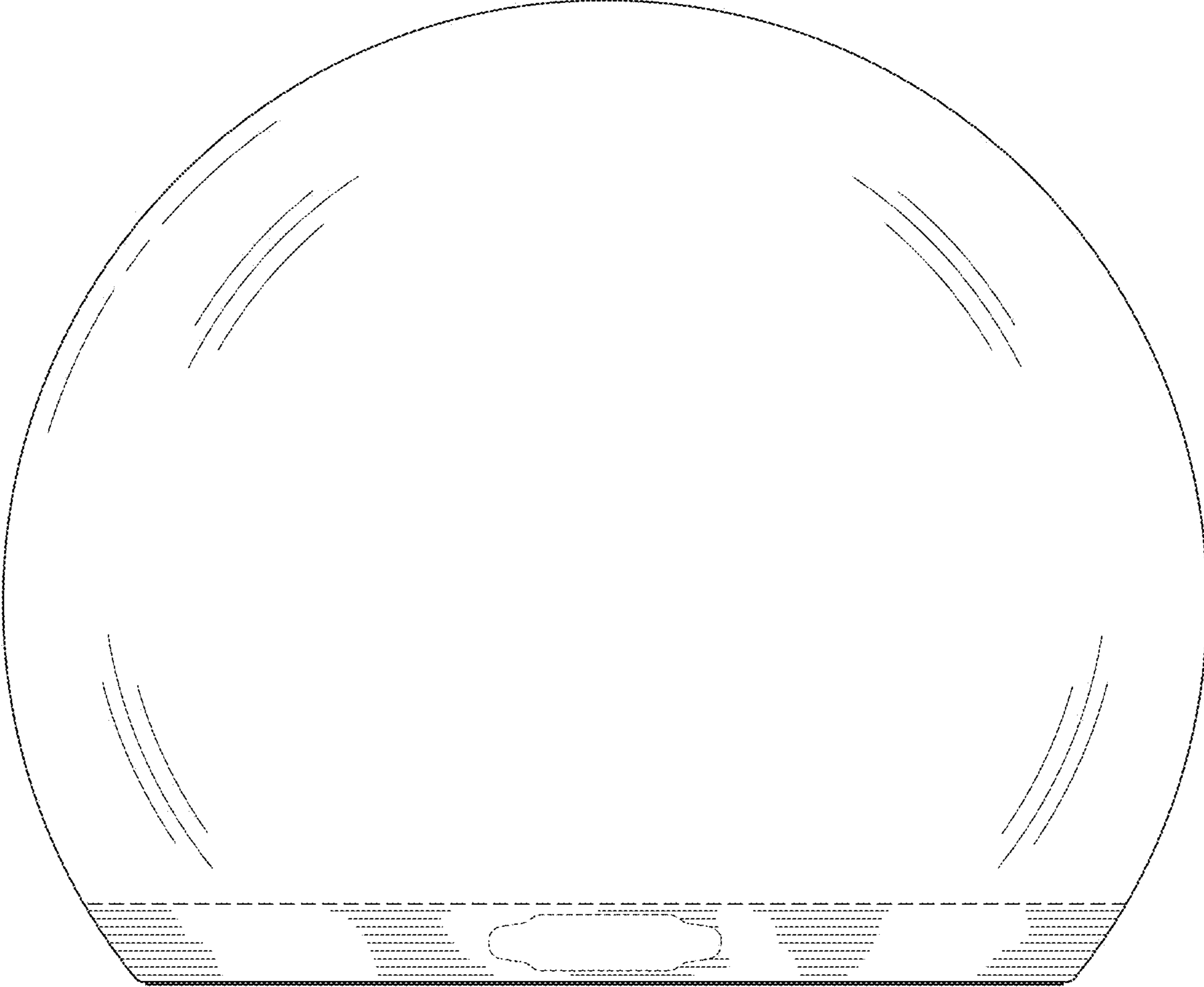

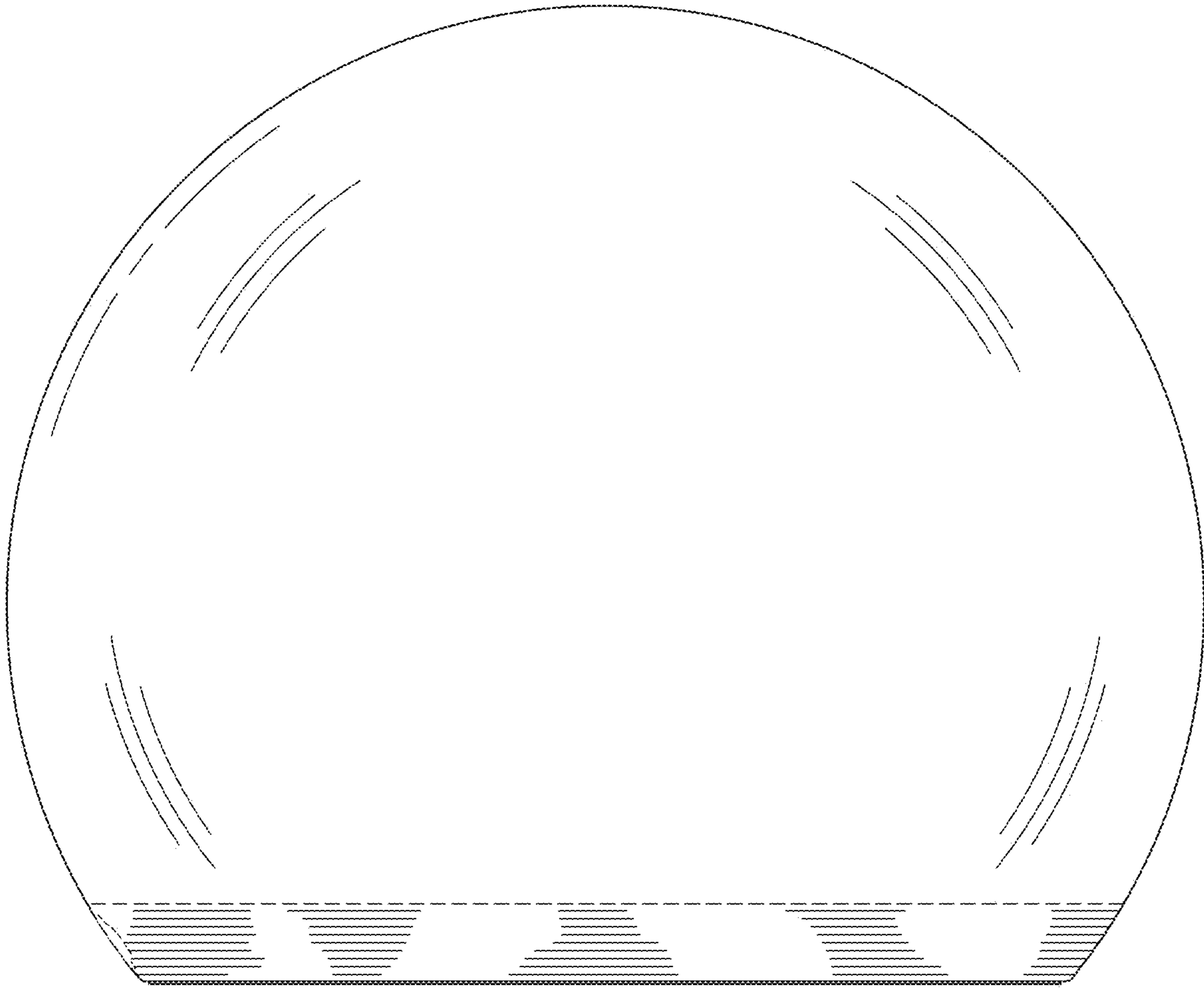

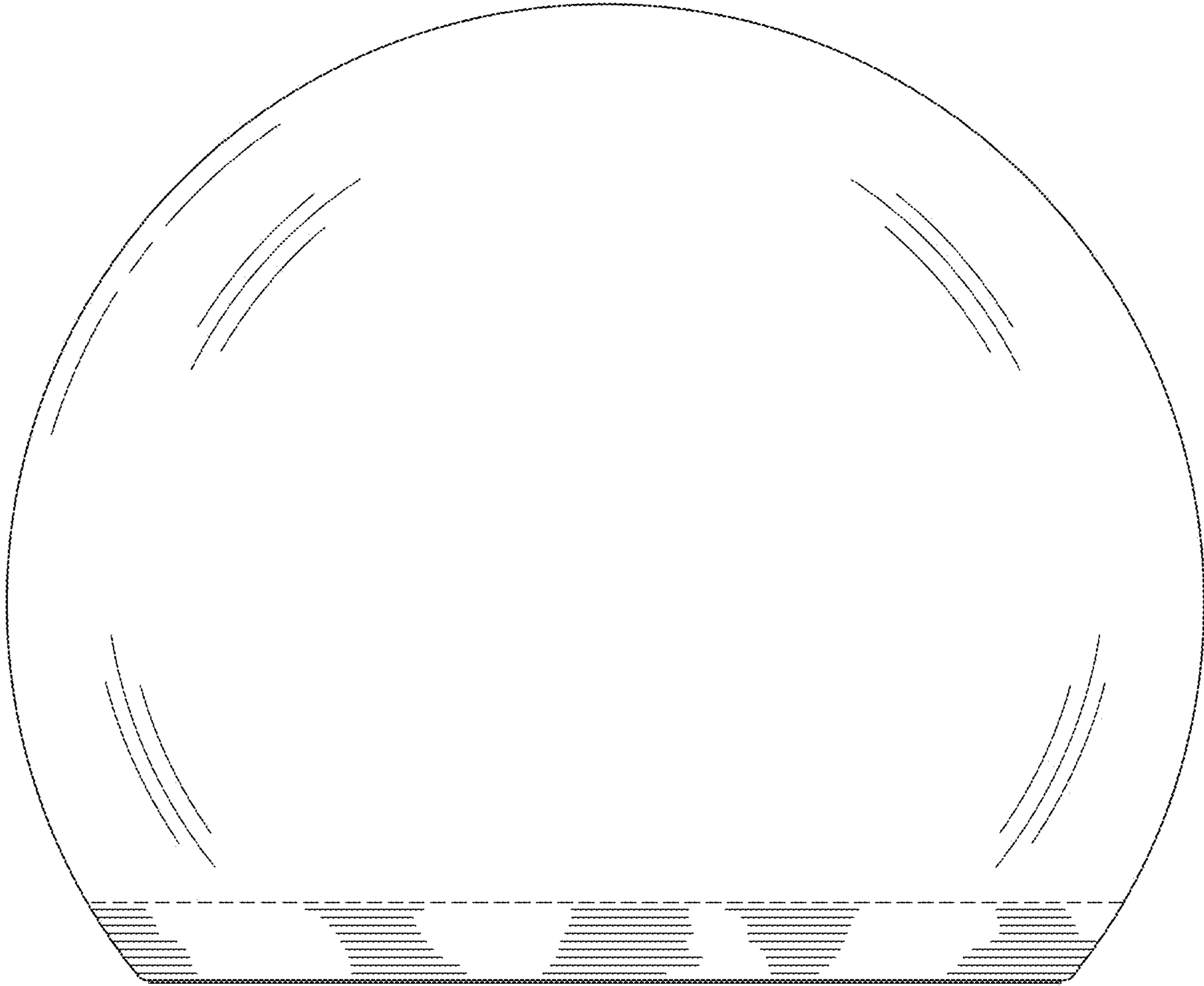

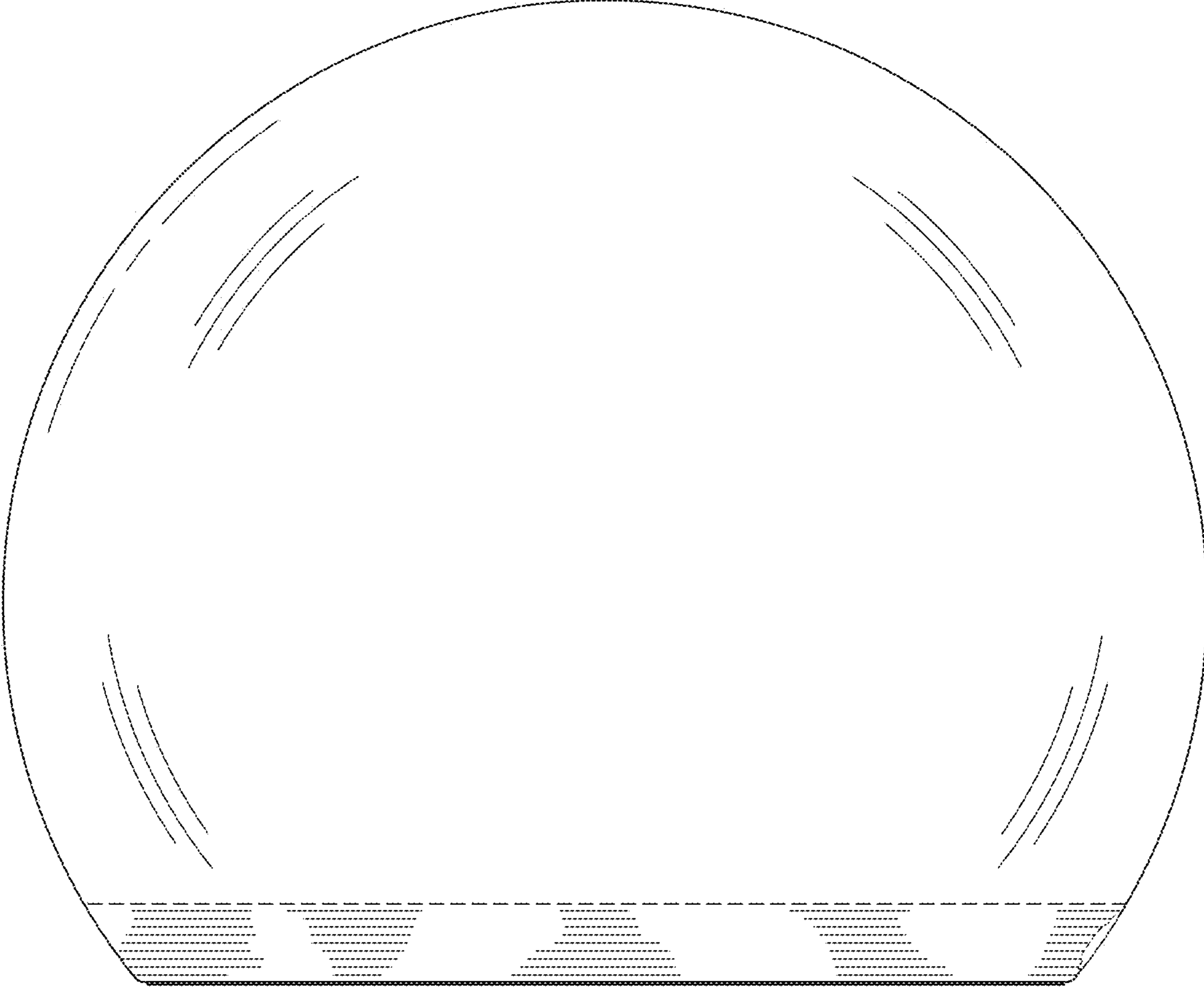

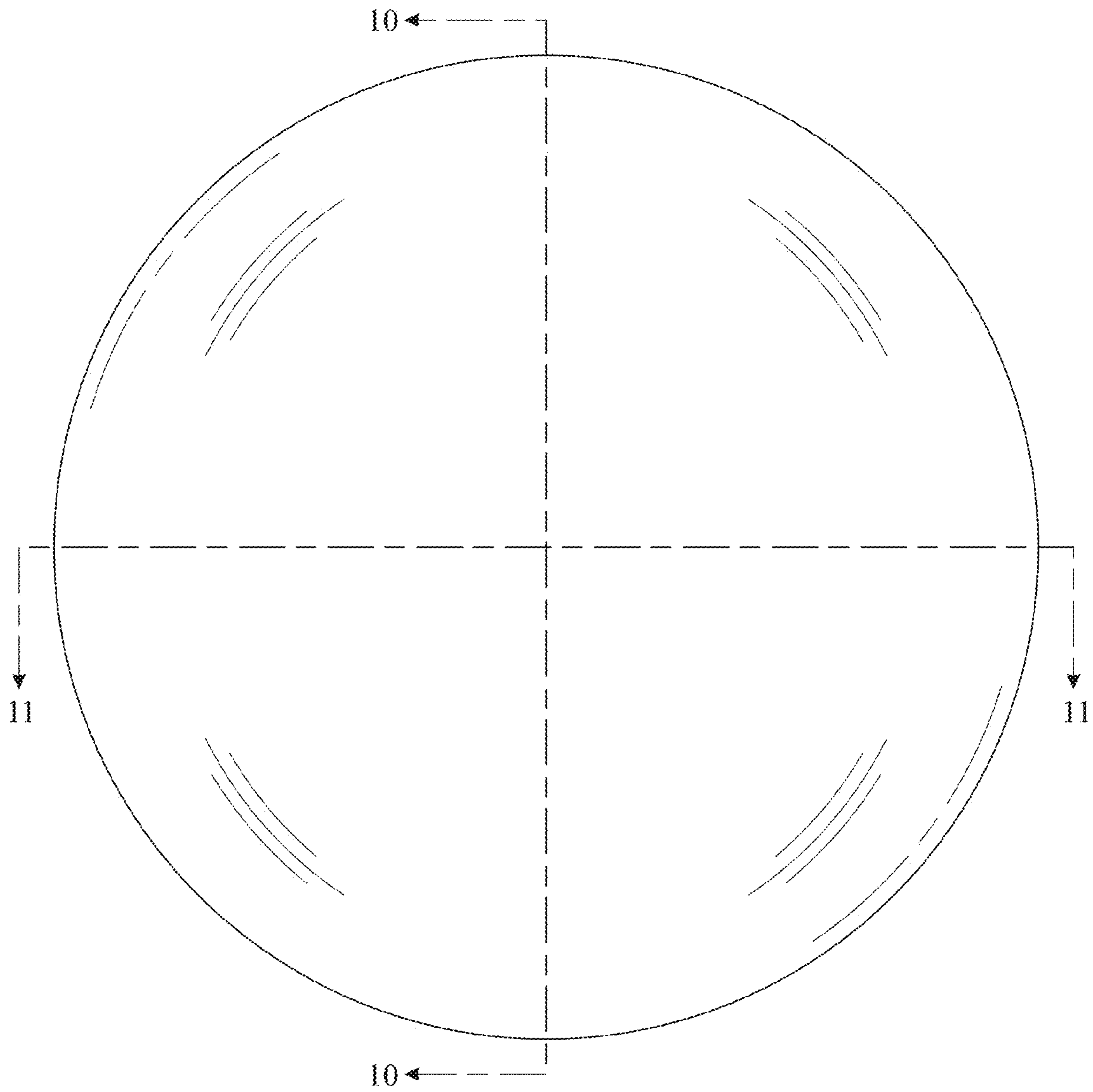

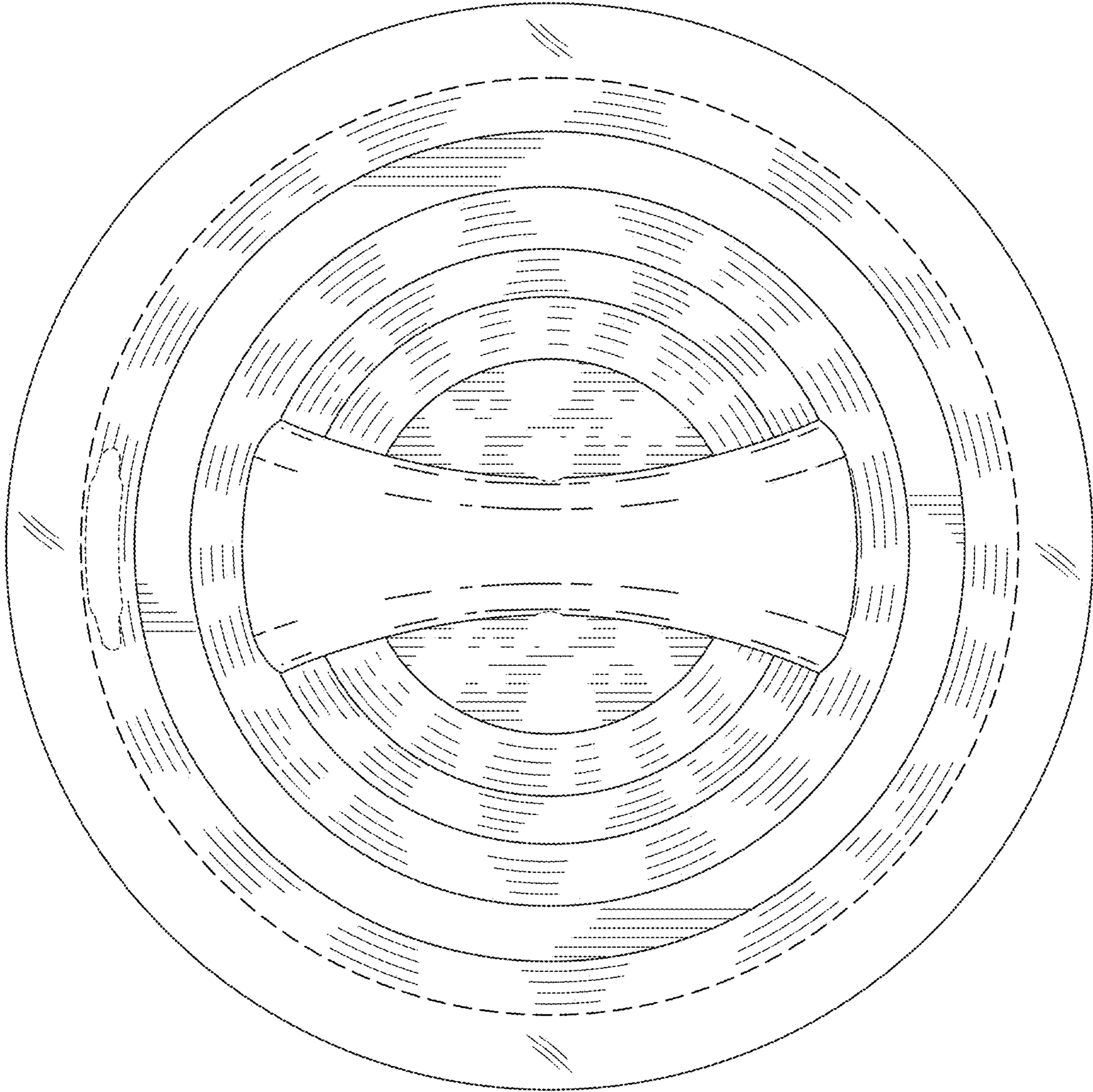

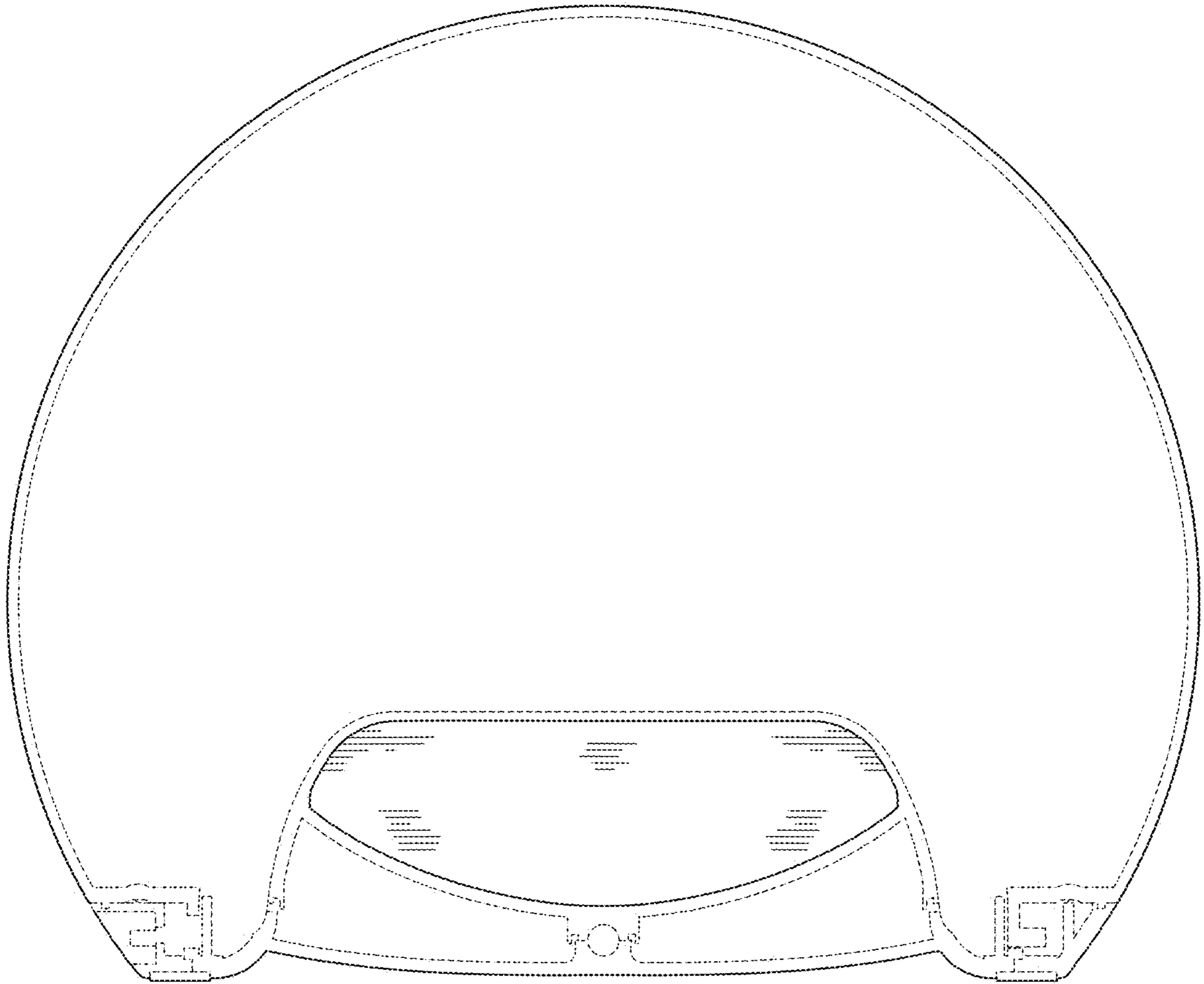

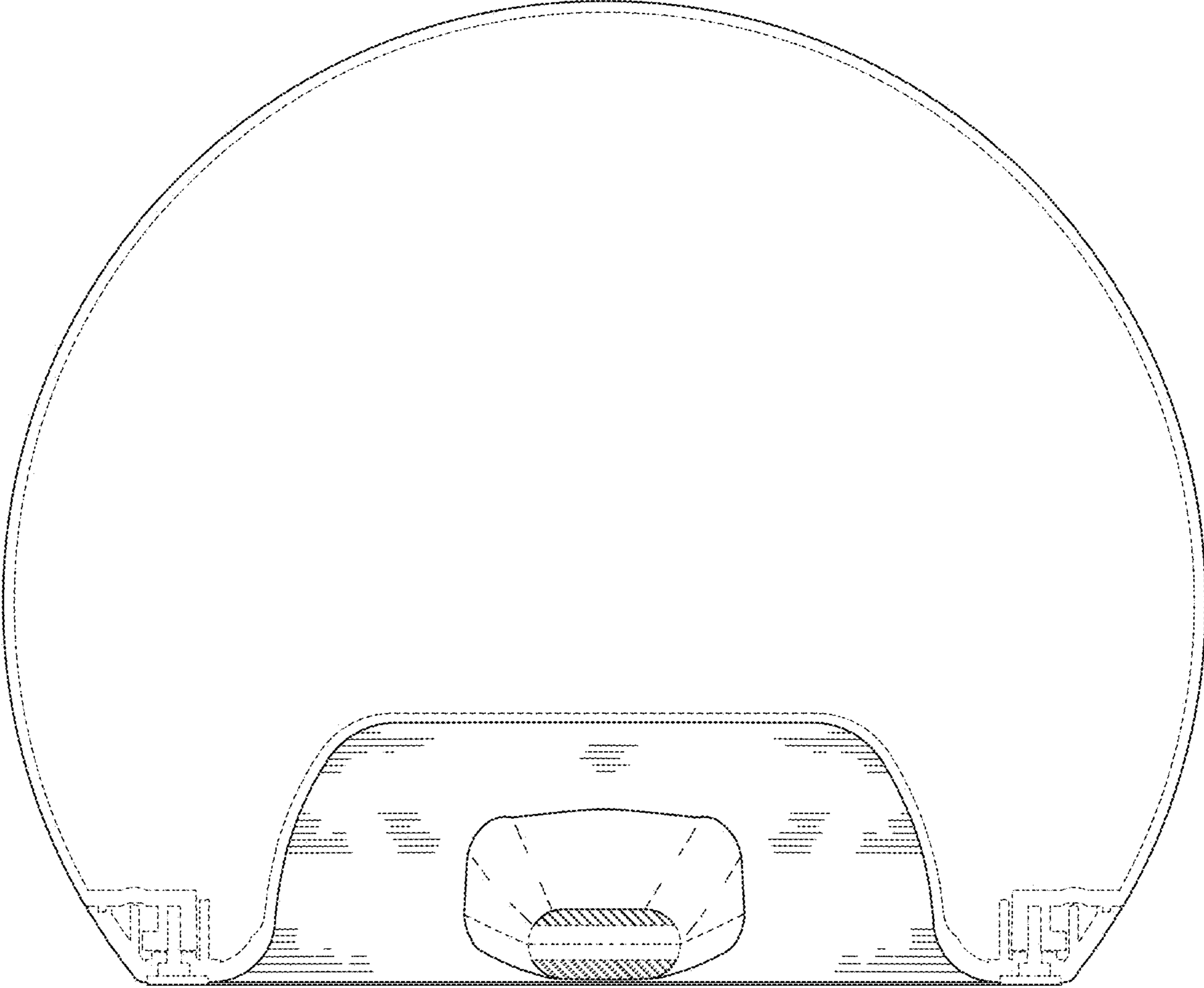

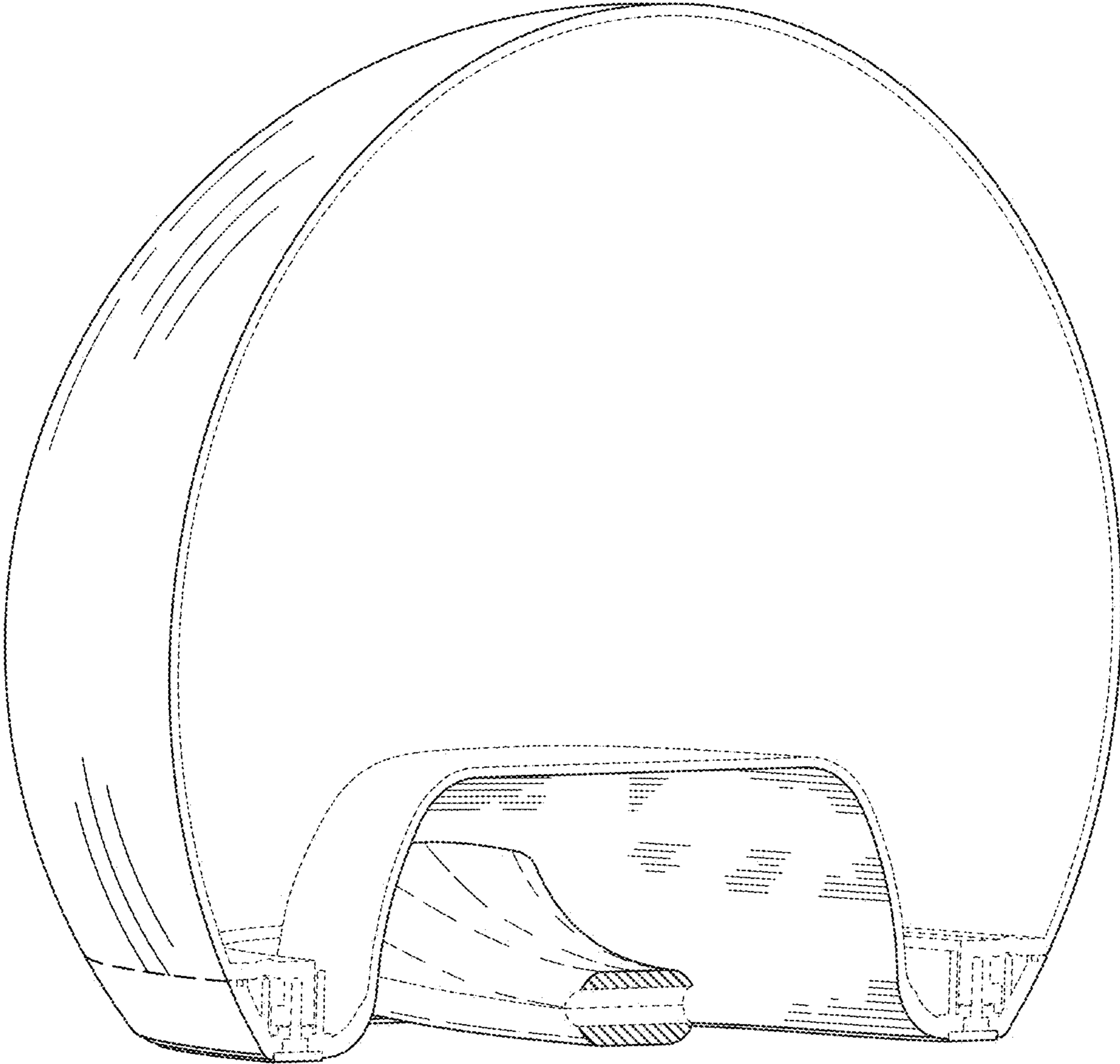

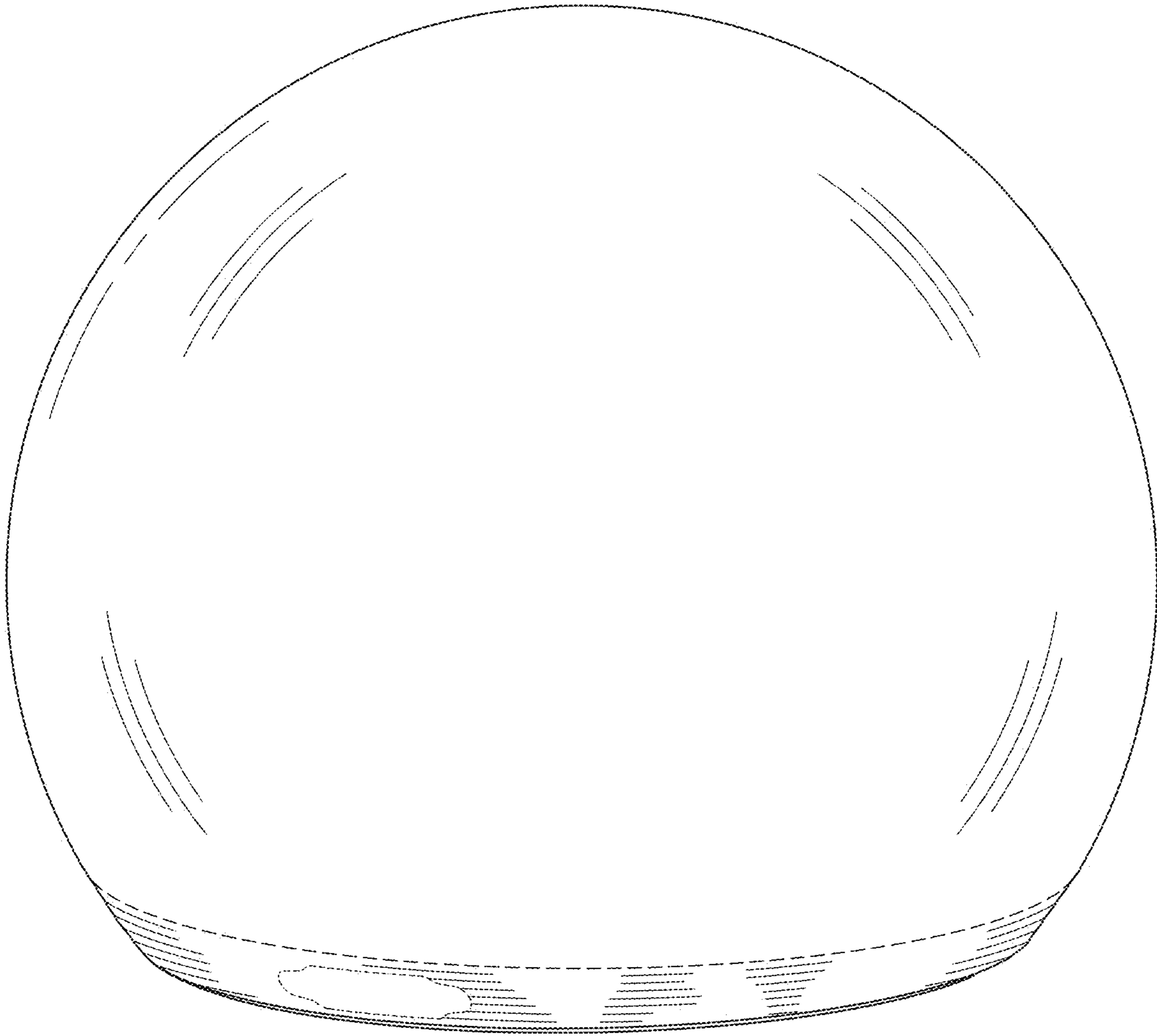

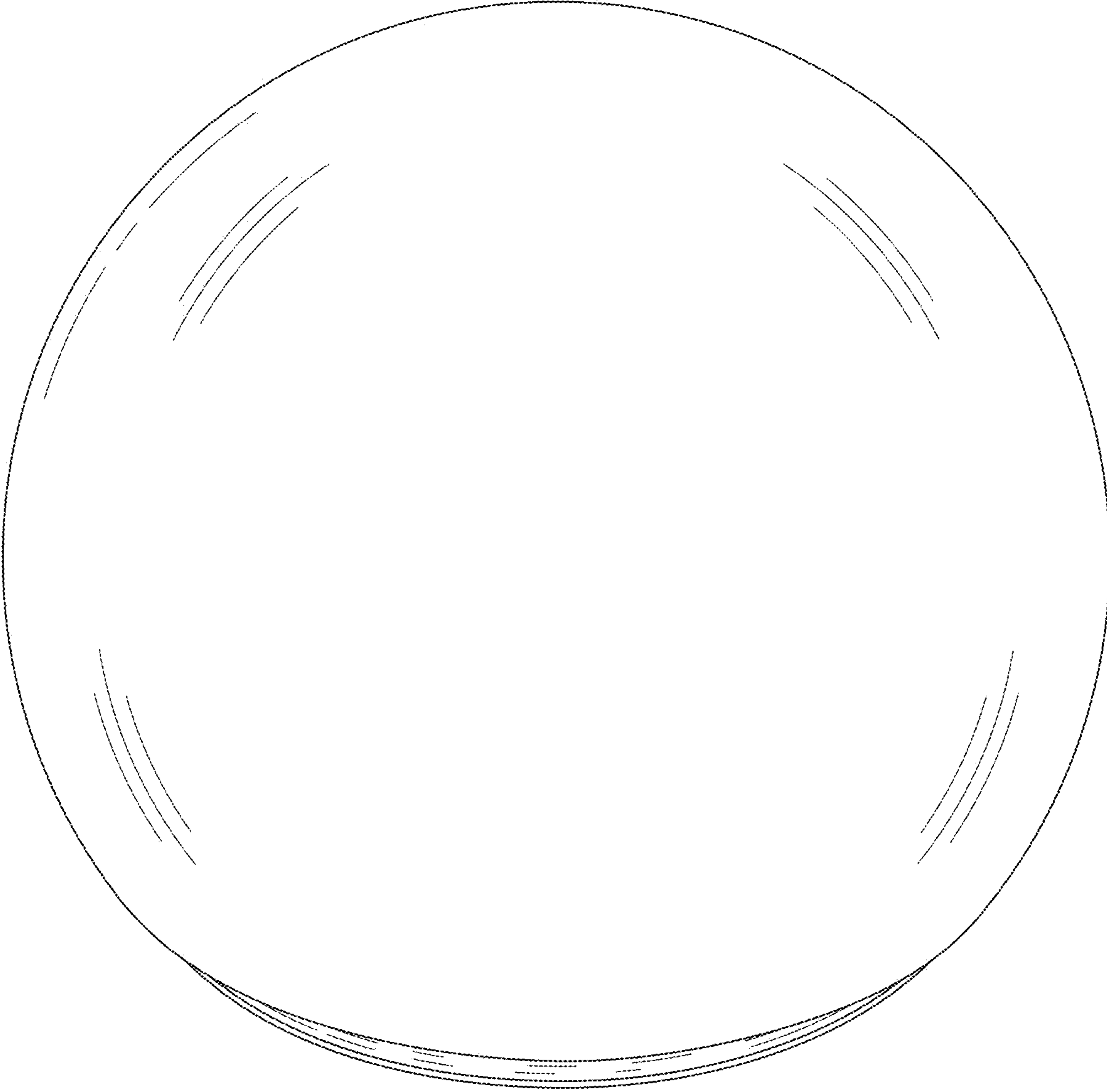

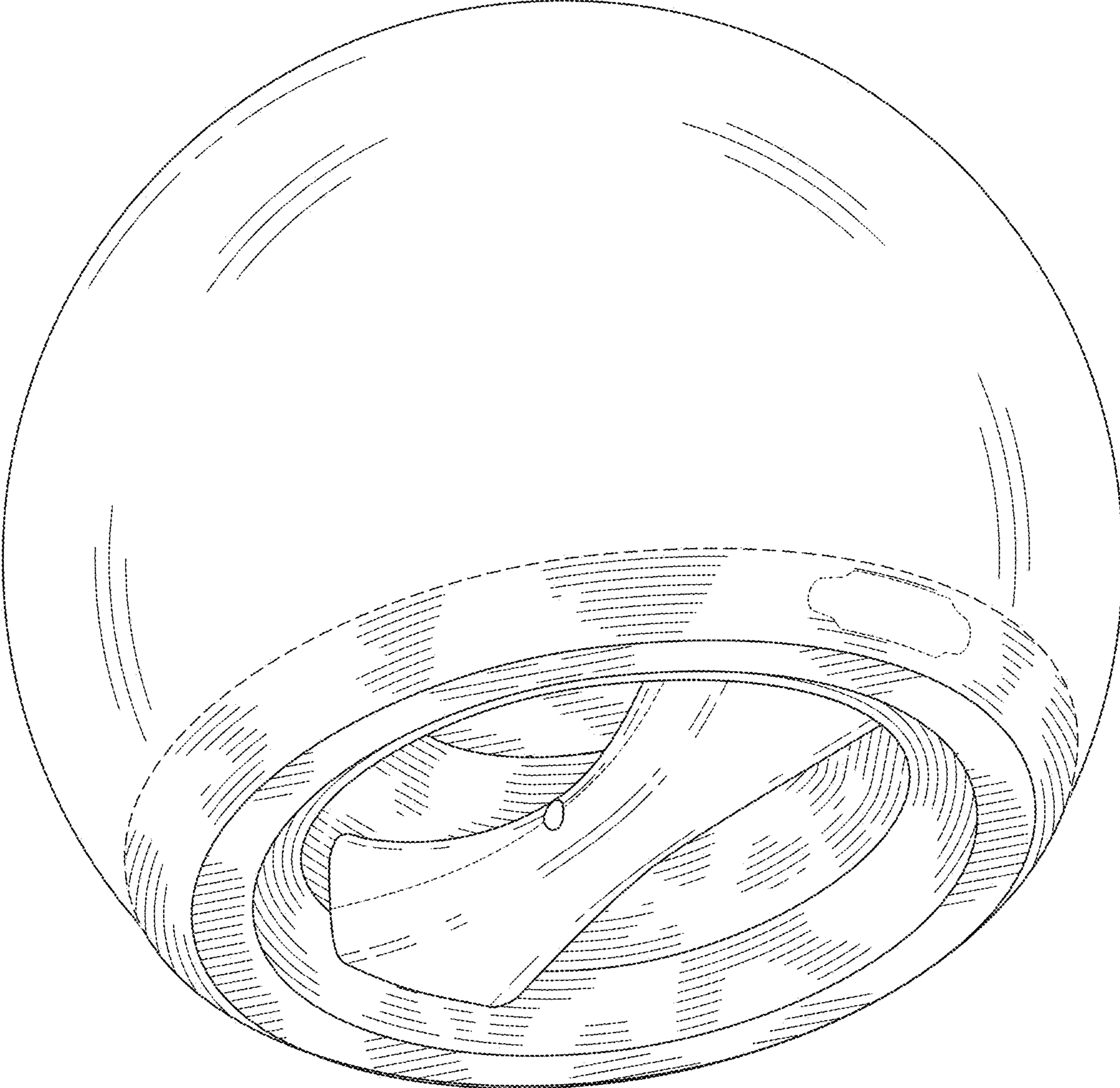

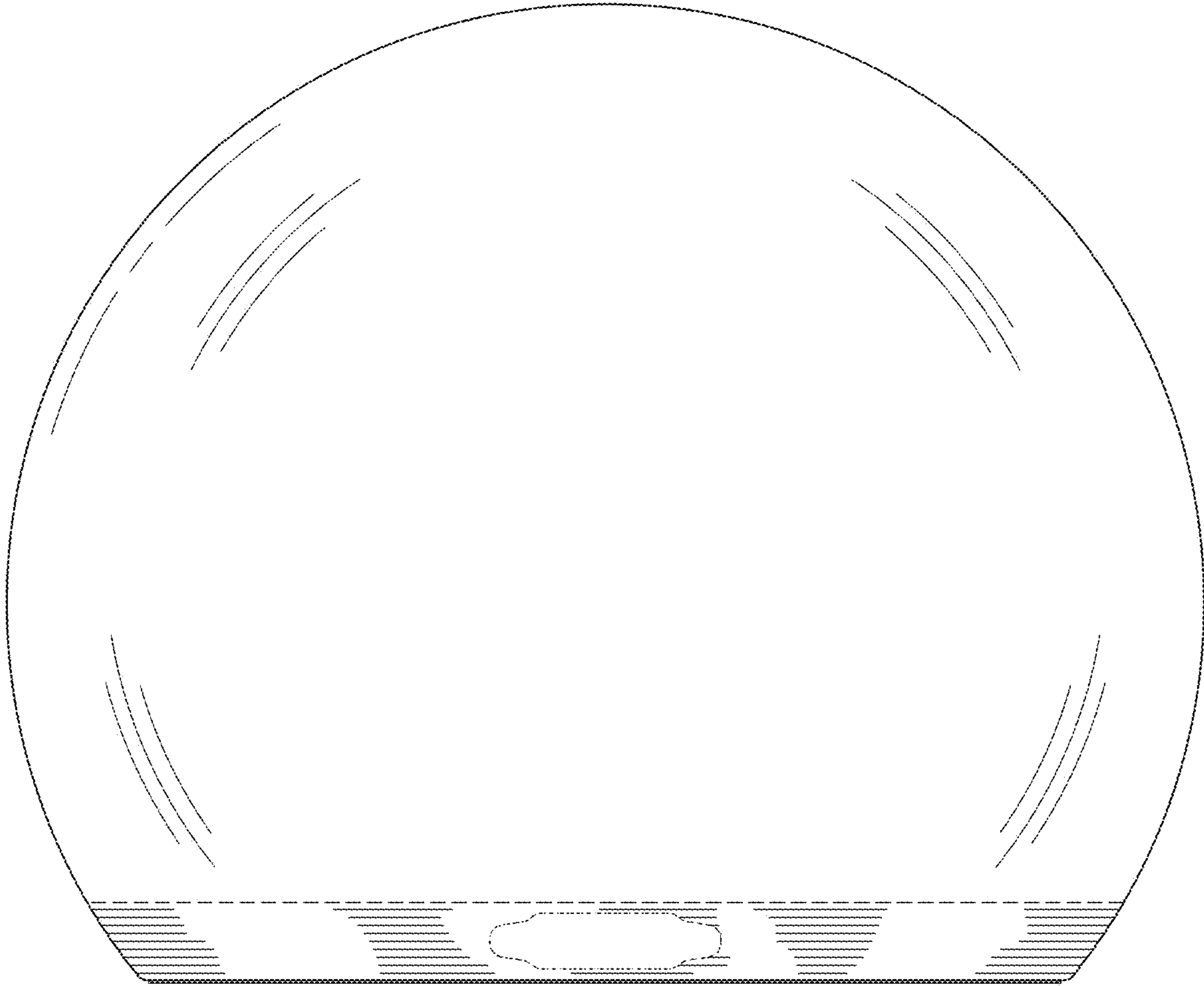

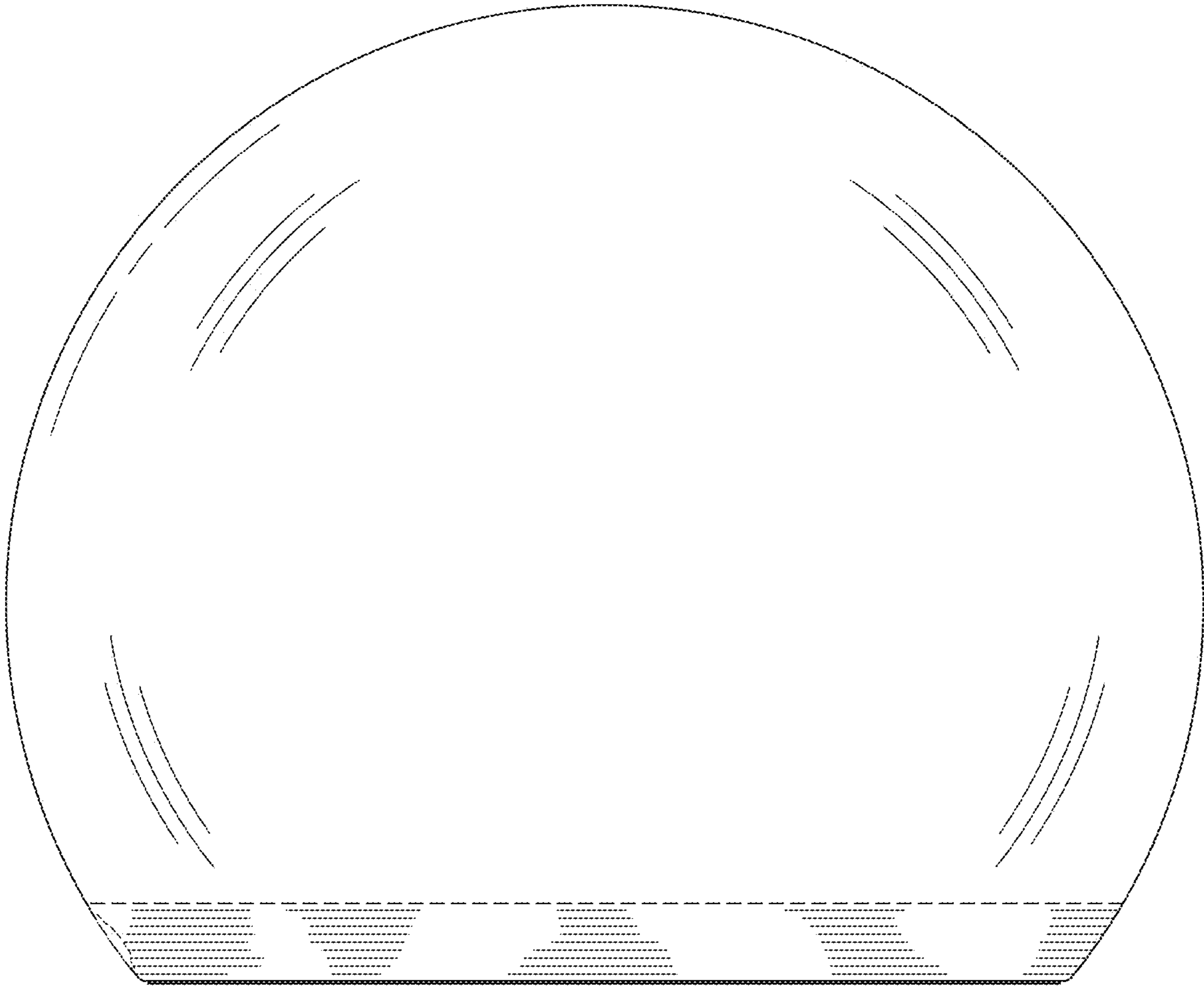

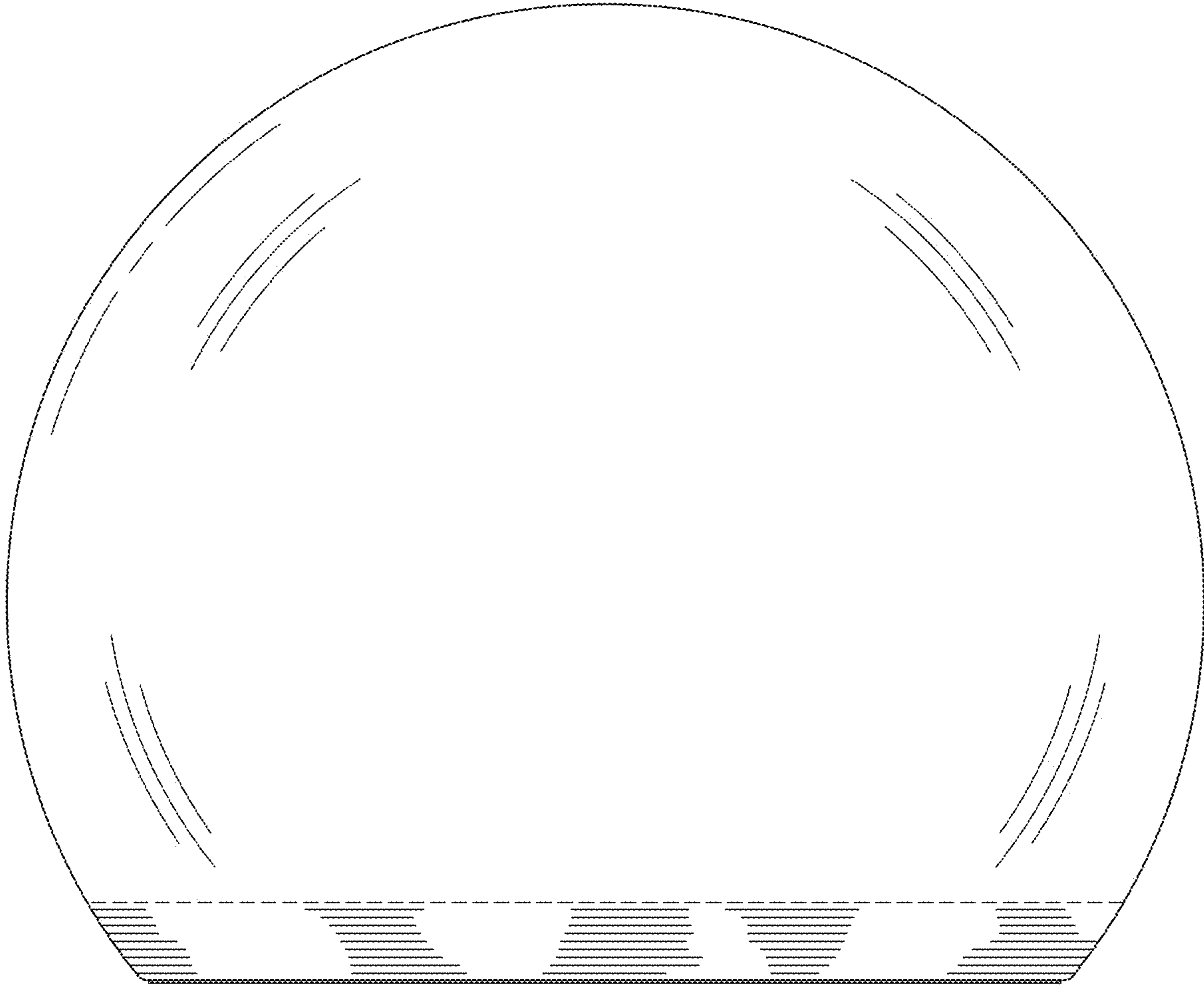

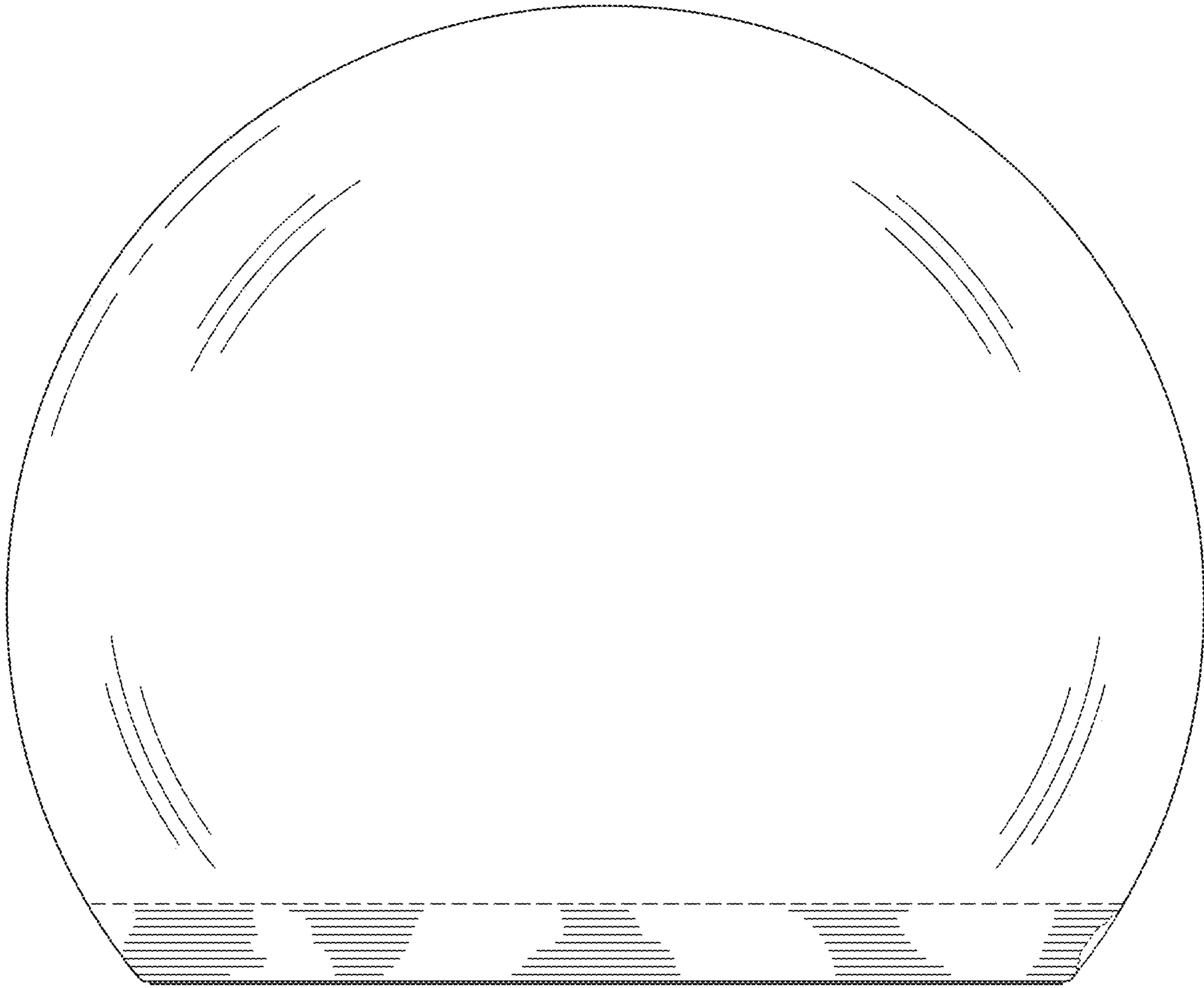

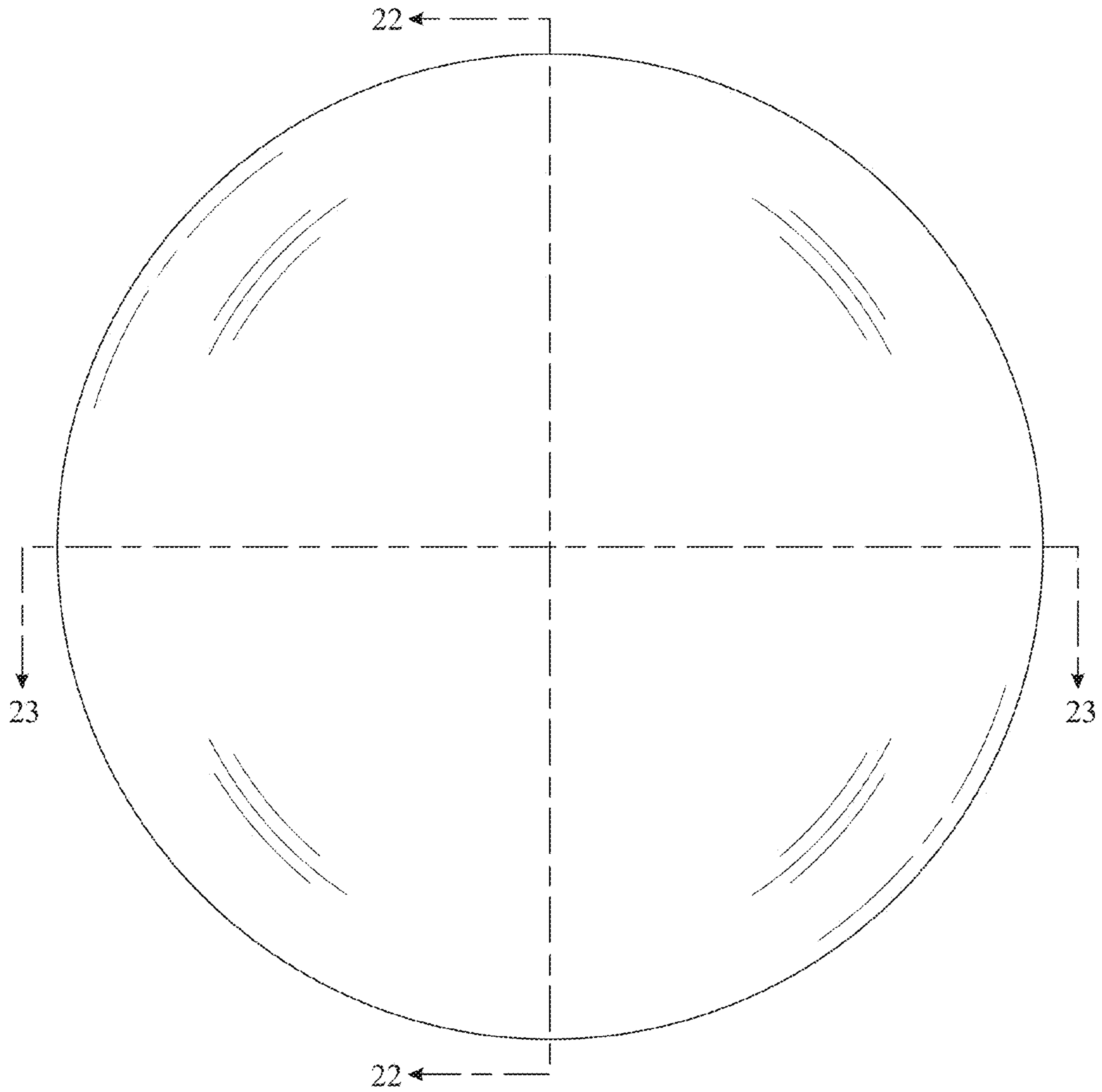

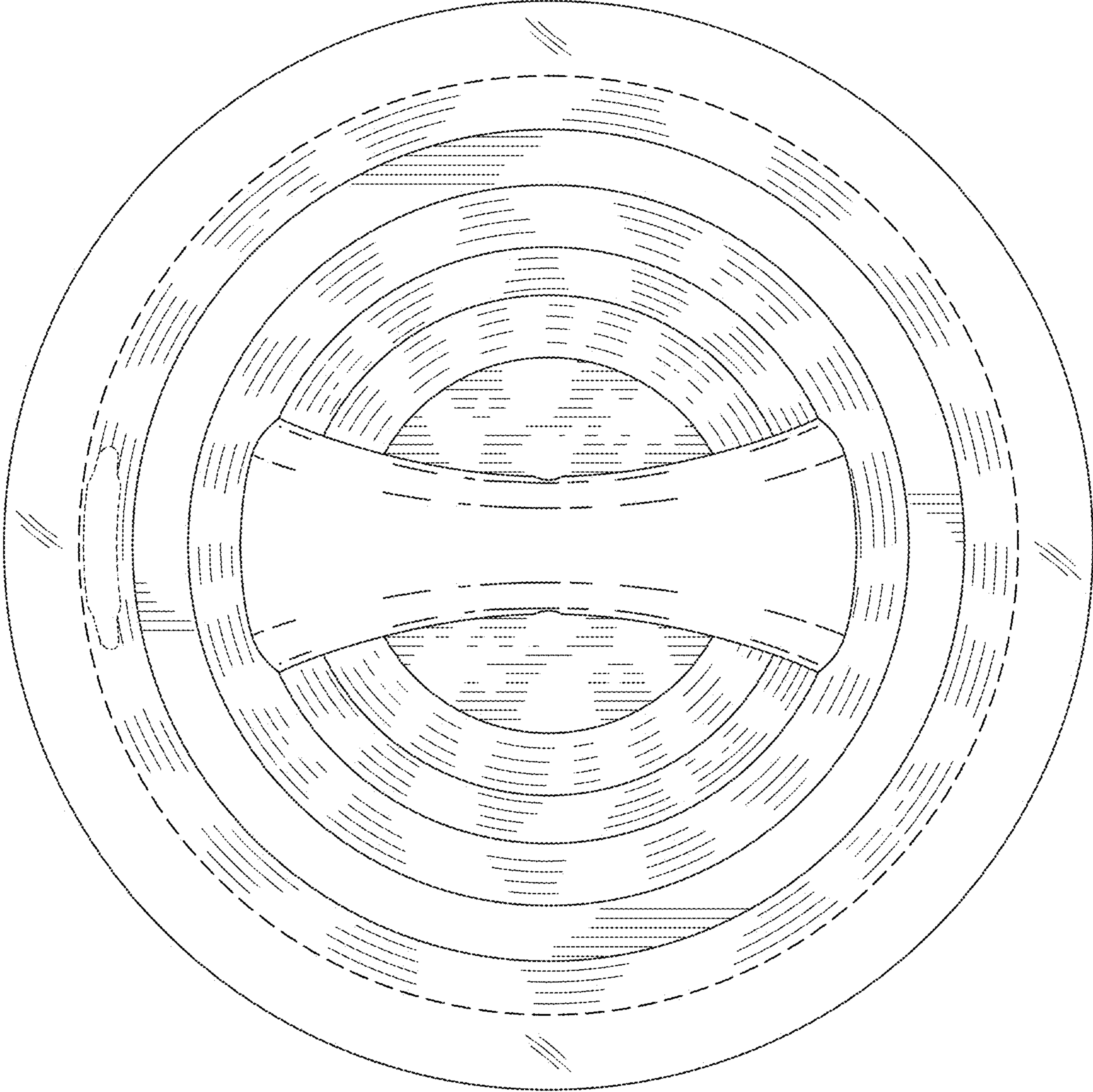

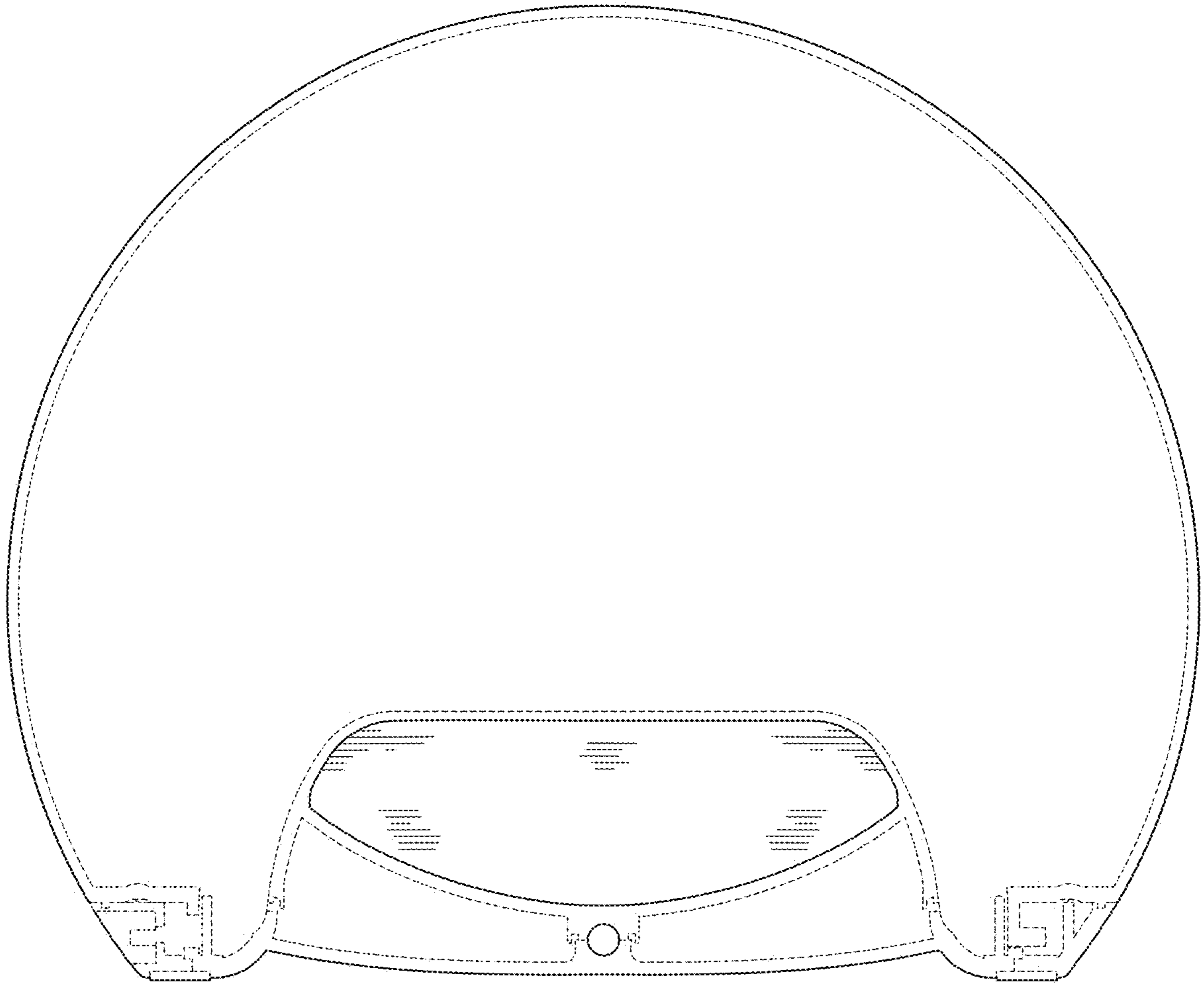

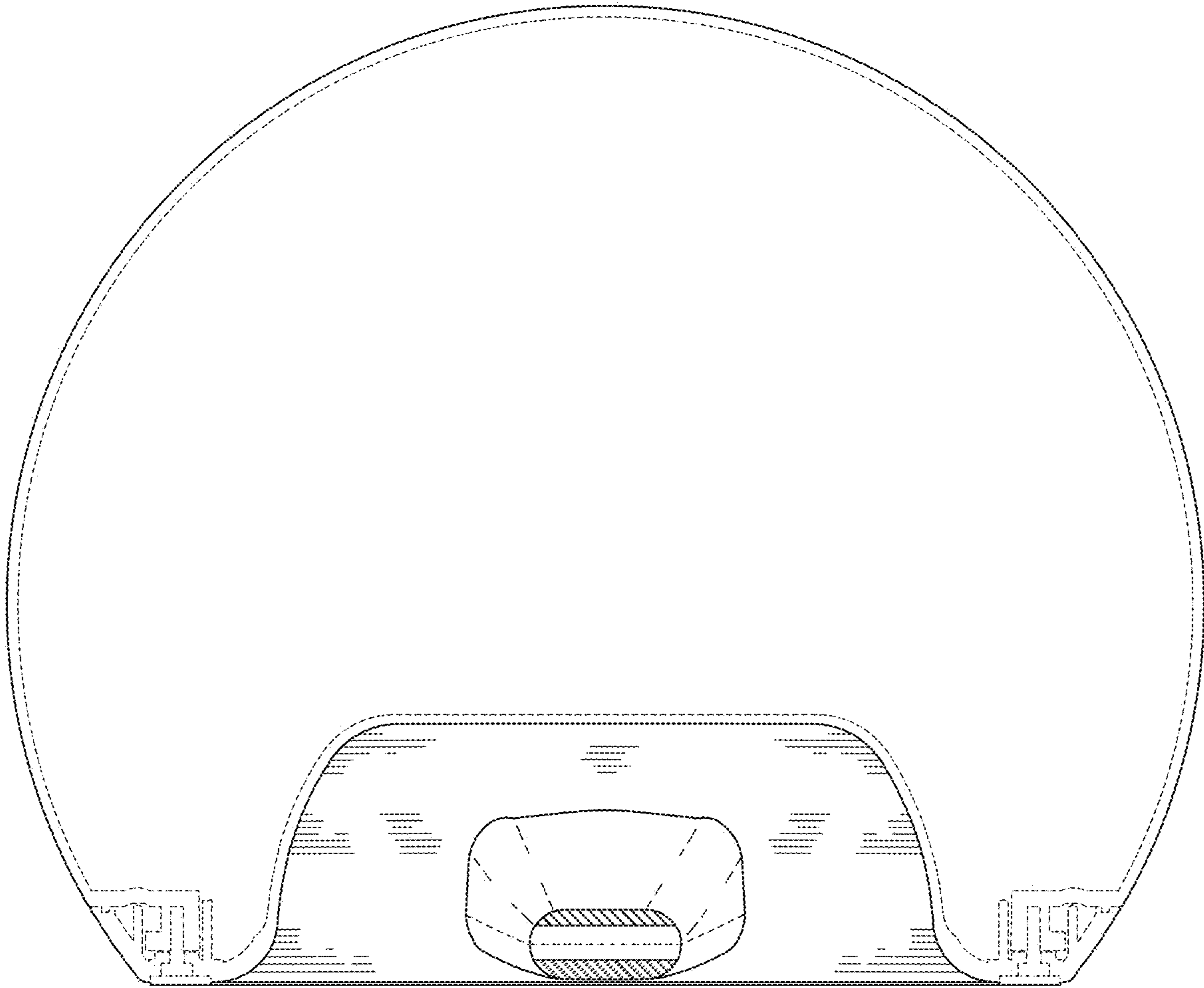

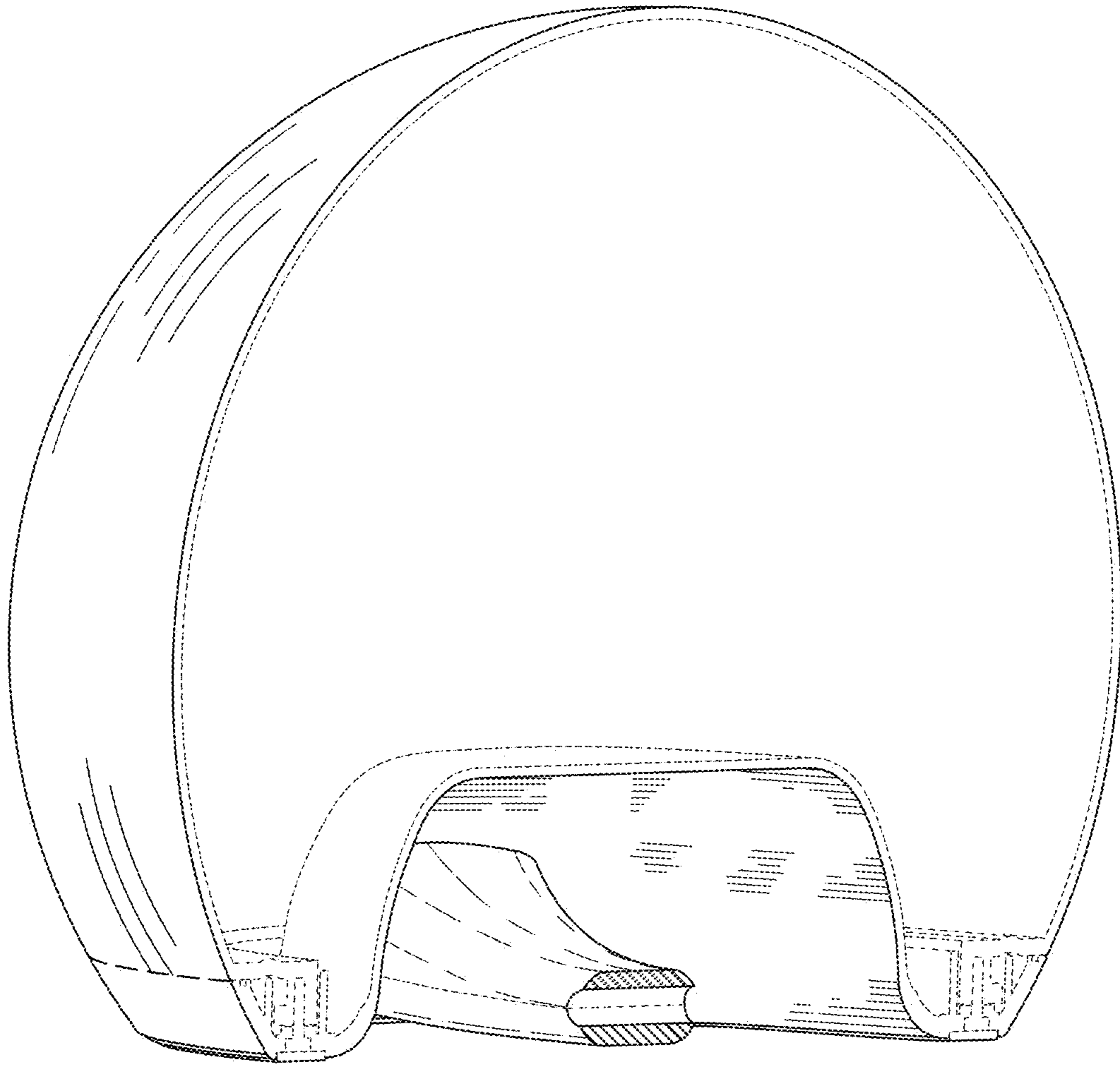
