The ornamental design for a projector lamp, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a projector lamp according to an embodiment of my design;

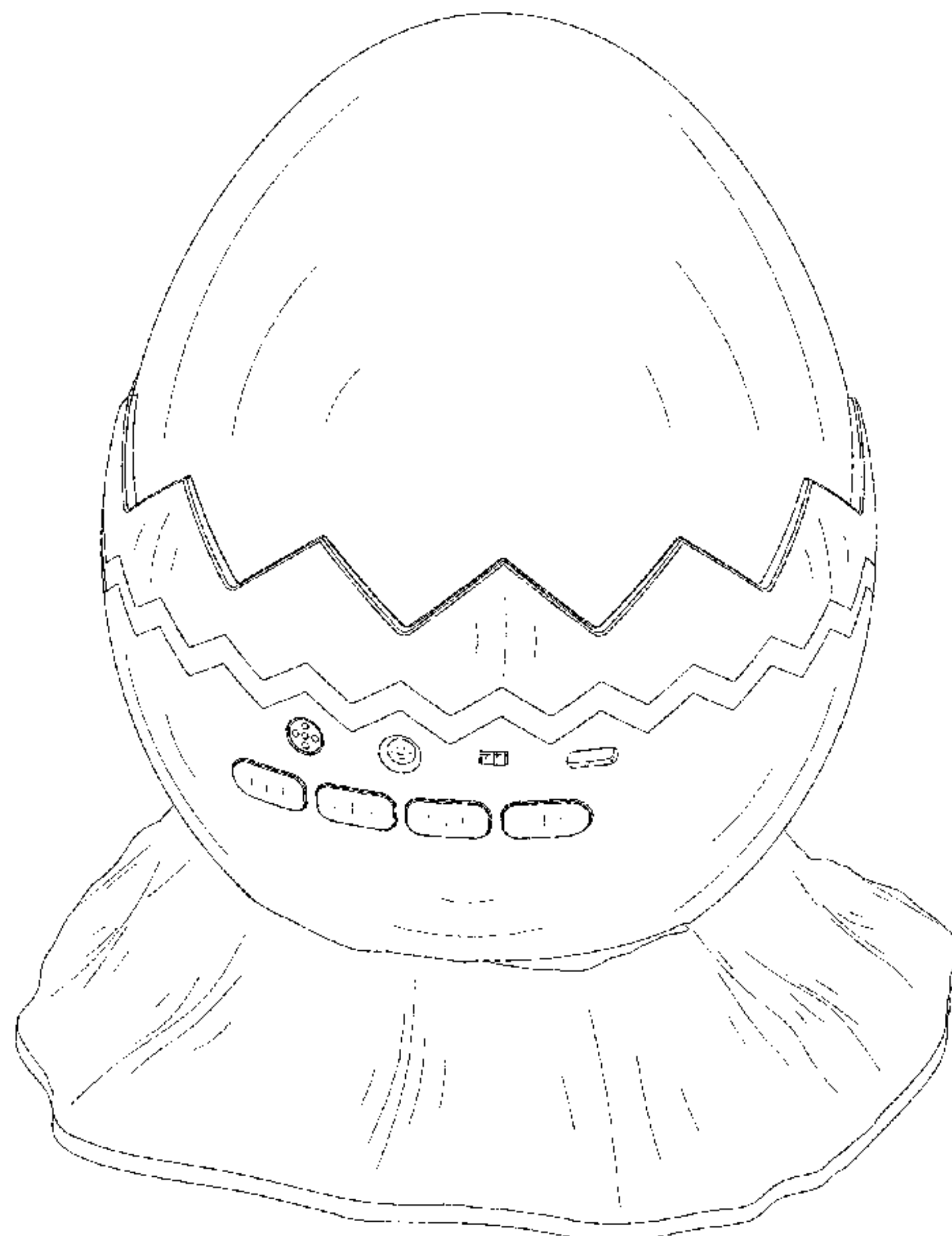

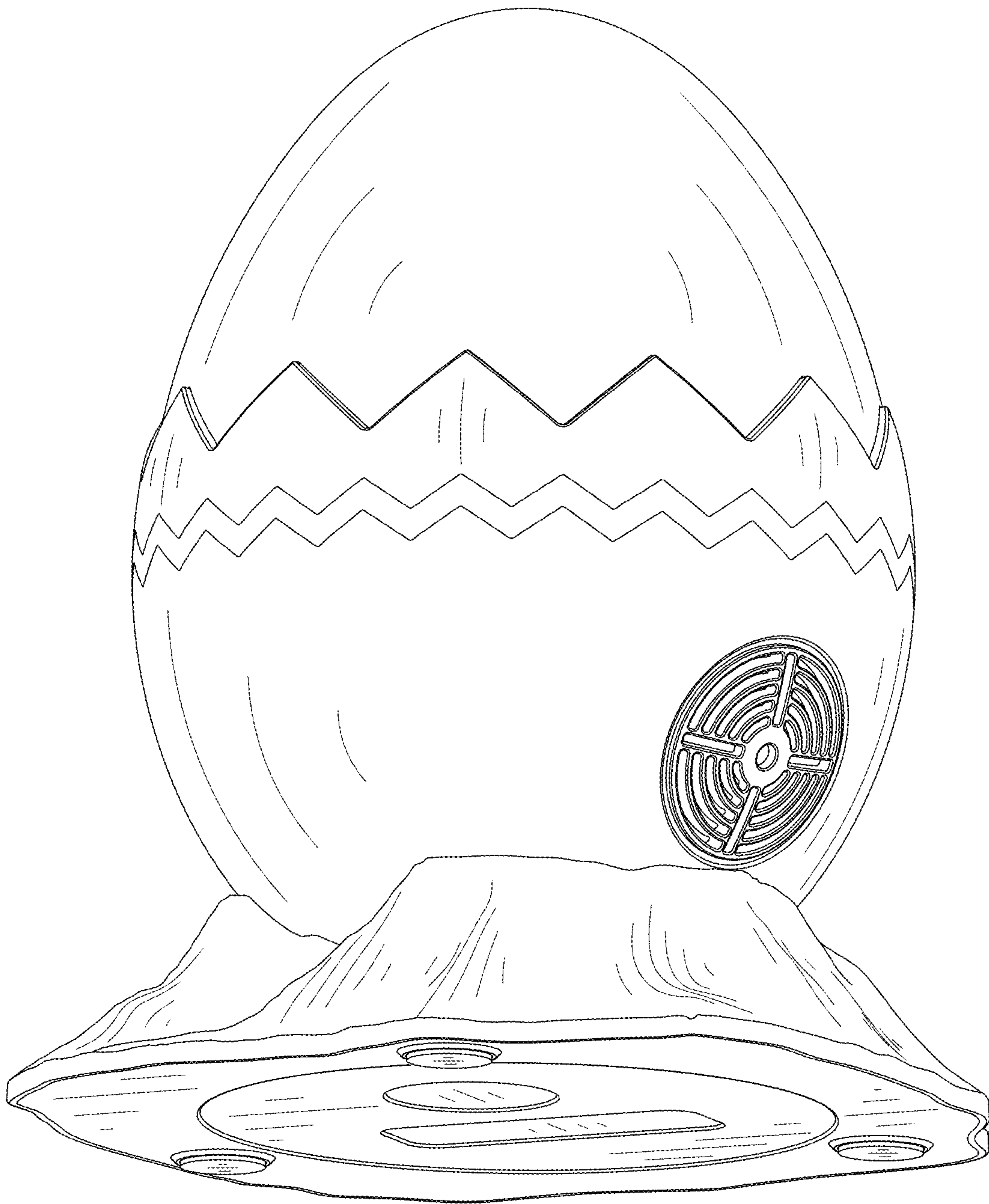

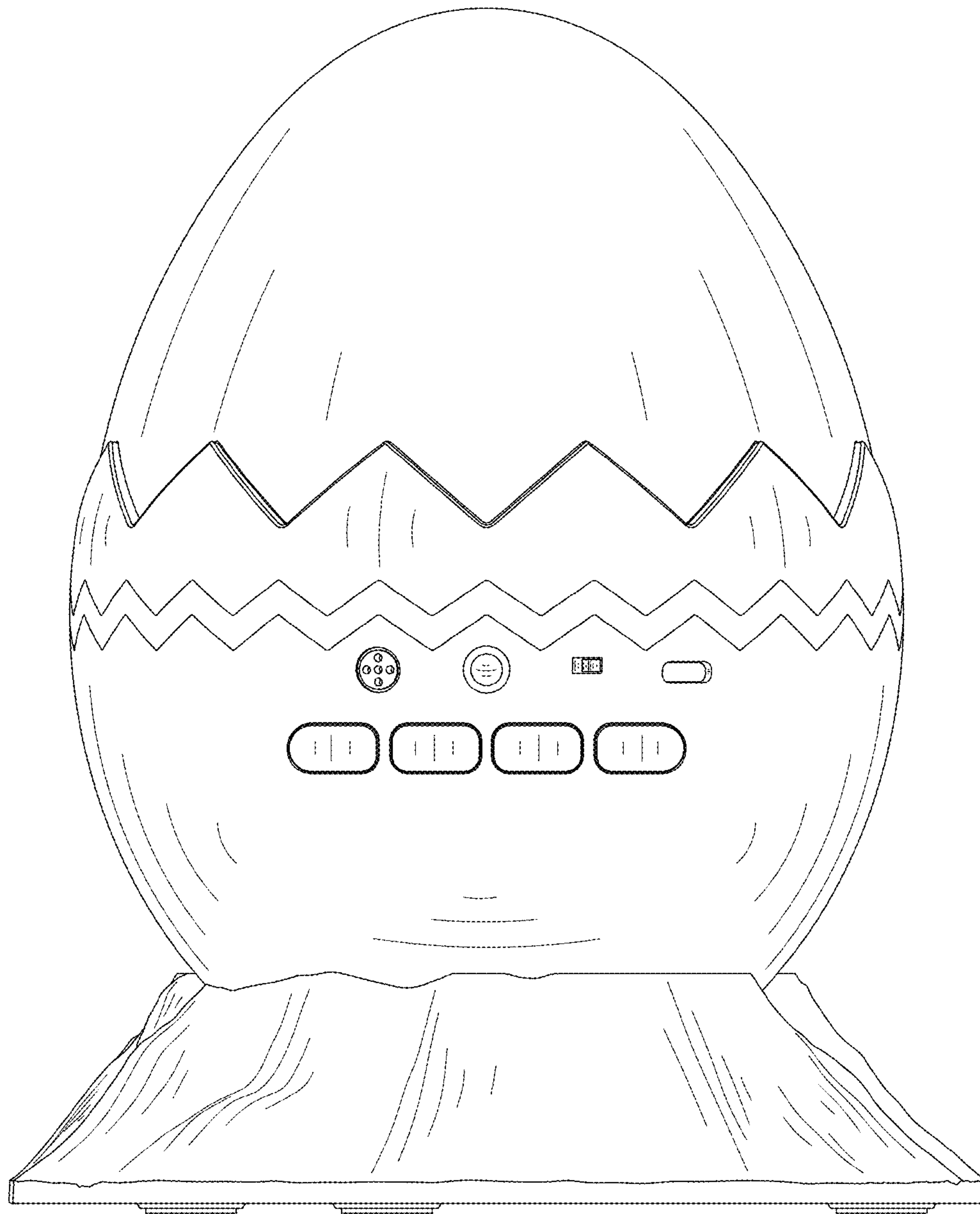

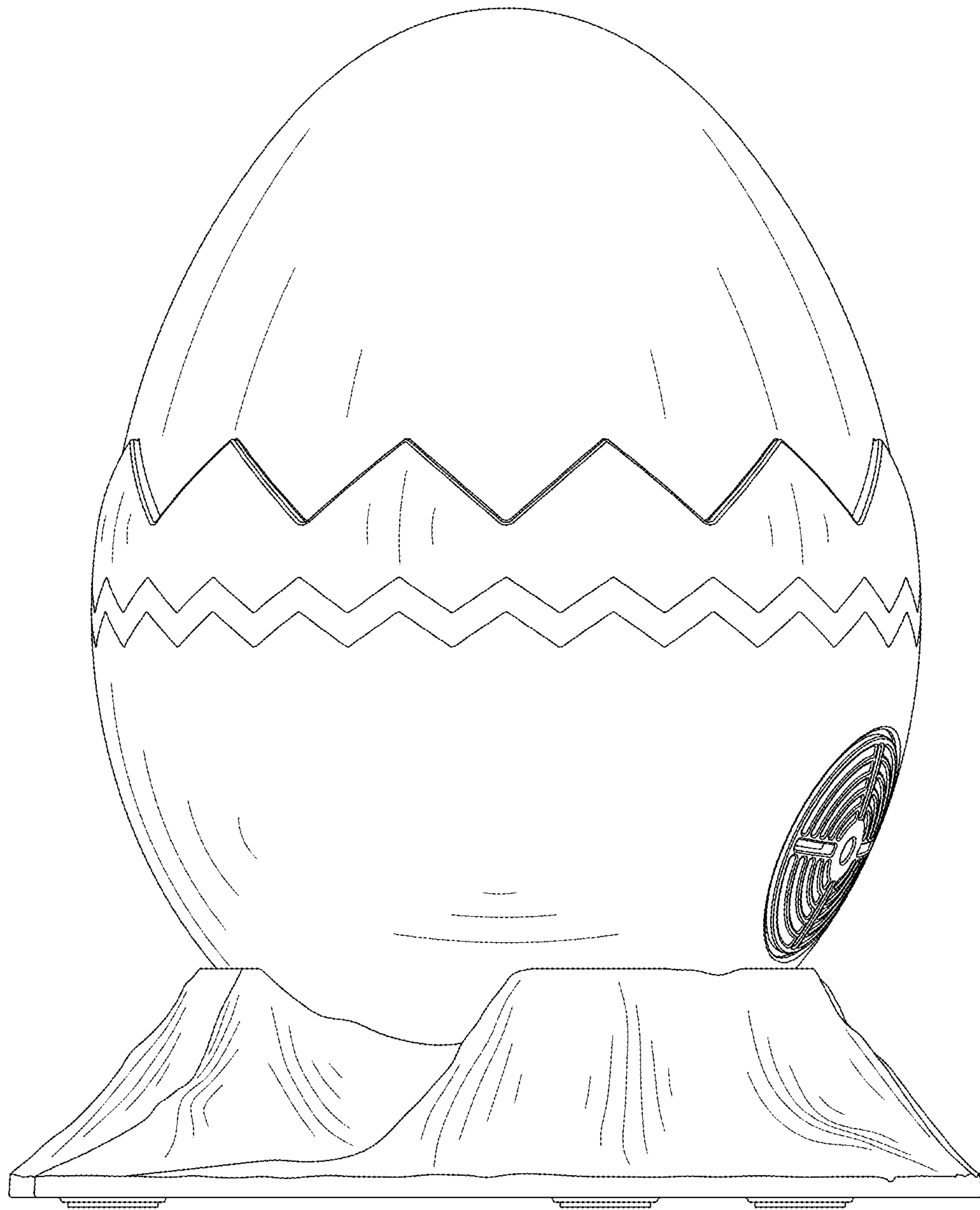

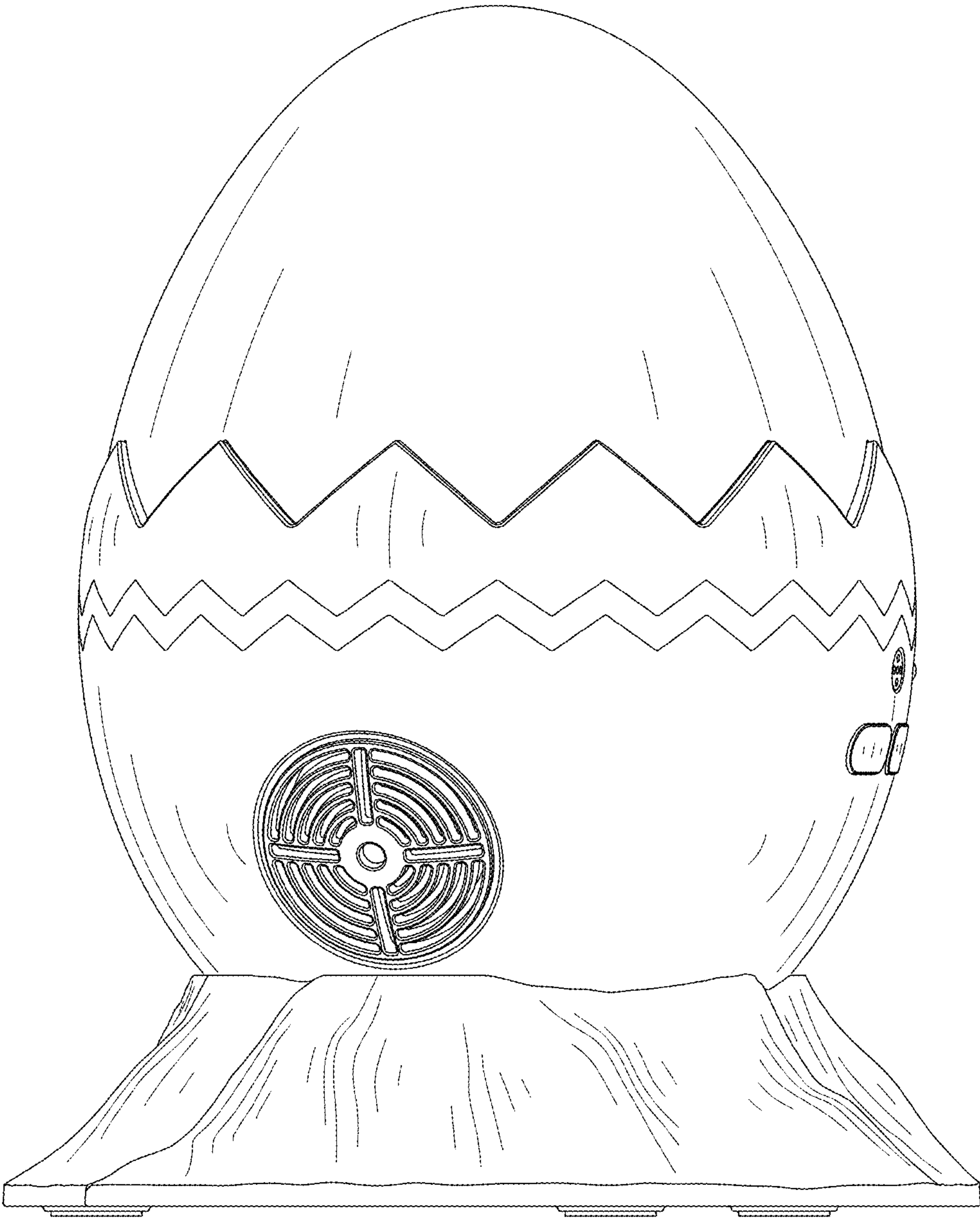

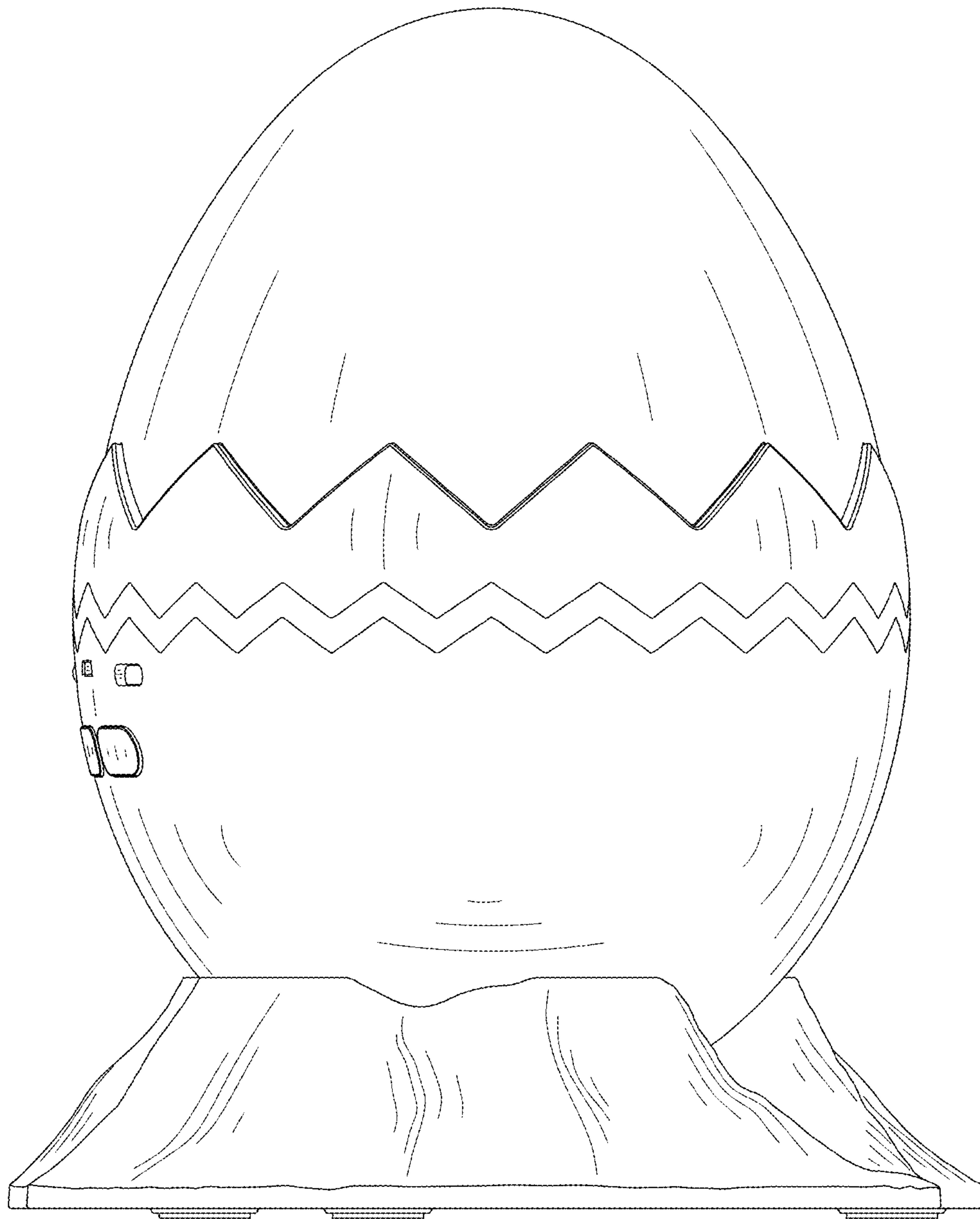

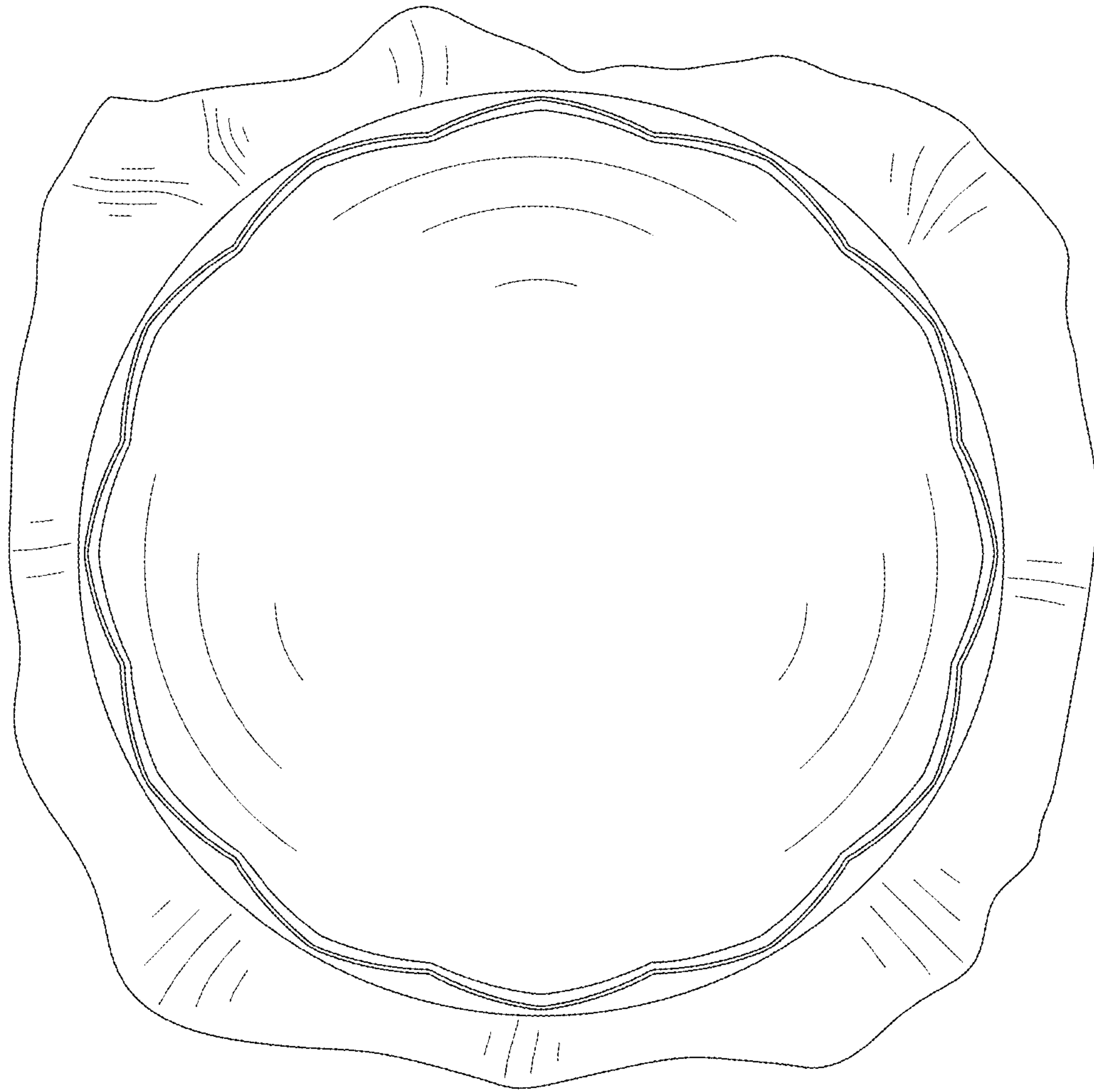

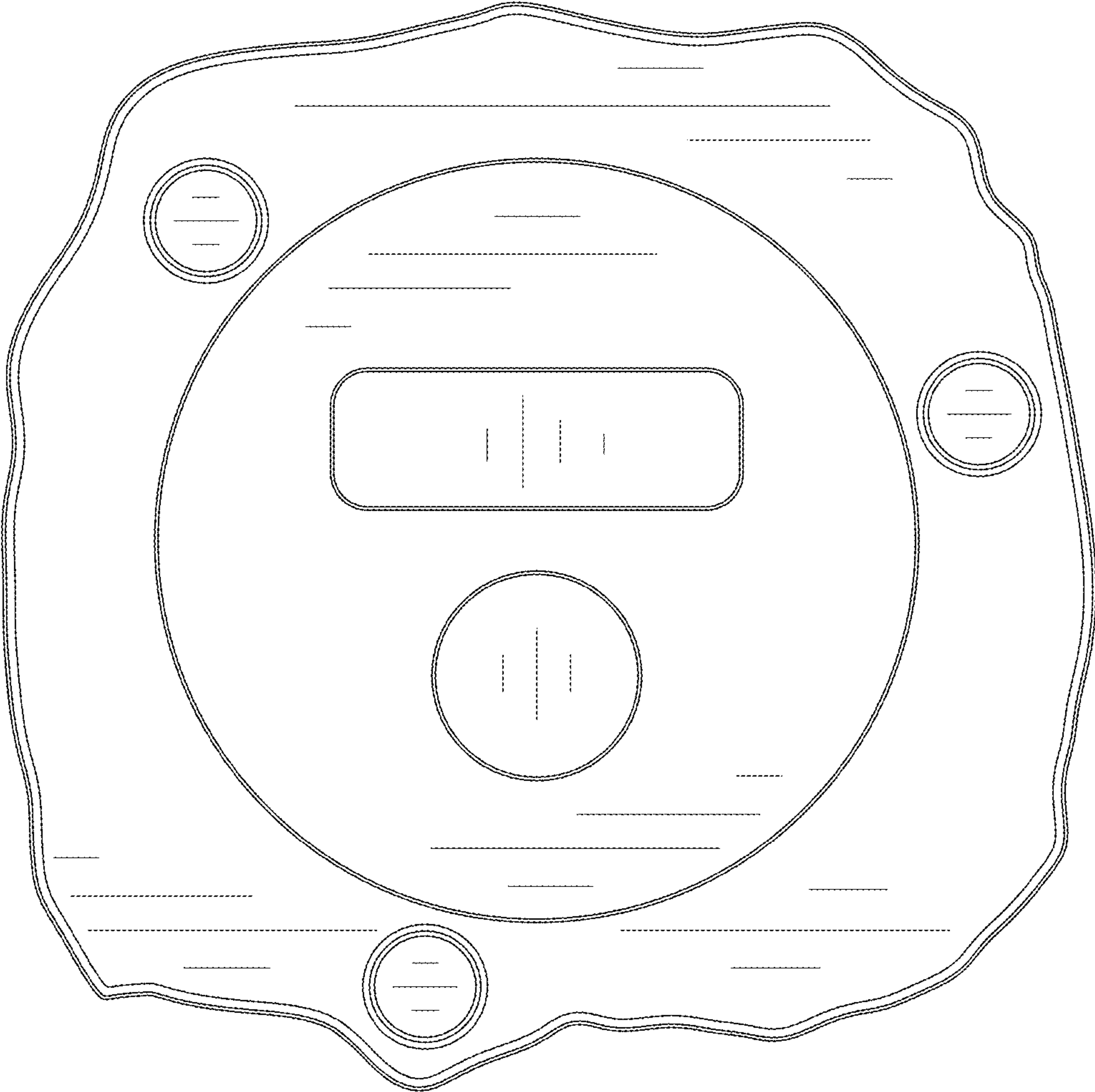

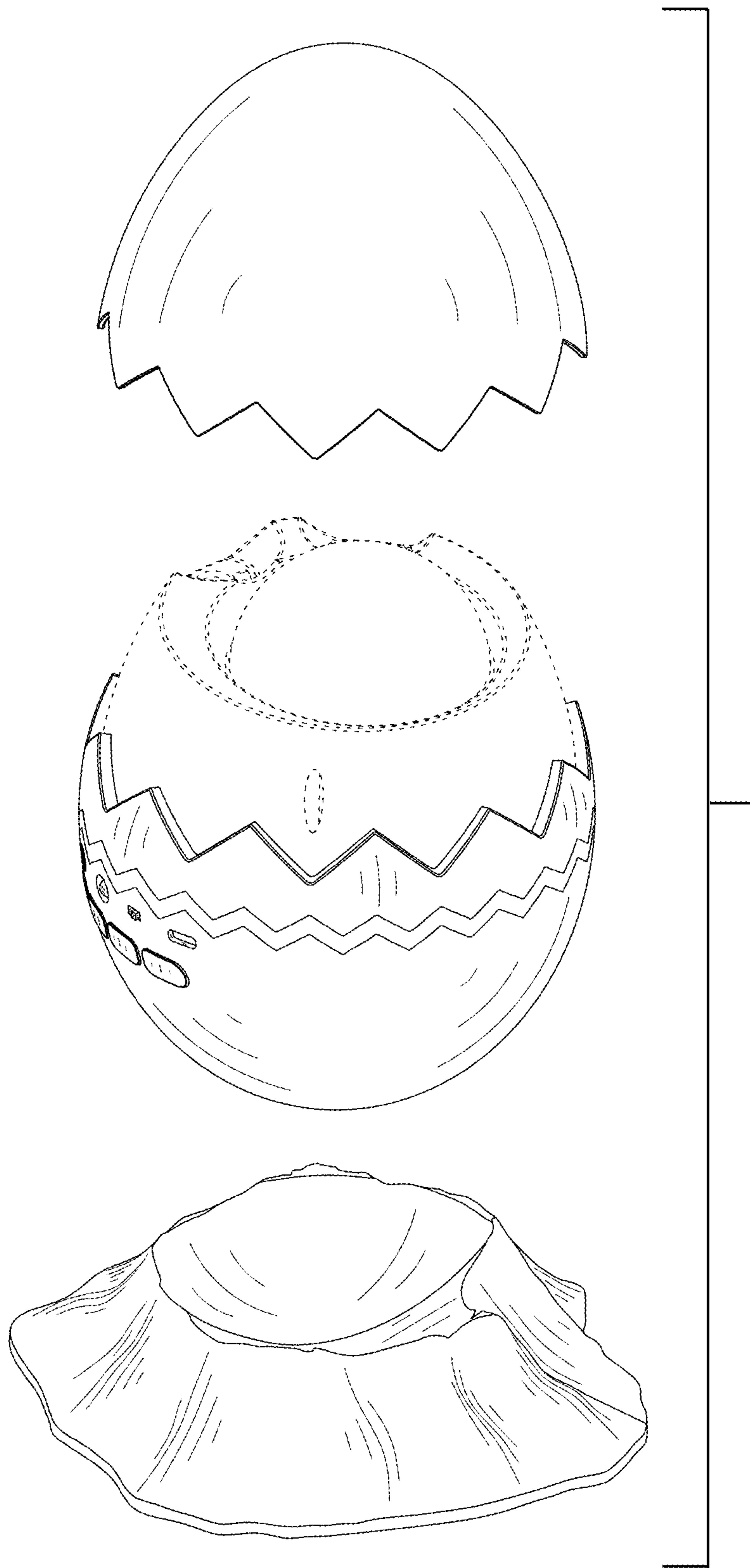

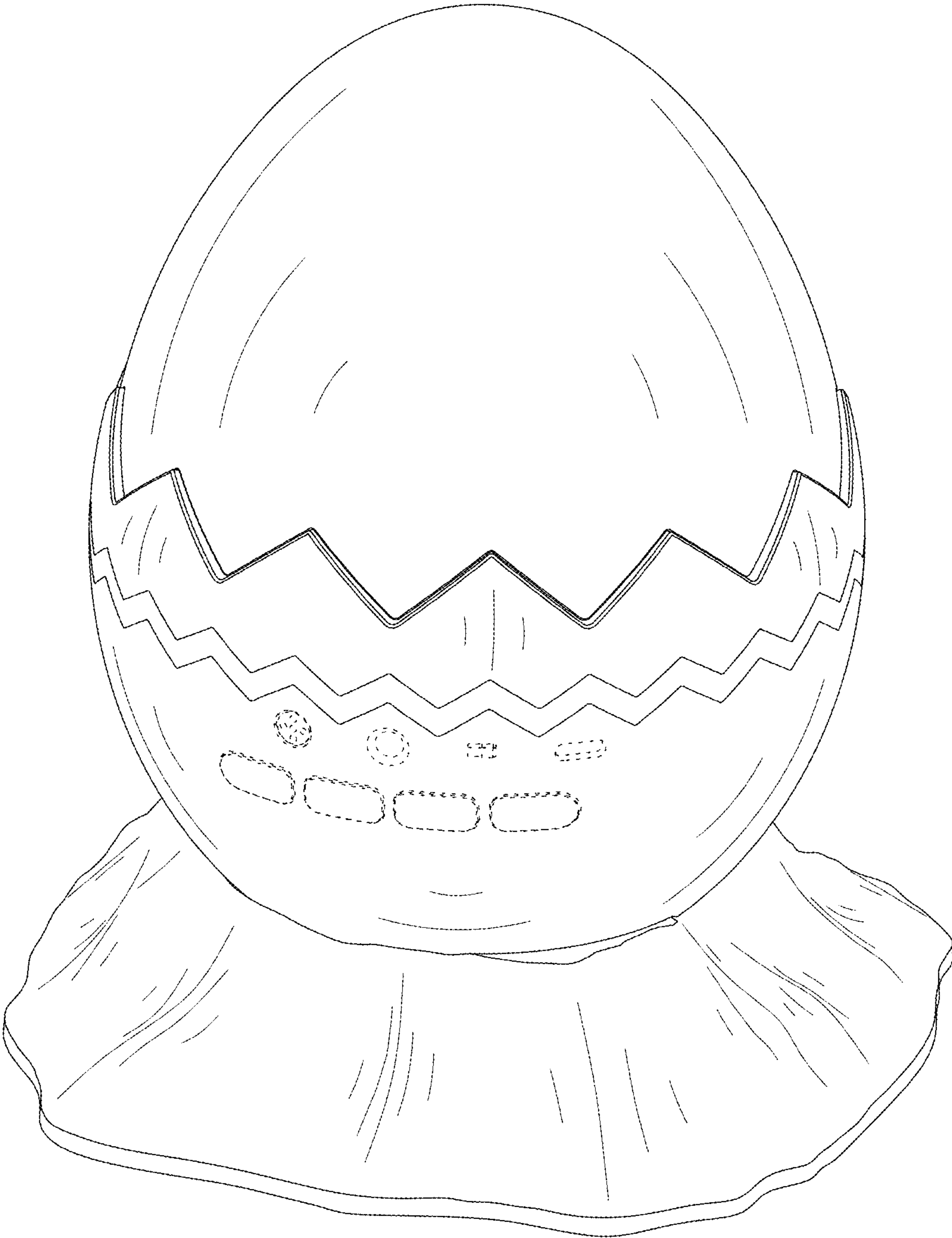

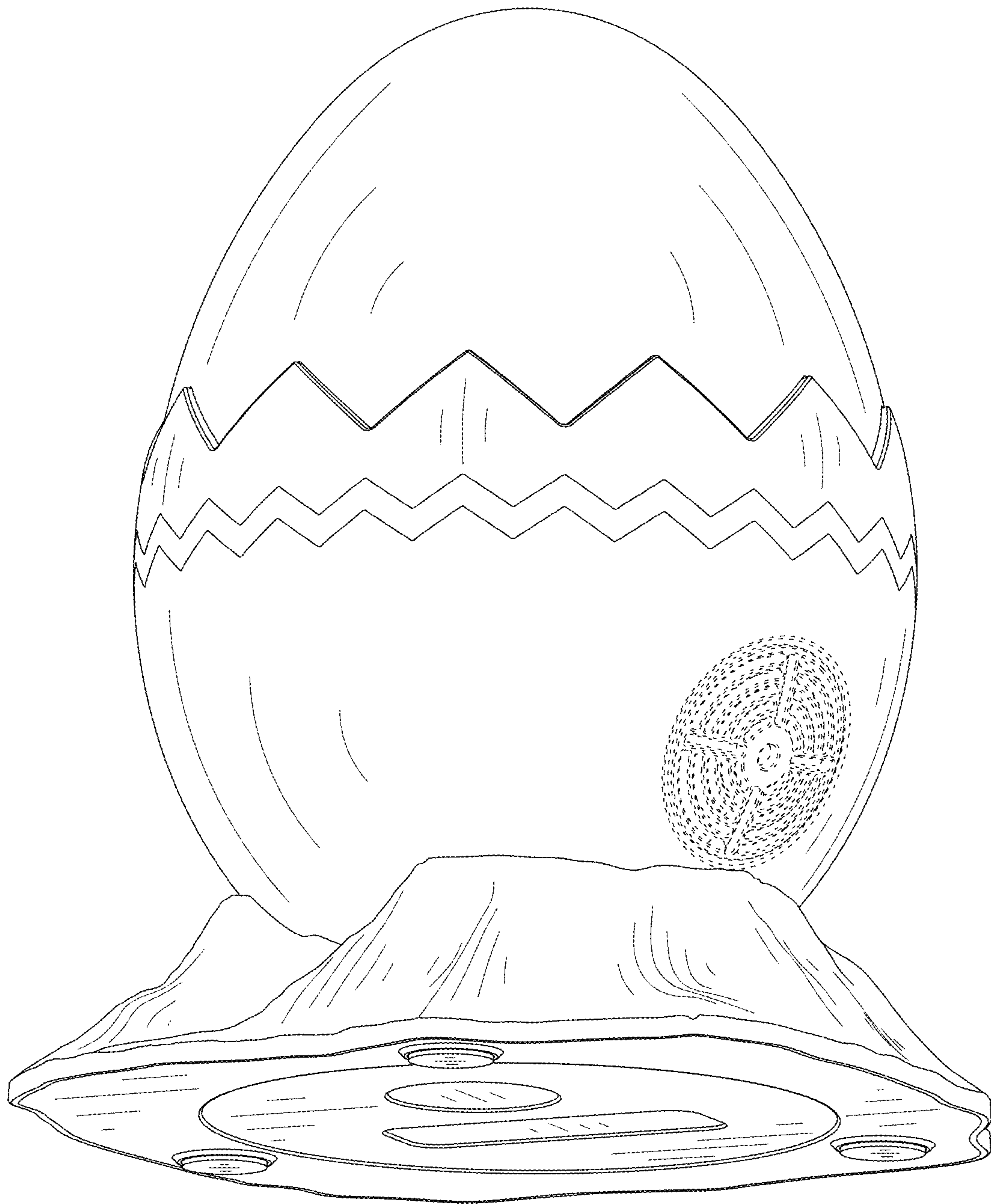

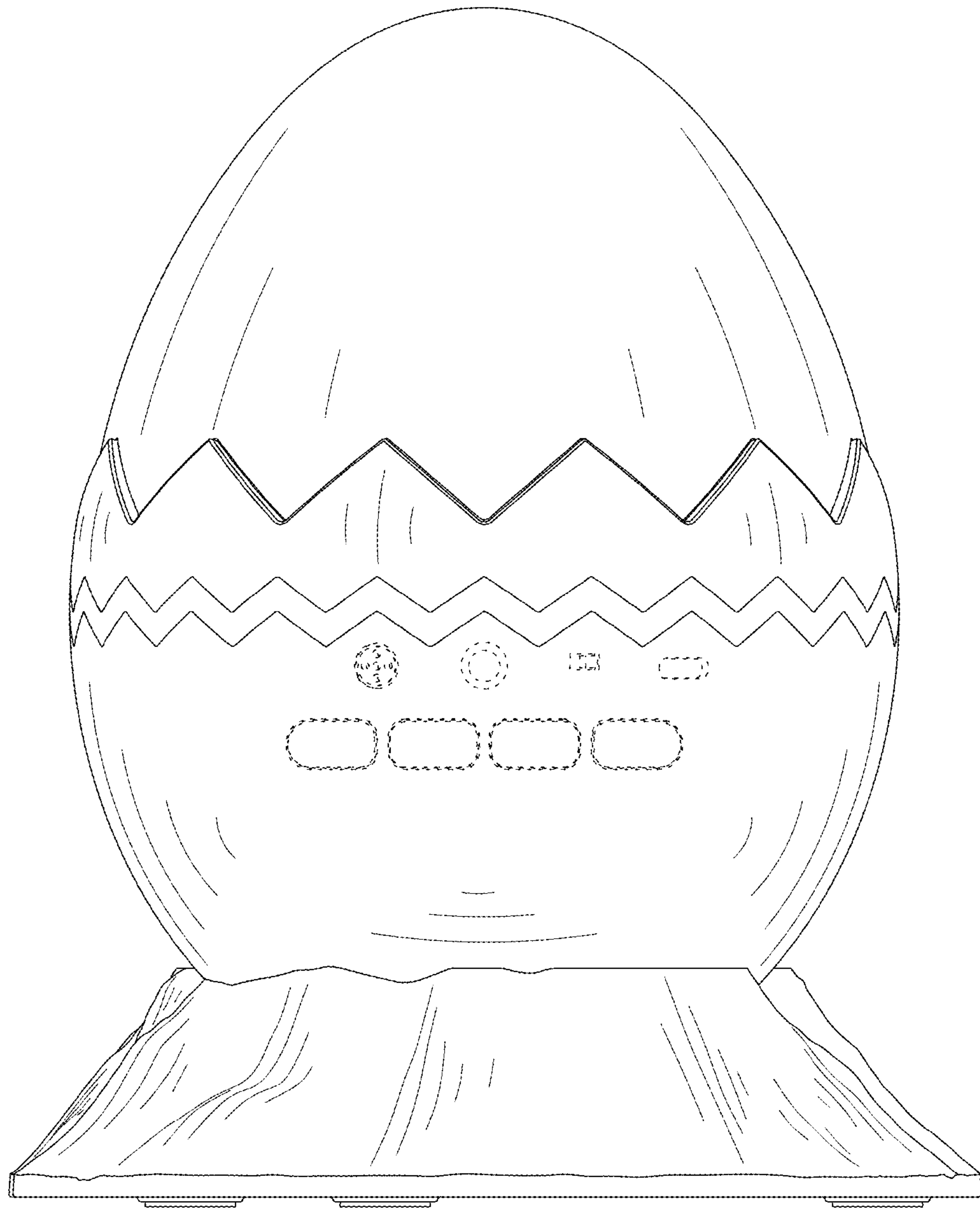

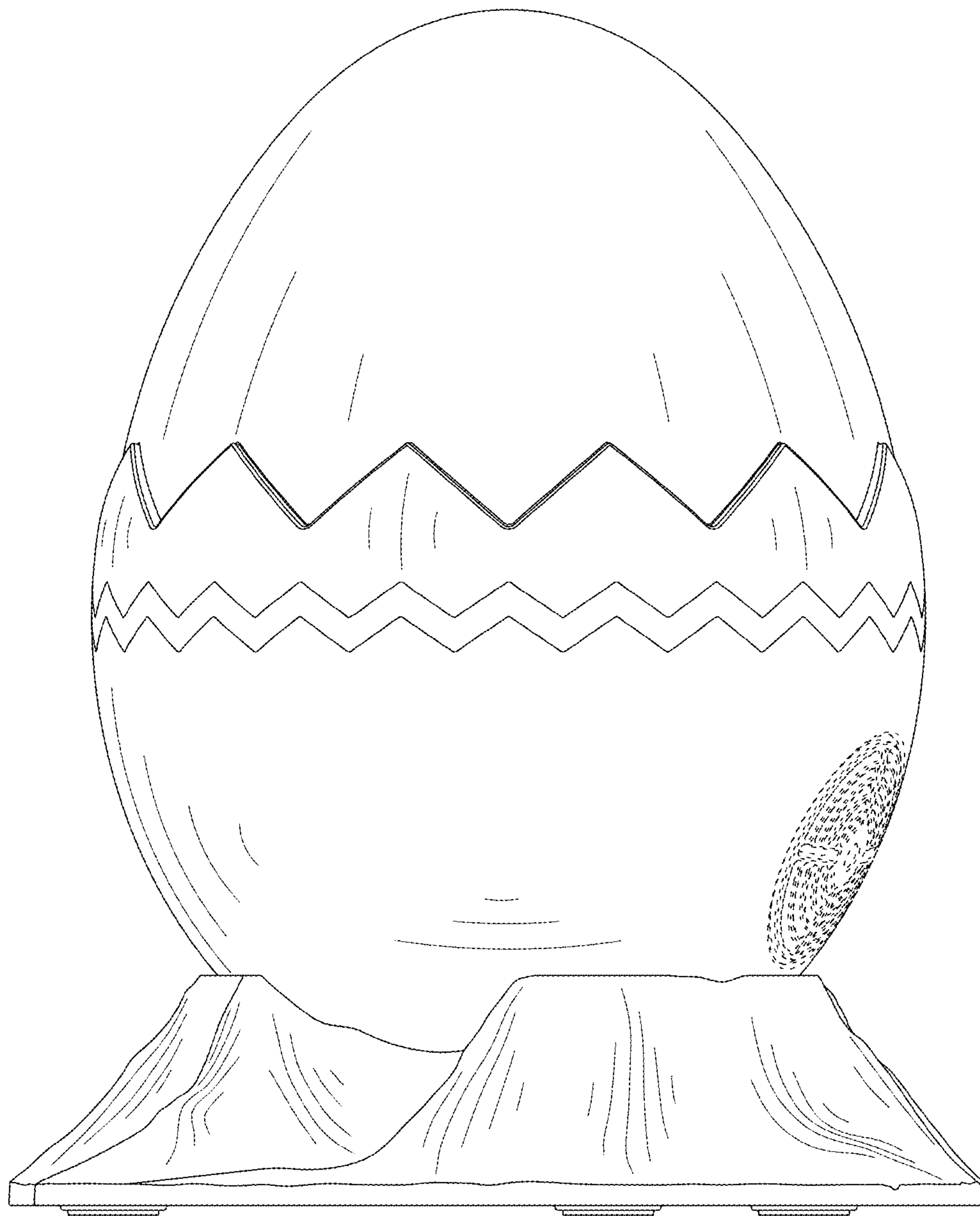

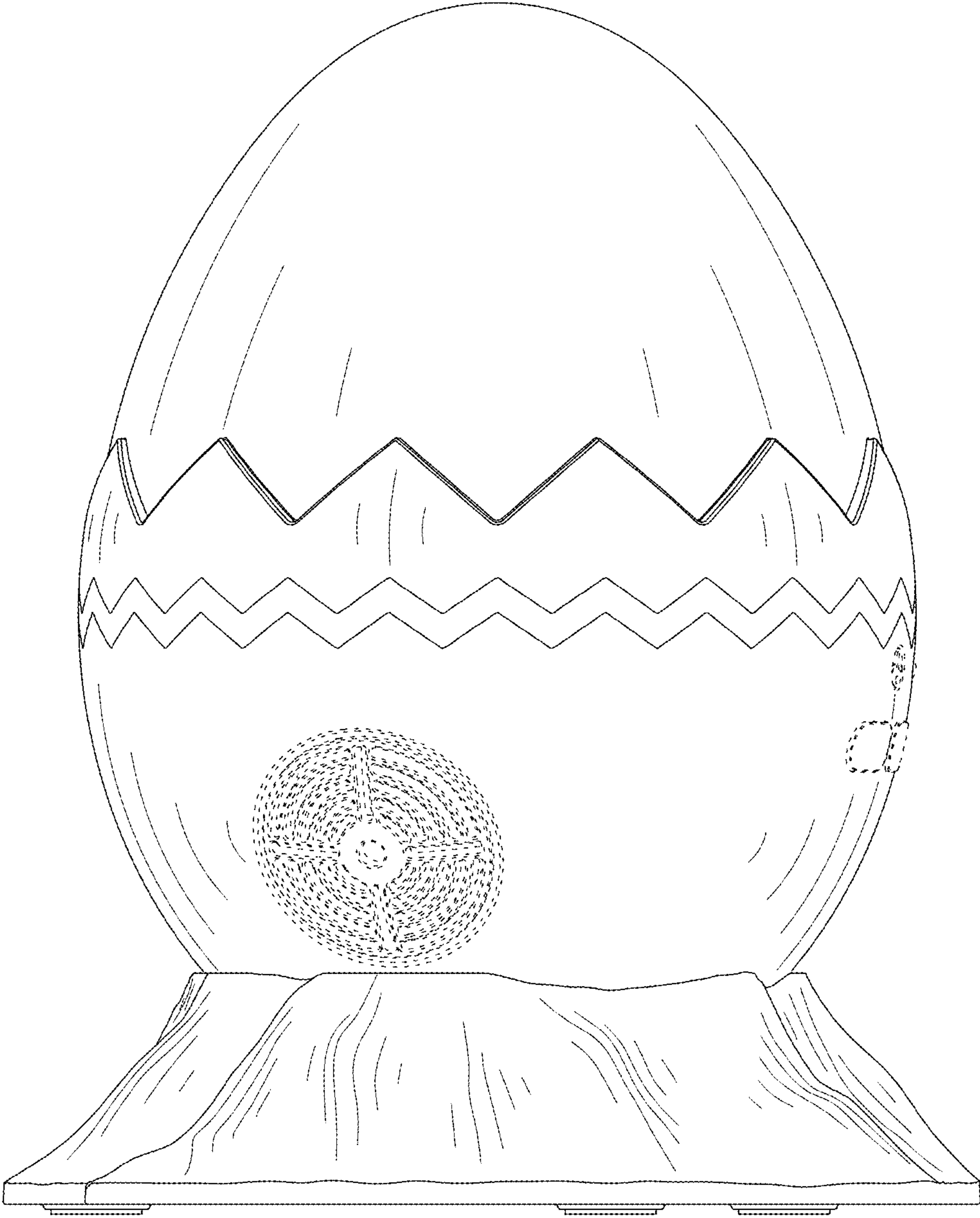

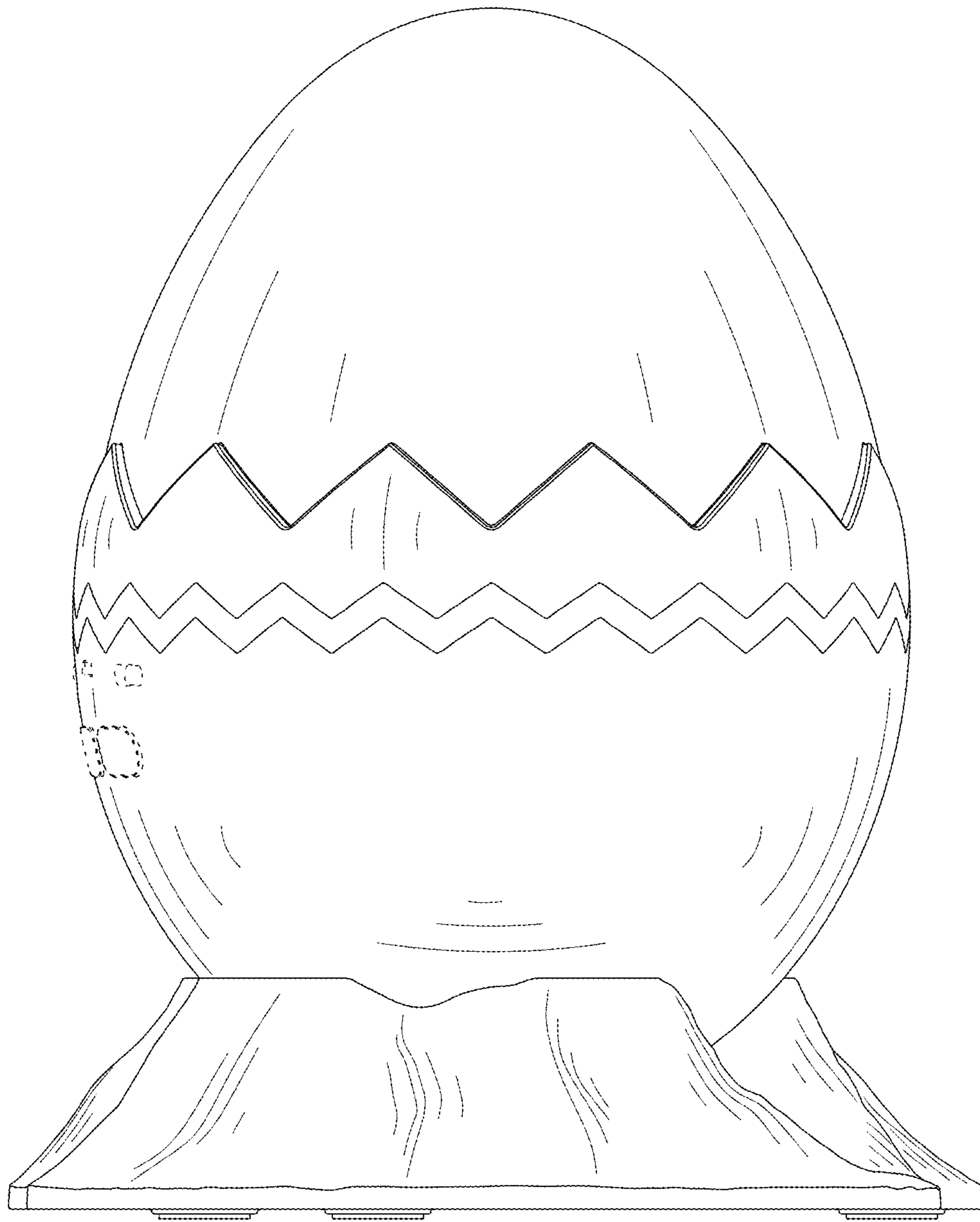

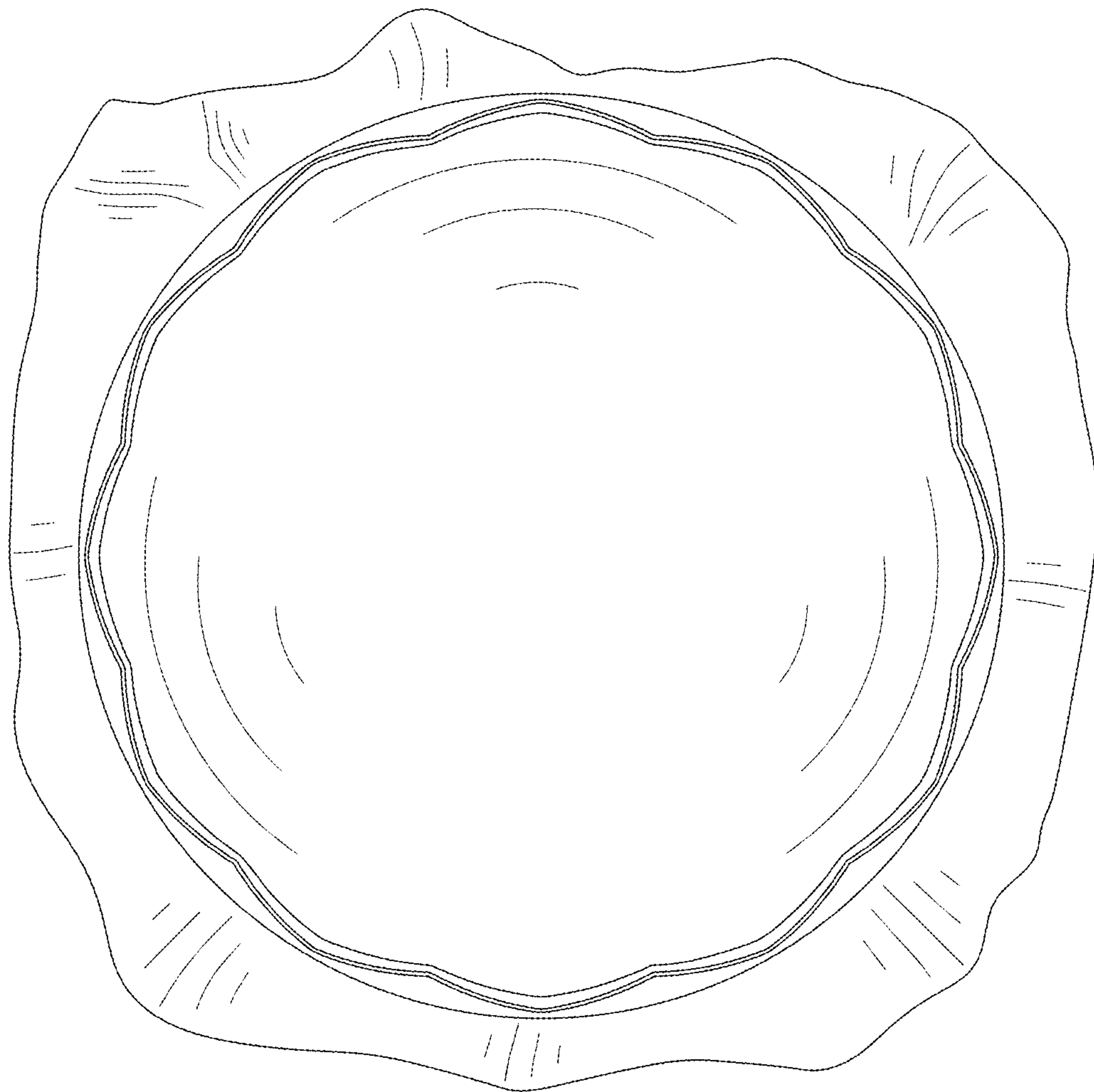

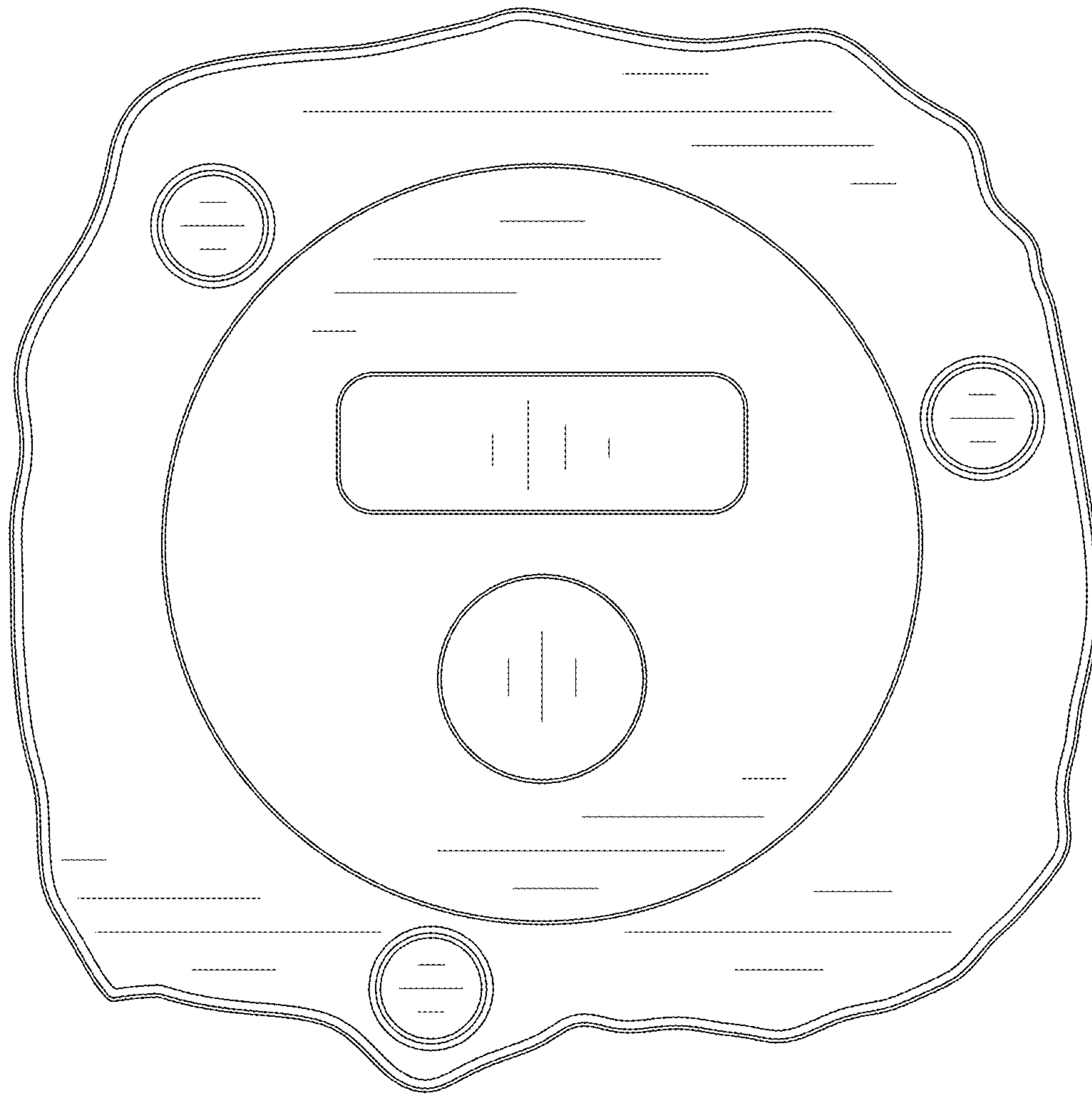

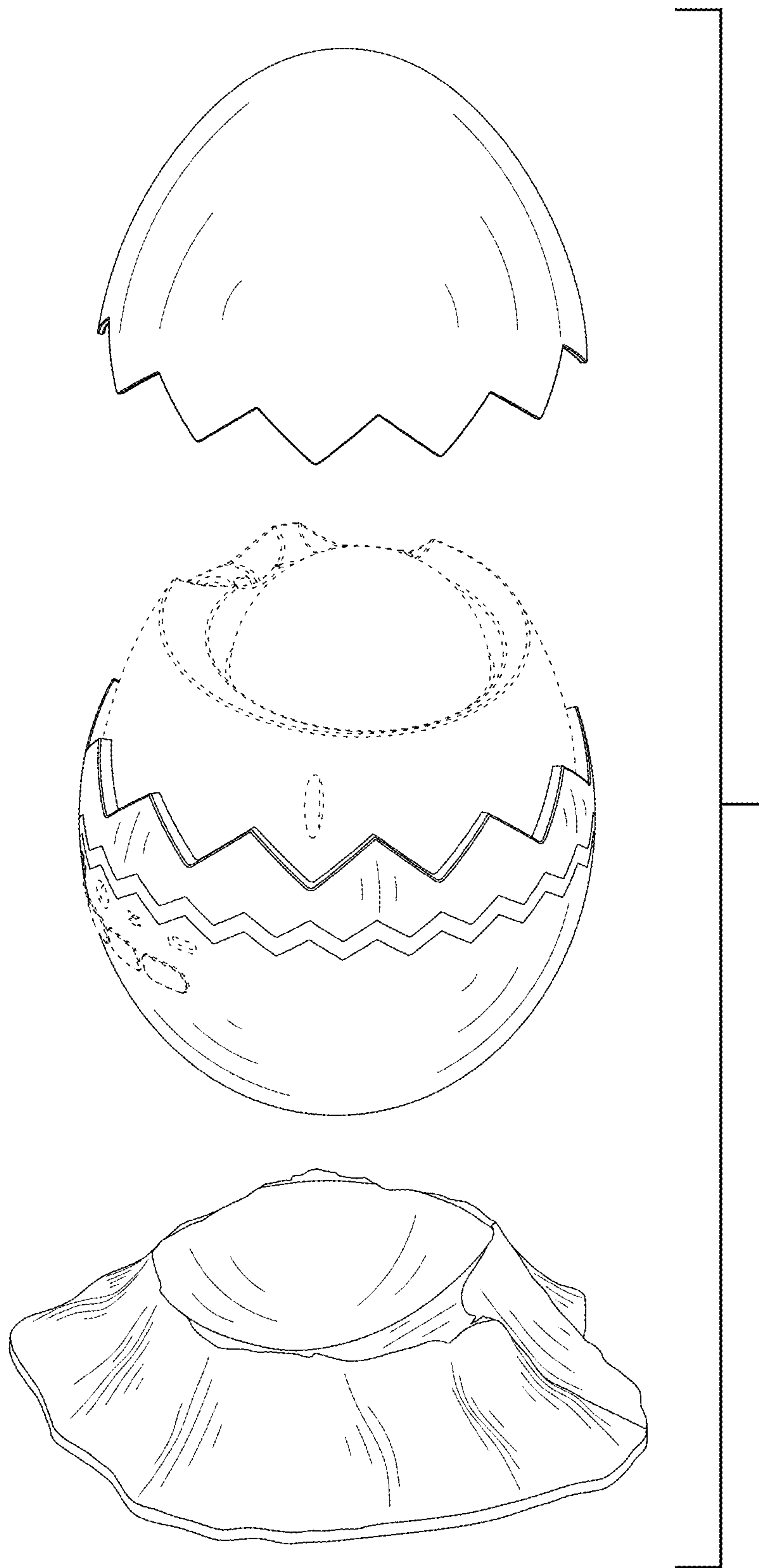
