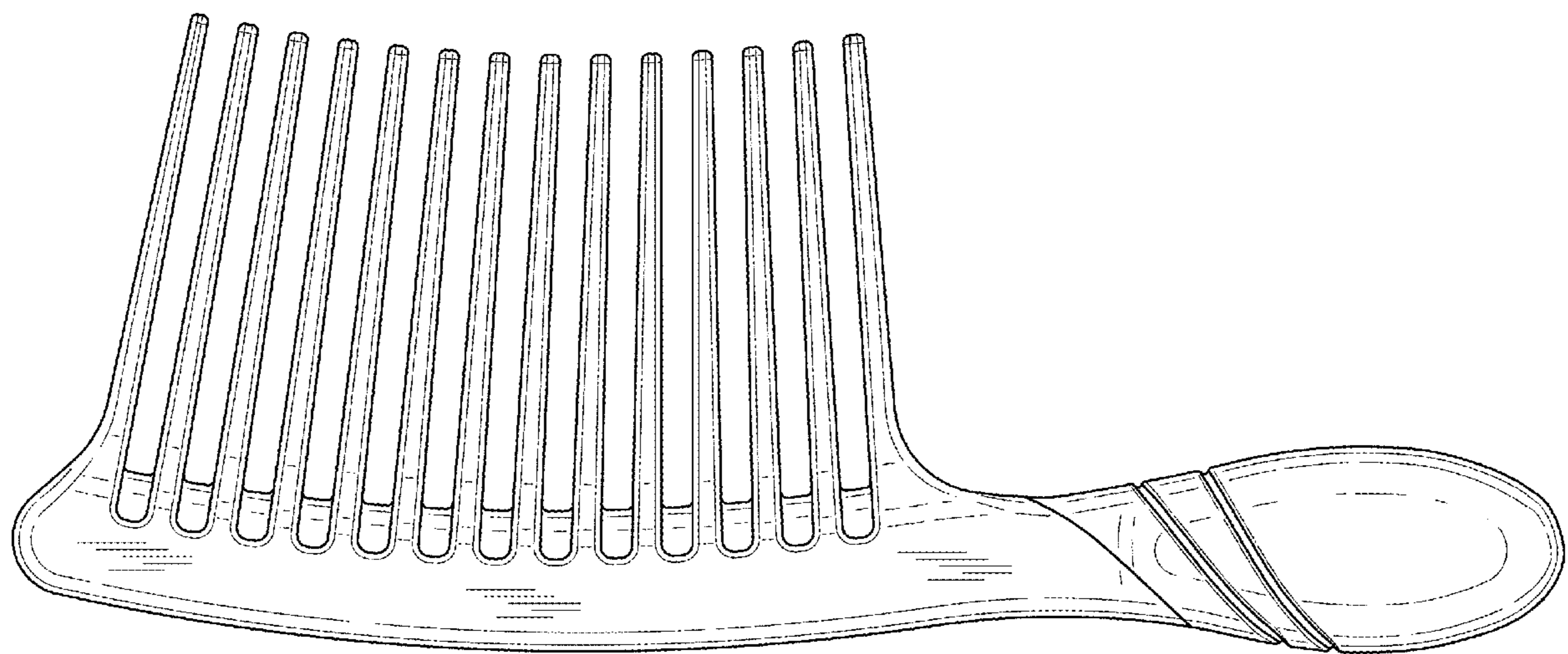
The ornamental design for a comb, as shown and described.

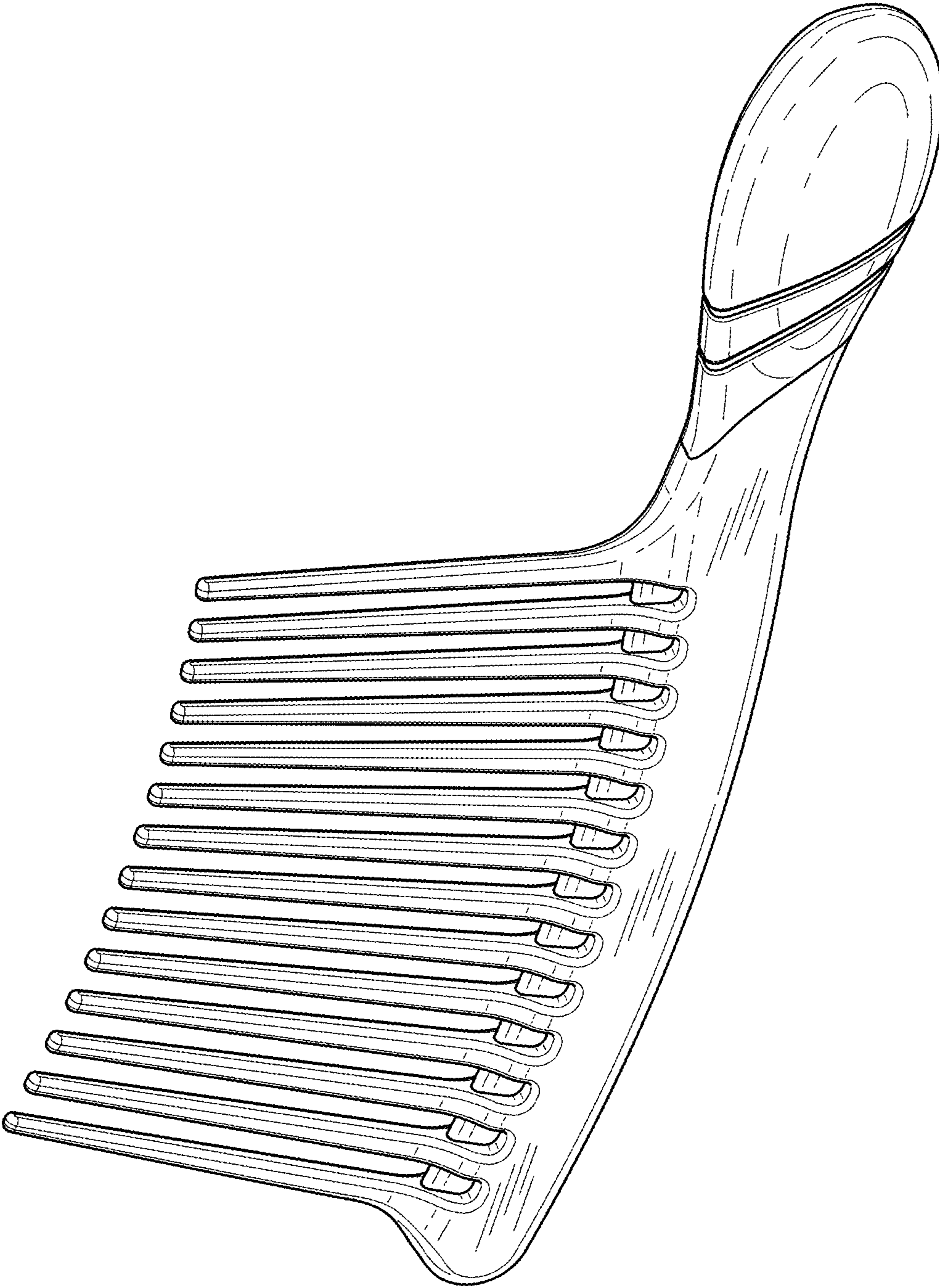

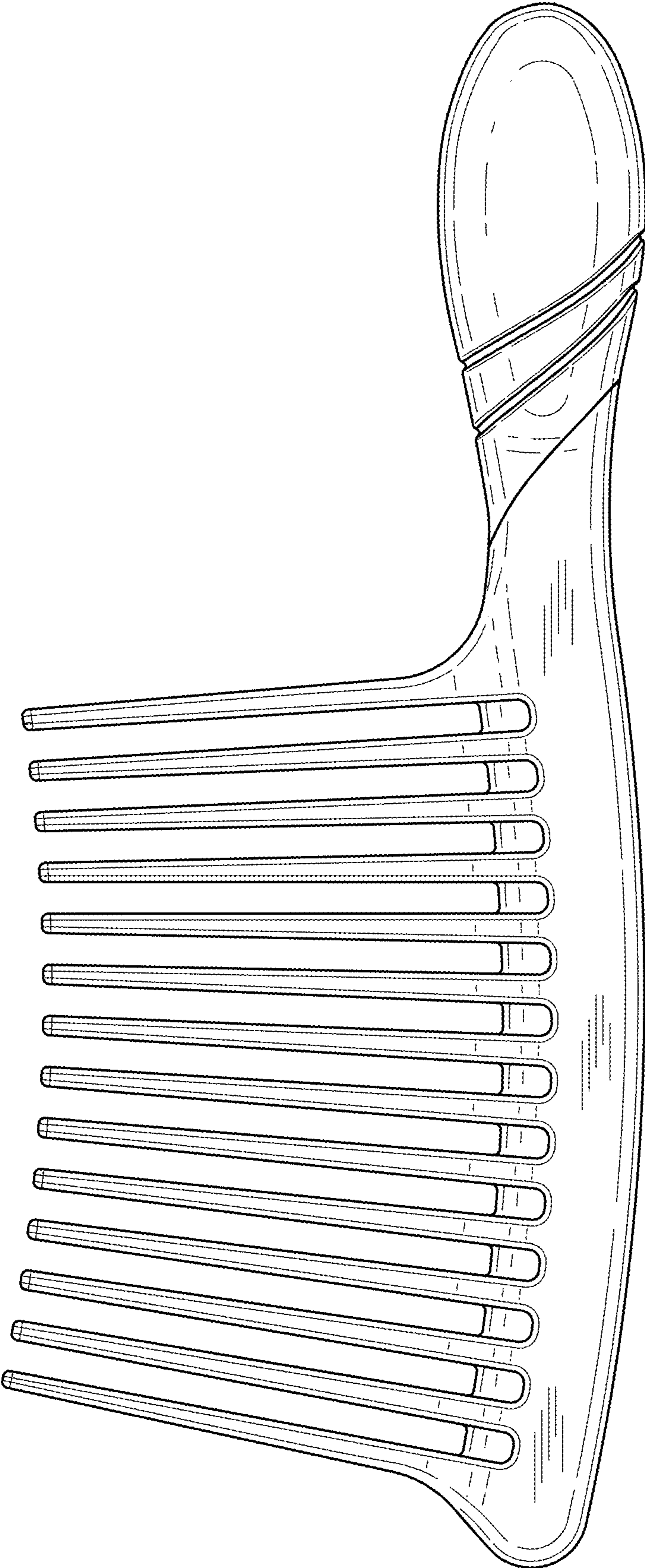

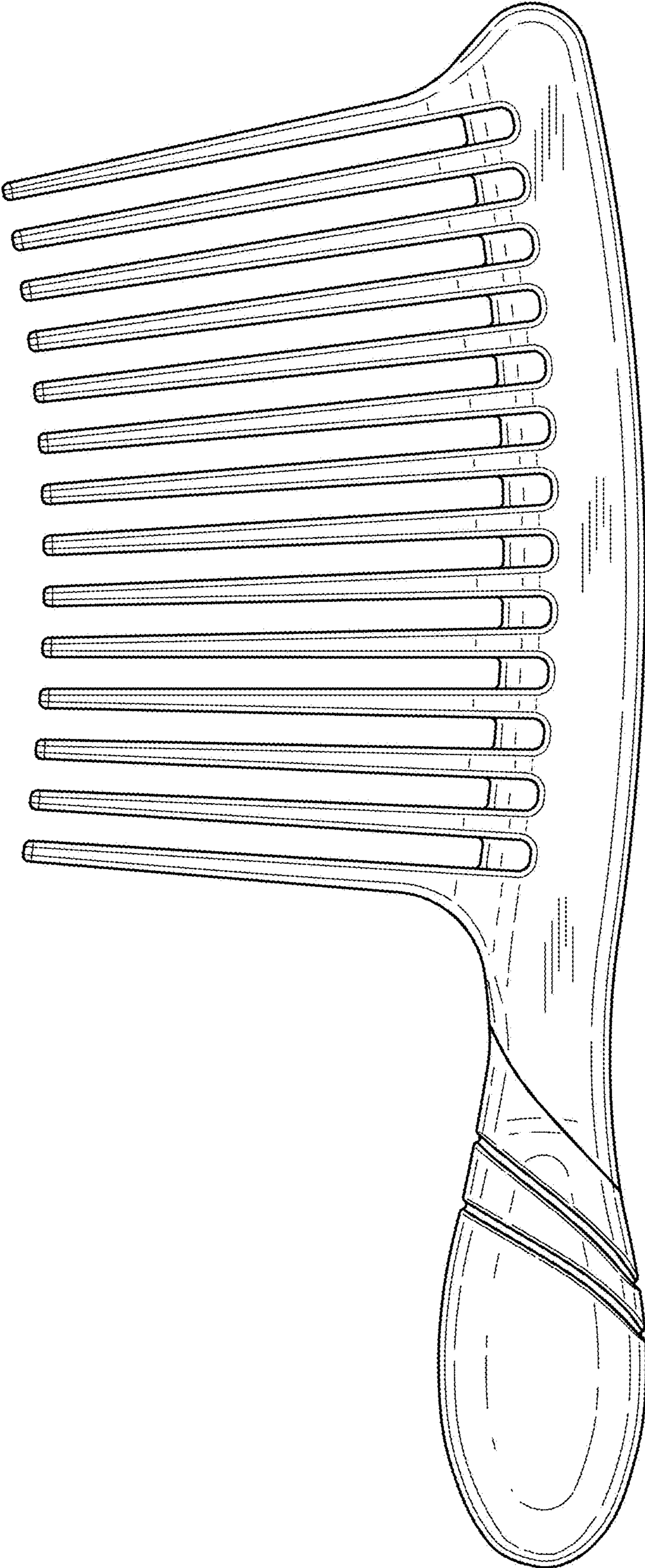

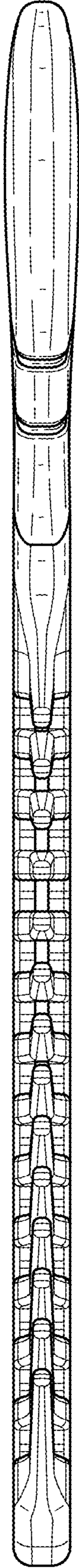

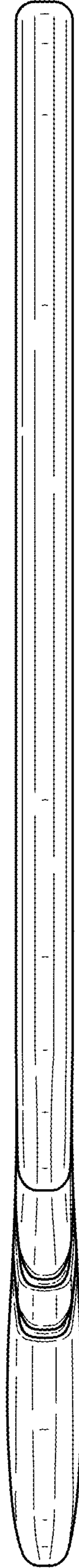

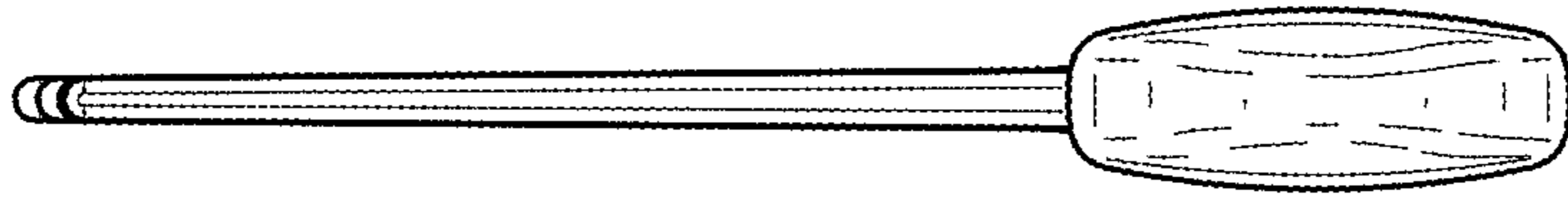

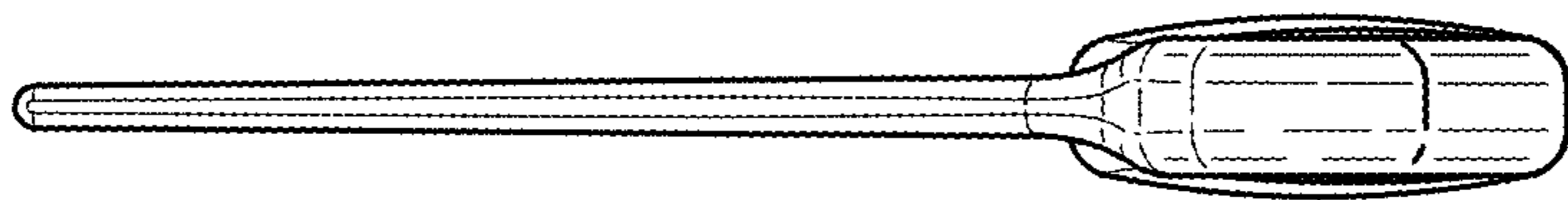
