The broken away symbols in the drawings indicate the appearance of any portion of the article between the brake lines forms no part of the claimed design.

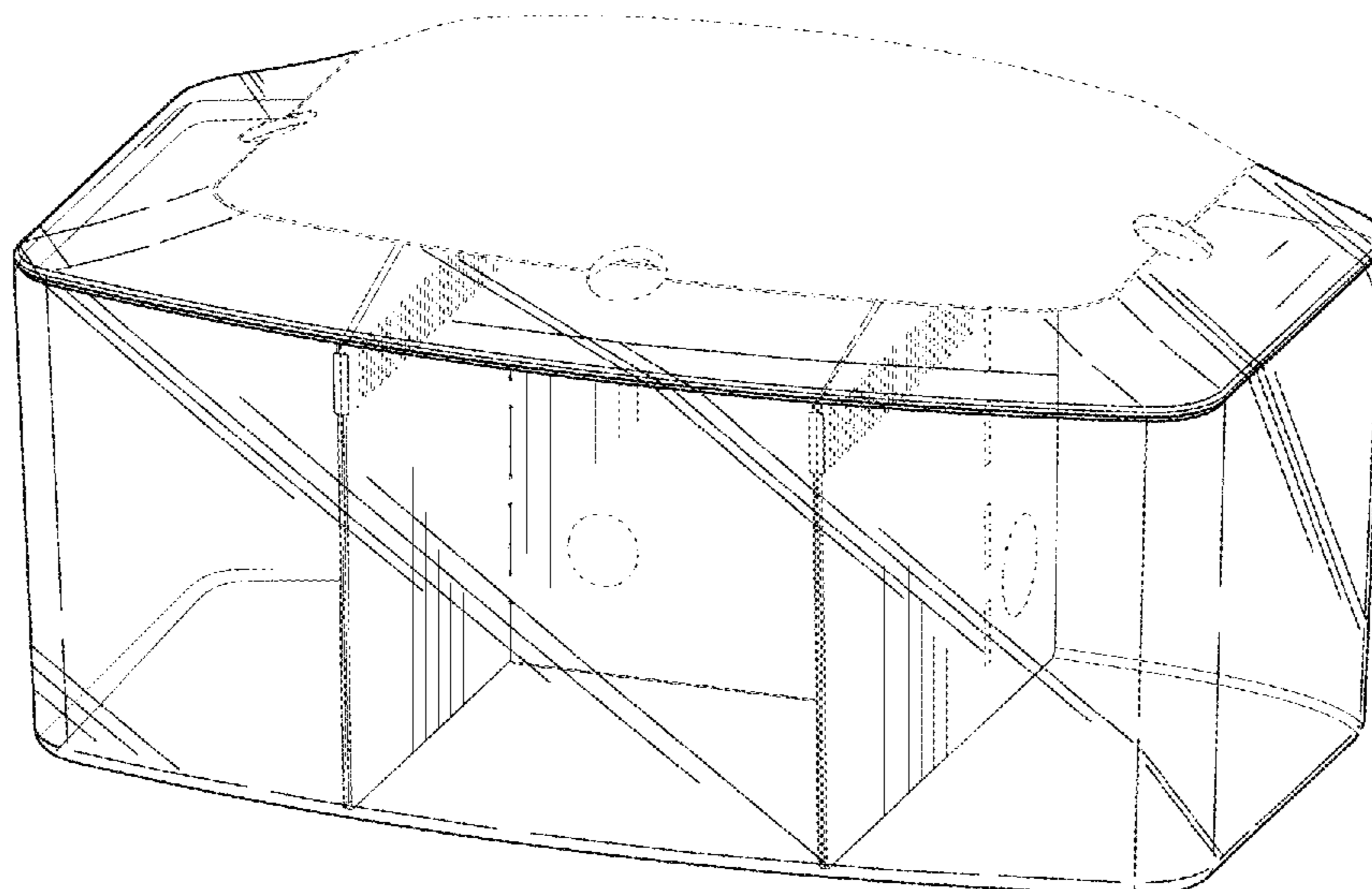

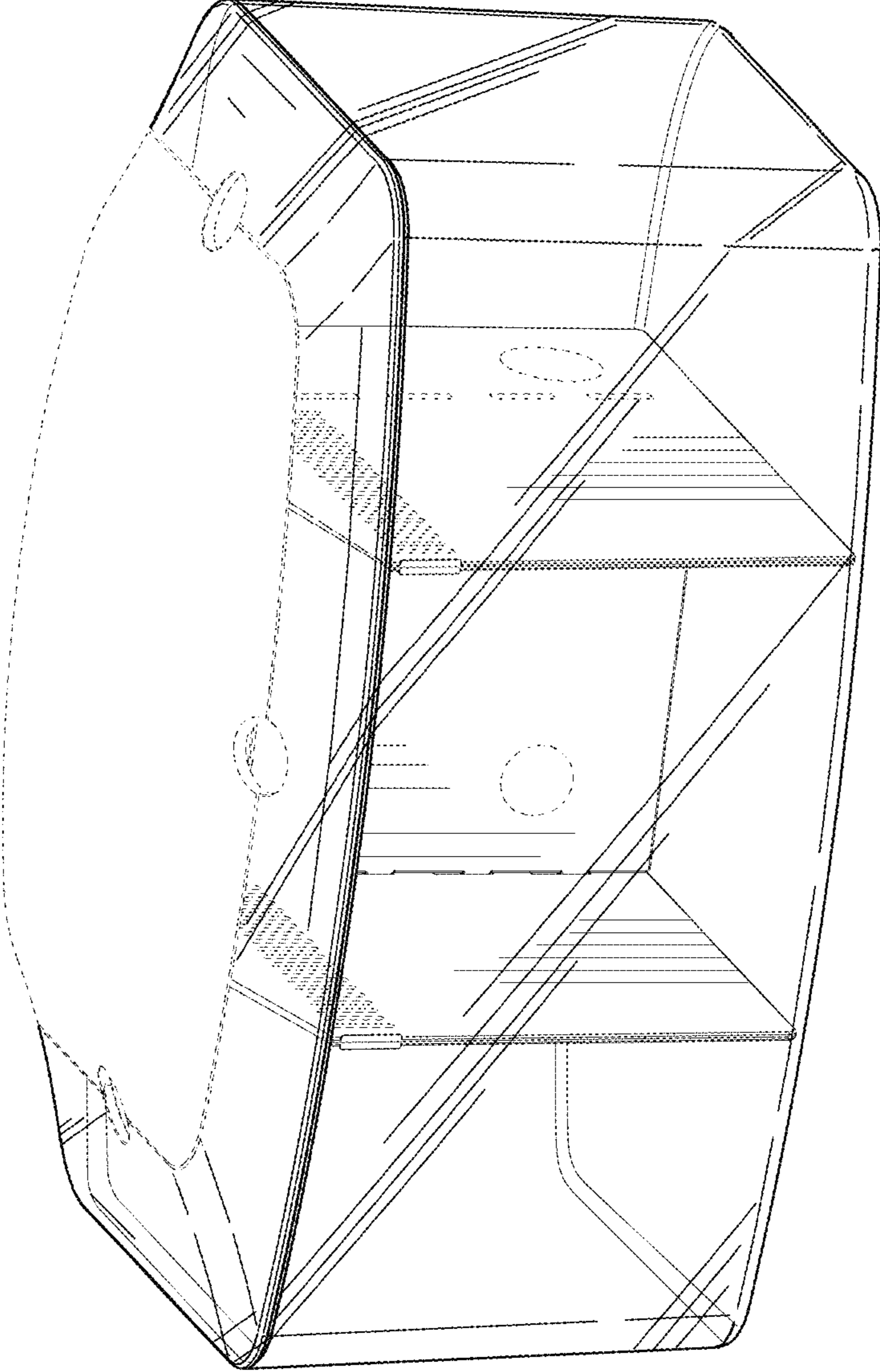

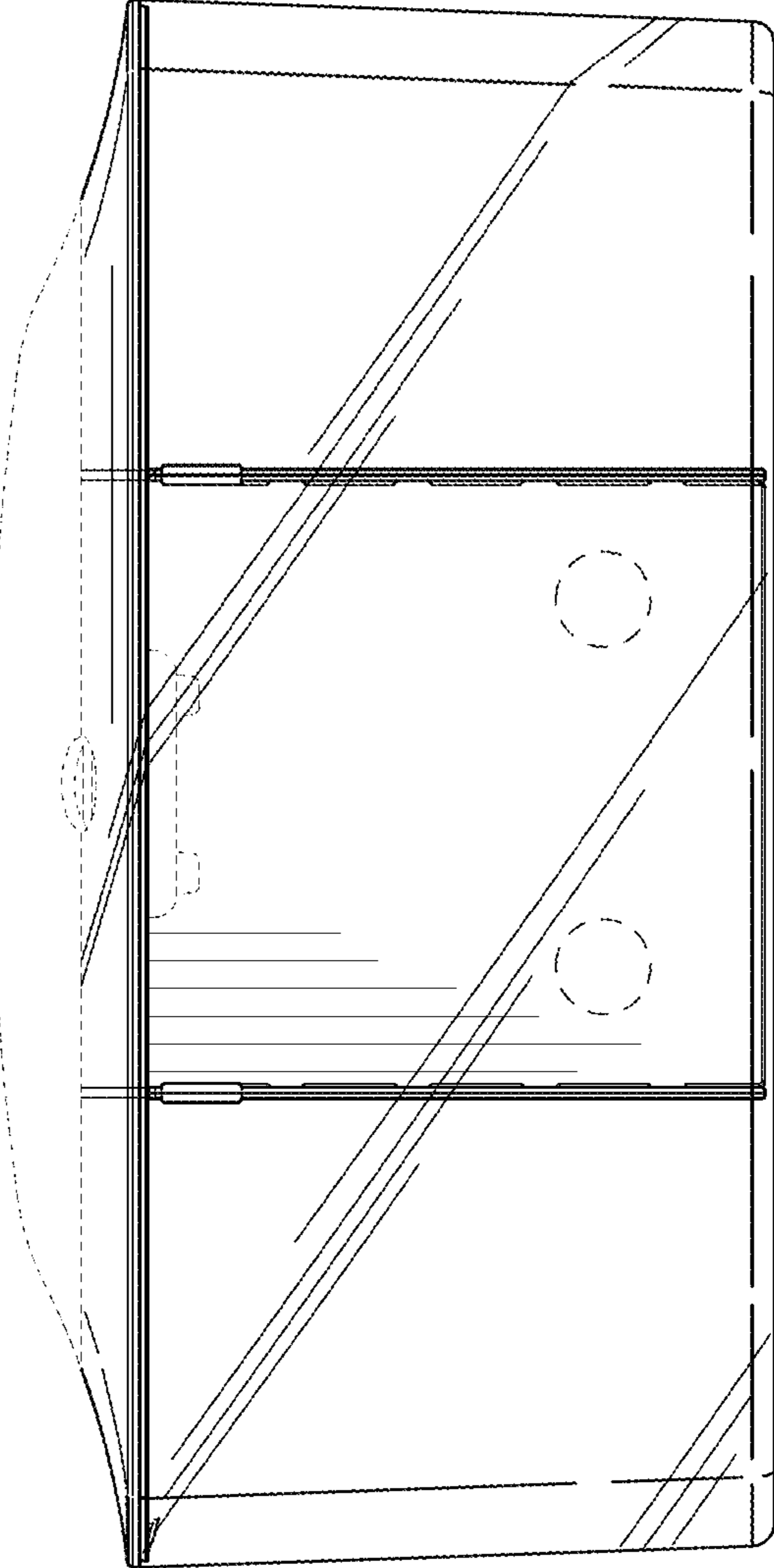

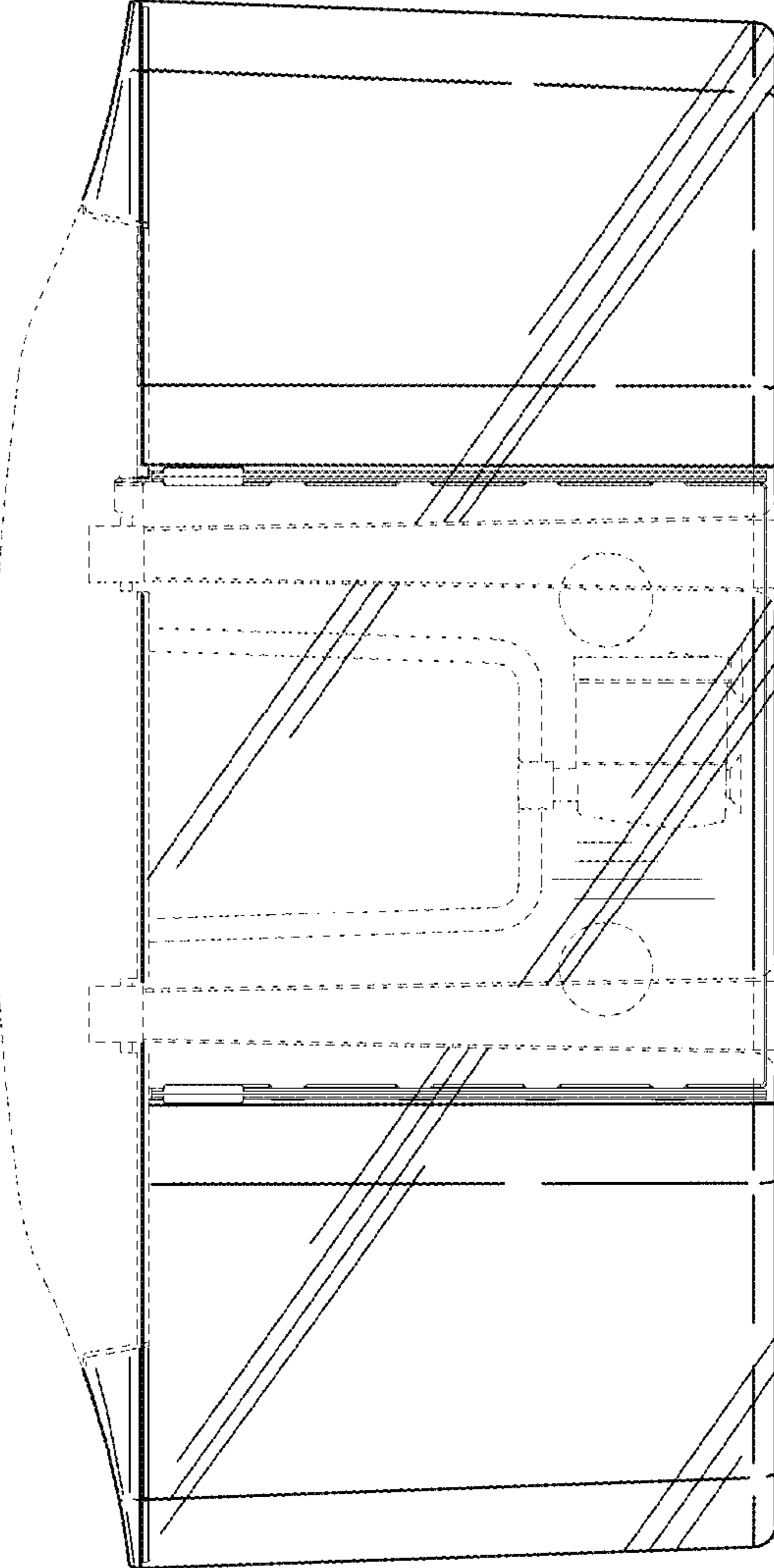
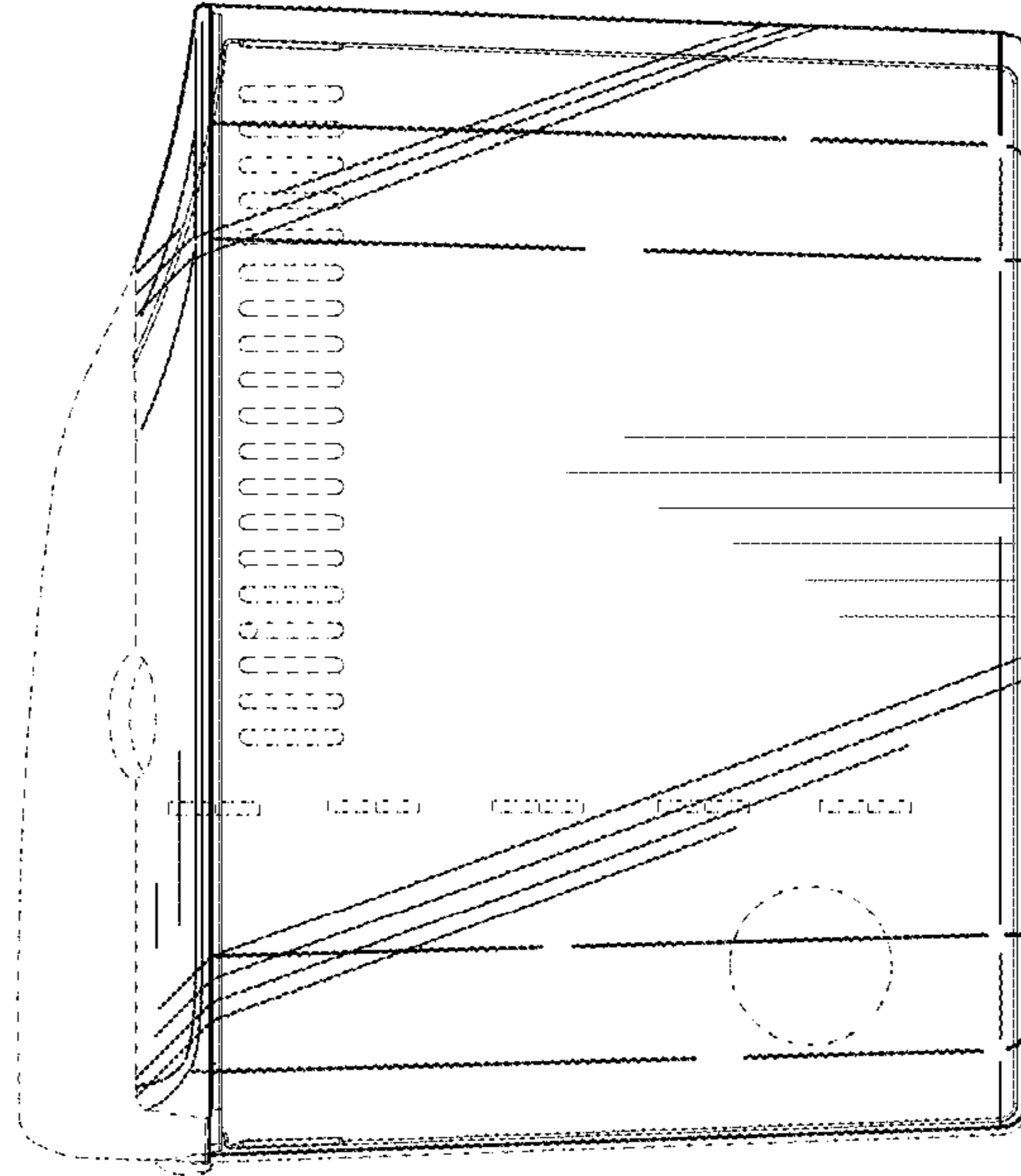
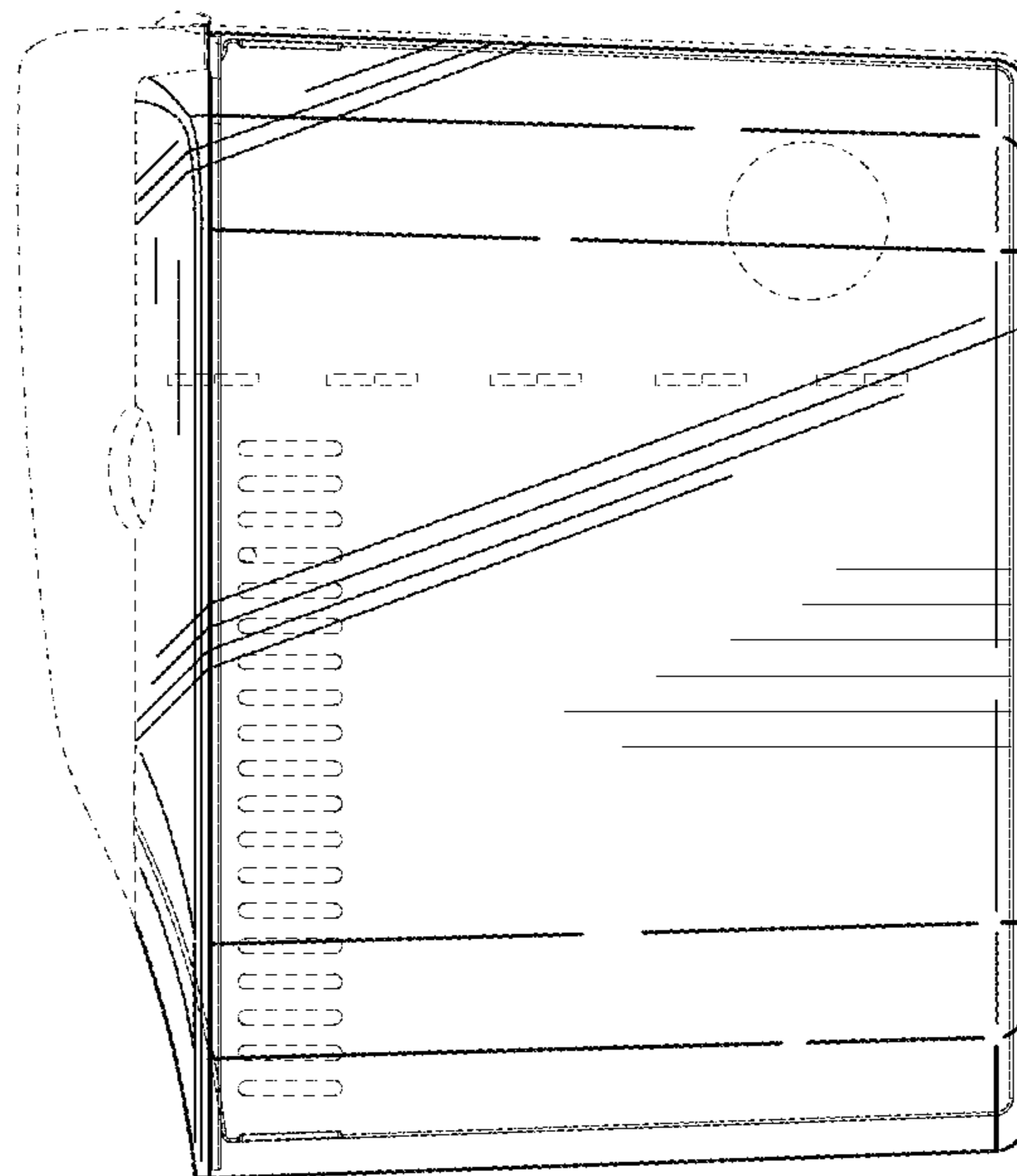

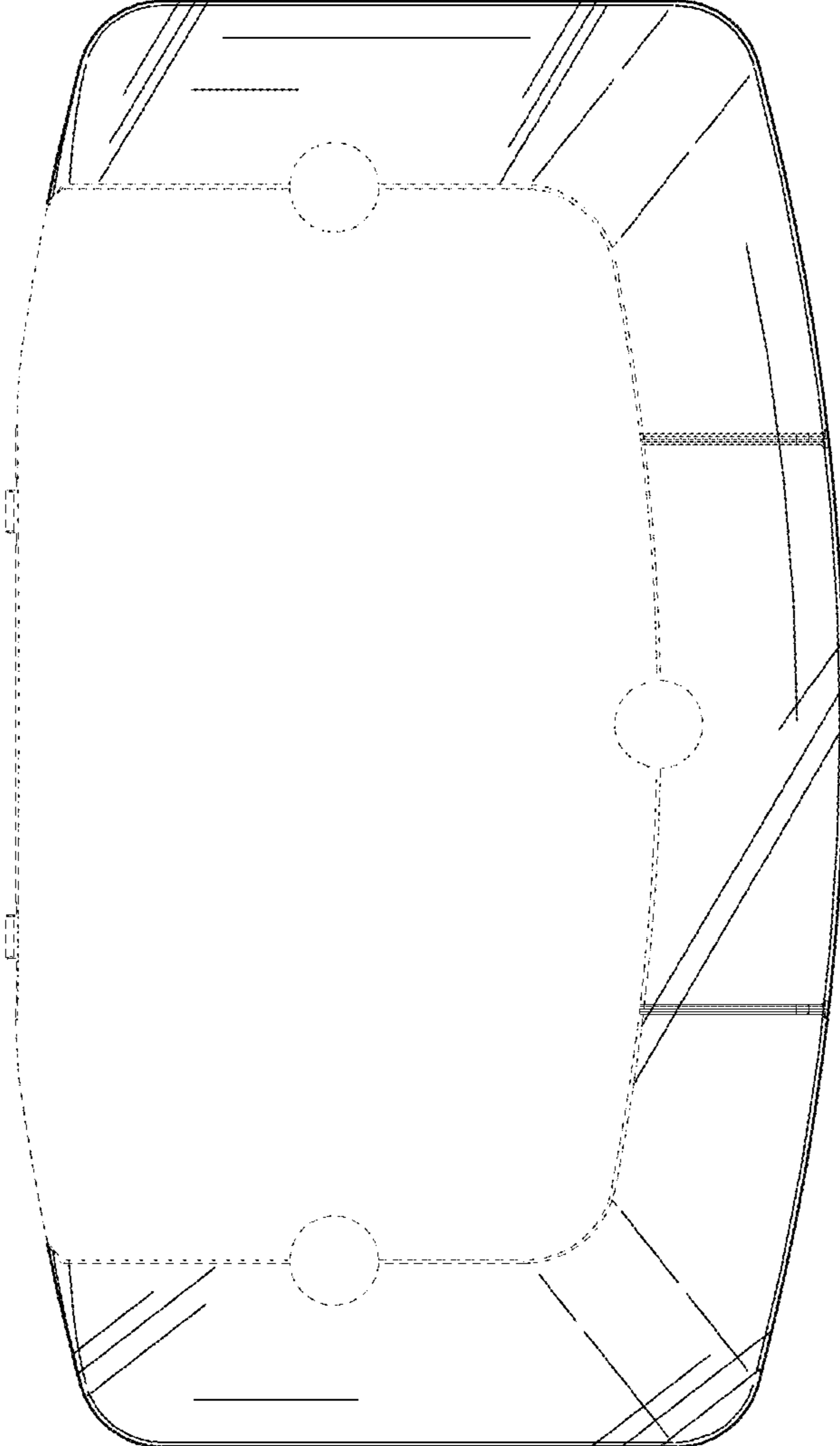

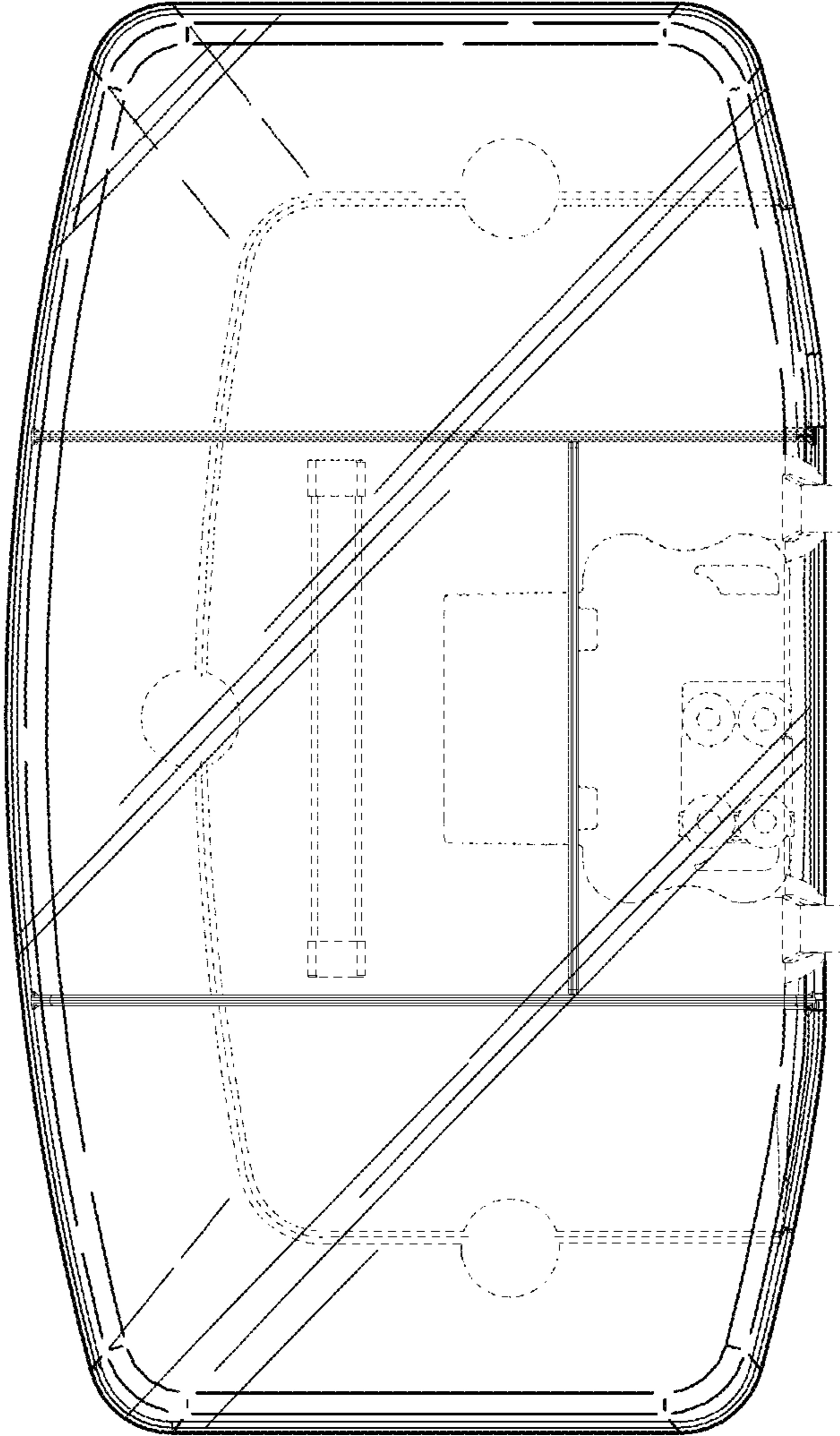
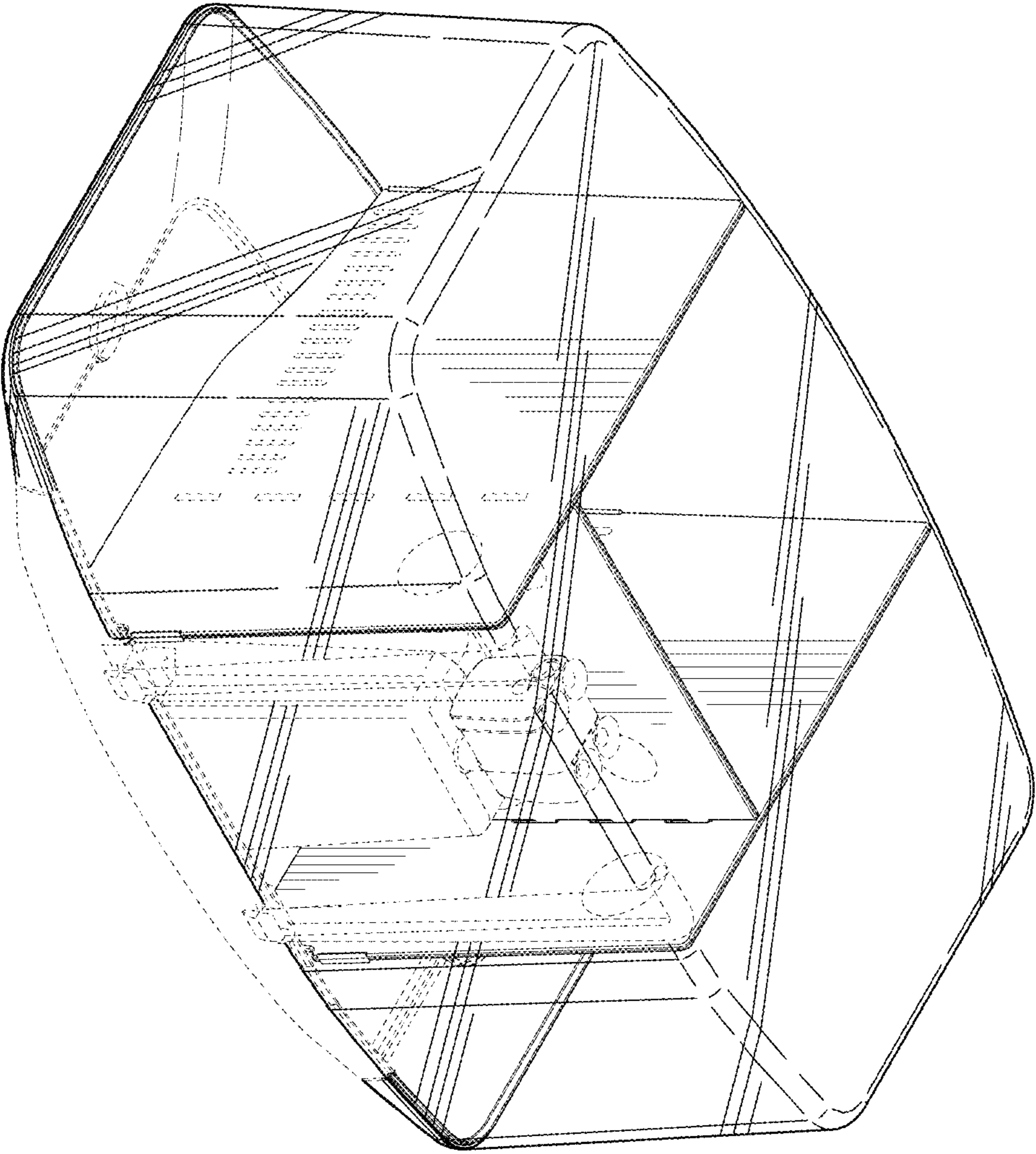
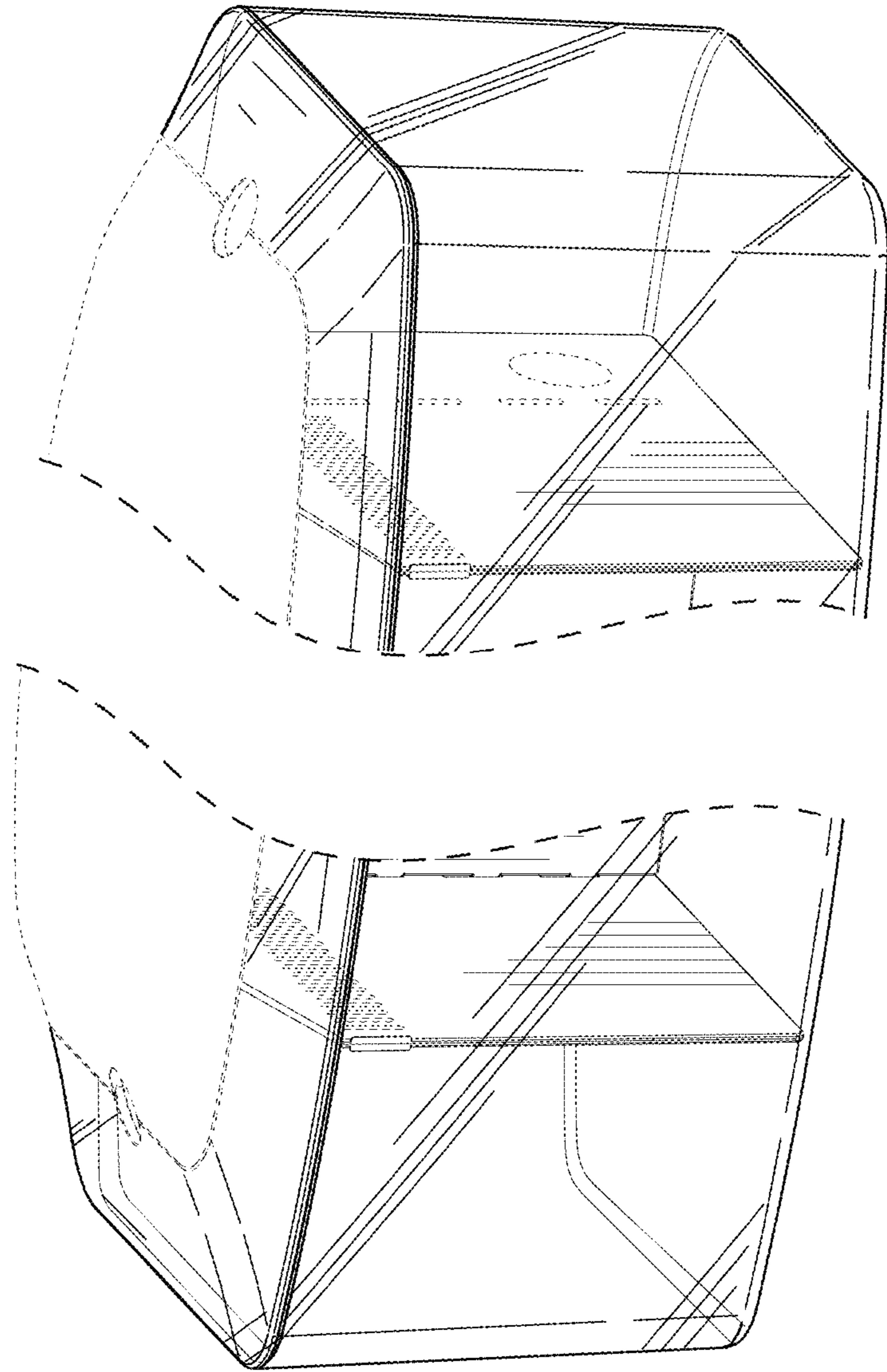

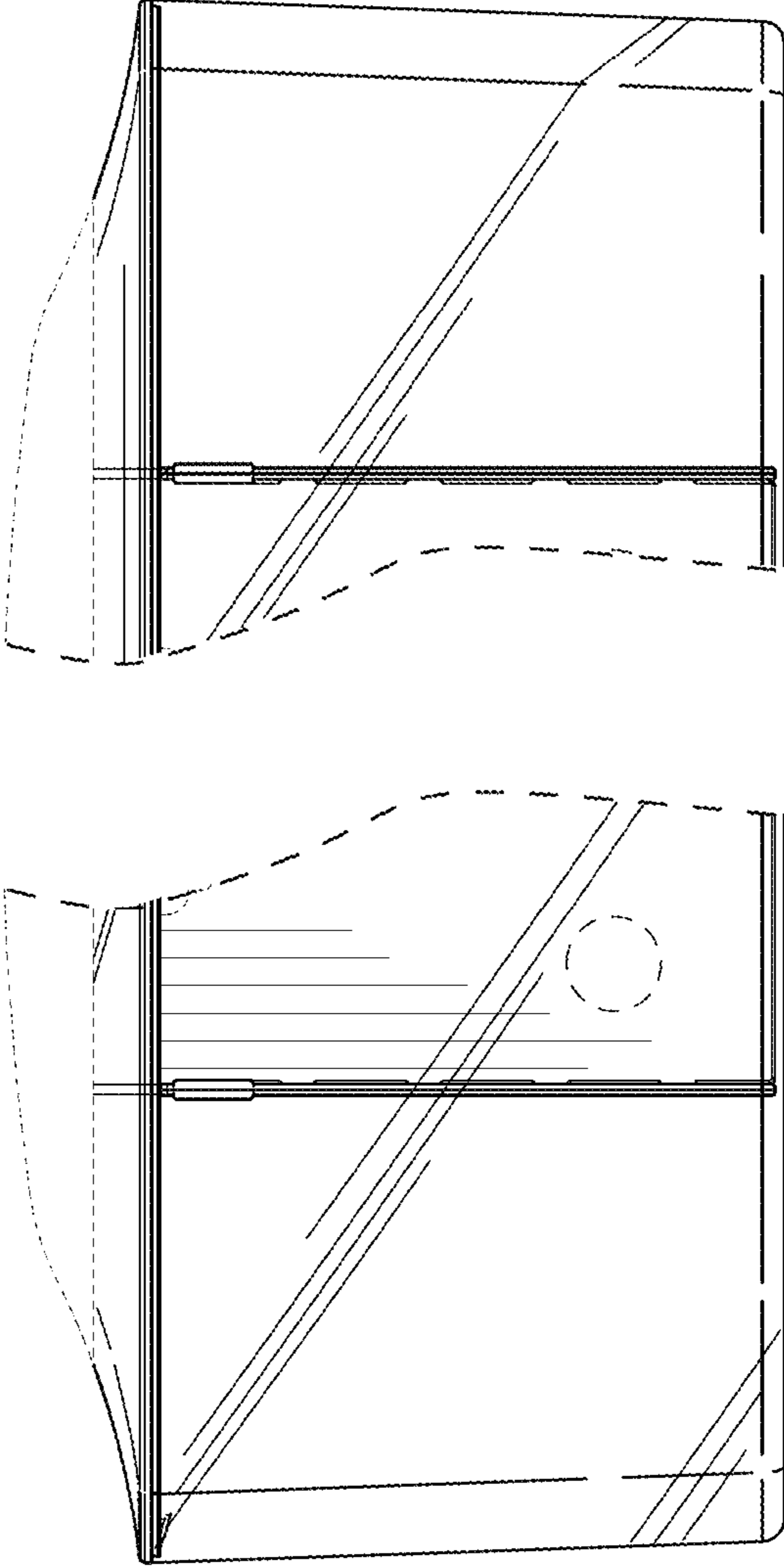
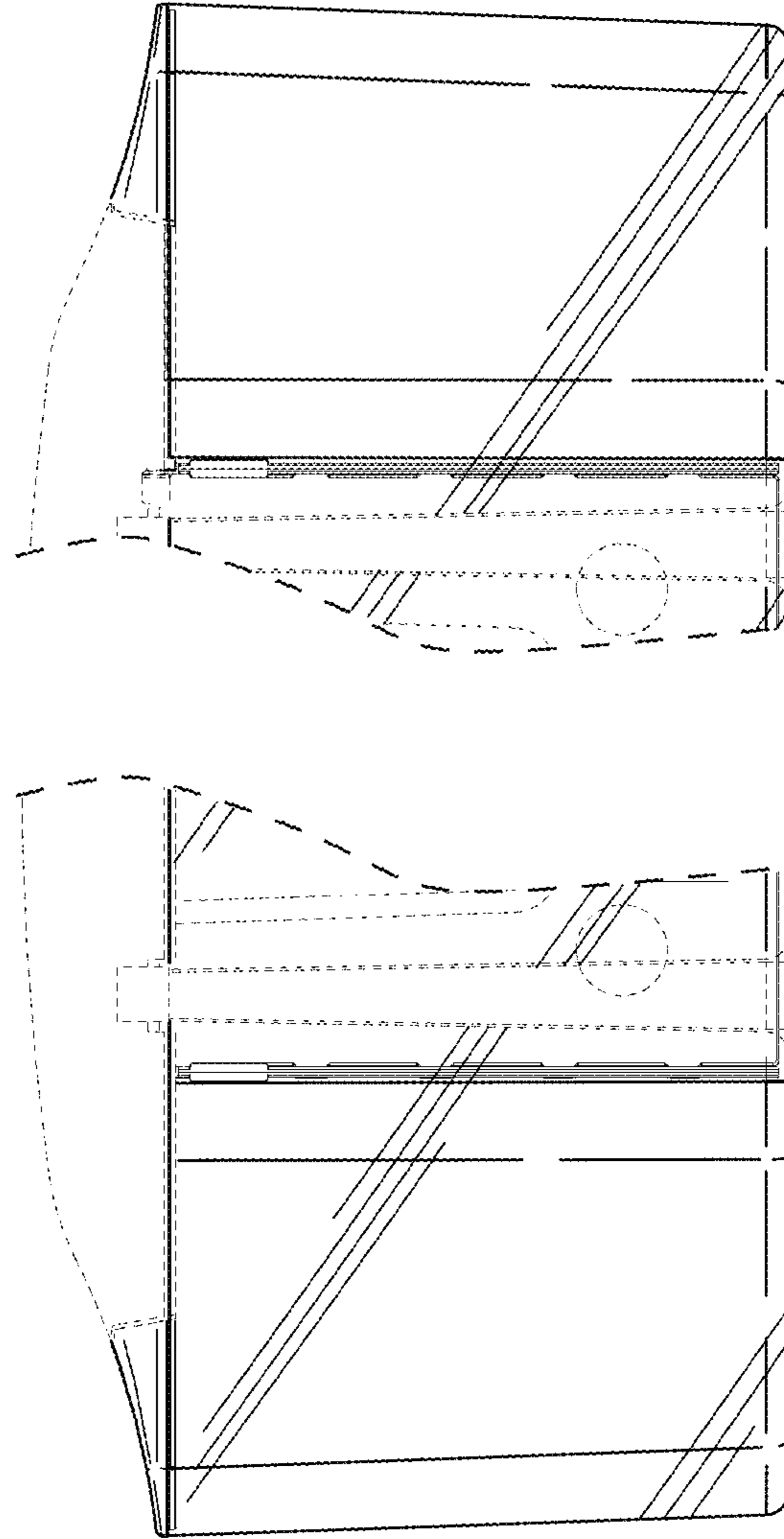
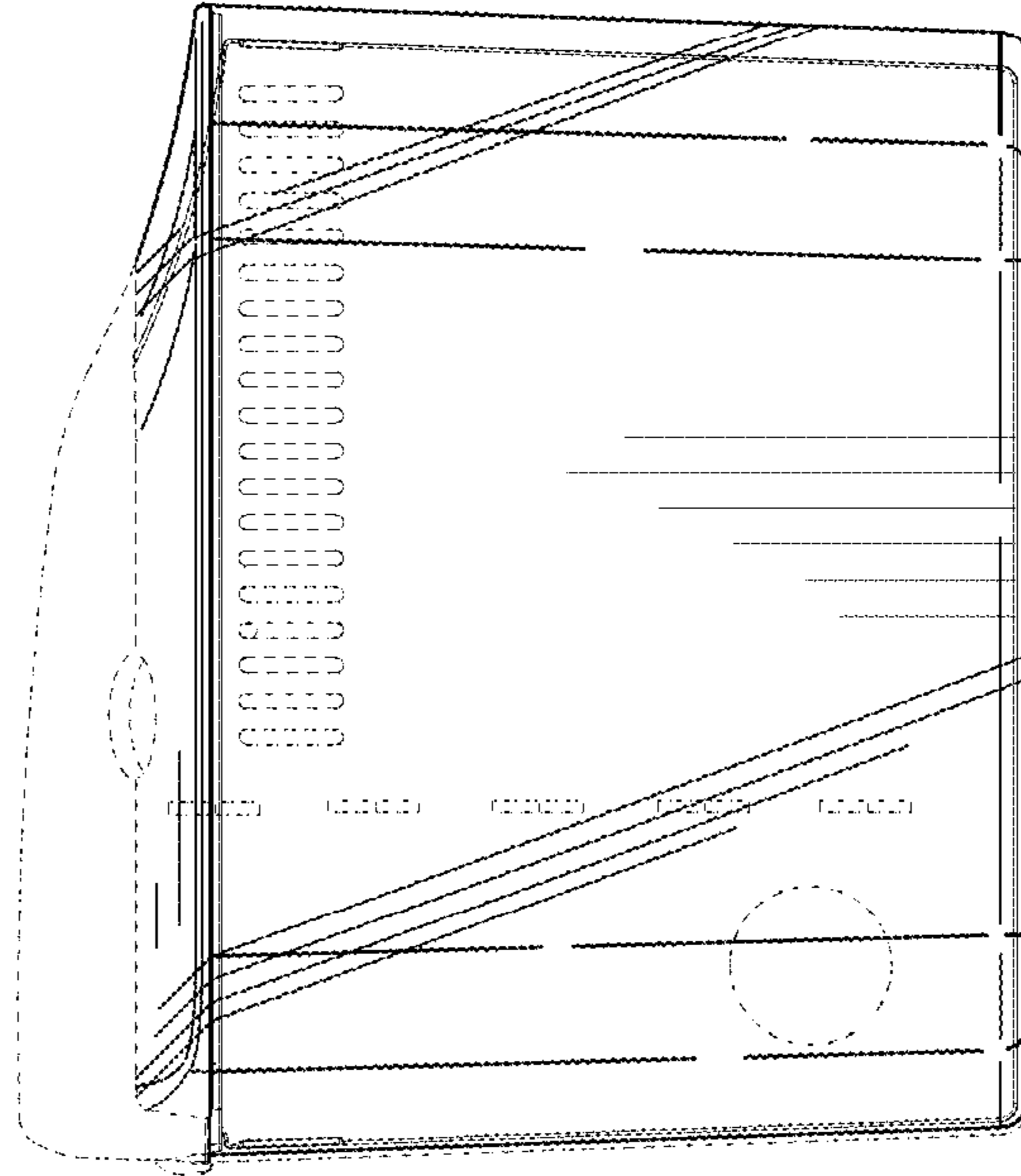

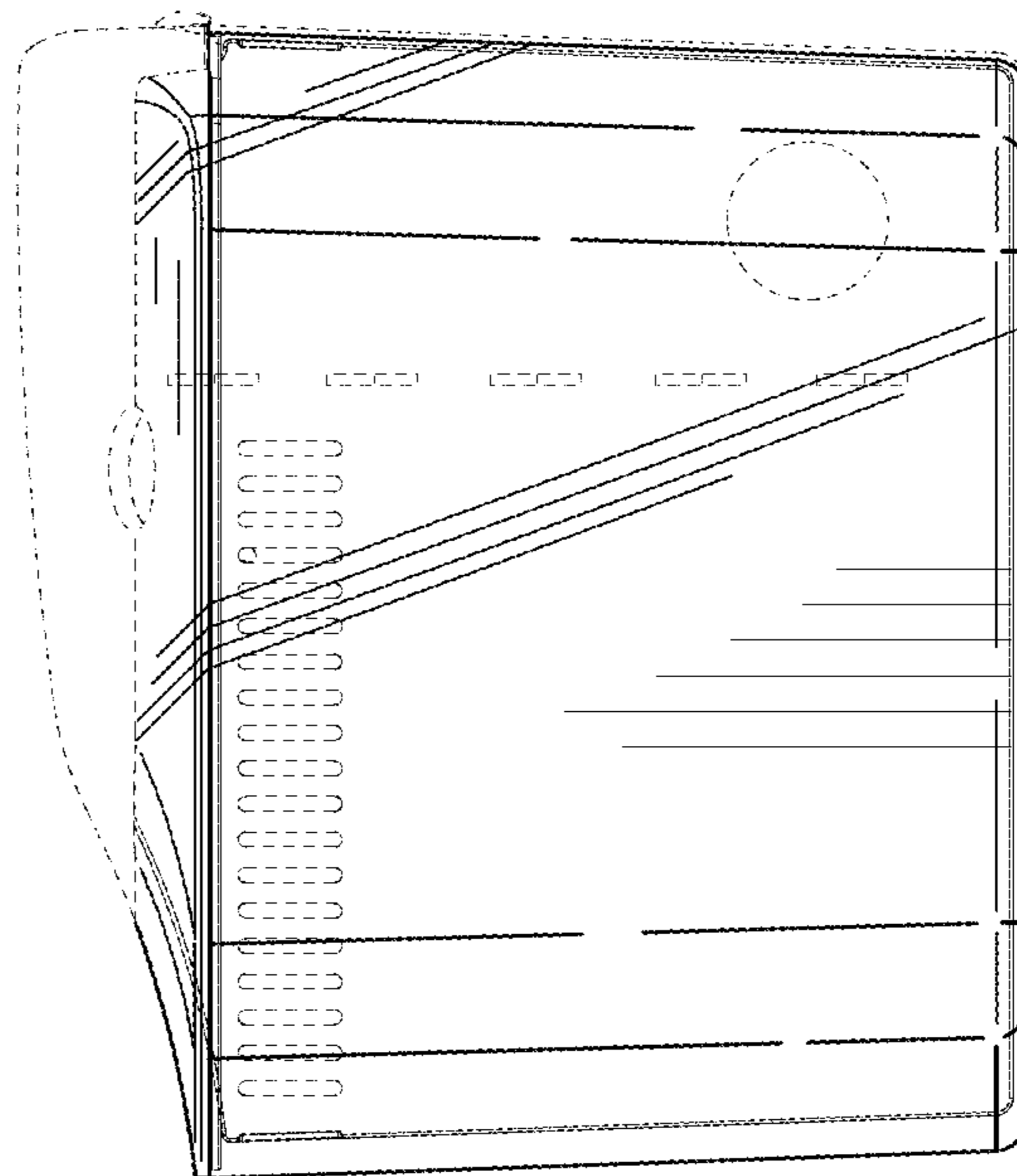


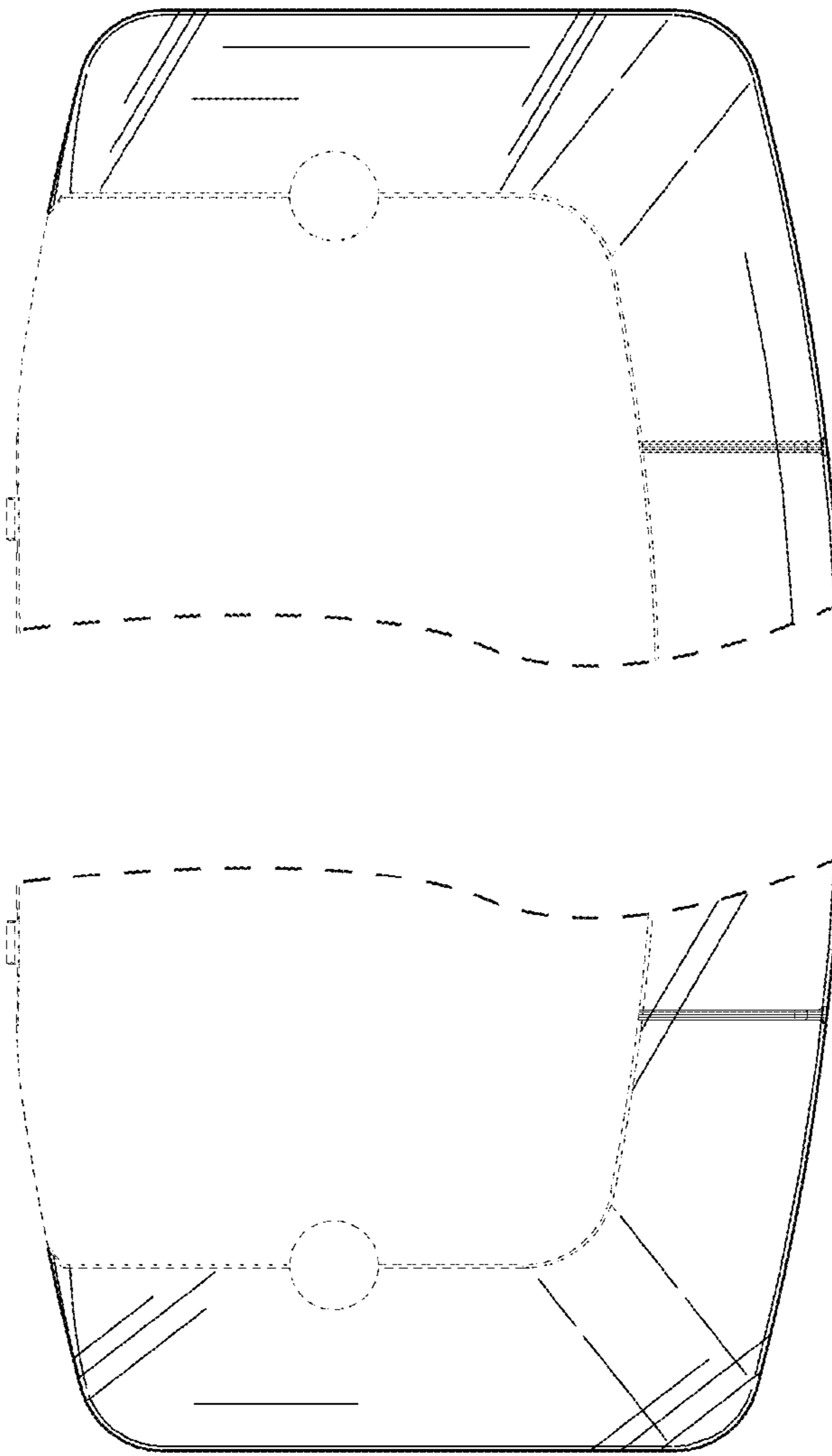

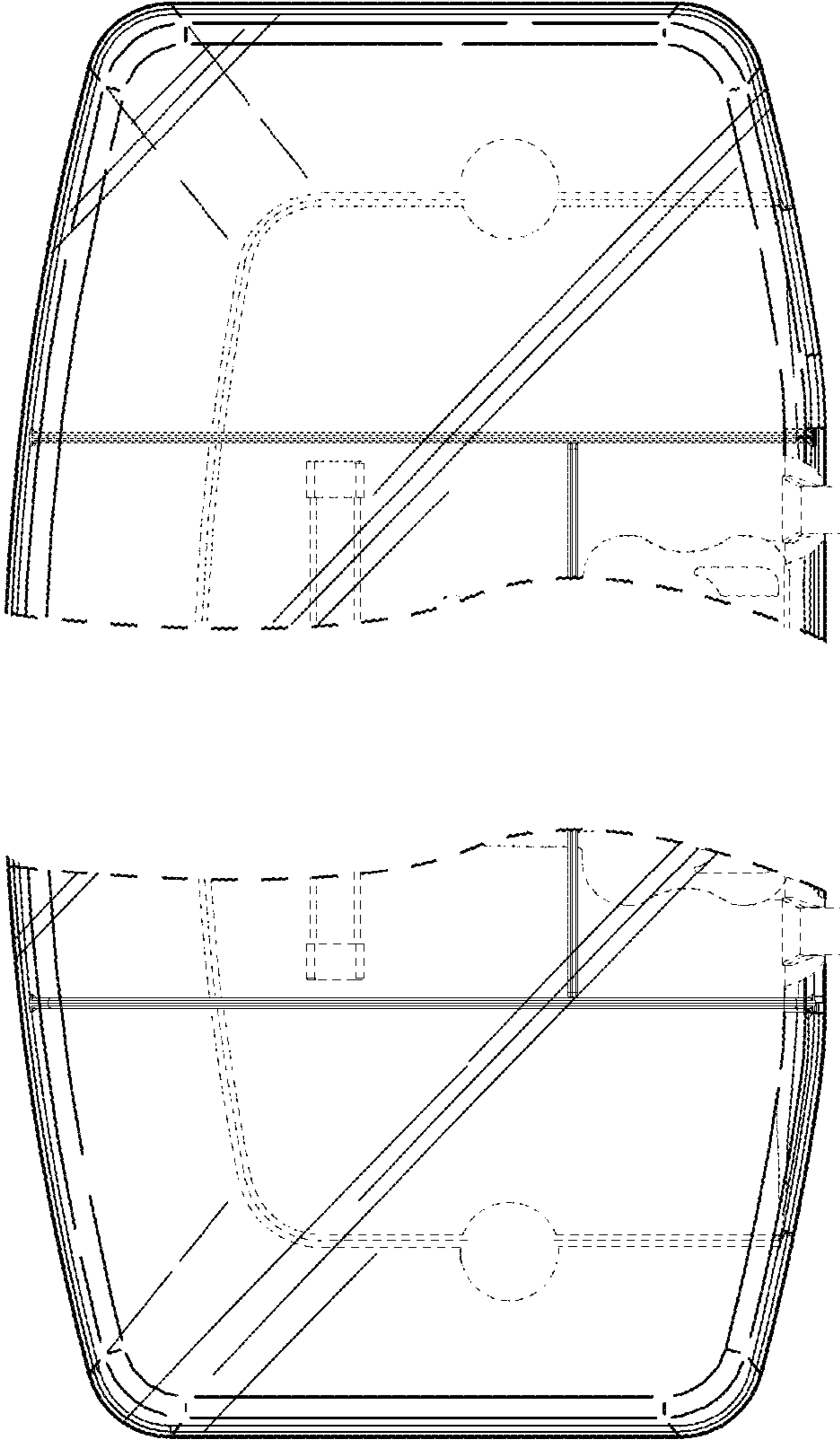
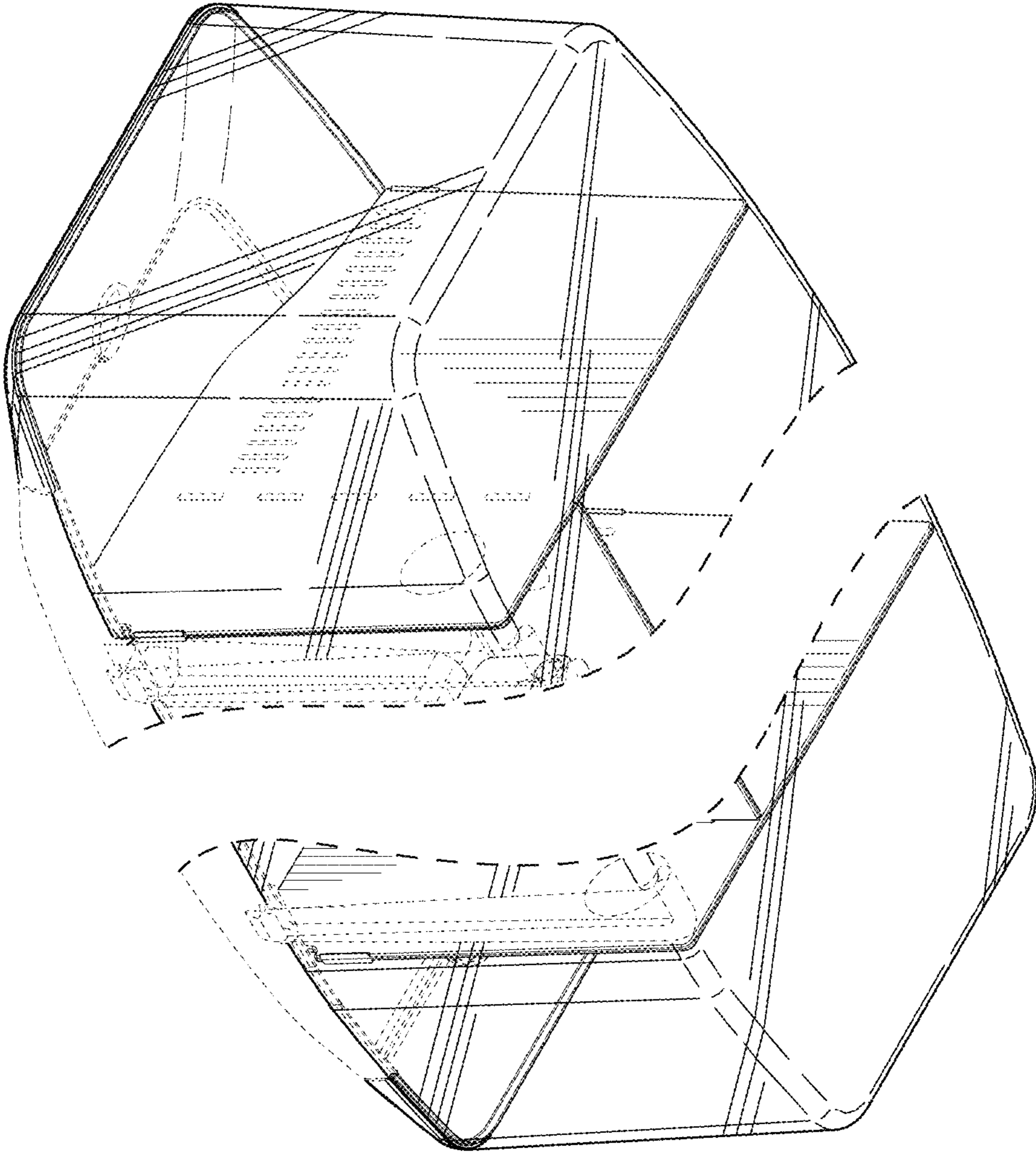
