(57) **CLAIM**

The ornamental design for a kabob pet treat, as shown and described.

**DESCRIPTION**

FIG. 1 is front, top and right side perspective view of a first embodiment of a kabob pet treat according to the new design;

FIG. 13 is a right side elevation view thereof;

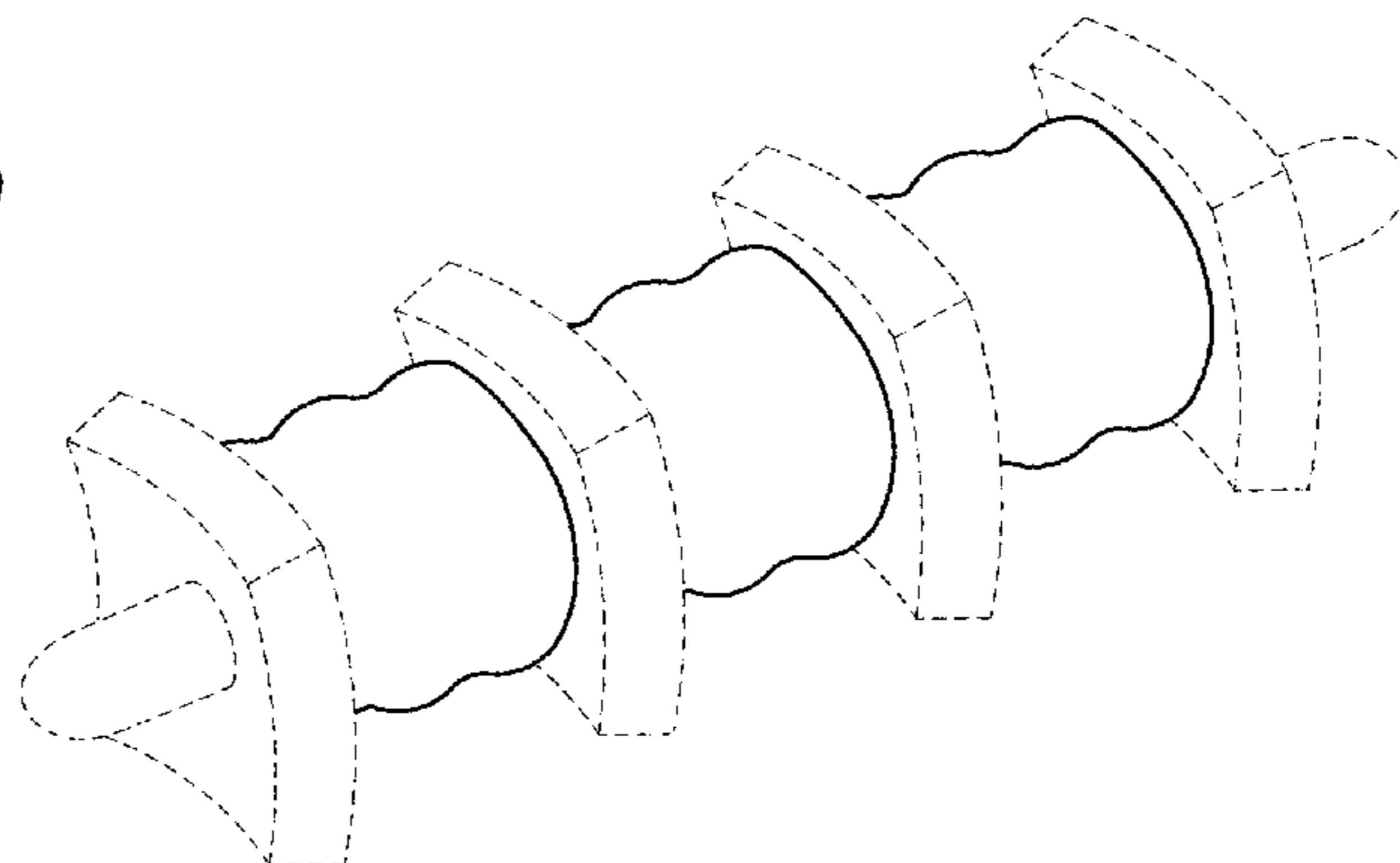
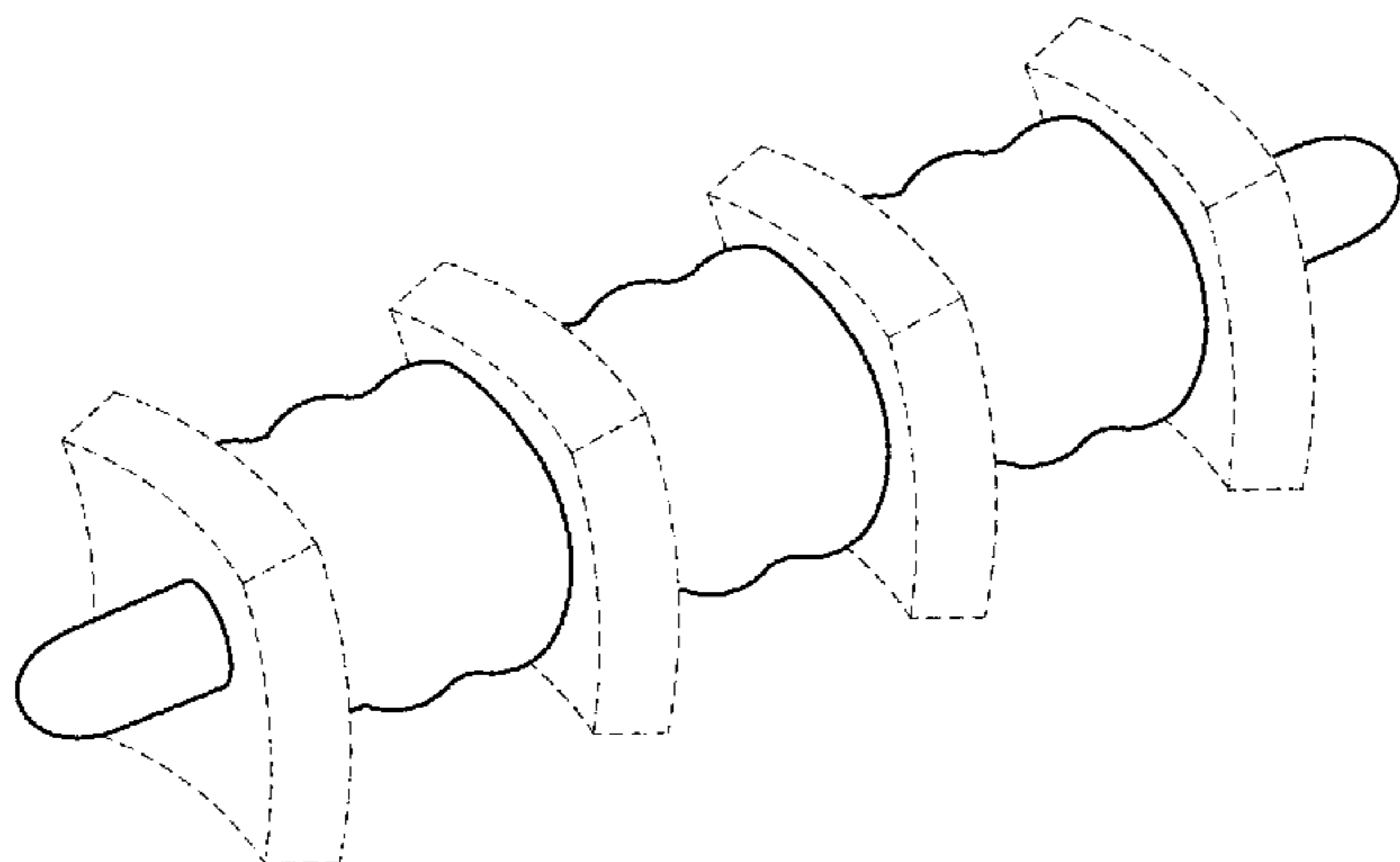
FIG. 14 is a left side elevation view thereof;

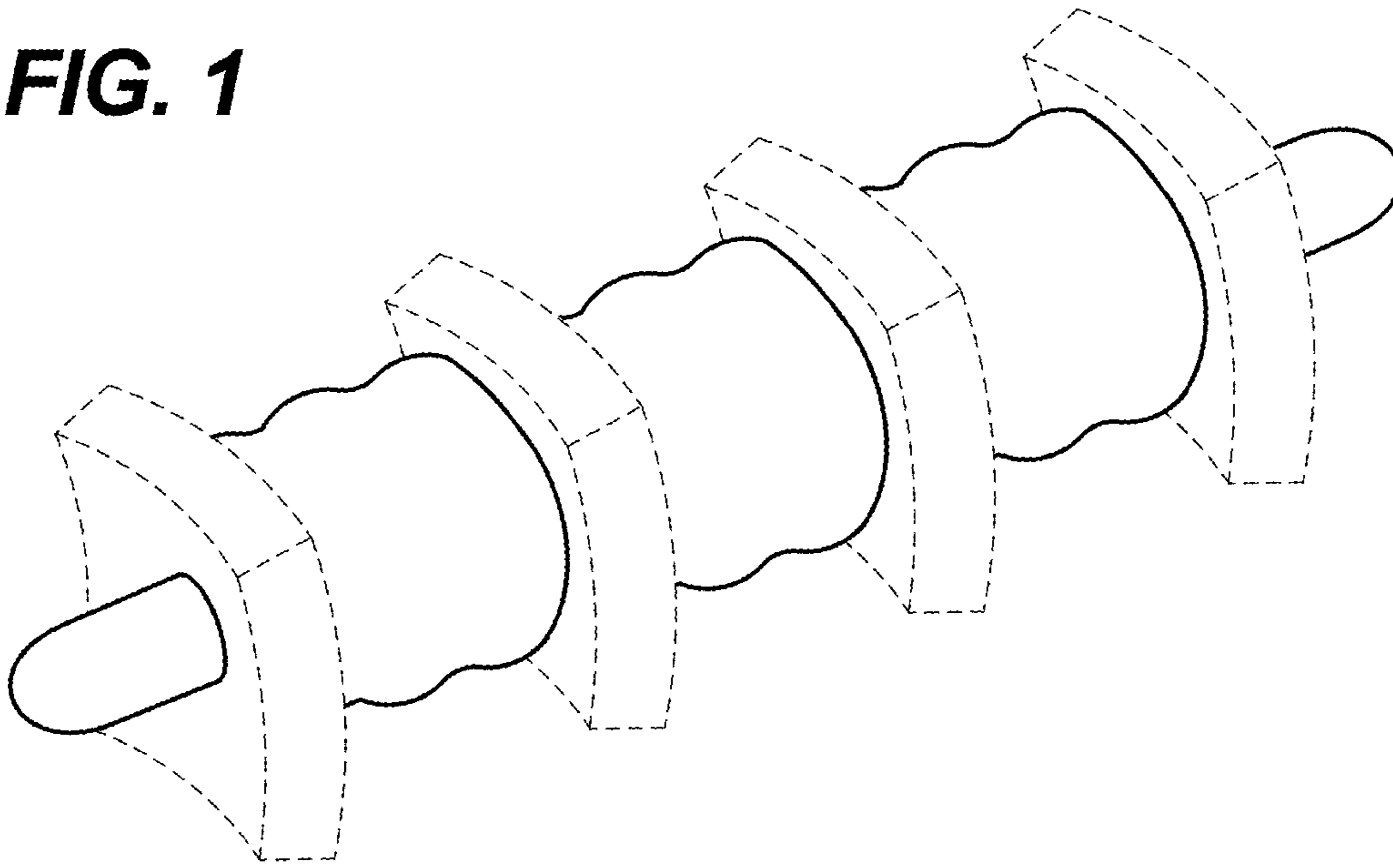

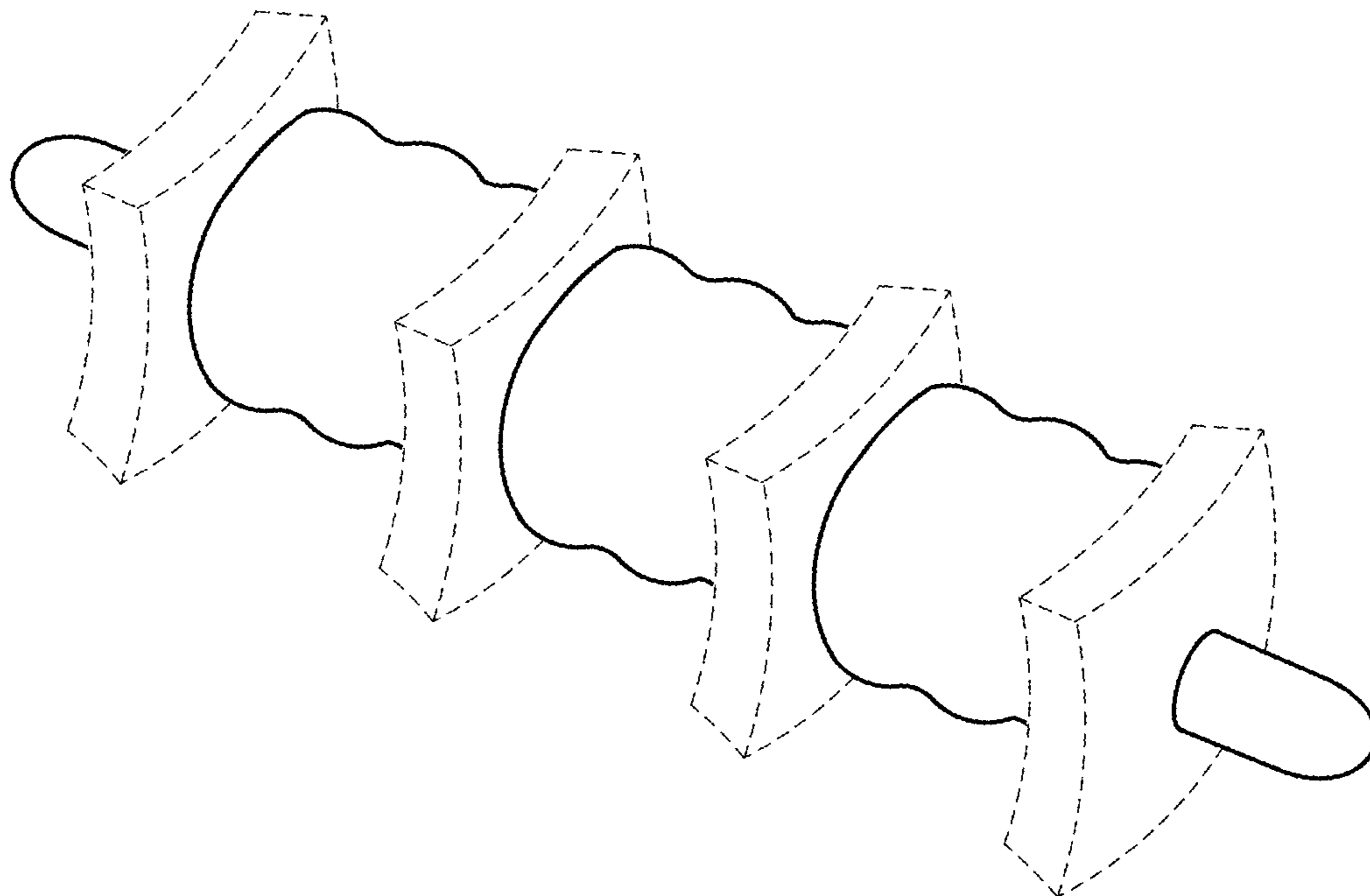

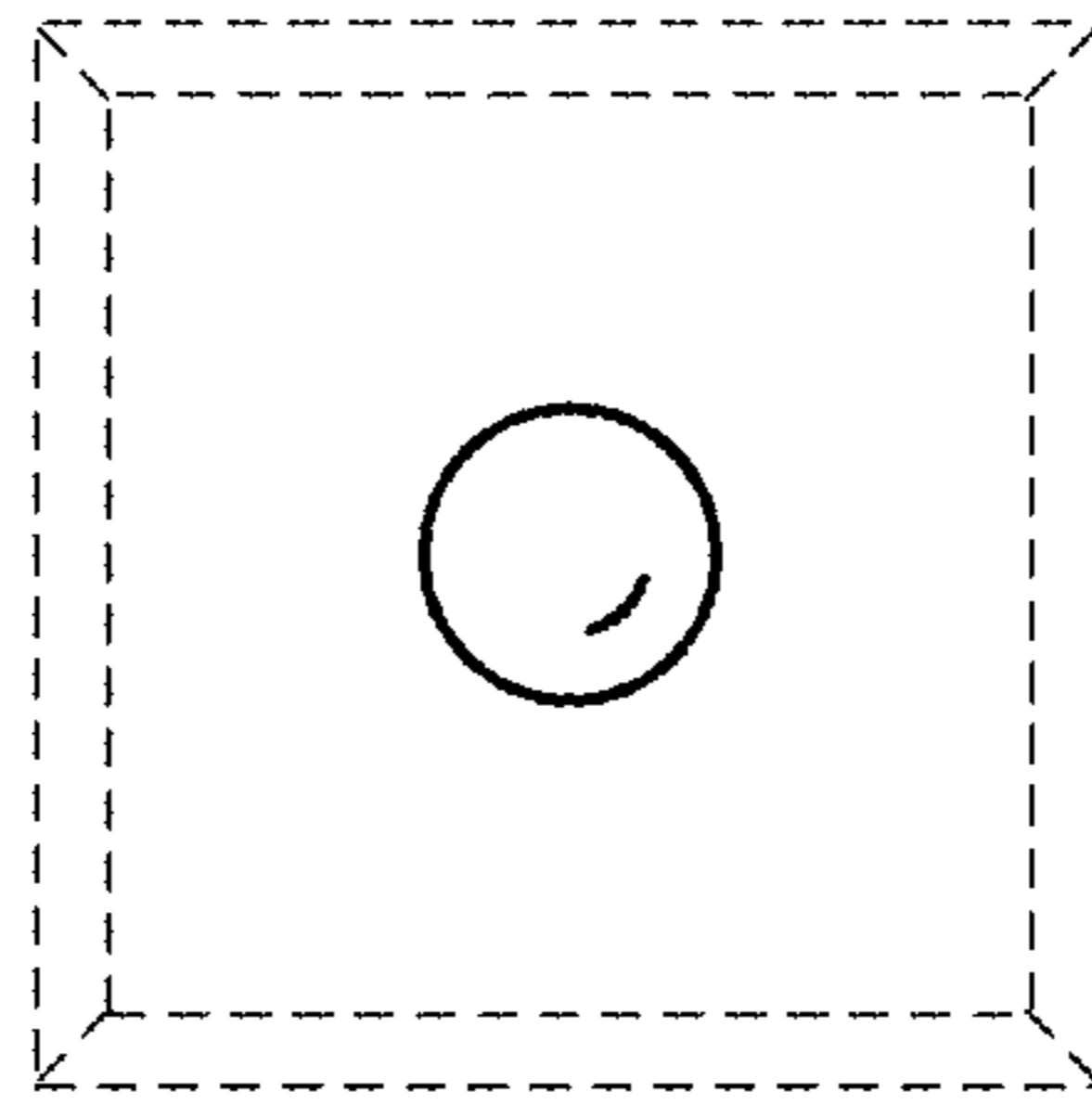

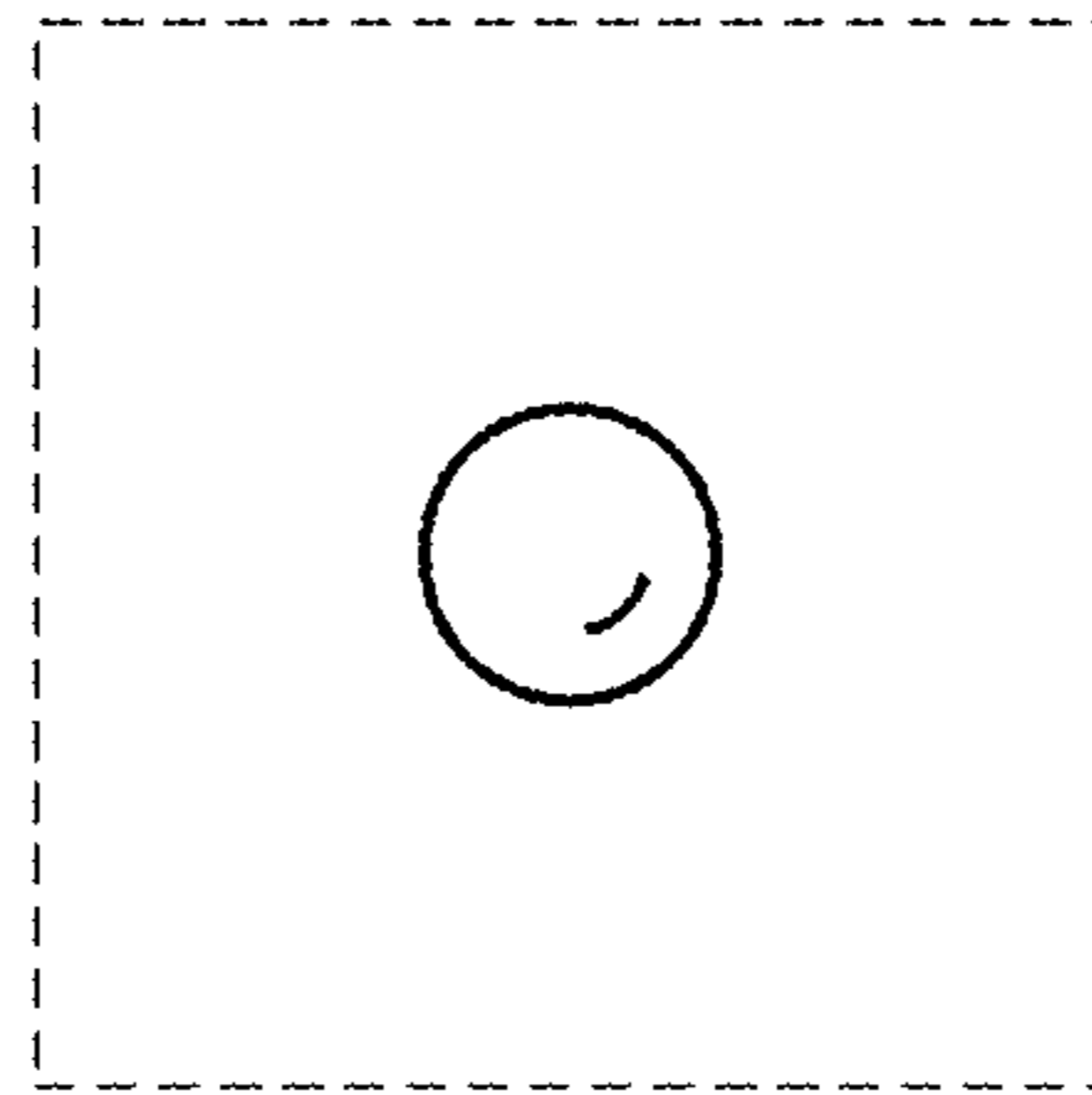

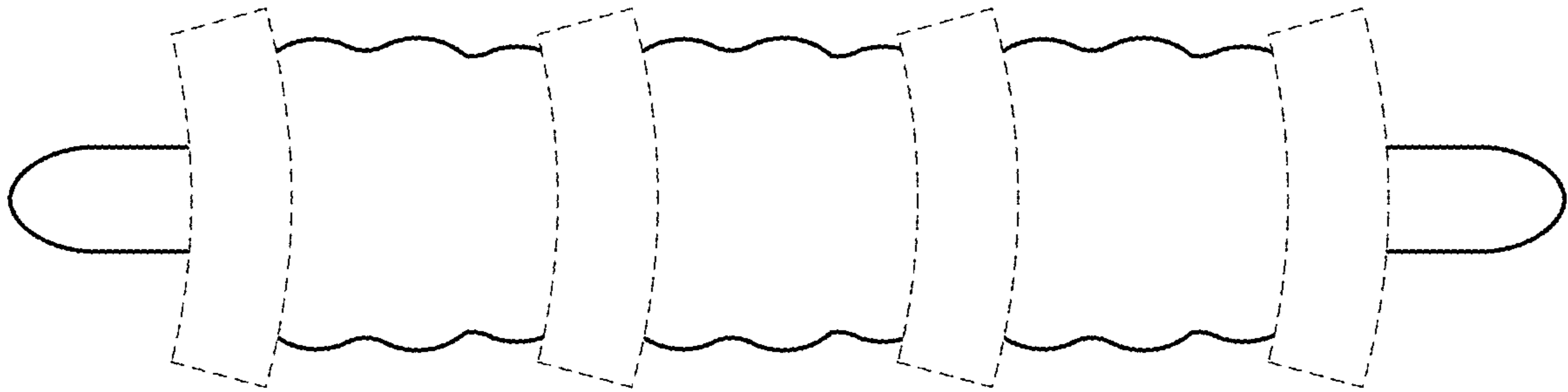

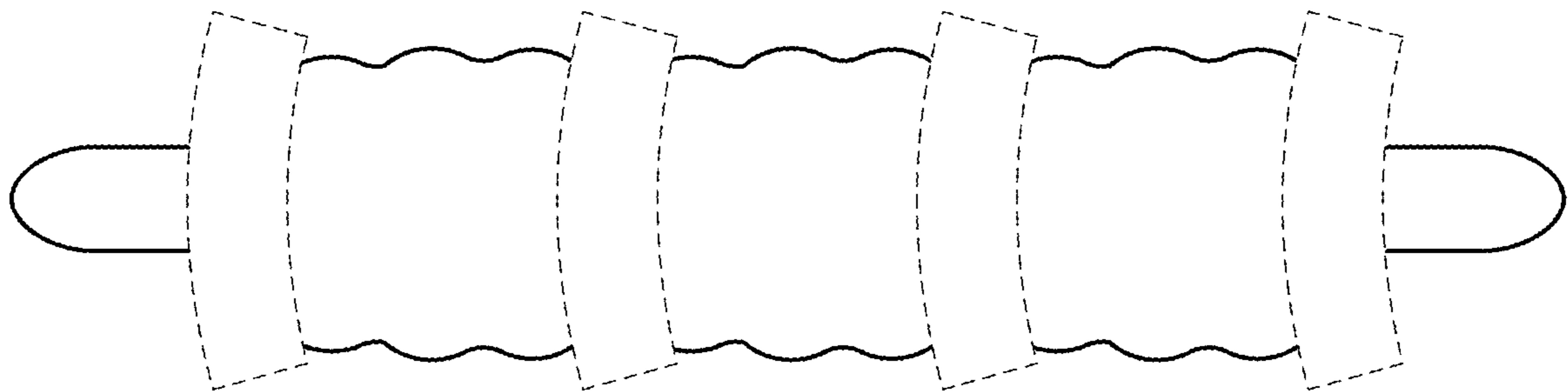

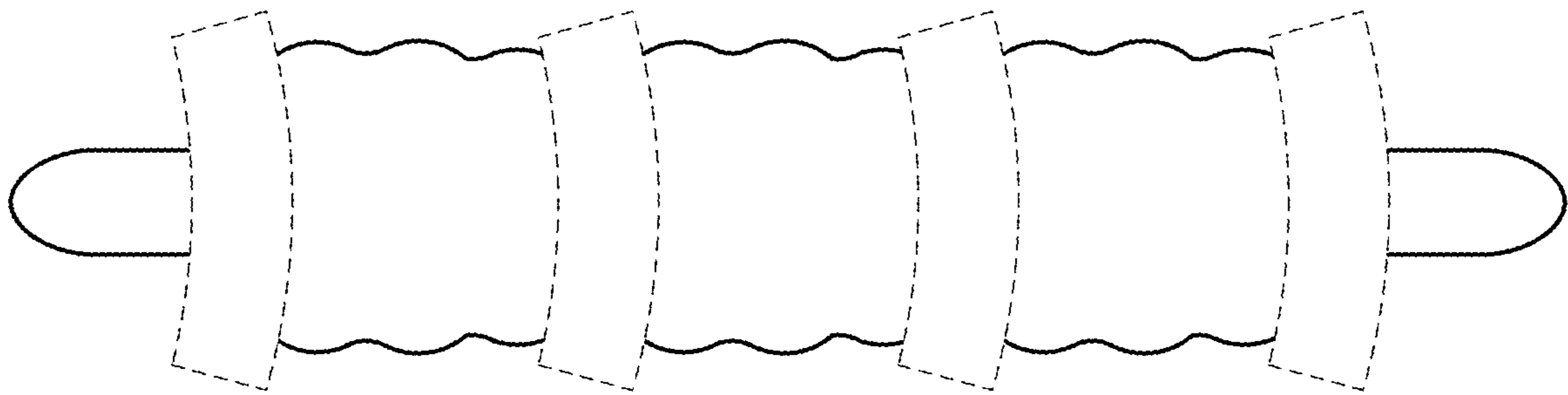

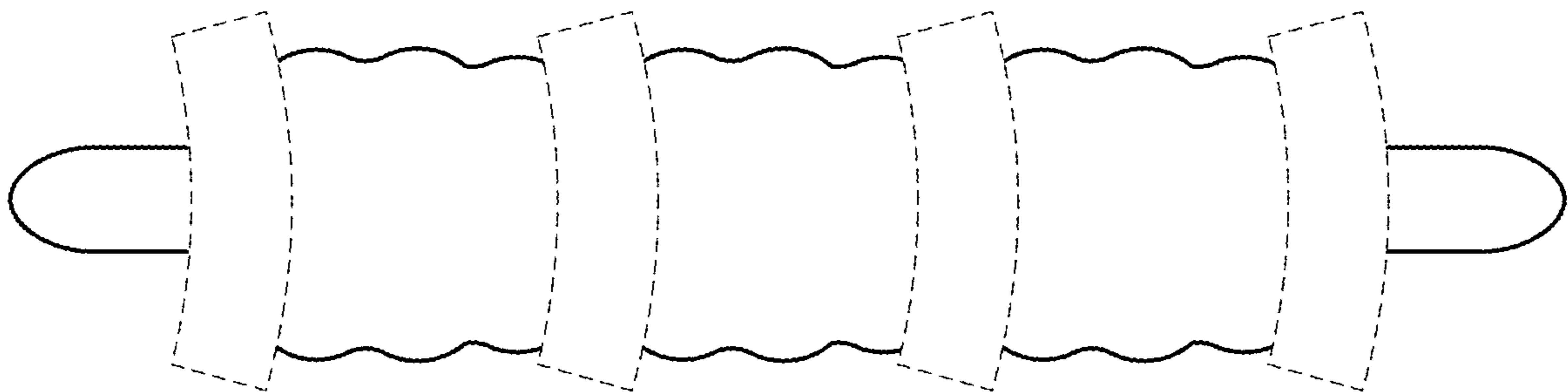

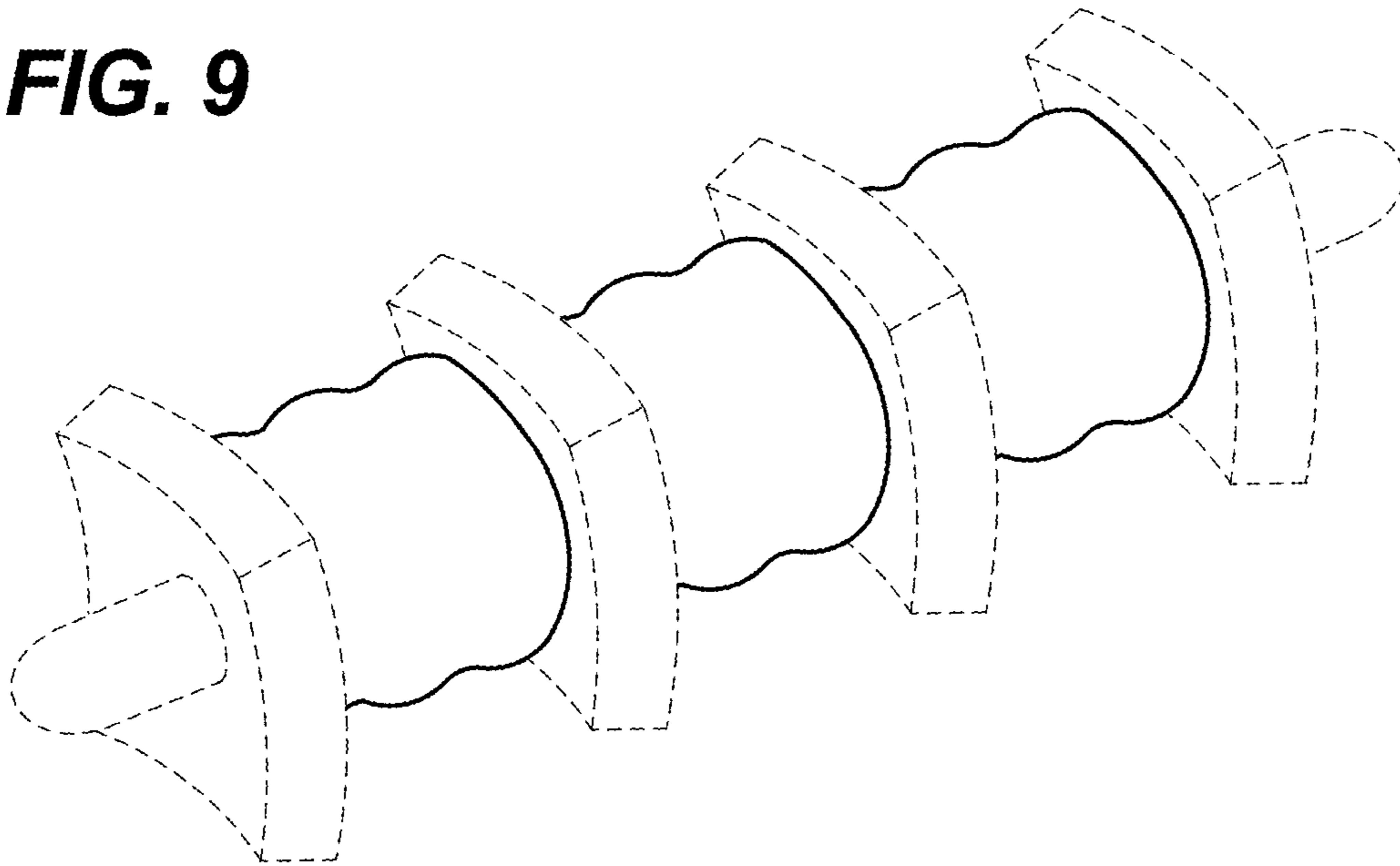

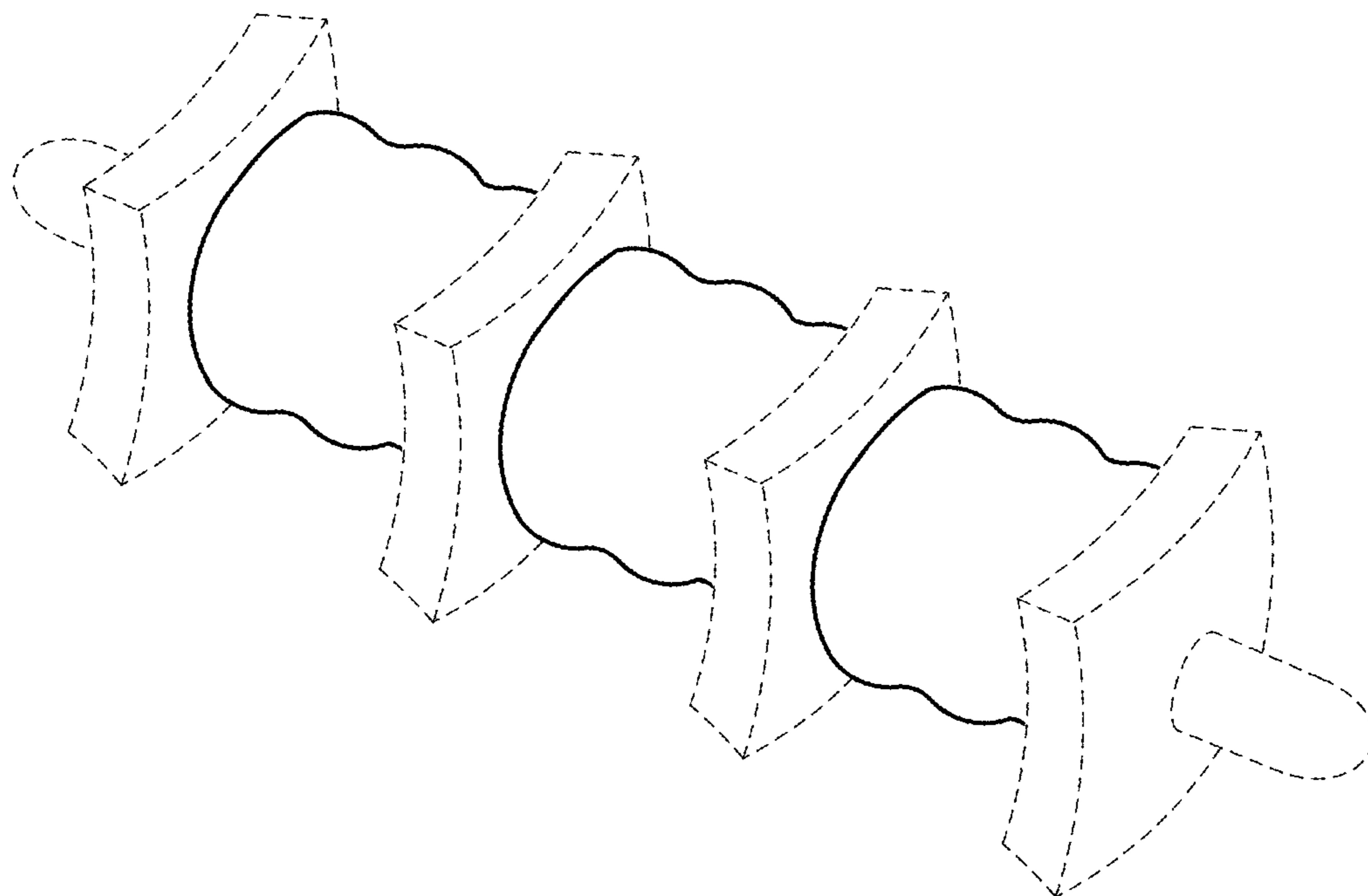

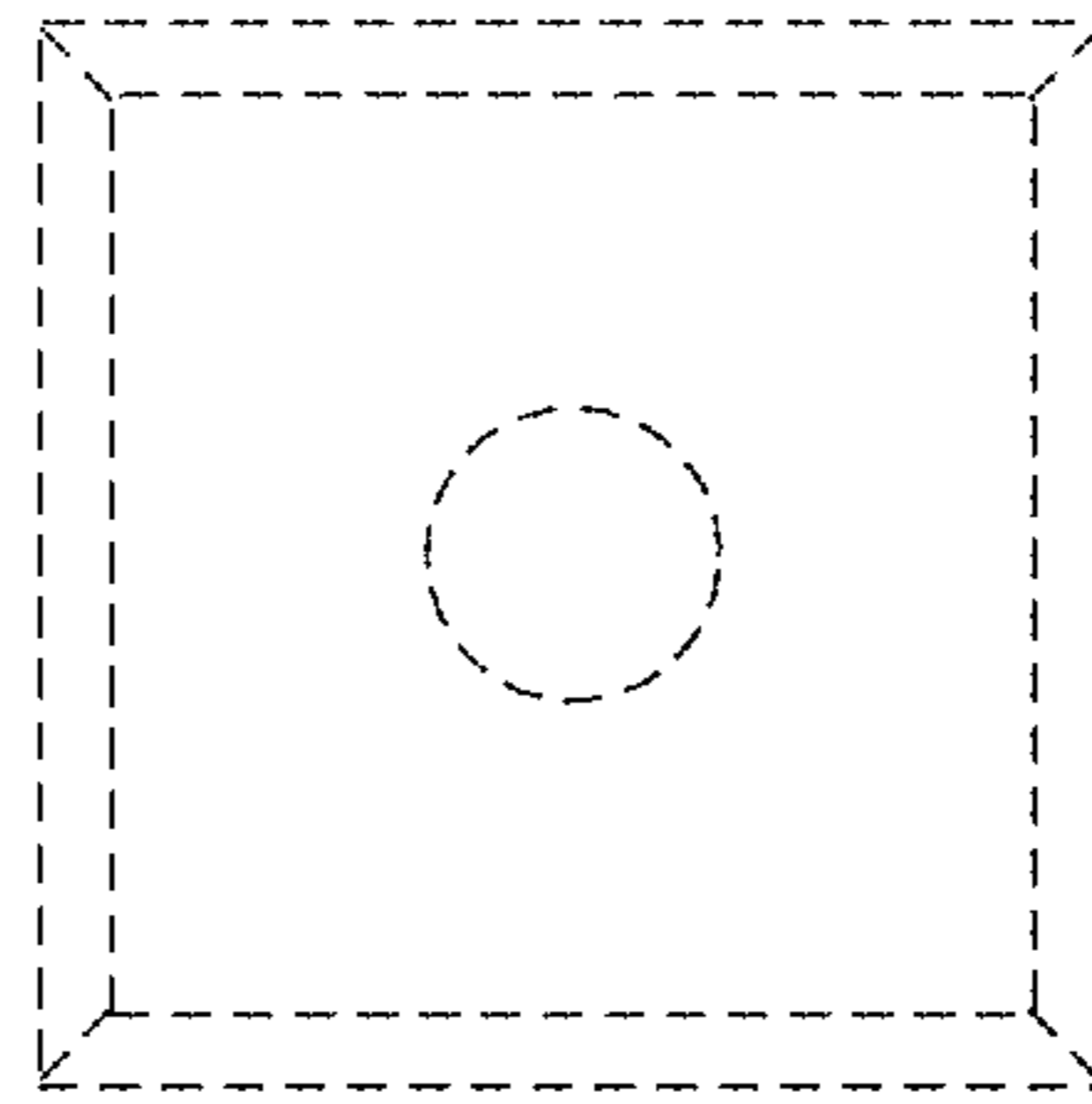

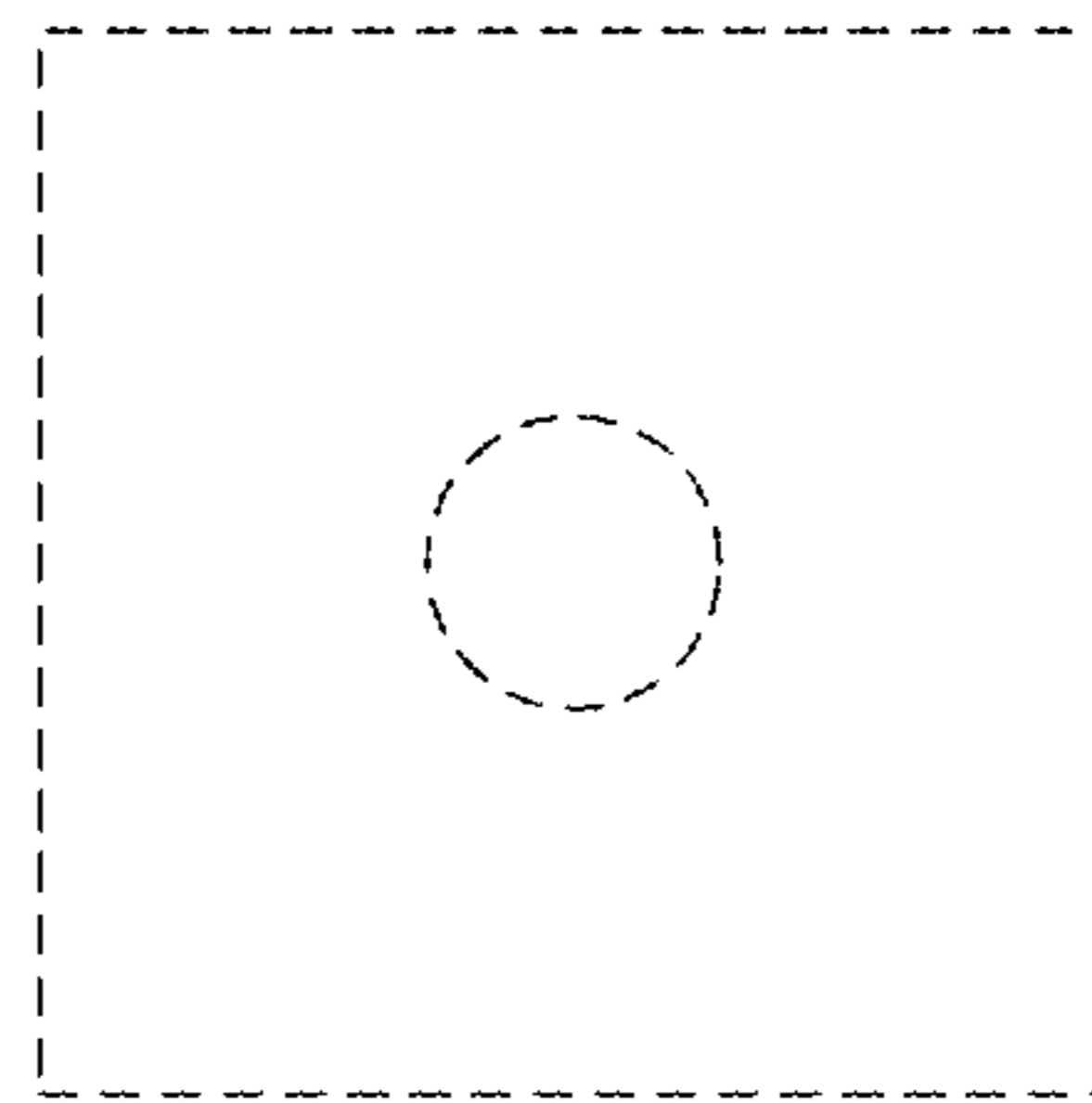




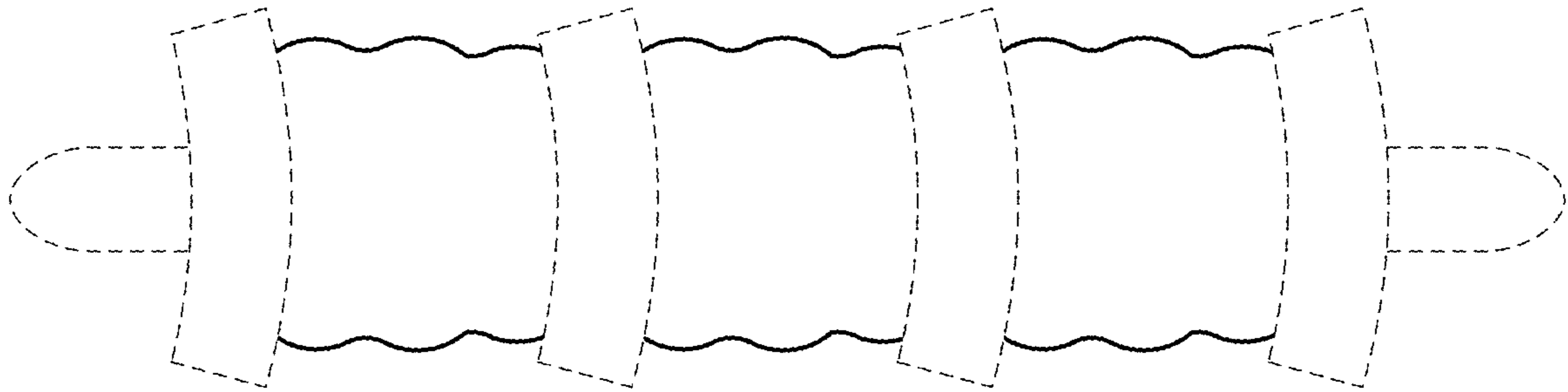

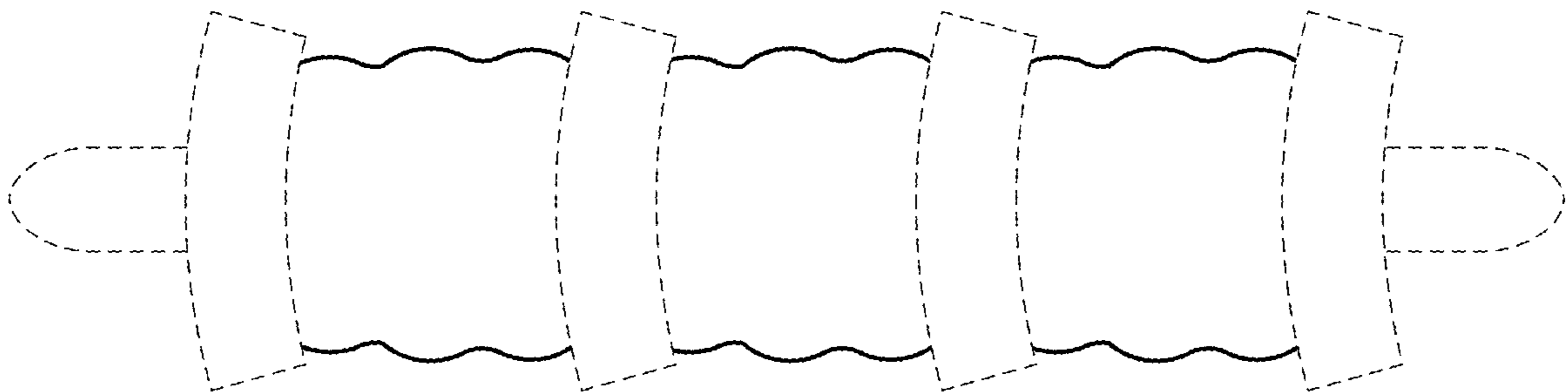

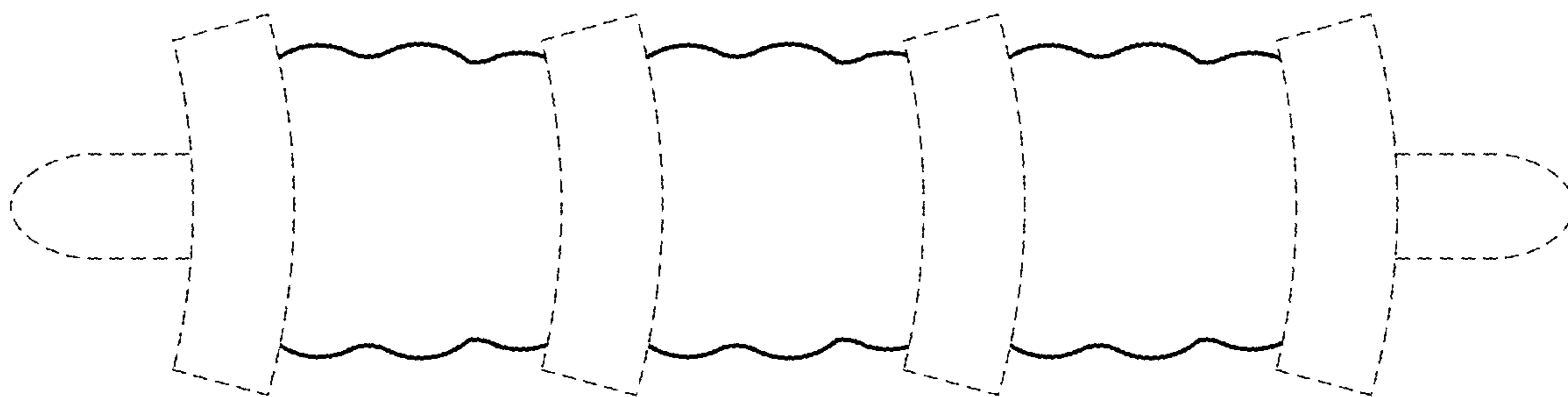
