The ornamental design for a men's sports short, as shown and described.

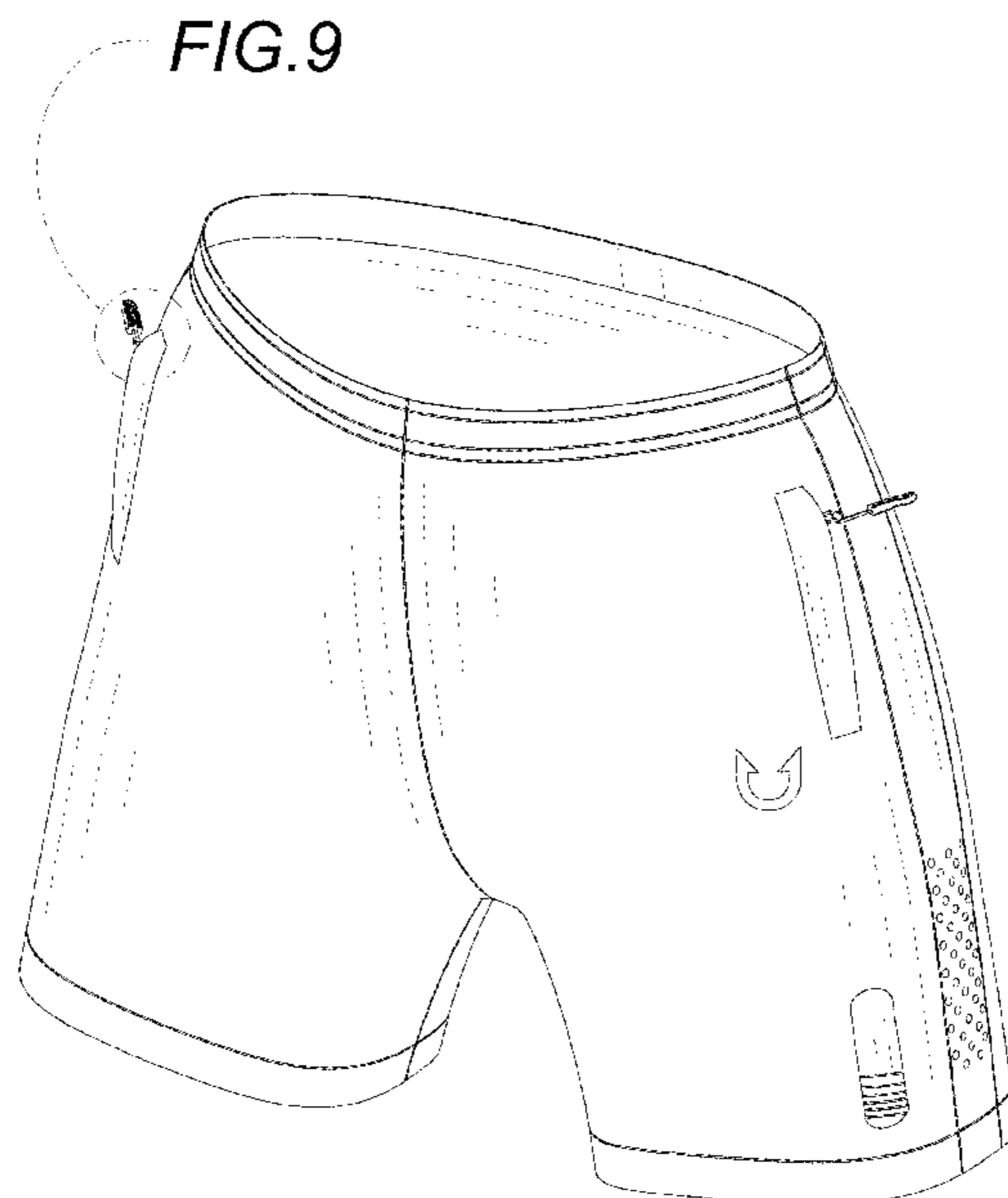
DESCRIPTION

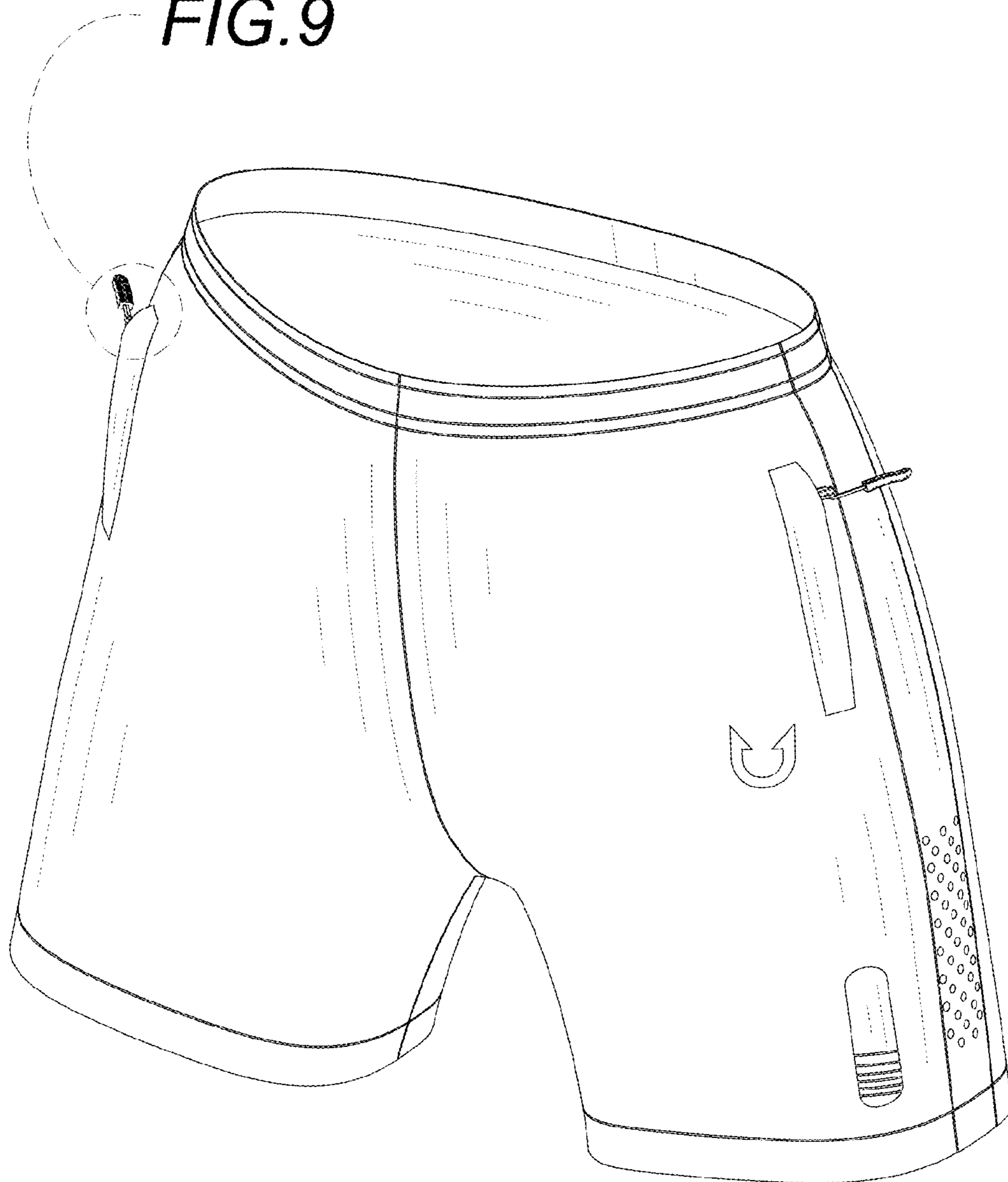

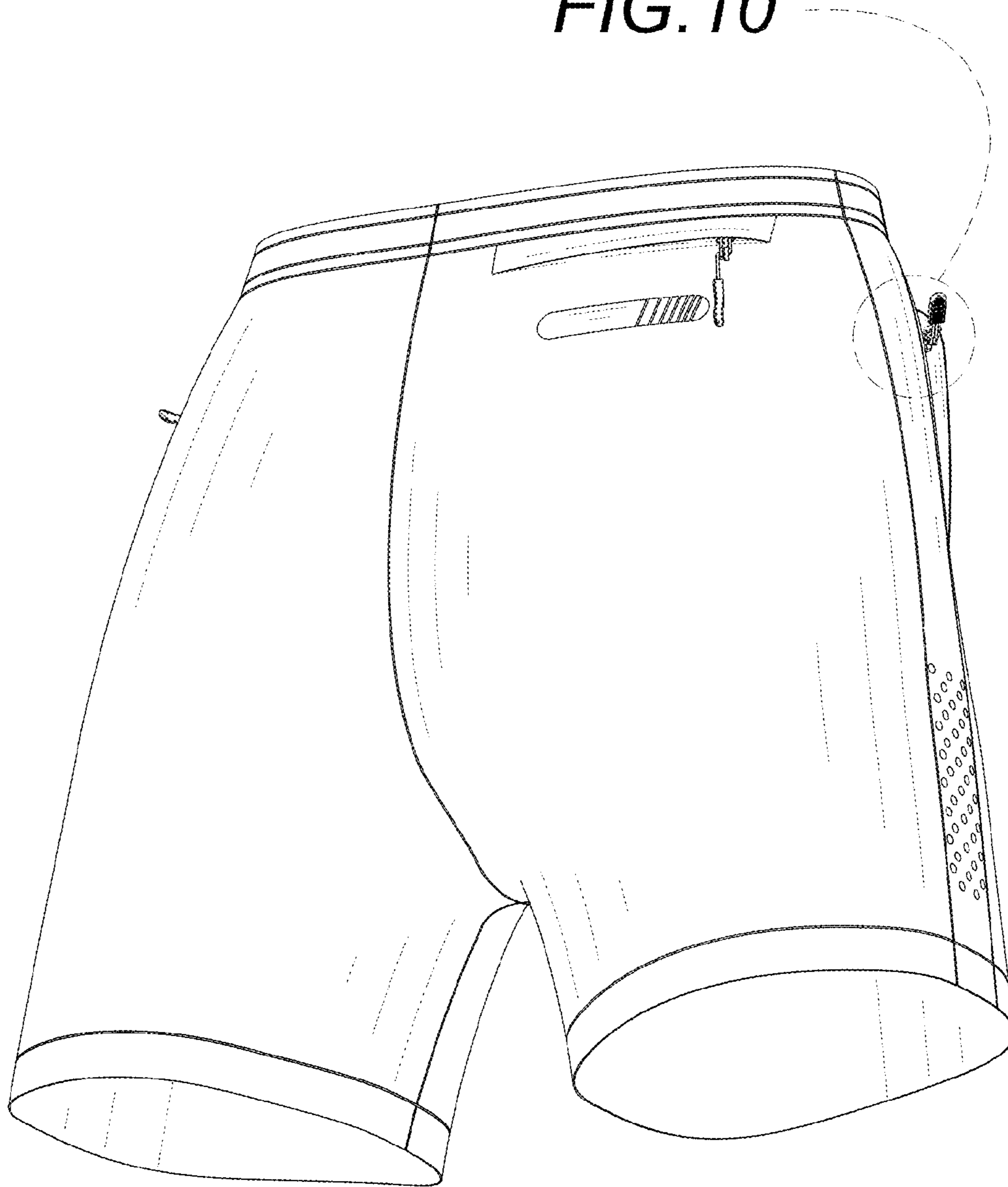

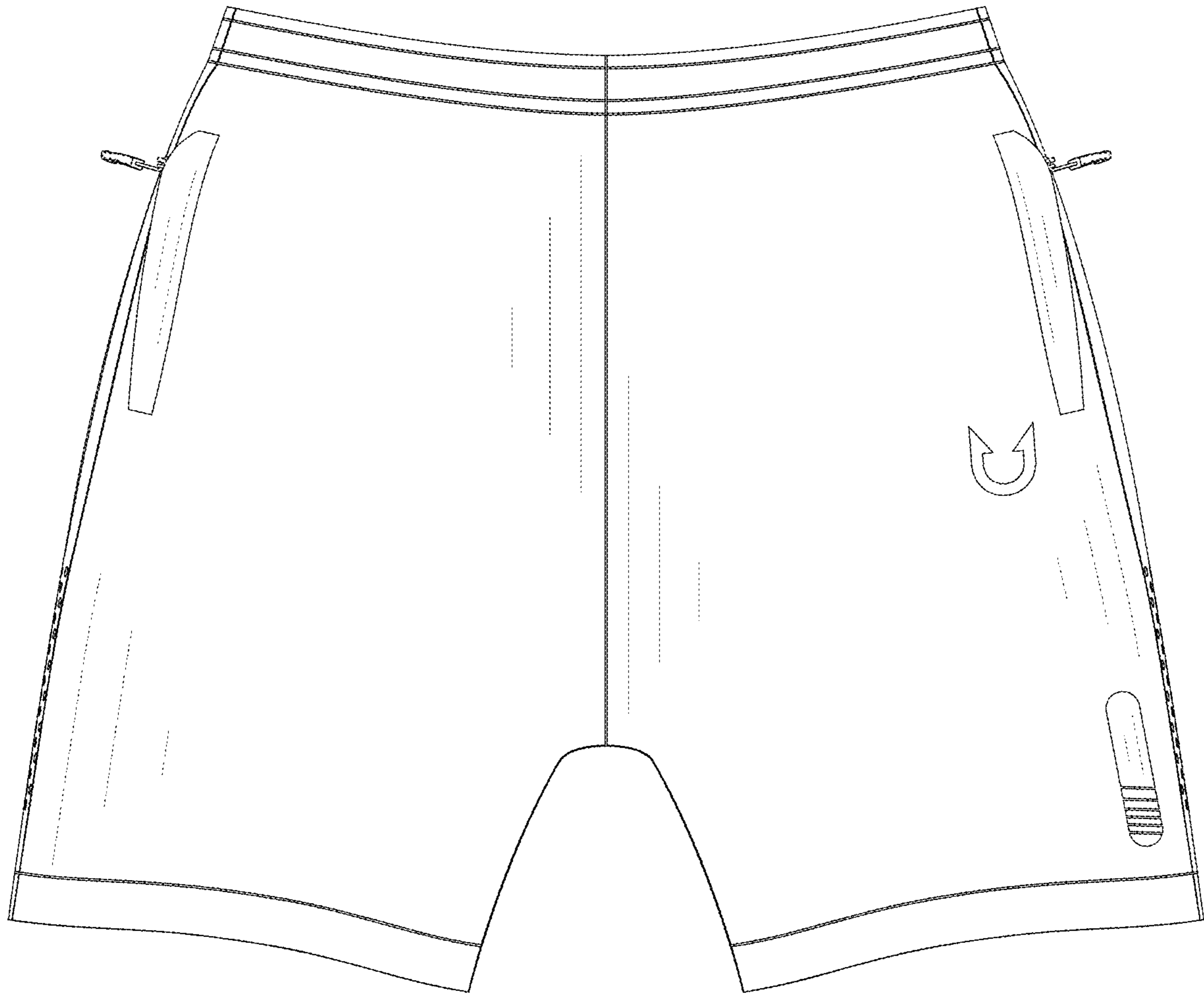

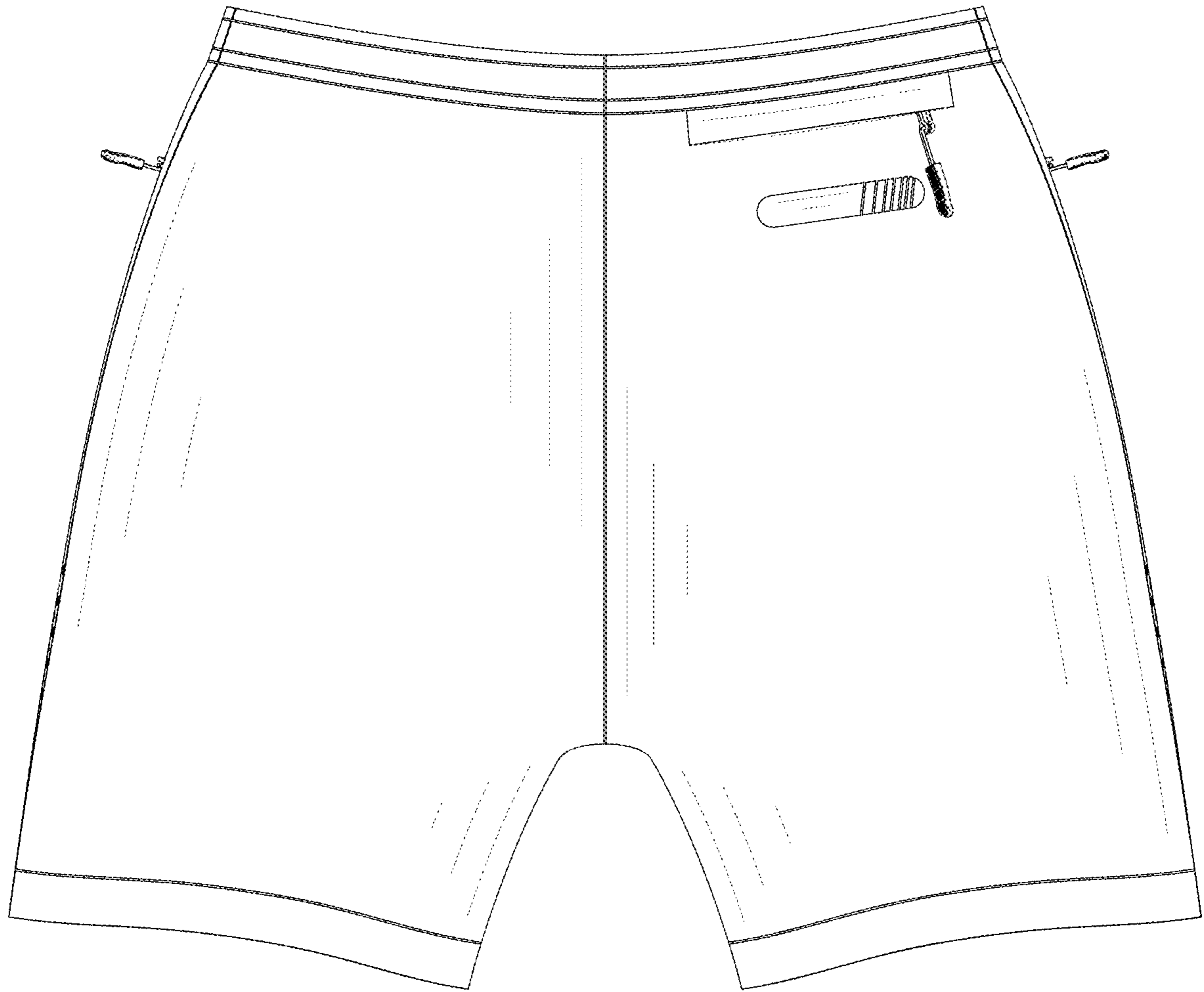

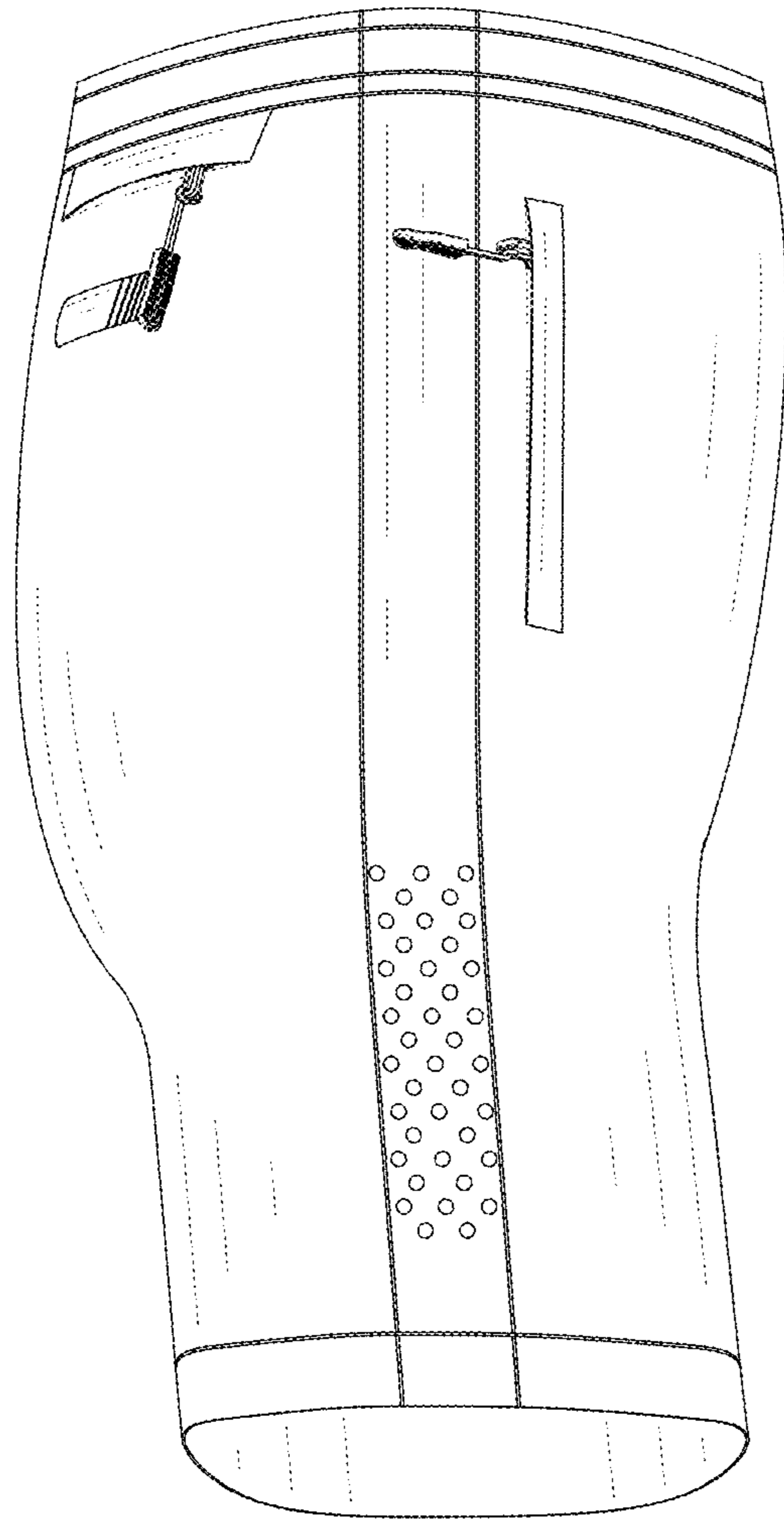

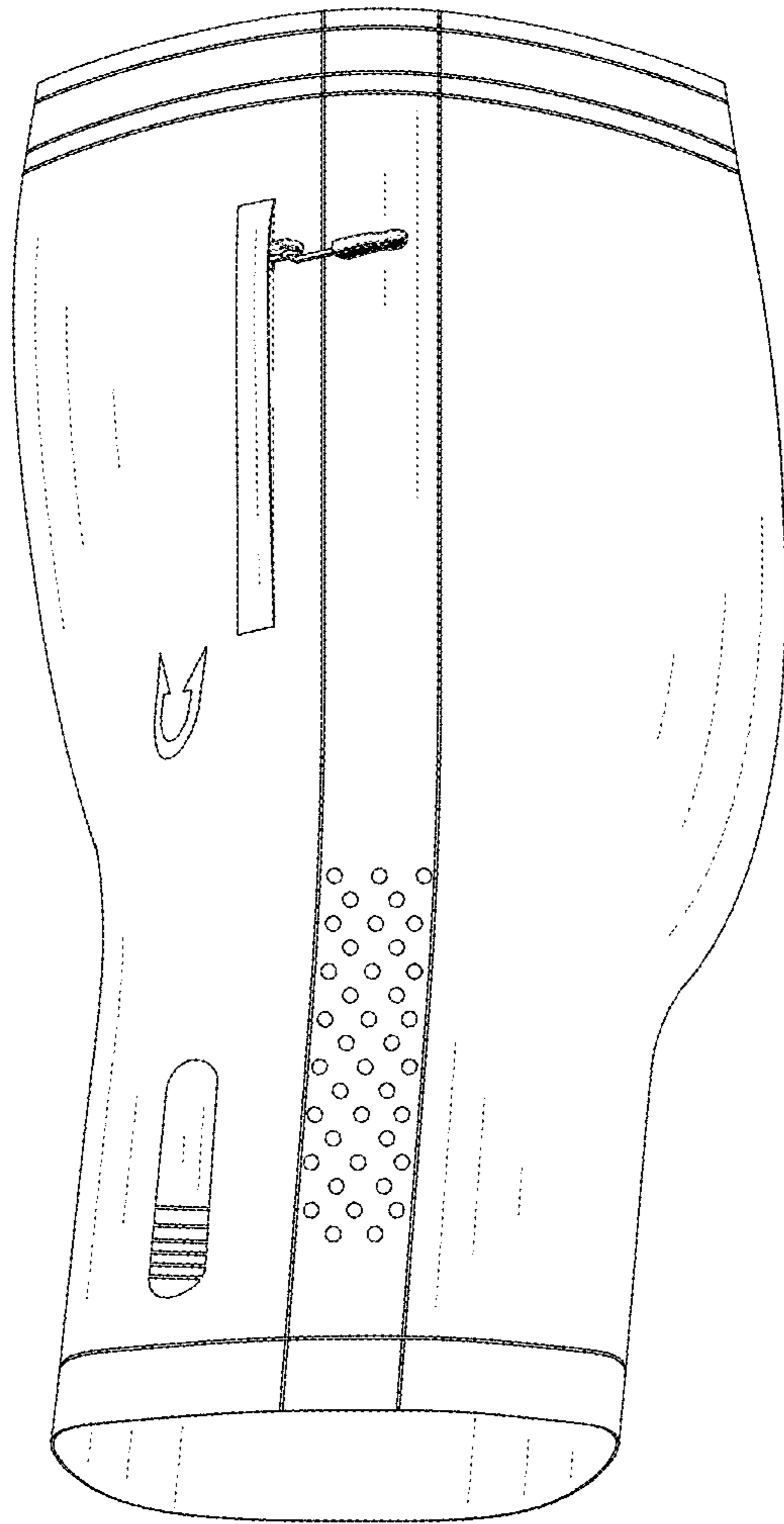

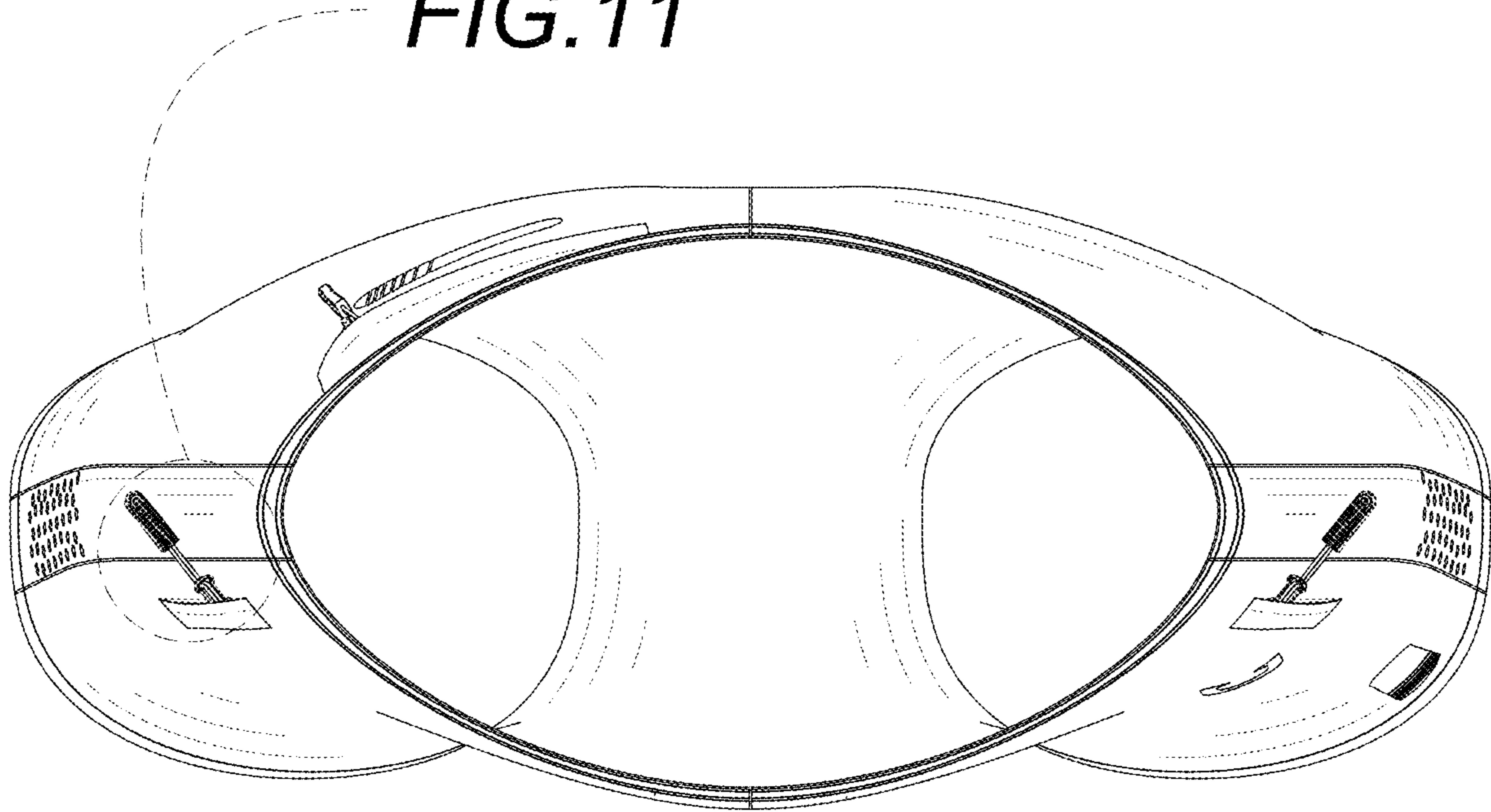

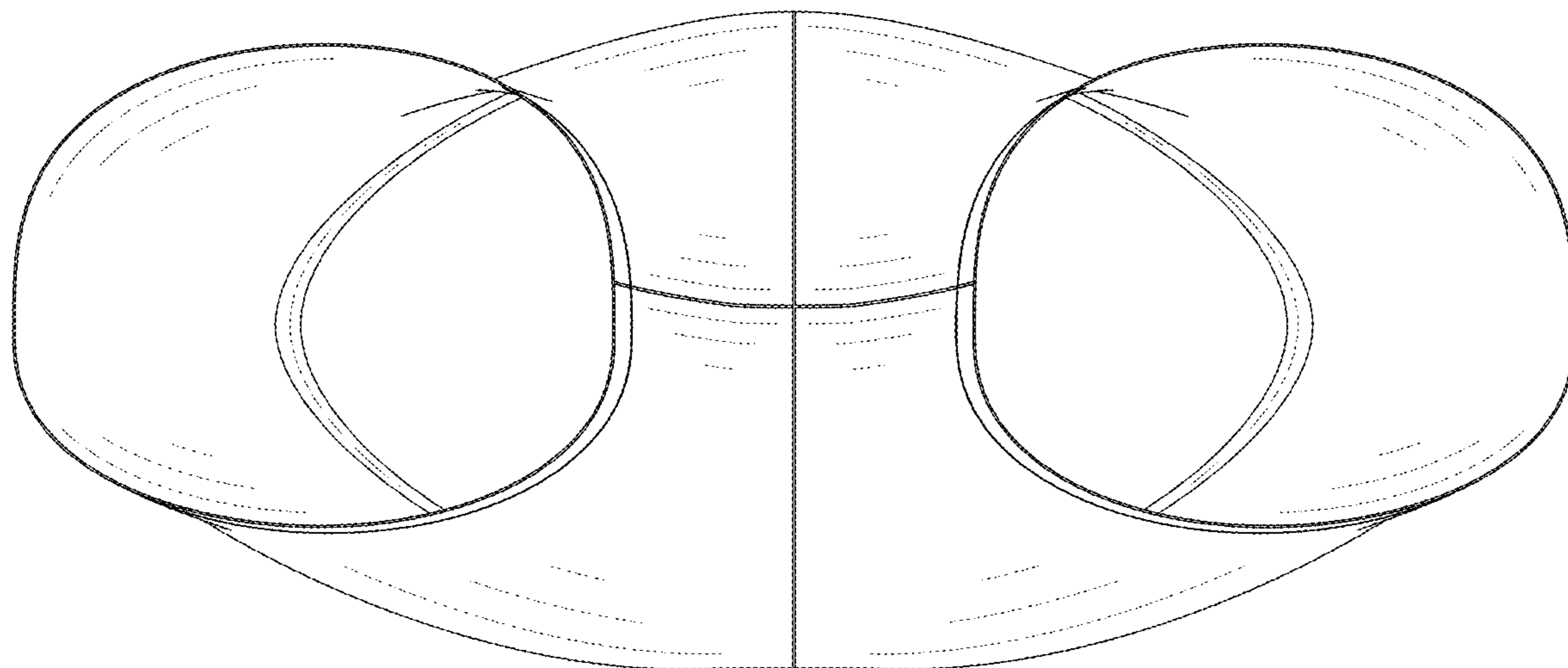

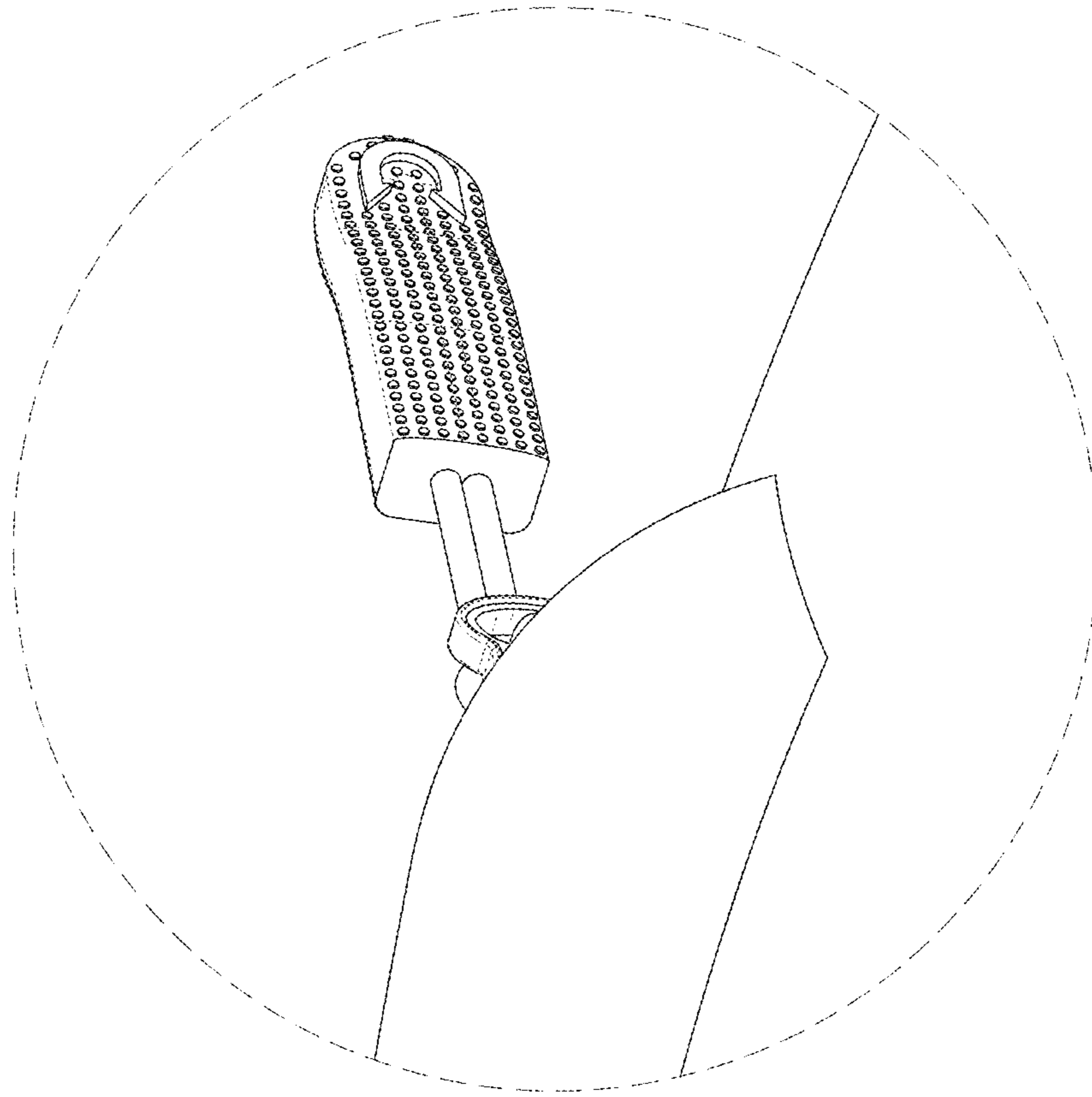

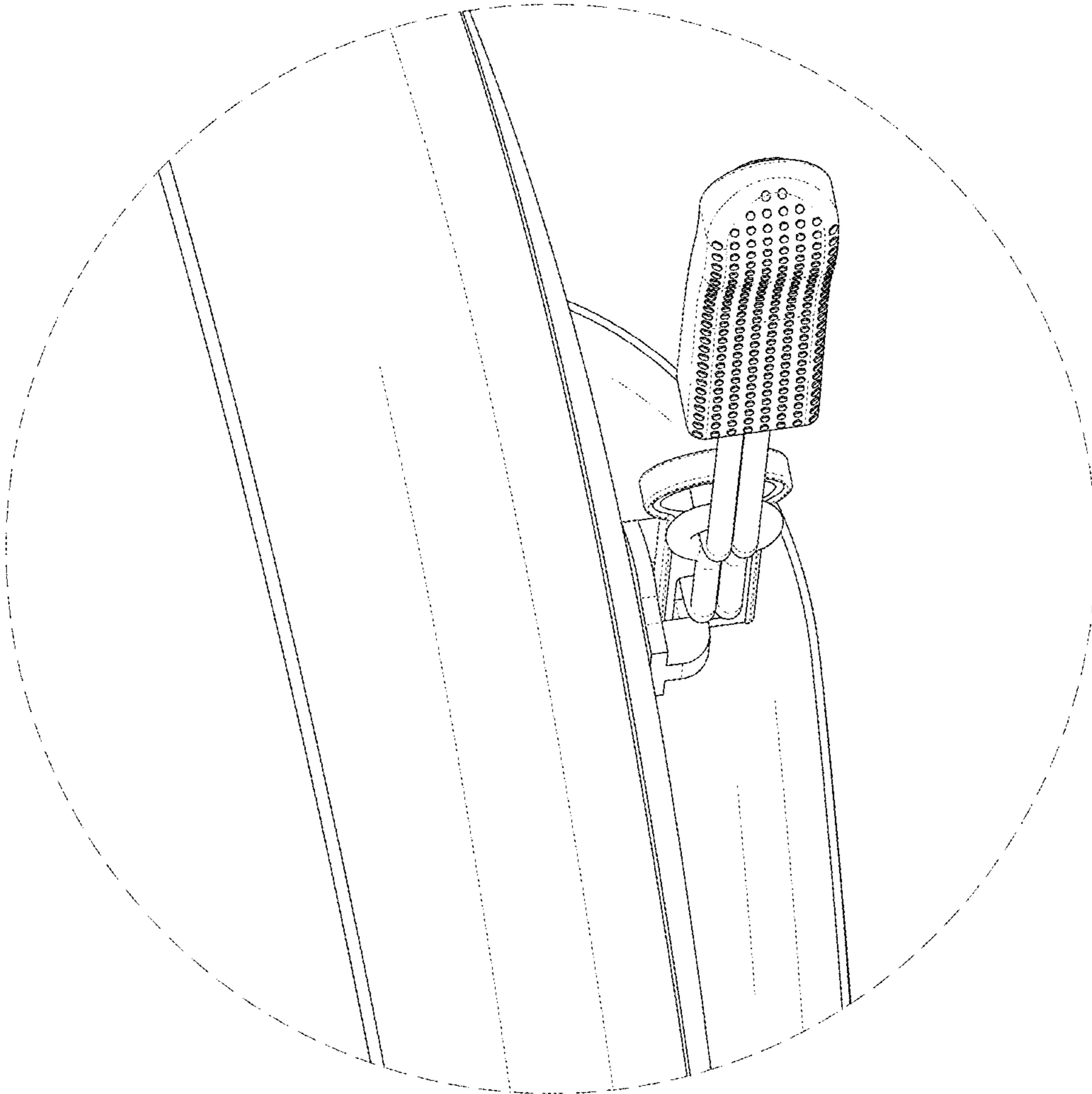

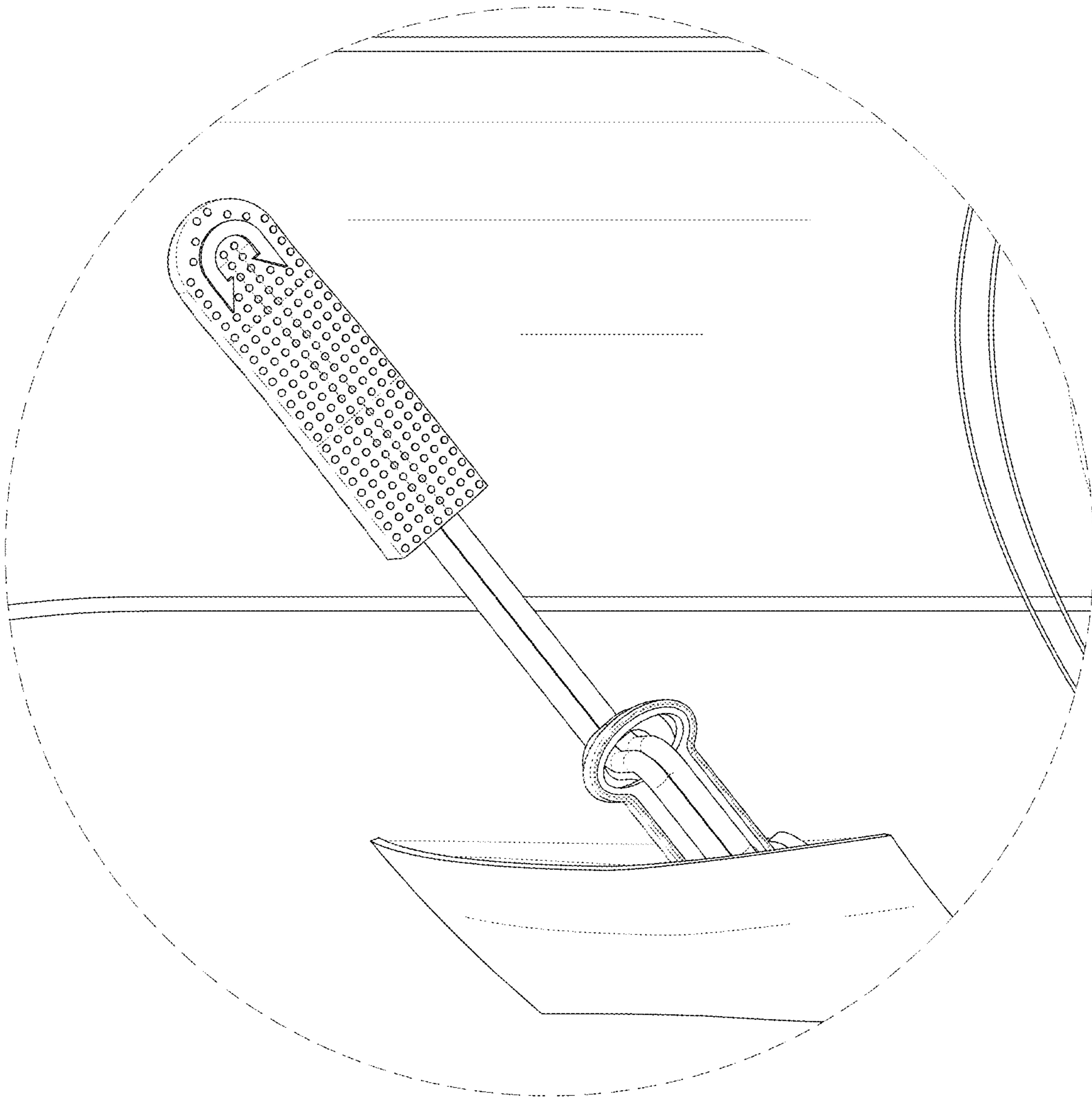
