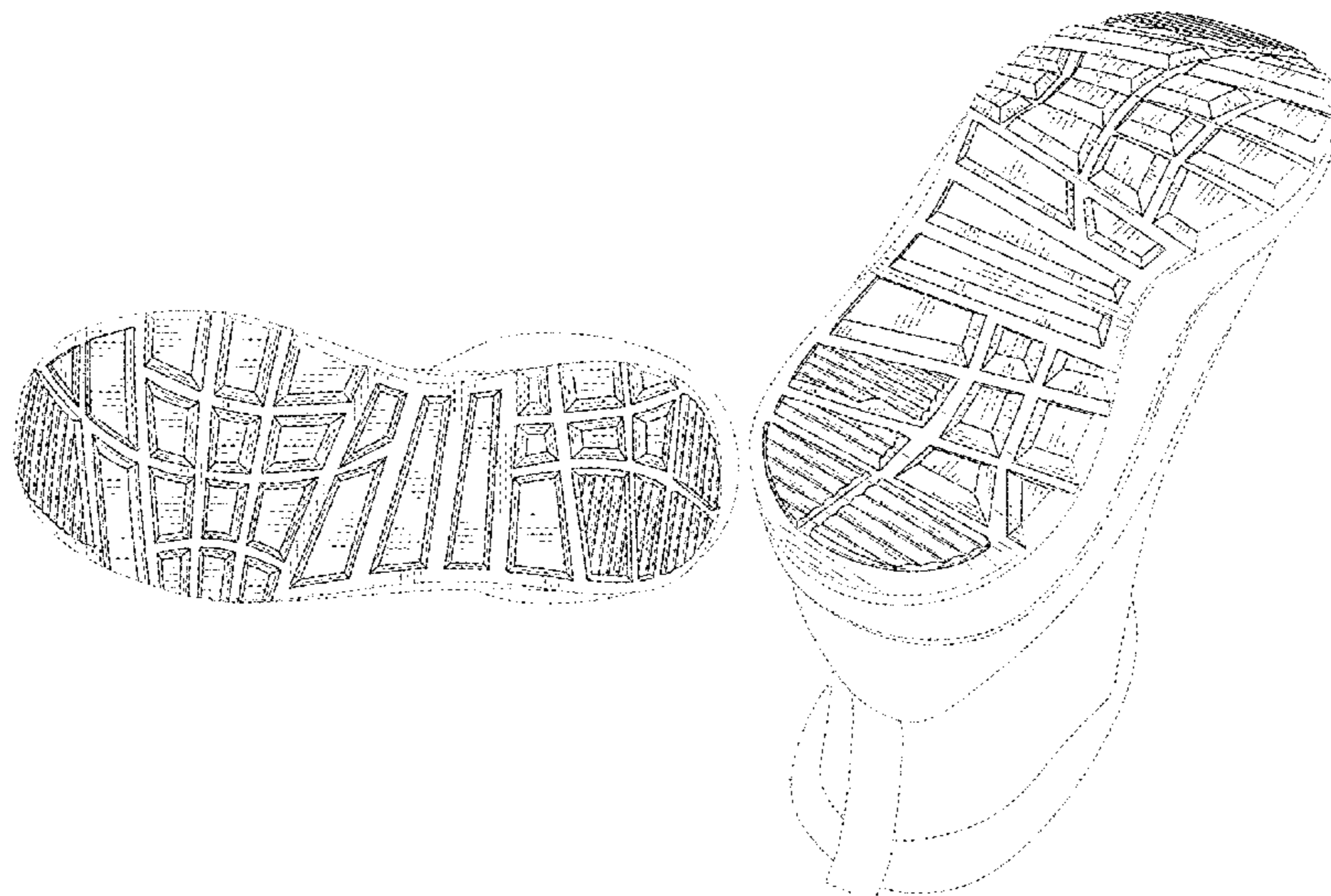
The ornamental design for a footwear, as shown and

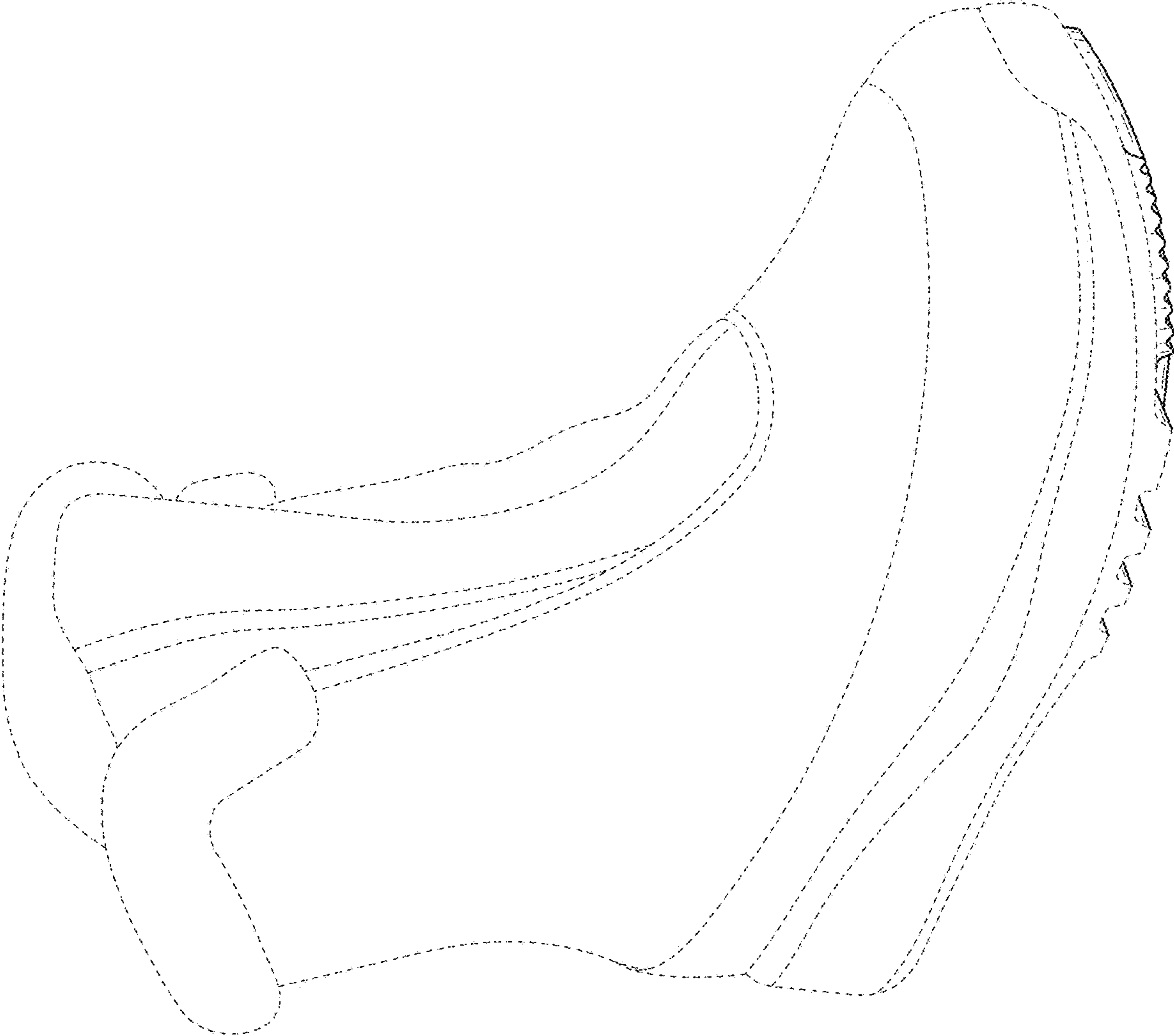

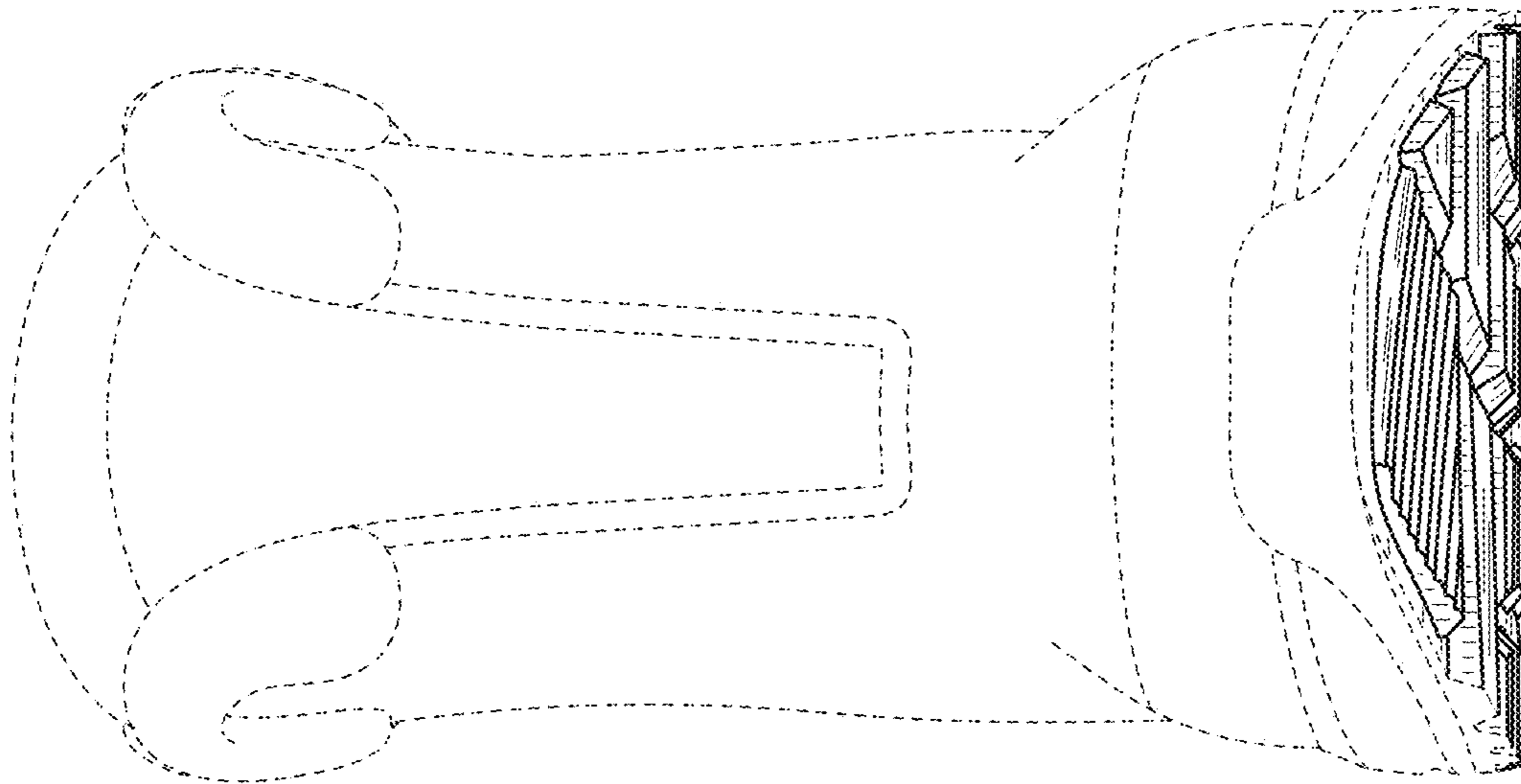

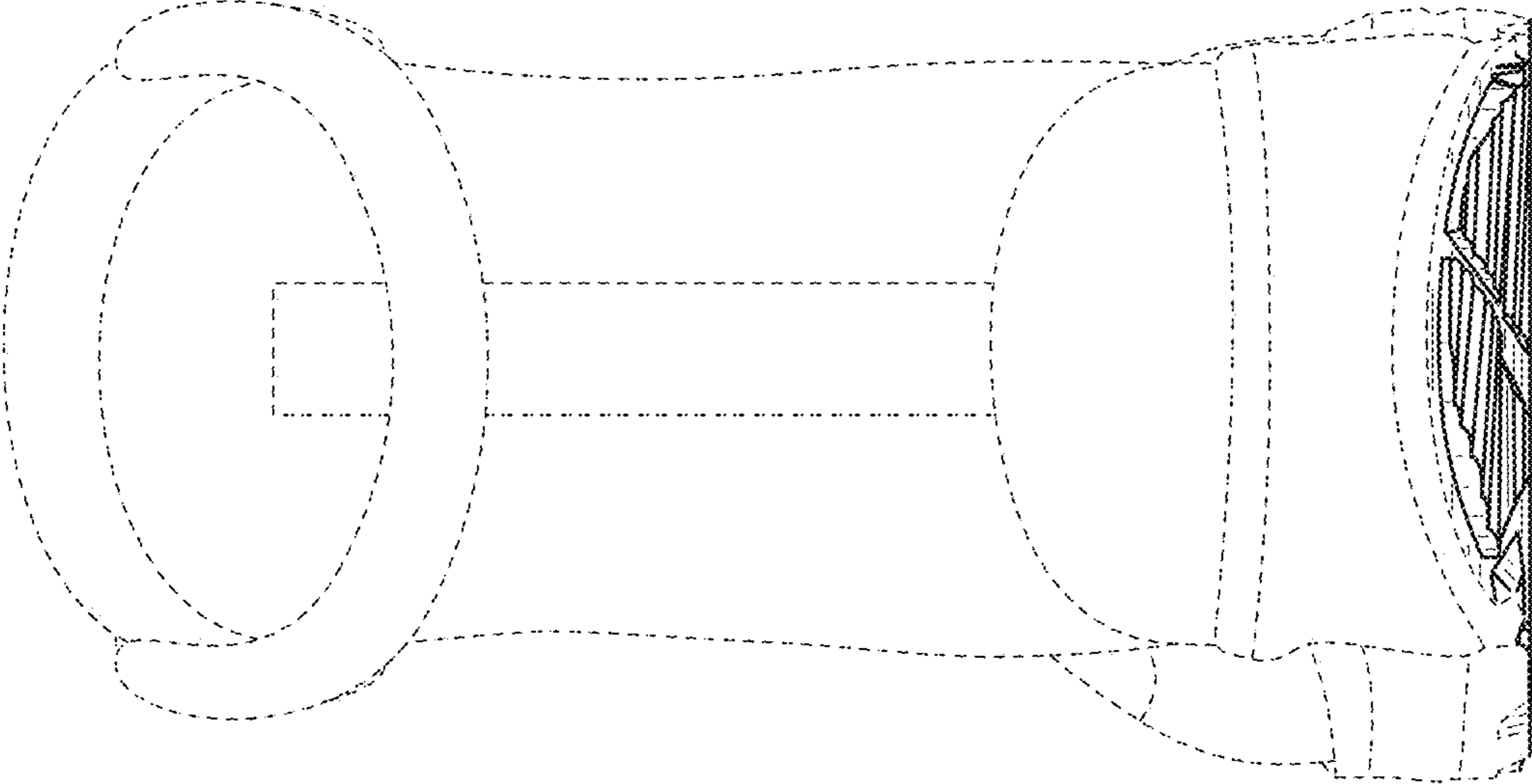

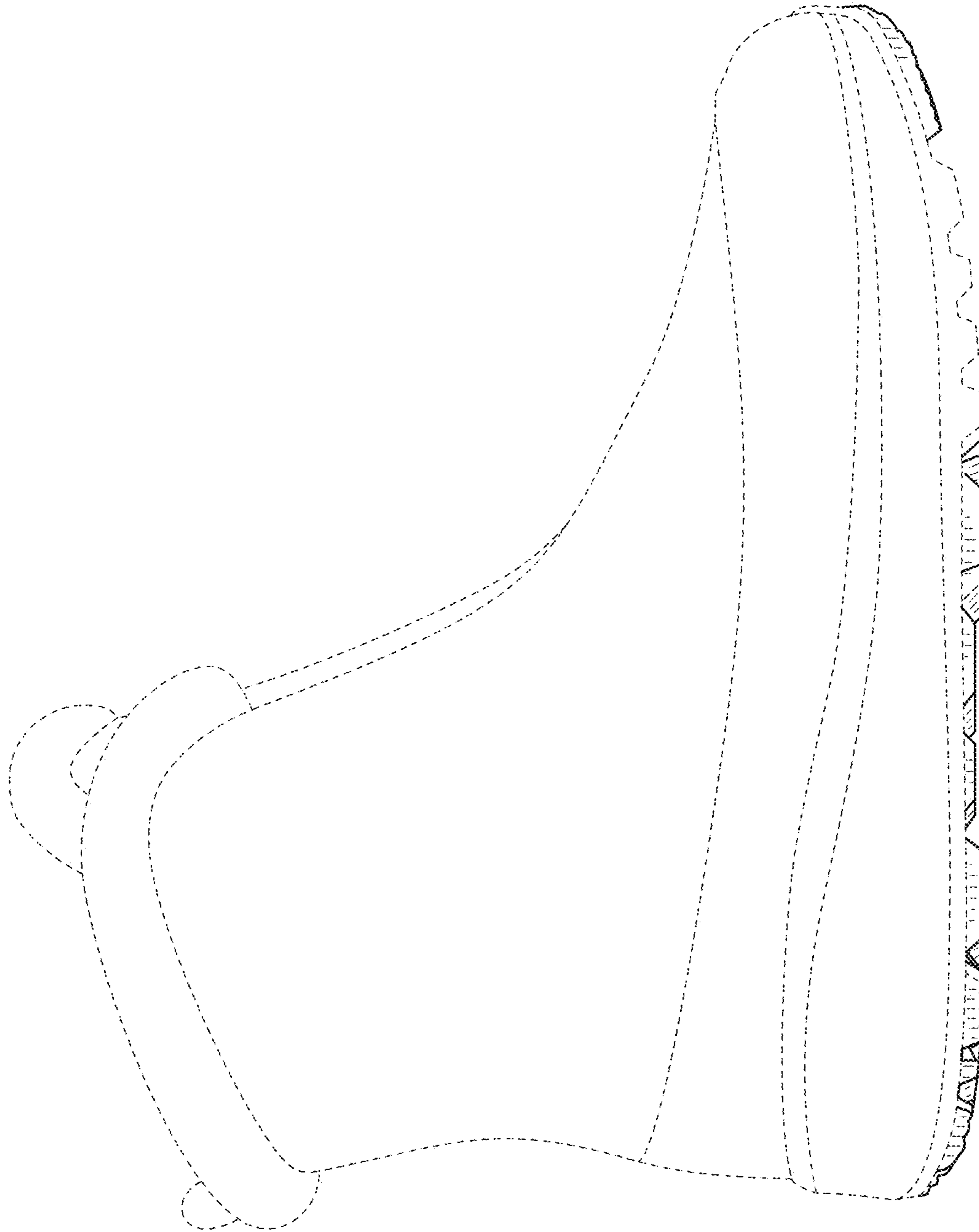

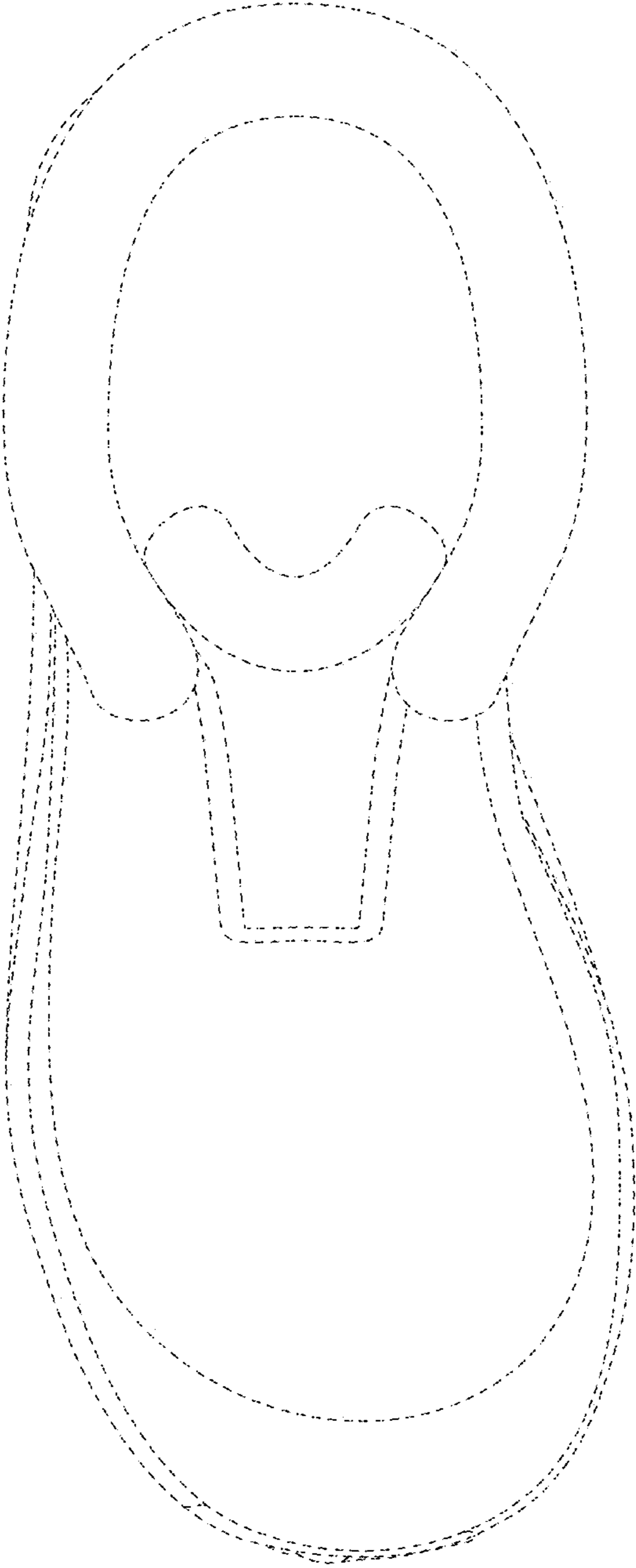

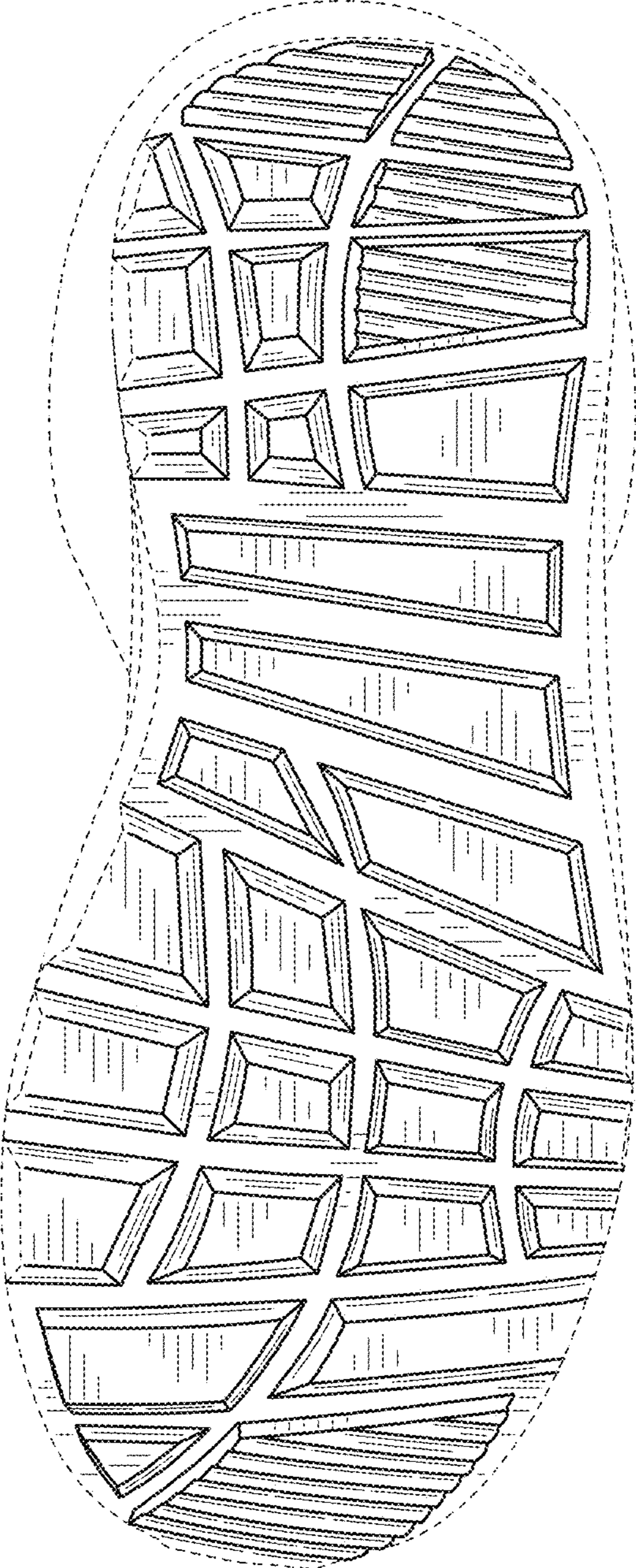

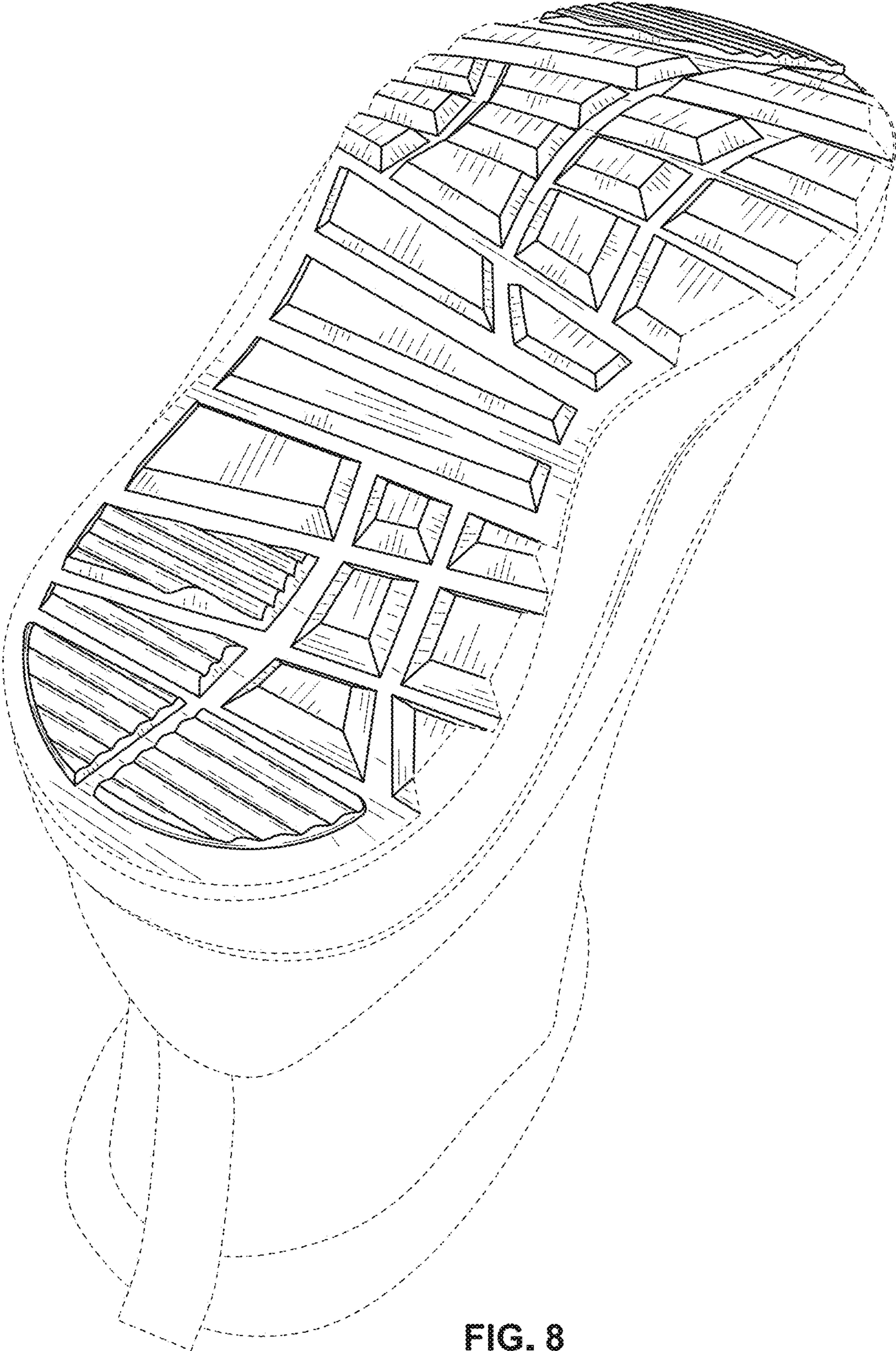
