The ornamental design for a toiletry bag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a toiletry bag showing my new design where the toiletry bag is in a first configuration of use;

FIG. 2 is another perspective view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a right side elevational view thereof;

FIG. 7 is a top plan view thereof;

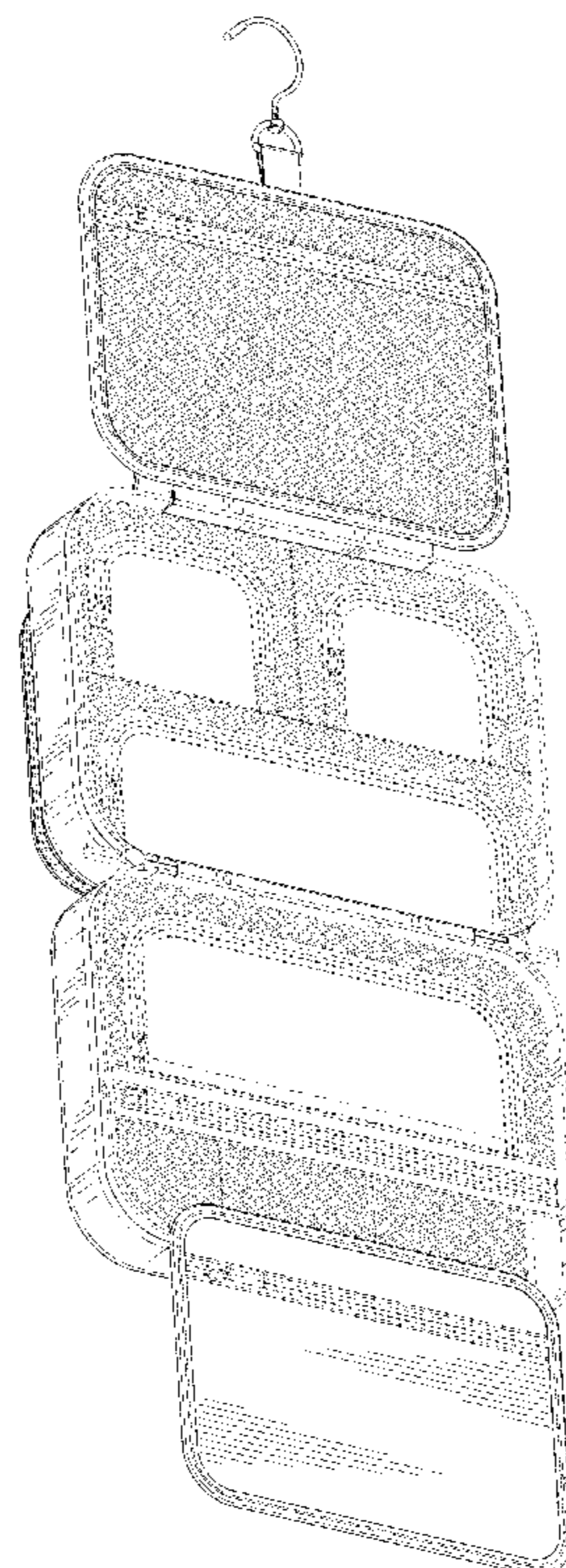
FIG. 8 is a bottom plan view thereof;

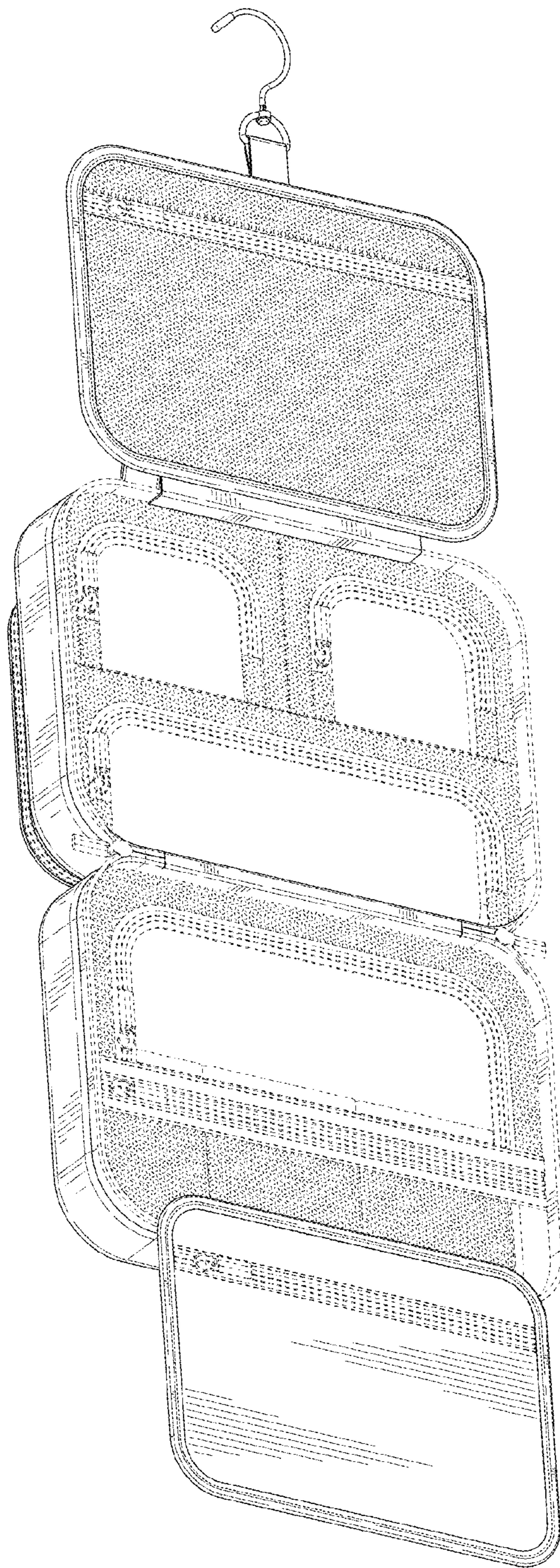

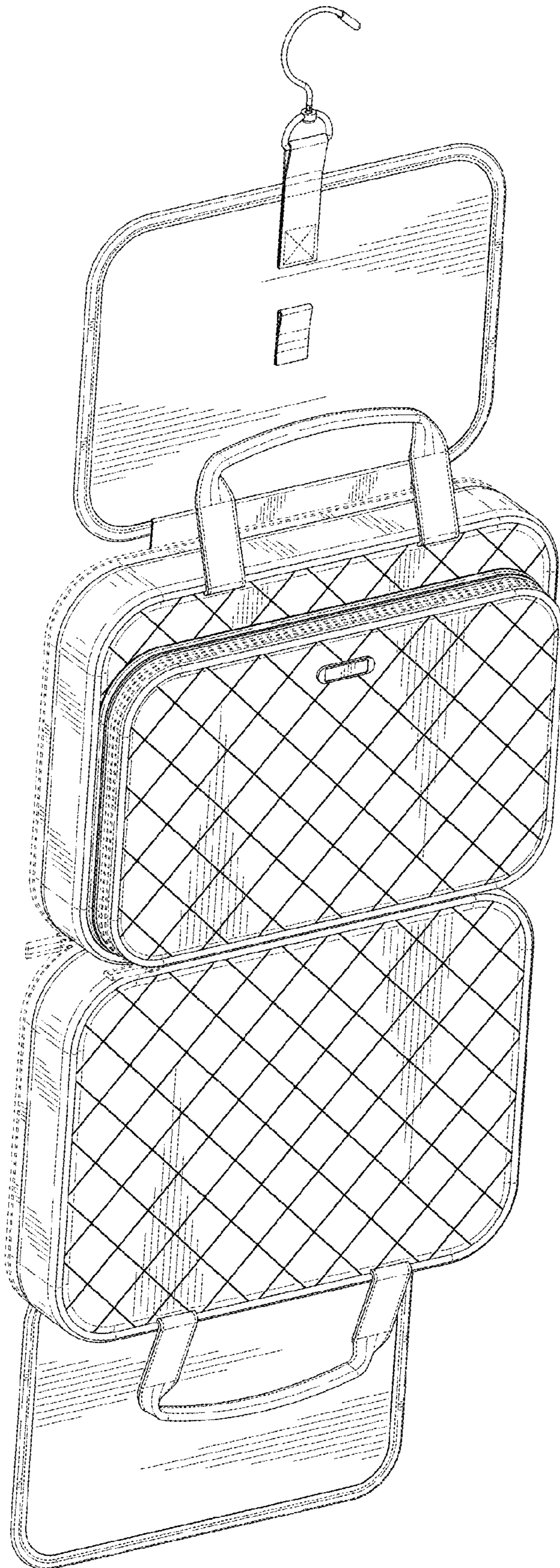

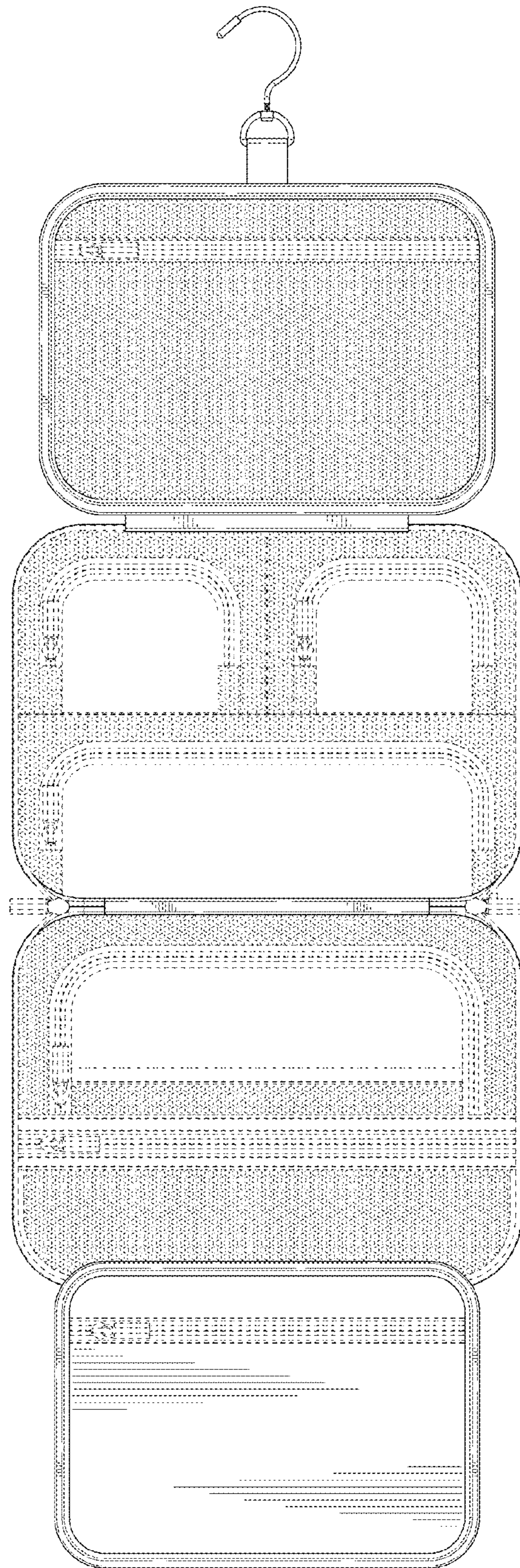

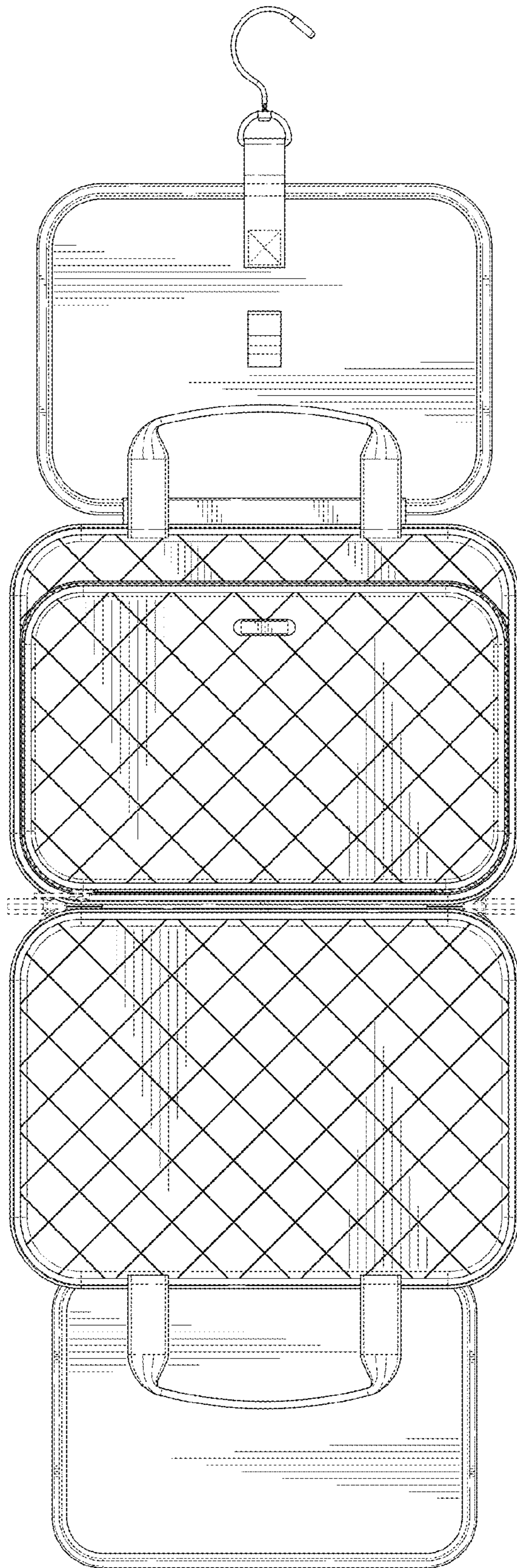

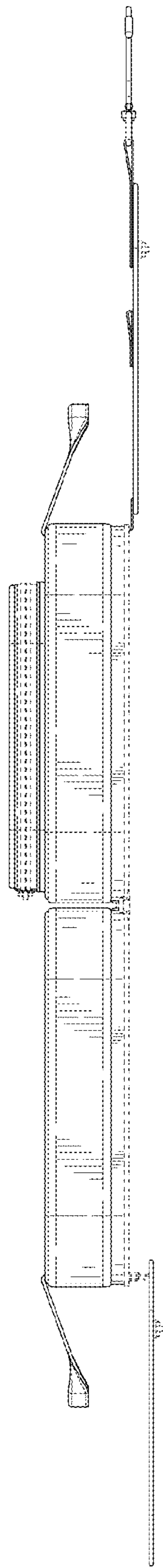

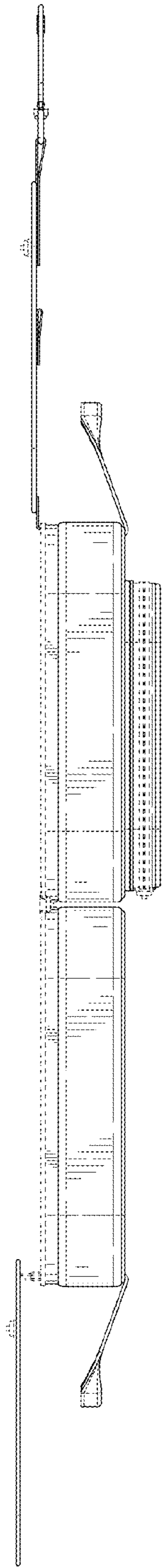

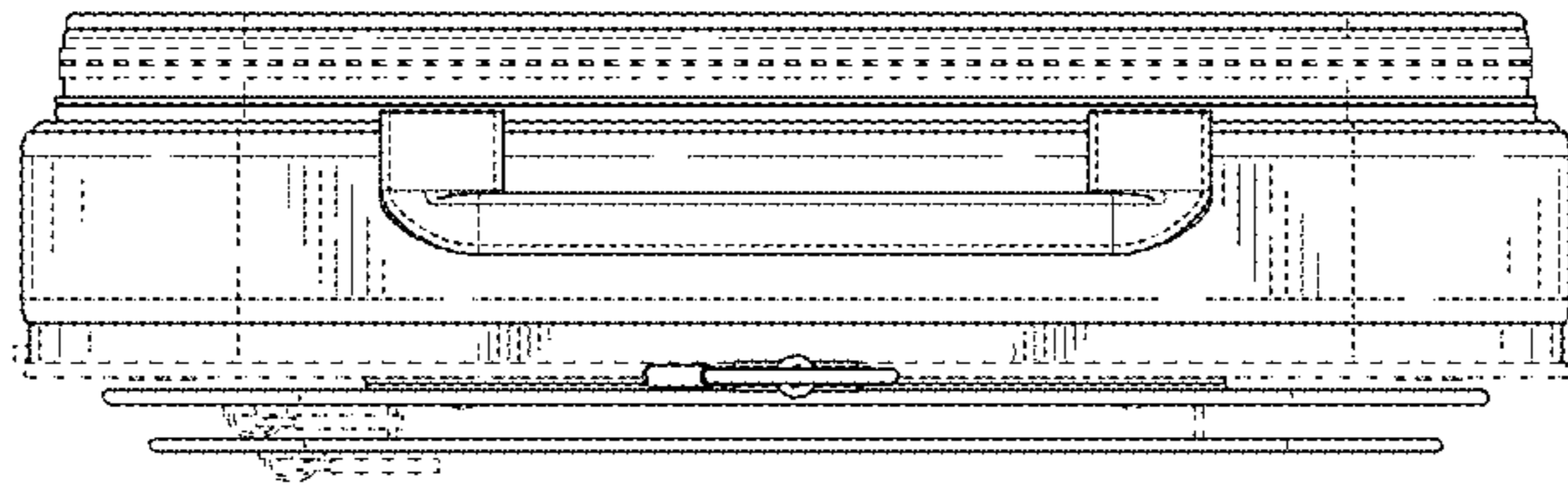

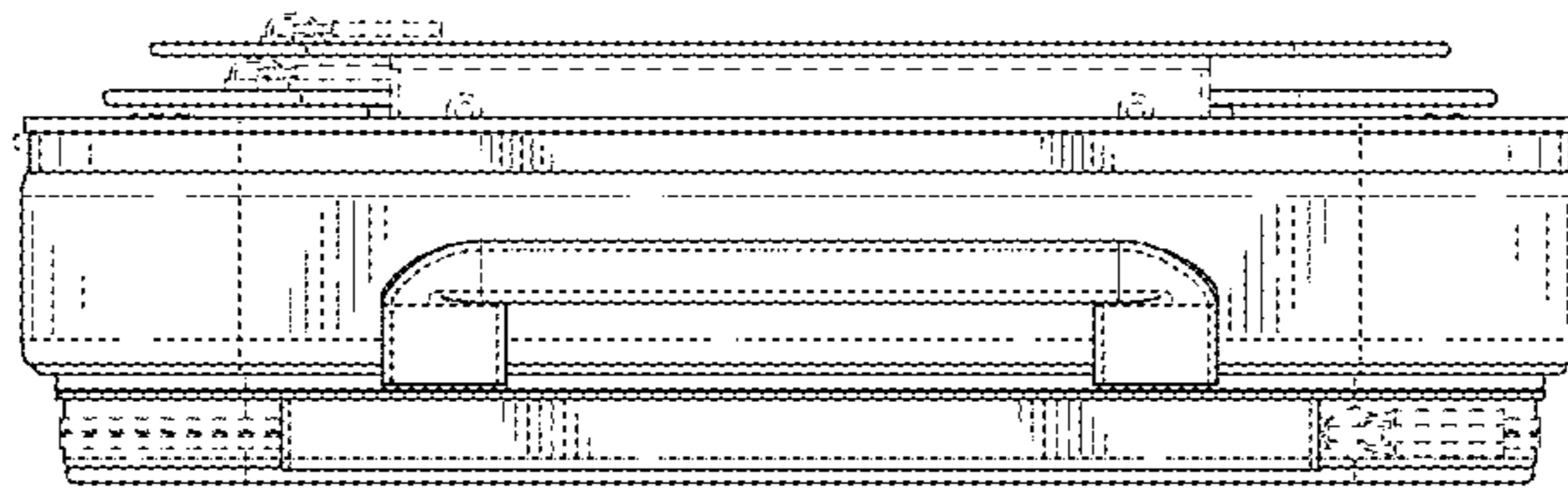
