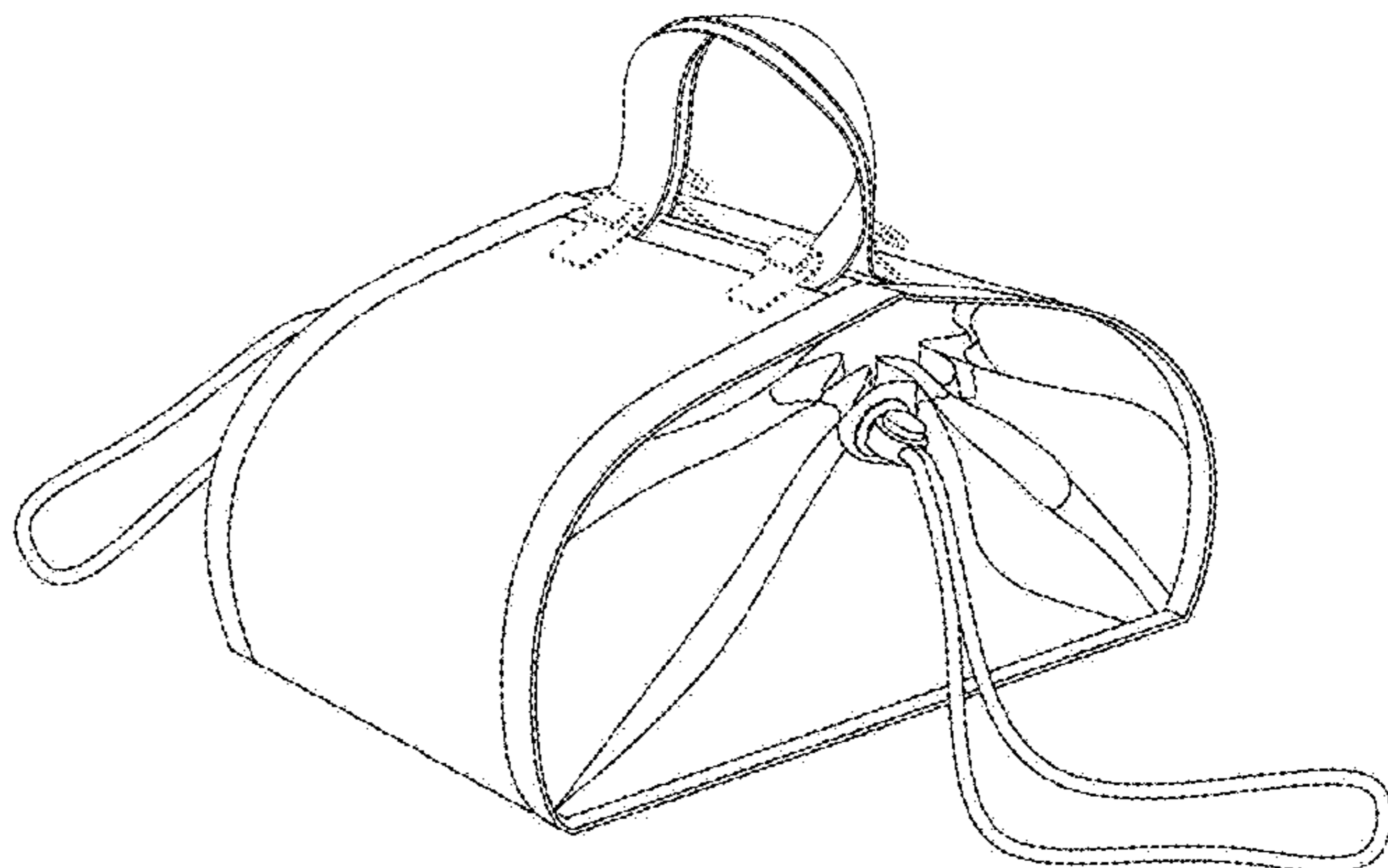
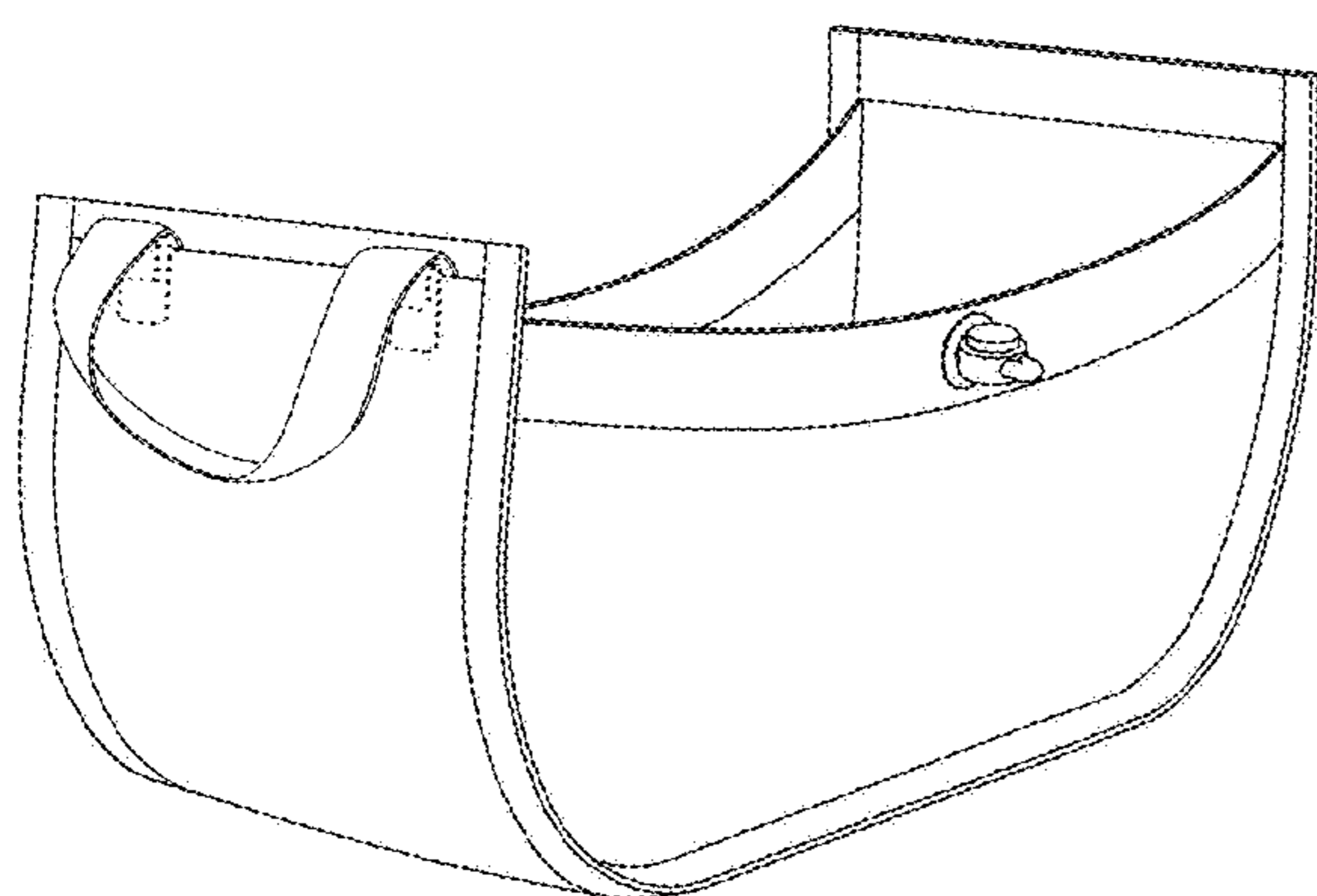
(57) **CLAIM**

The ornamental design for a bag for baby carriage, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and left side perspective view of a bag for baby carriage showing my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a top, front, and left side perspective view showing the bag for baby carriage in a closed configuration. The broken lines depict portions of the bag for baby carriage that form no part of the claimed design.

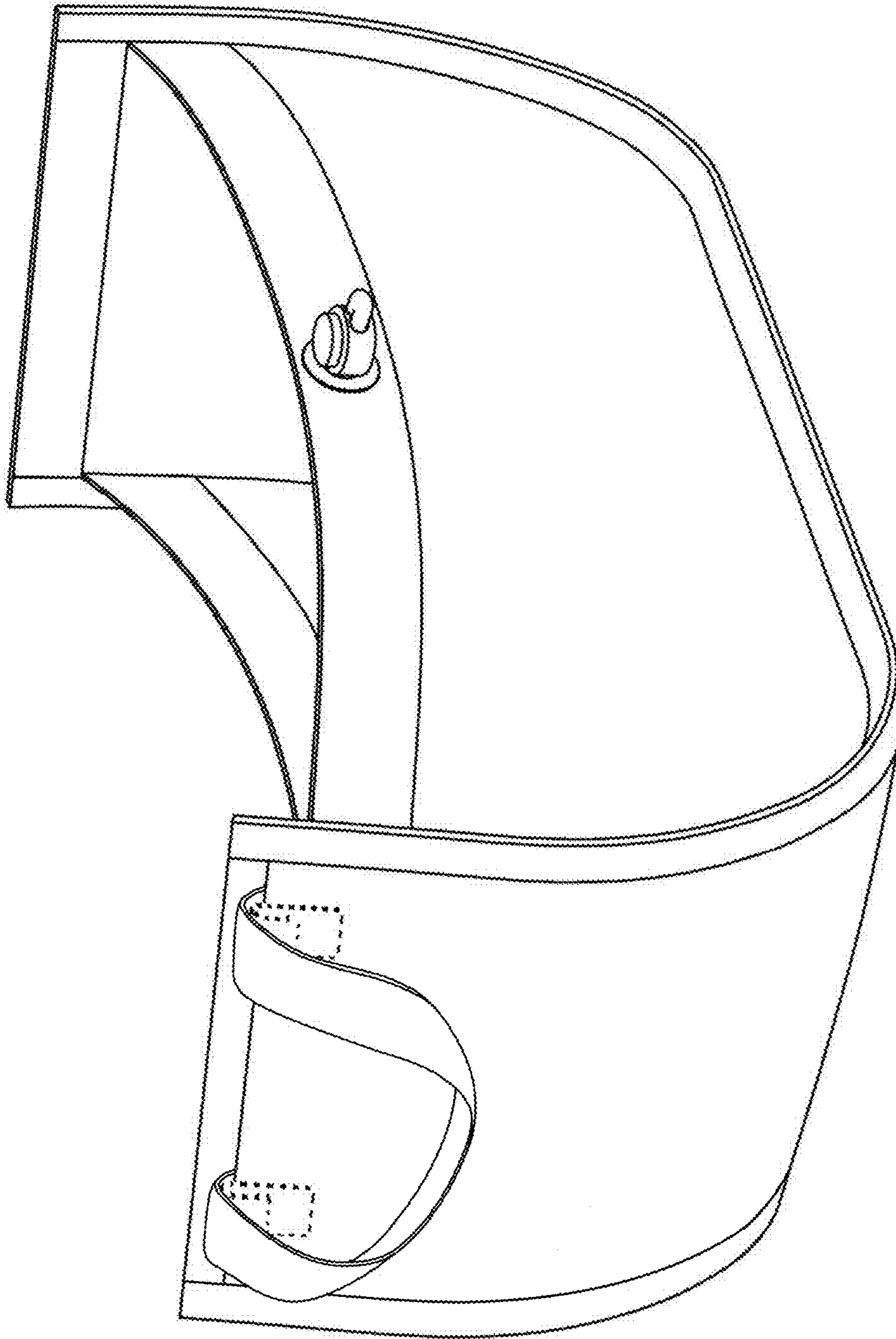

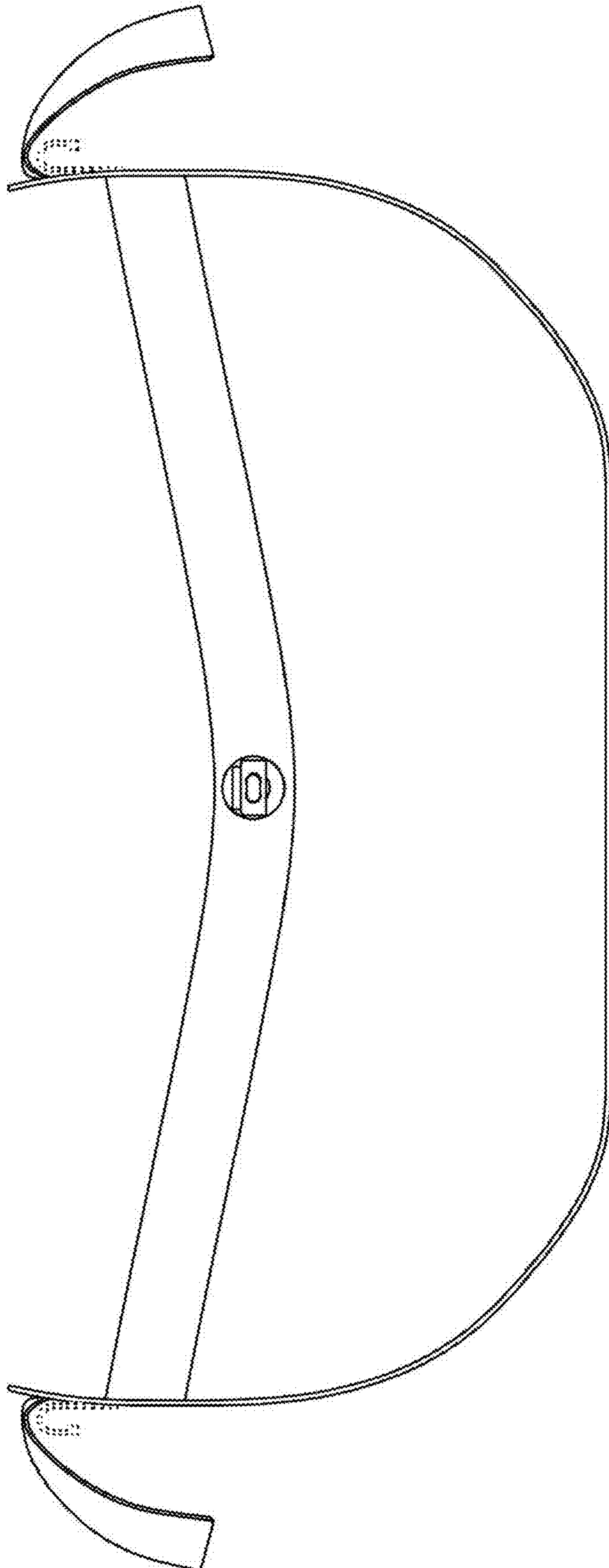

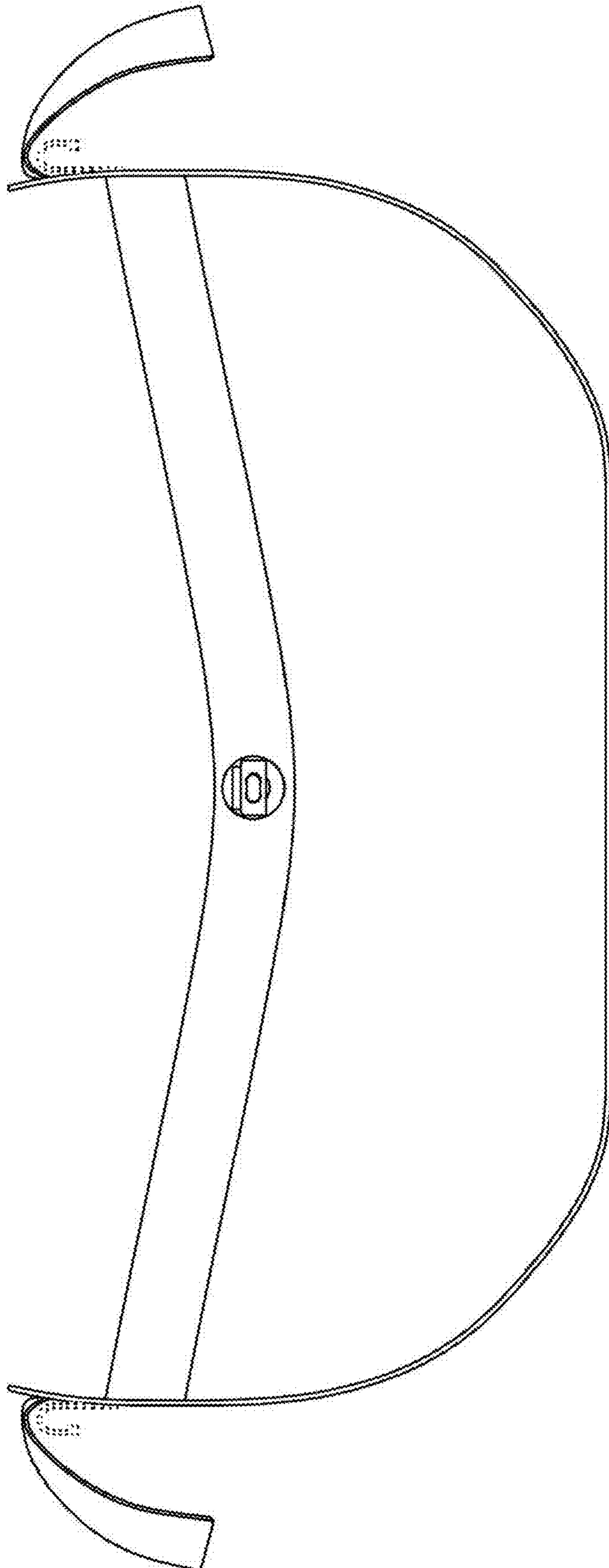

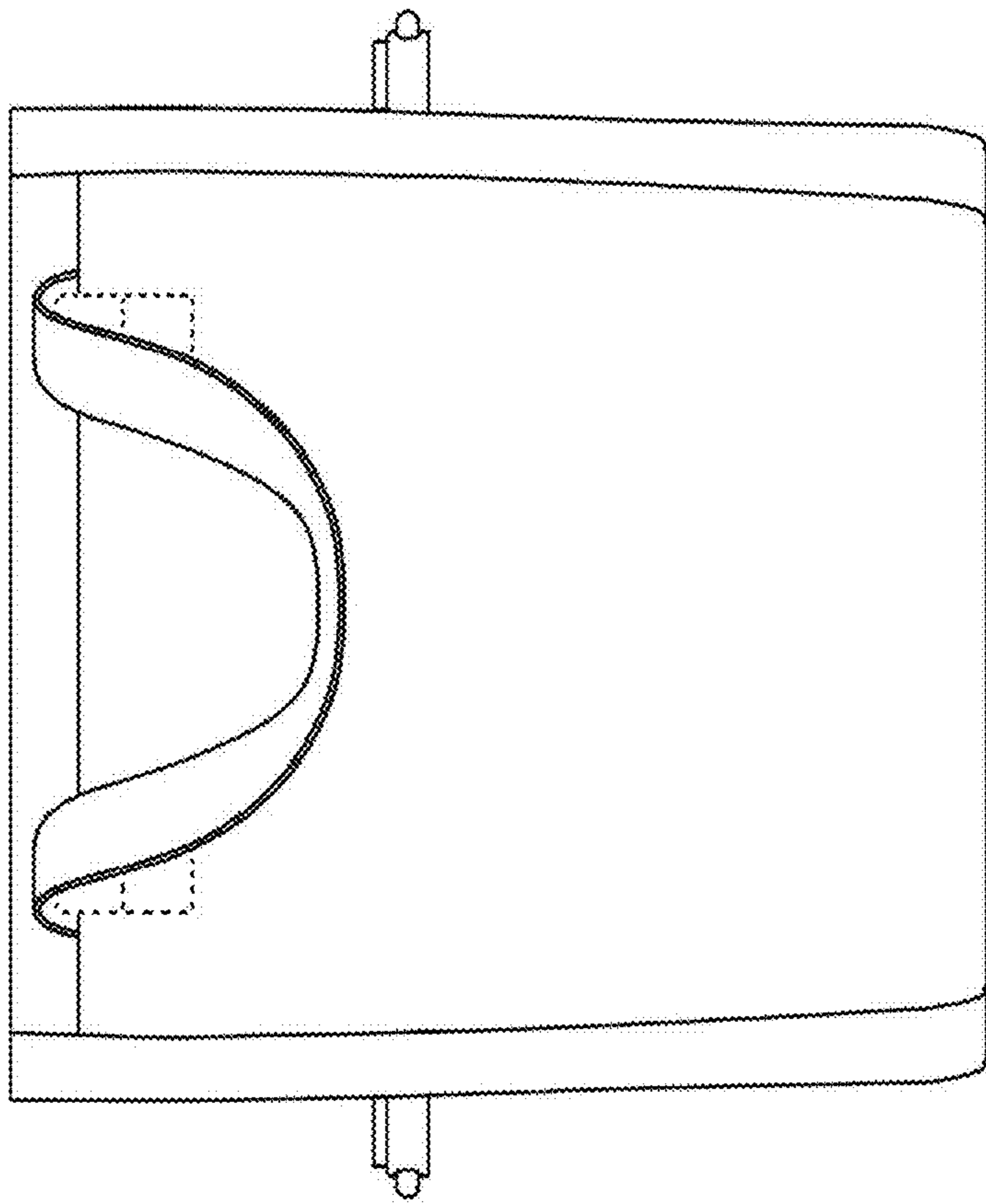

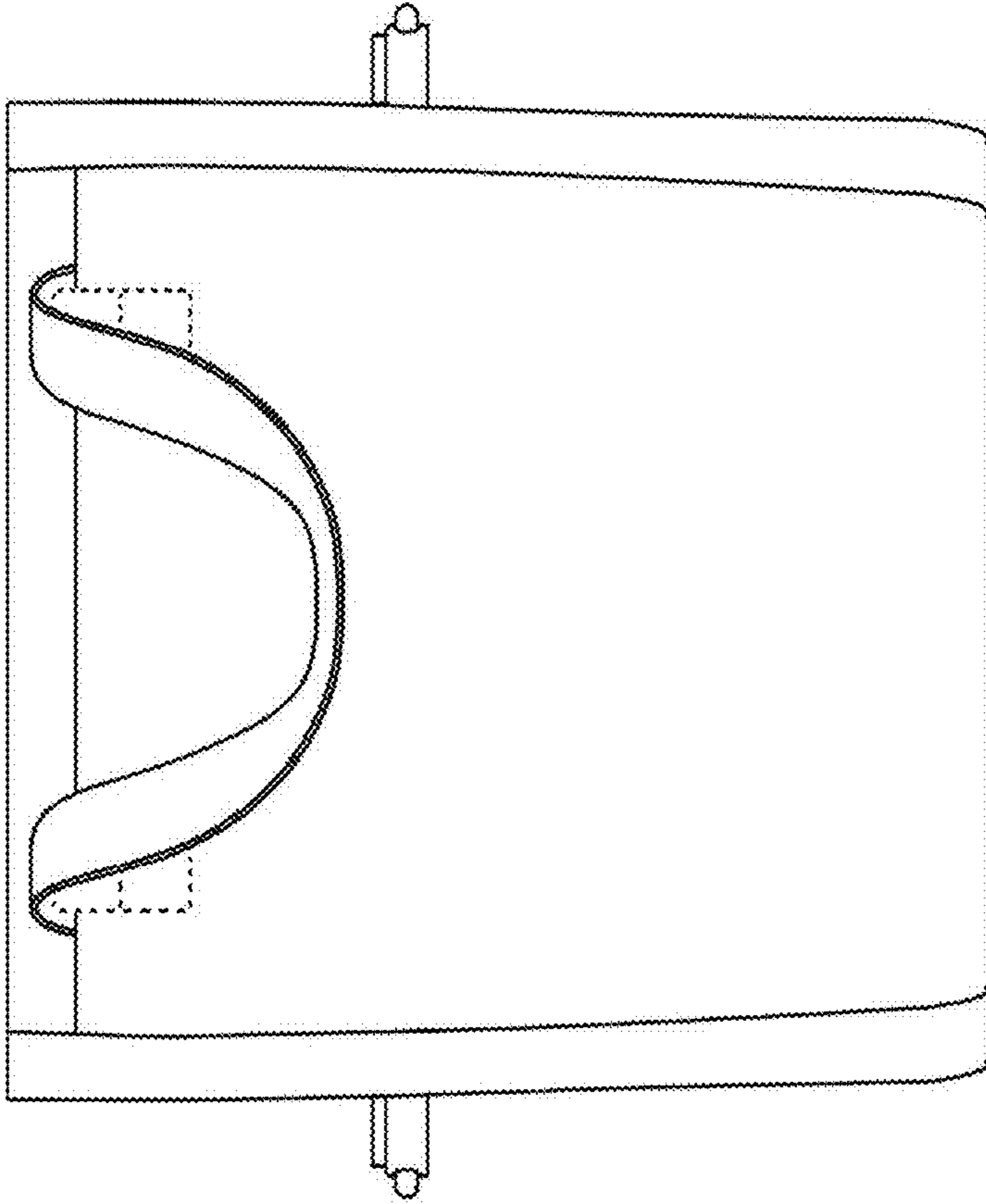

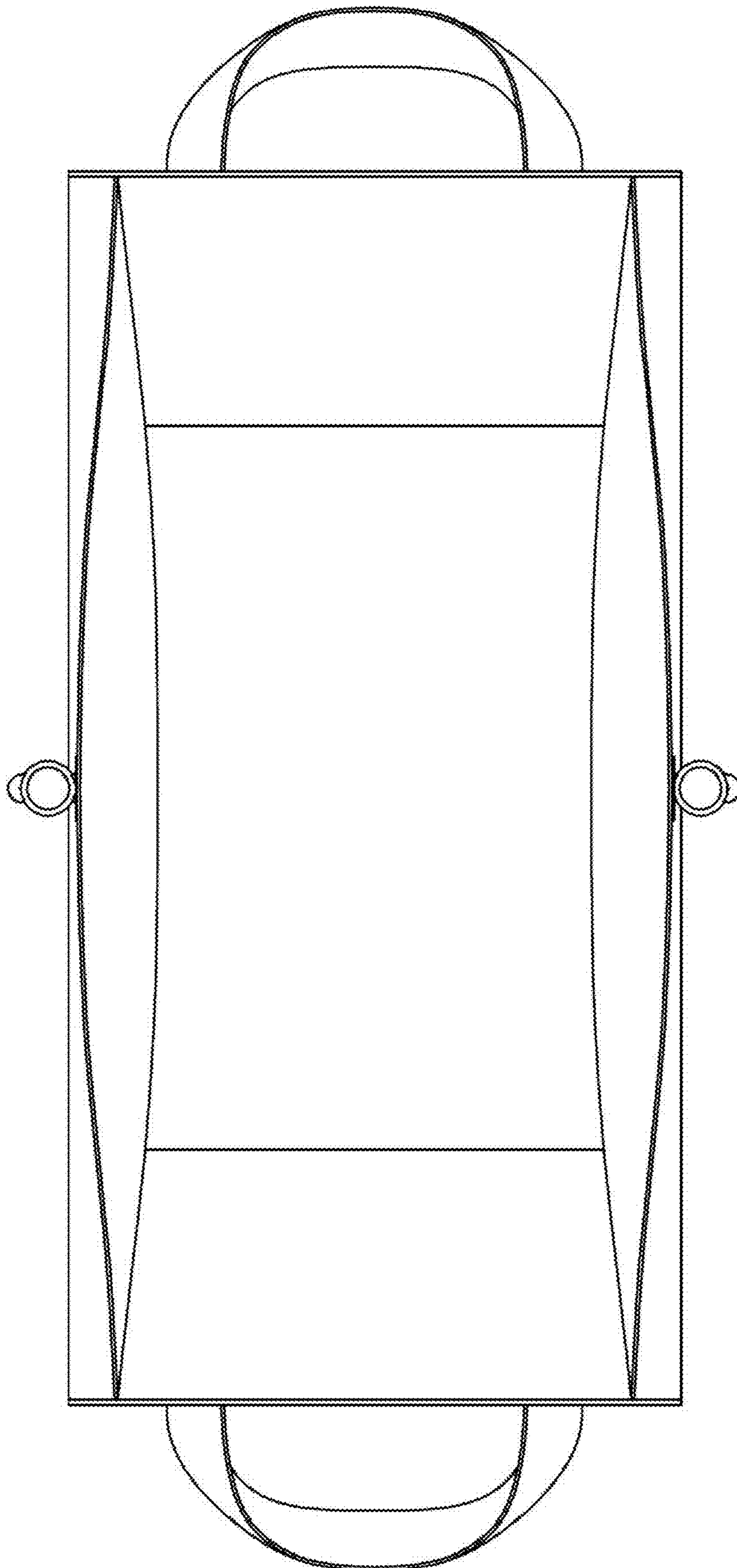

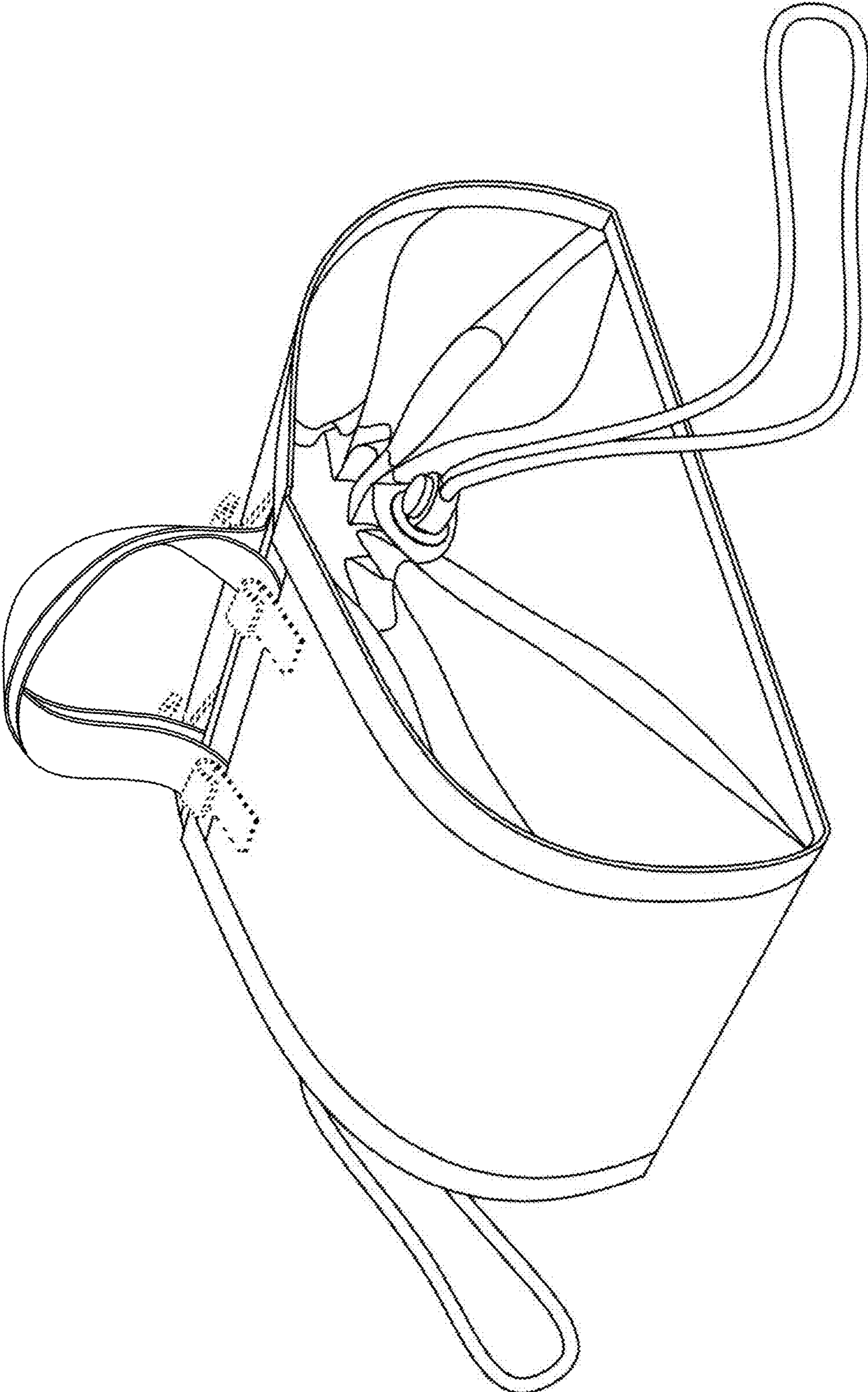
