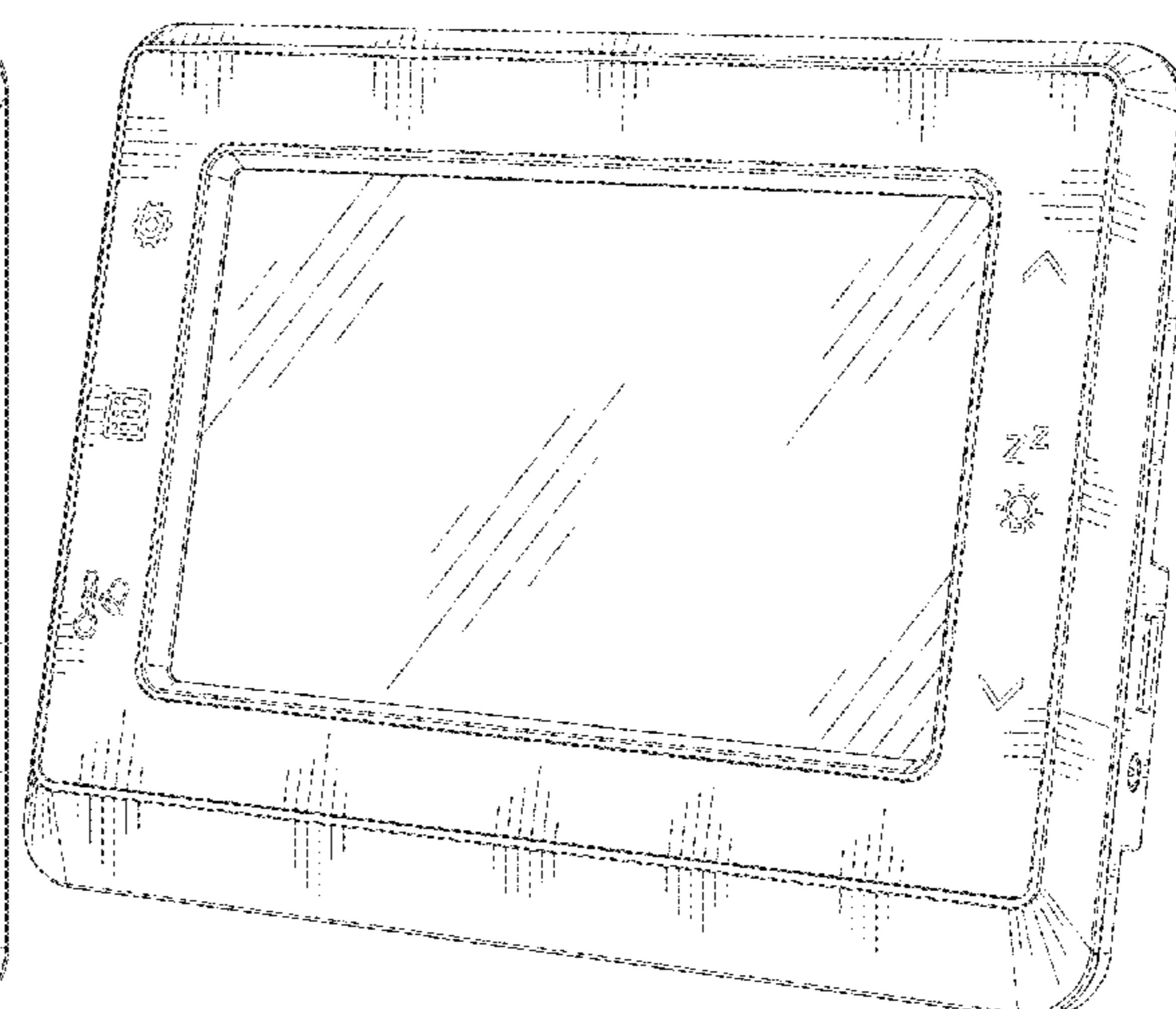
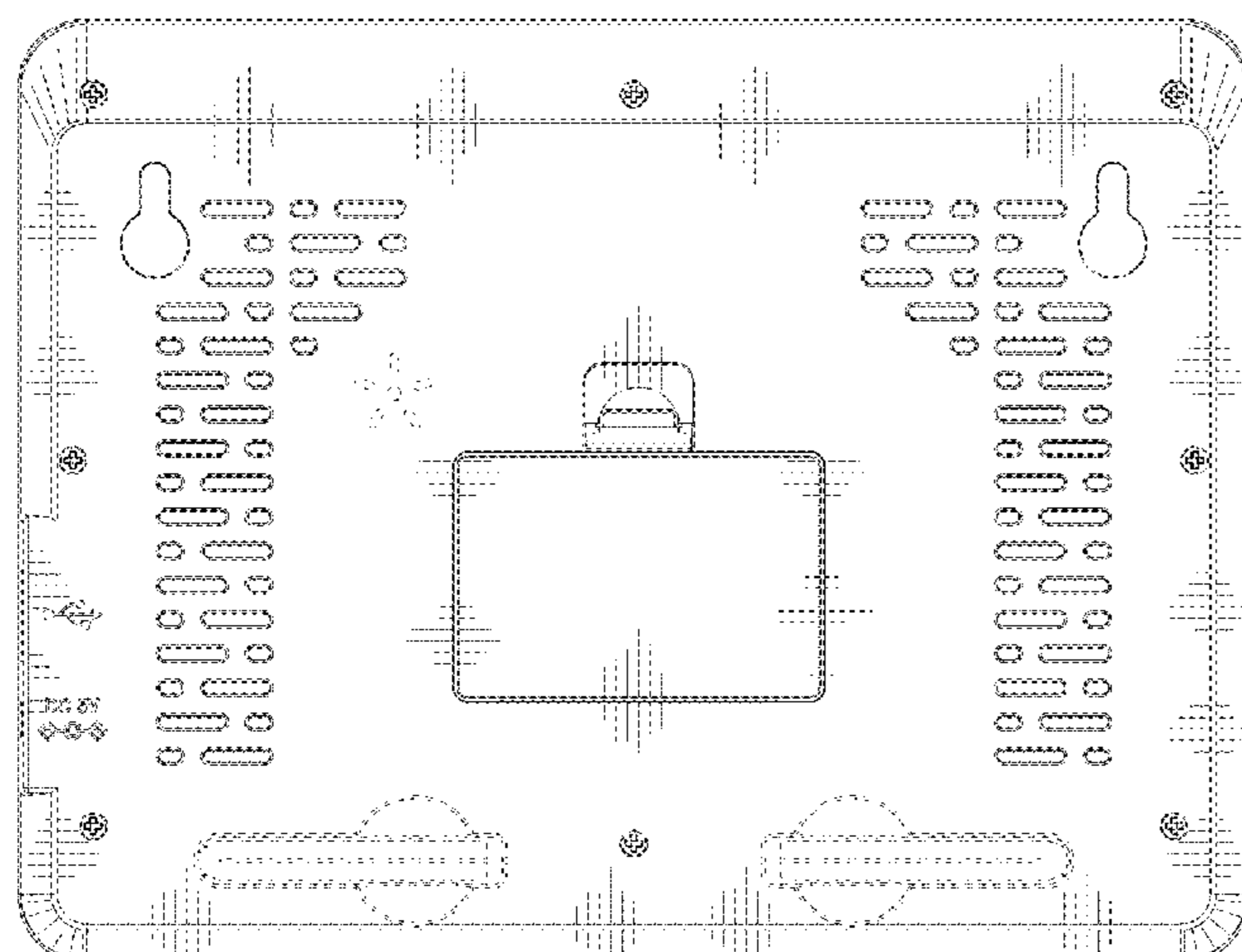
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of a weather station showing my new design;
FIG. 2 is a rear elevational view thereof;

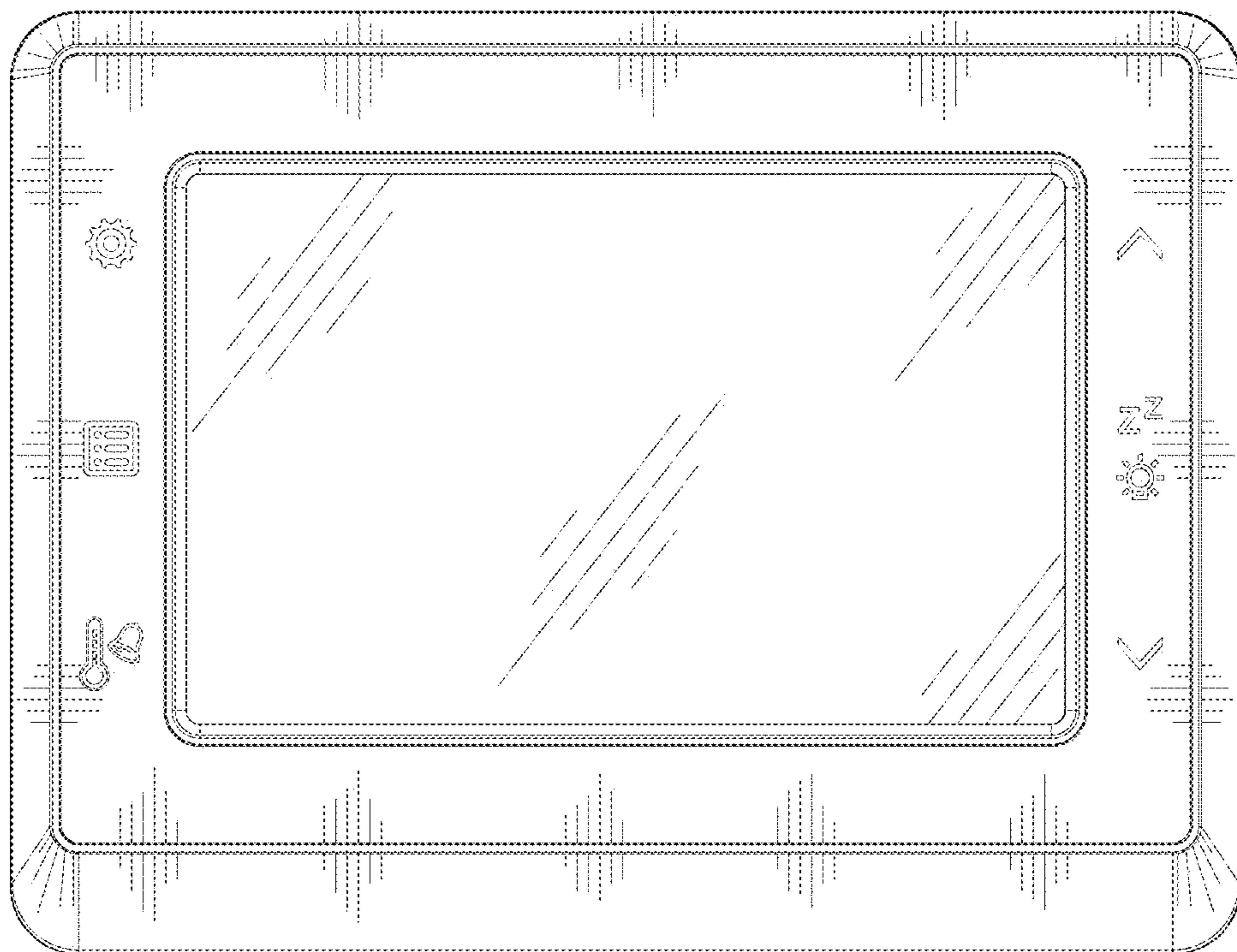

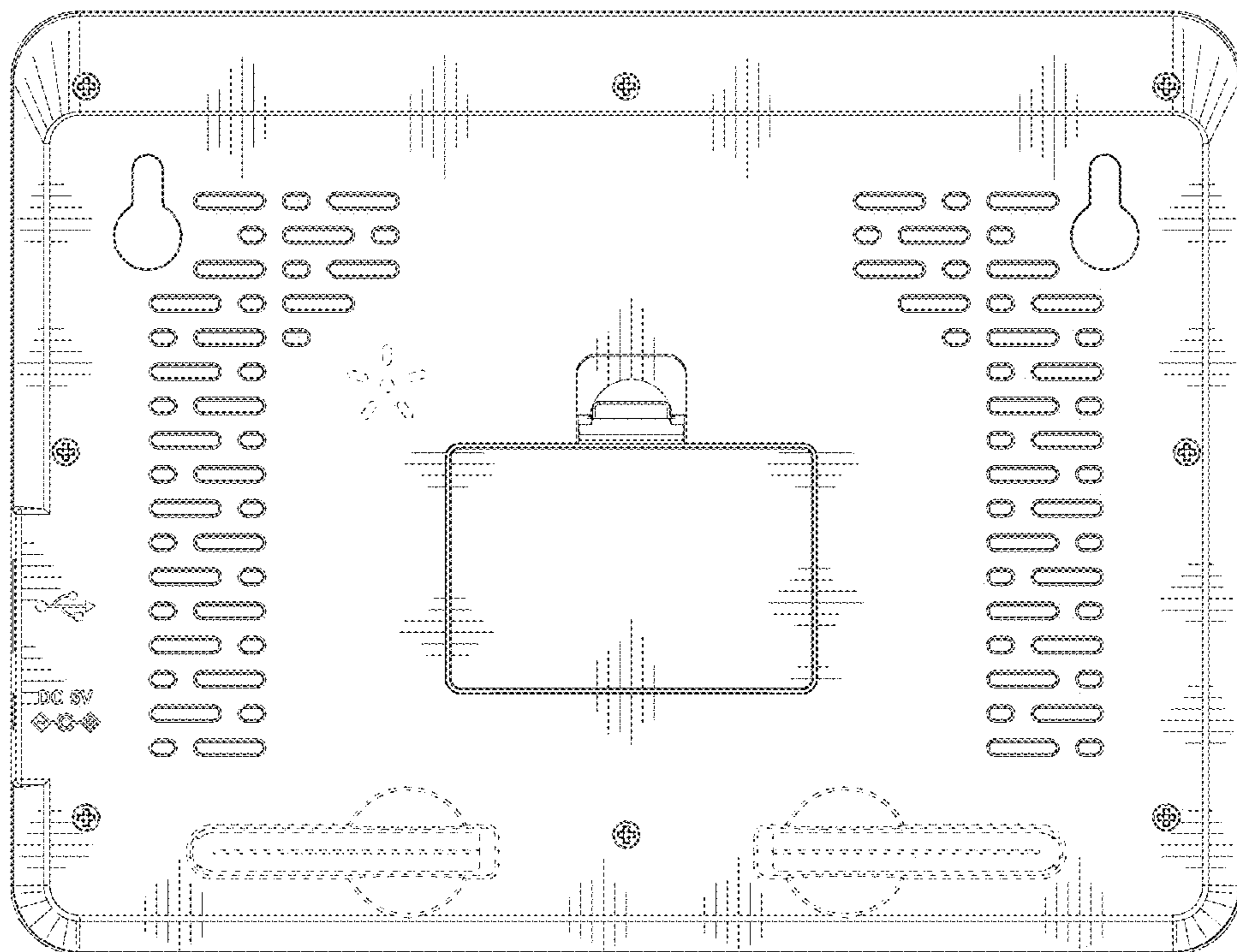

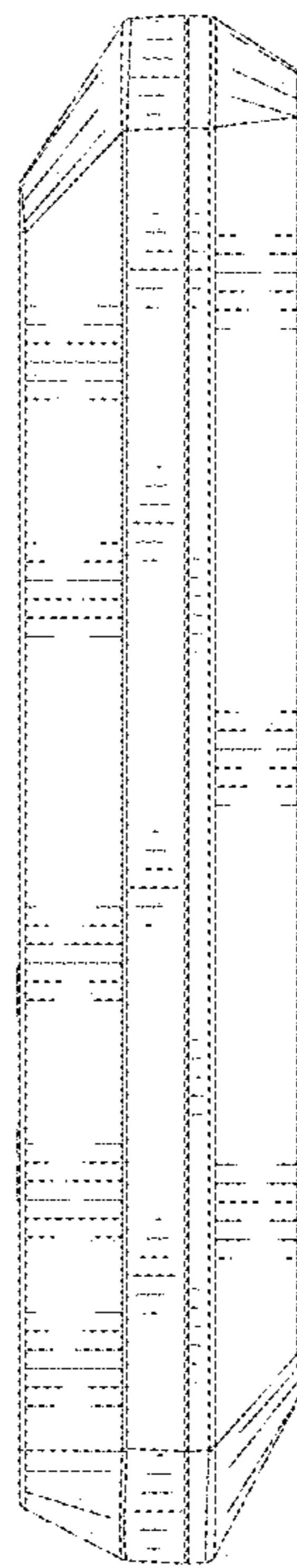

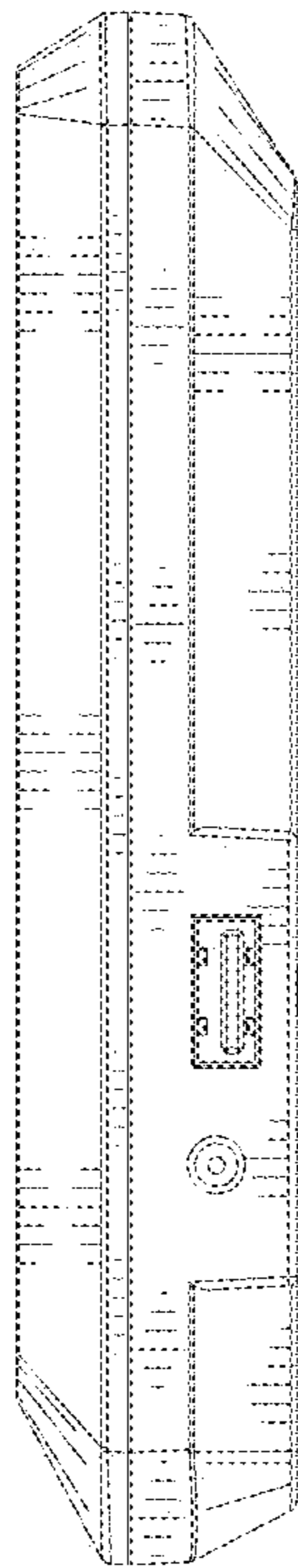

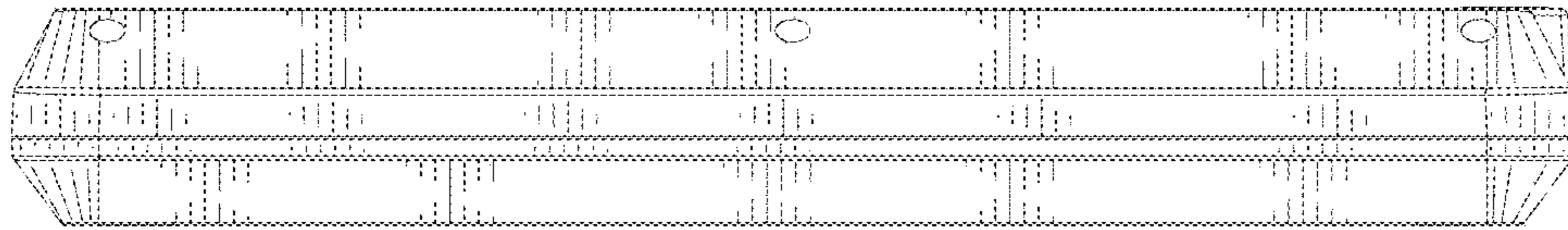

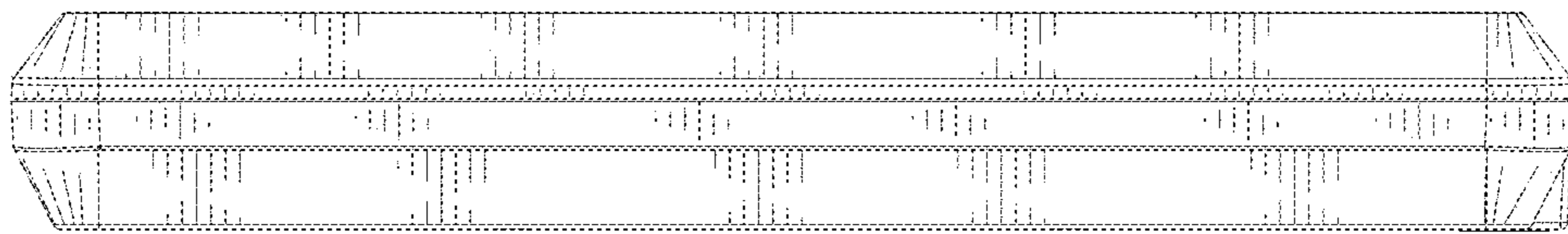

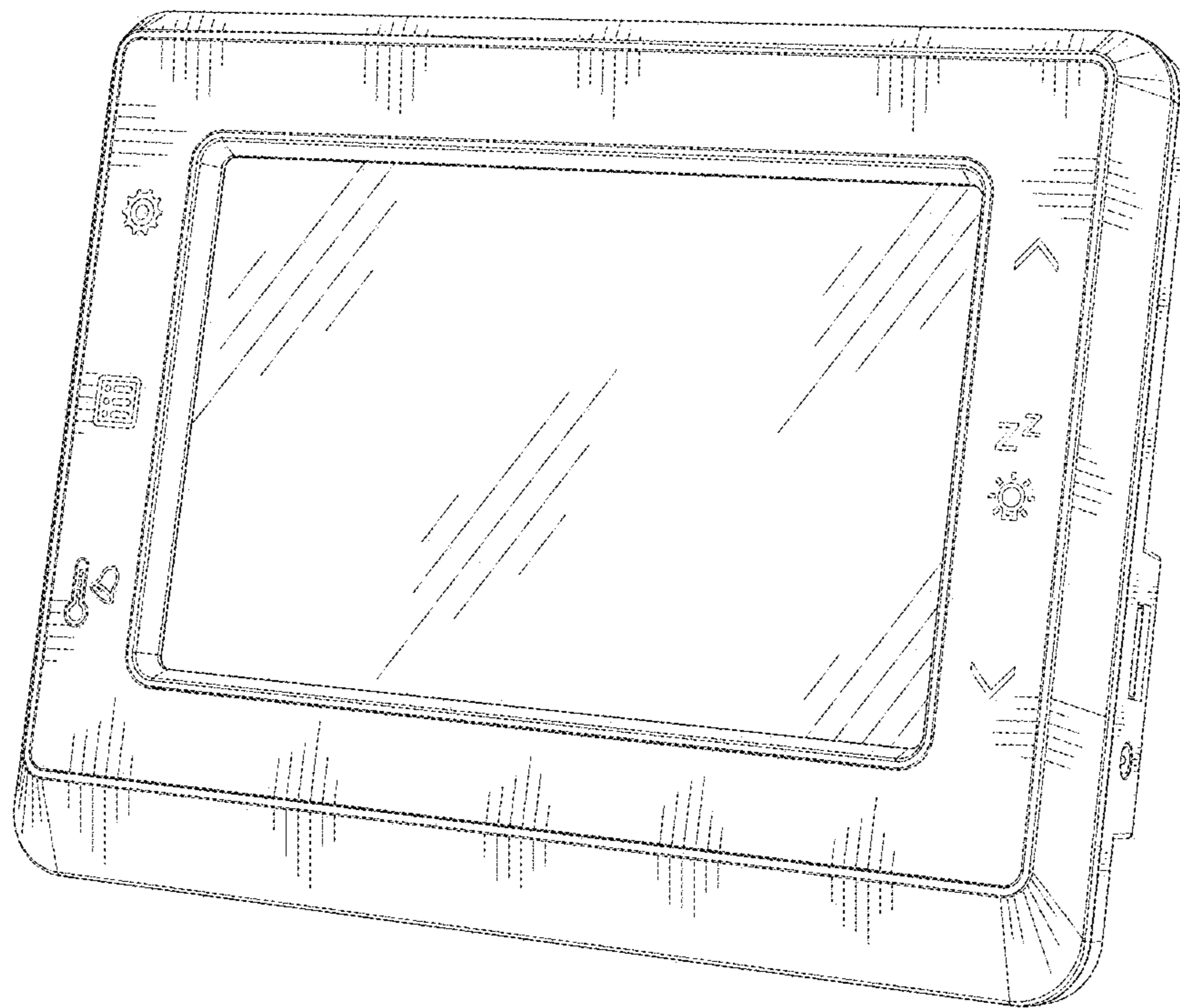
