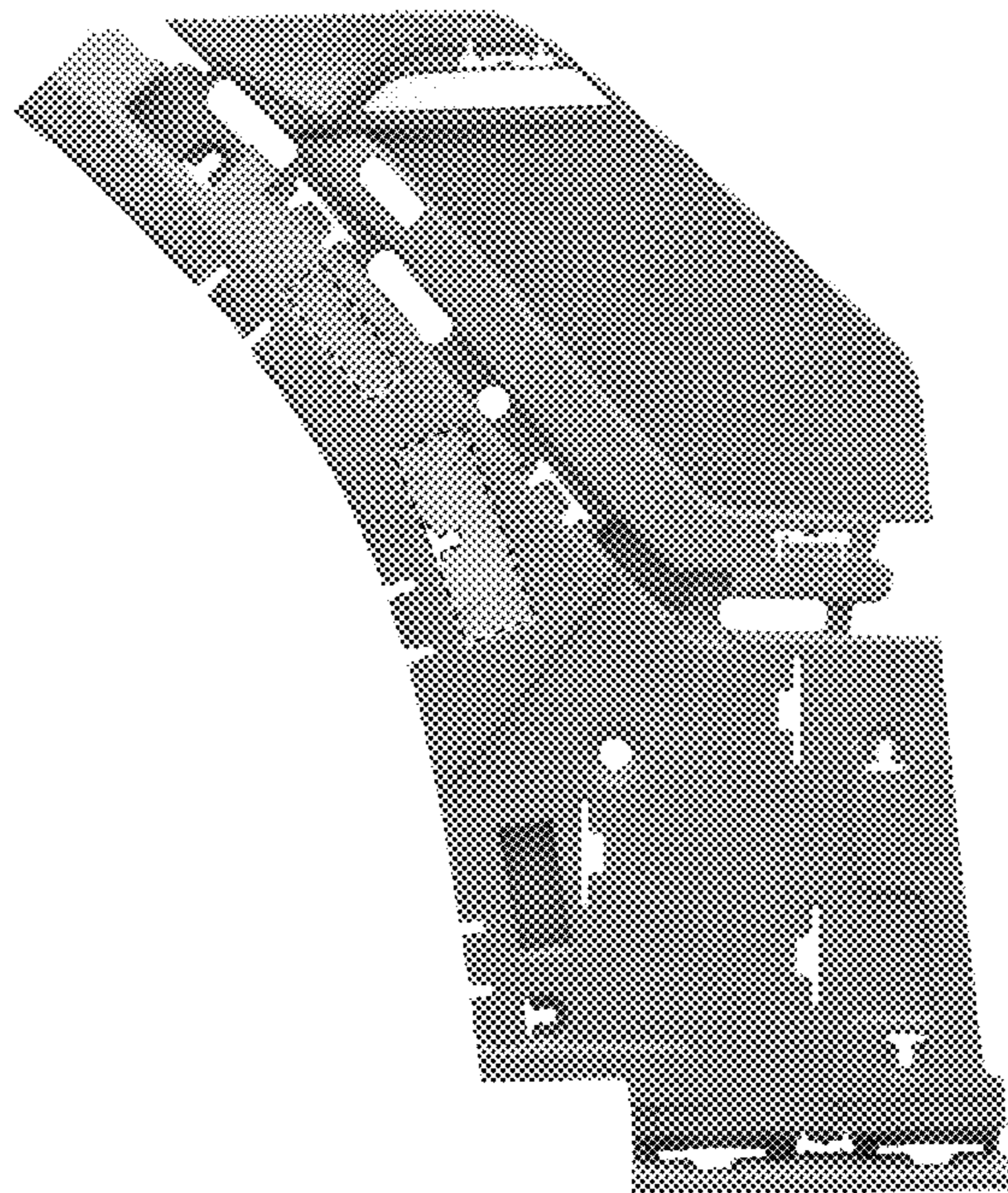
The ornamental design for a decorative element for a vehicle body exterior, as shown and described.

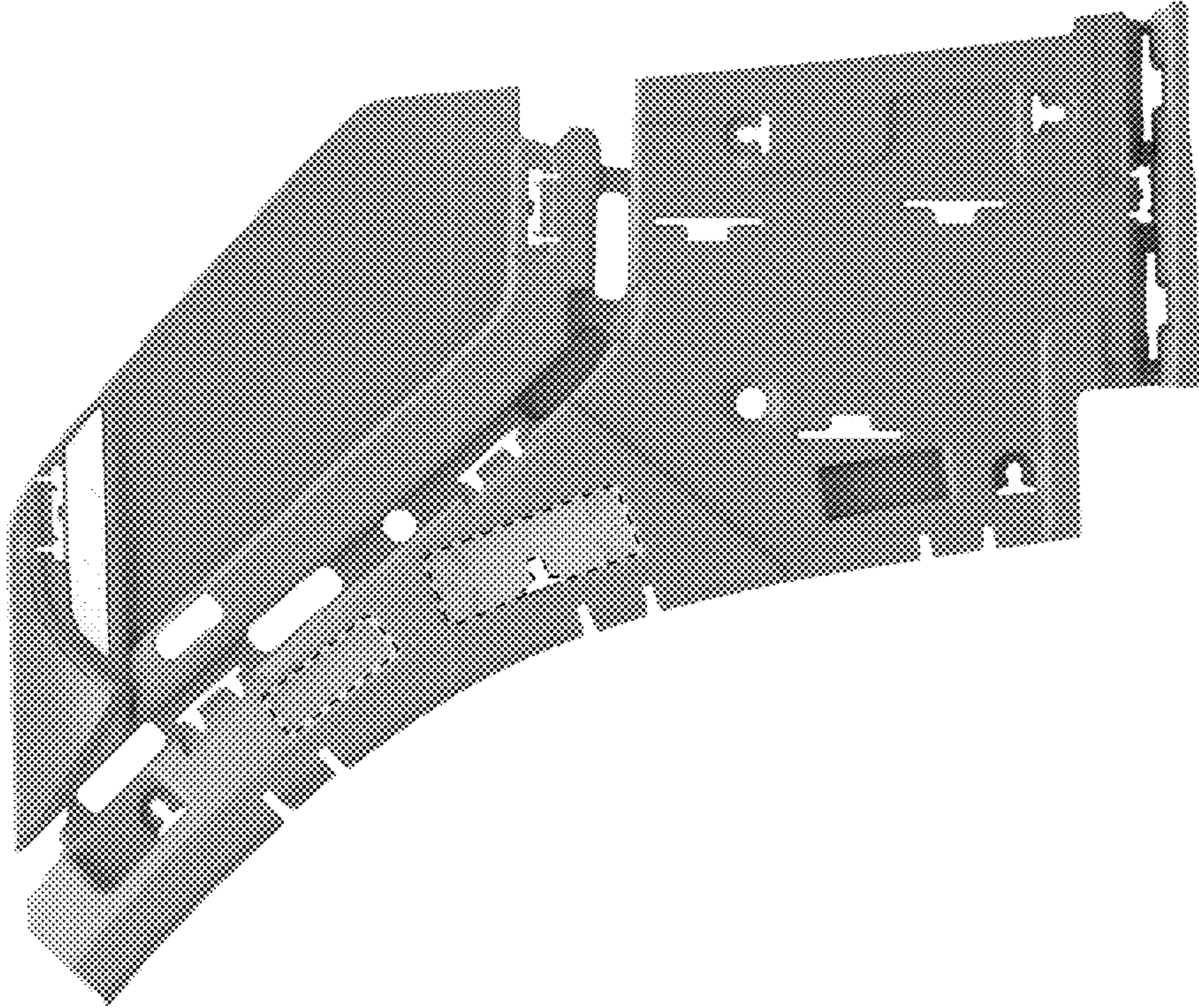
**DESCRIPTION**

 FIG. 8 is a rear view thereof.

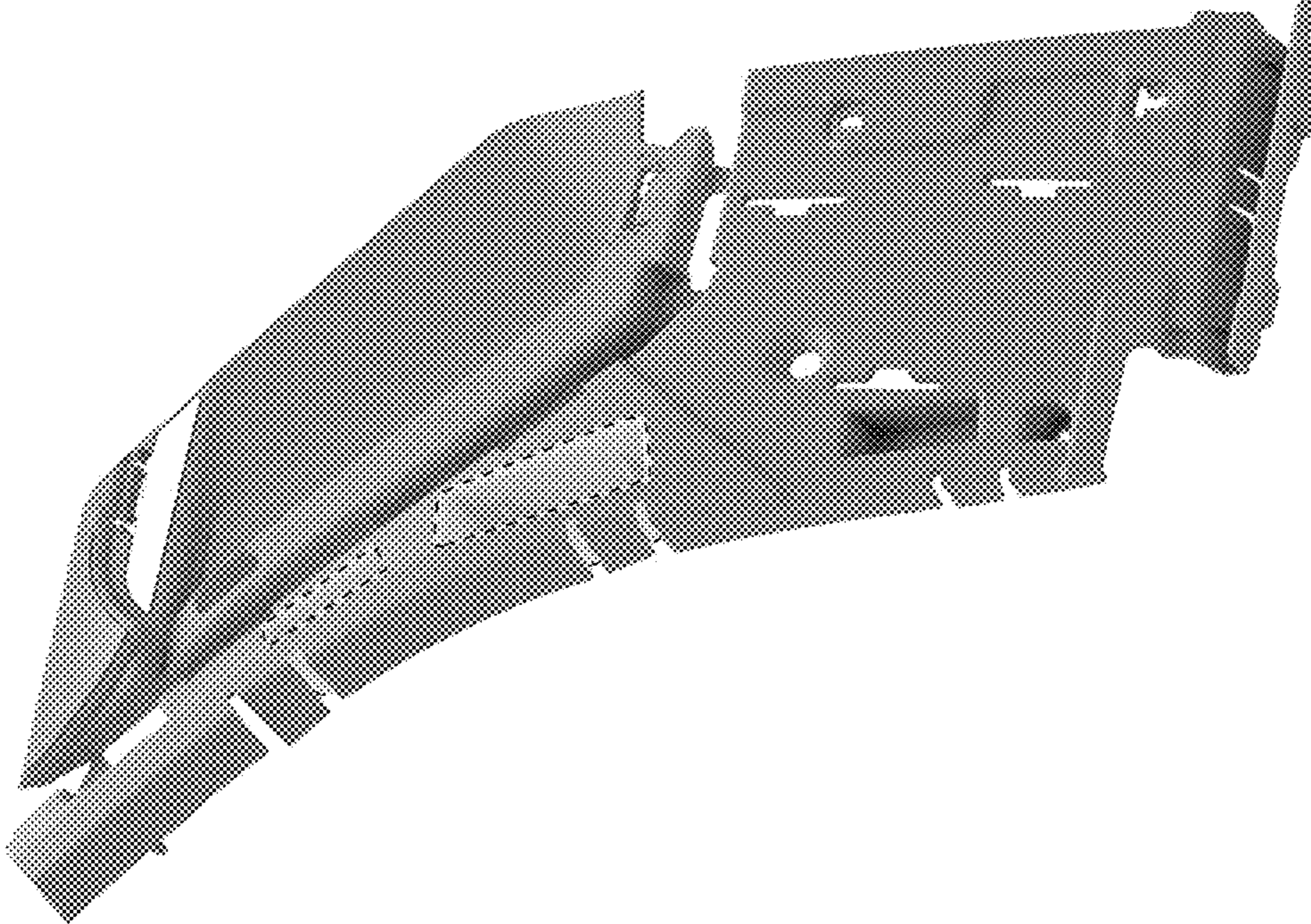
The broken lines in the drawings and the lightened areas within the broken lines illustrate portions of the decorative element for a vehicle body exterior that form no part of the claimed design.

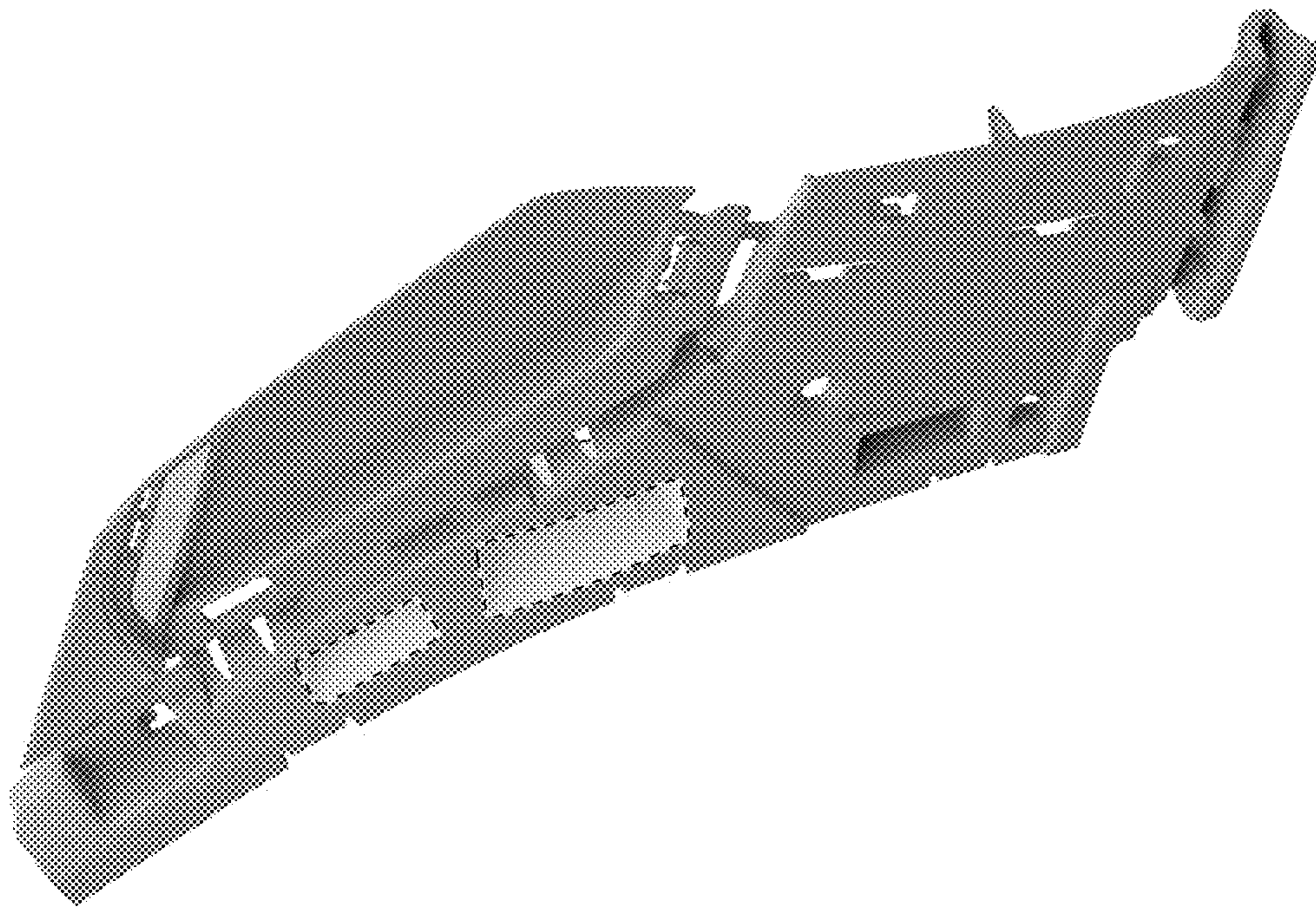




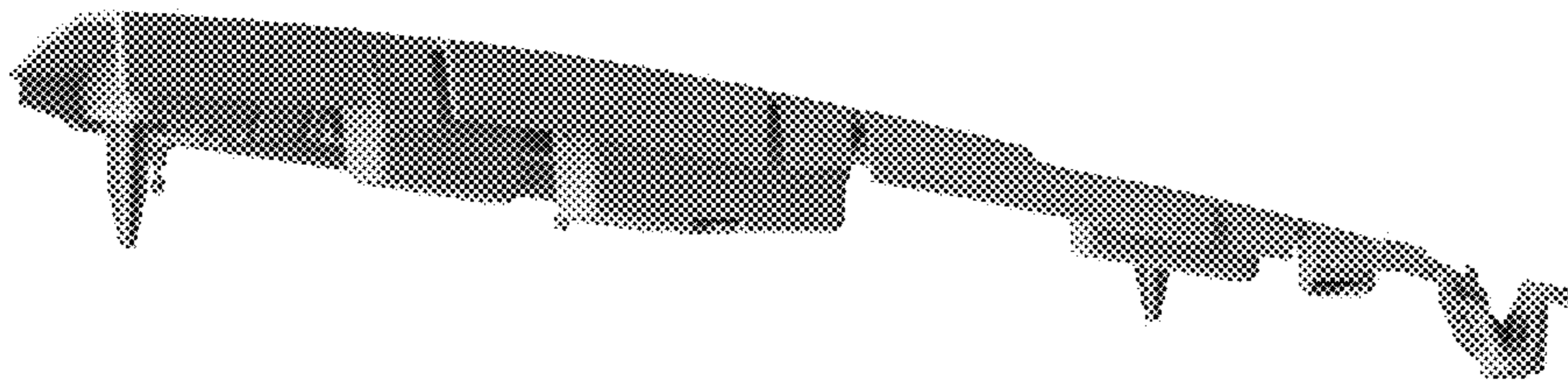

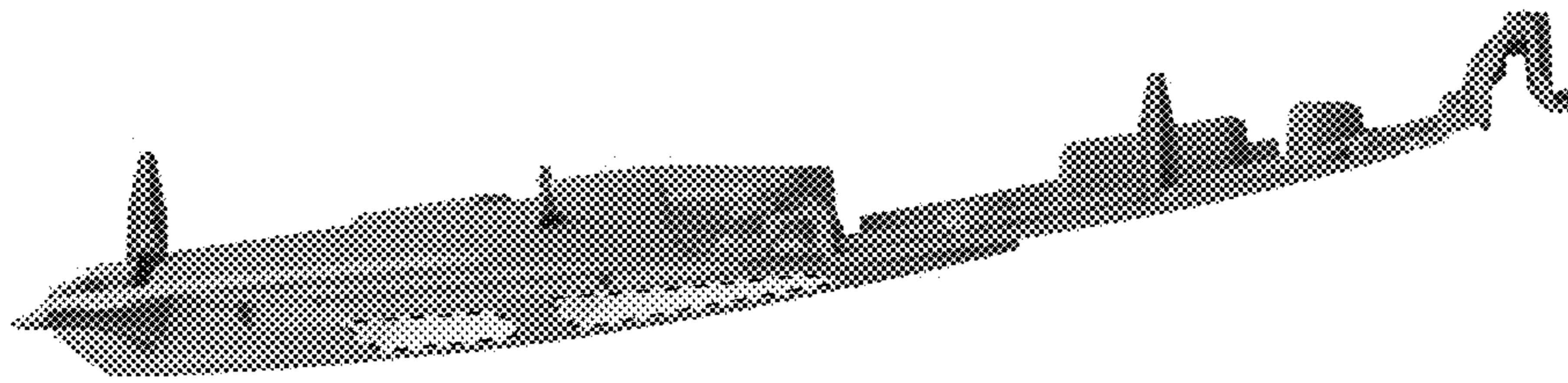

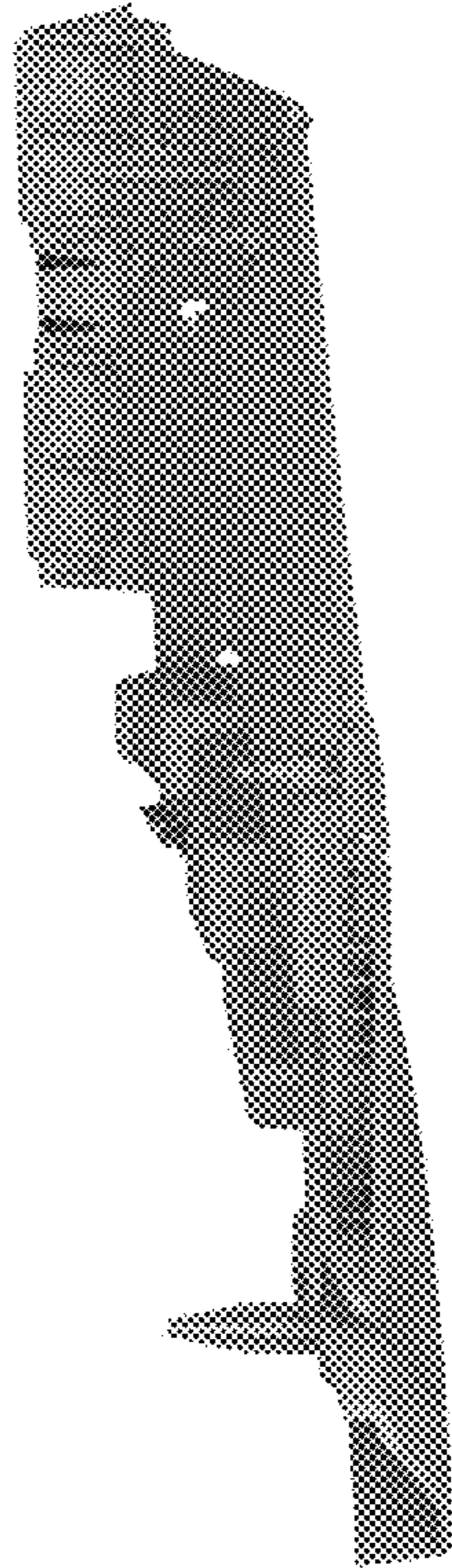

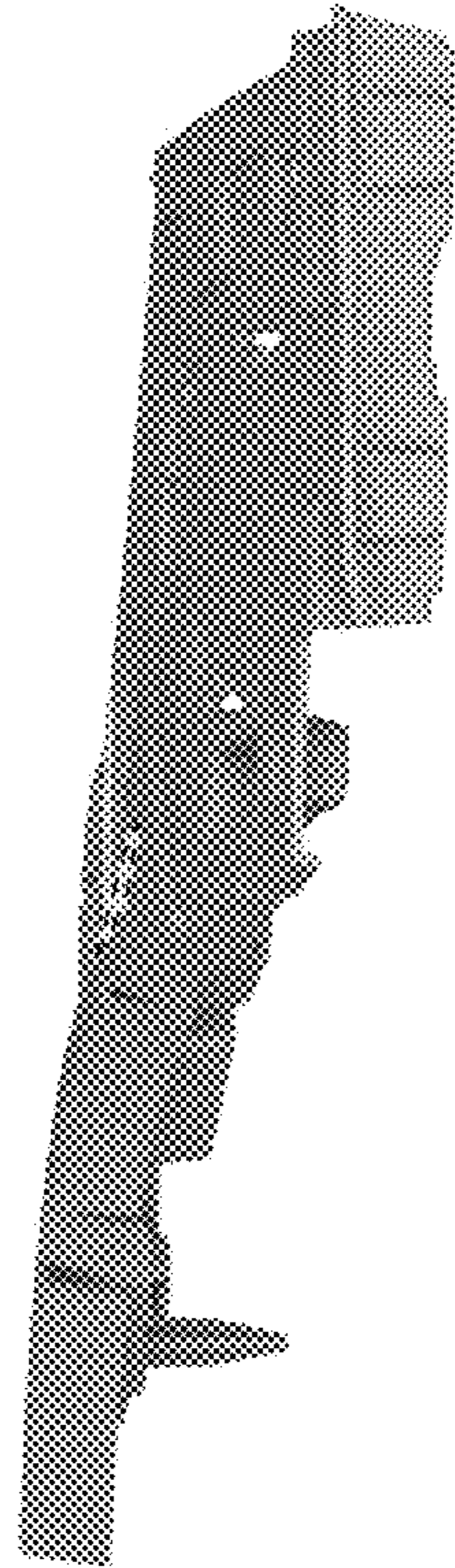

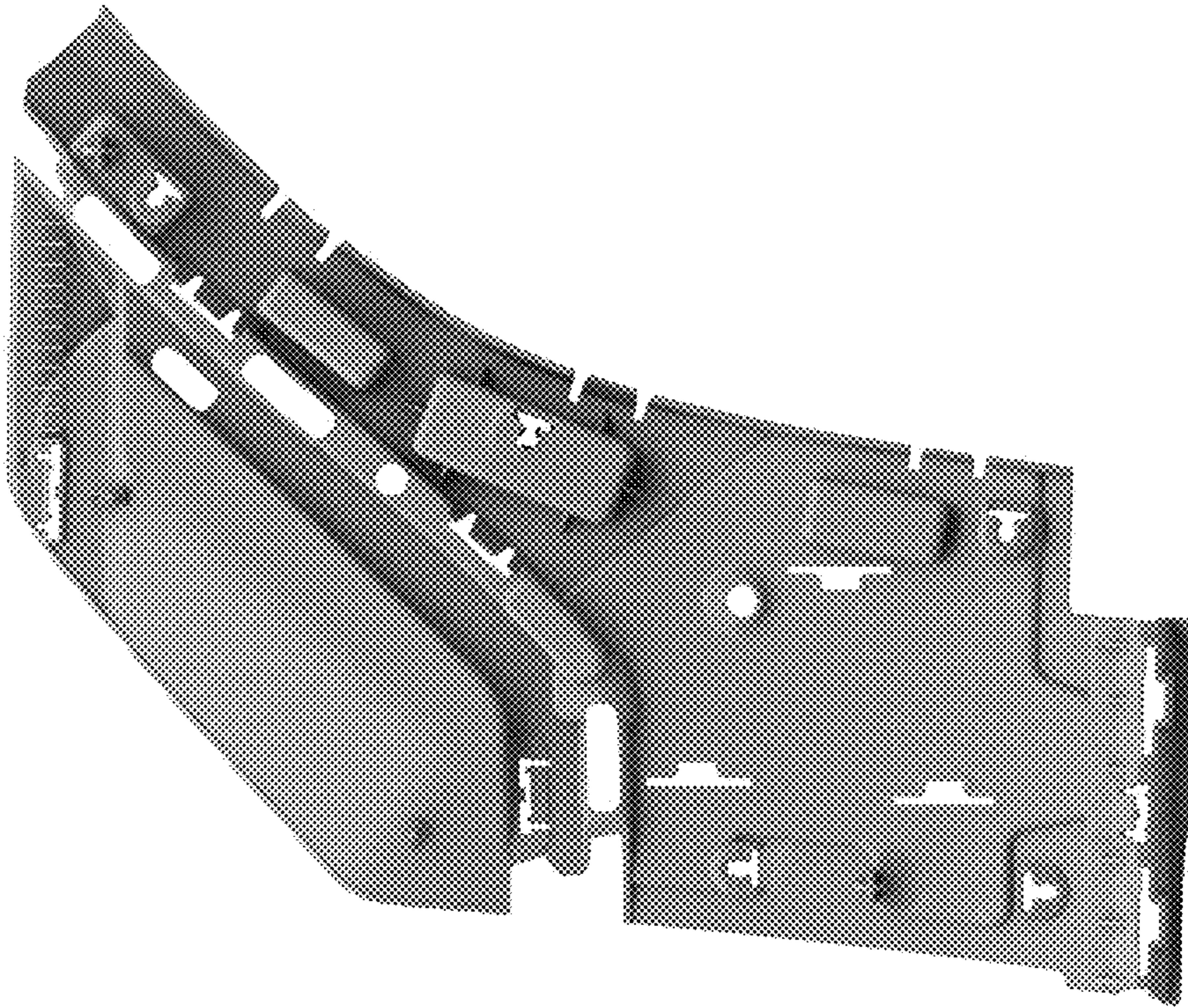
