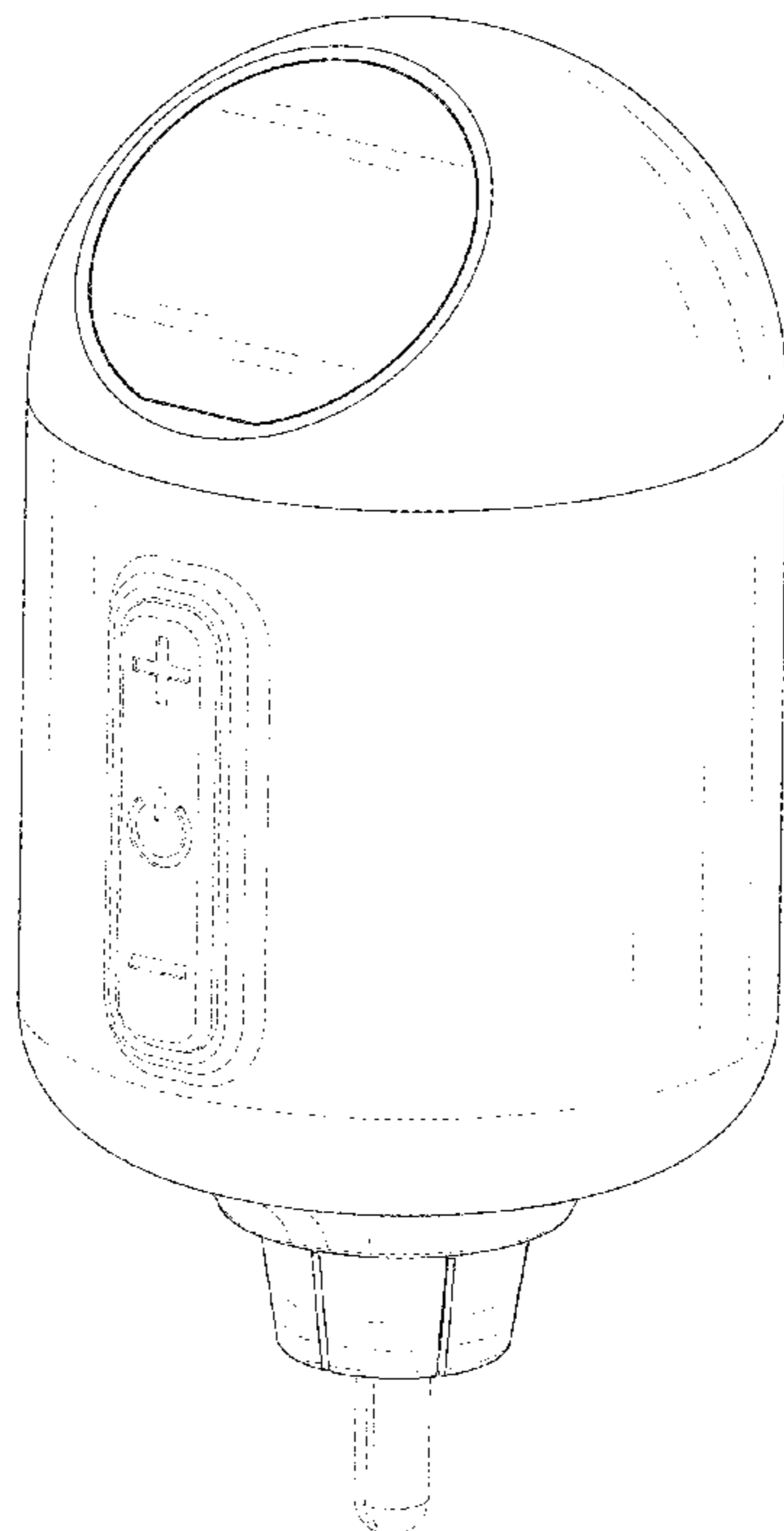

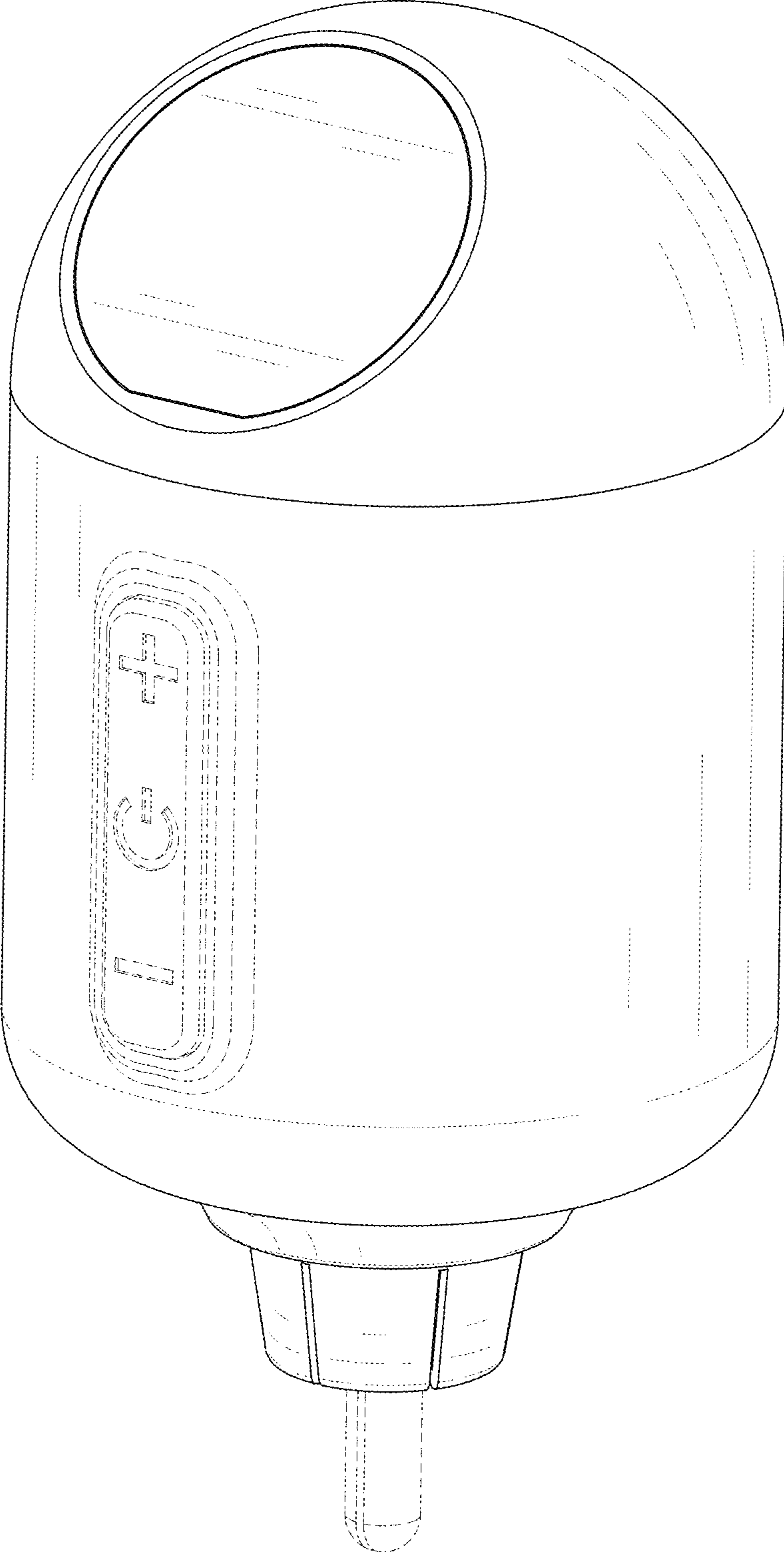
The ornamental design for a power supply for tattoo machine, as shown and described.

**DESCRIPTION**

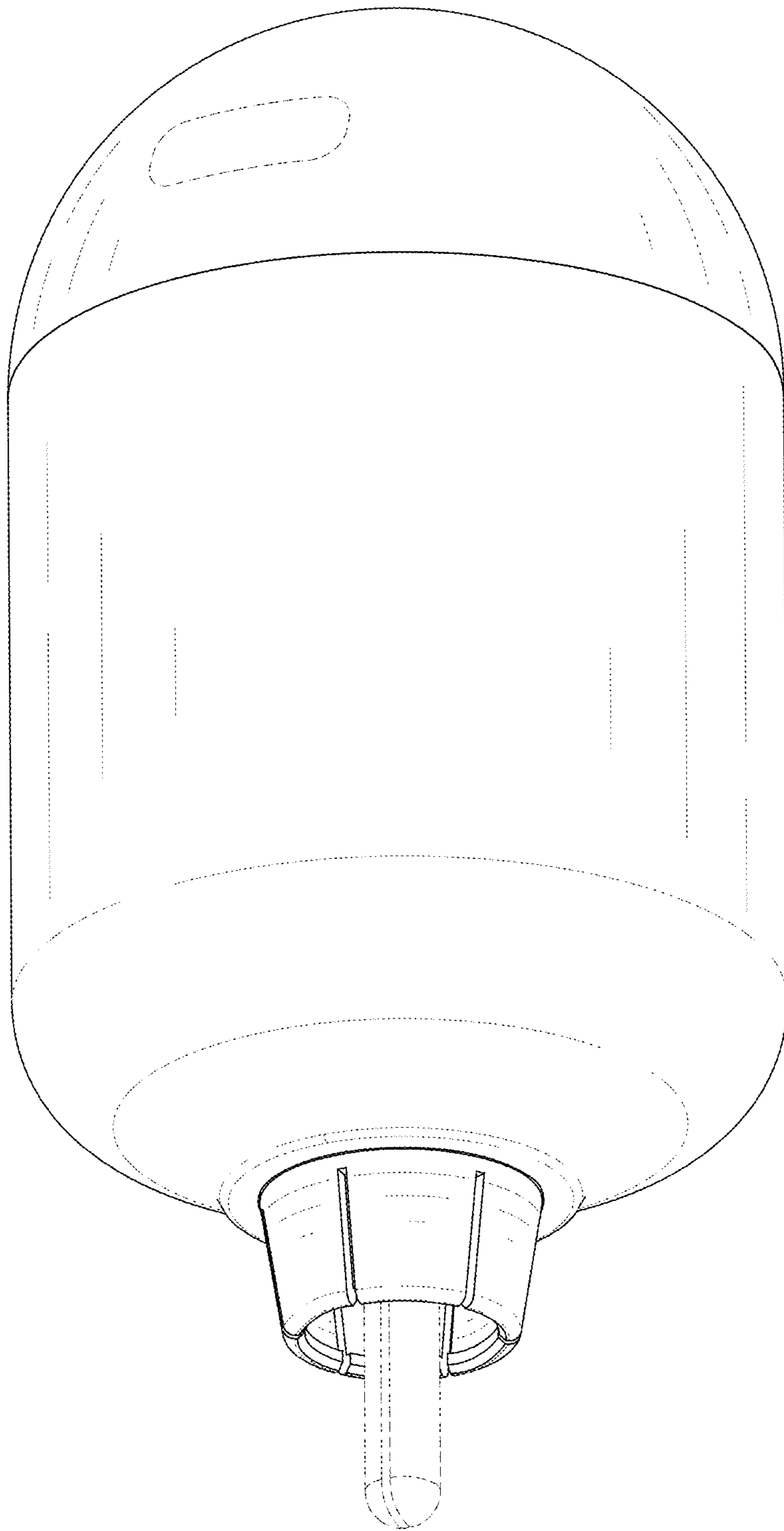
FIG. 1 is a perspective view of a power supply for tattoo machine showing my new design;

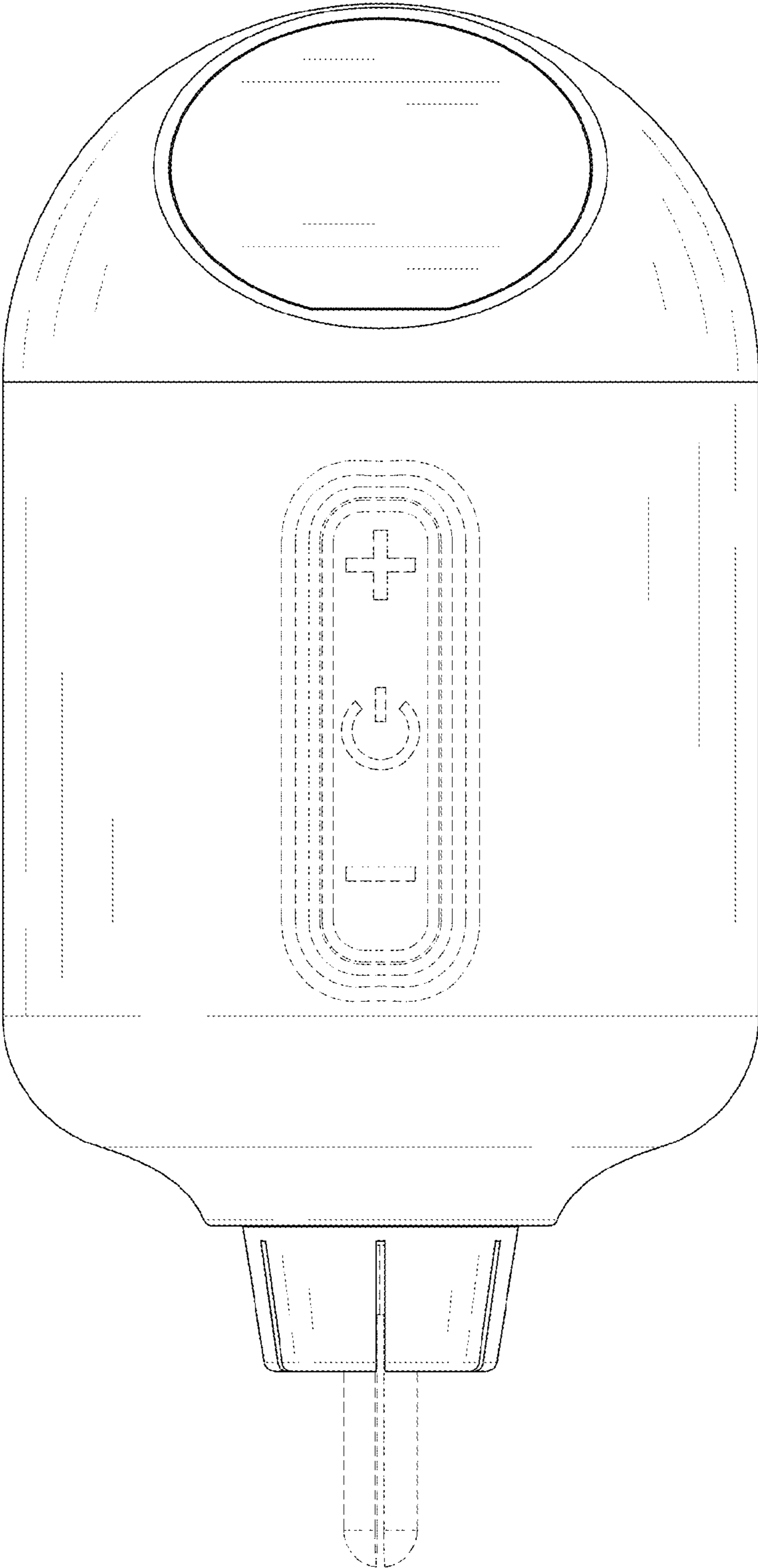




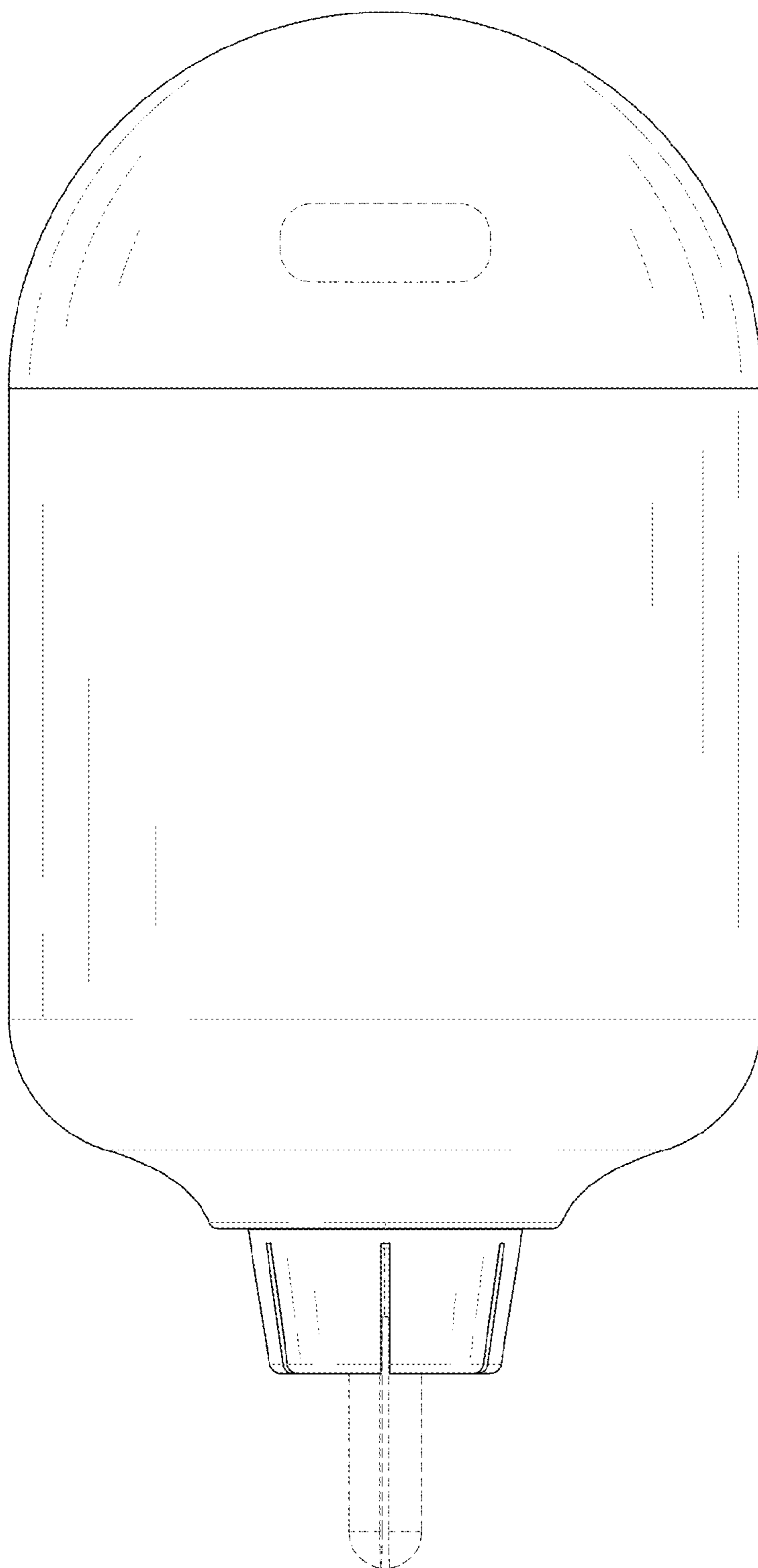

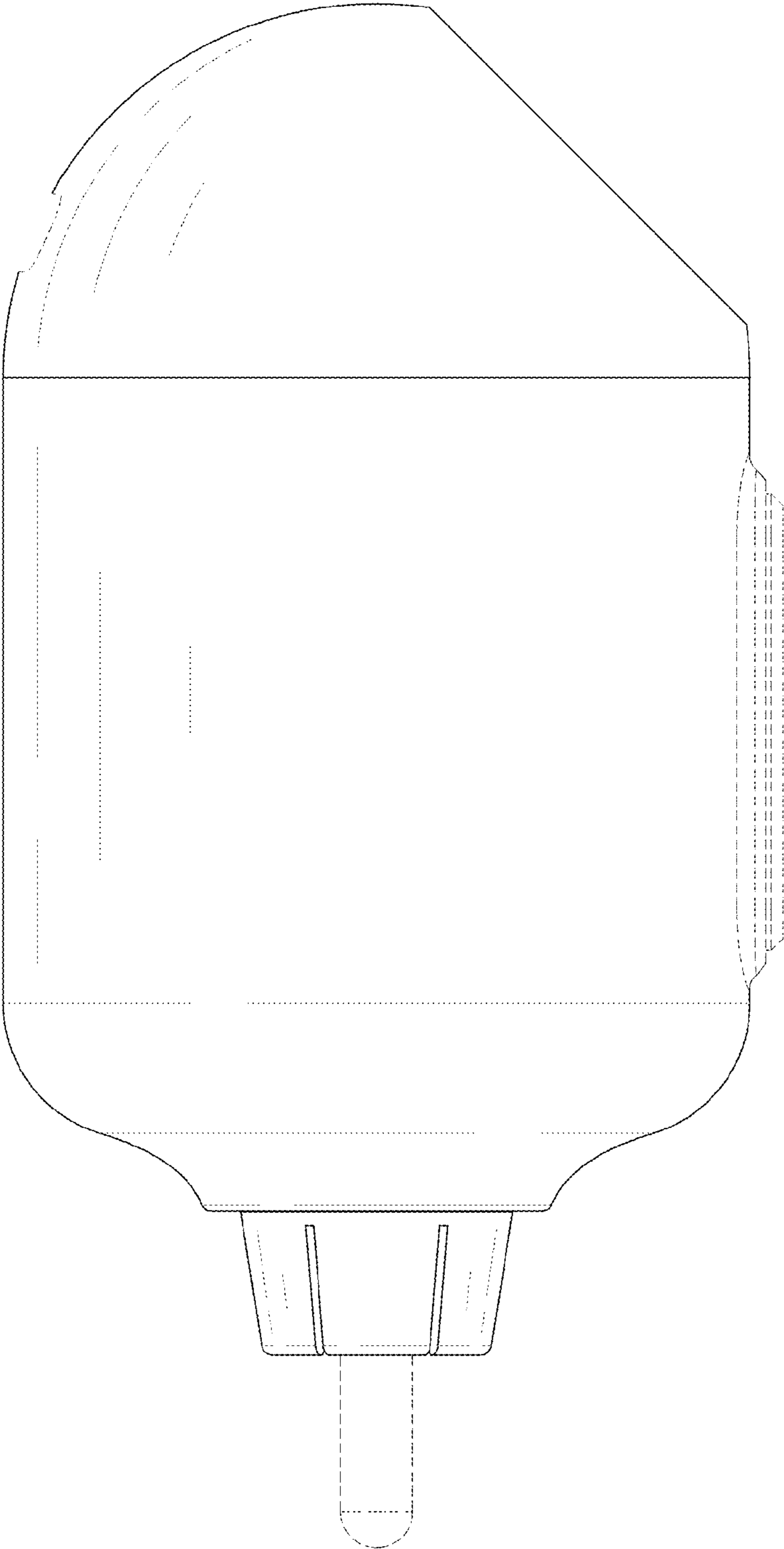

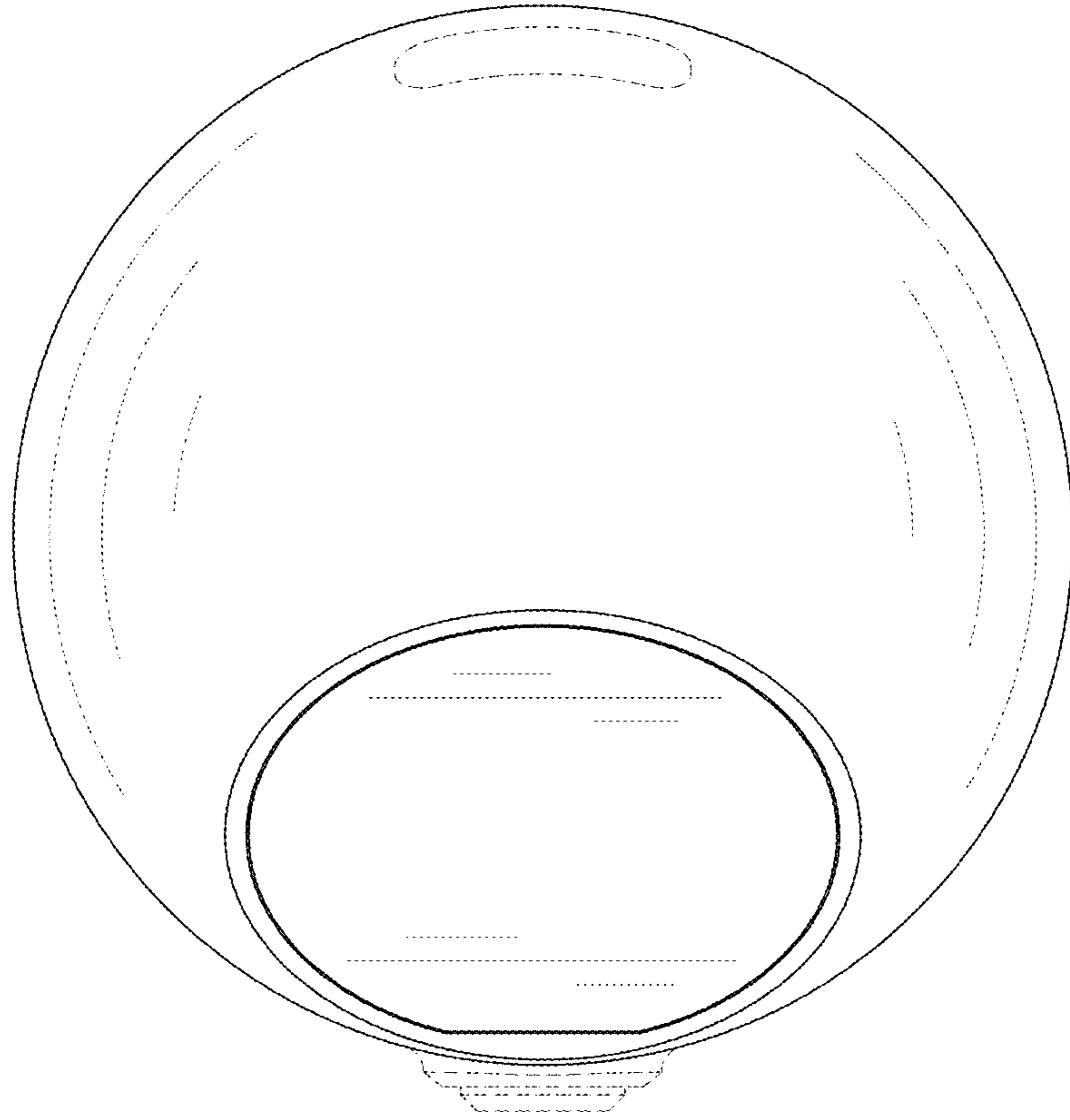

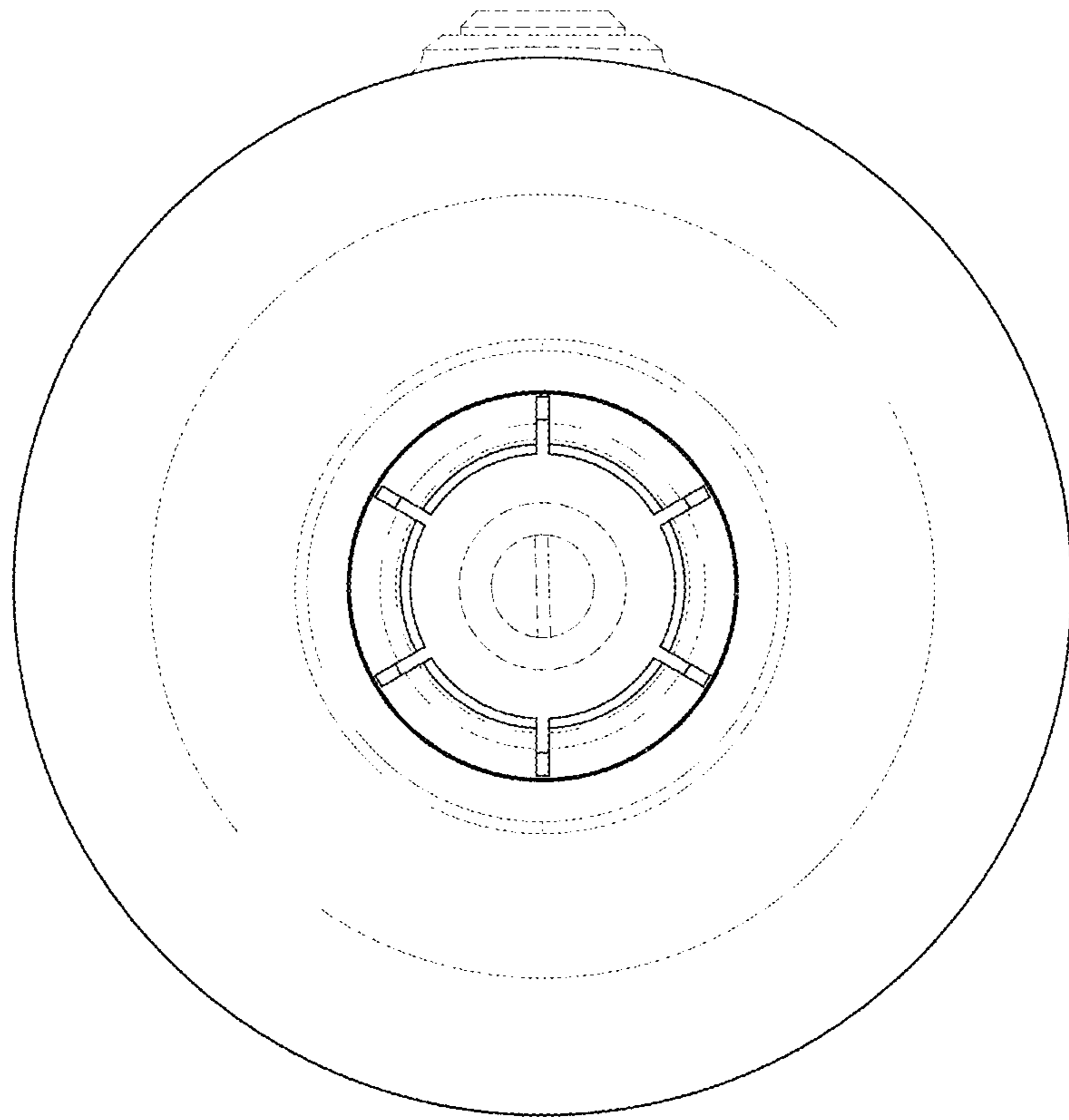
