FIG. 4 illustrates a front view thereof;

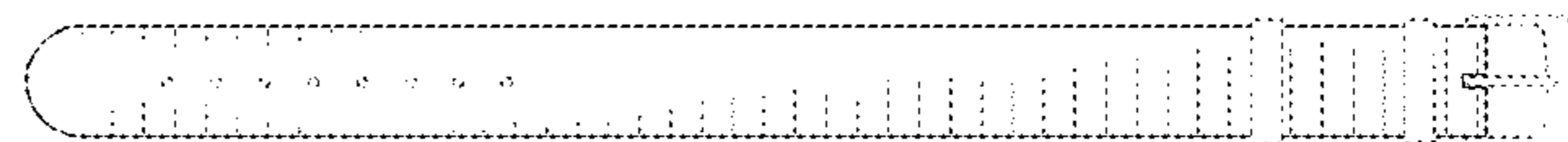
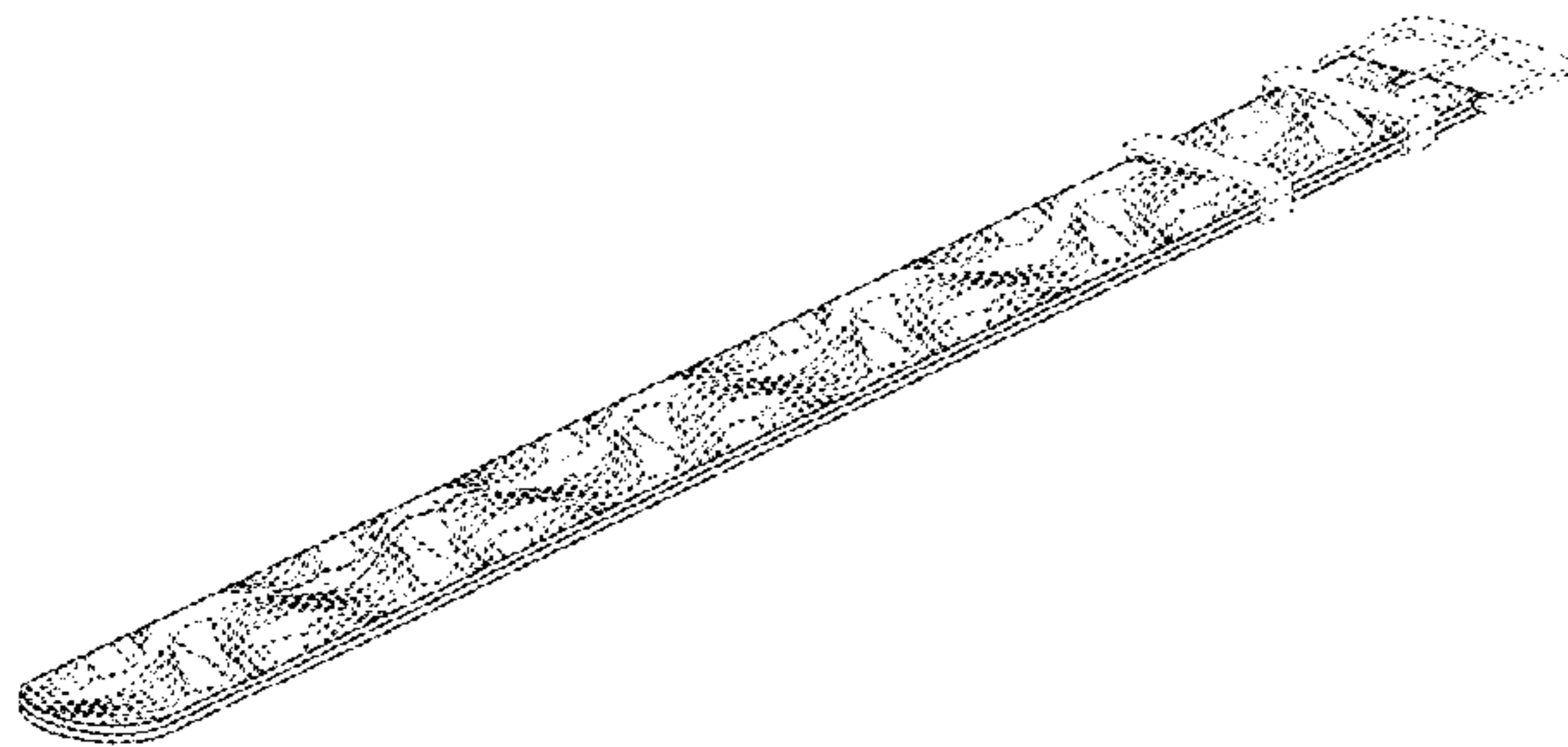
FIG. 5 illustrates a rear view thereof;

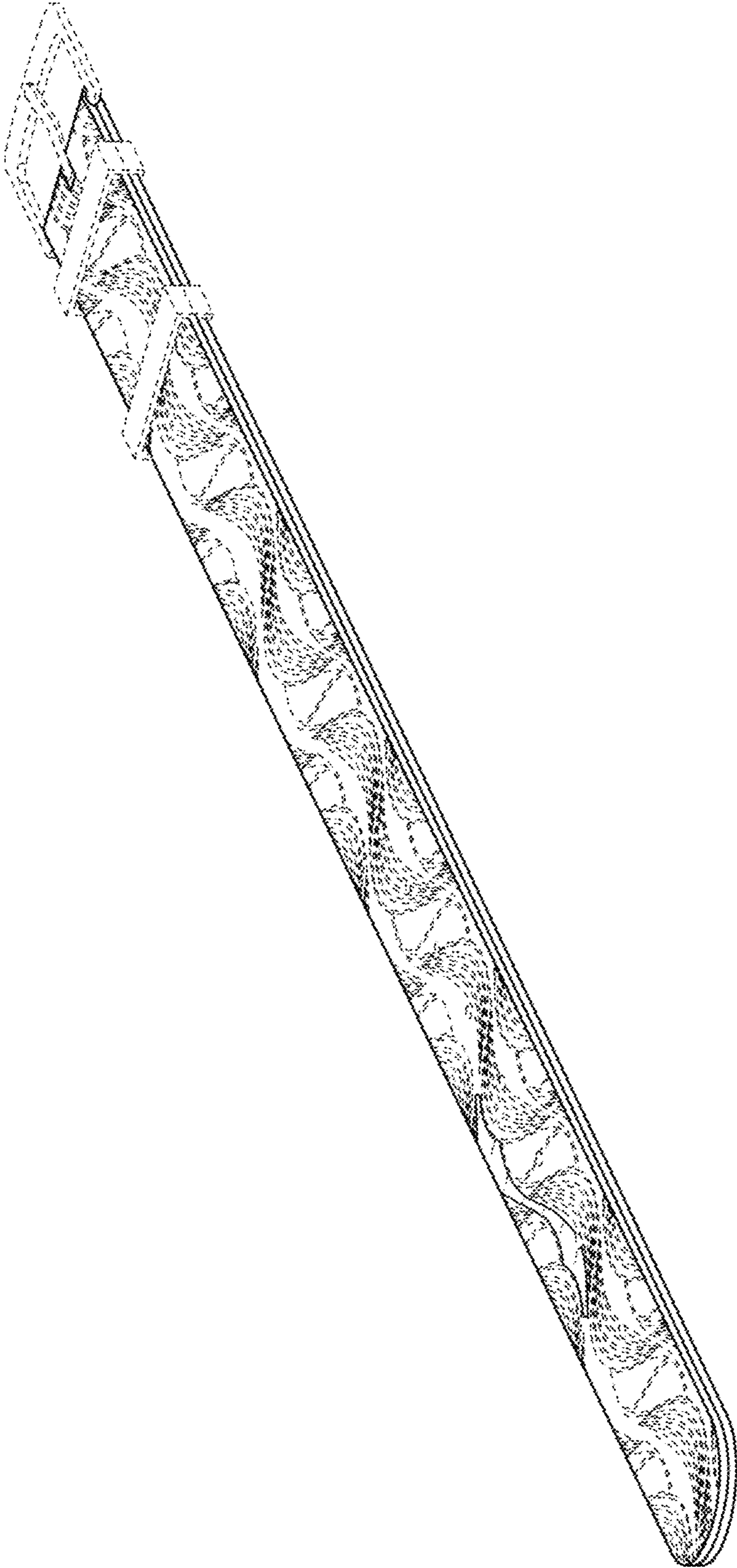

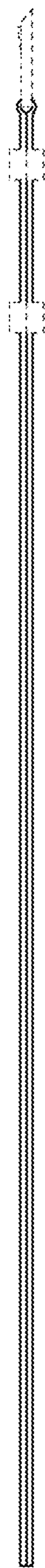

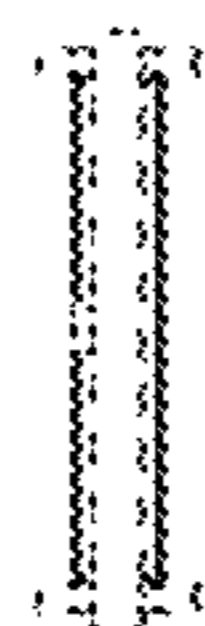

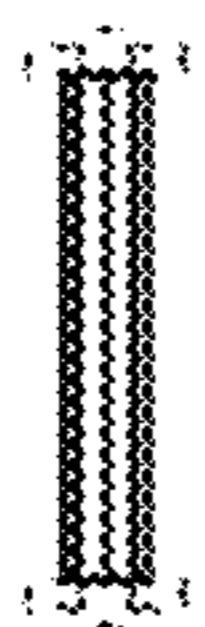

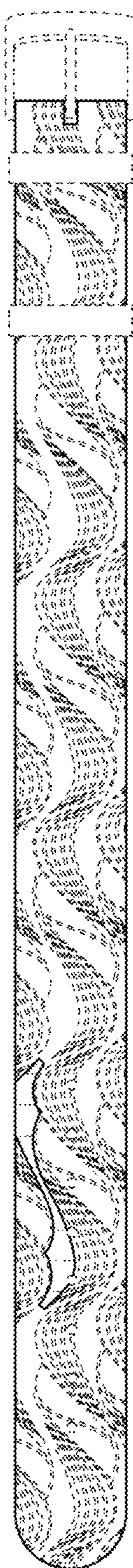

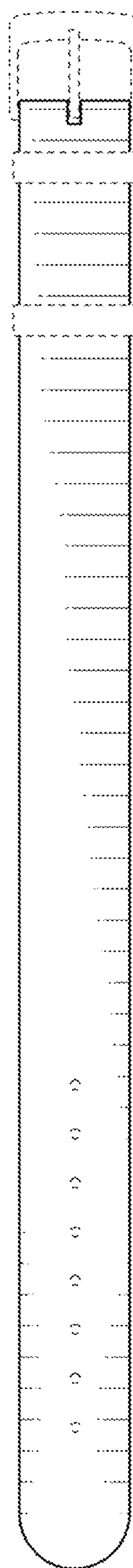
