(57) **CLAIM**

The ornamental design for a portion of a counterweight for construction machine, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and right side perspective view of a portion of a counterweight for construction machine according to the design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a top plan view thereof;

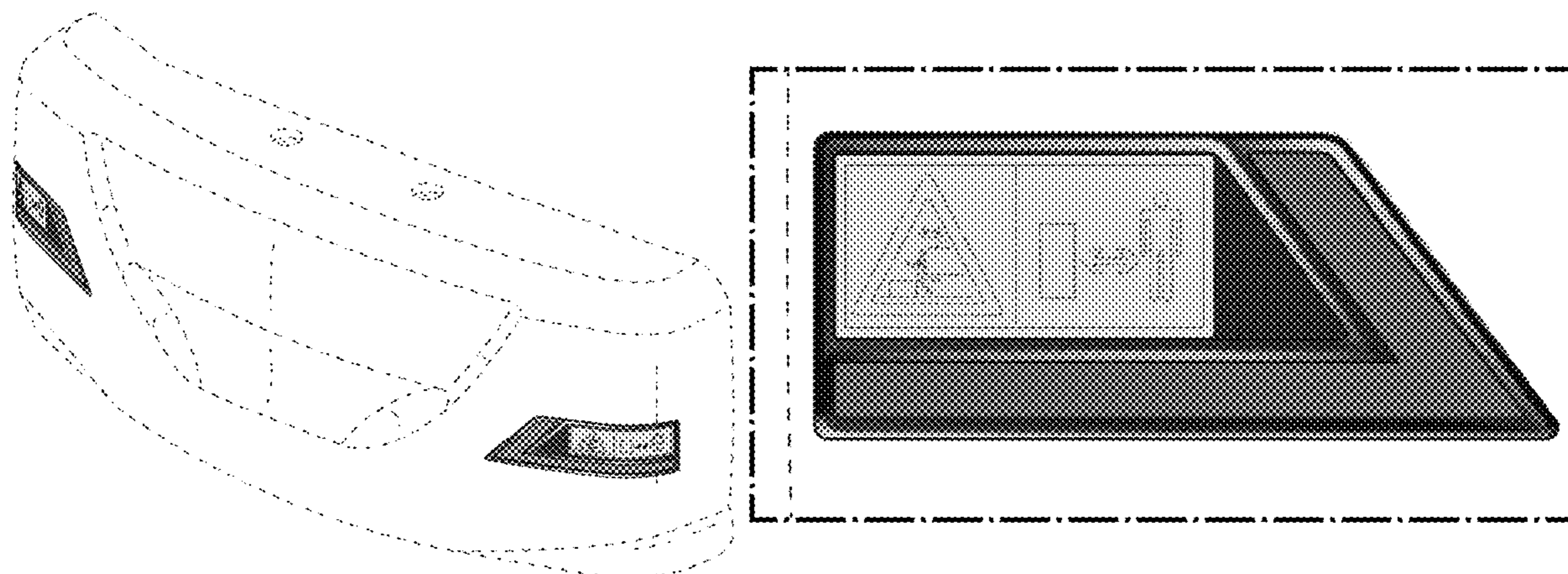
FIG. 6 is a bottom plan view thereof;

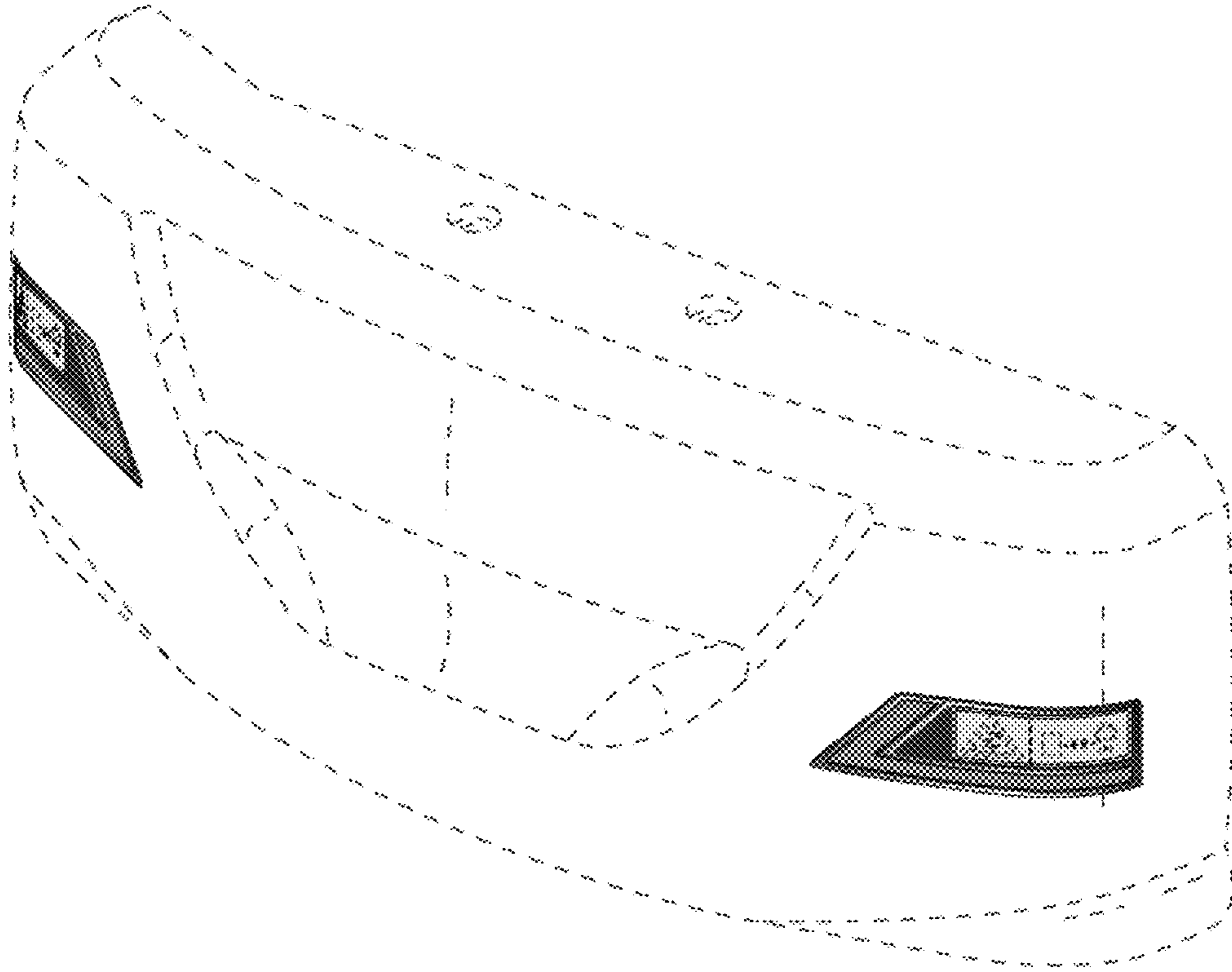

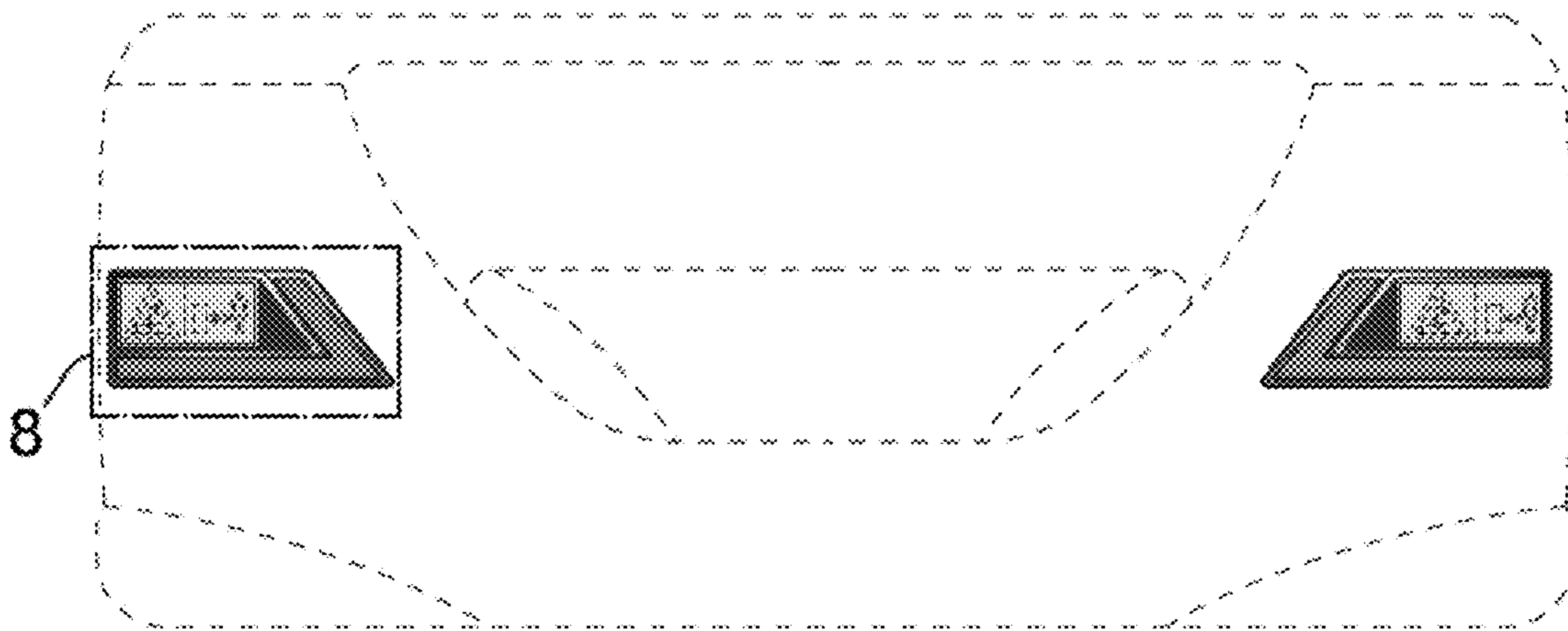
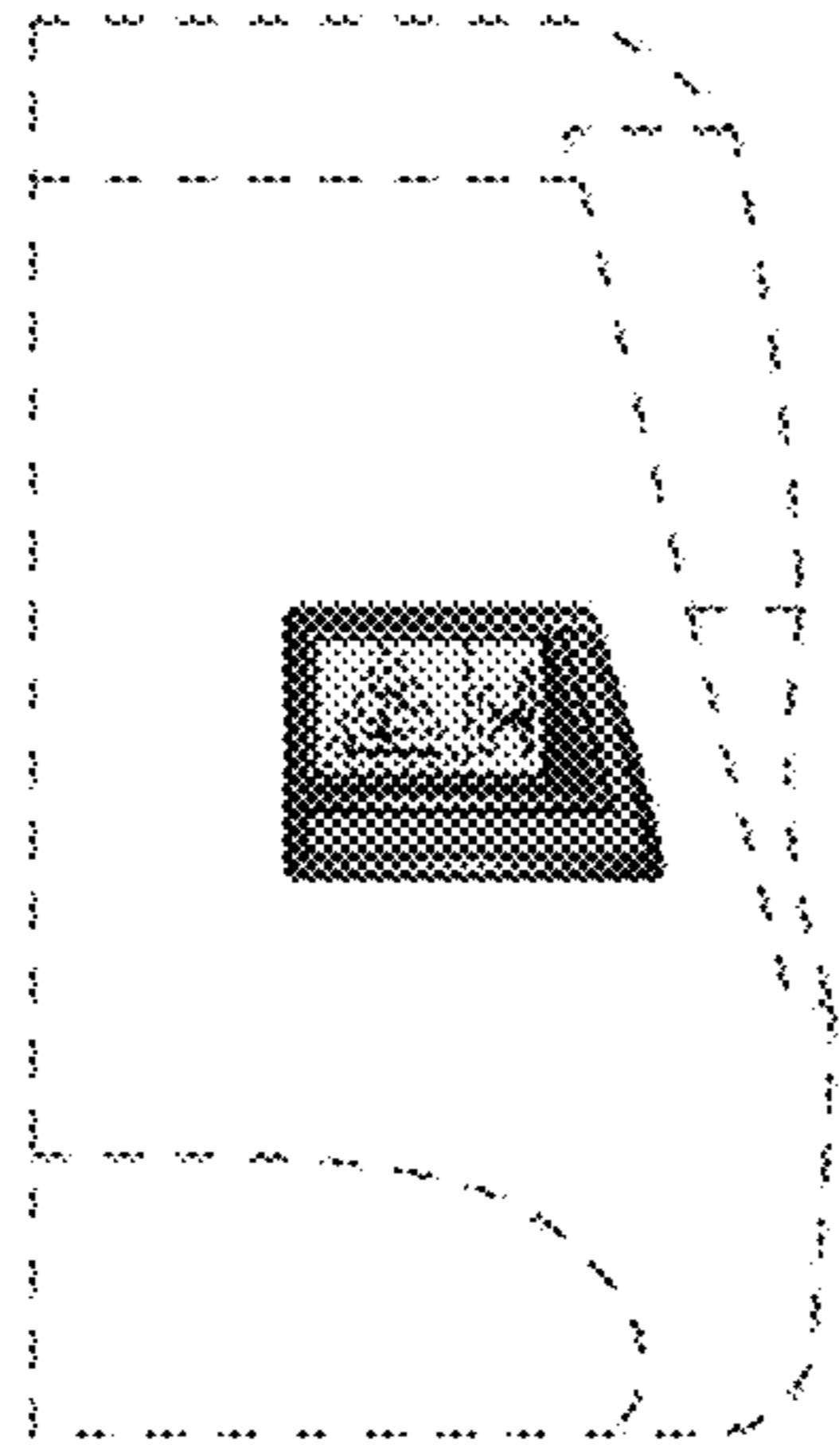
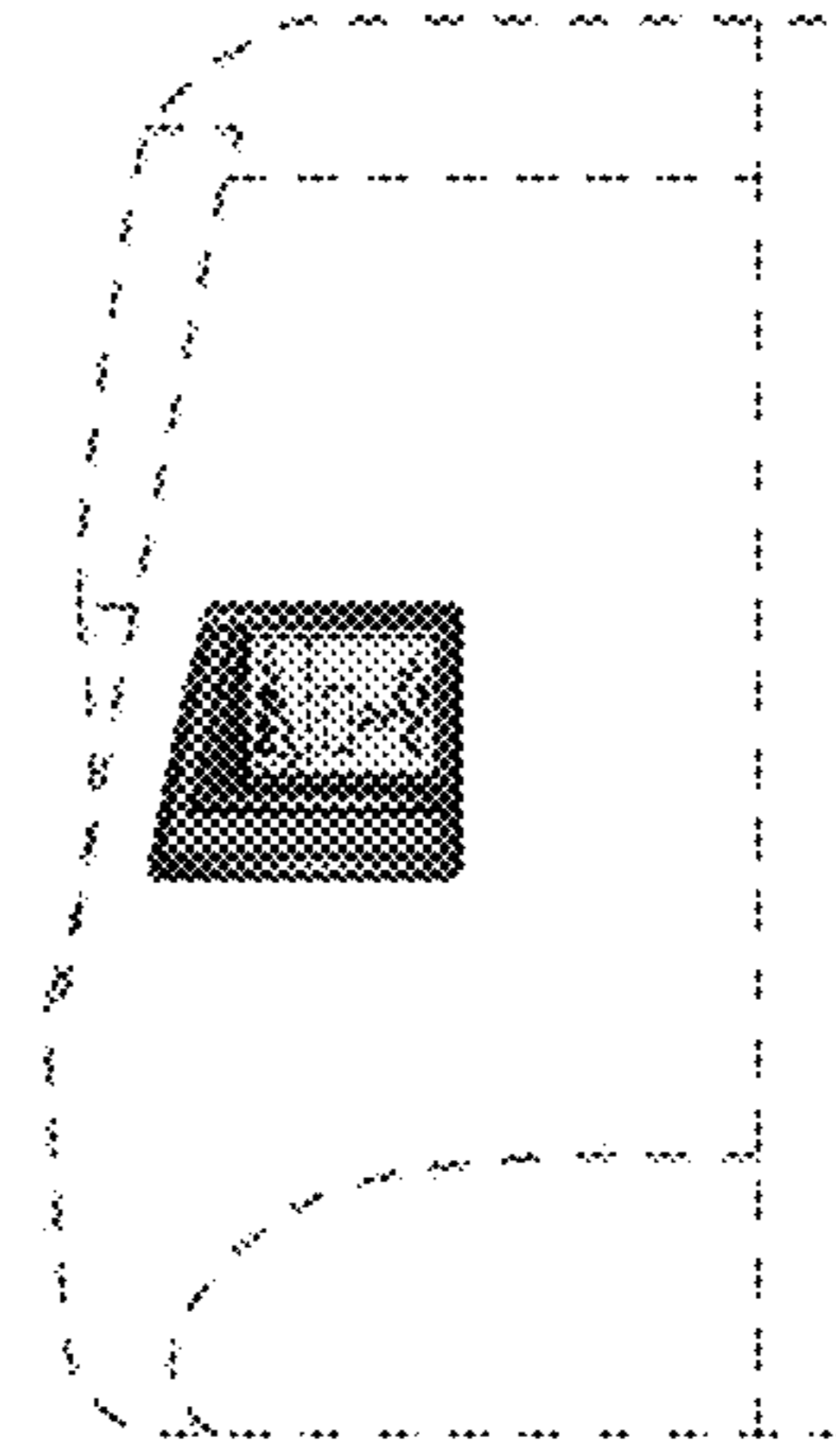


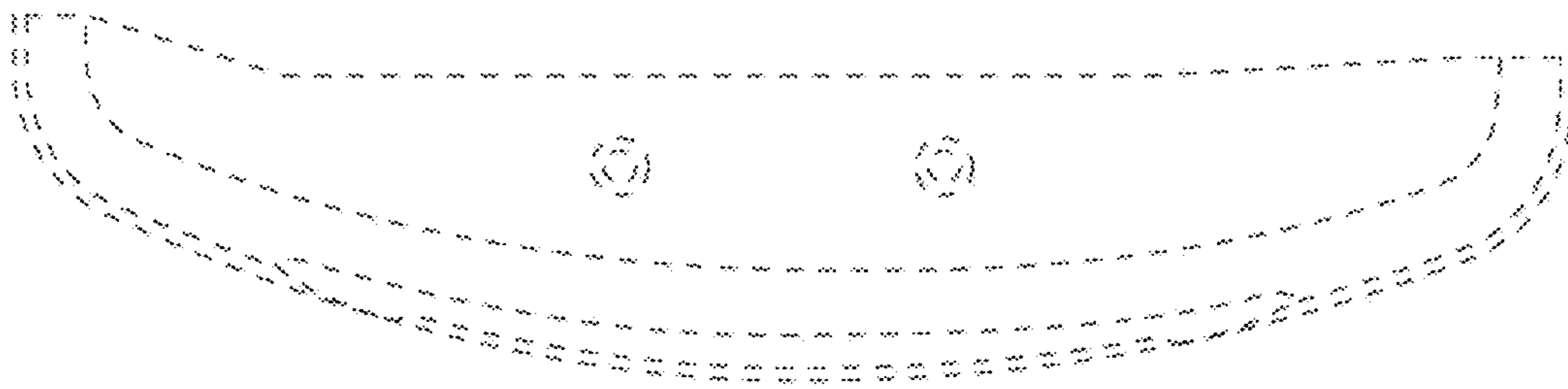

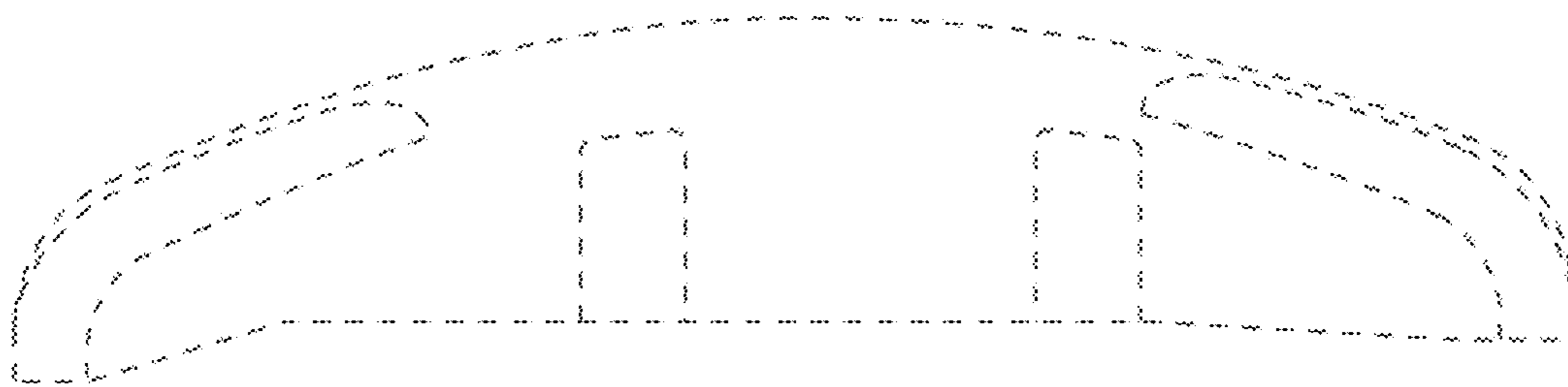

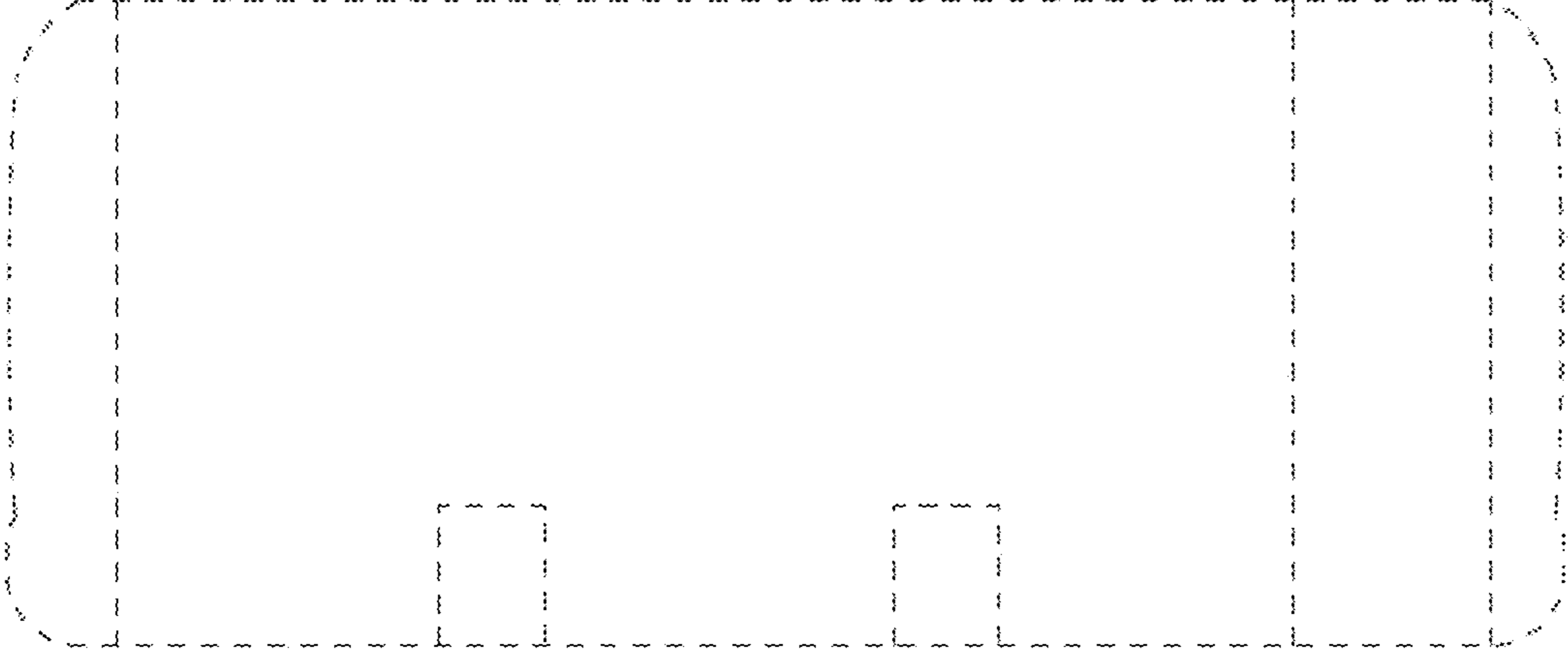

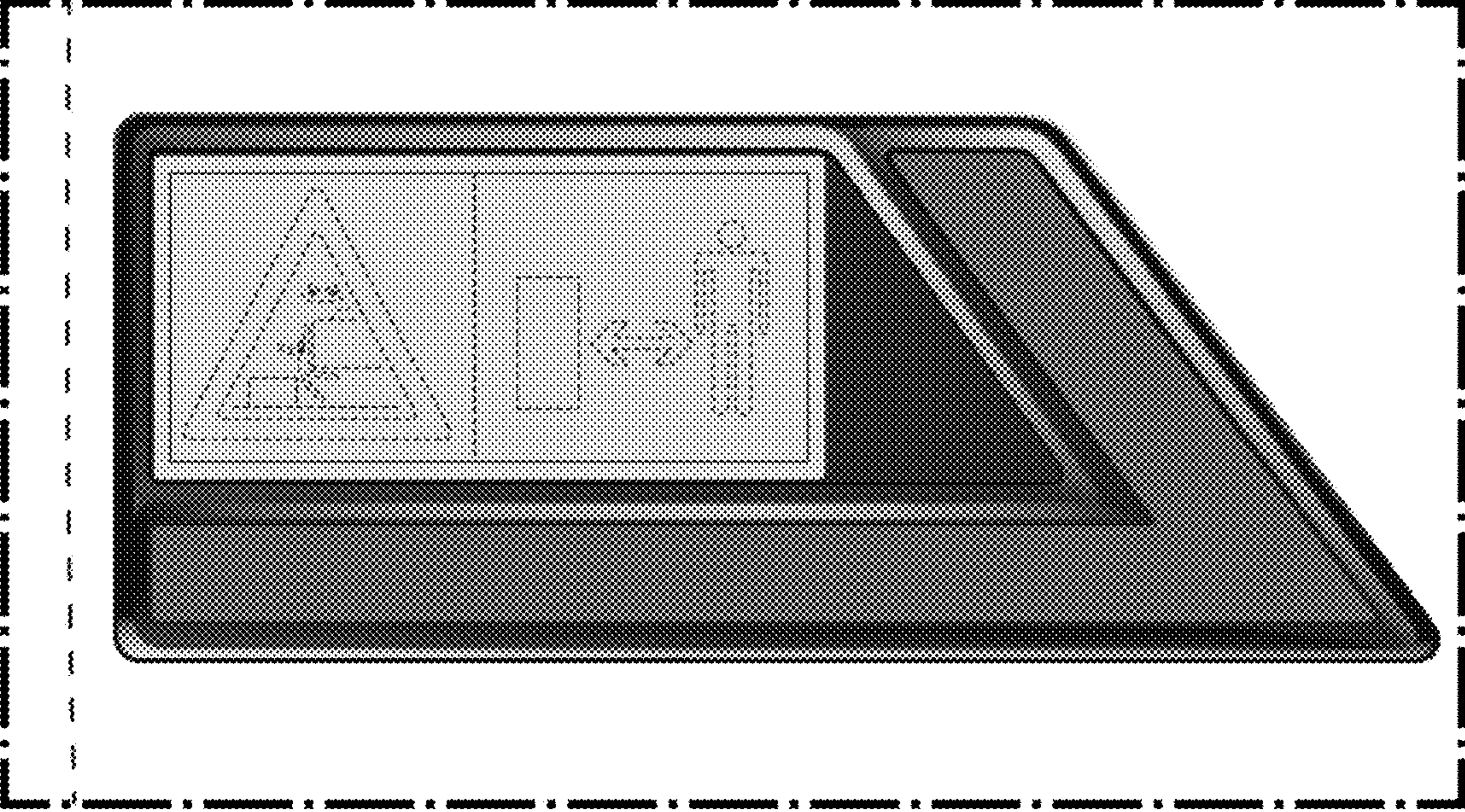
