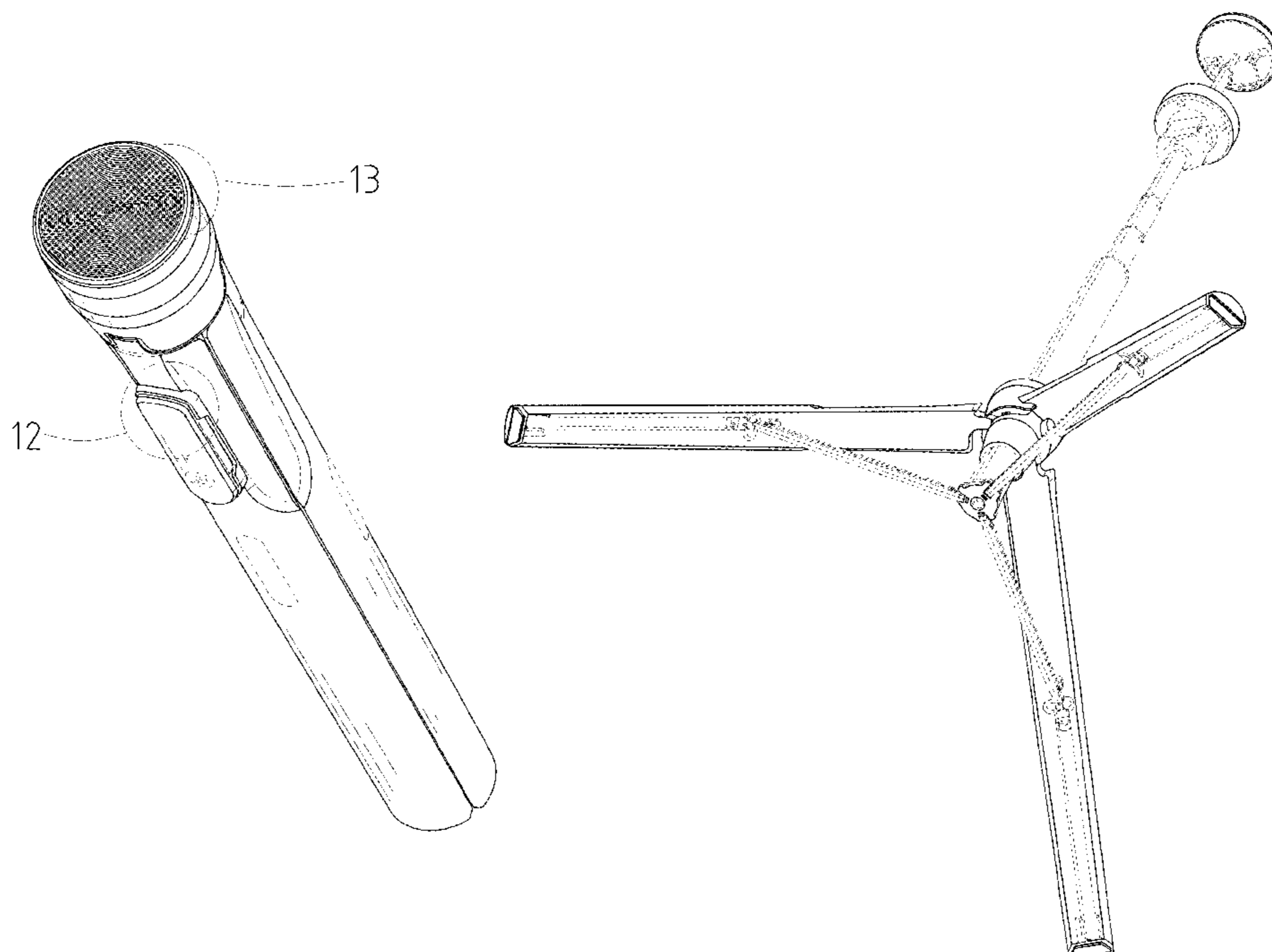
(57) **CLAIM**

The ornamental design for a tripod, as shown and described.

DESCRIPTION

FIG. 1 is a bottom, front and left side perspective view of a tripod showing my new design;
 FIG. 2 is a top, back and right side perspective view thereof;
 FIG. 3 is a front view thereof;
 FIG. 4 is a back view thereof;
 FIG. 5 is a left side view thereof;
 FIG. 6 is a right side view thereof;
 FIG. 7 is a top view thereof;
 FIG. 8 is a bottom view thereof;
 FIG. 9 is a bottom, front and left side perspective view thereof, shown with the tripod in an extended configuration;
 FIG. 10 is a bottom perspective view thereof, shown with the tripod in condition of use;
 FIG. 11 is an enlarged view of portion 11 shown in FIG. 1;
 FIG. 12 is an enlarged view of portion 12 shown in FIG. 2;

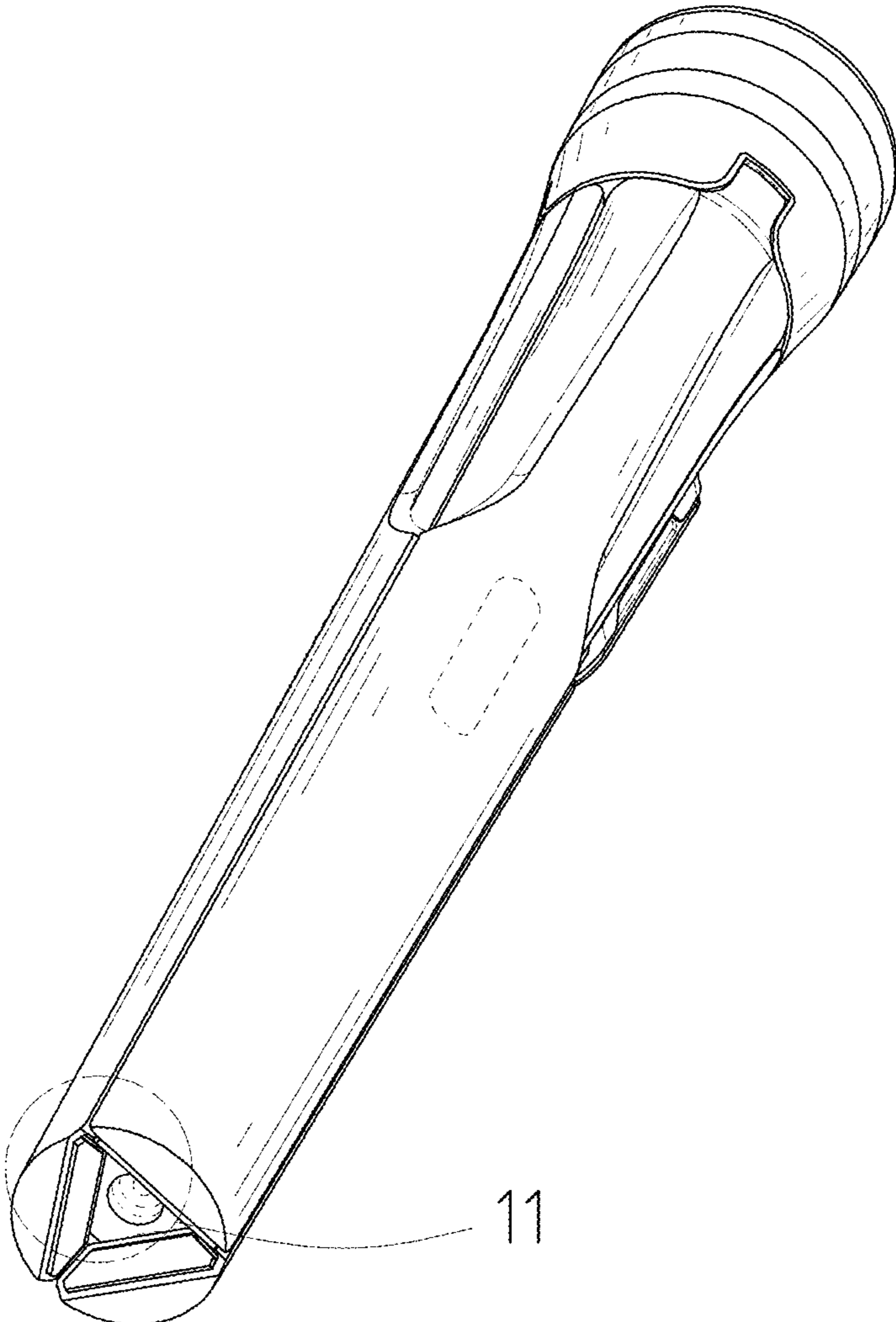

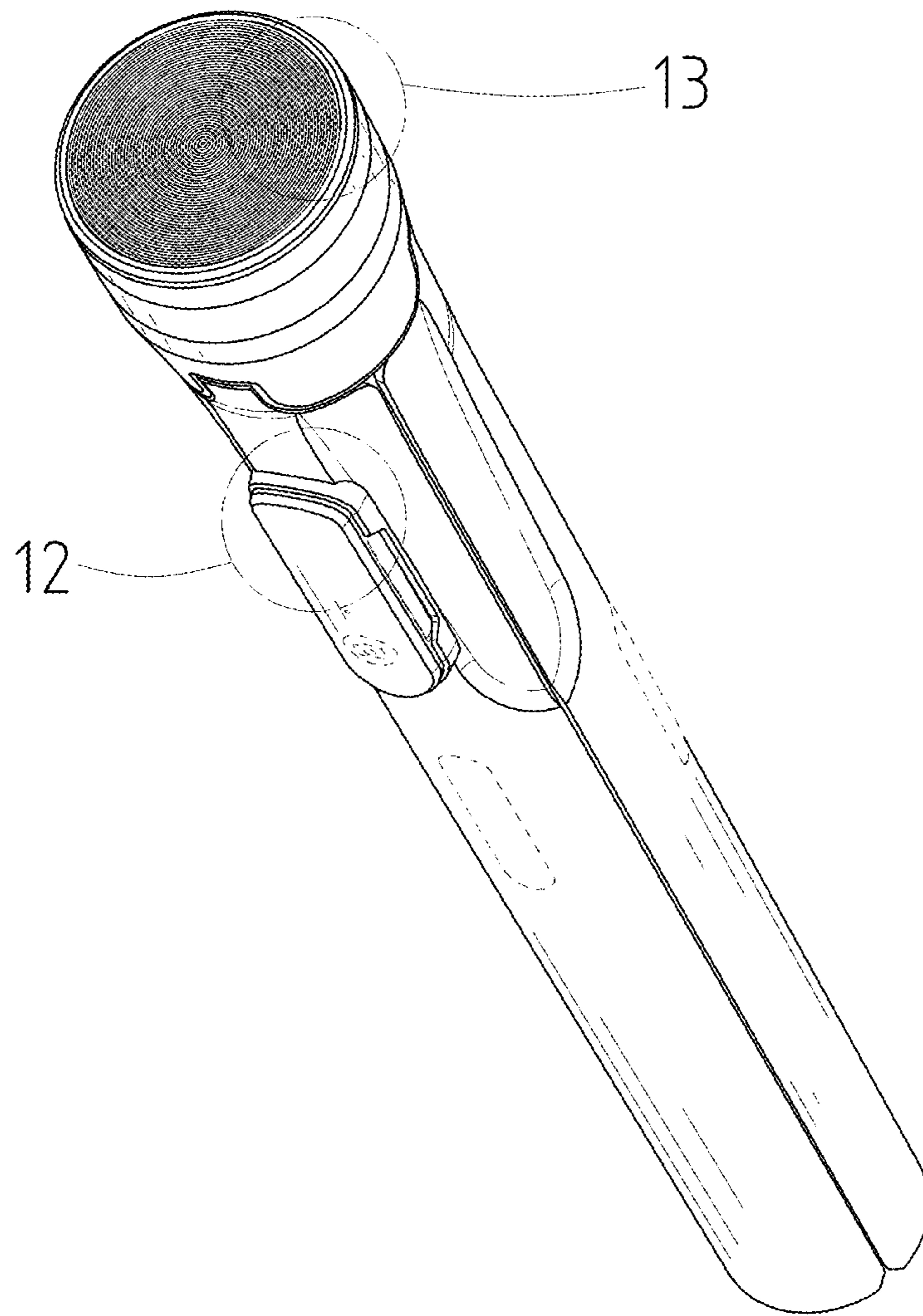

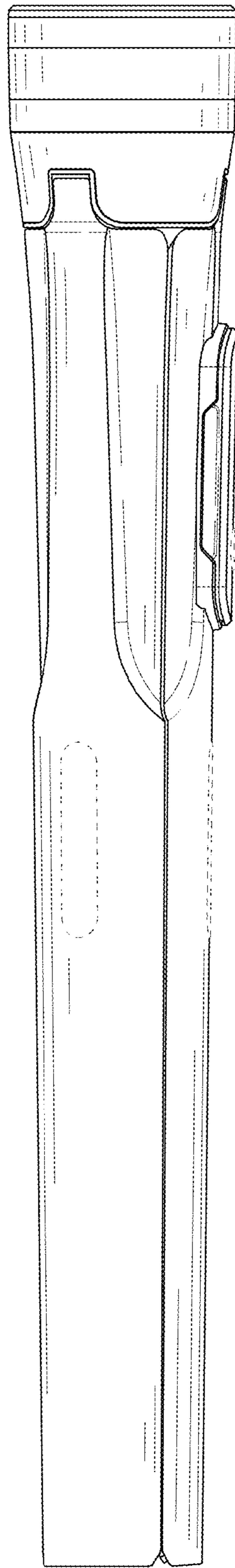

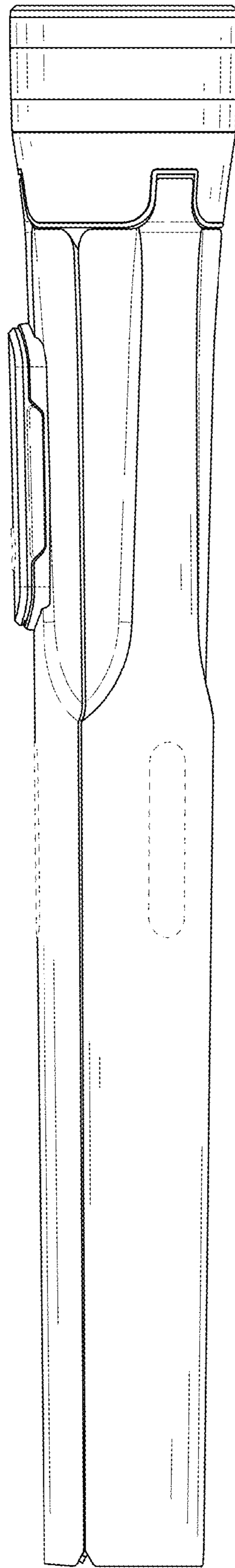

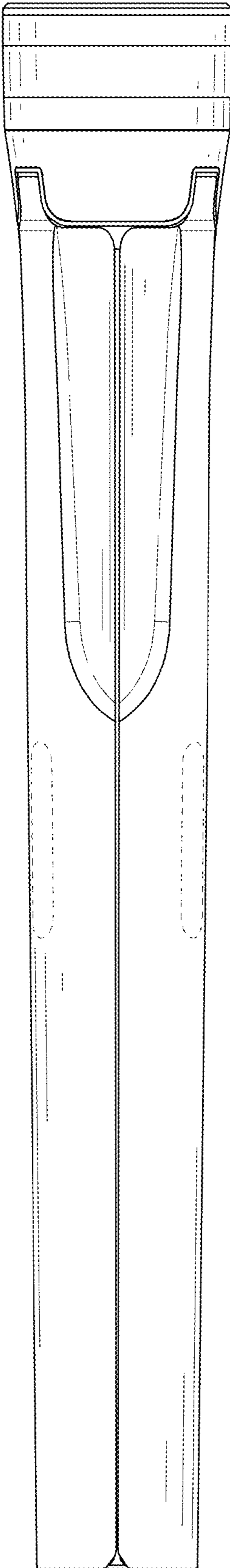

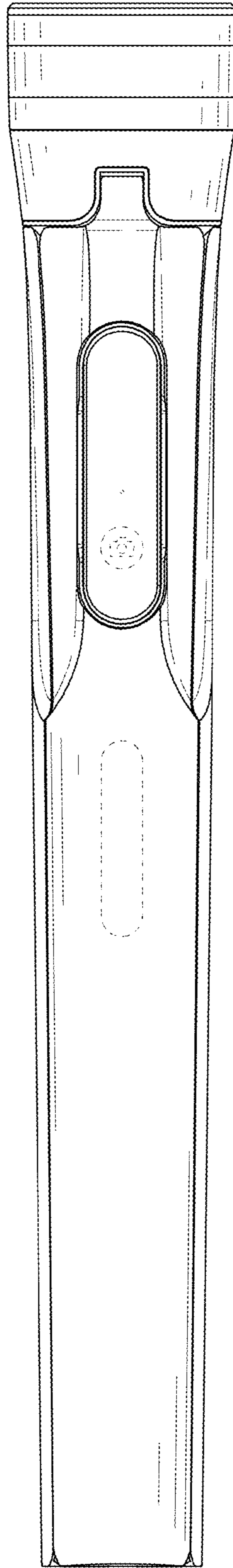

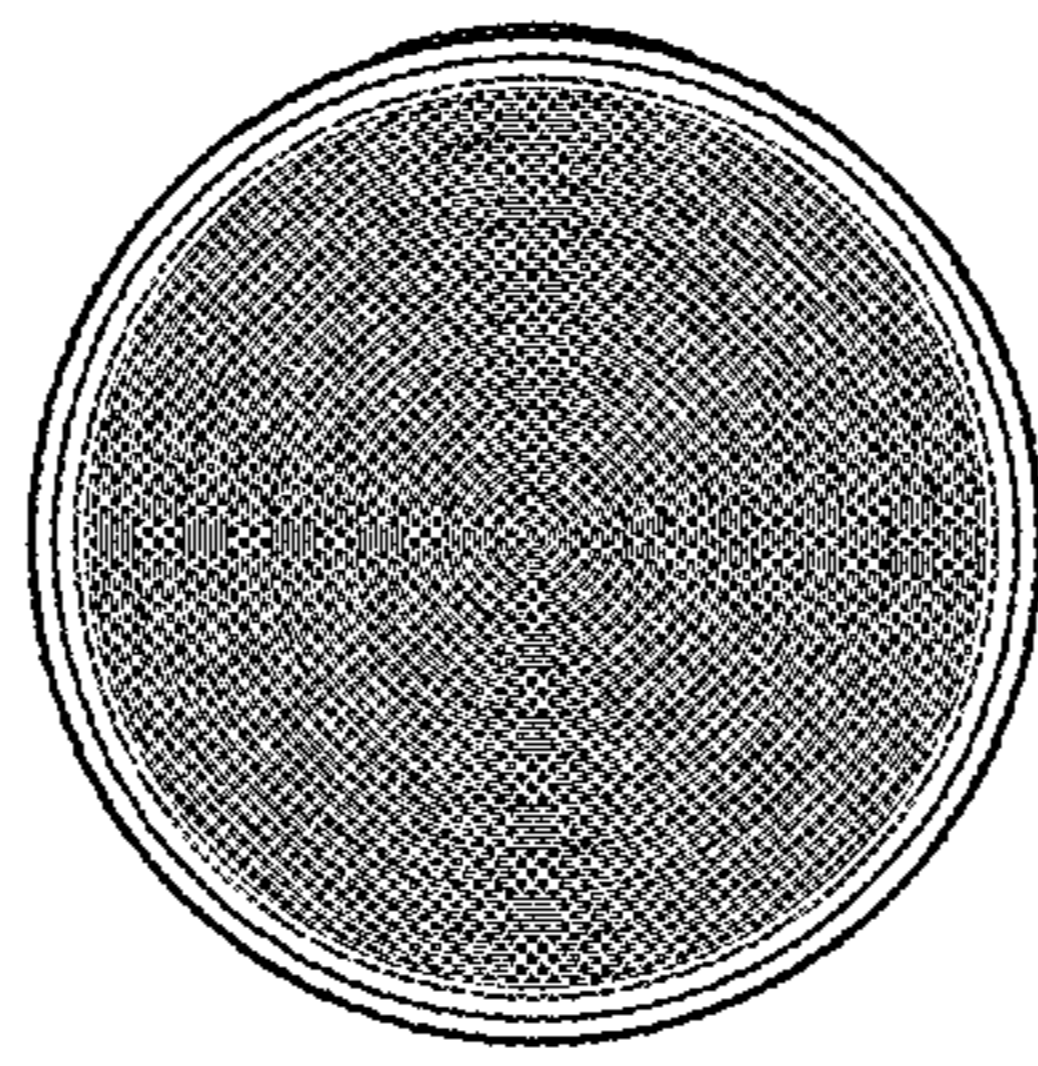

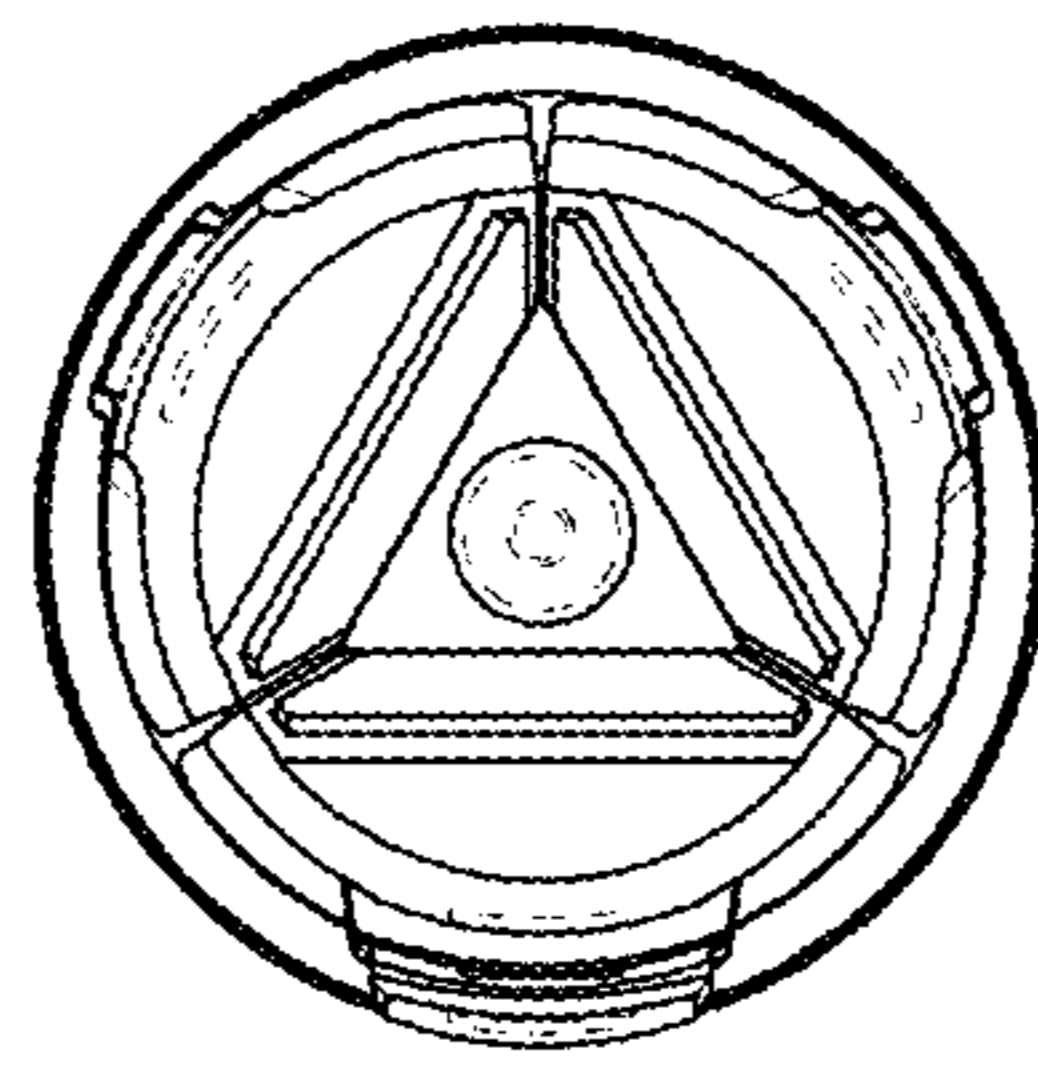

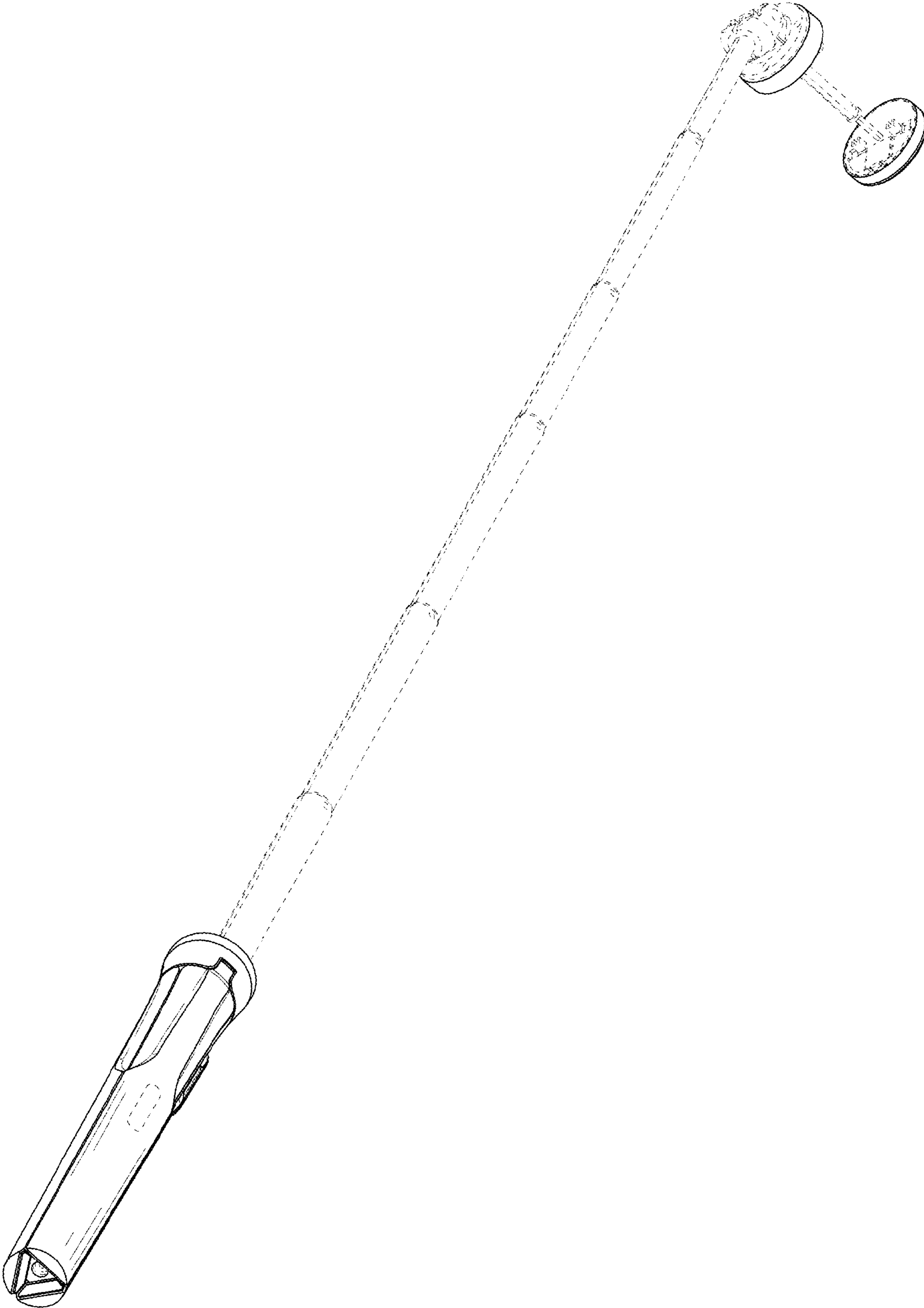

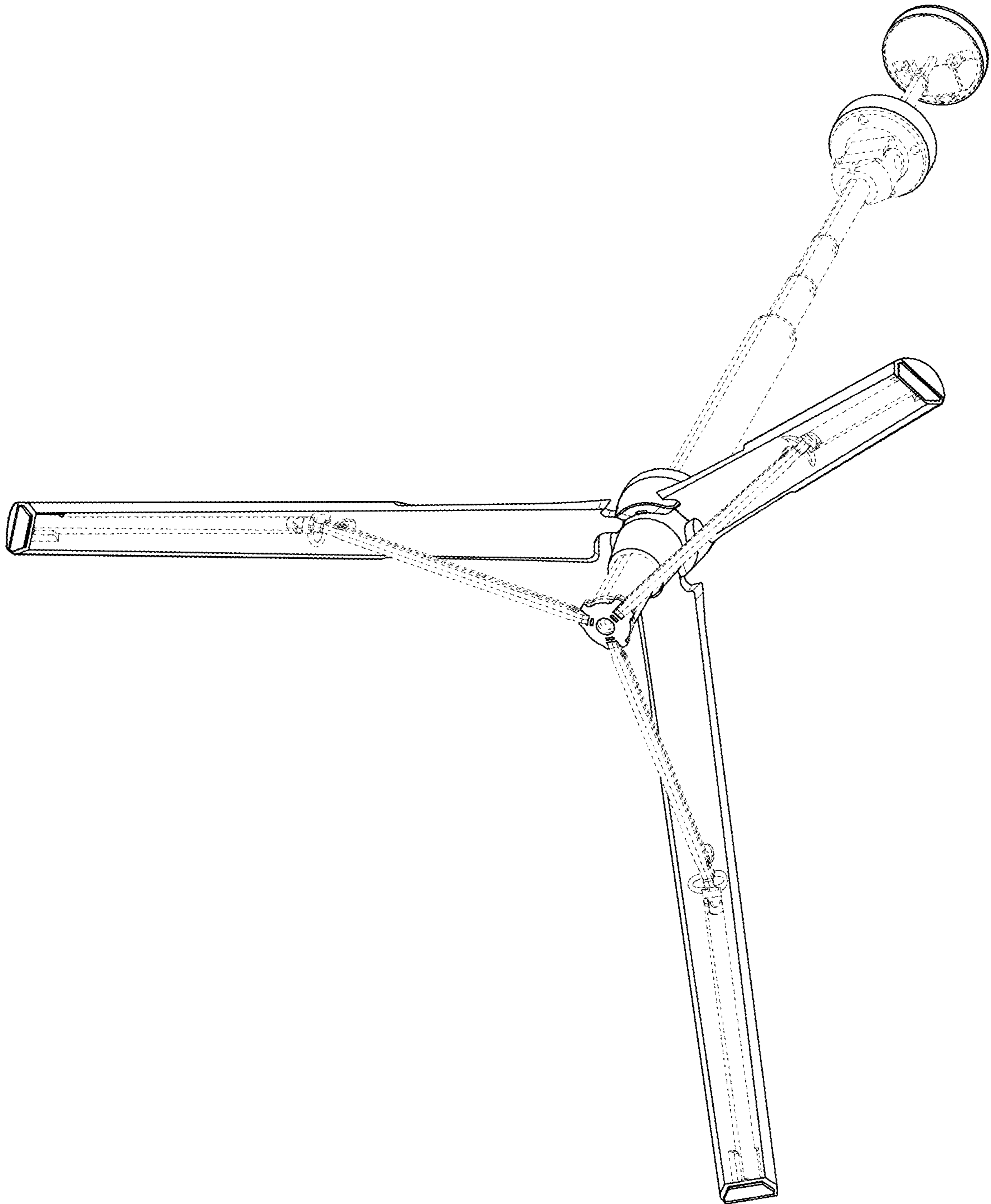

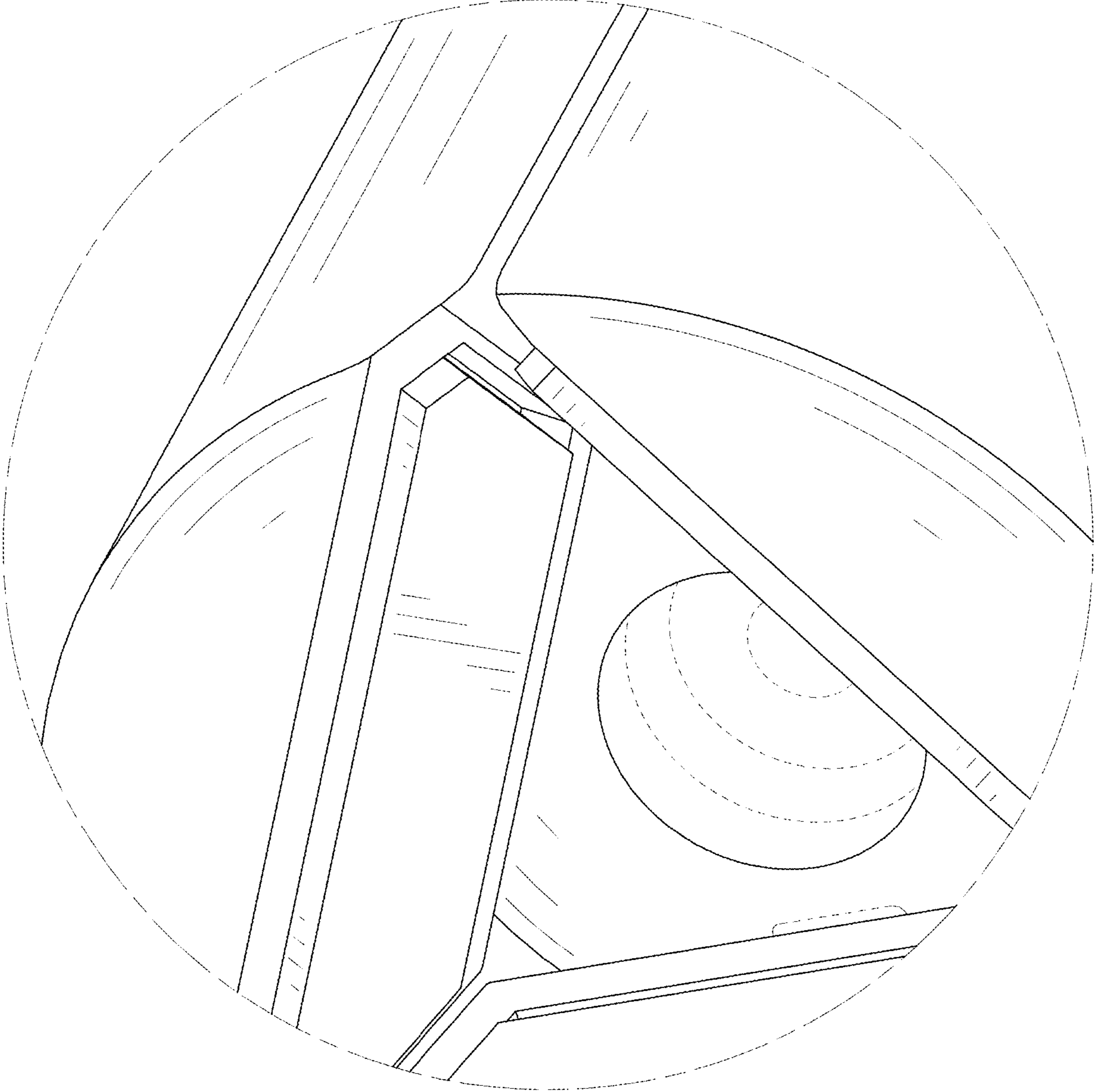

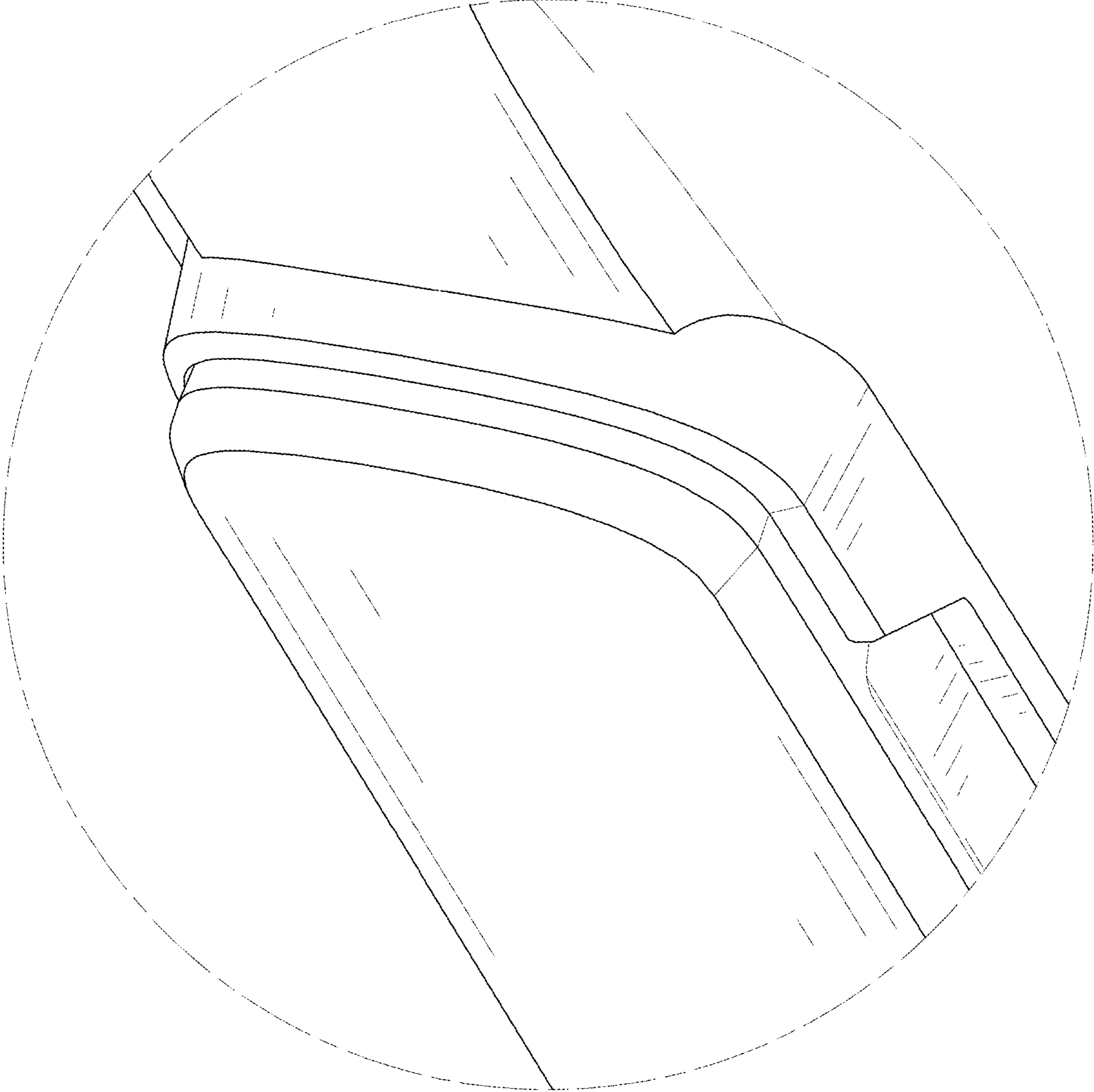

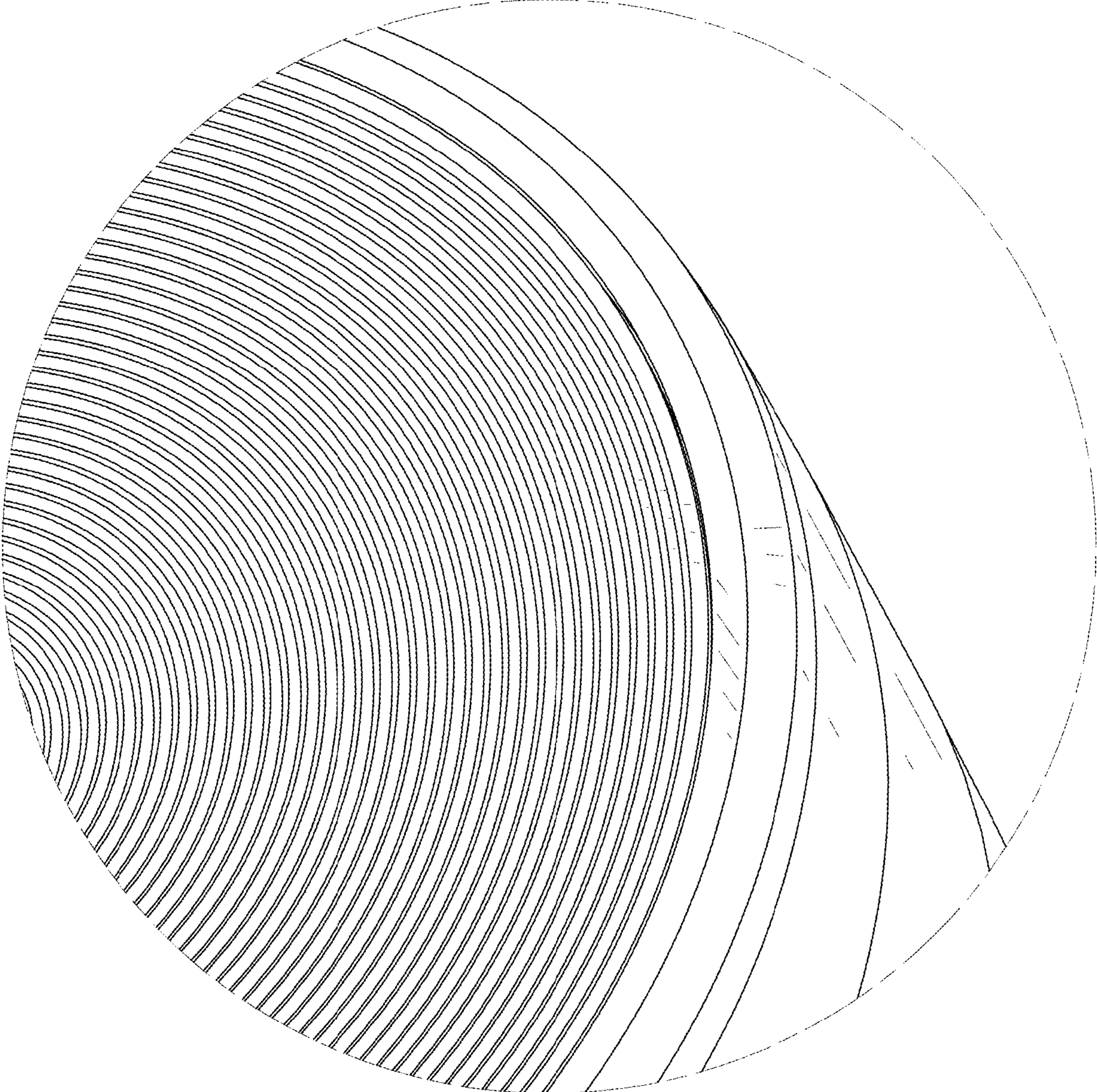
