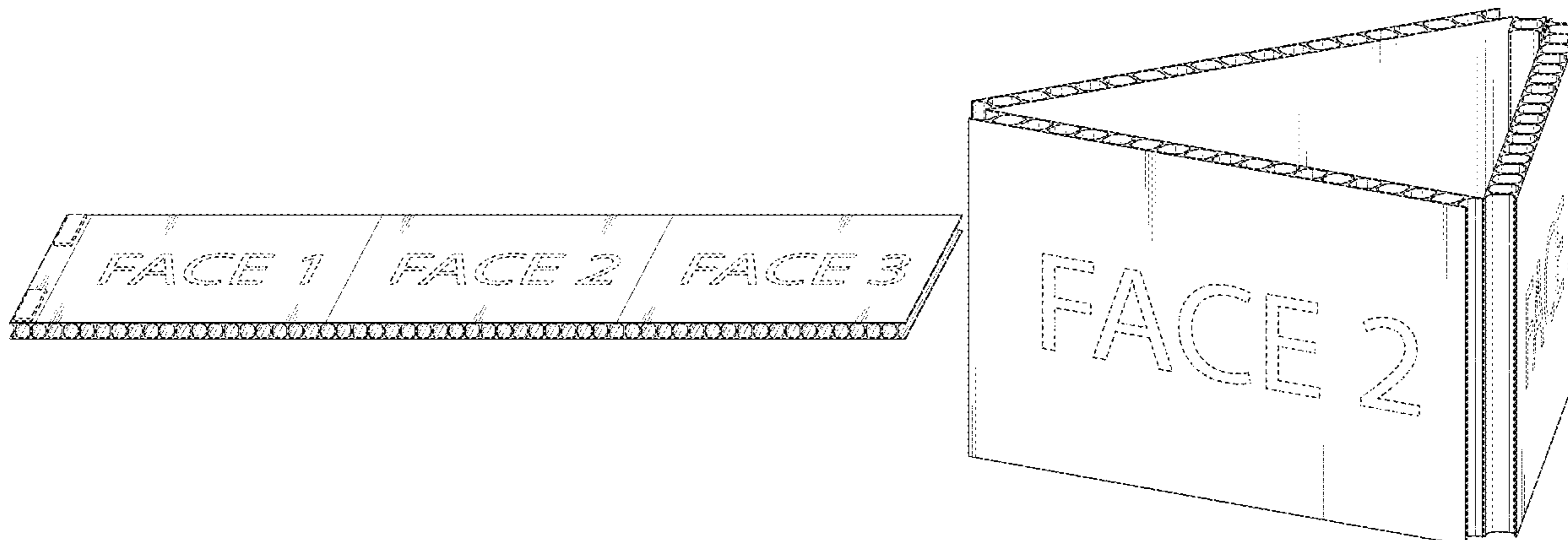
(57) **CLAIM**

The ornamental design for a three-sided yard sign, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a three-sided yard sign, showing my new design in a flat configuration;
 FIG. 2 is a rear perspective view of FIG. 1;
 FIG. 3 is a top plan view of FIG. 1, the bottom plan view being a mirror image thereof;
 FIG. 4 is a perspective view thereof, illustrated in an assembled configuration;
 FIG. 5 is a front elevational view of FIG. 4;
 FIG. 6 is a rear elevational view of FIG. 4;
 FIG. 7 is a left-side elevational view of FIG. 4;
 FIG. 8 is a right-side elevational view of FIG. 4; and,
 FIG. 9 is a top plan view of FIG. 4, the bottom plan view being a mirror image thereof.
 The broken lines showing text and hook-and-loop type fastening strips in the figures depict portions of the three-sided yard sign that form no part of the claimed design.

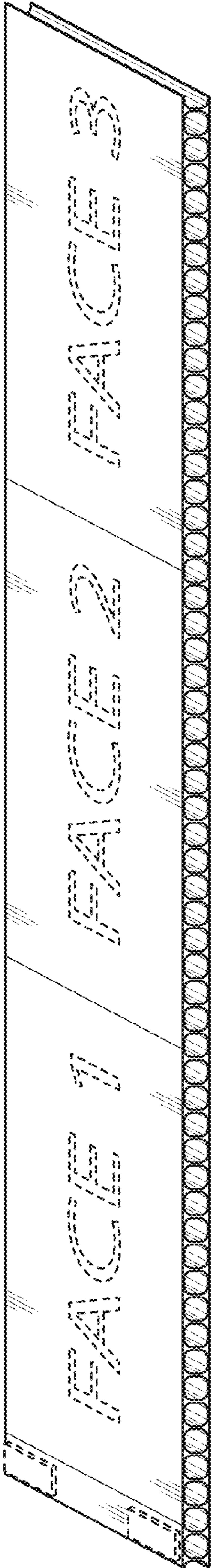

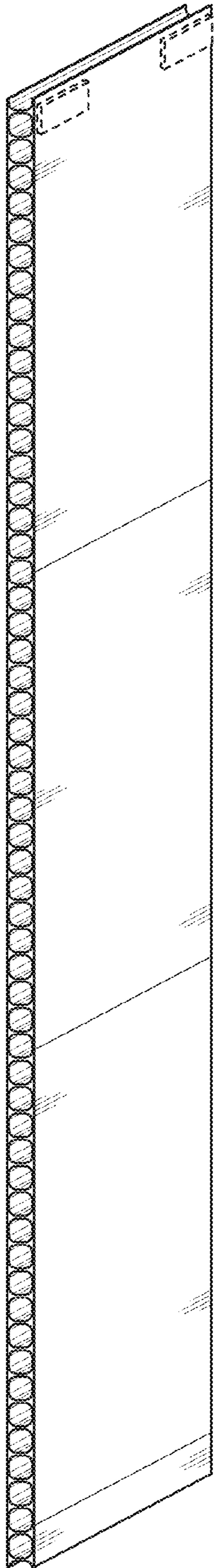

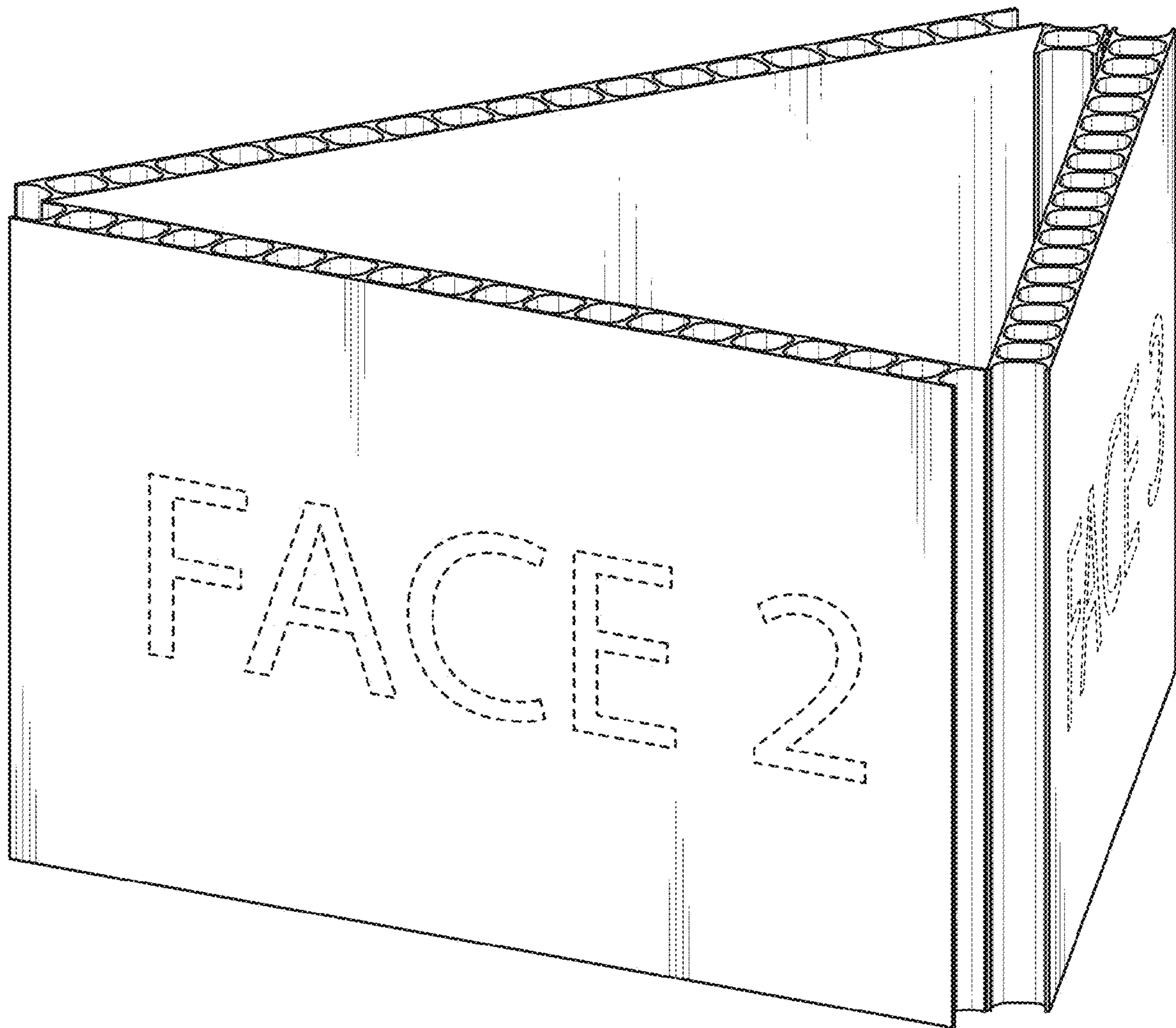

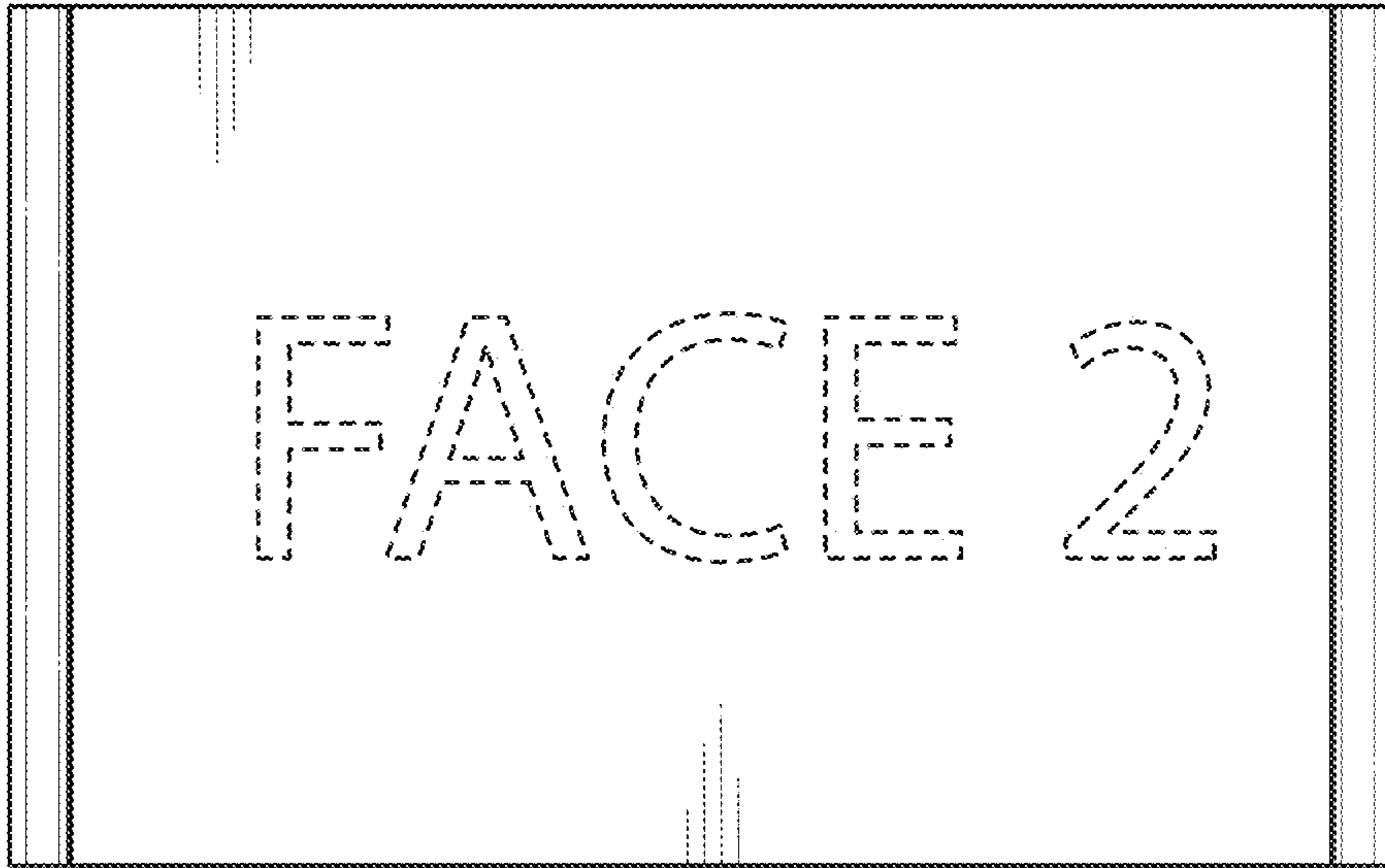

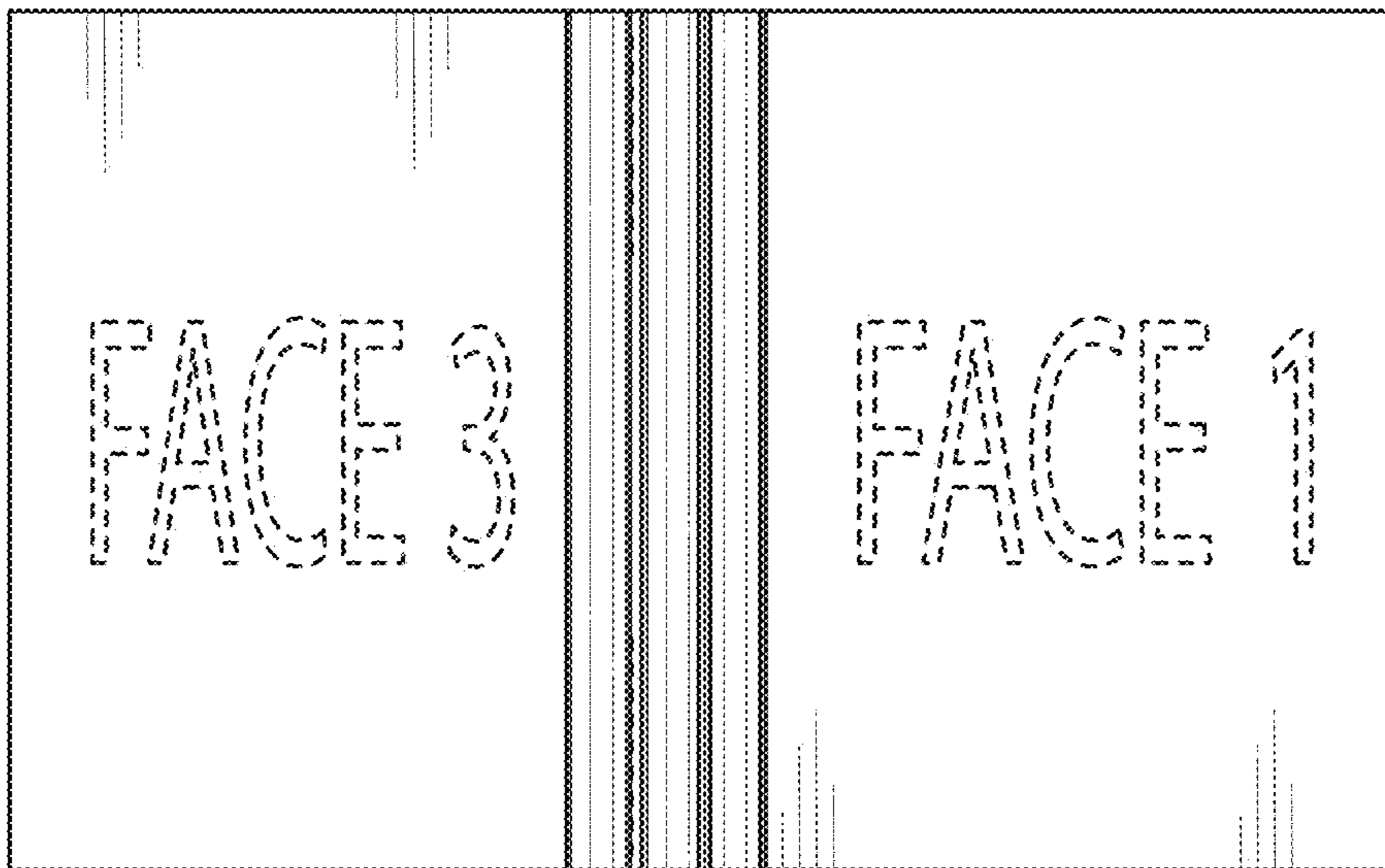

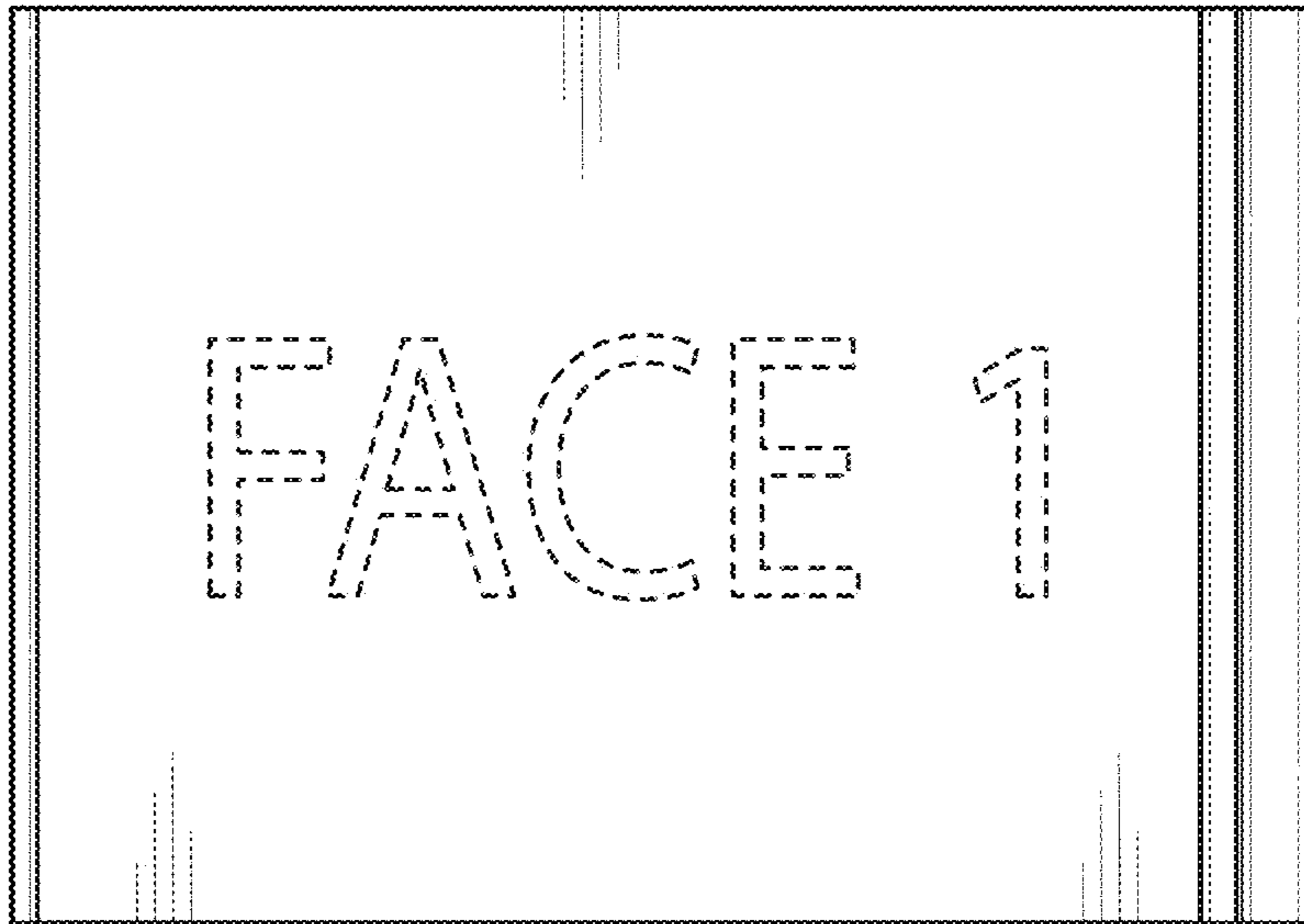

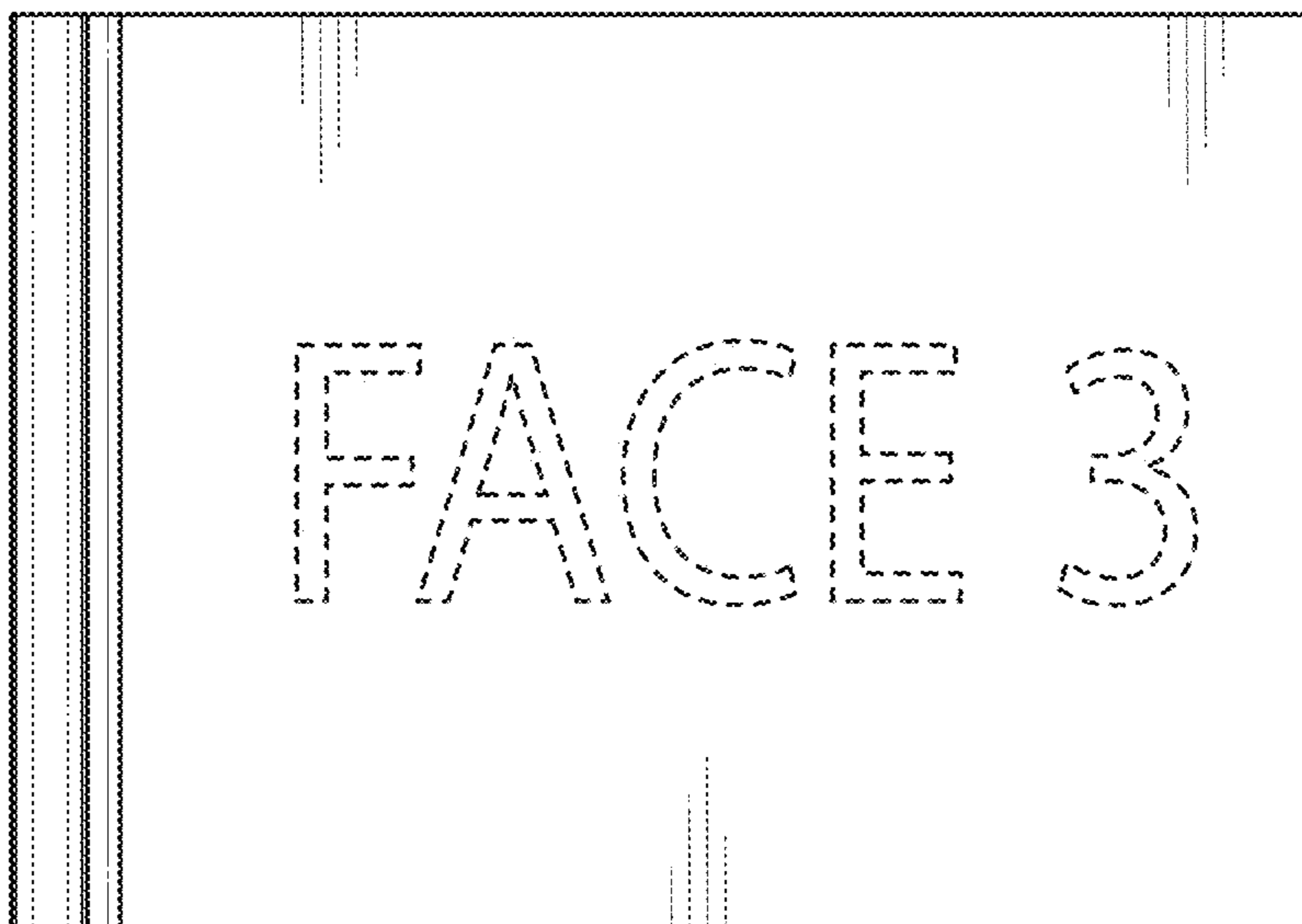

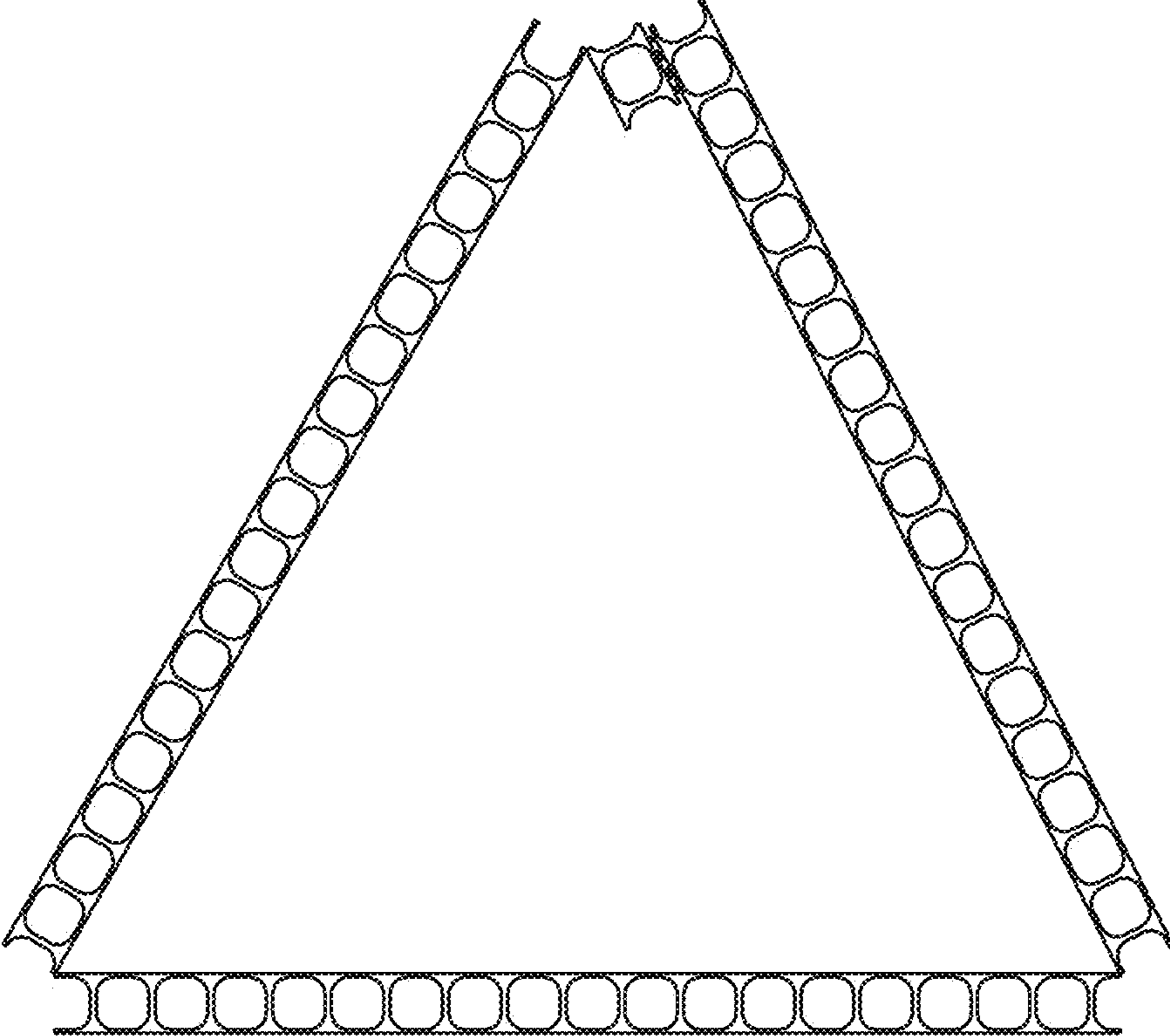
