The ornamental design for a dinosaur shaped toy, as shown and described.

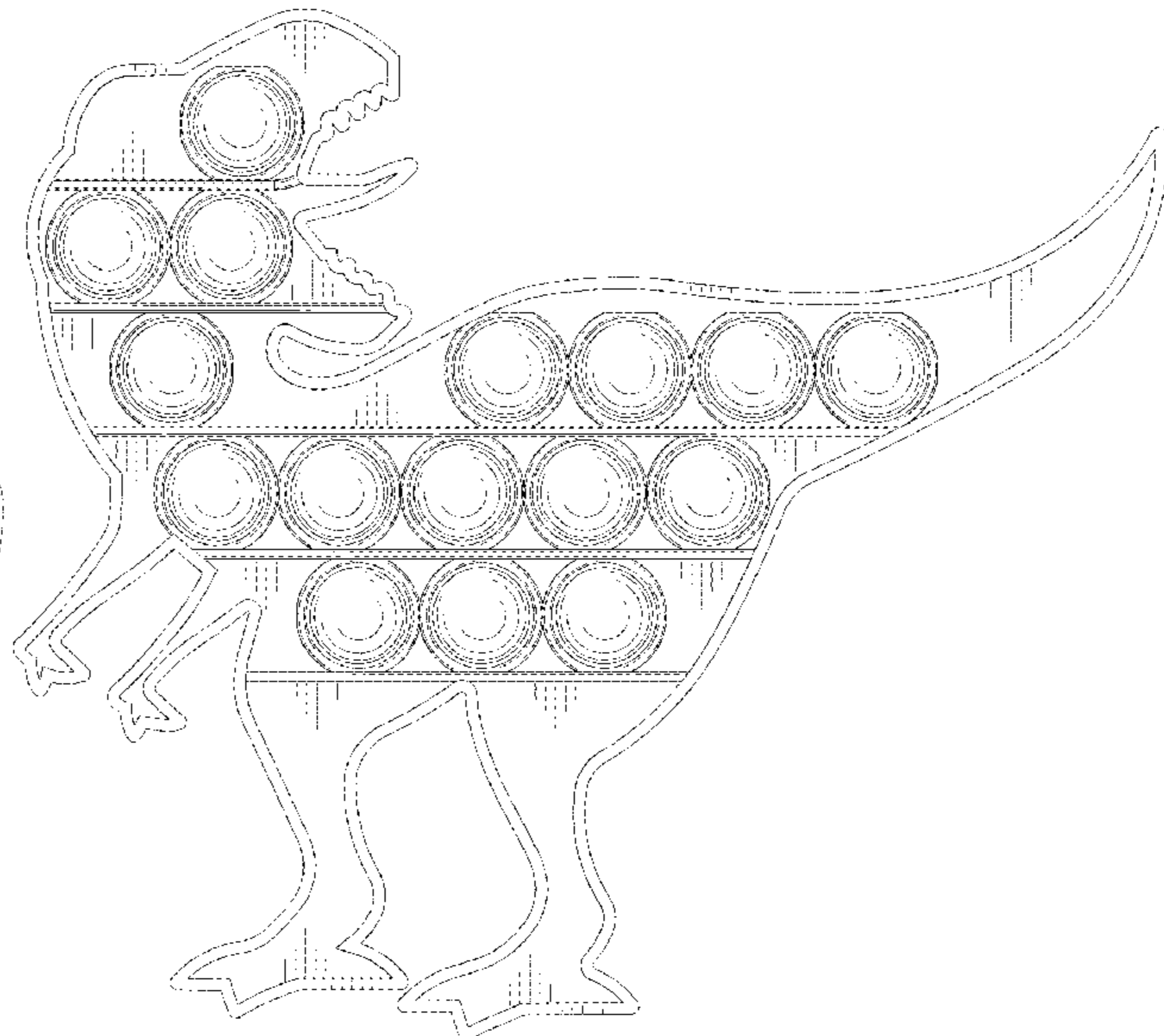
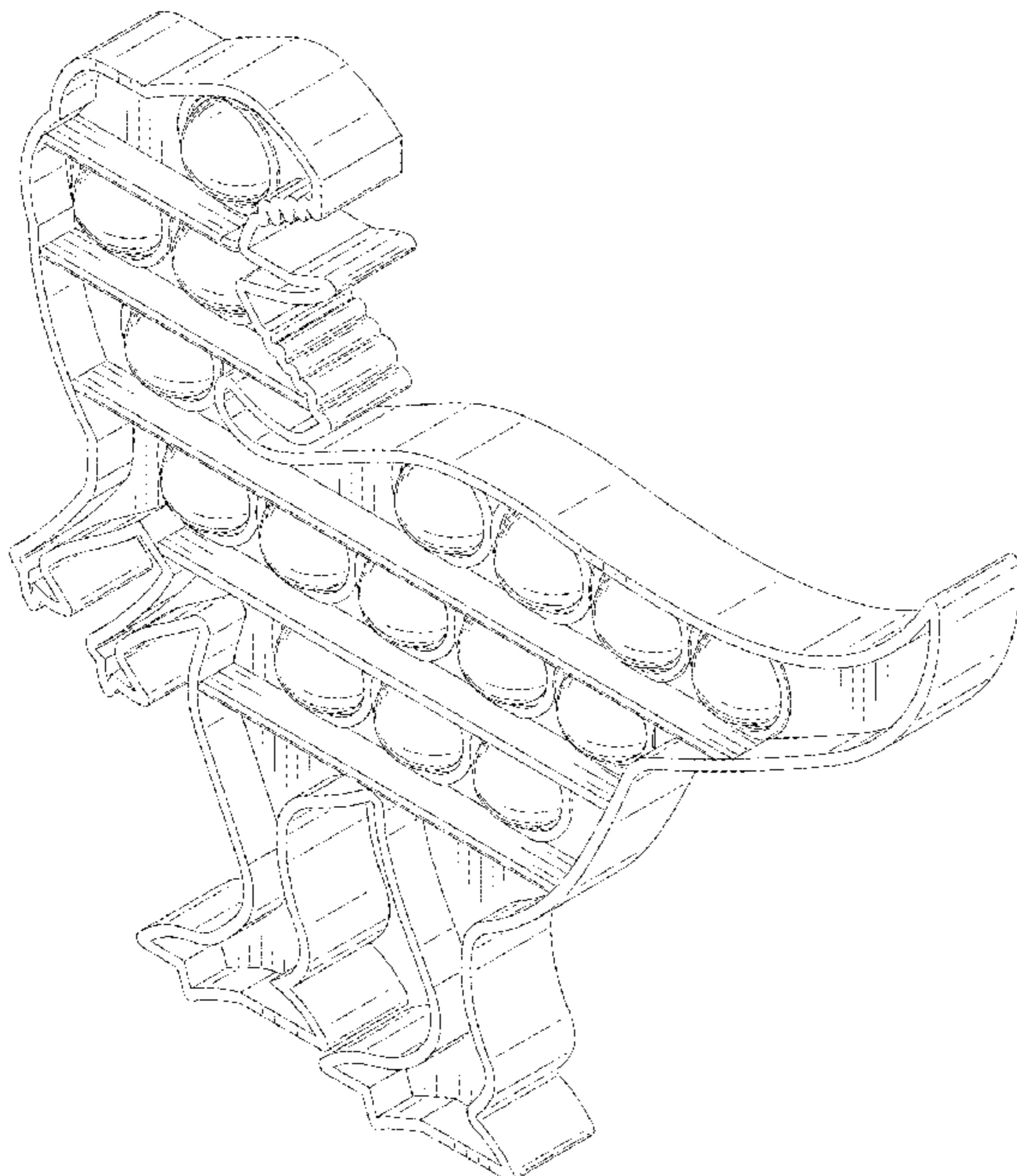
DESCRIPTION

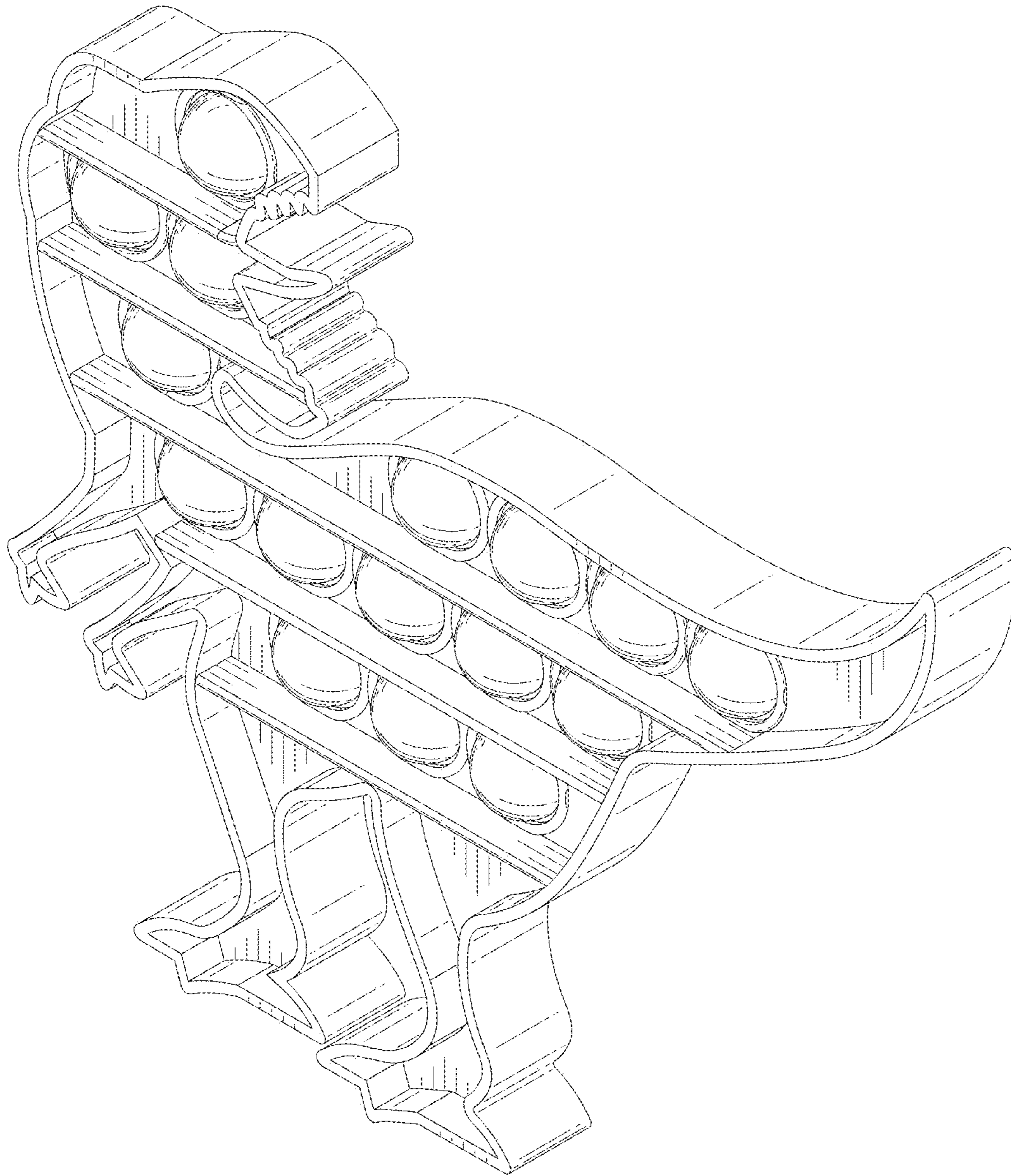

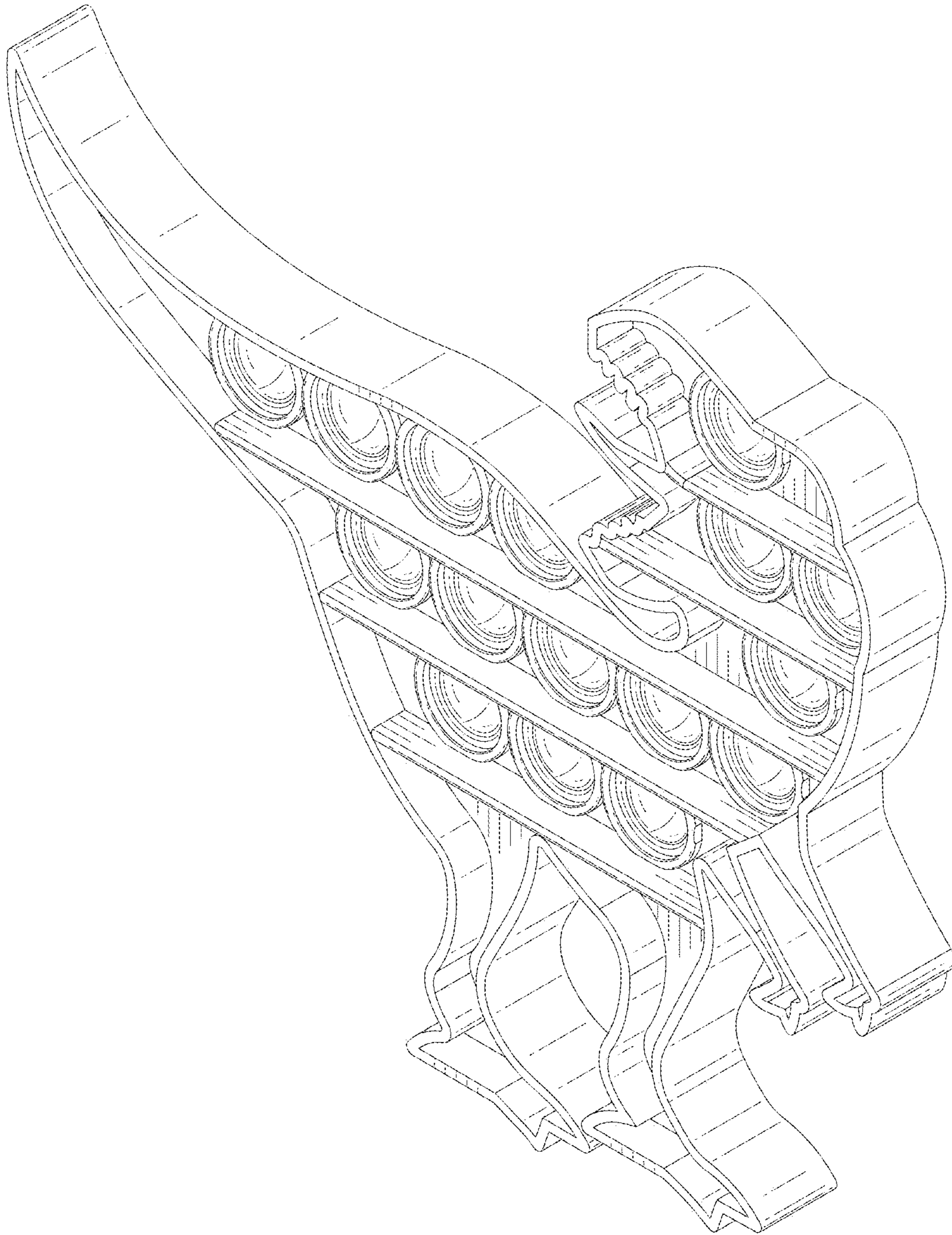

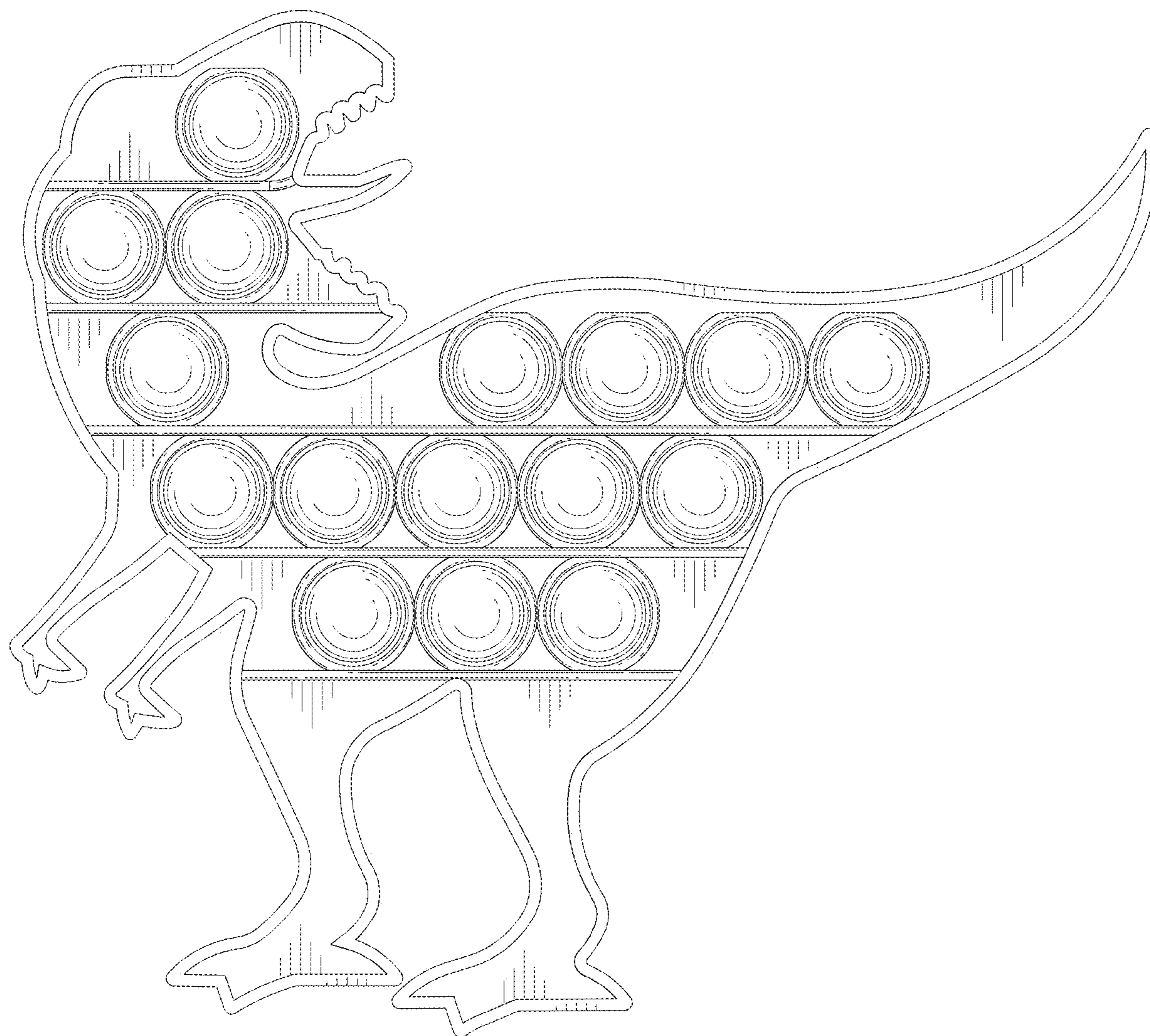

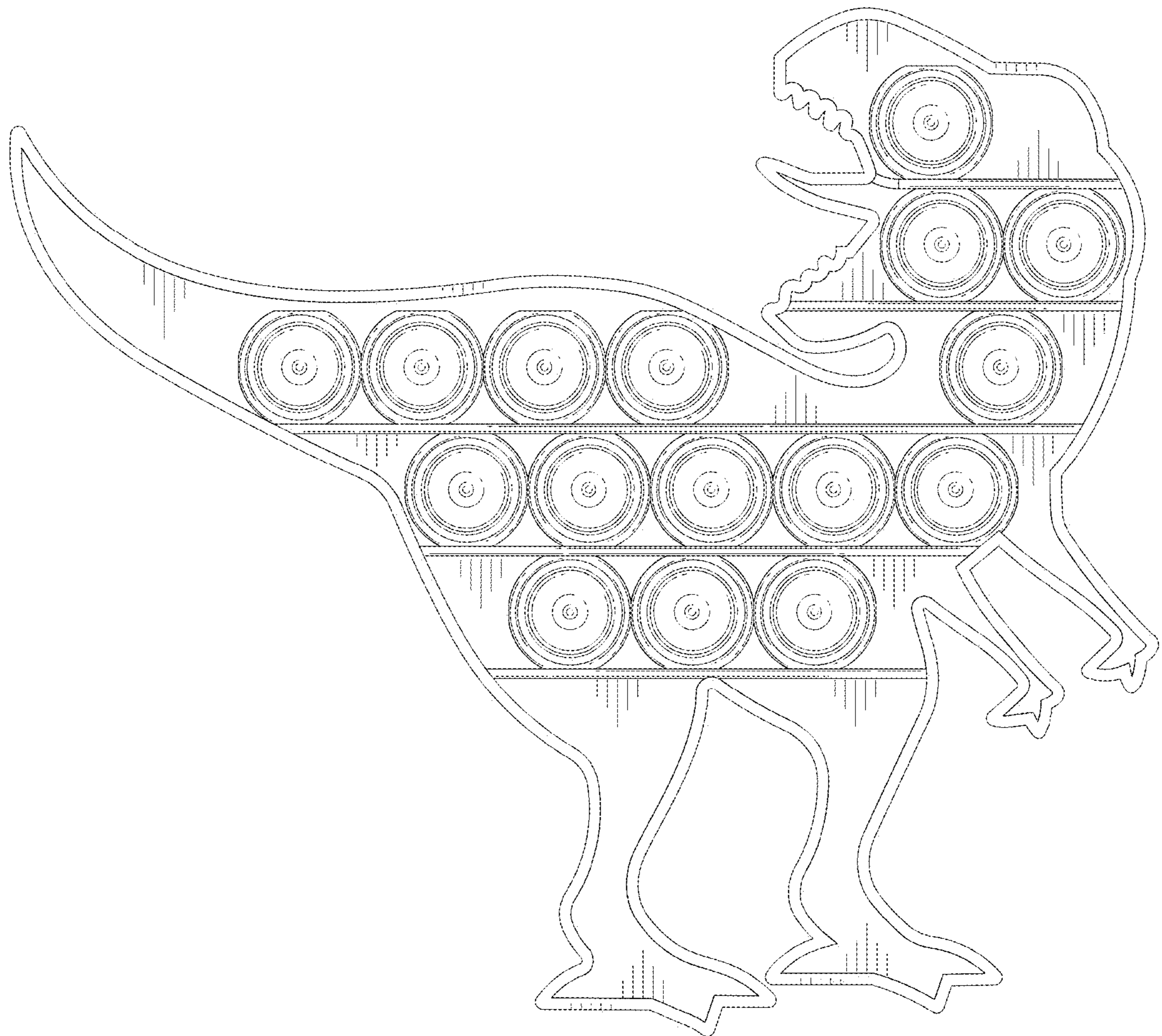

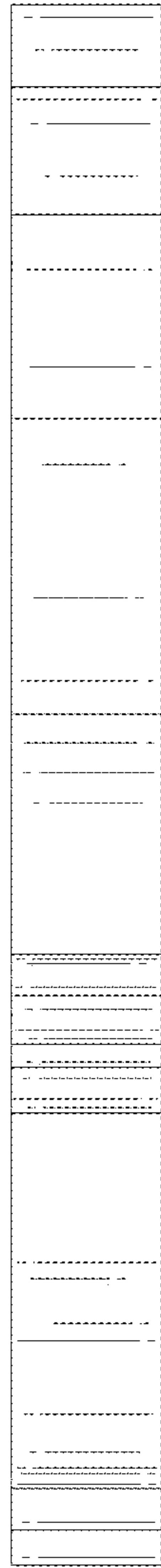

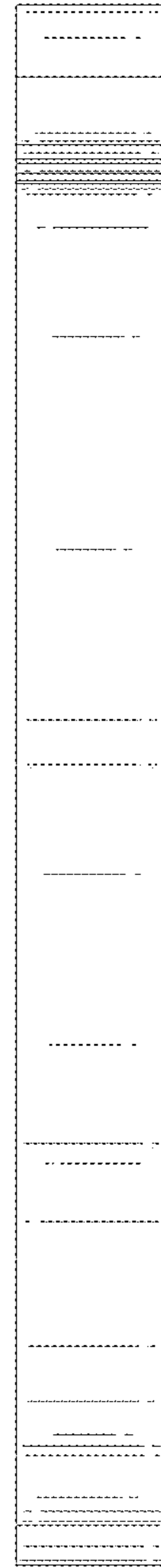

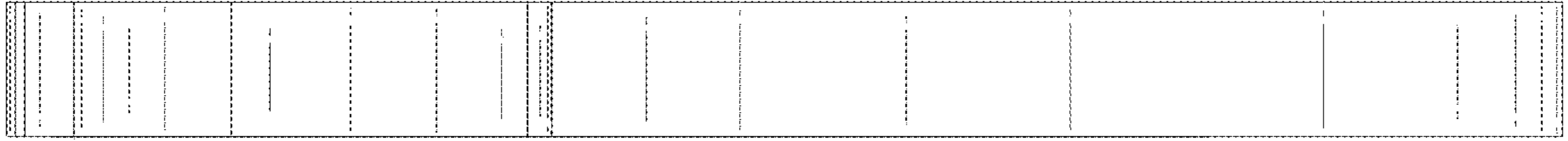

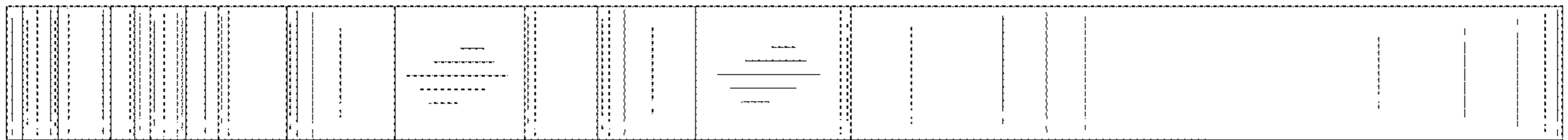
