(57) **CLAIM**

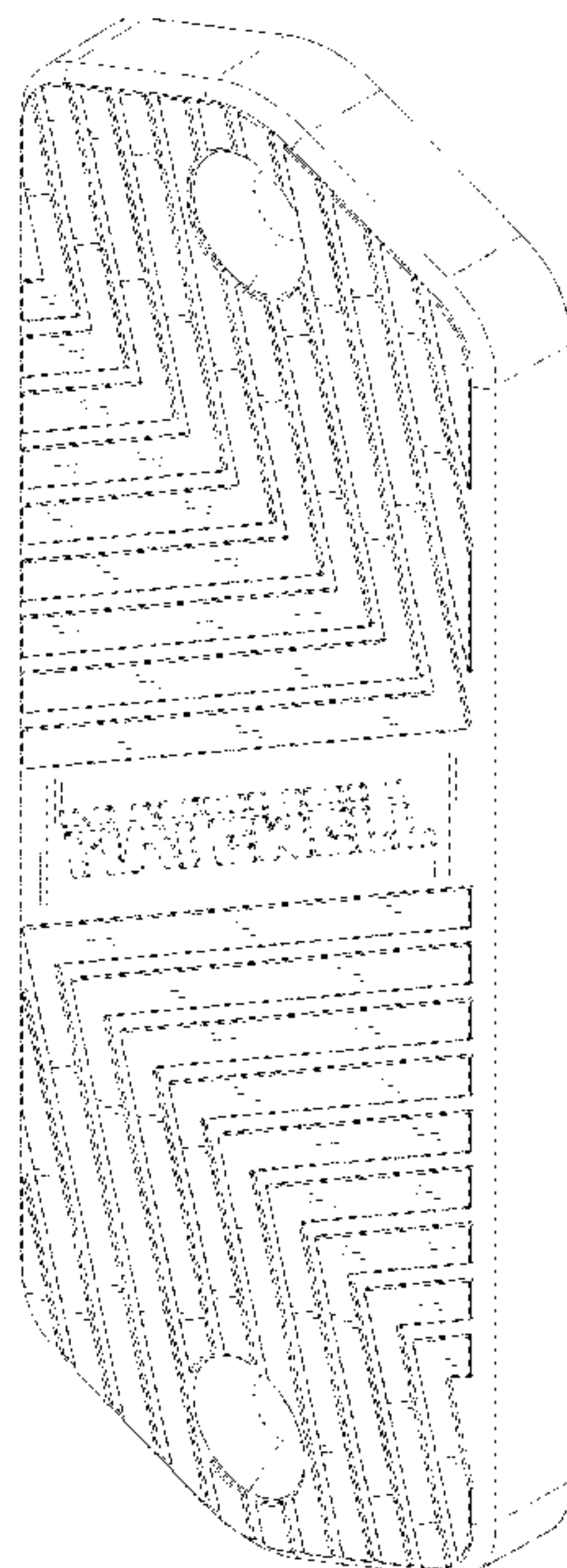
The ornamental design for a magnetic gun mount, as shown and described.

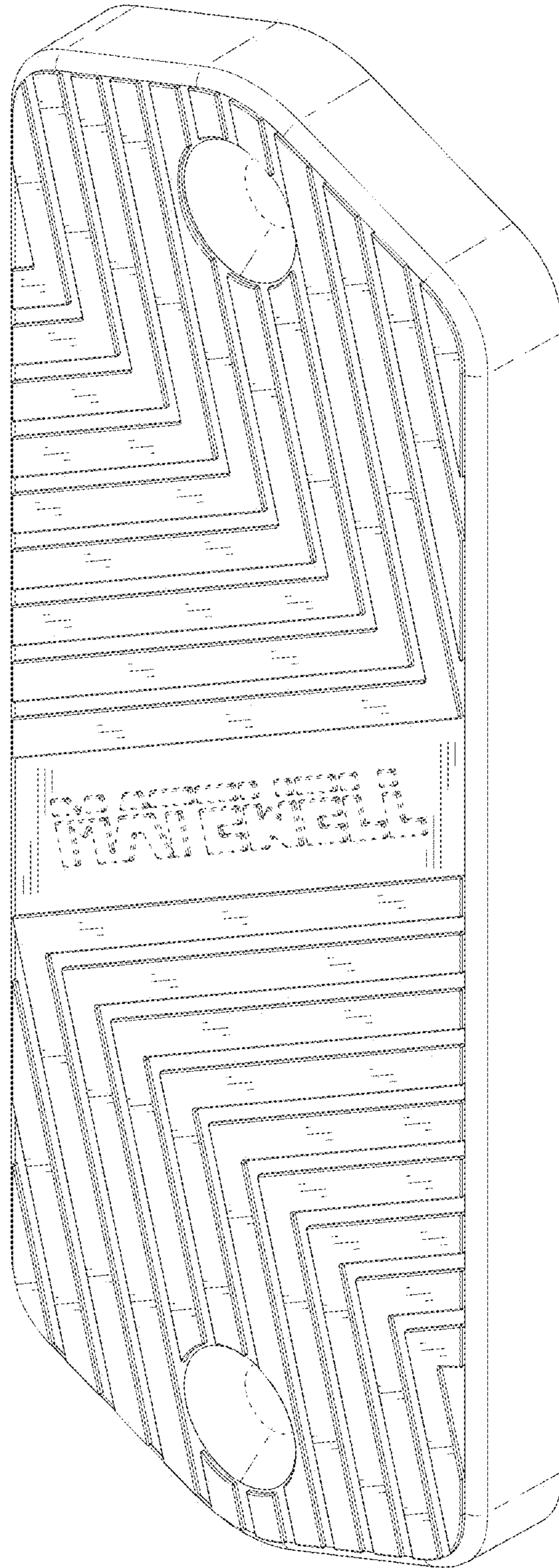

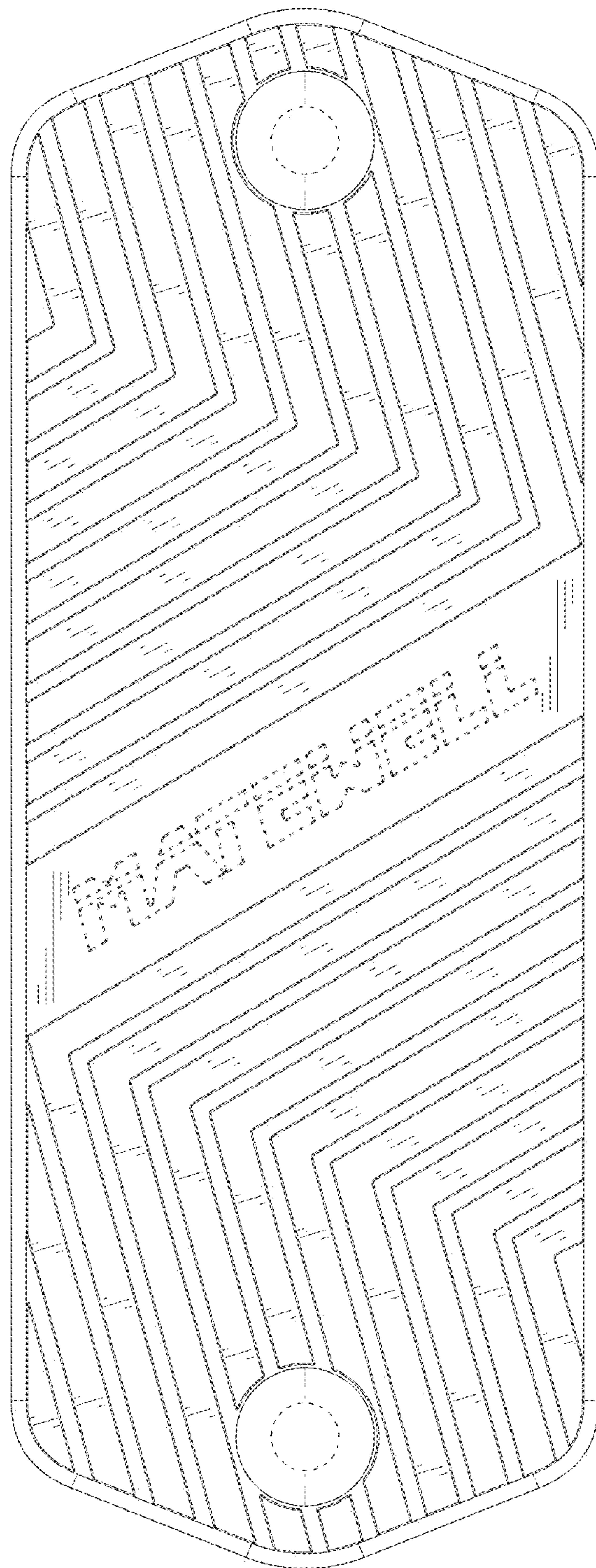

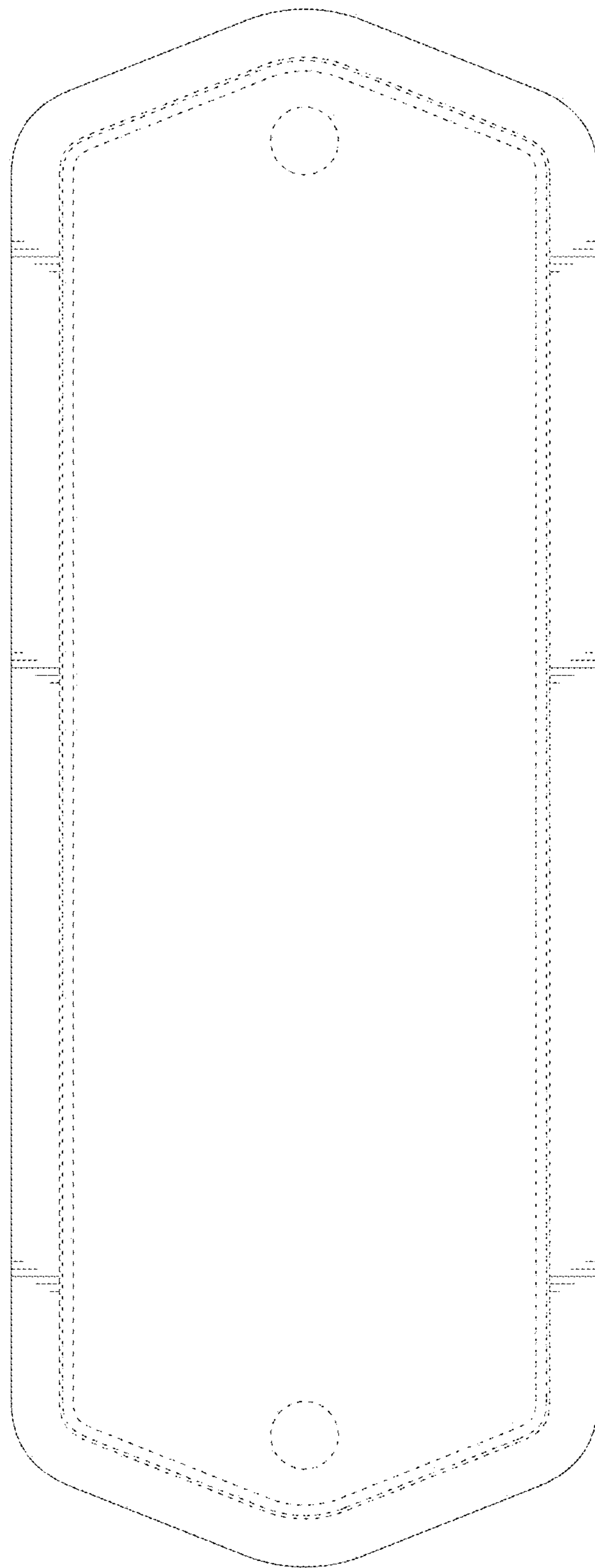

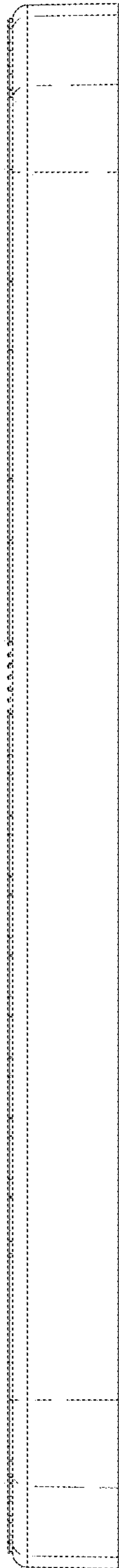

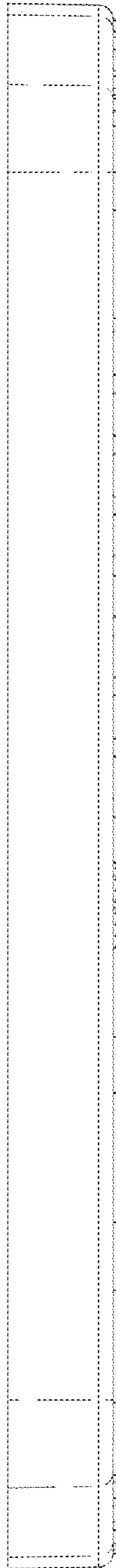

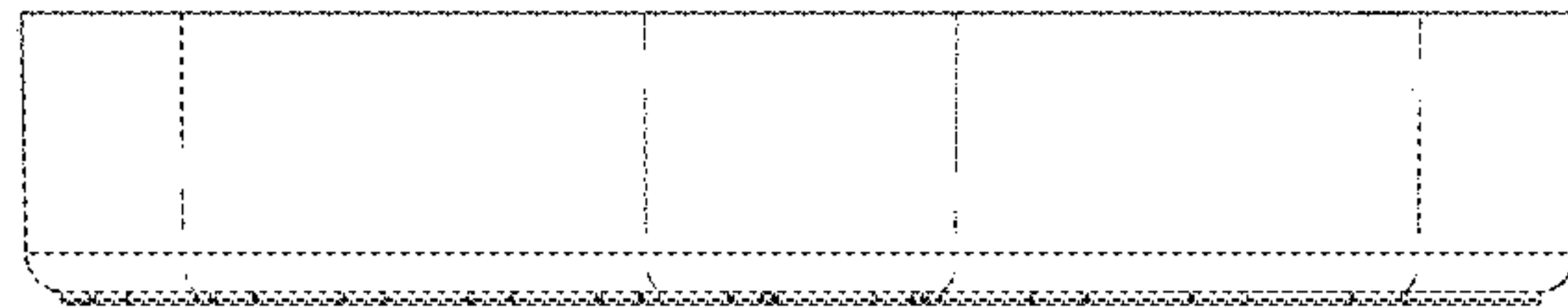

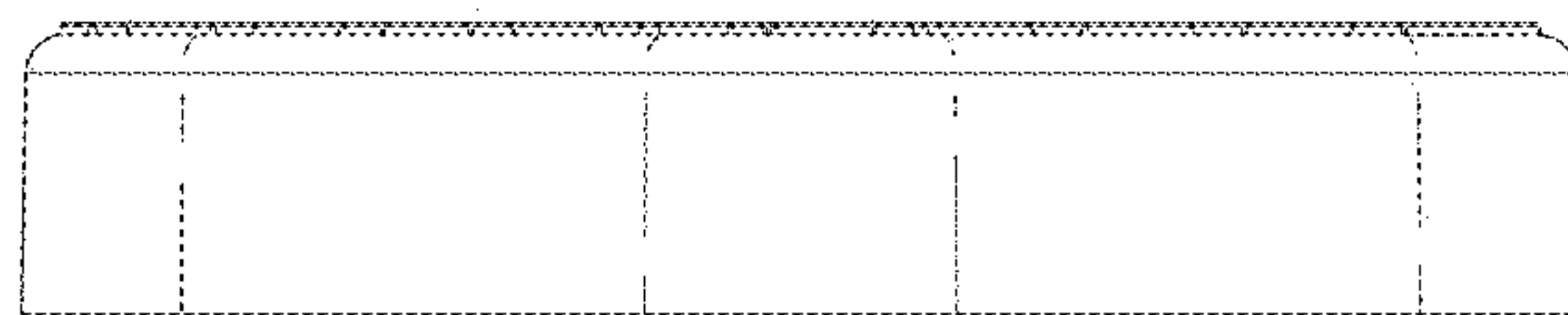
