FIG. 4 is a Right-side view thereof;

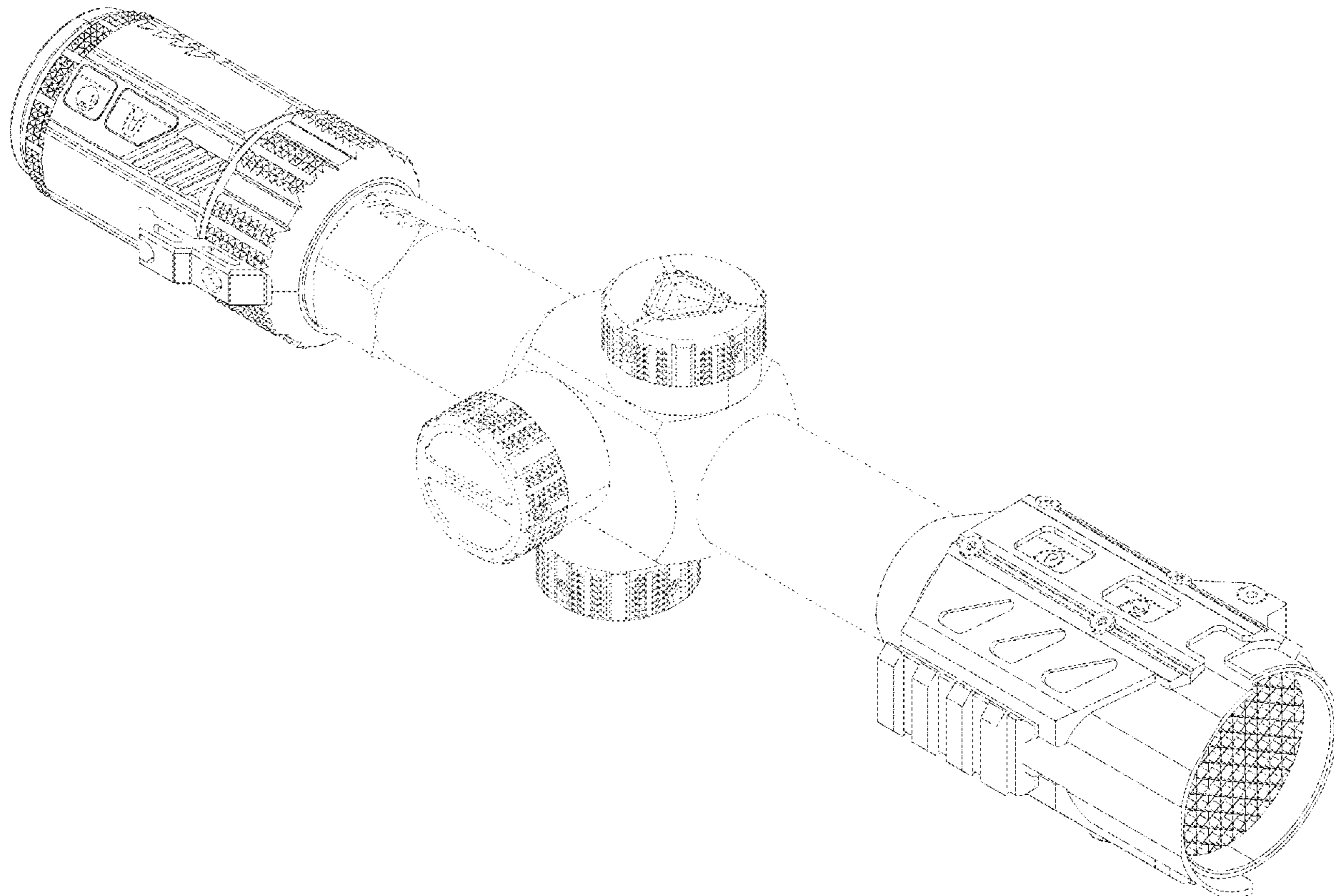
FIG. 5 is a Left-side view thereof;

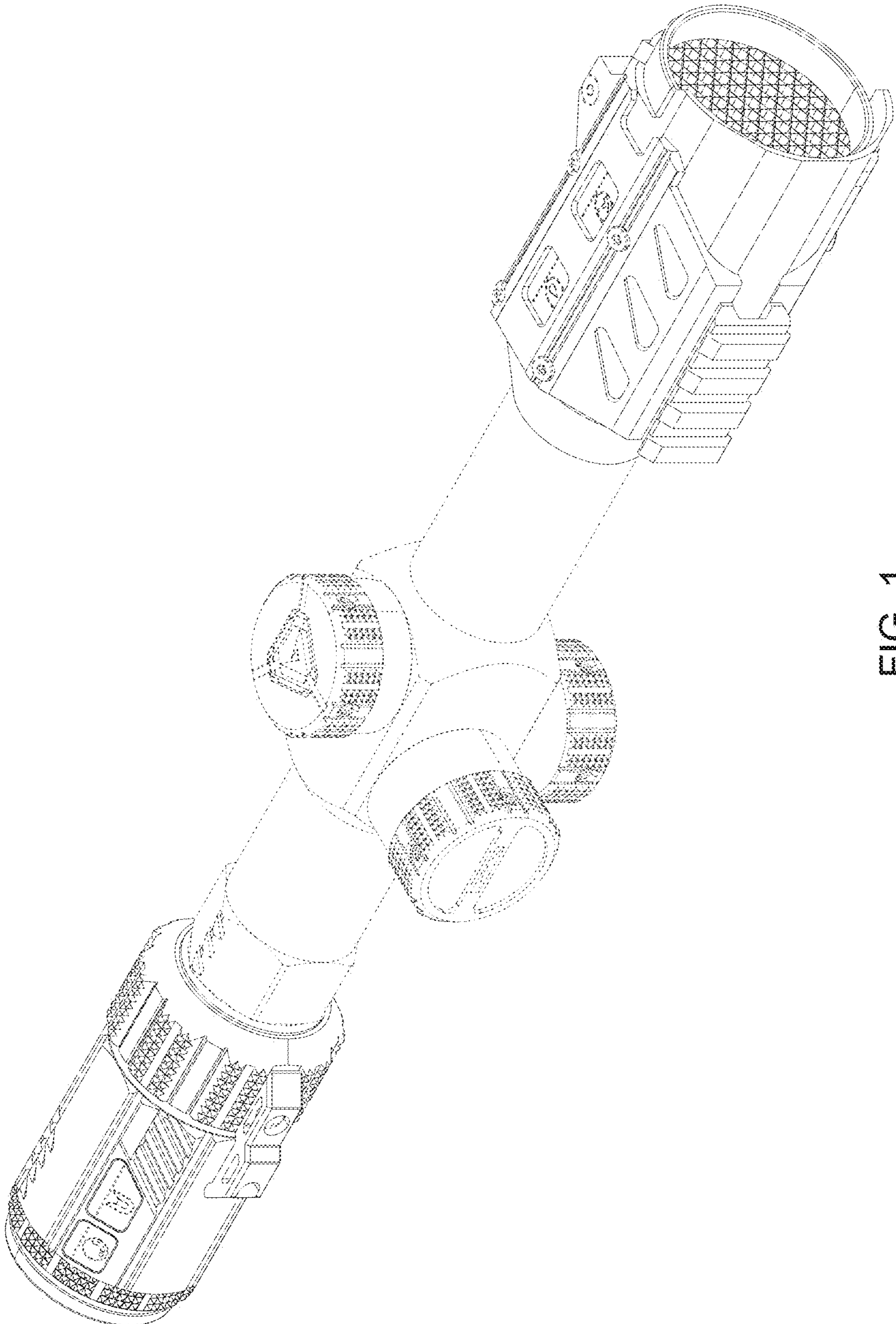

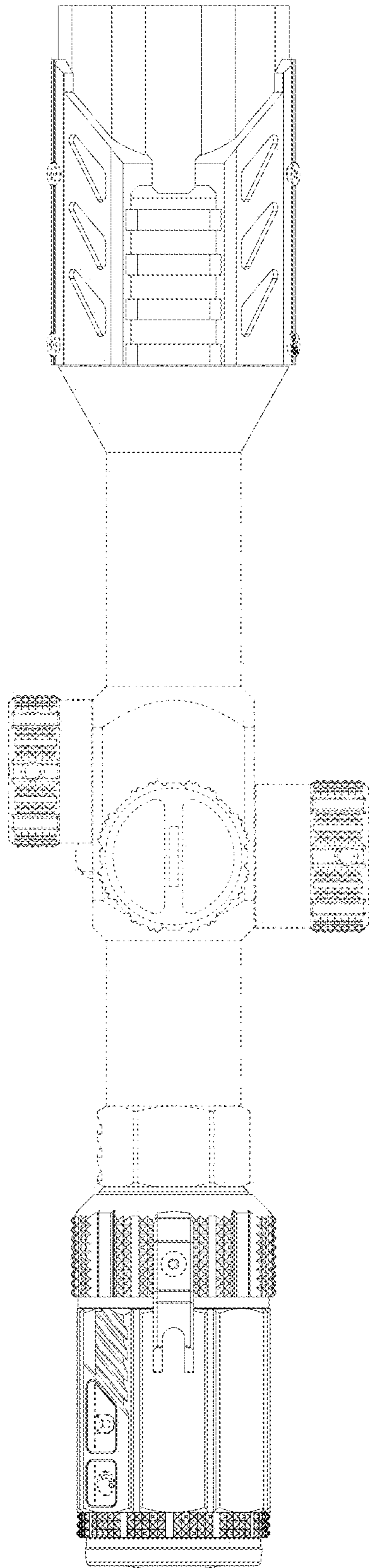

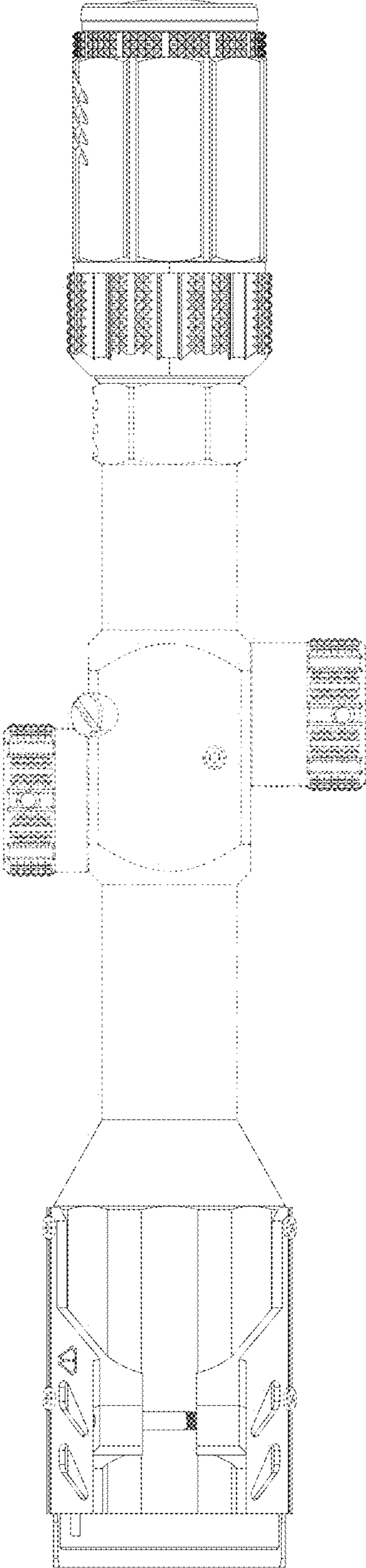

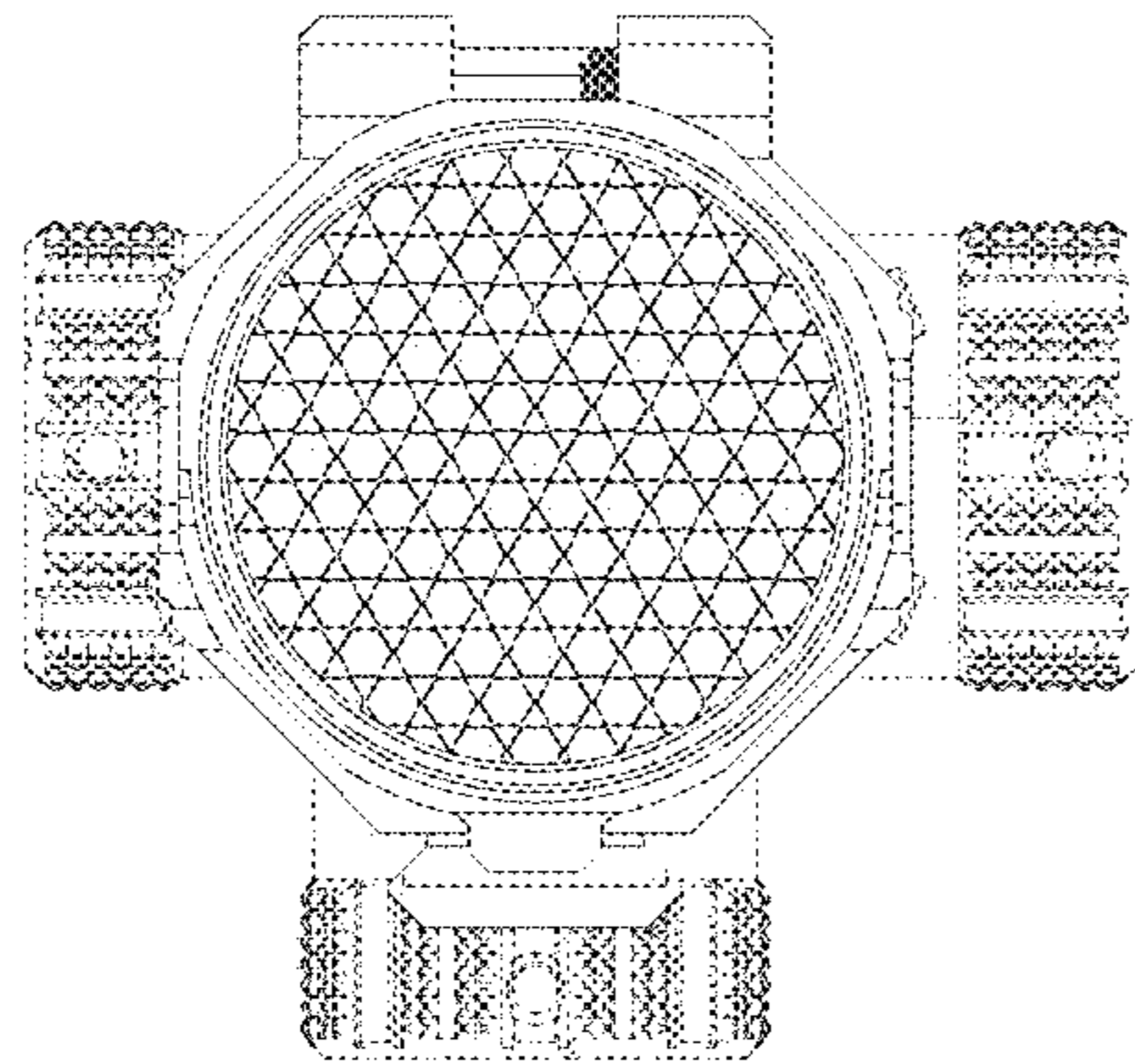

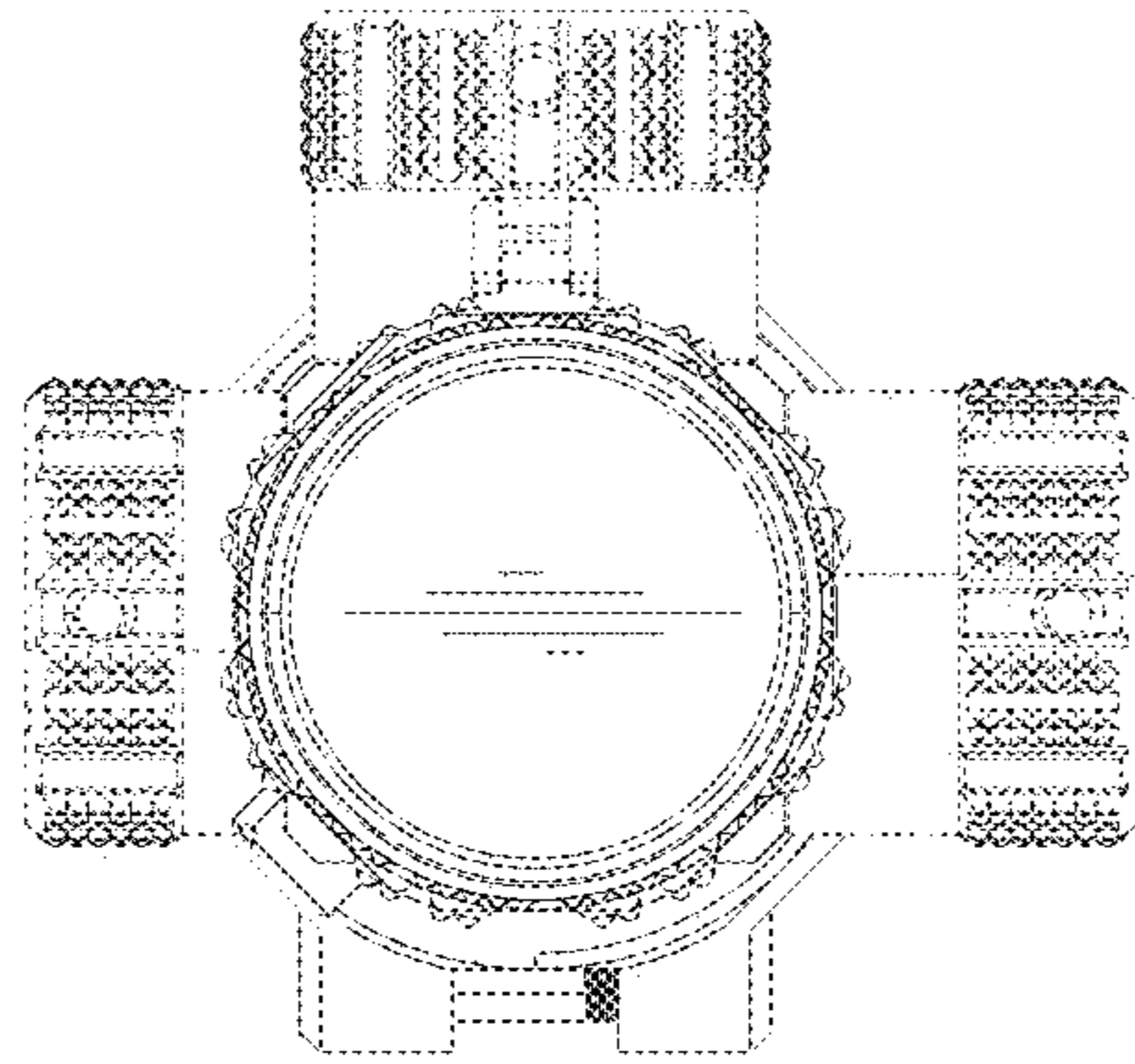

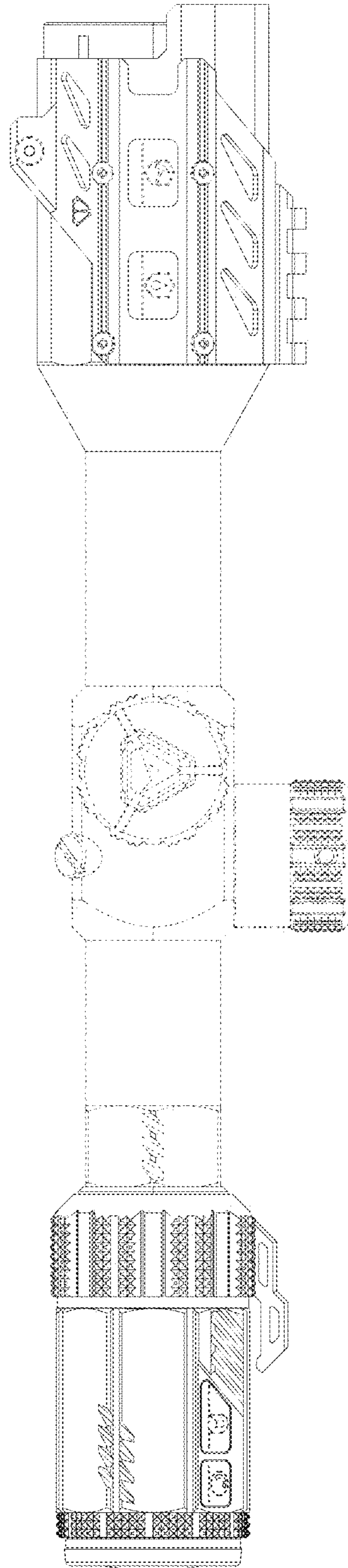

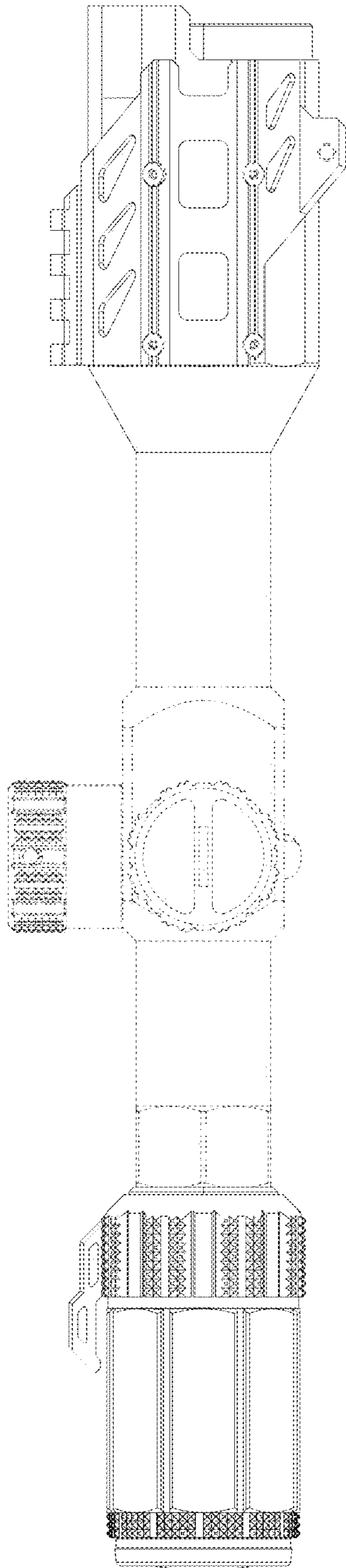
