(57) **CLAIM**

The ornamental design for a rail mounted slat, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a rail mounted slat; FIG. 2 is a left side view of the rail mounted slat; FIG. 3 is a right side view of the rail mounted slat; FIG. 4 is a front view of the rail mounted slat; FIG. 5 is a rear view of the rail mounted slat; FIG. 6 is a top view of the rail mounted slat; FIG. 7 is a bottom view of the rail mounted slat; FIG. 8 is a rear perspective view of the rail mounted slat; FIG. 9 is a detailed view of the rail mounted slat, as shown in FIG. 1; FIG. 10 is a detailed view of the rail mounted slat, as shown in FIG. 2; and, FIG. 11 is a detailed view of the rail mounted slat, as shown in FIG. 8.

The broken lines in FIGS. 1 through 11 form no part of the claimed design.

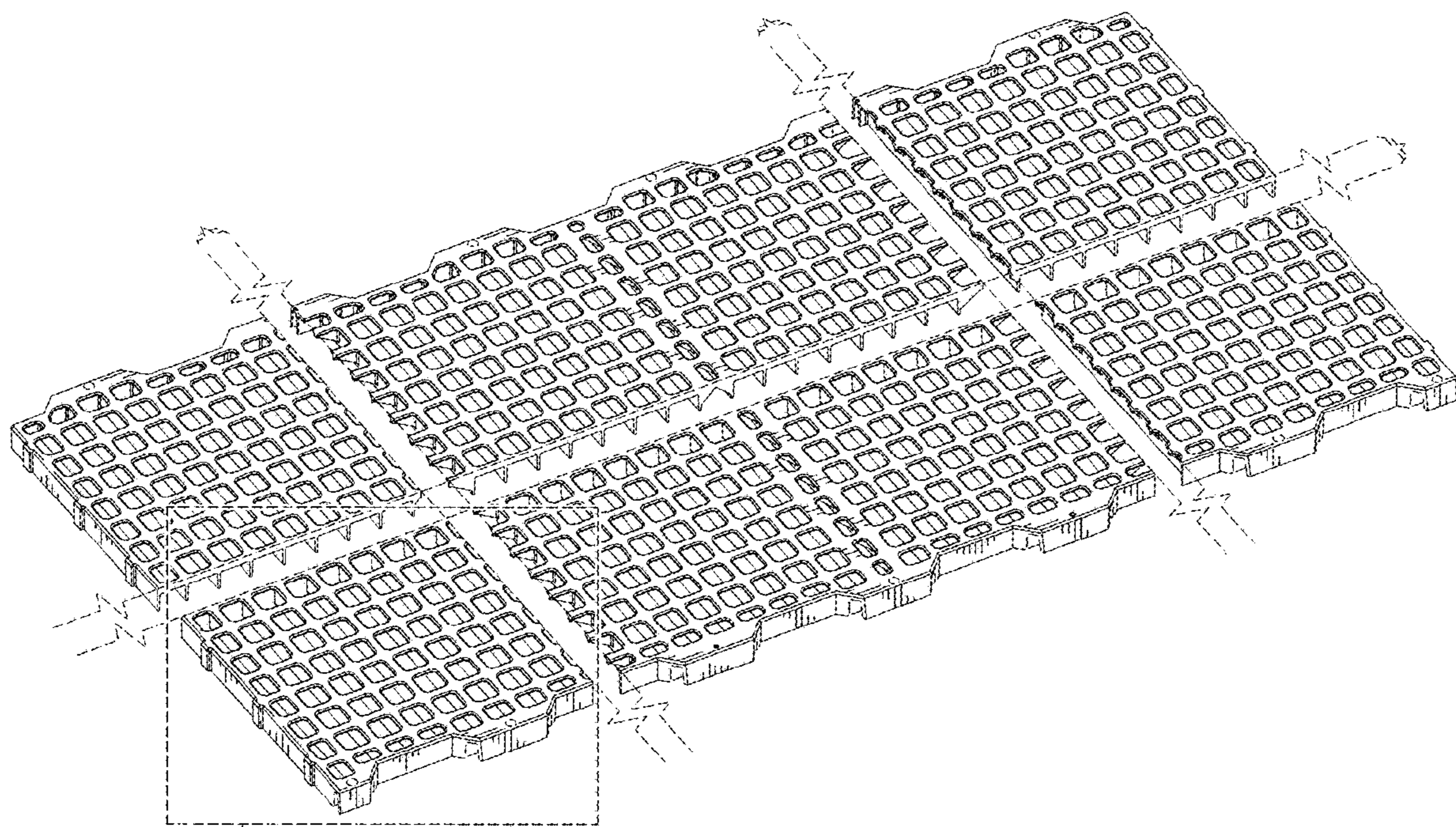

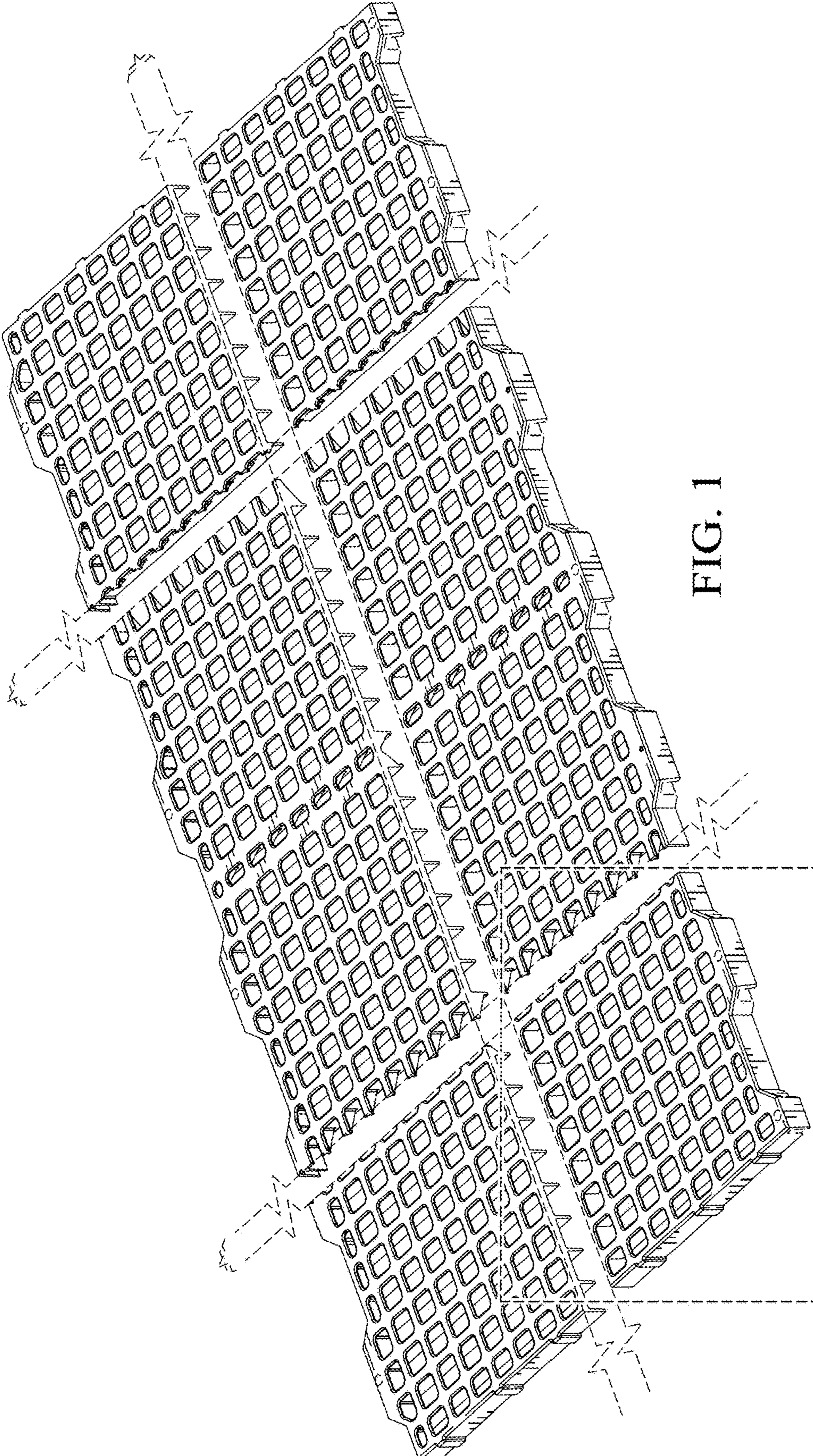

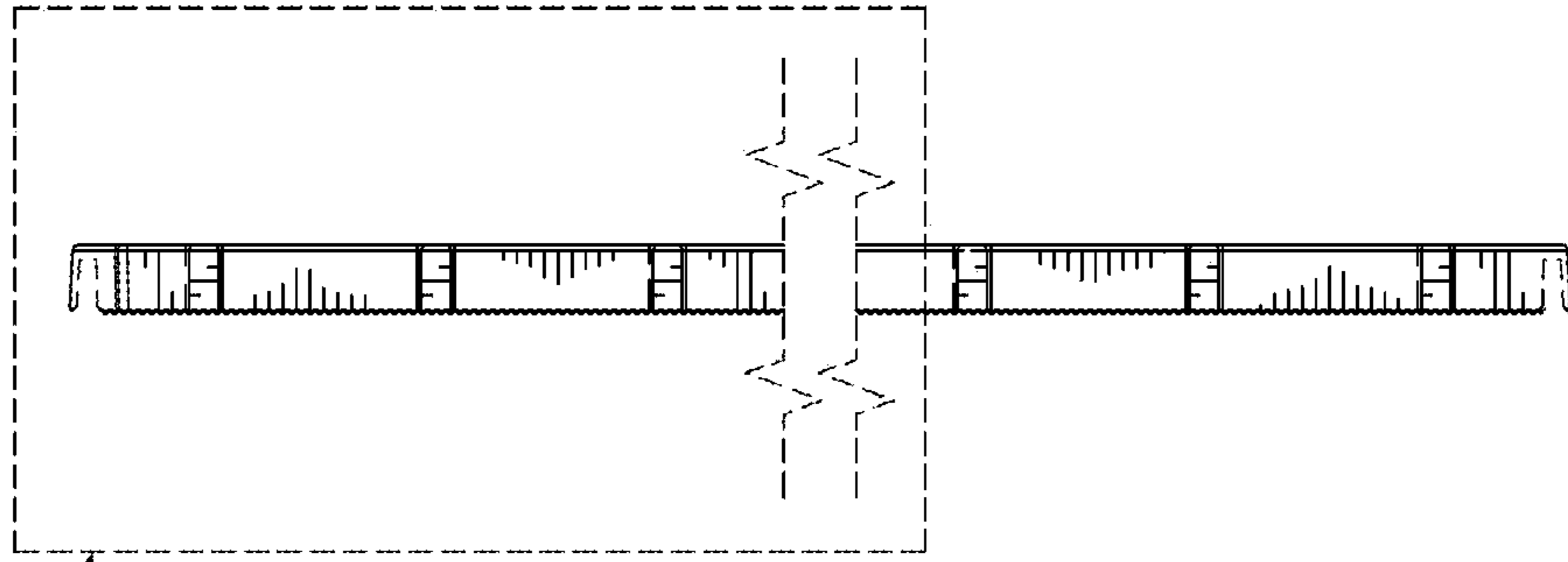

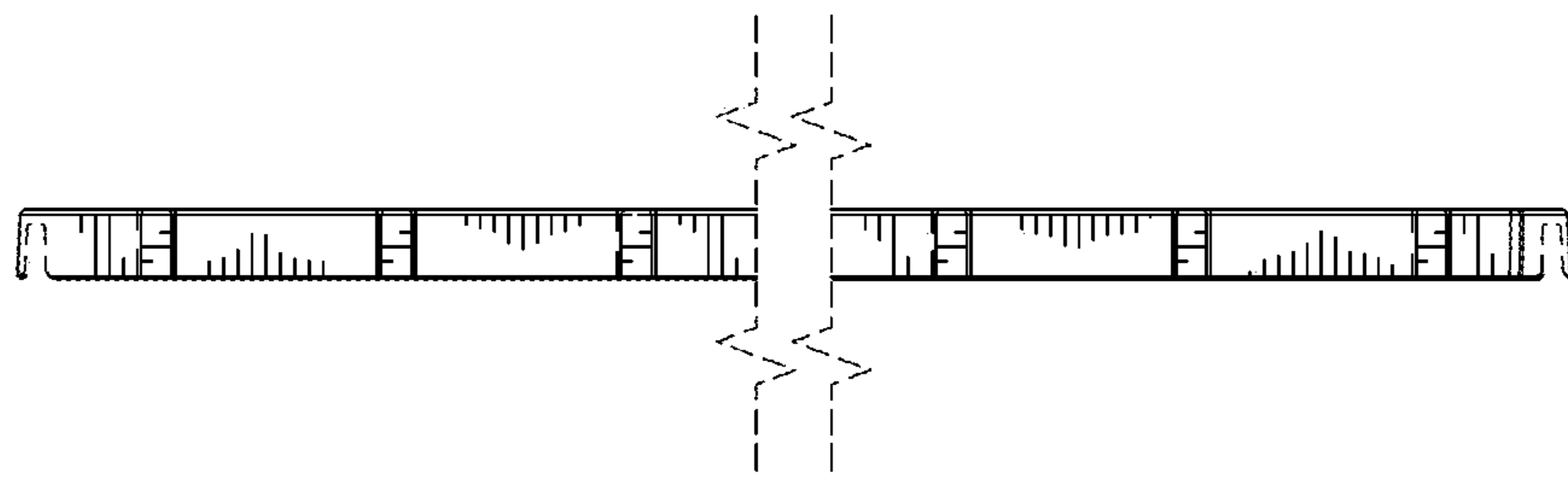

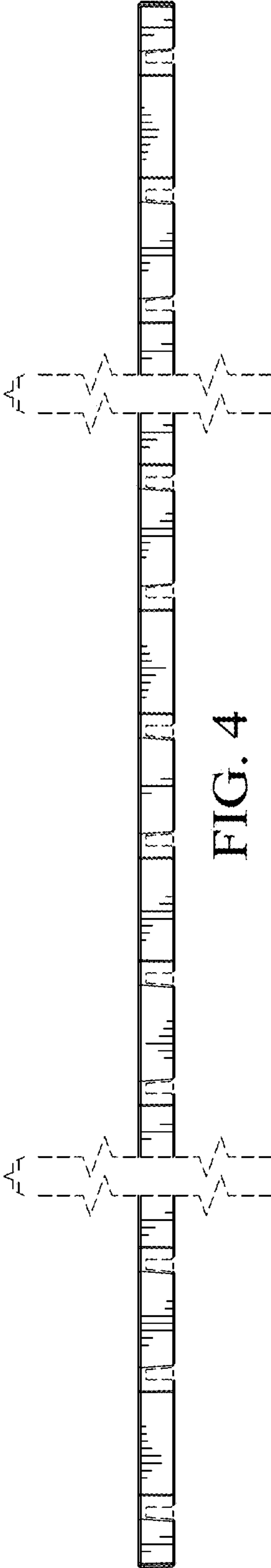

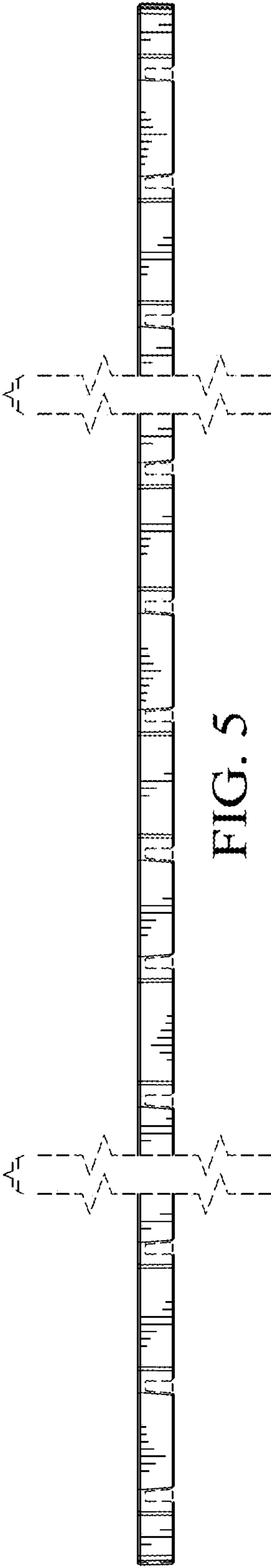

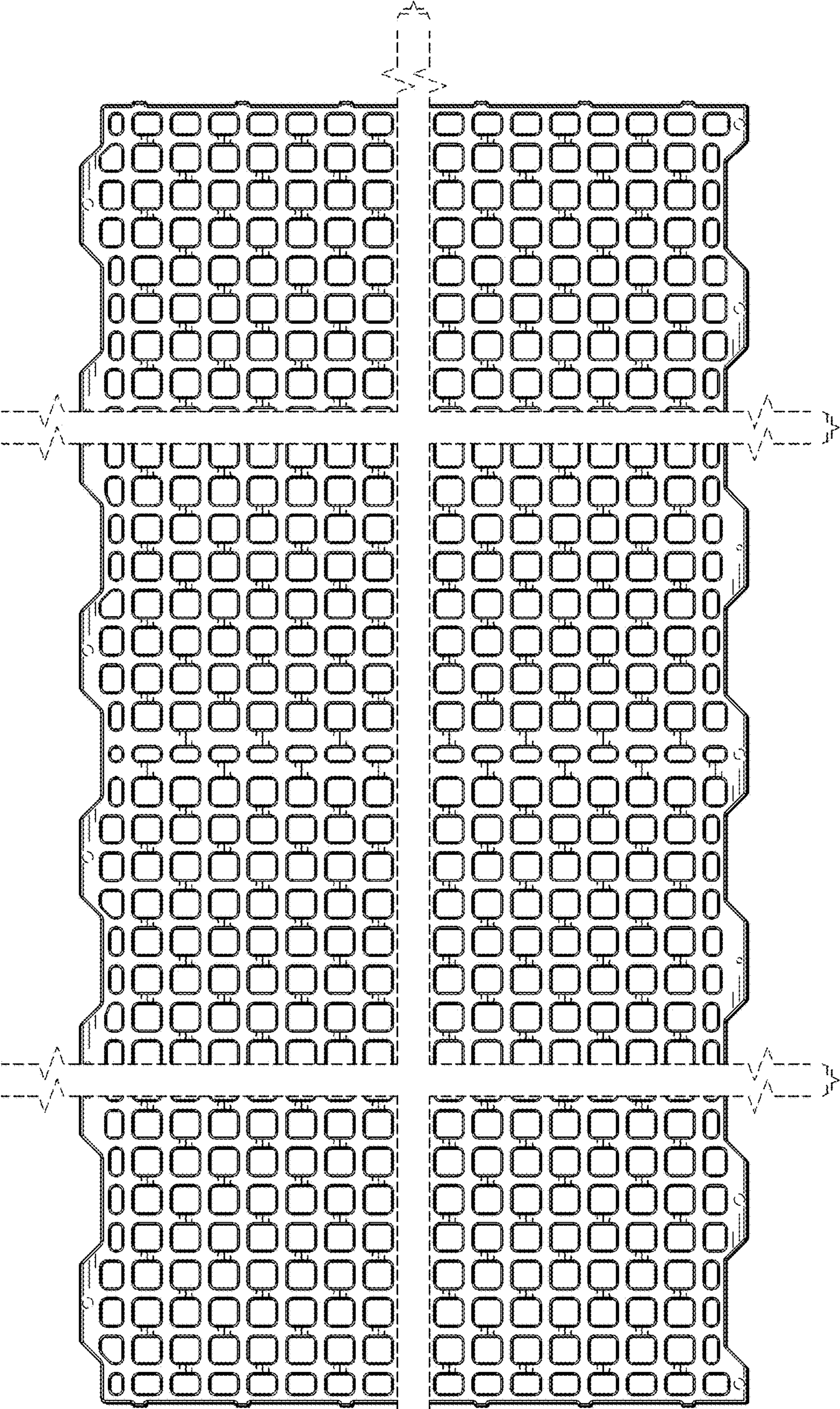

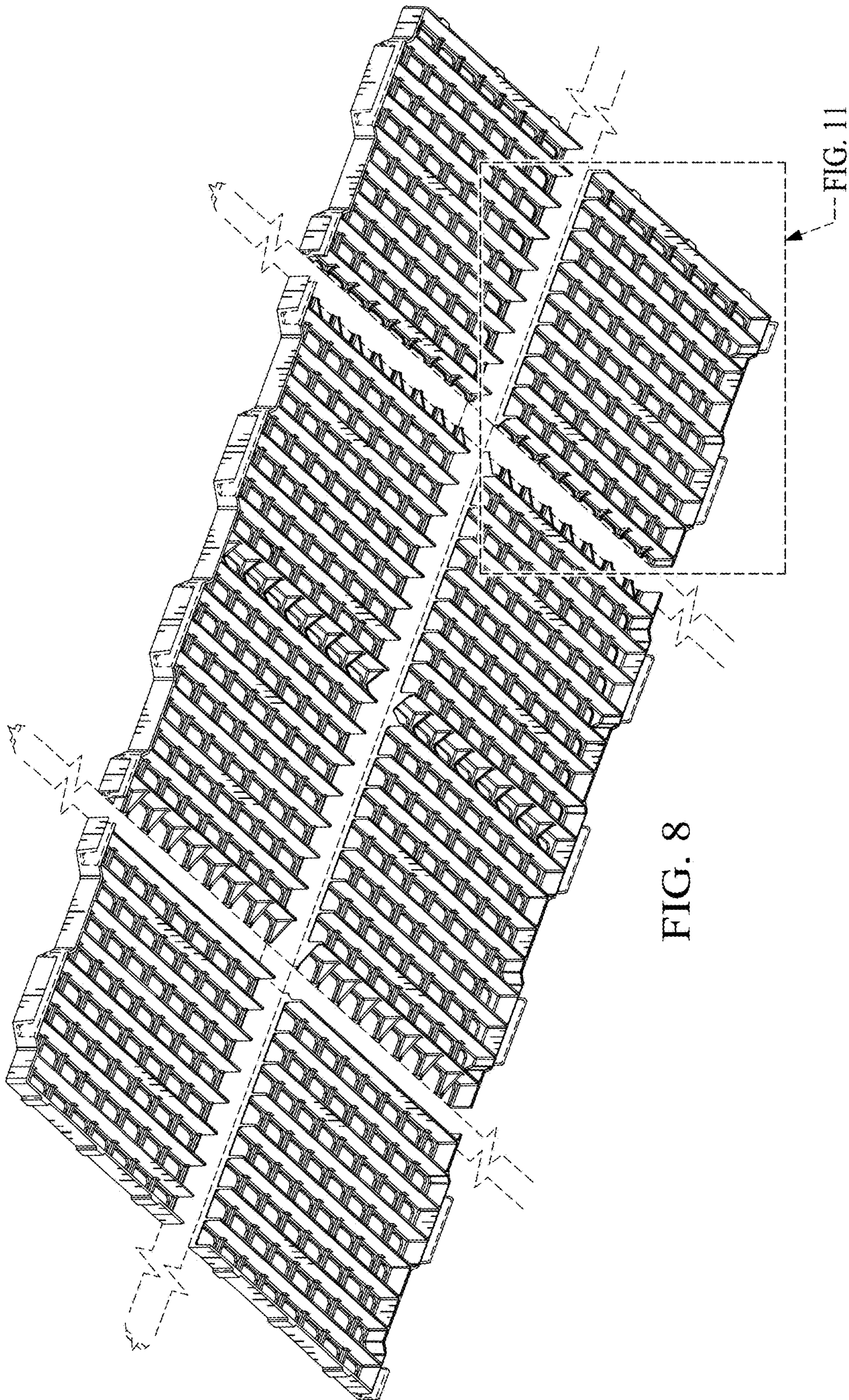

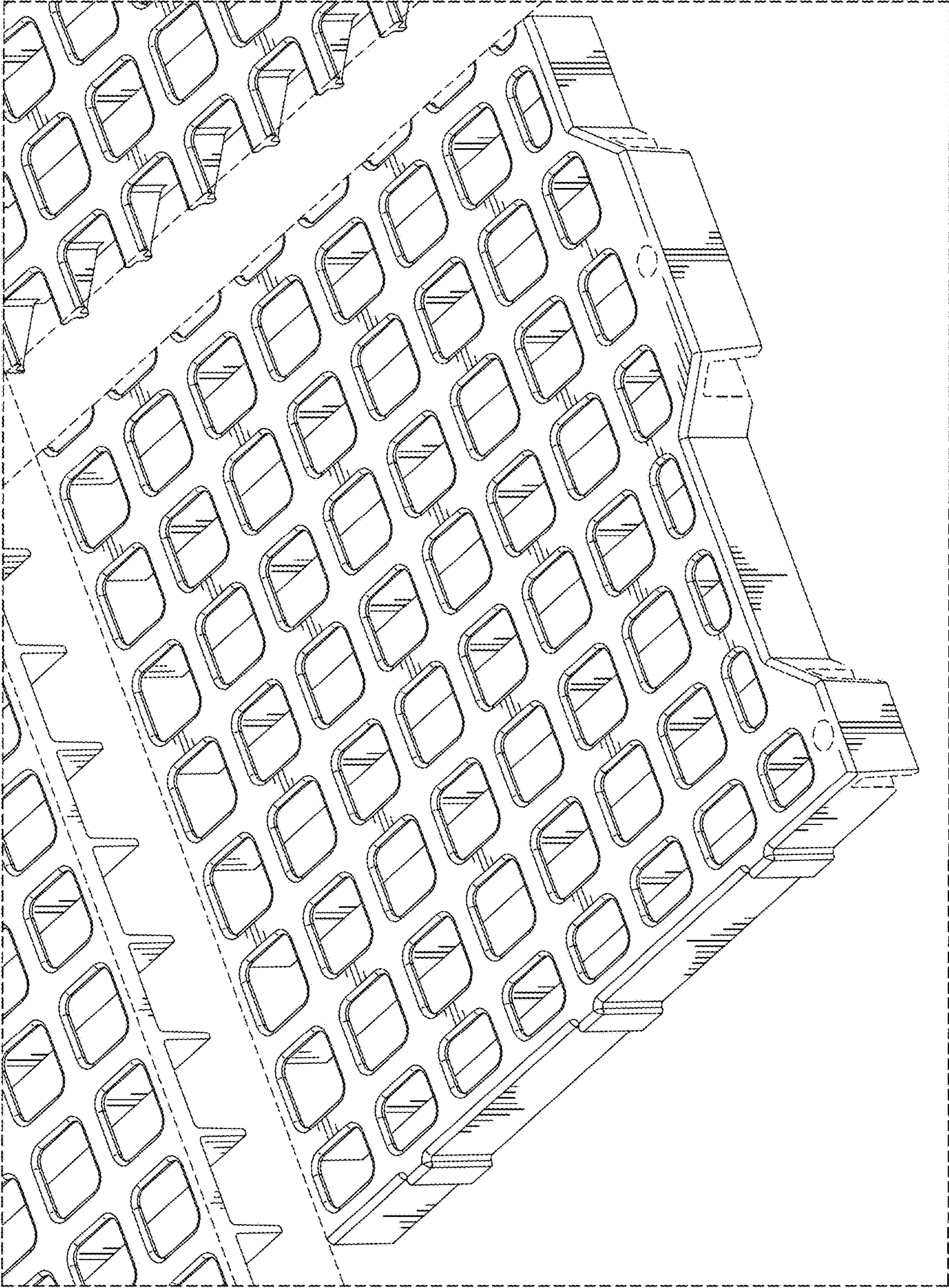

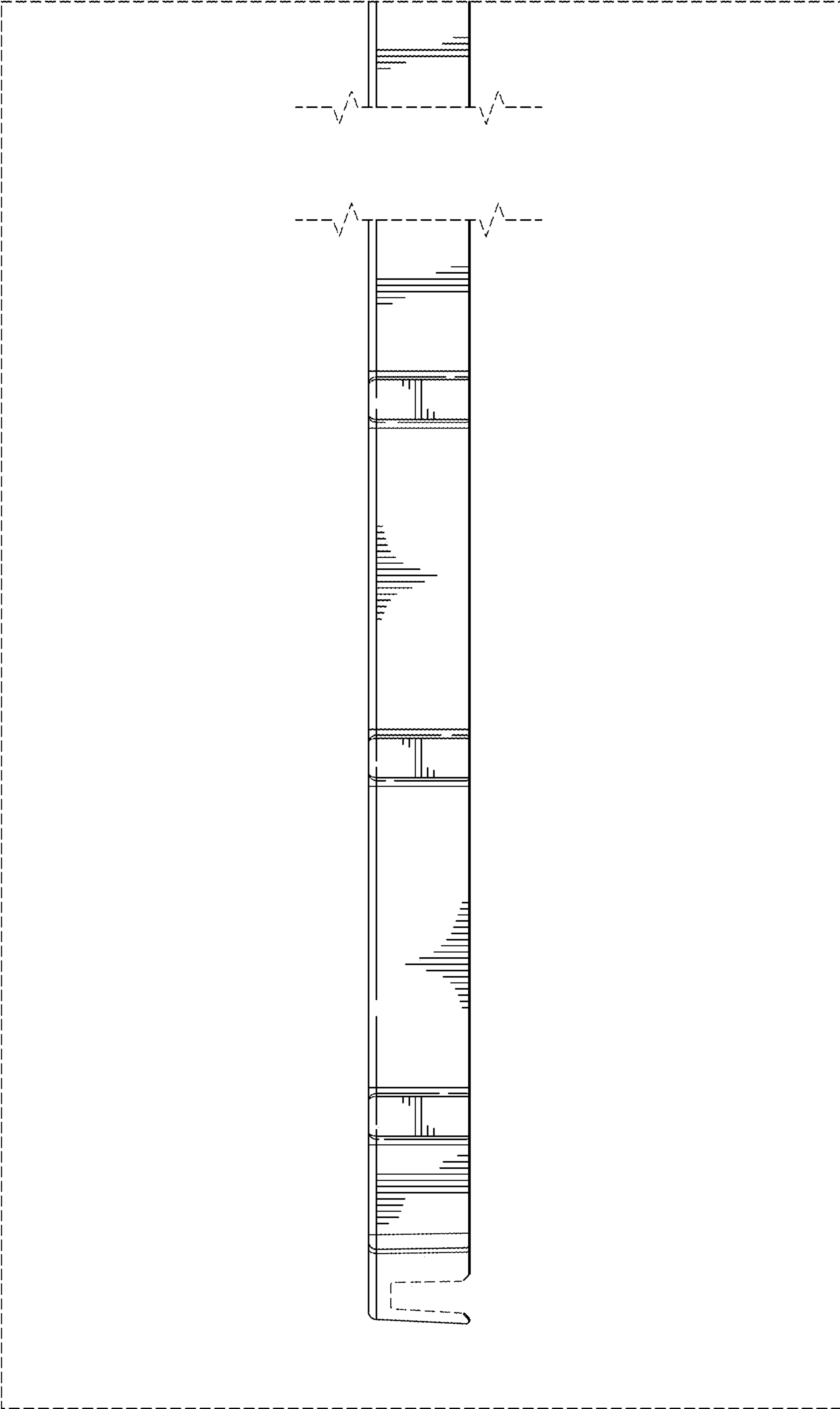

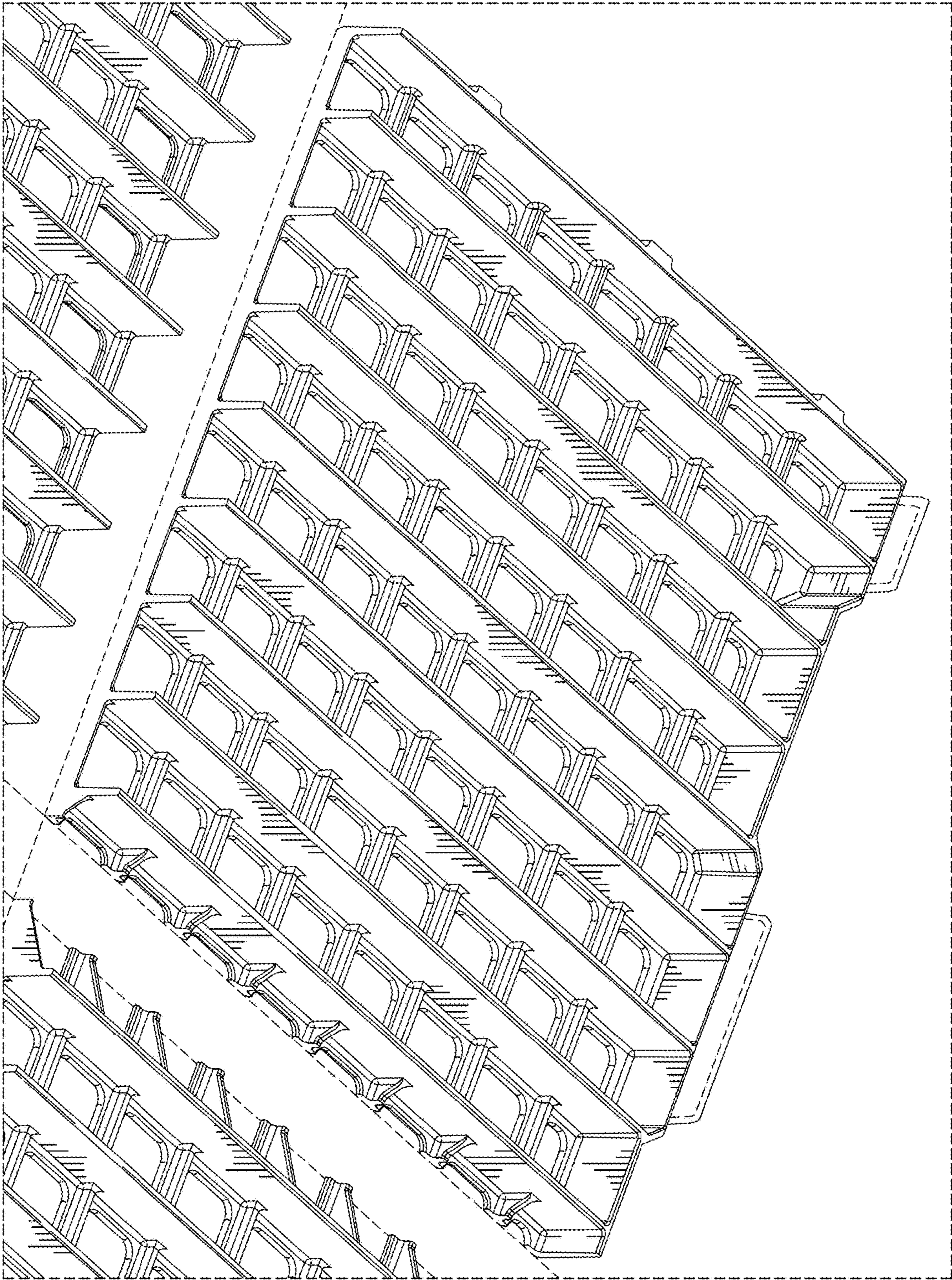
