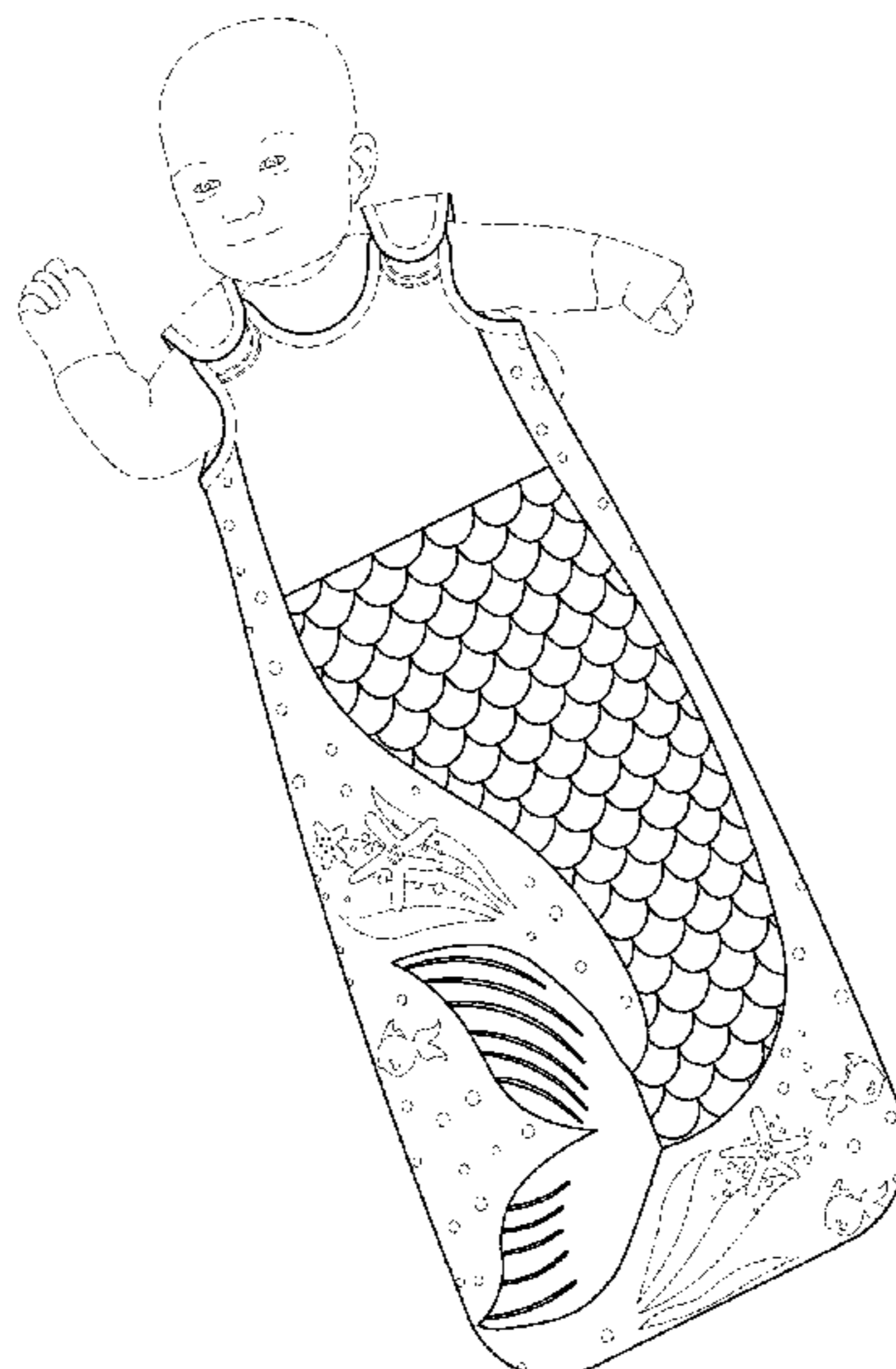
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an exemplary perspective view illustrating a baby within a sleep bag as illustrated herein;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a bottom plan view thereof; and,

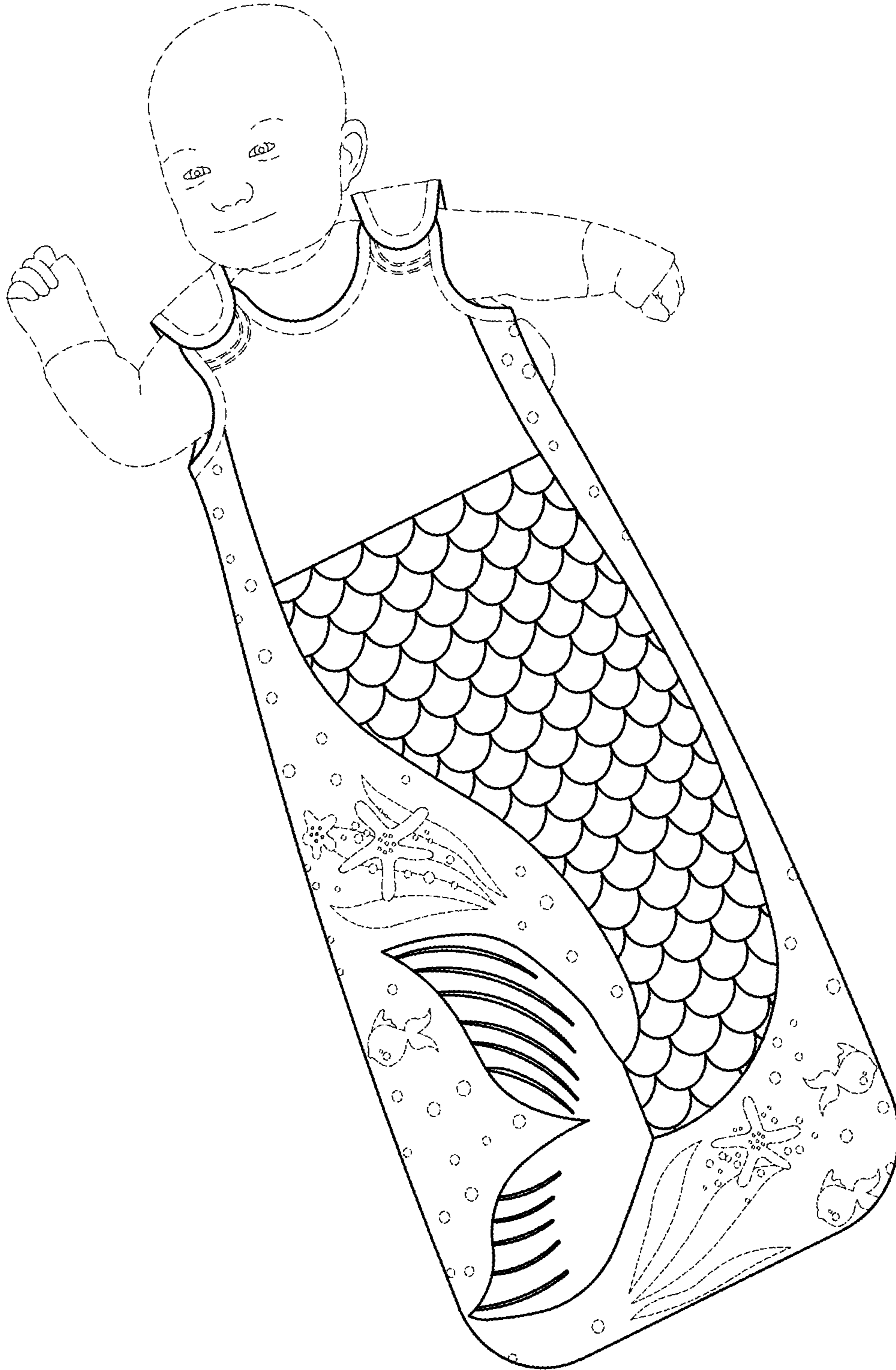

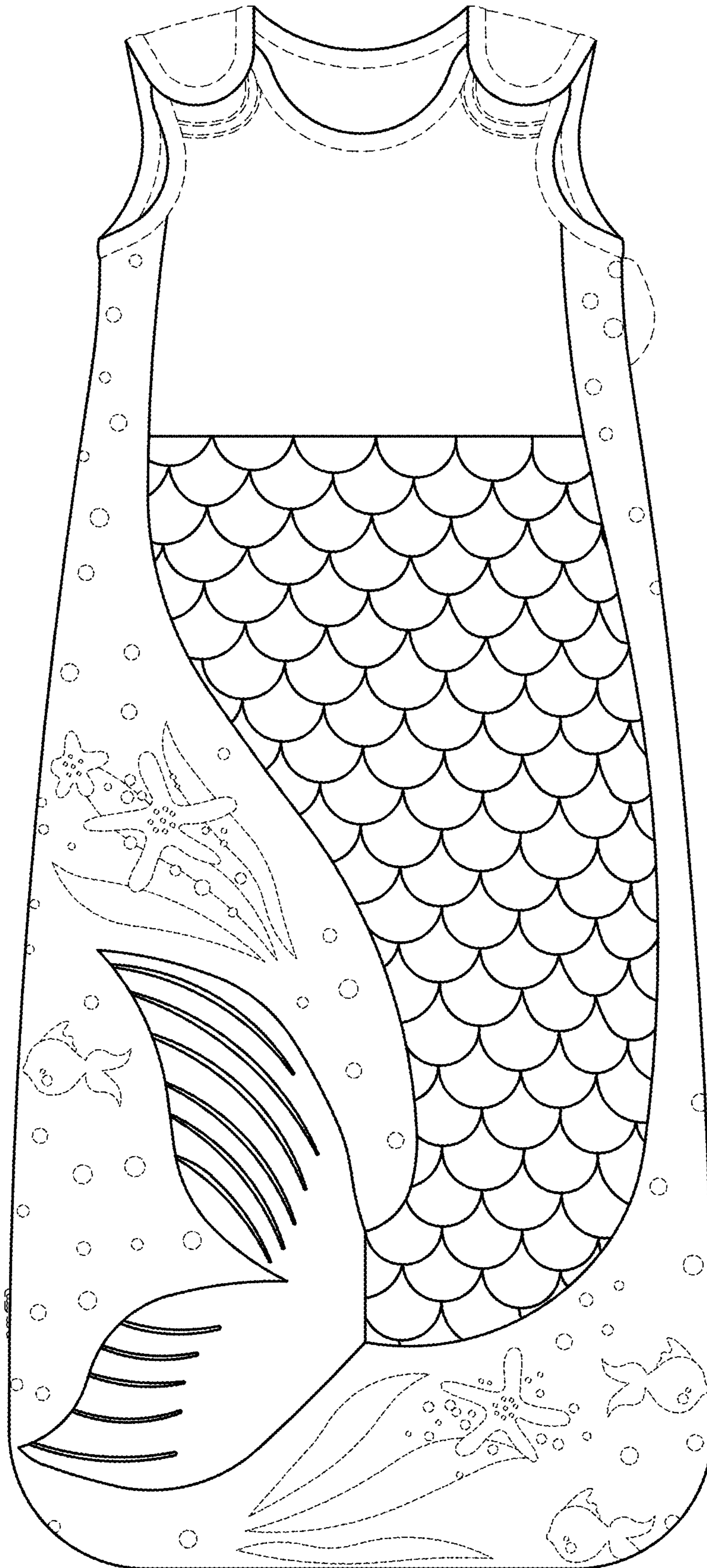

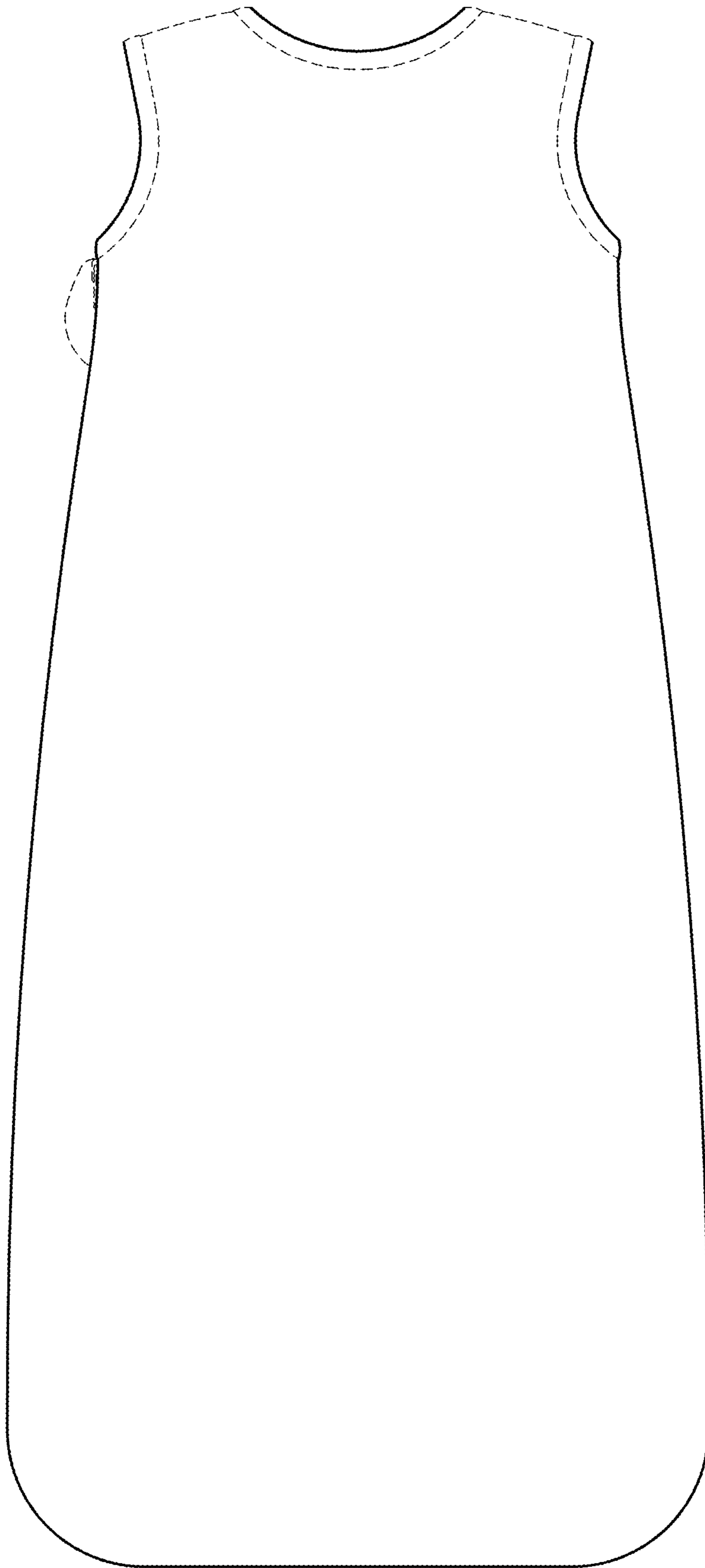
