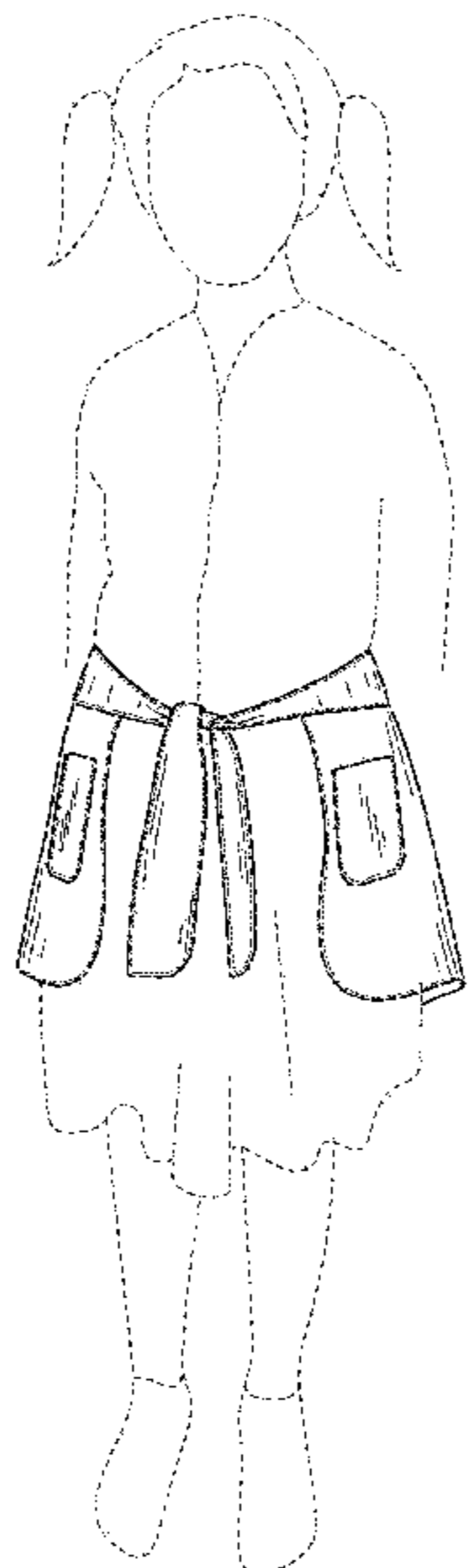
(57) **CLAIM**

The ornamental design for youth body banner with integrated patch pockets, as shown.

**DESCRIPTION**

FIG. 1 is a front perspective view of the youth body banner with integrated patch pockets showing a unique design. FIG. 2 is an angled perspective rear view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof, FIG. 5 is a left-side elevational view thereof; and, FIG. 6 is a right-side perspective view thereof. The large dashed lines are used to illustrate the human wearing the article and do not form any part of the claimed design. The small dashed lines parallel to the edges of the article show a portion of the article, and do not form any part of the claimed design.

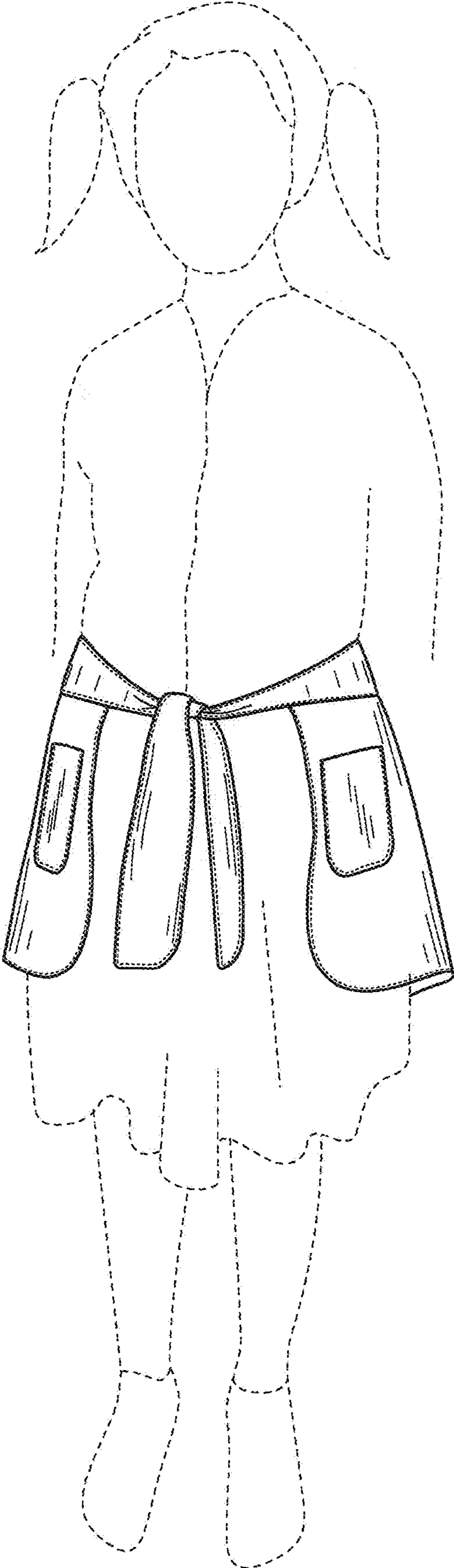

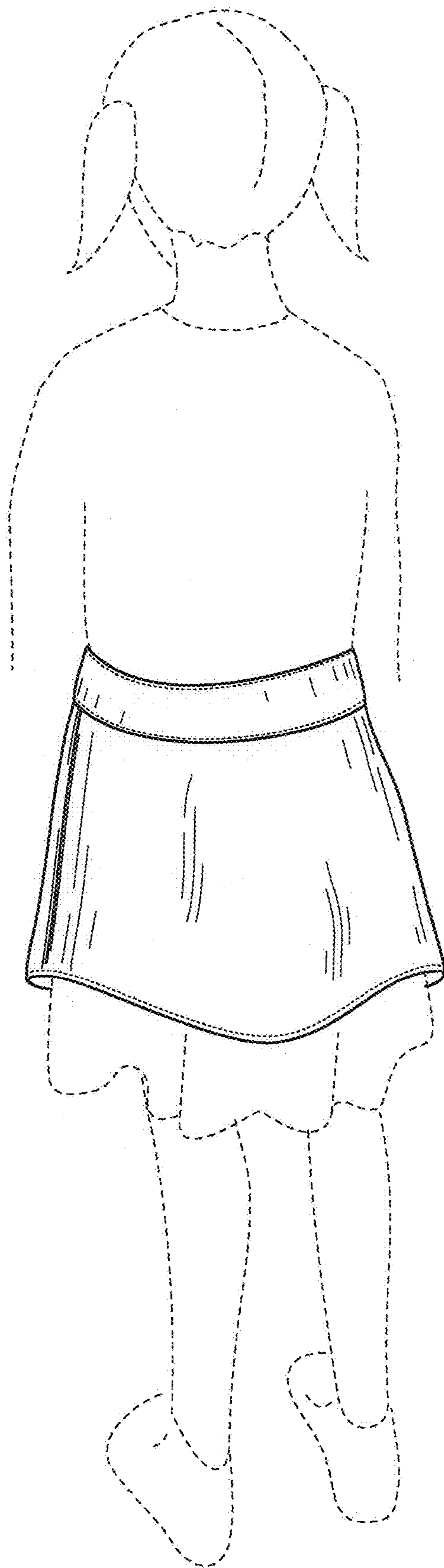

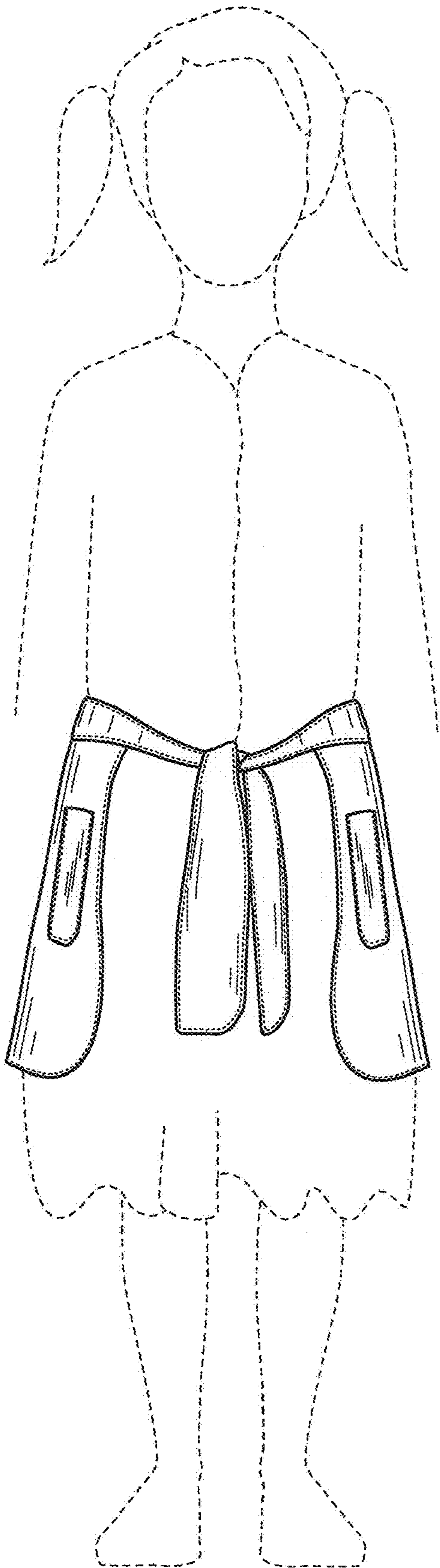

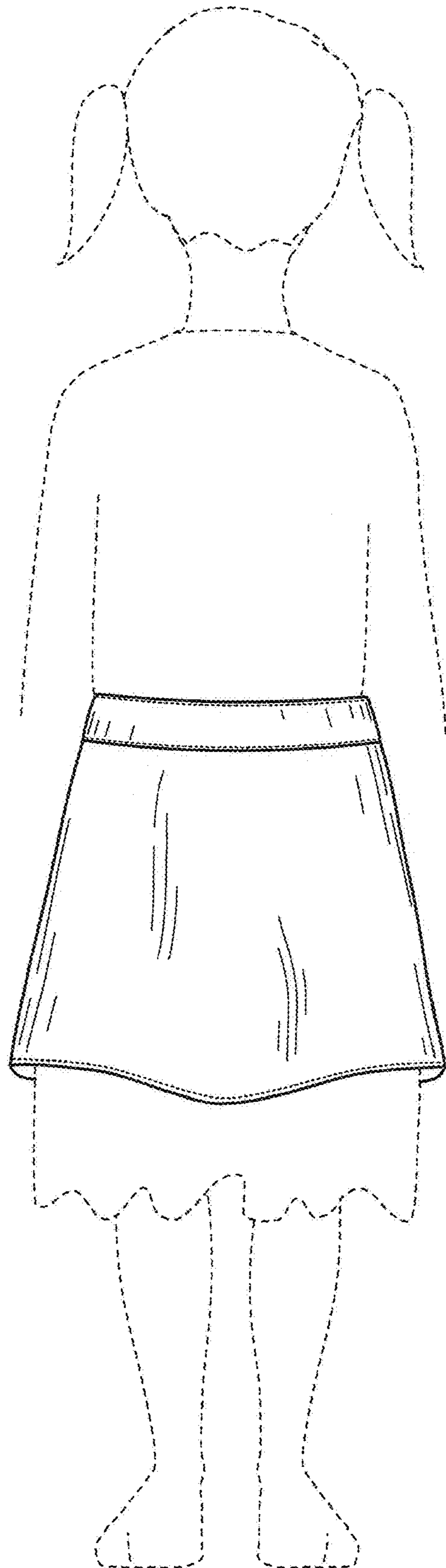

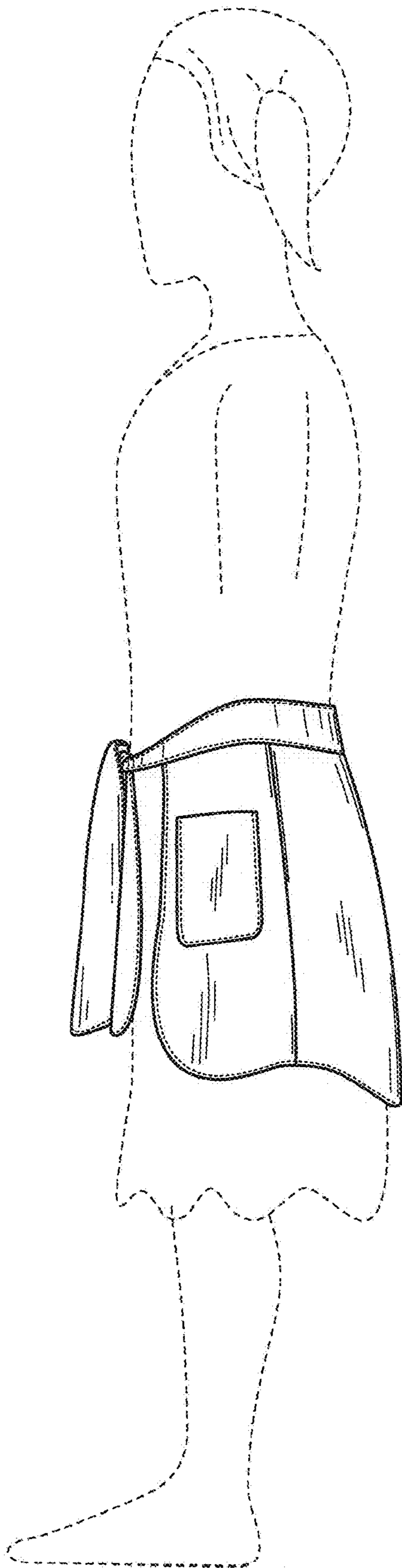

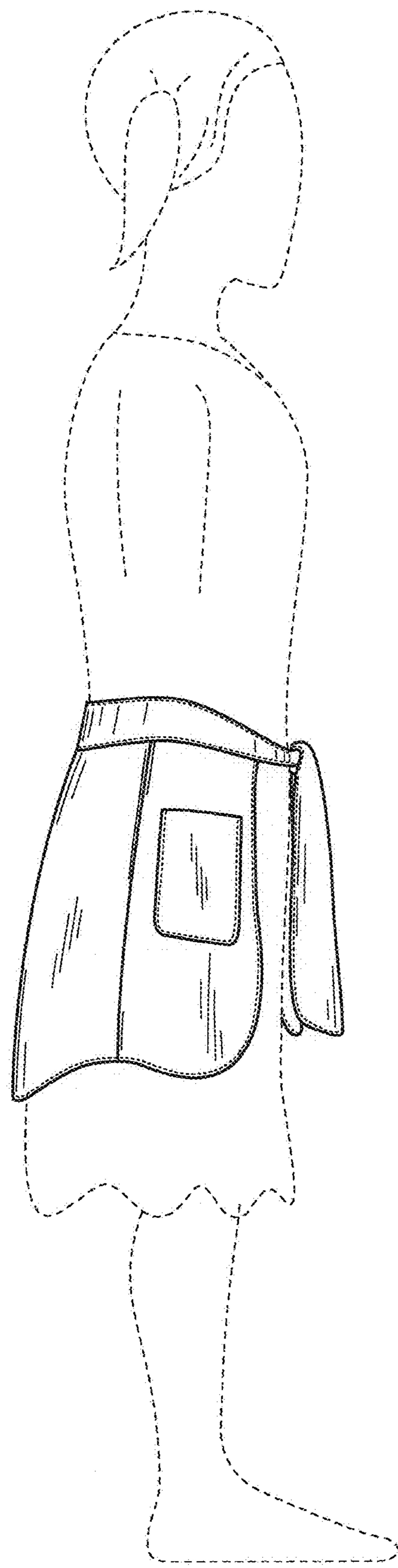
