The ornamental design for a bag, as shown and described.

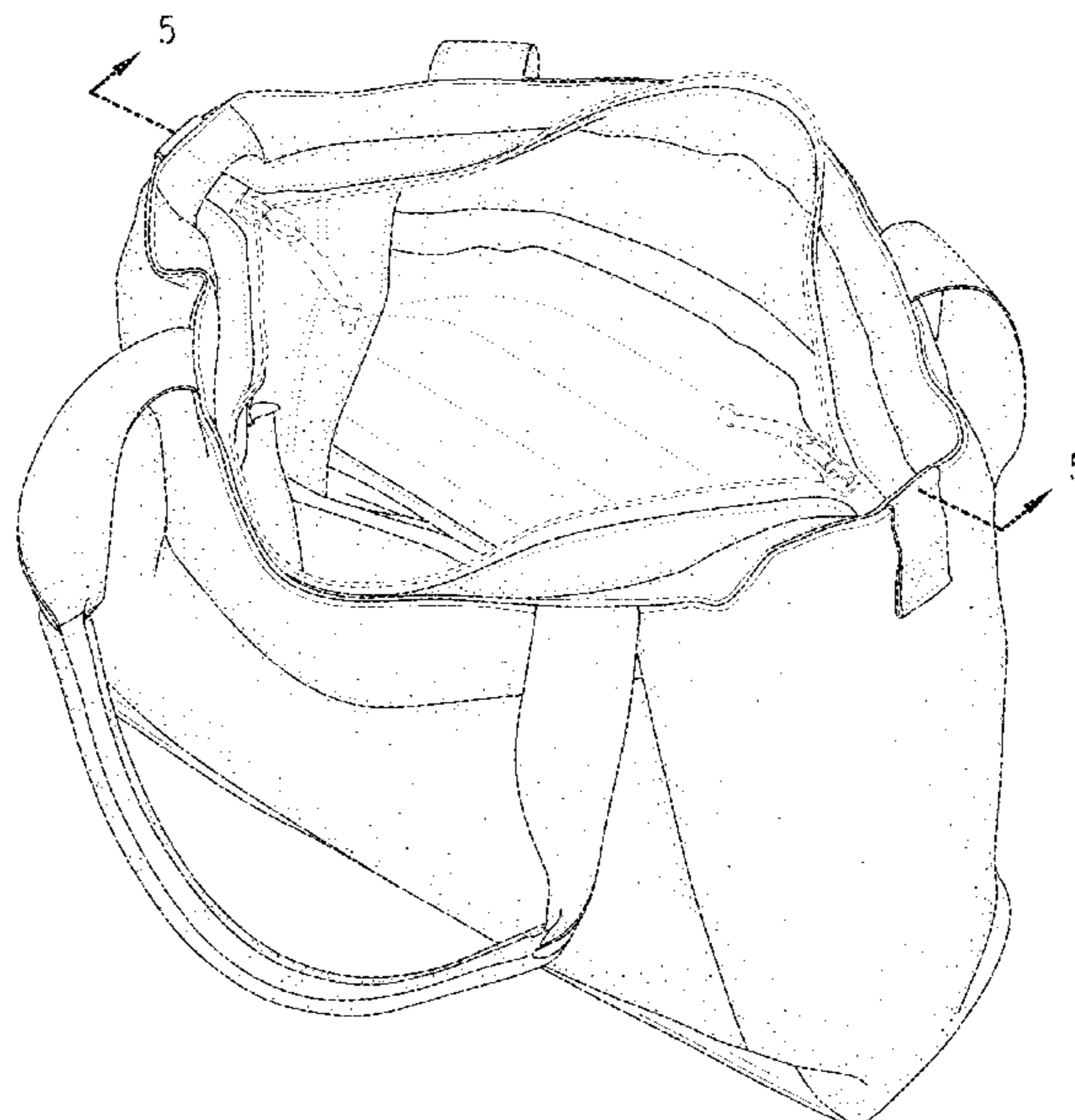
DESCRIPTION

FIG. 1 is a top, front, right perspective view of a bag showing our new design;
 FIG. 2 is a top, rear, left perspective view thereof;
 FIG. 3 is a top view thereof;
 FIG. 4 is a top view of the bag shown in FIG. 1-3 in a partially closed configuration;
 FIG. 5 is a front cross-sectional view thereof; and,
 FIG. 6 is a rear cross-sectional view thereof.
 The even-length broken lines and dotted lines represent stitching or other features and form no part of the claimed design. The uneven-length broken lines define the bounds of the claimed design and form no part thereof.

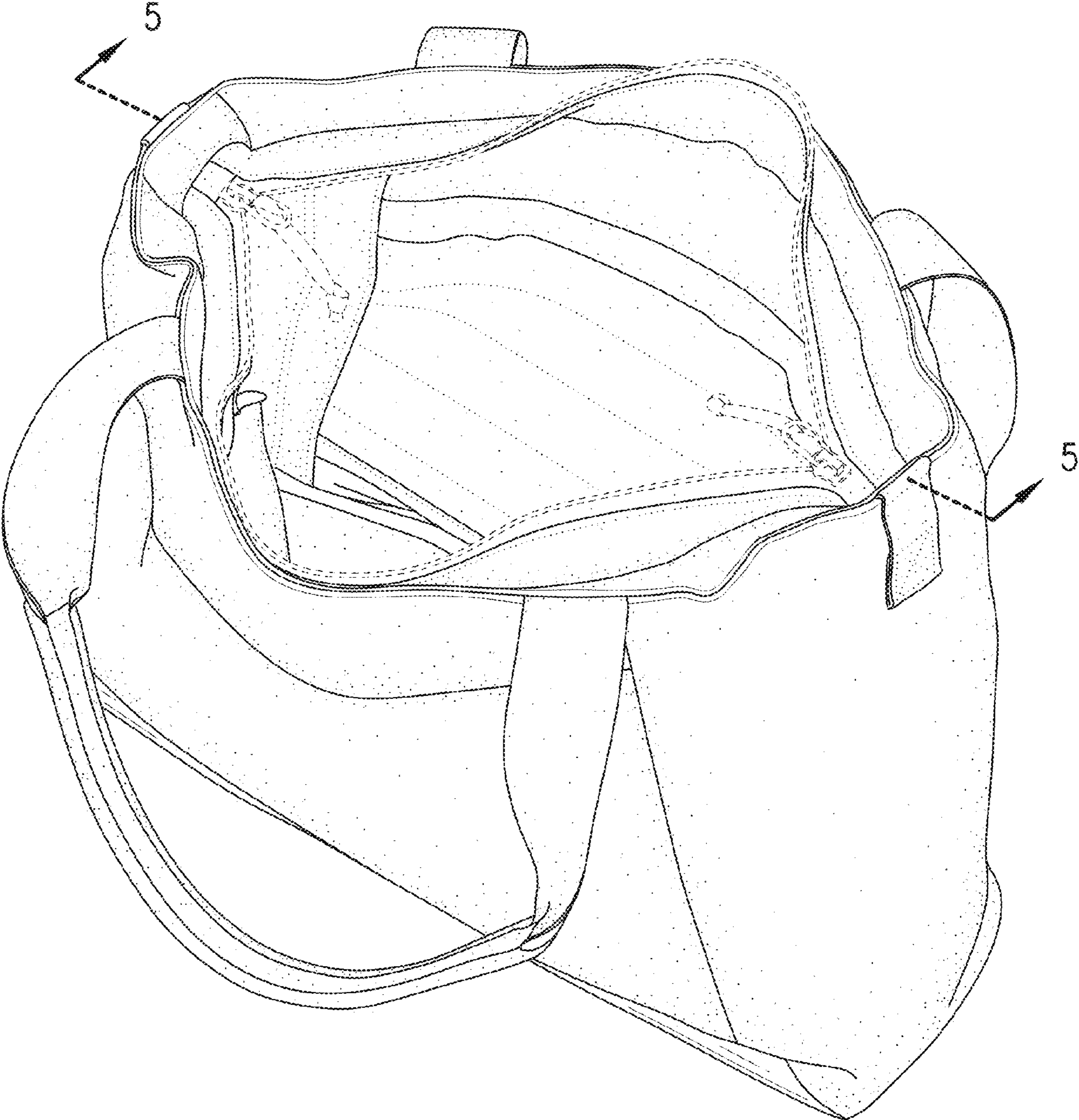

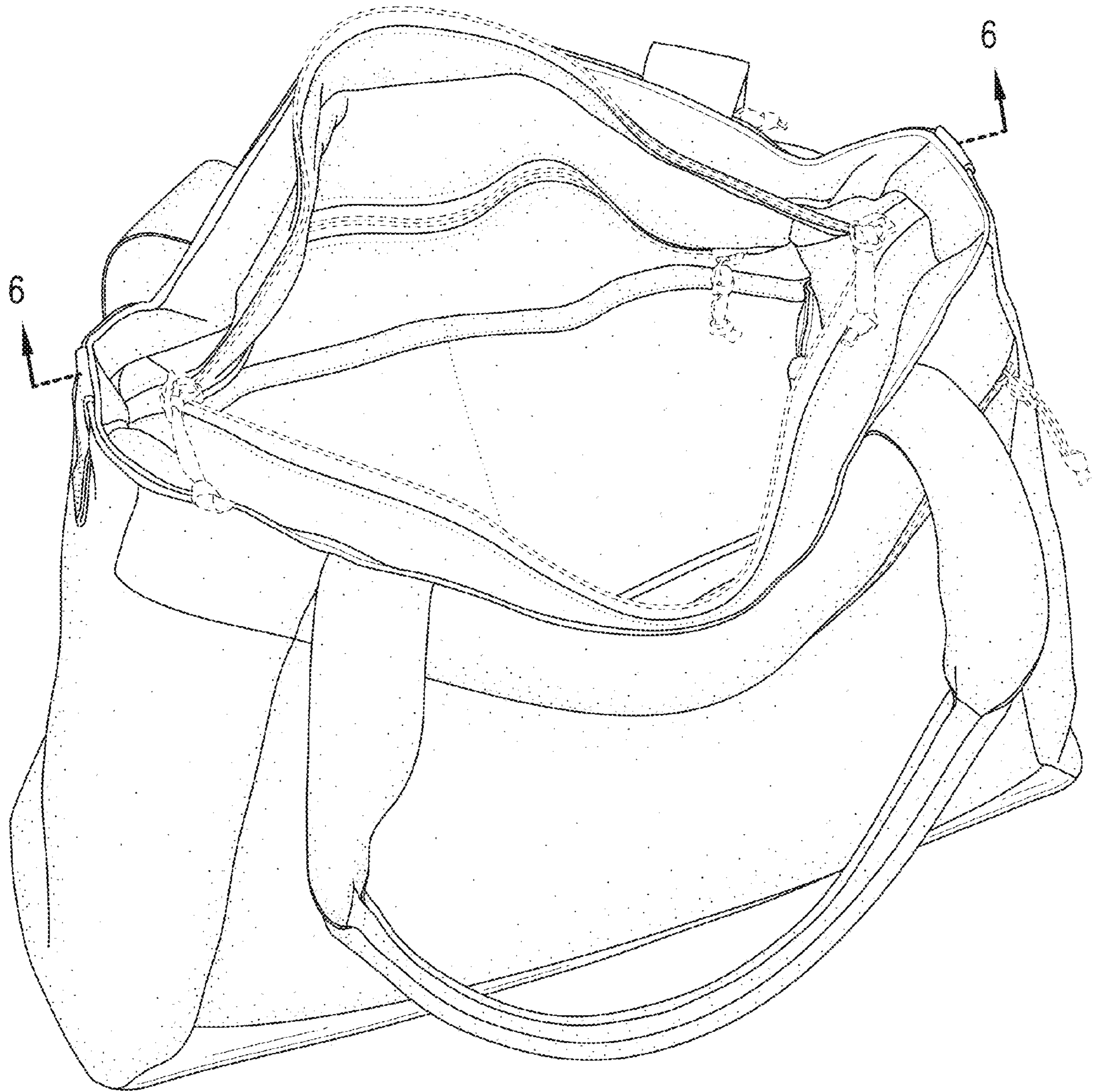

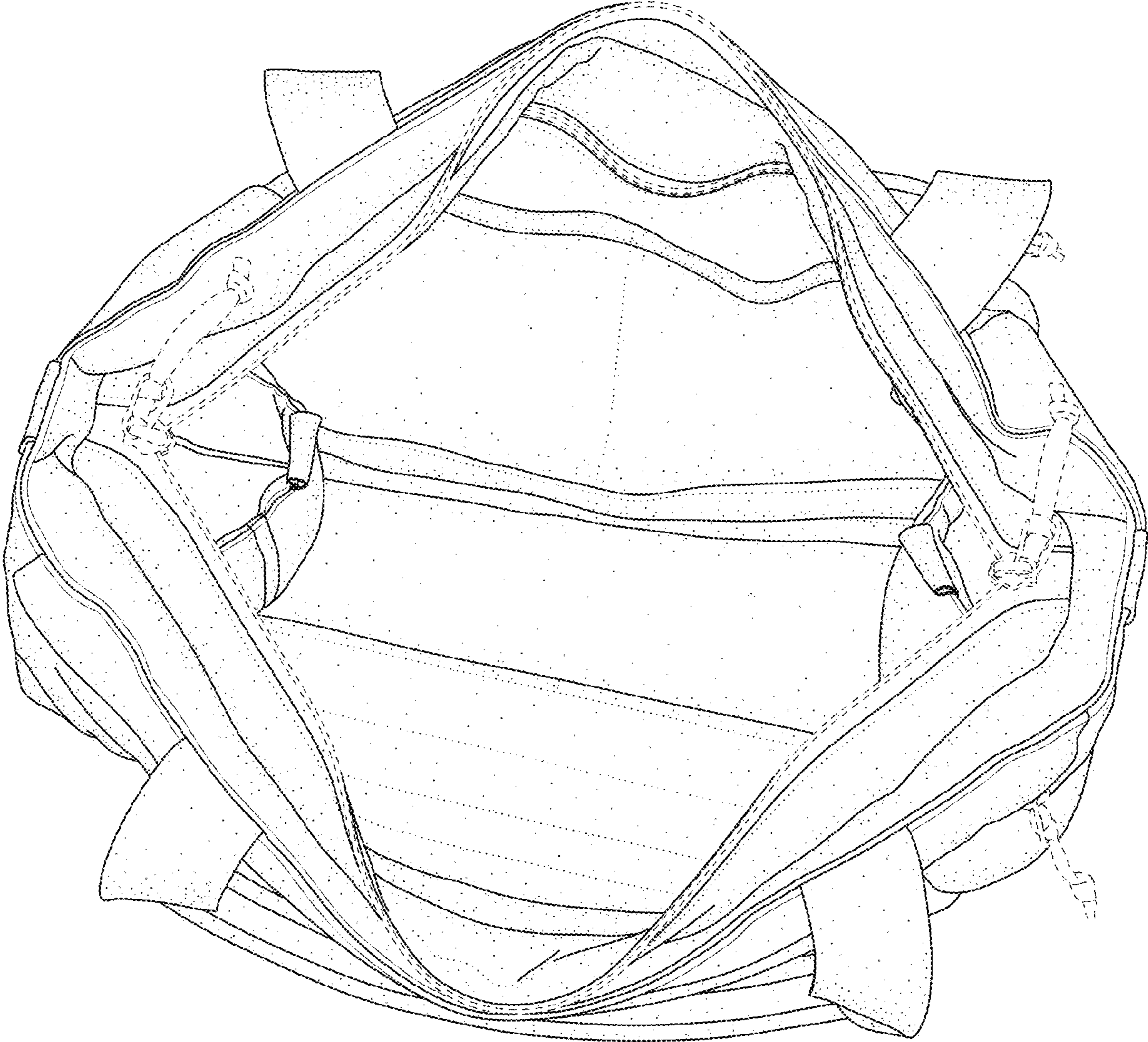

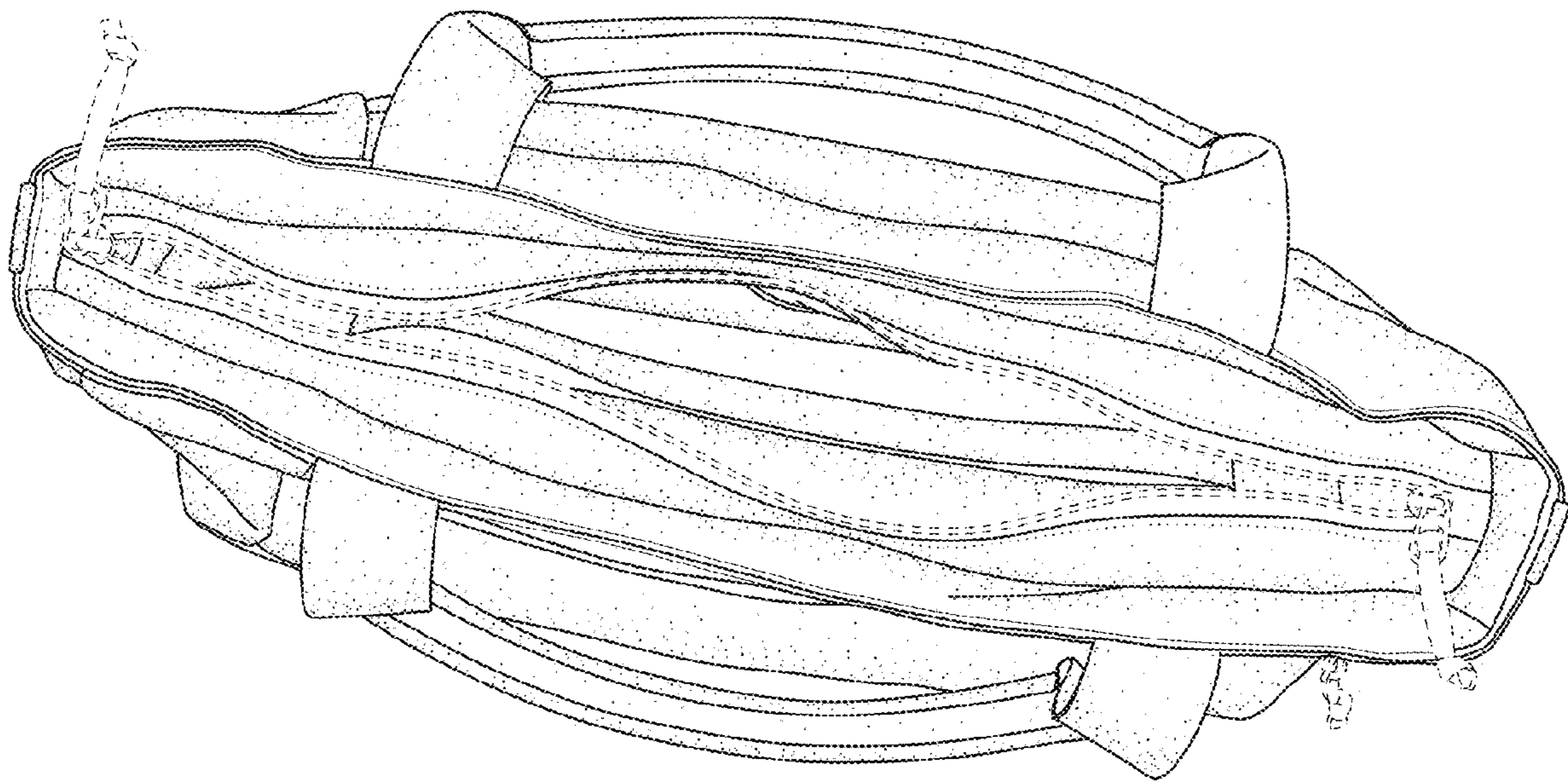

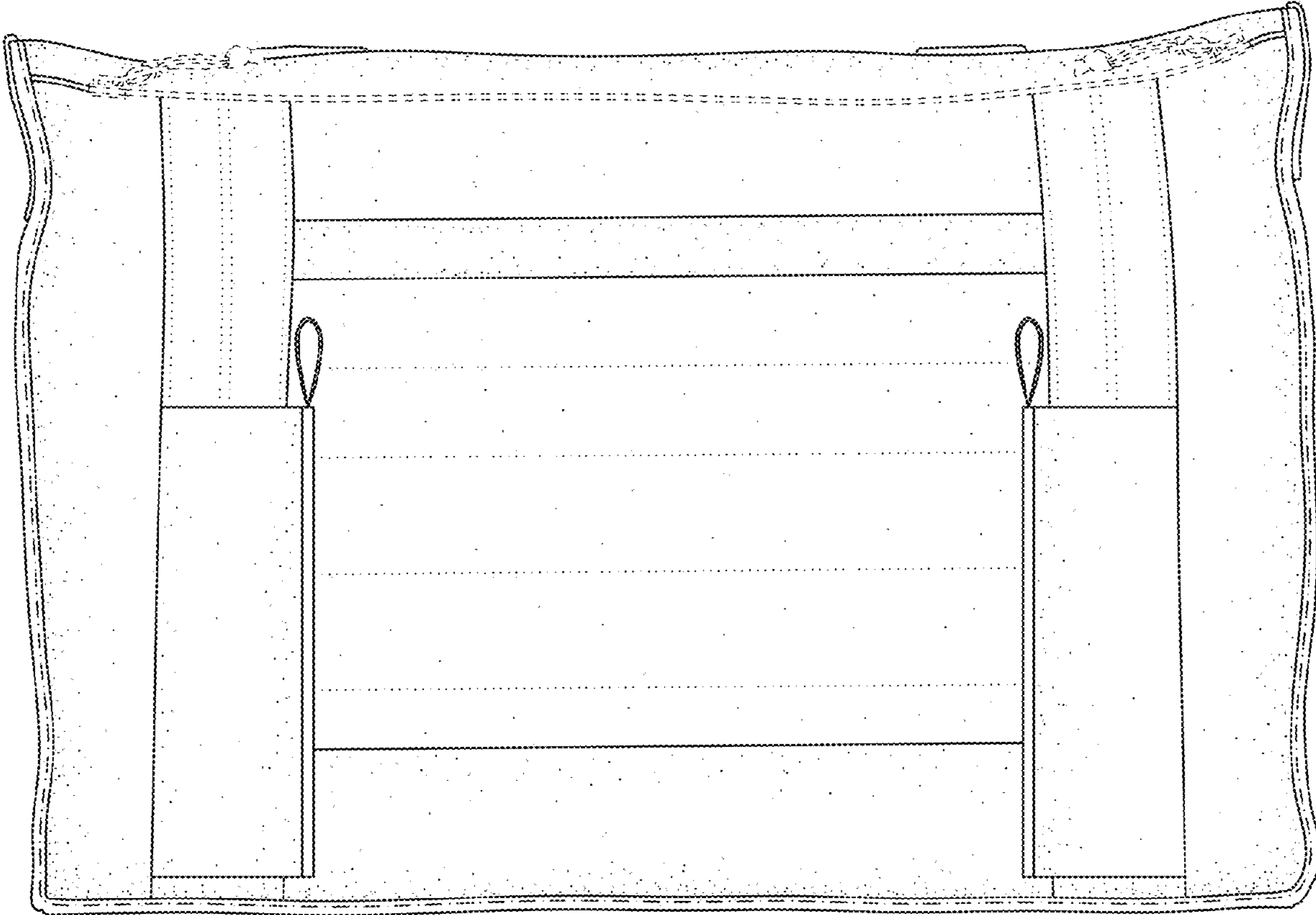

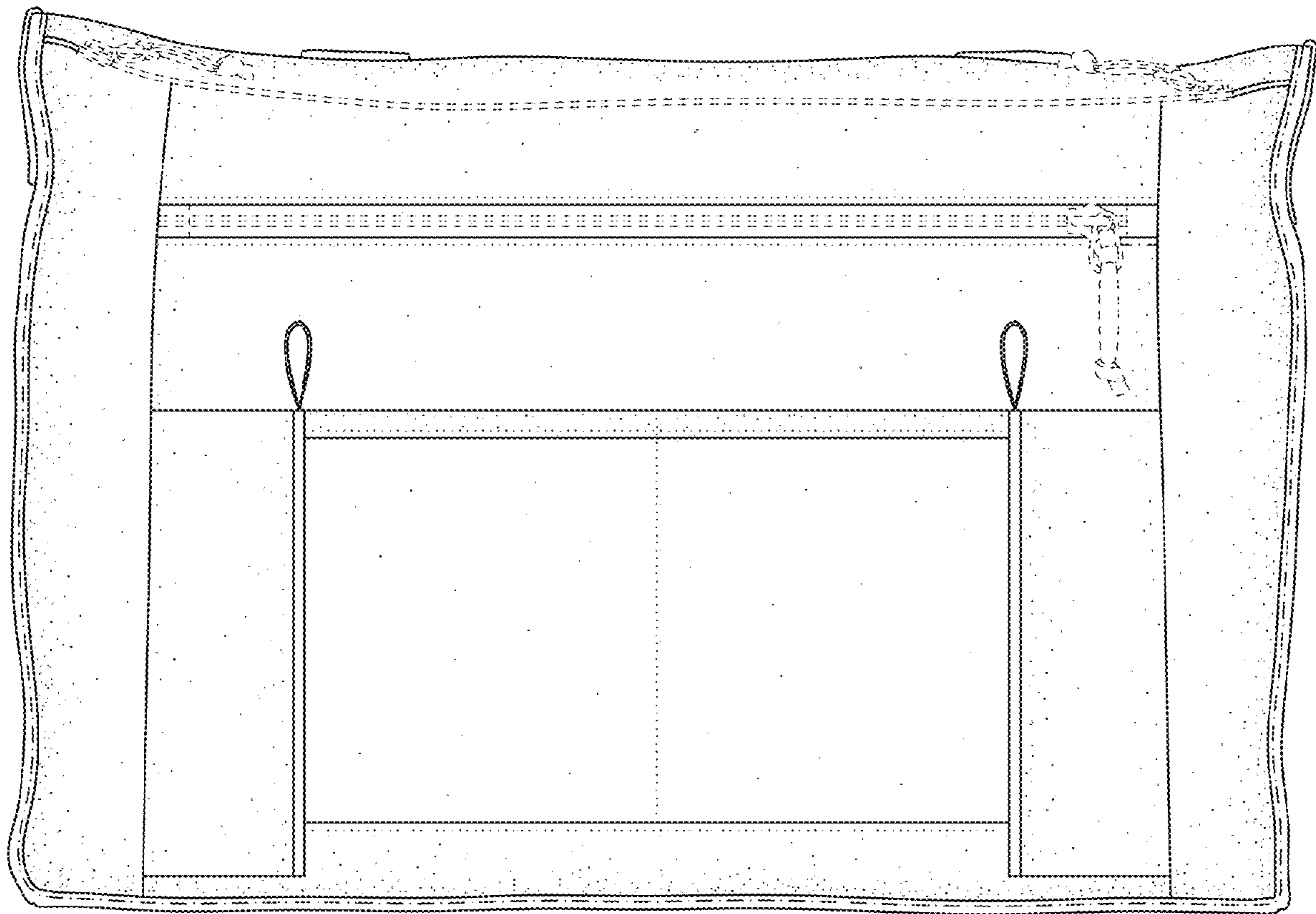
