The ornamental design for a tumbler, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a tumbler of the present invention;

FIG. 2 is a front view of the tumbler of FIG. 1;

FIG. 3 is a back view of the tumbler of FIG. 1;

FIG. 4 is a top view of the tumbler of FIG. 1;

FIG. 5 is a bottom view of the tumbler of FIG. 1;

FIG. 6 is a left view of the tumbler of FIG. 1;

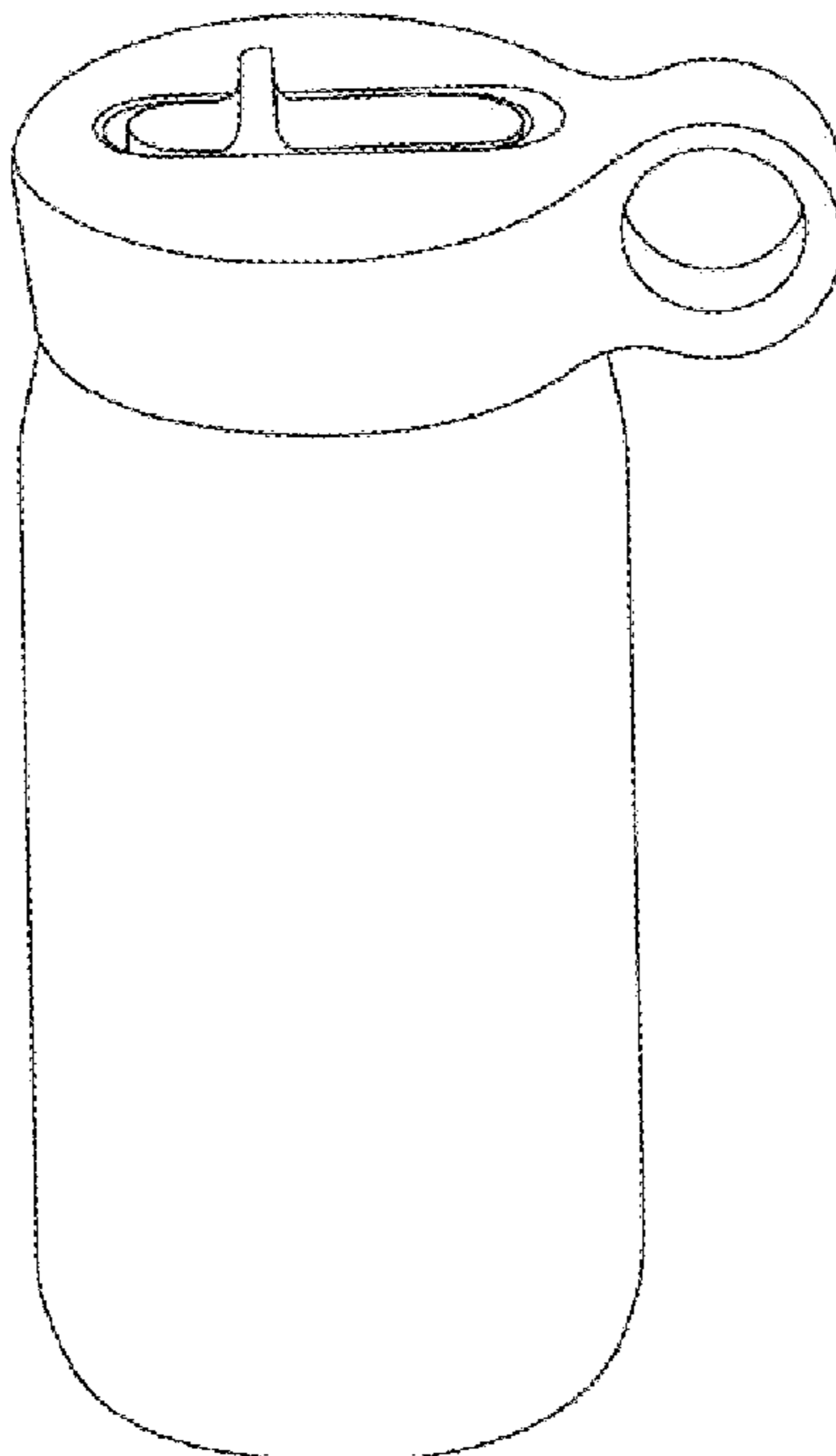
FIG. 7 is a right view of the tumbler of FIG. 1; and,

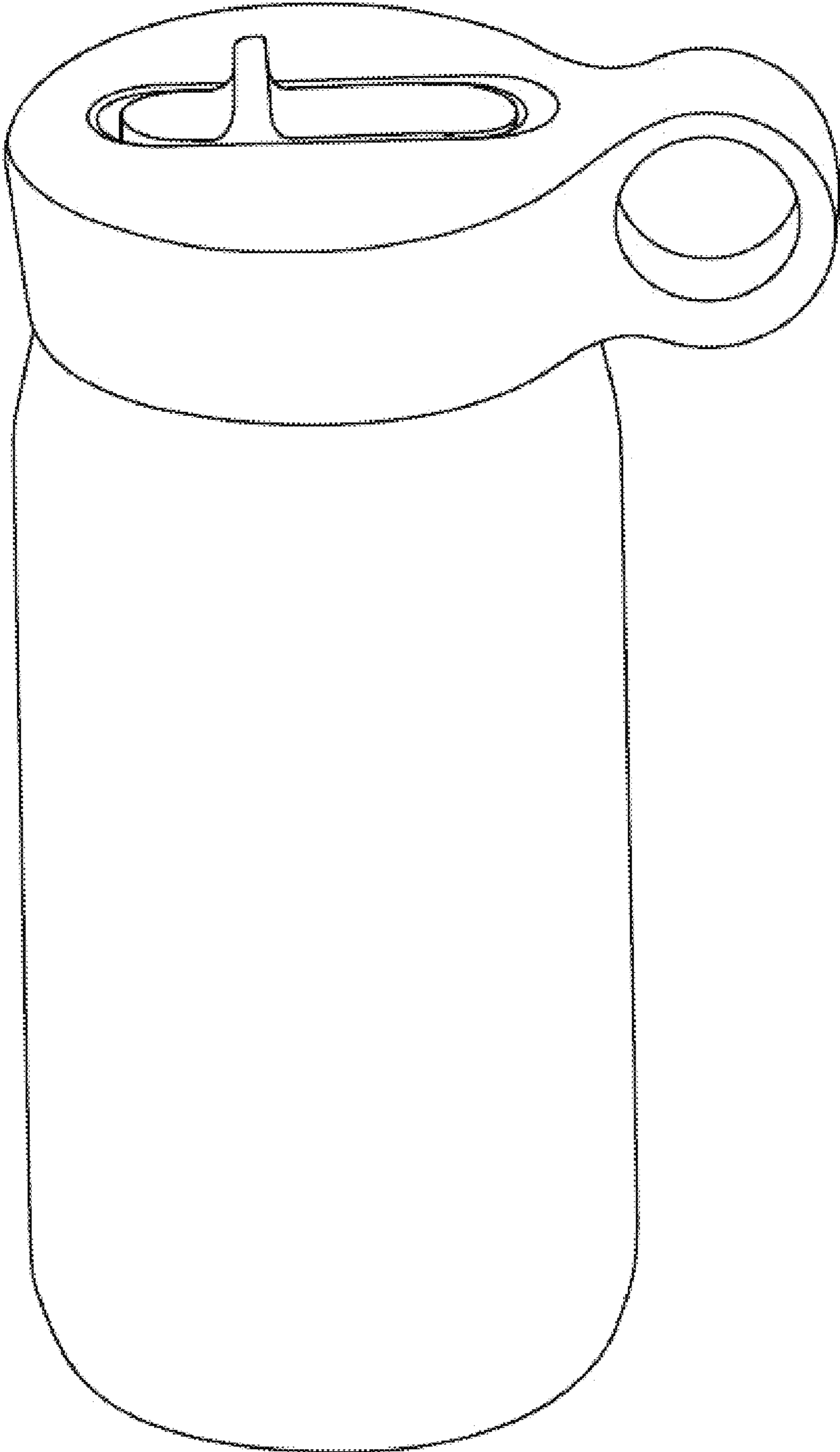

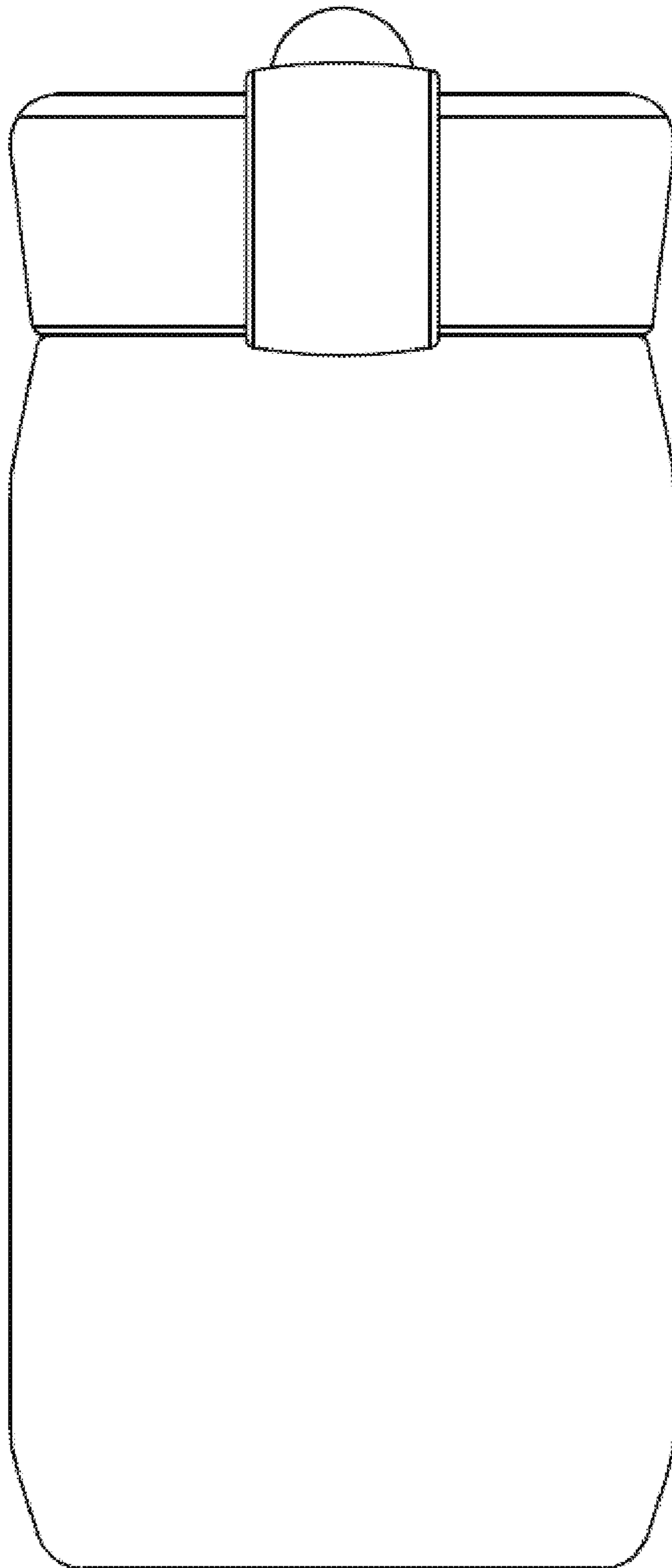

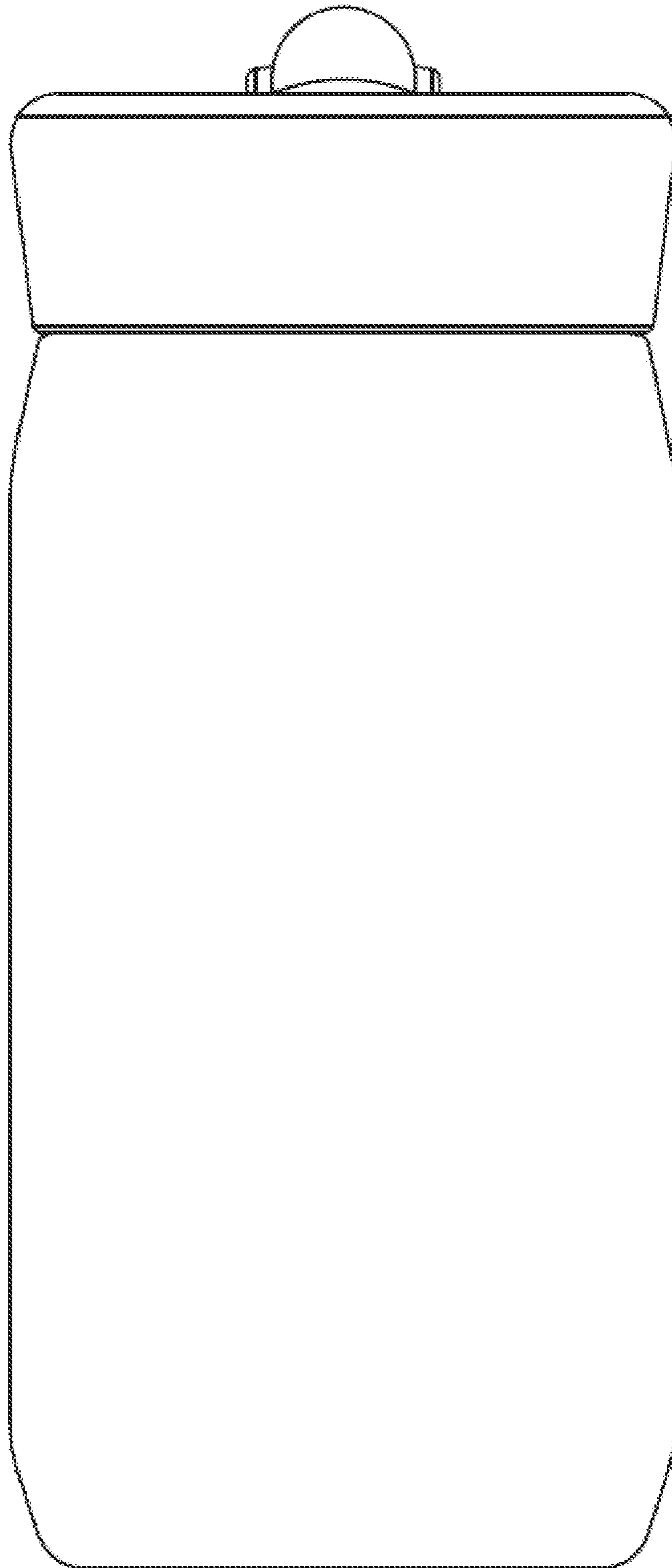

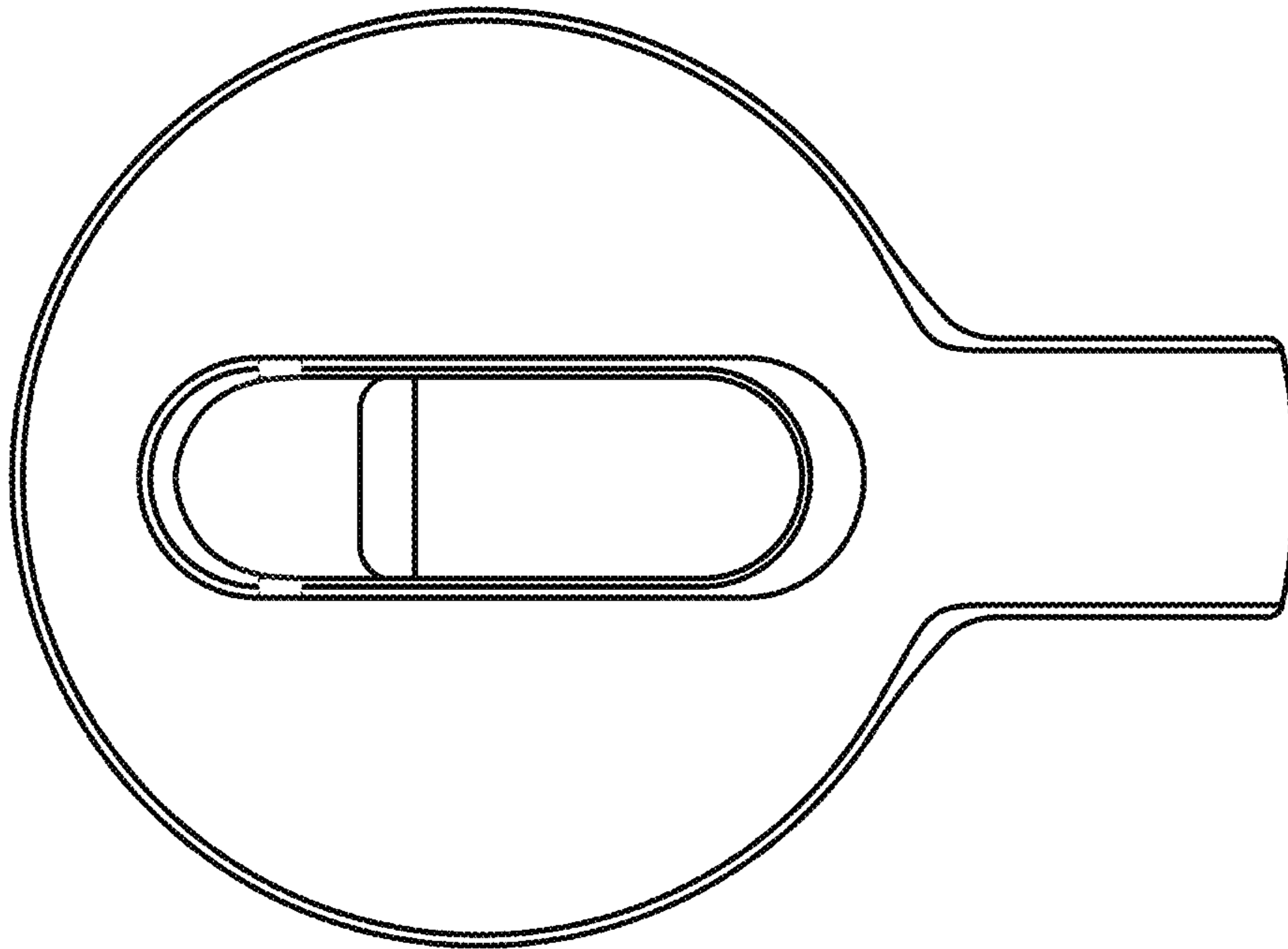

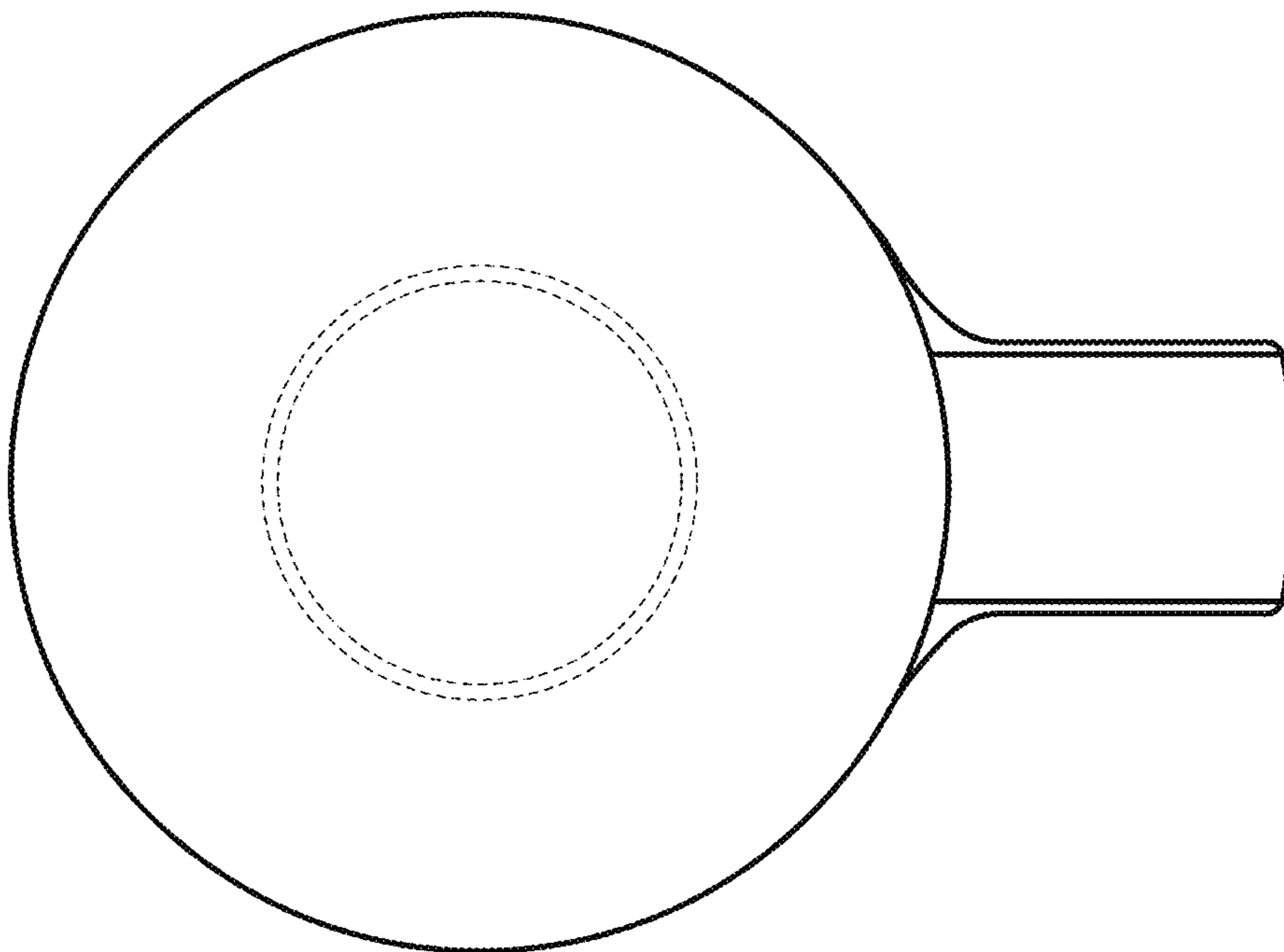

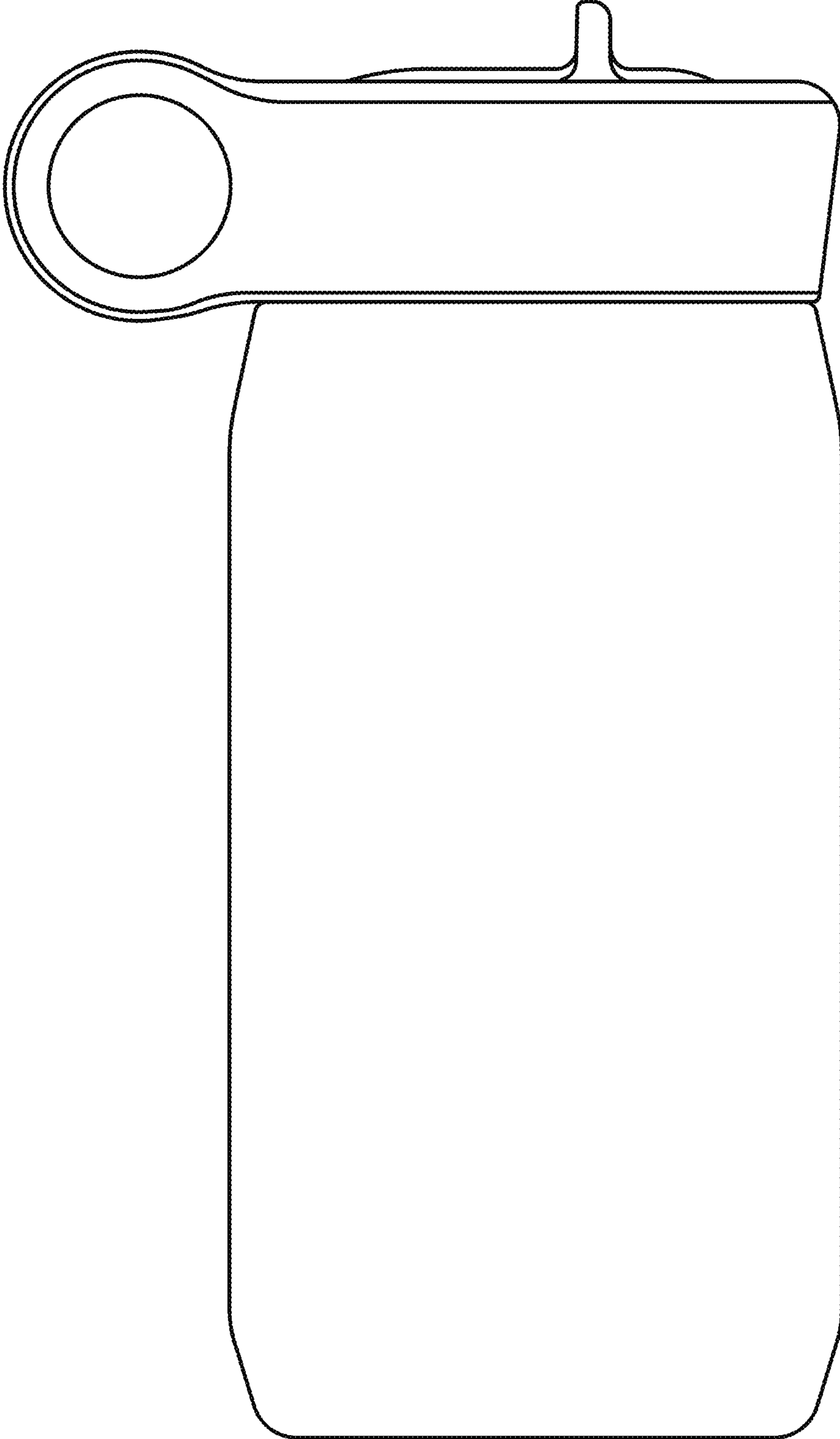

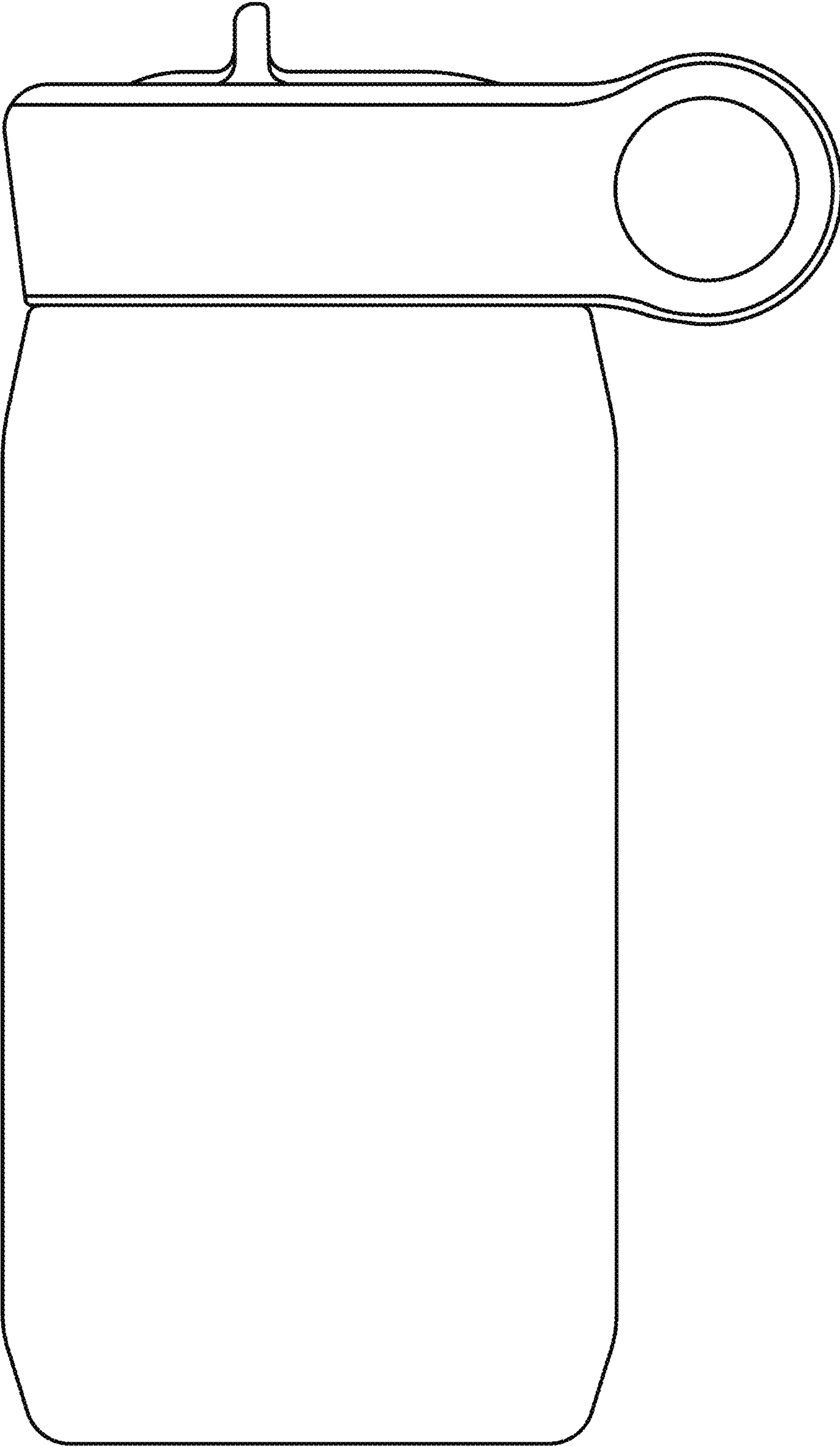

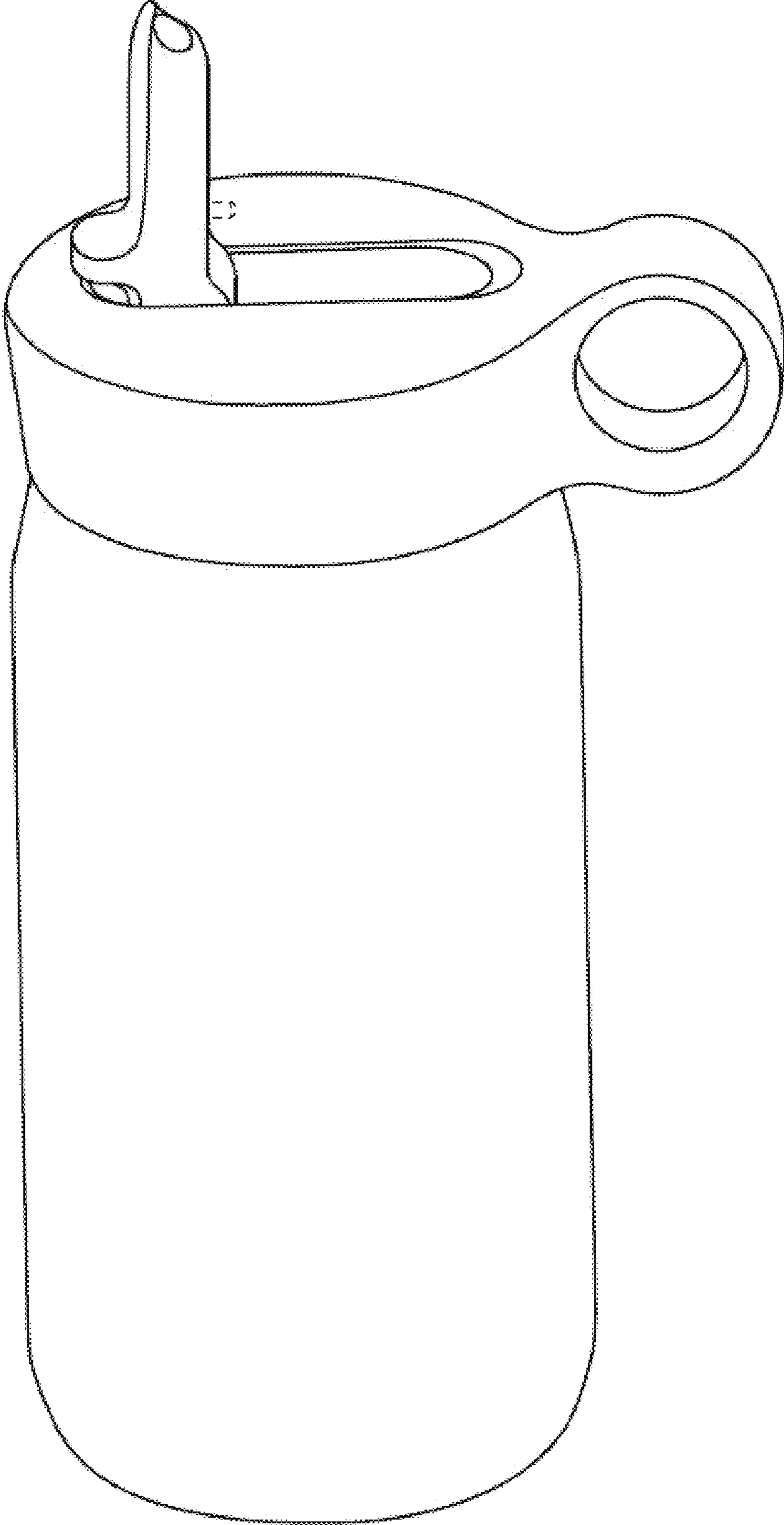
