The ornamental design for a hillside planter dam, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hillside planter dam showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a right-side elevational view thereof;  
FIG. 5 is a left-side elevational view thereof;  
FIG. 6 is a top plan view thereof;

FIG. 8 is a cross-sectional view taken about line 8-8 in FIG. 7.

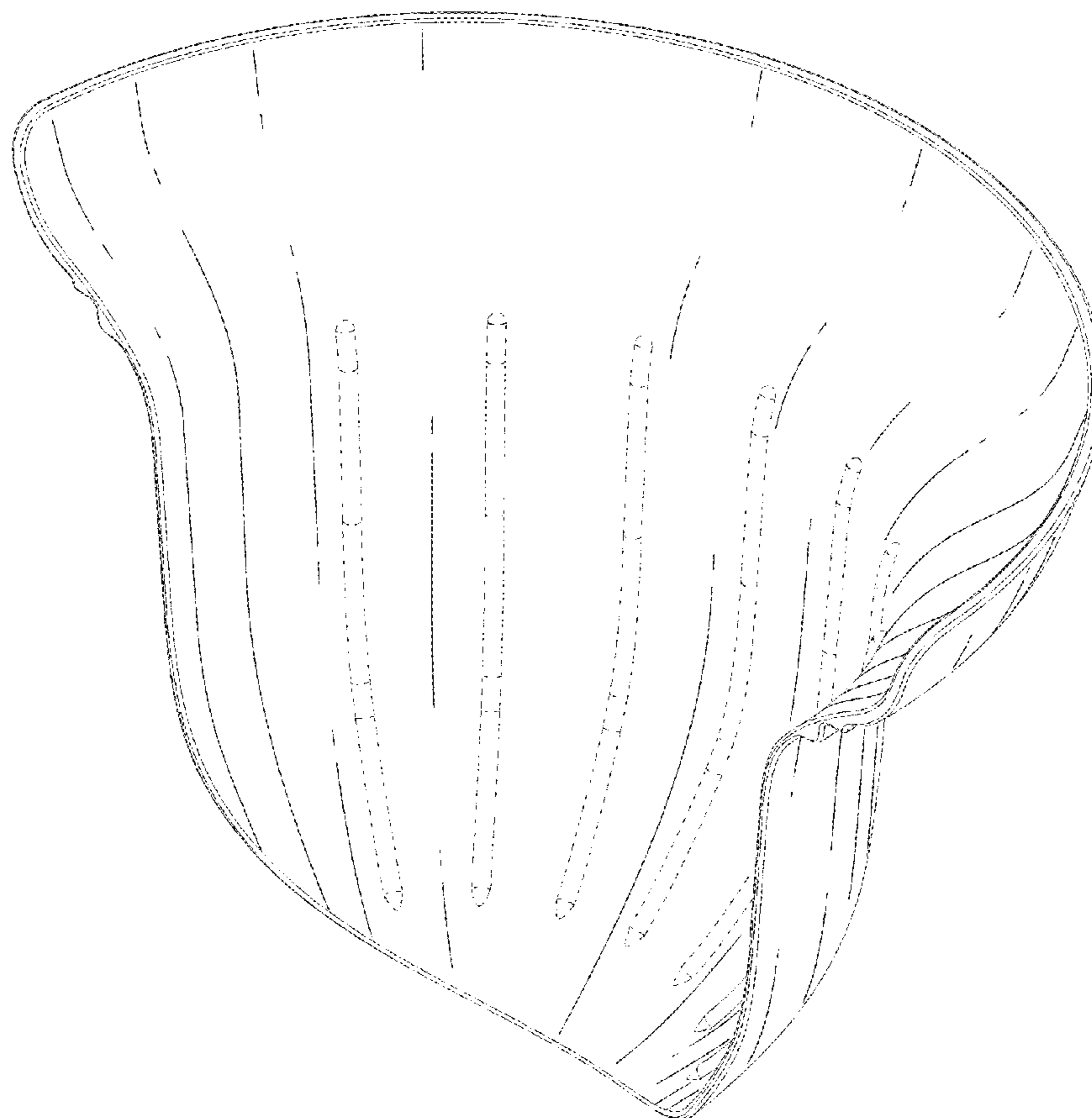
The broken lines in the figures depict portions of the hillside planter dam that form no part of the claimed design.

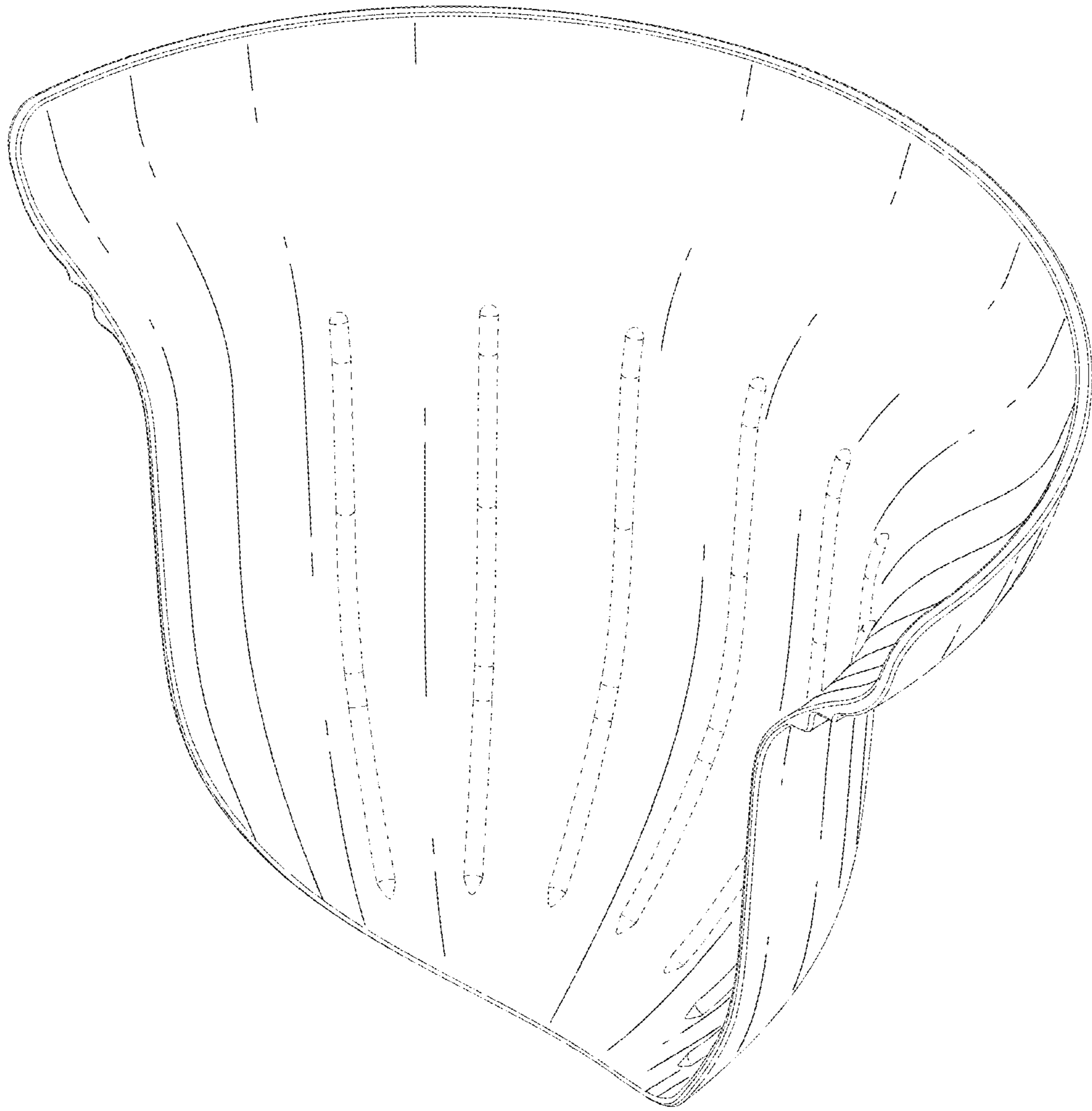

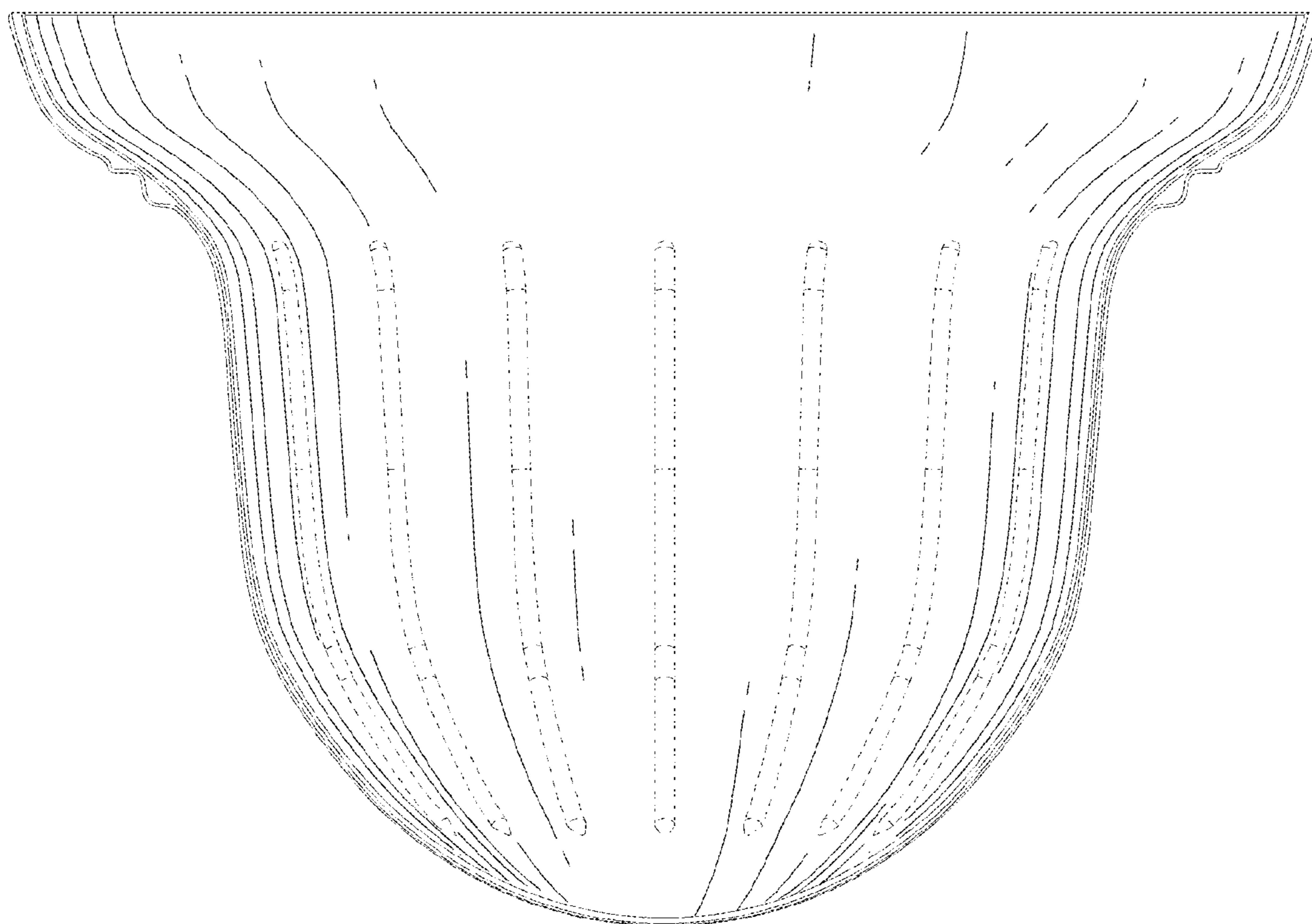

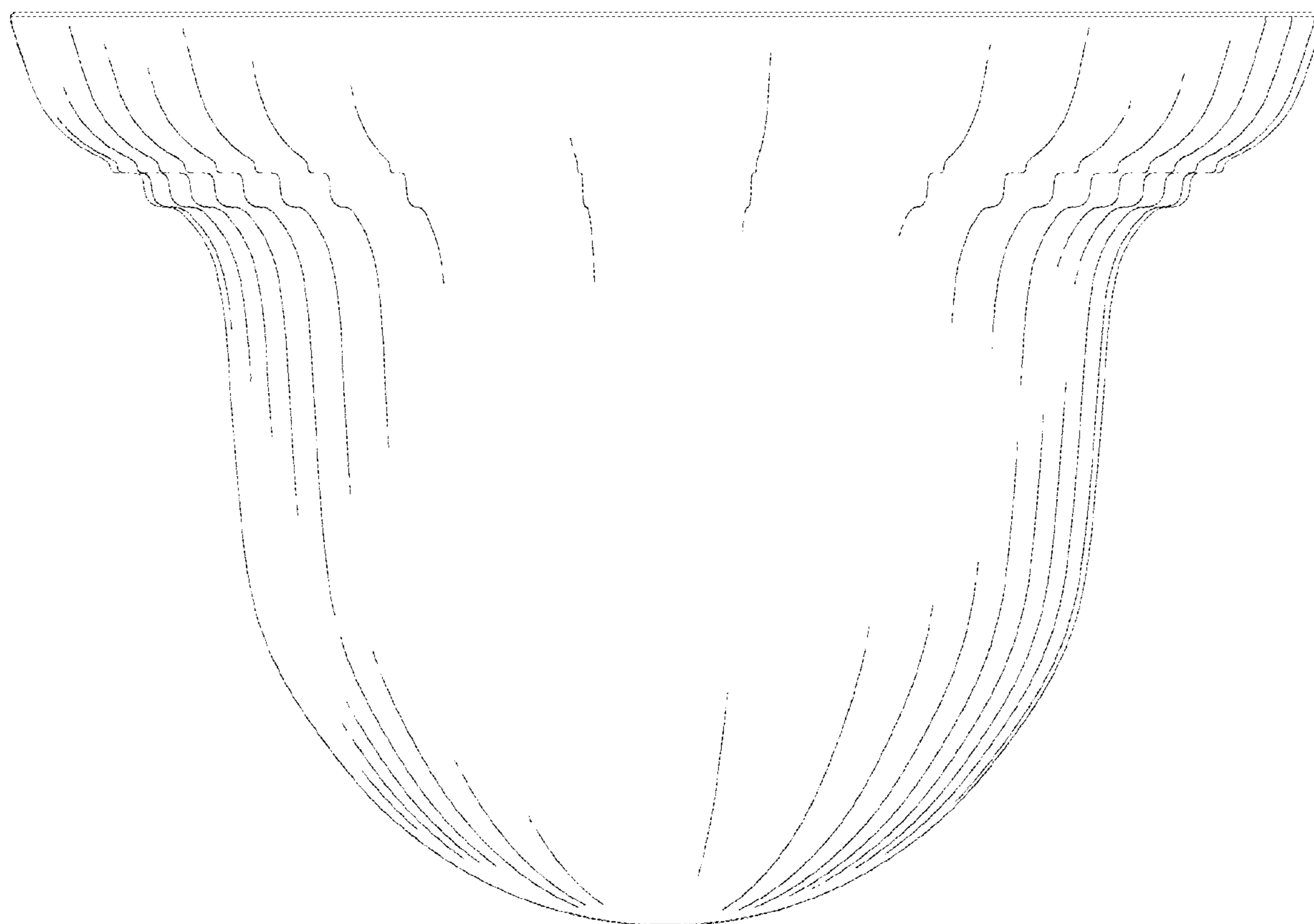

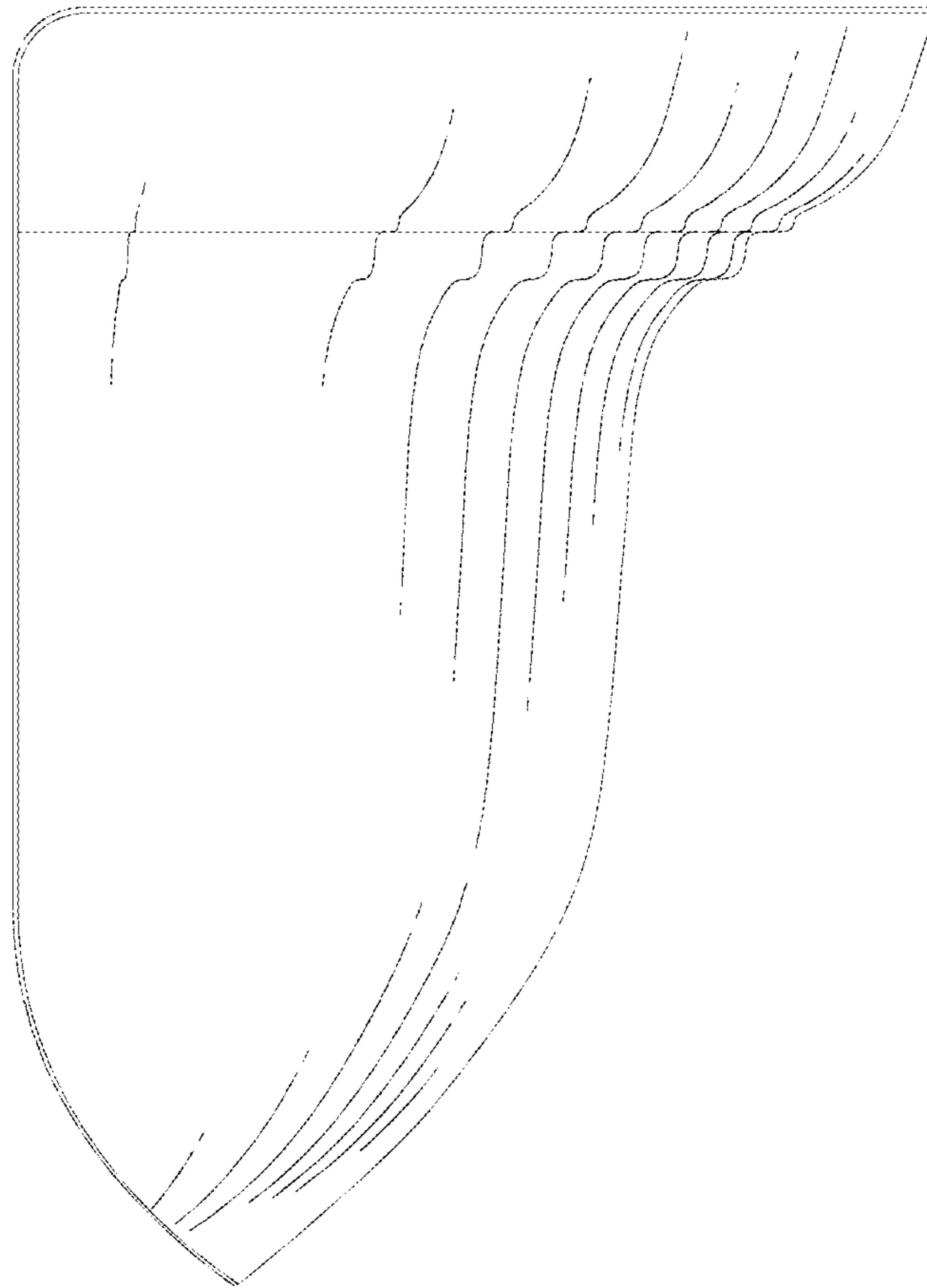

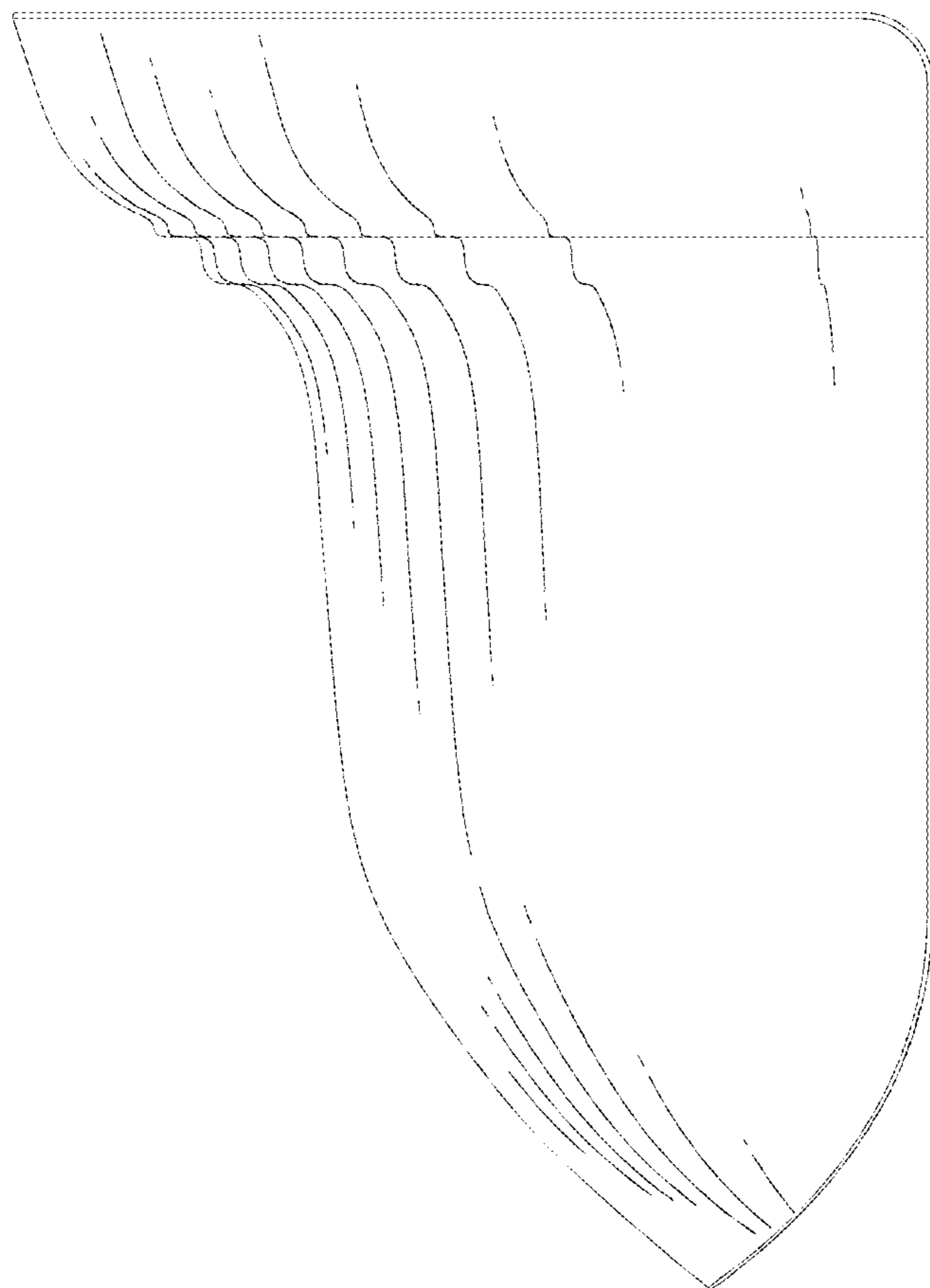

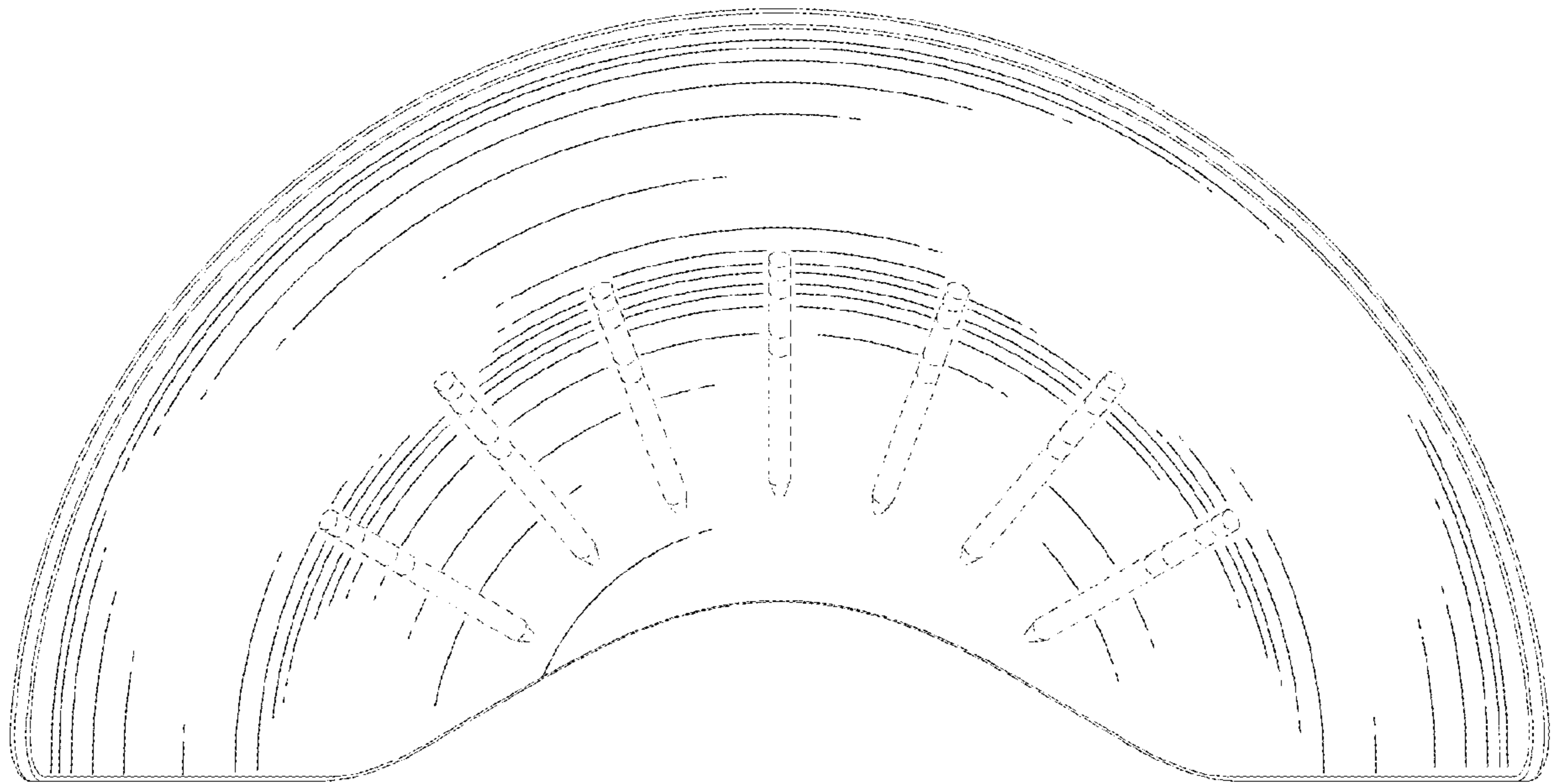

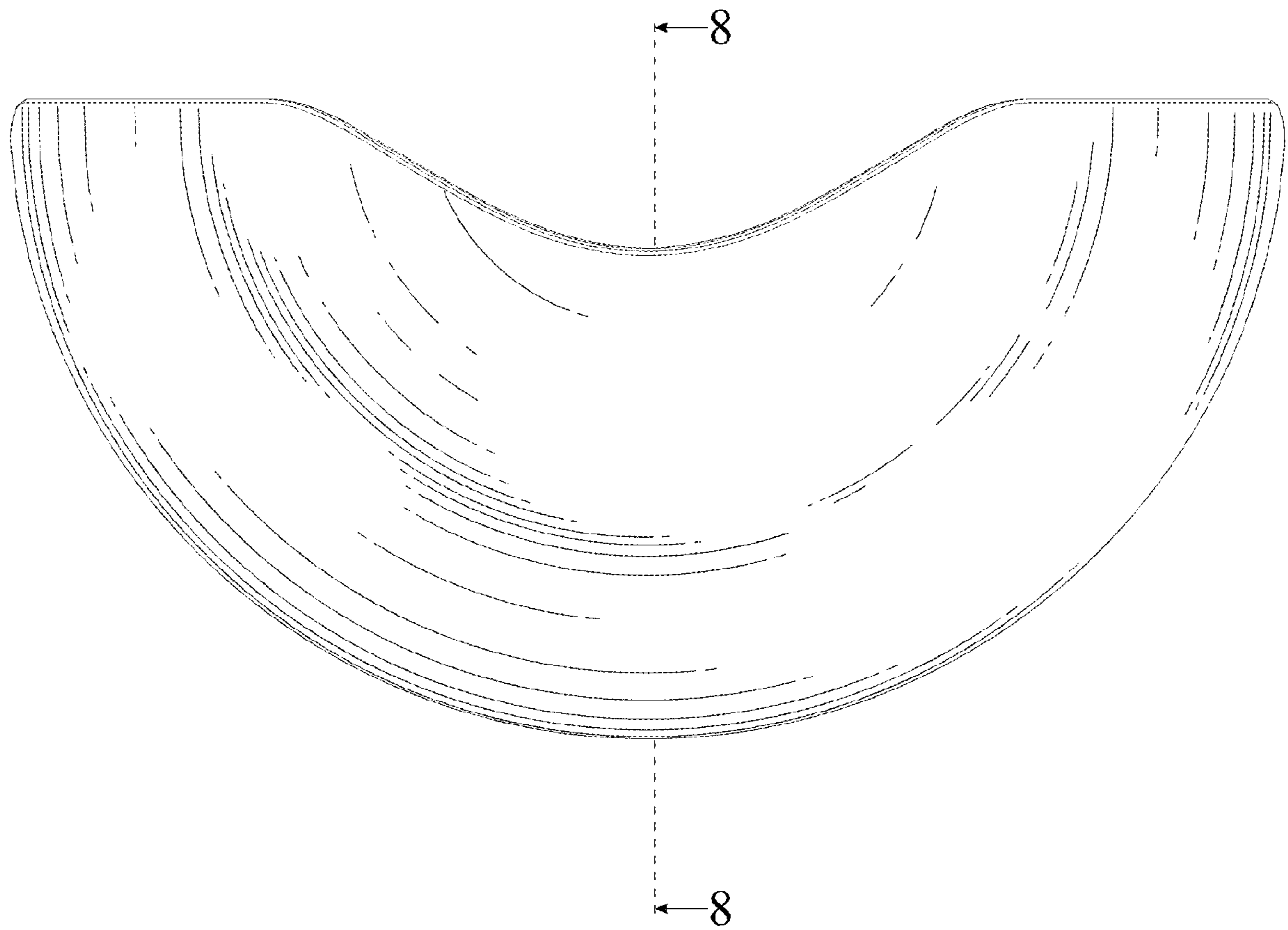

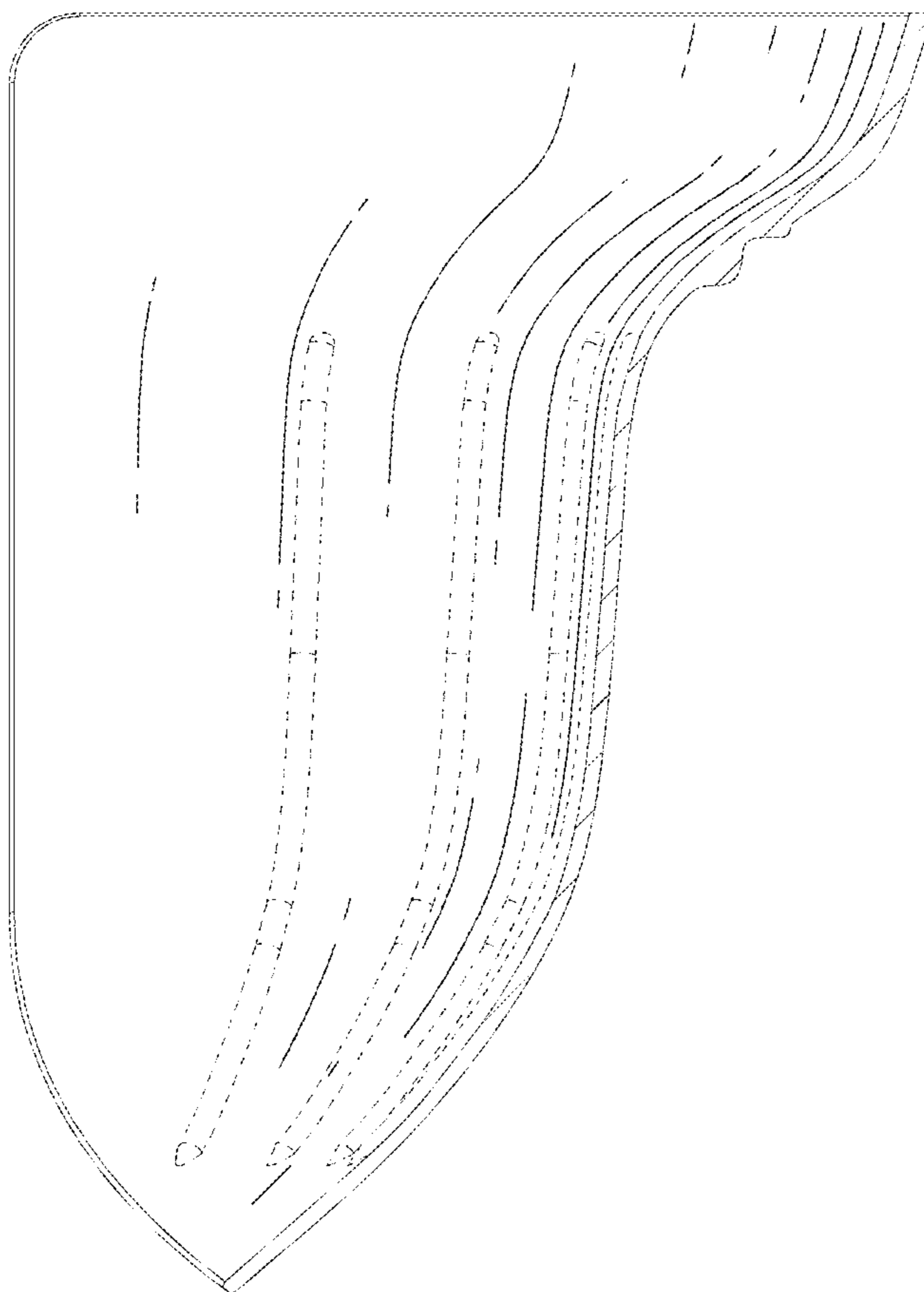
